The ornamental design for a bottle, as shown and described.

DESCRIPTION

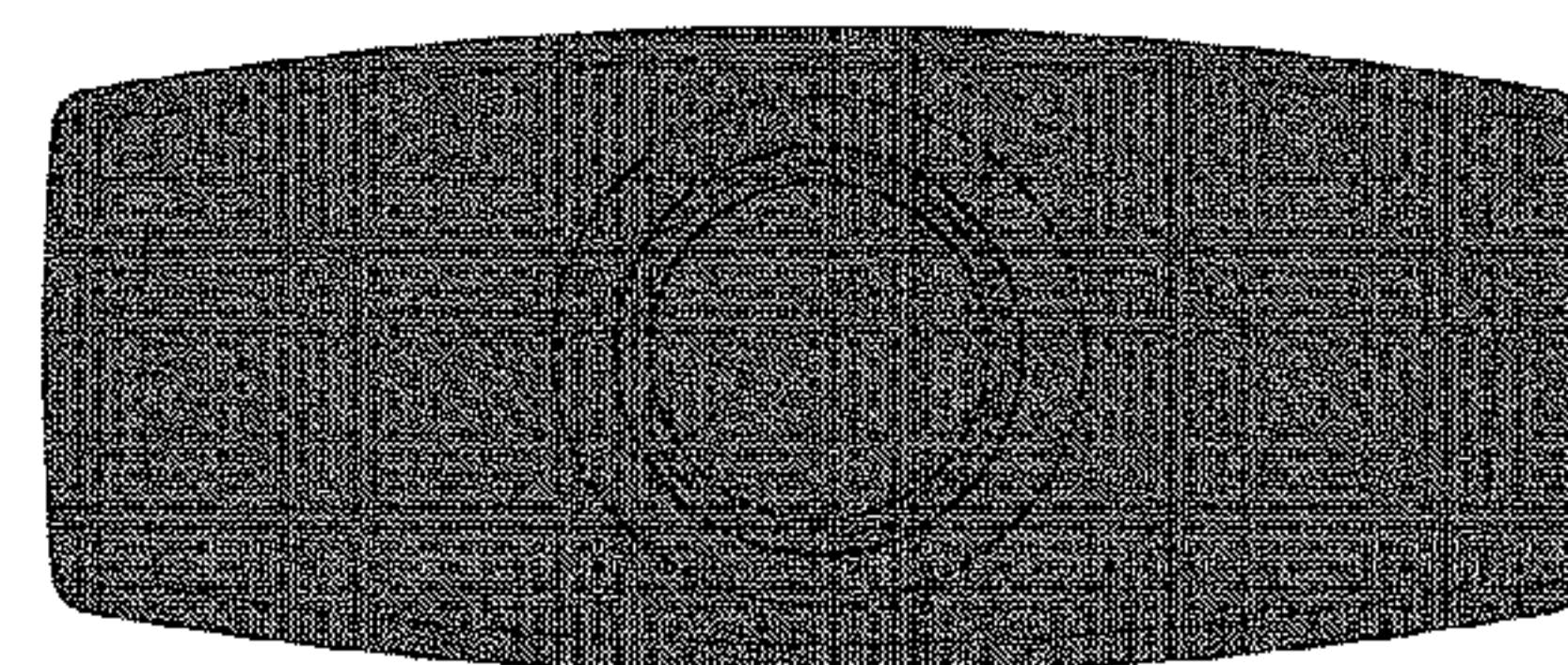
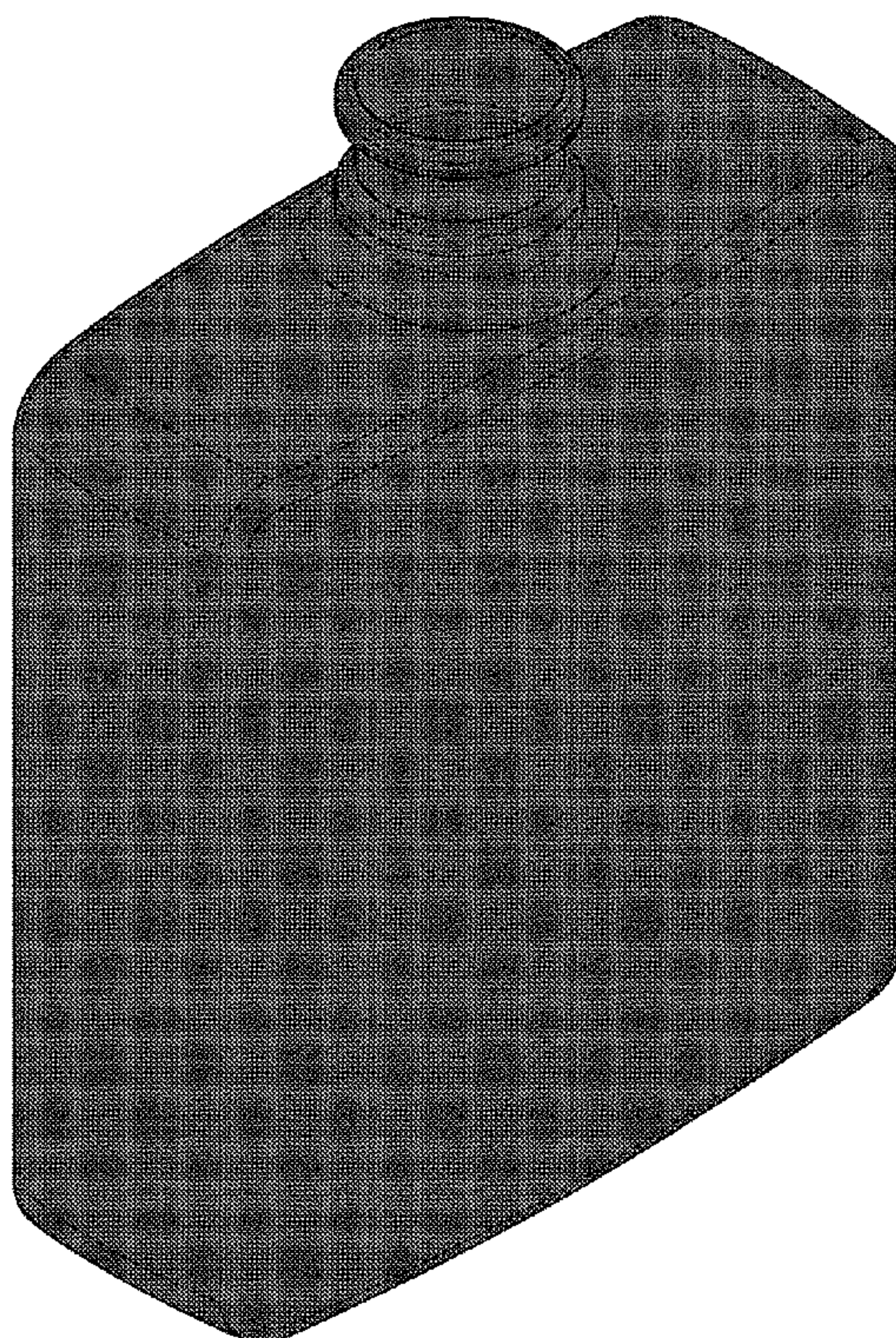
FIG. 1 is a front perspective view of a bottle in accordance with my new design;

FIG. 2 is a front elevational view of the bottle shown in FIG. 1, the rear being a mirror image of the front;

FIG. 3 is a right-side elevational view of the bottle shown in FIG. 1, the left side being a mirror image of the right side; and,

FIG. 4 is a top plan view of the bottle shown in FIG. 1. Color forms part of the claimed design. The broken lines shown in the drawings represent portions of the bottle that form no part of the claimed design.

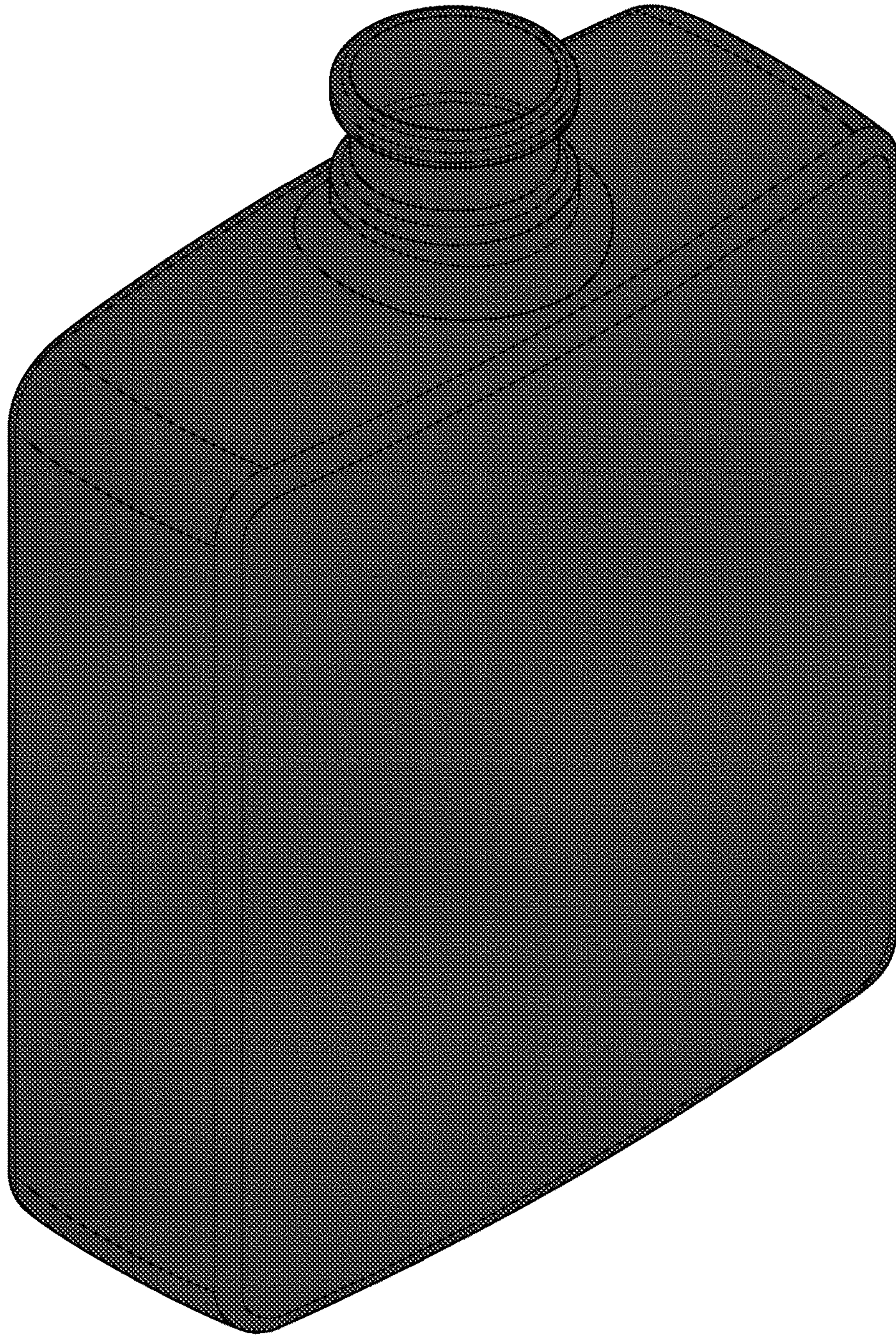

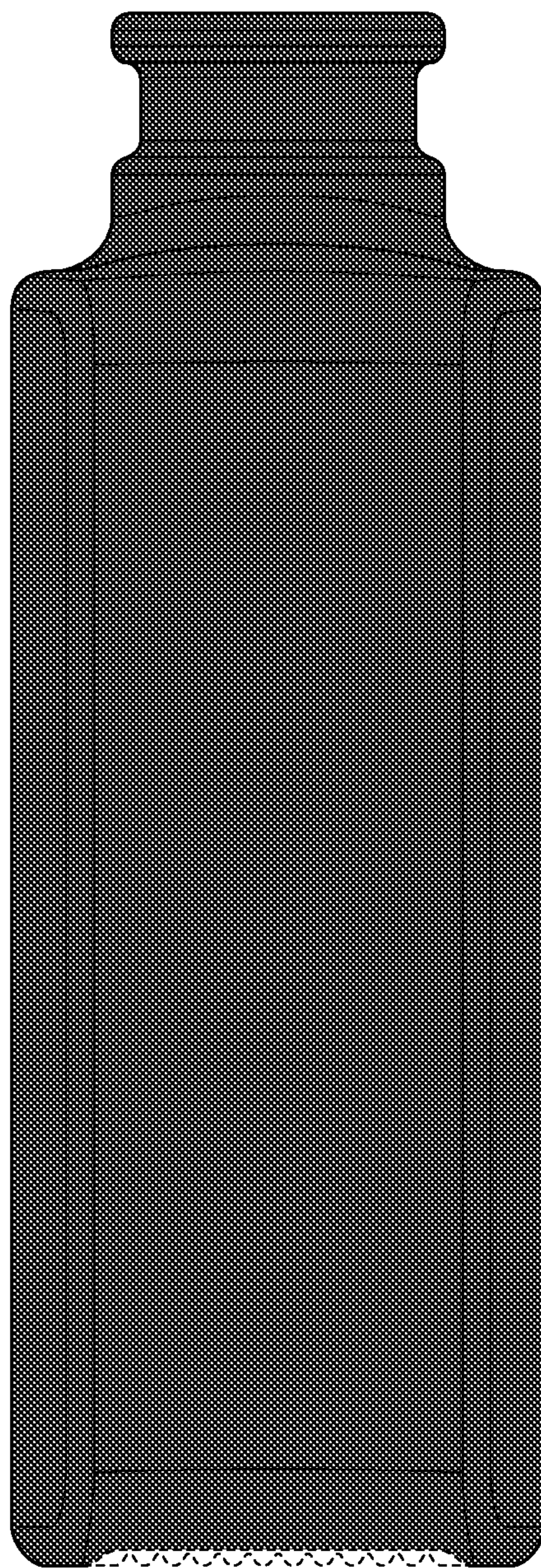

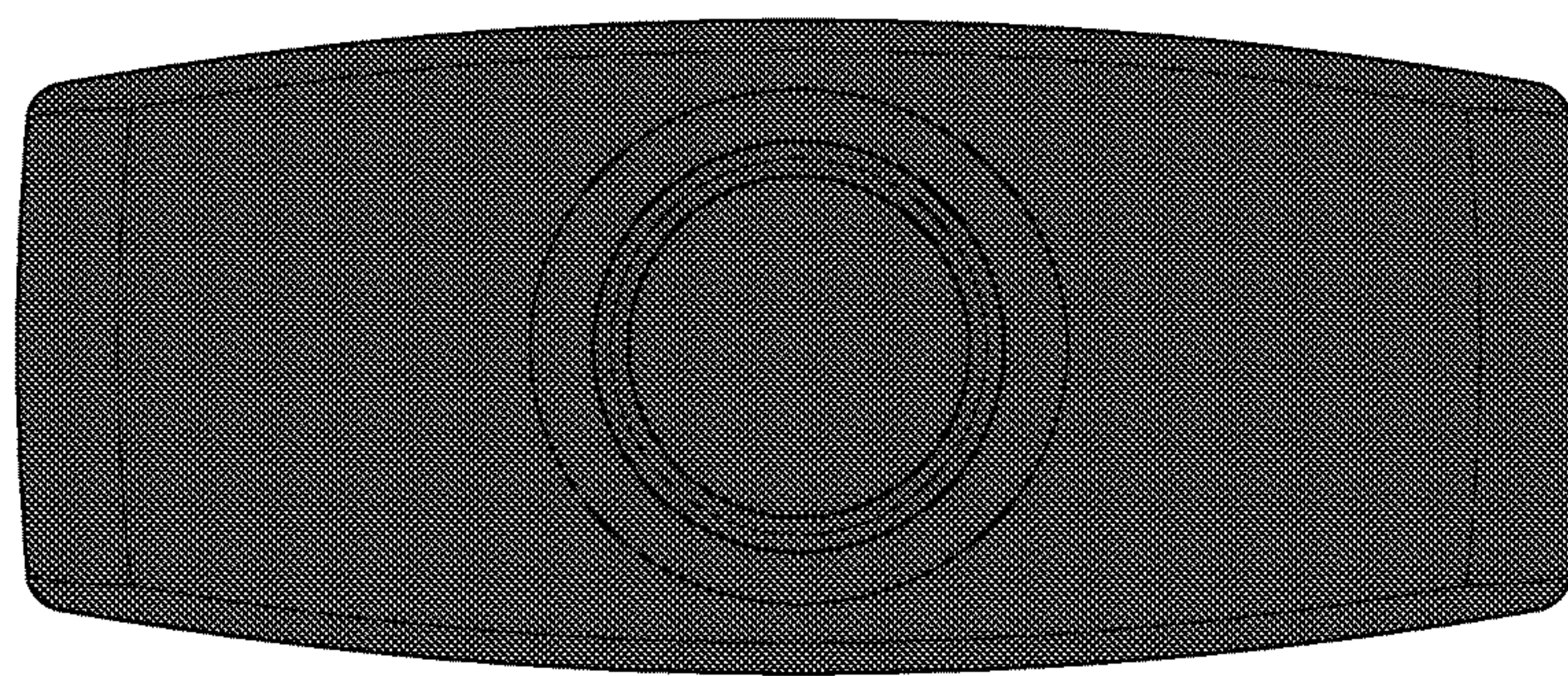
