**DESCRIPTION**

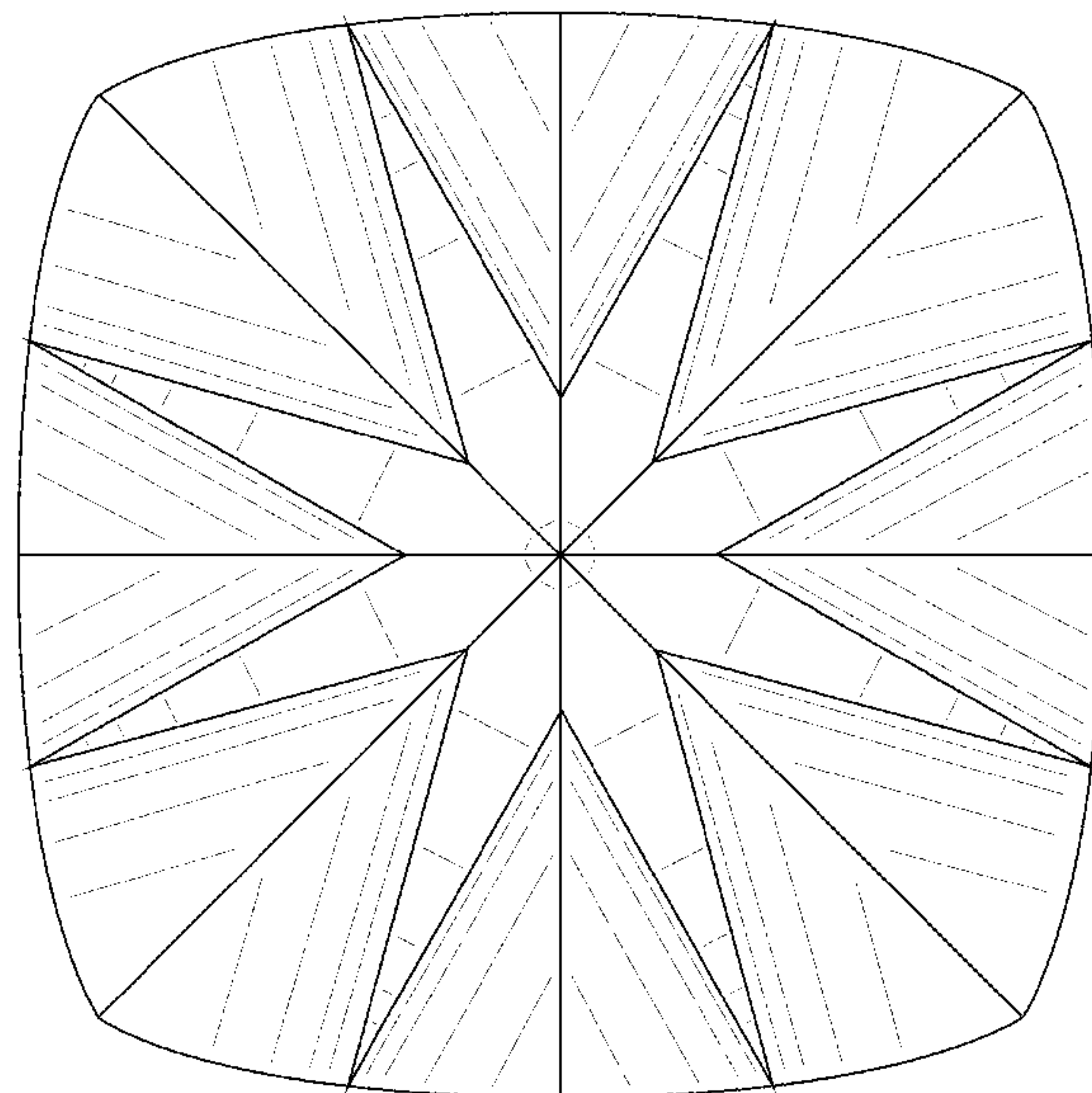
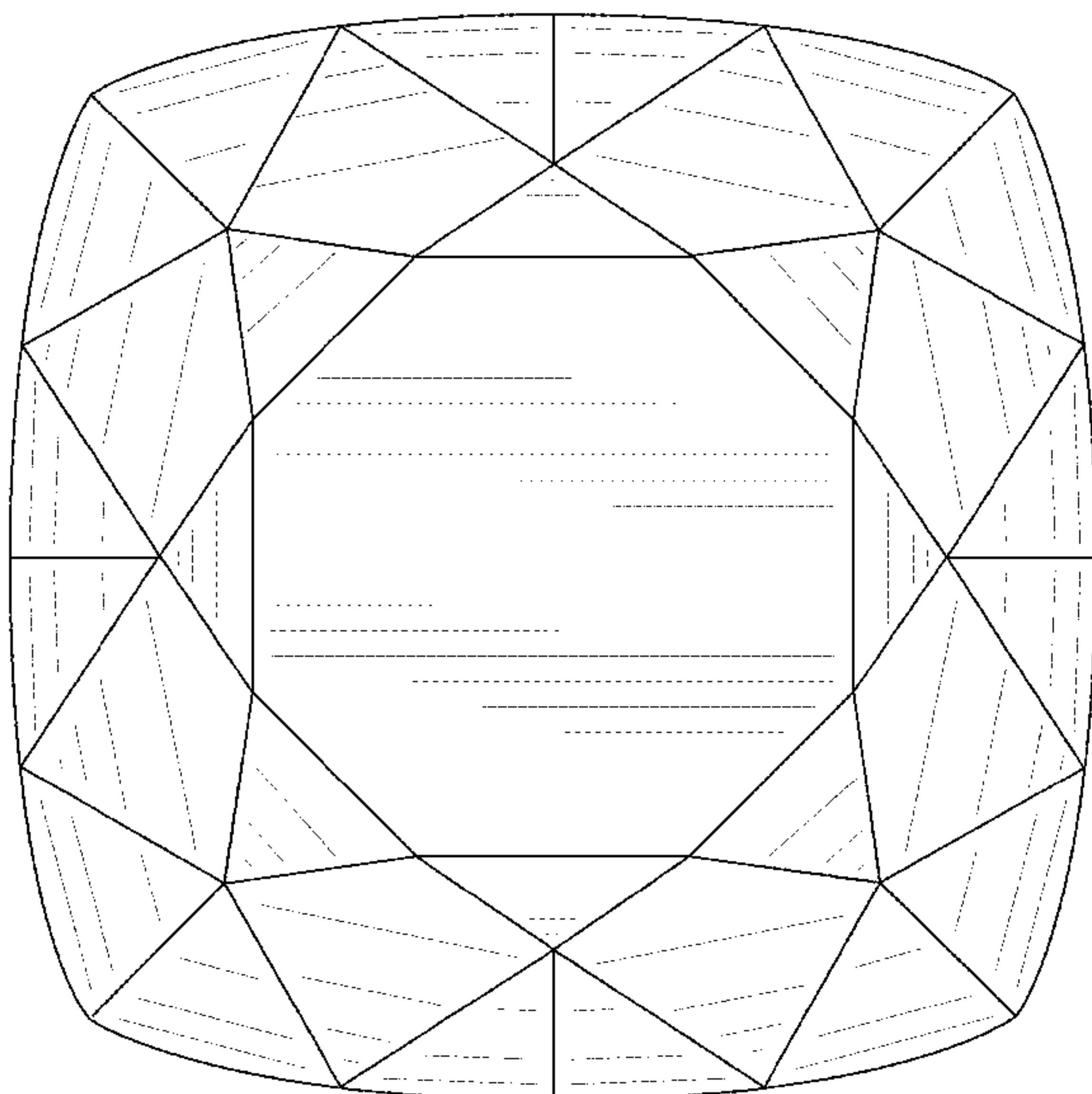
FIG. 1 is a perspective view of one embodiment of a gemstone.

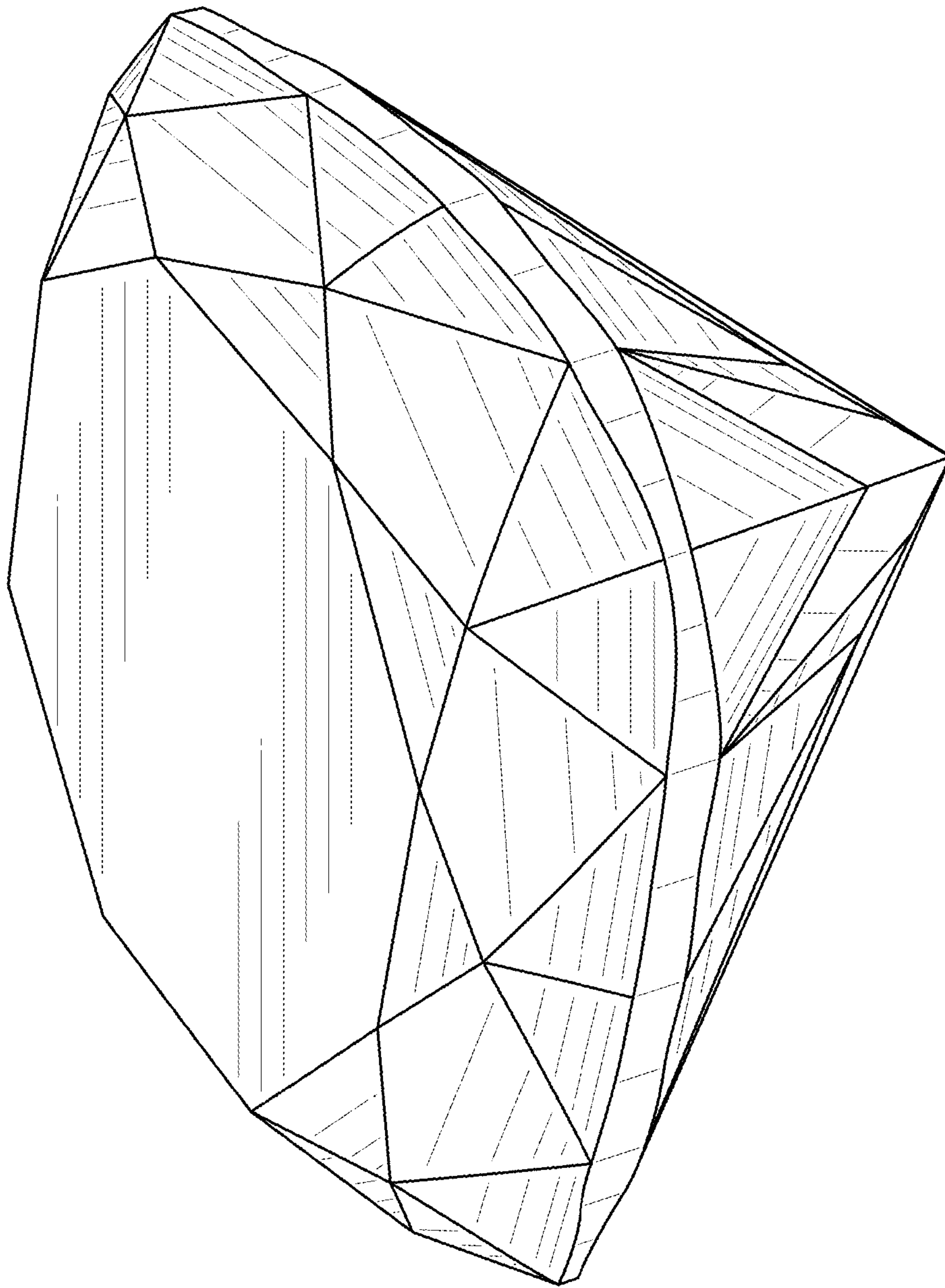
FIG. 2 is a side view of the gemstone of FIG. 1.

FIG. 3 is a top view of the gemstone of FIG. 1; and,

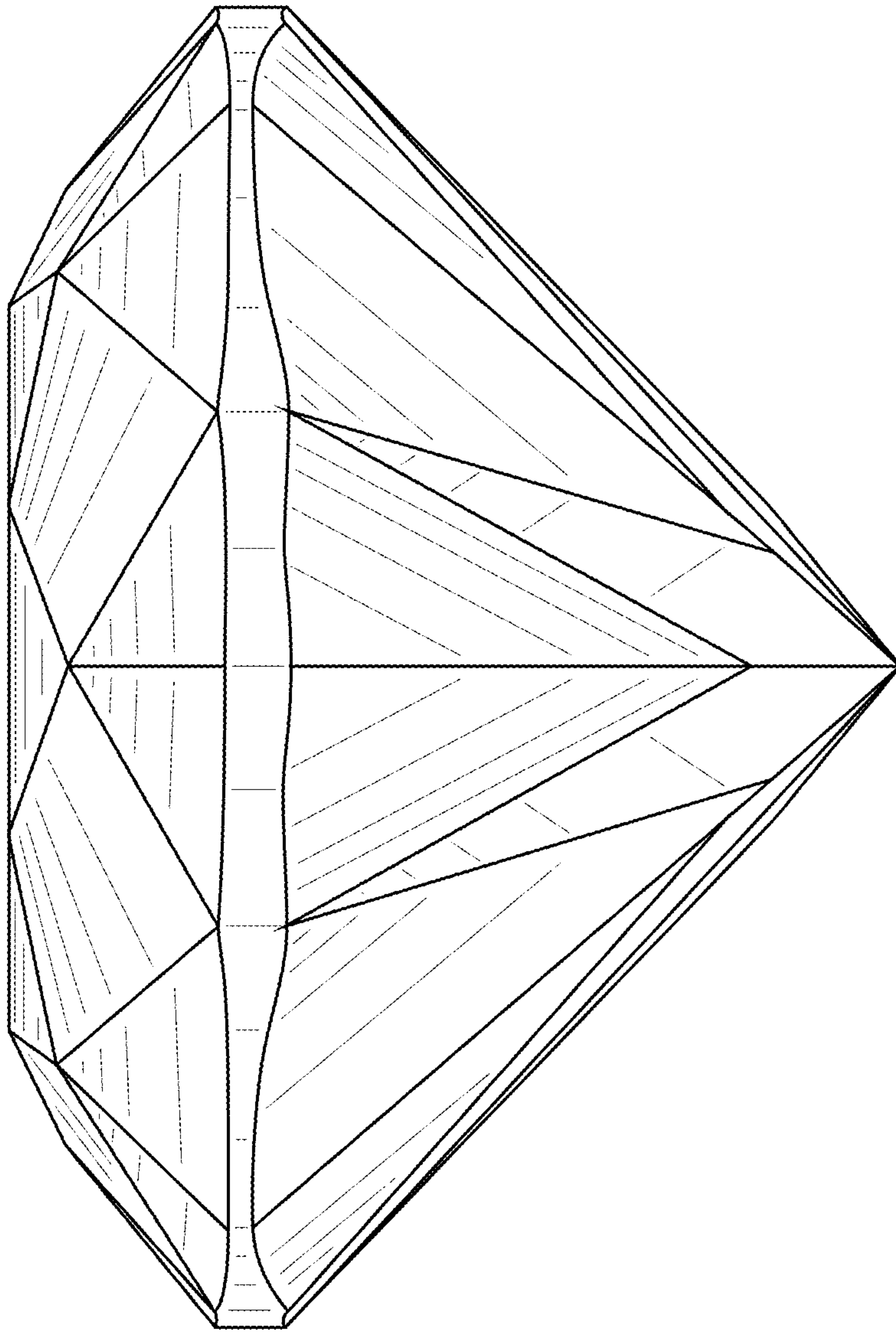
FIG. 4 is a bottom view of gemstone of FIG. 1.

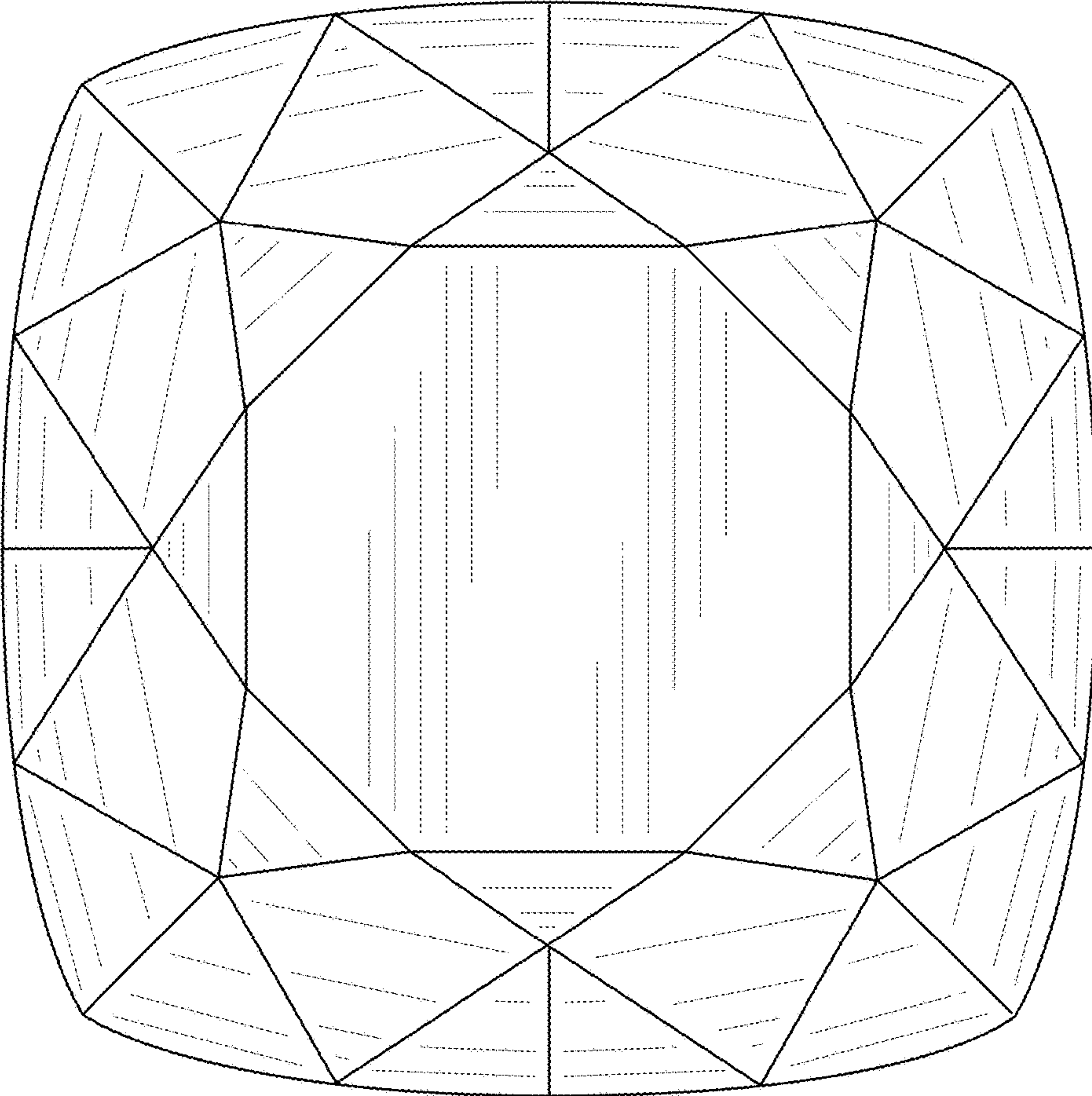

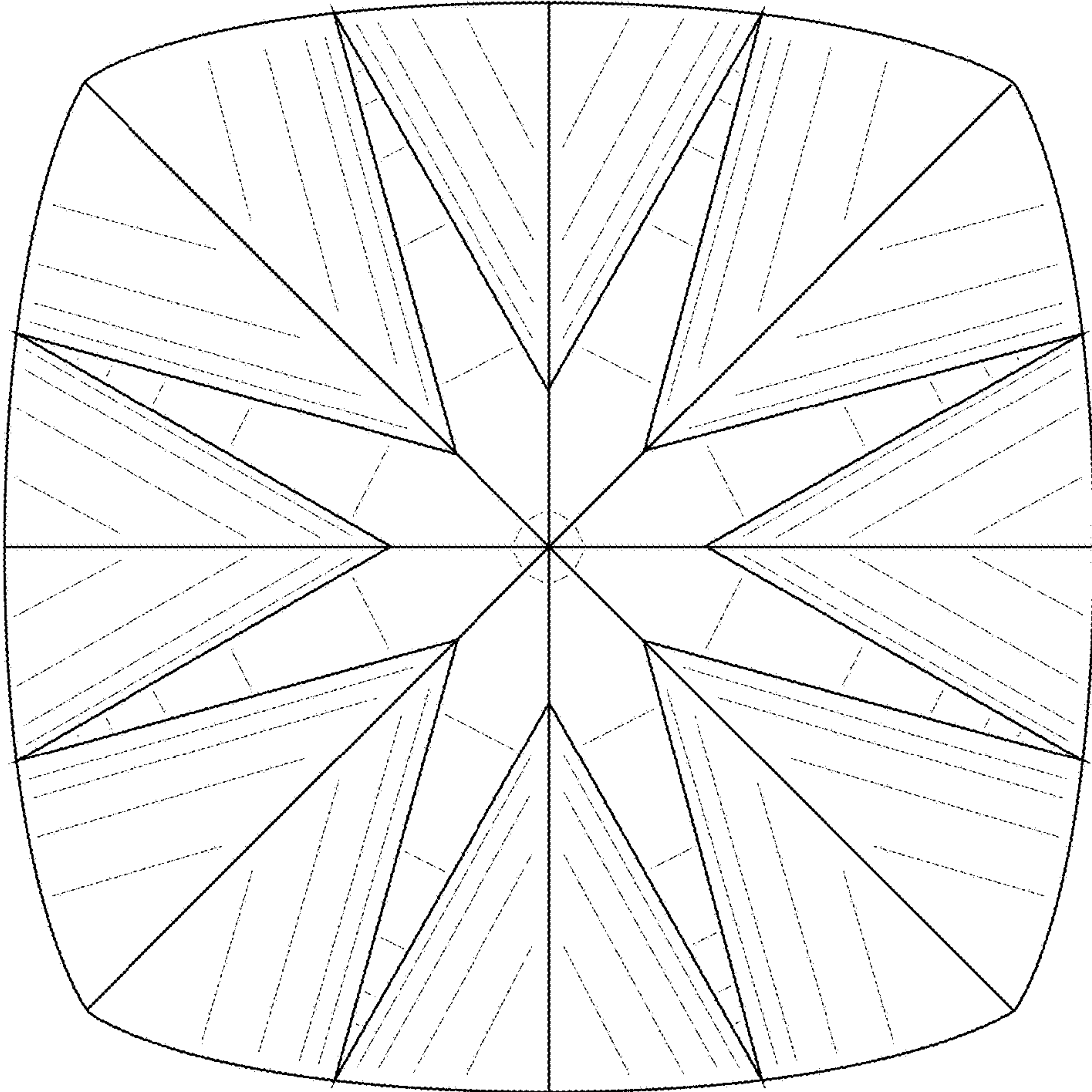
