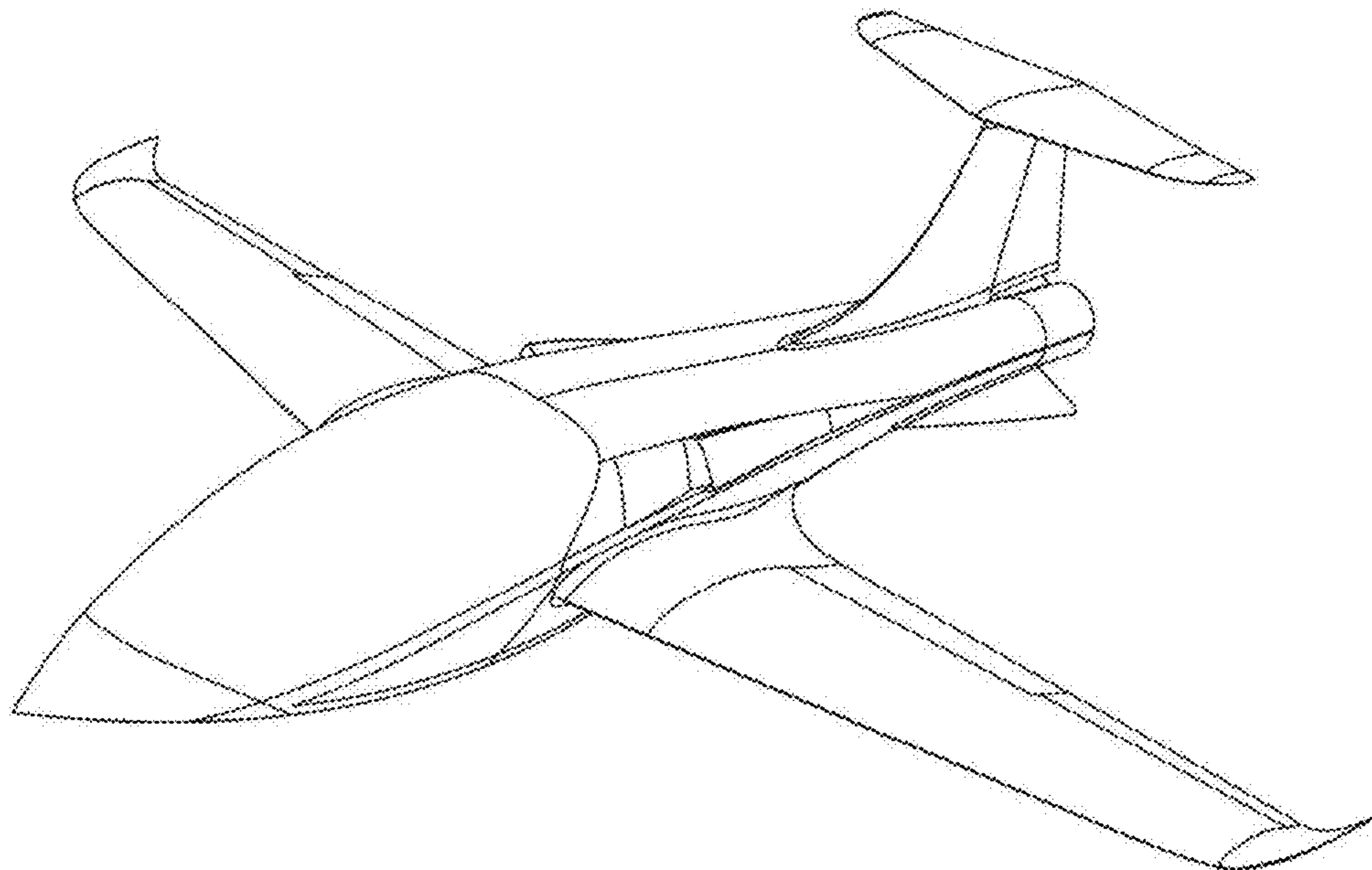
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top perspective view of an airplane showing my new design;
FIG. 2 is a first bottom perspective view thereof;
FIG. 3 is a second bottom perspective view thereof;
FIG. 4 is a front elevation view thereof;
FIG. 5 is a top elevation view thereof;
FIG. 6 is a left side elevation view thereof, the right side elevation view being a mirror image of that shown;

FIG. 8 is a partial front elevation view thereof.

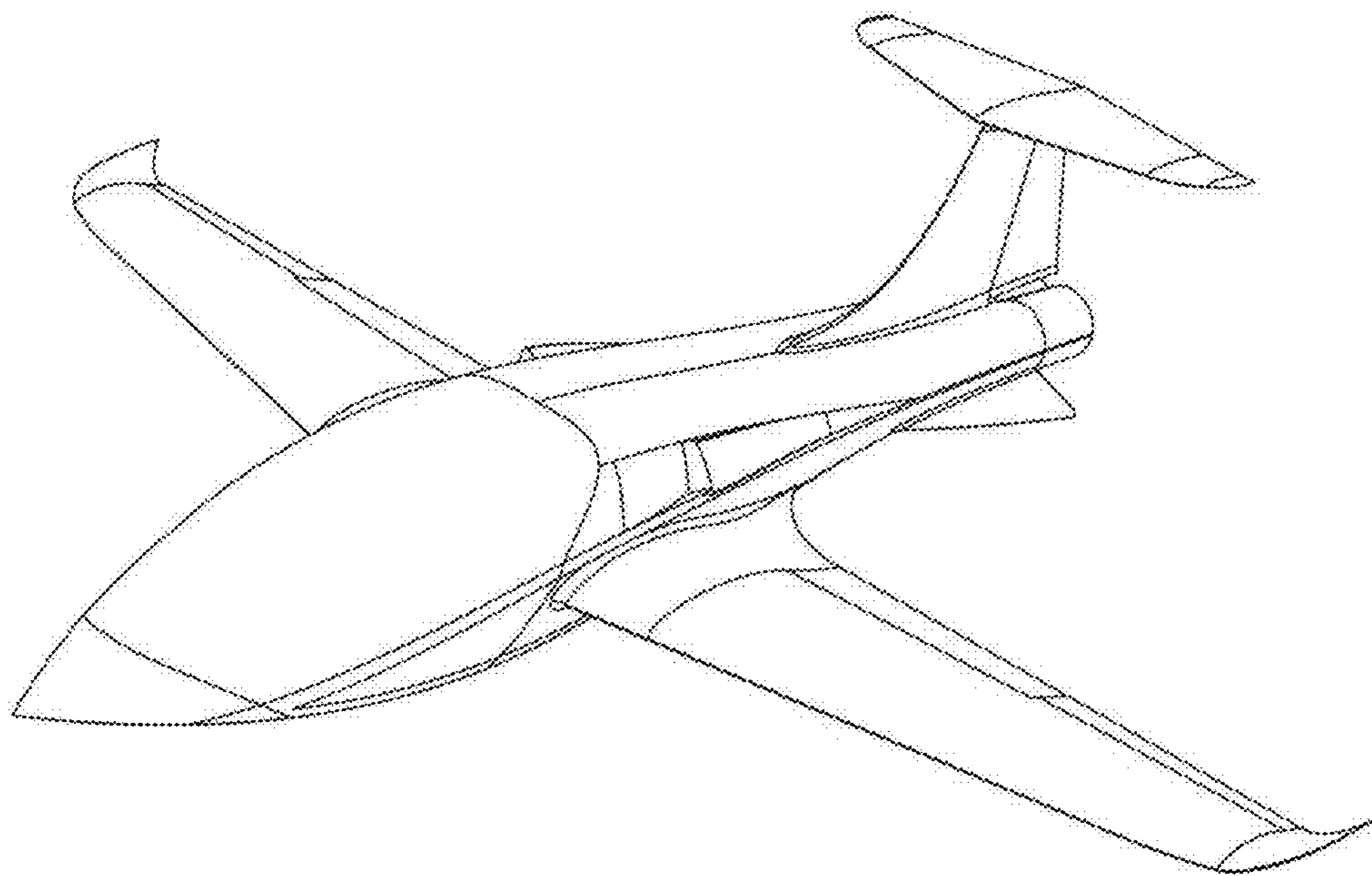

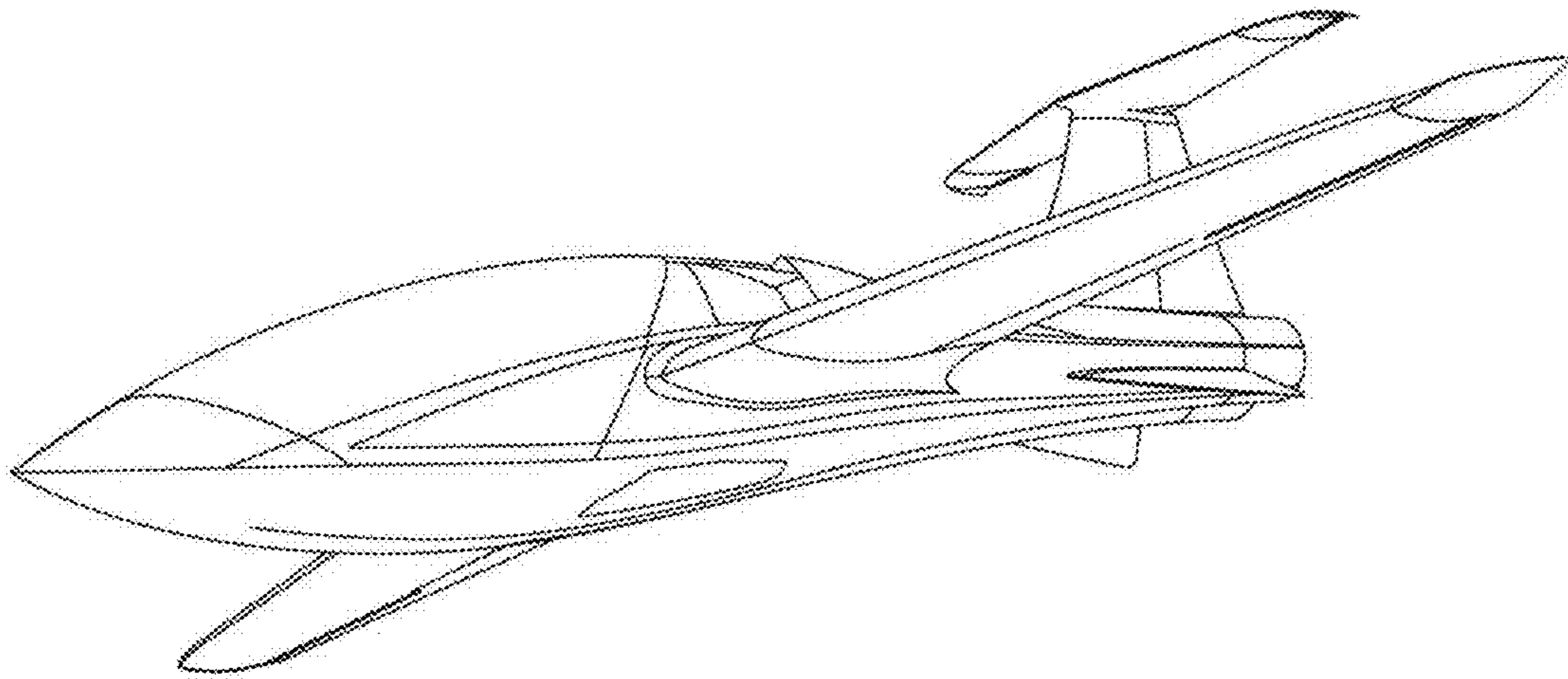

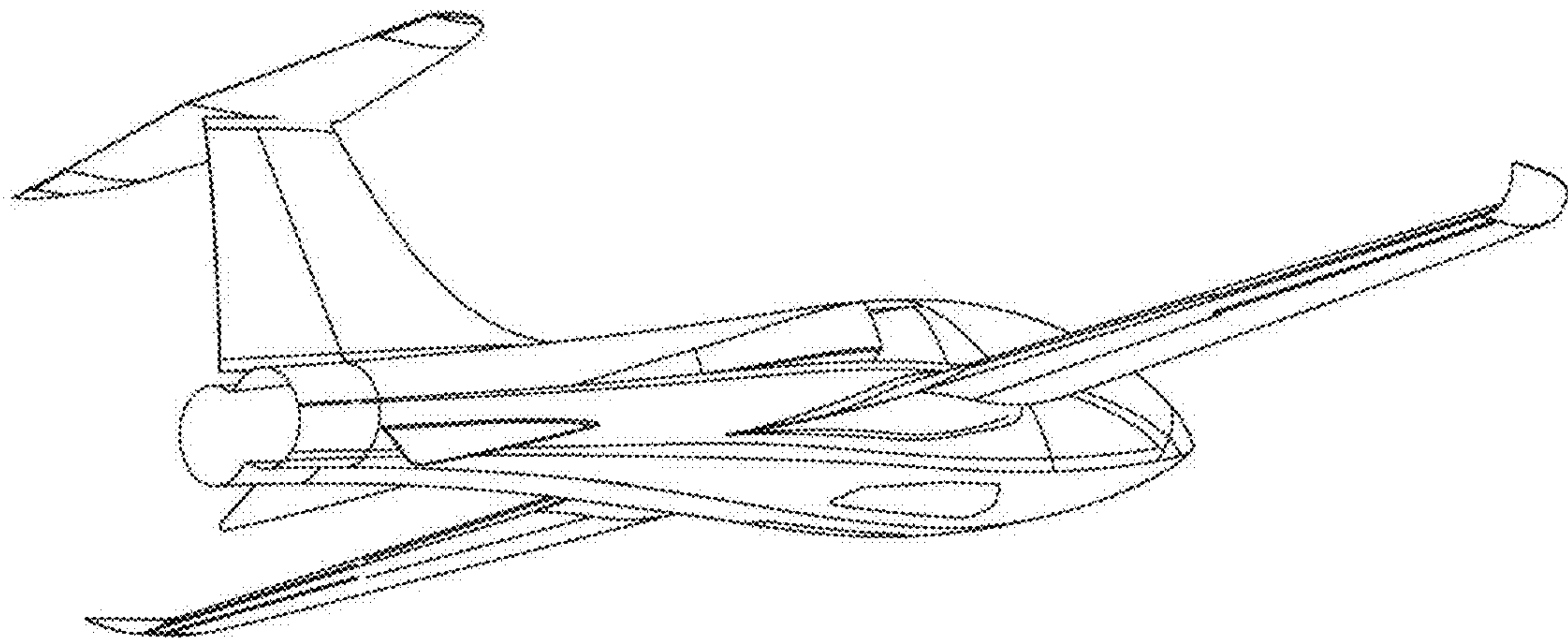

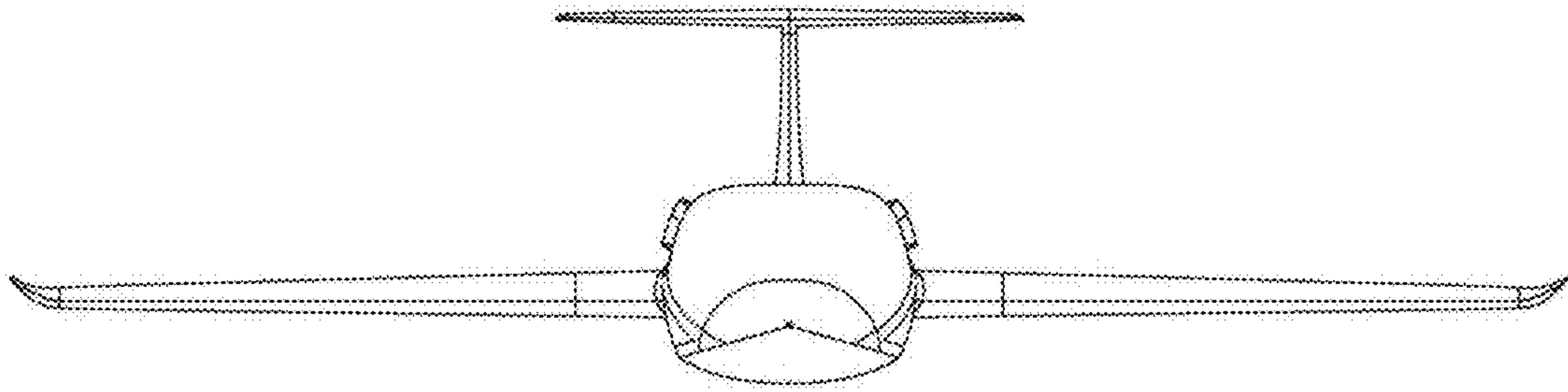

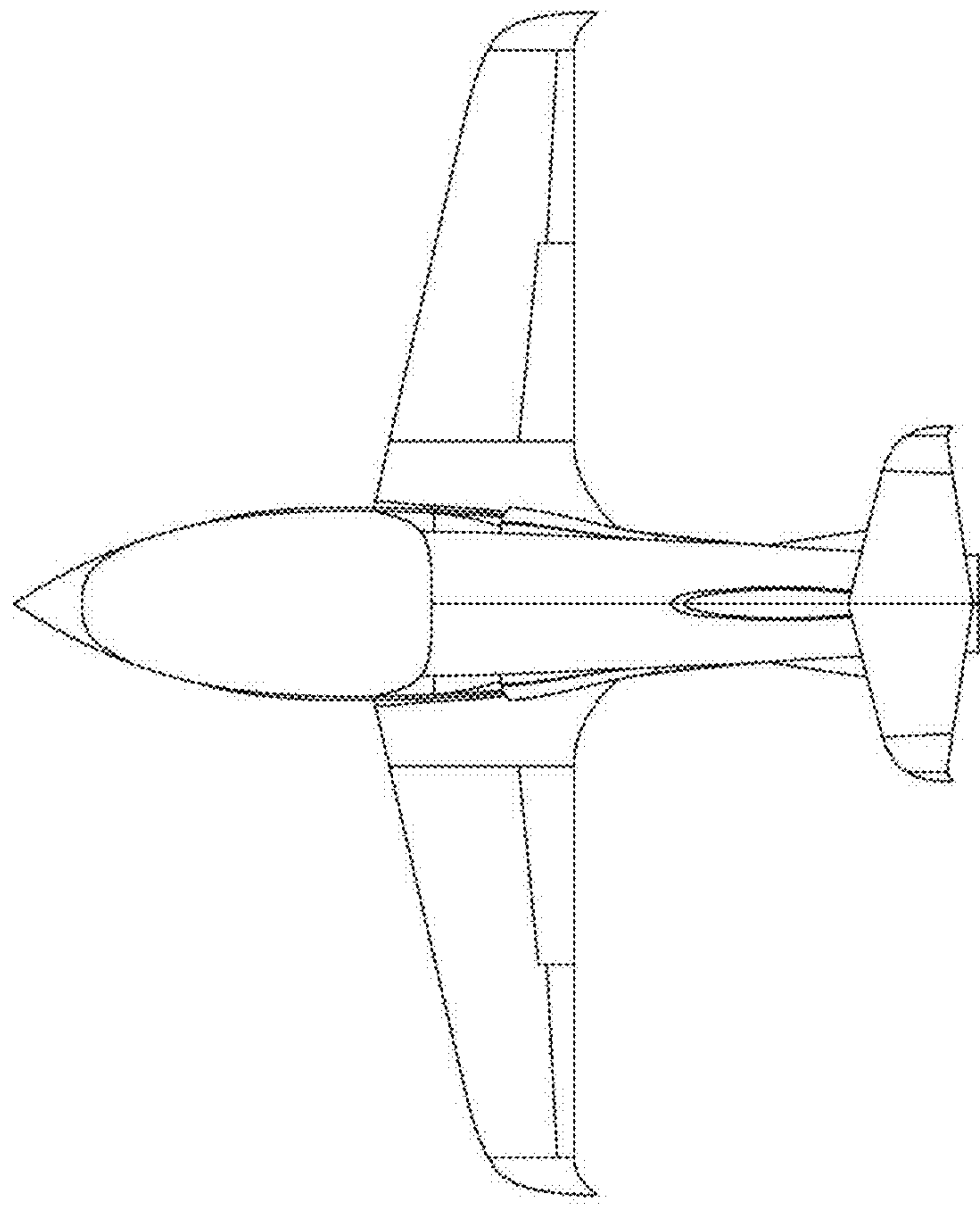

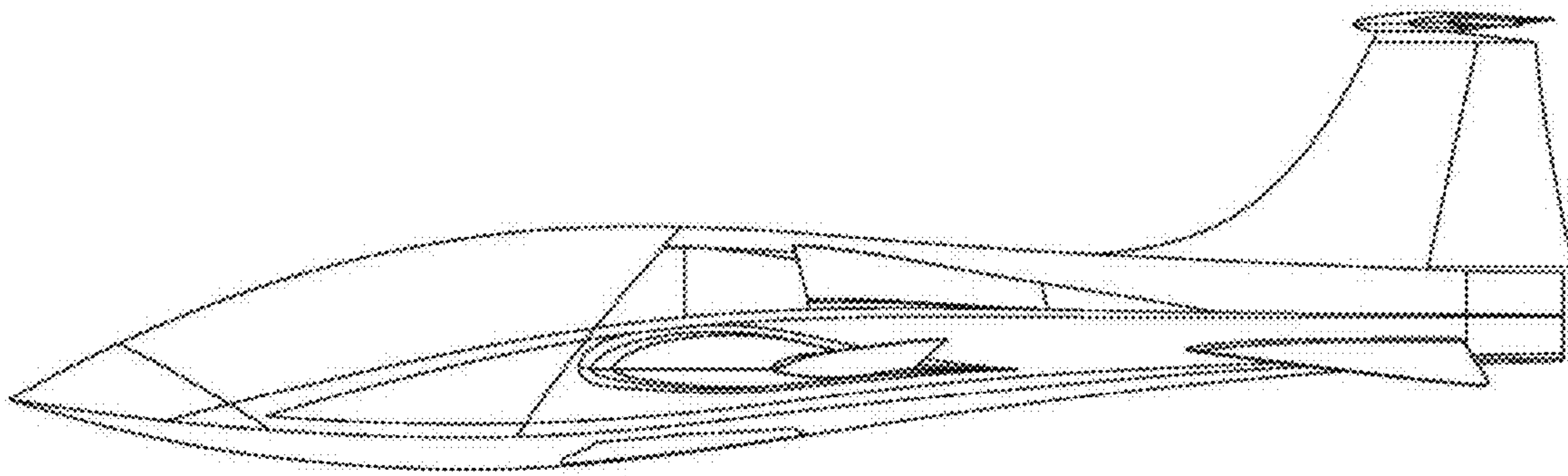

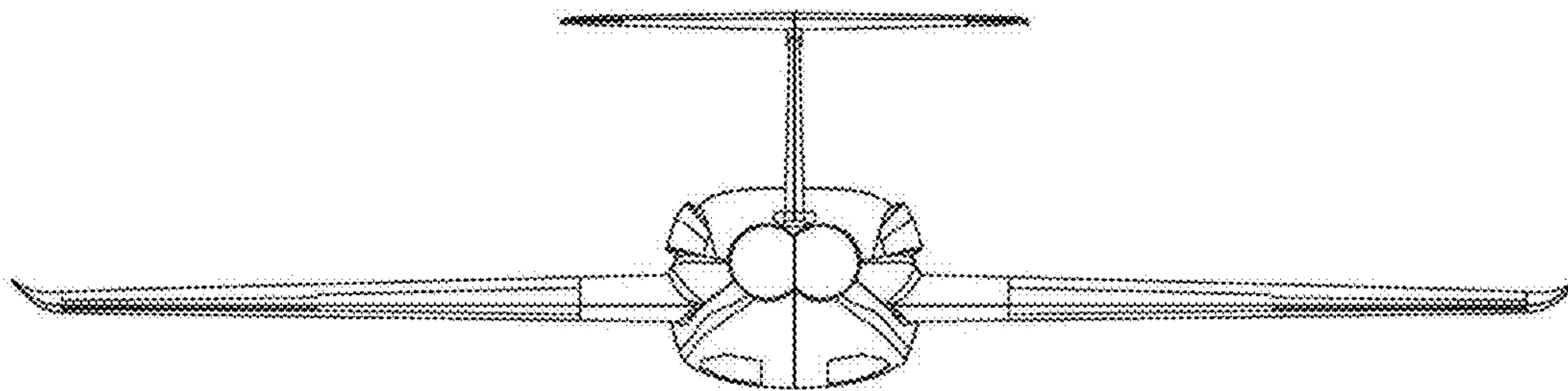

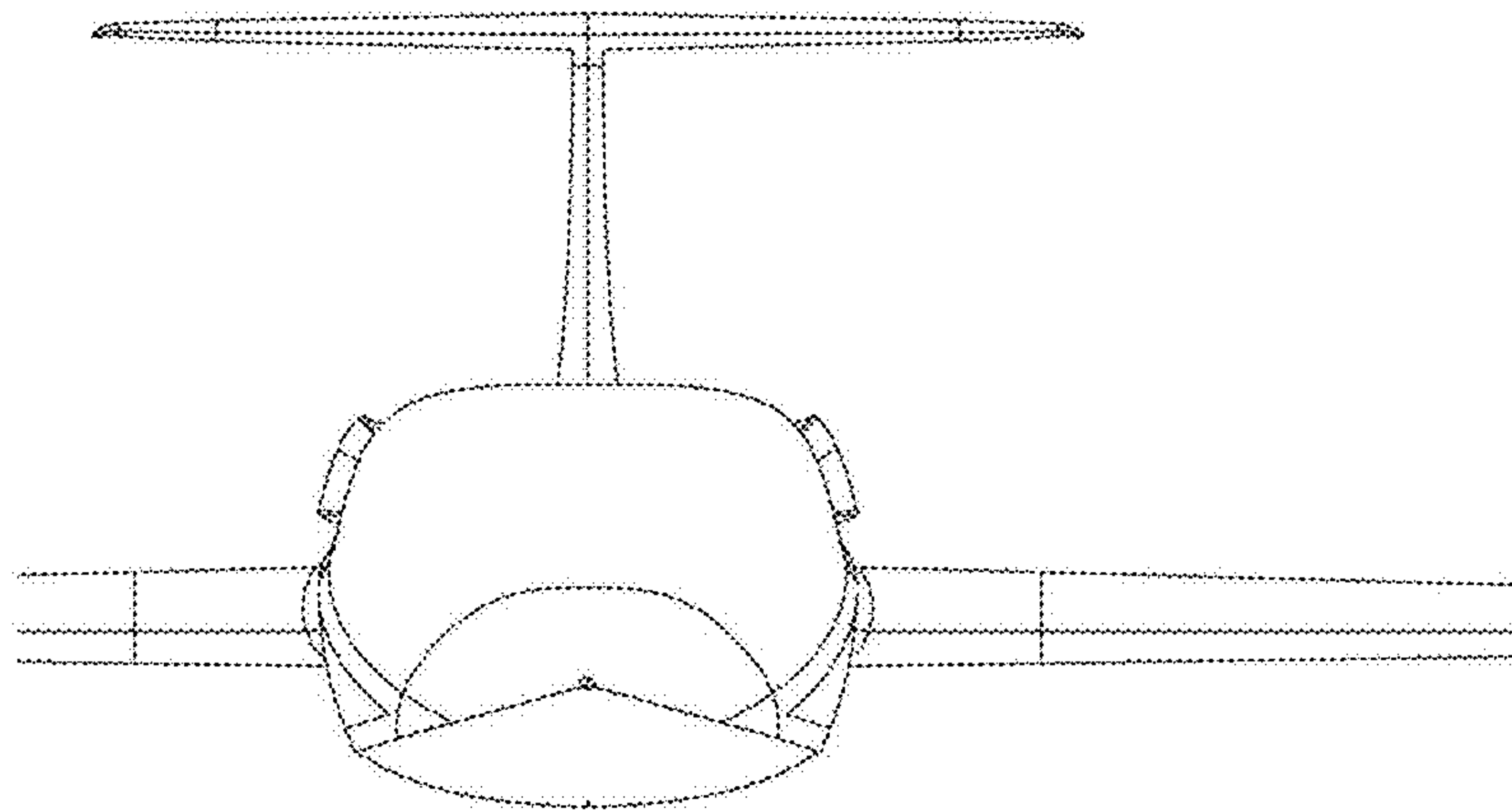
