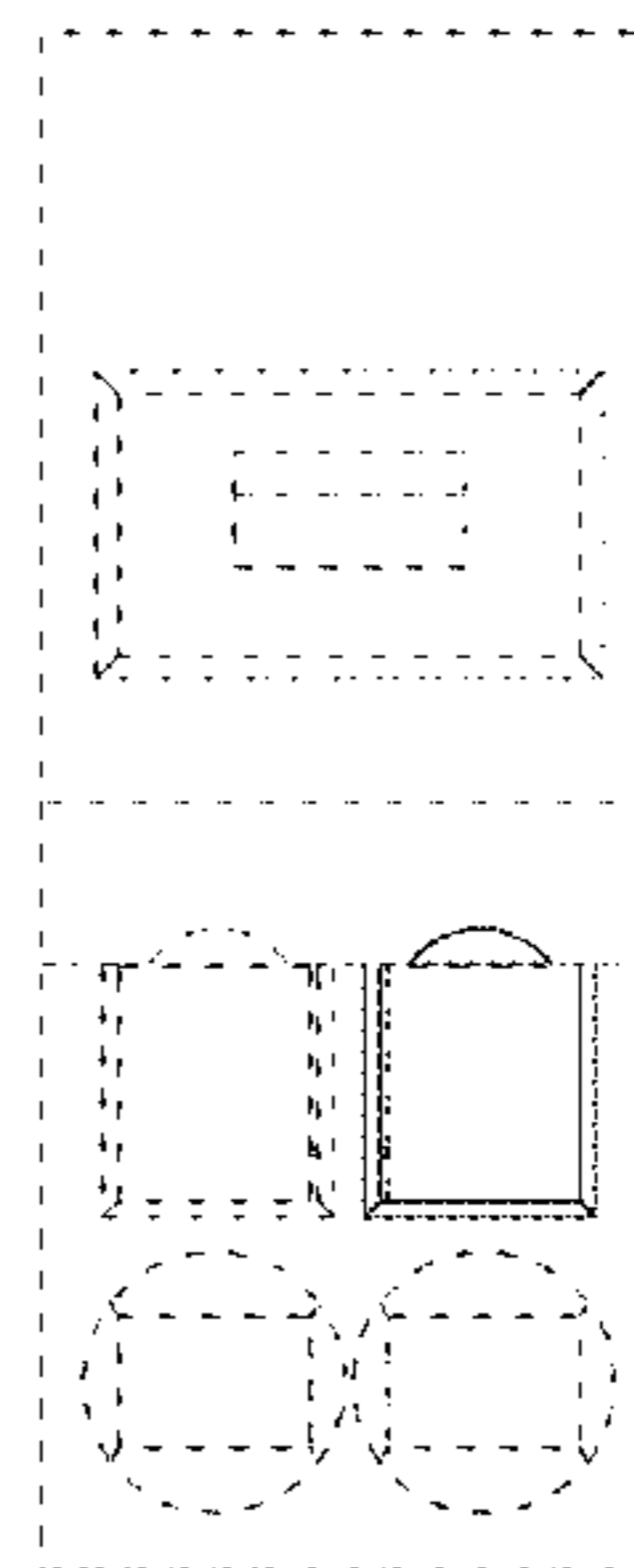
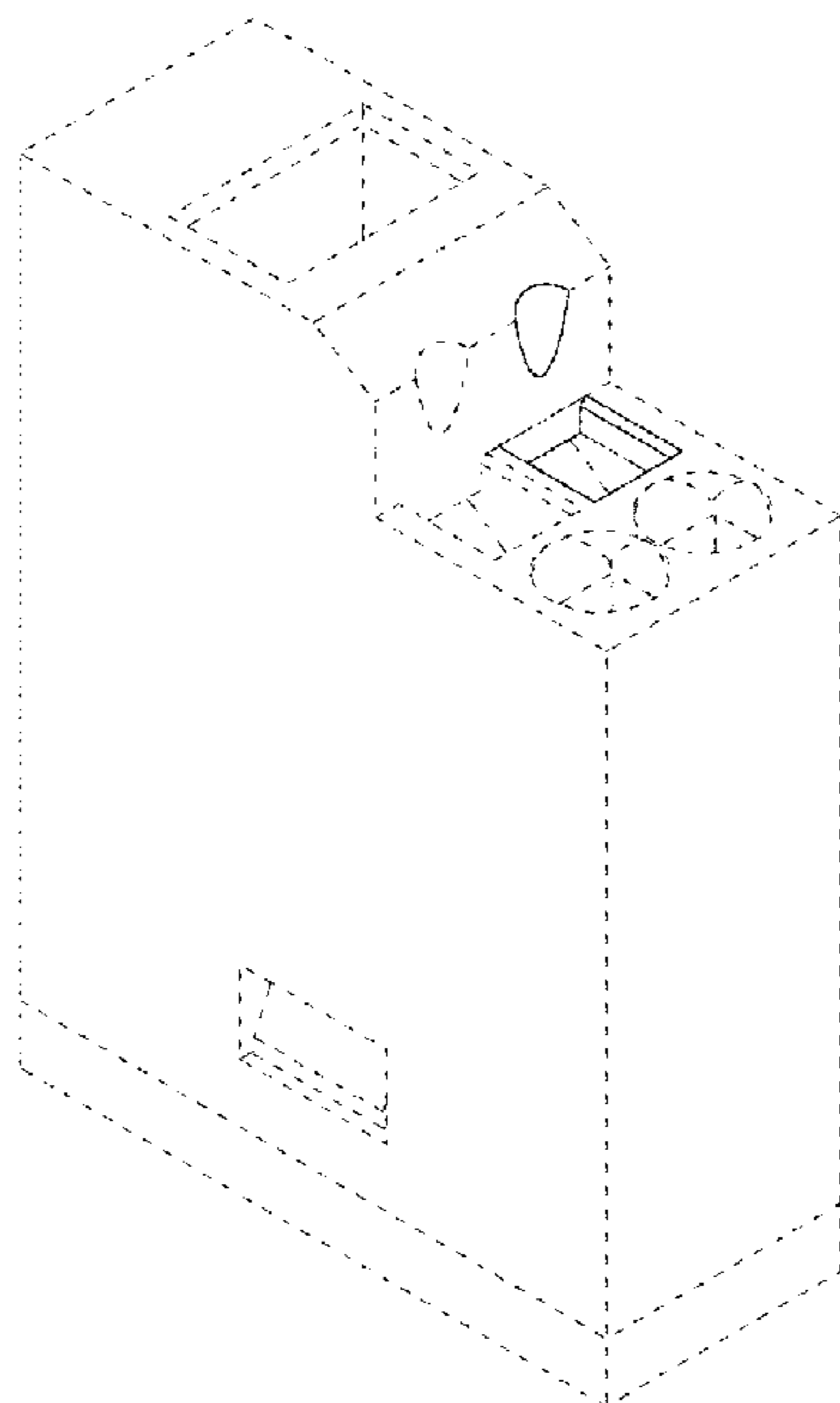
The ornamental design for a terminal block, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a terminal block showing our new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a left side view thereof;
FIG. 5 is a right side view thereof;
FIG. 6 is a top plan view thereof;
FIG. 7 is a bottom plan view thereof; and,
FIG. 8 is a cross-sectional view taken along the line VIII-VIII of FIG. 2.

The dashed broken lines in the figures show portions of the terminal block that form no part of the claimed design. The dot-dash broken lines in the figures show boundaries of the claimed design.

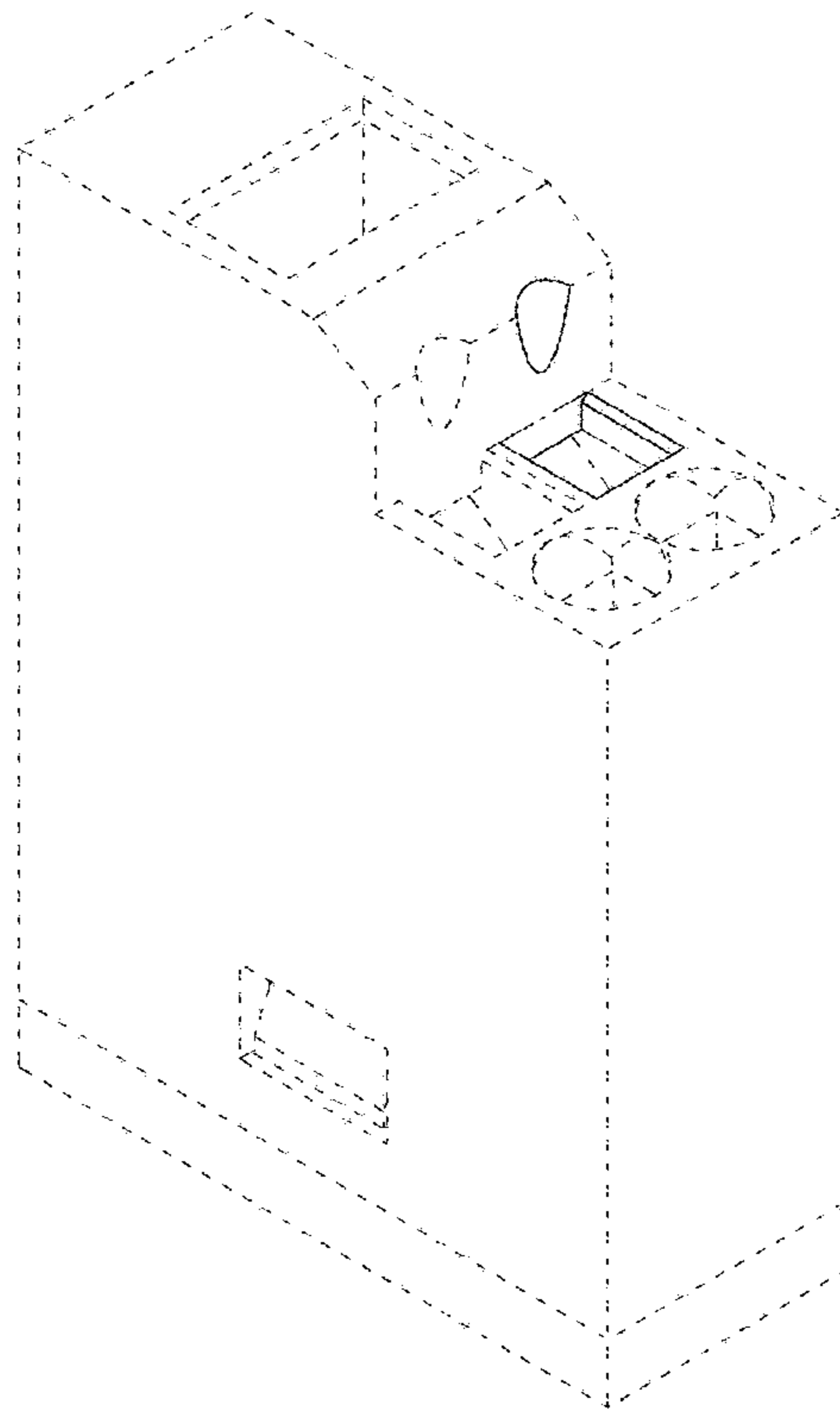

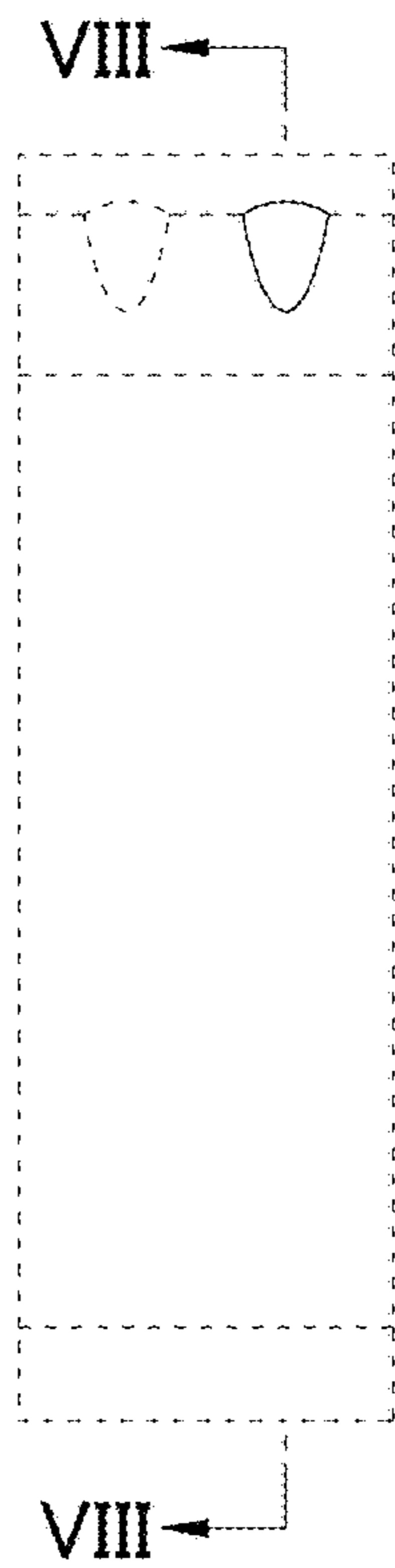

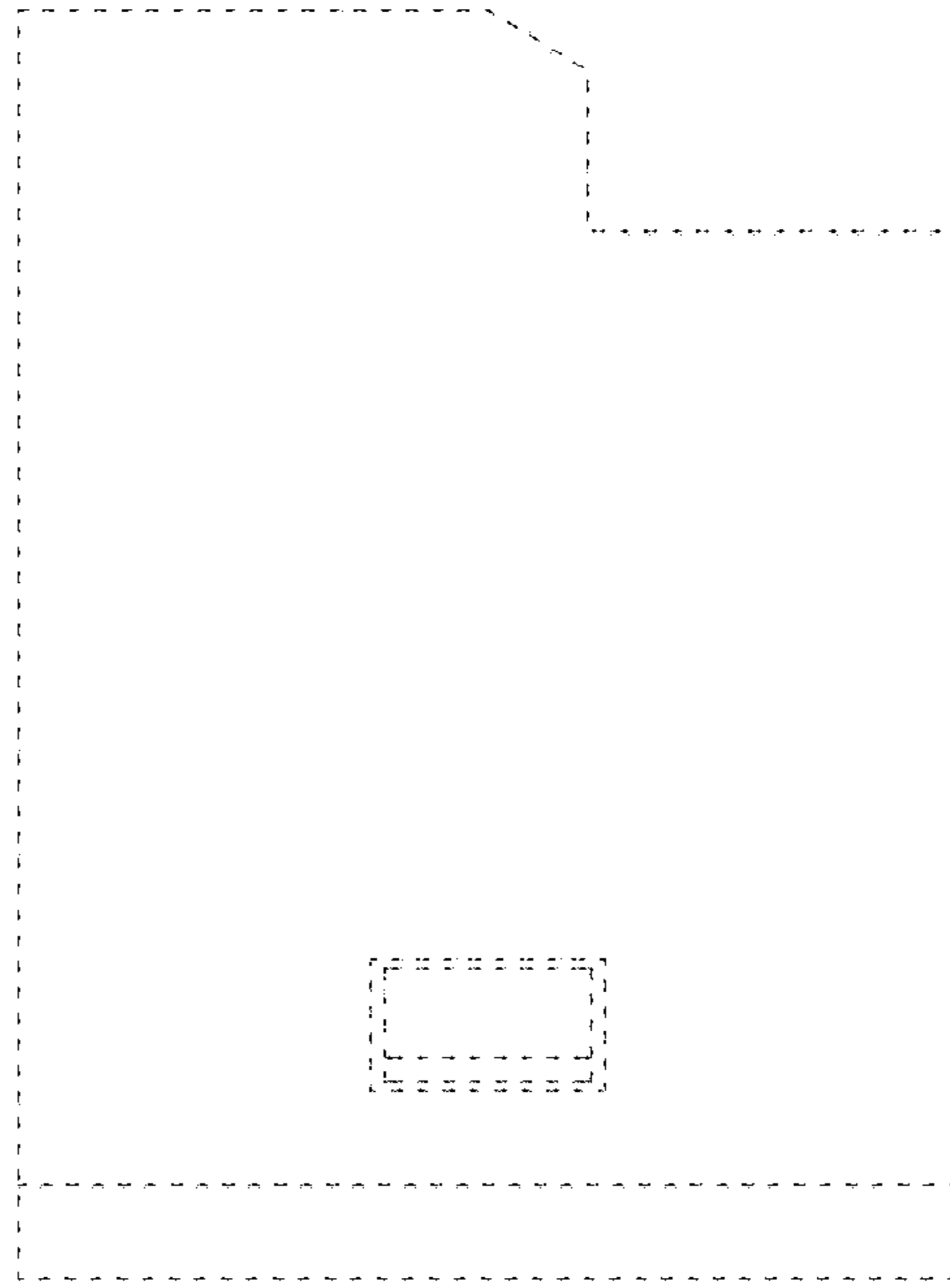

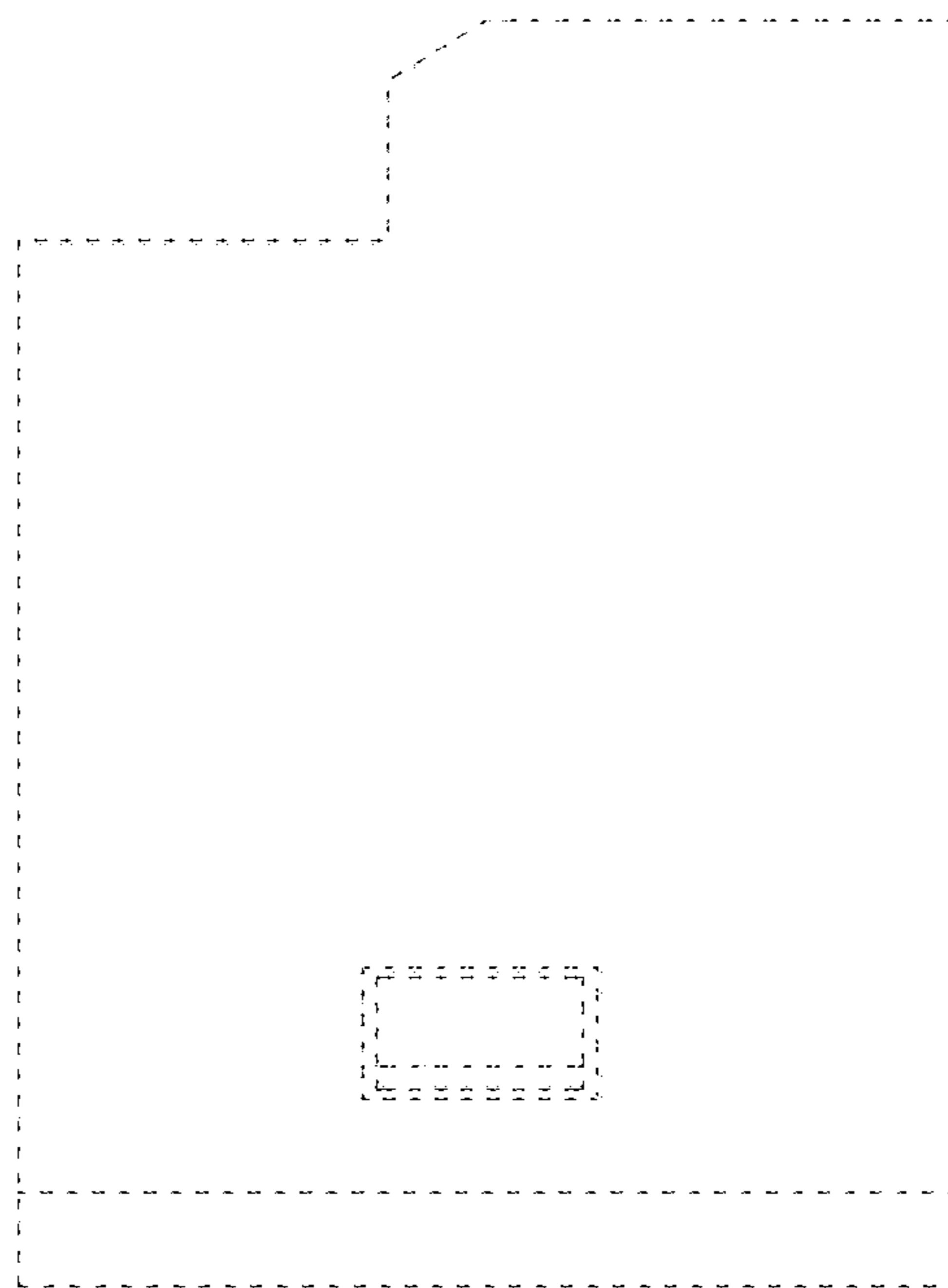

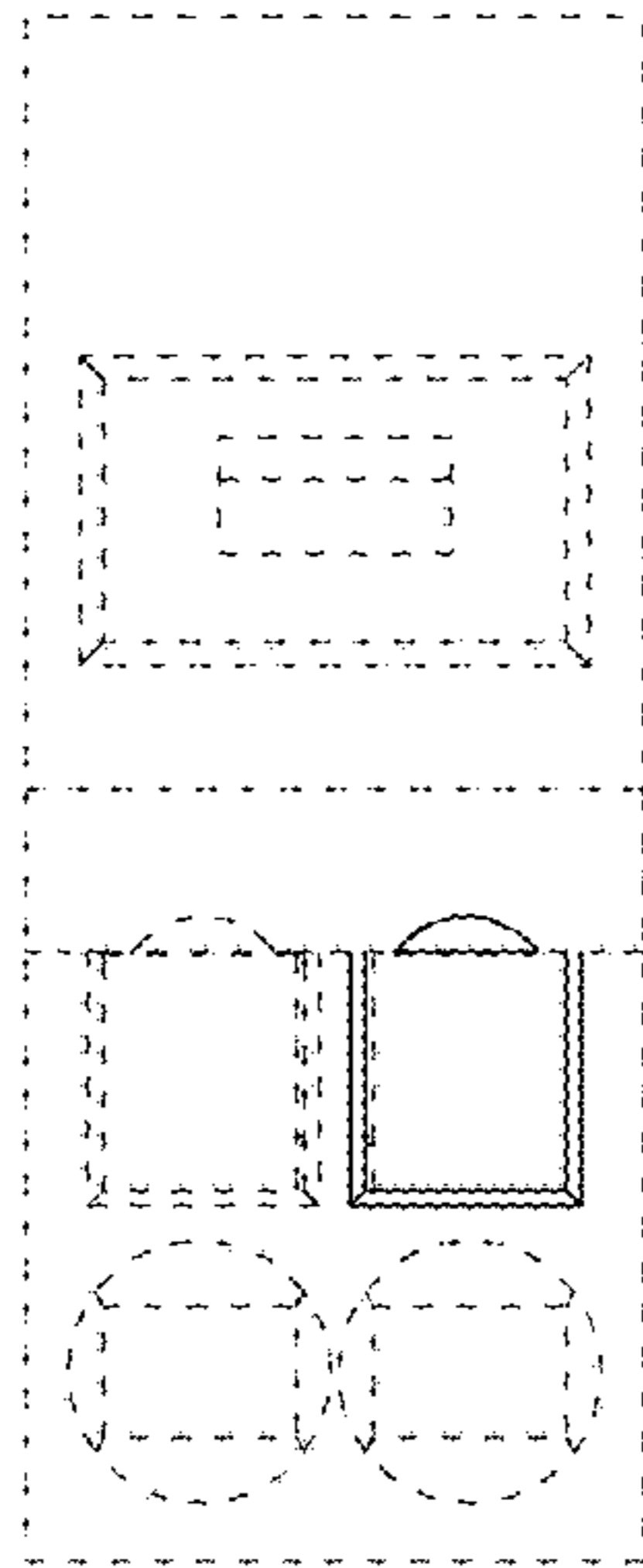

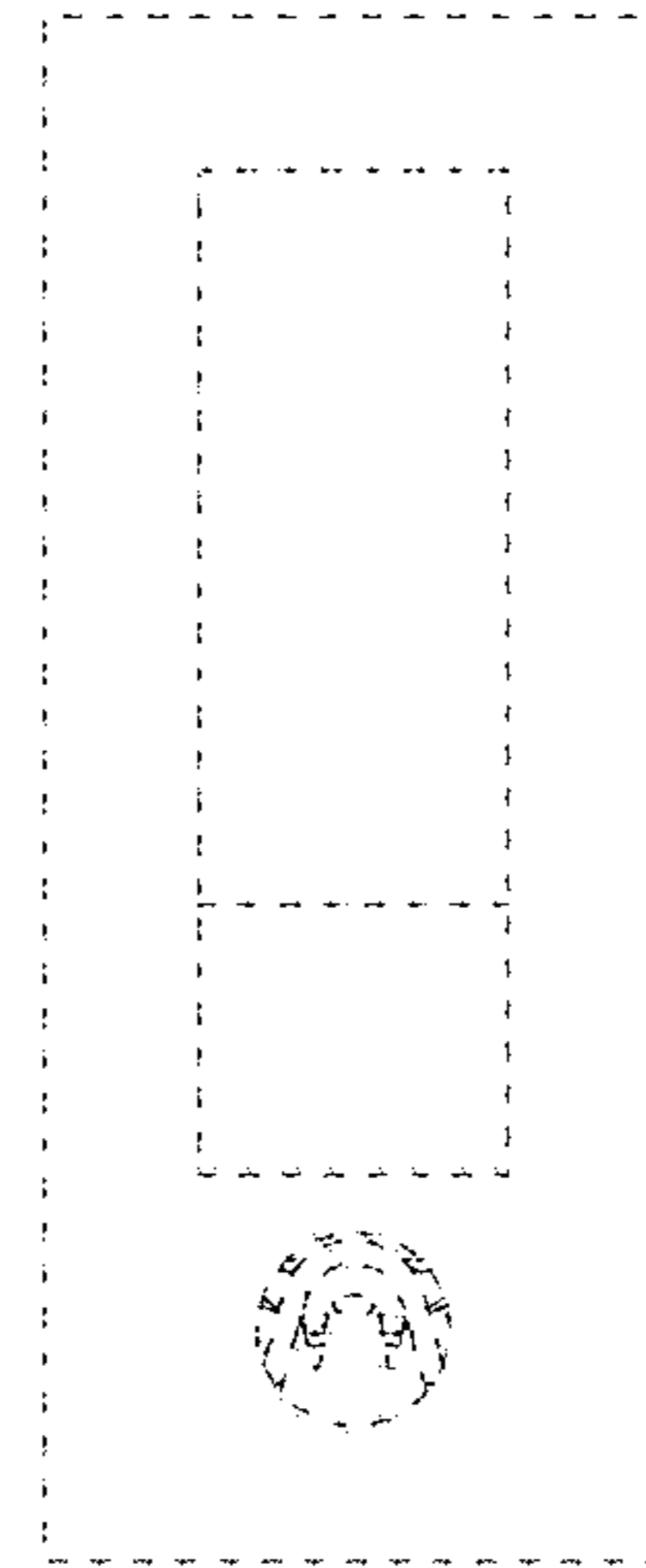

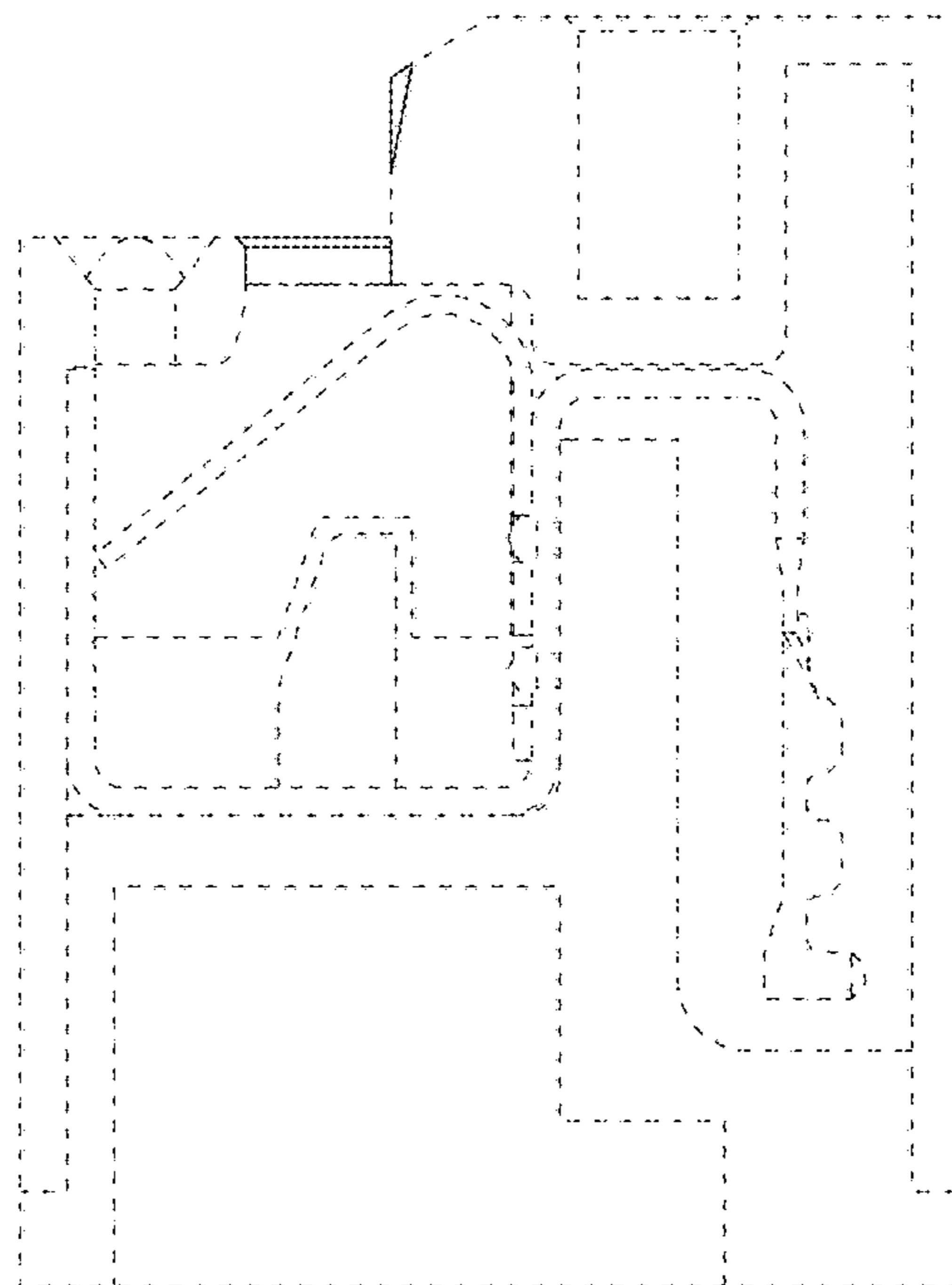
