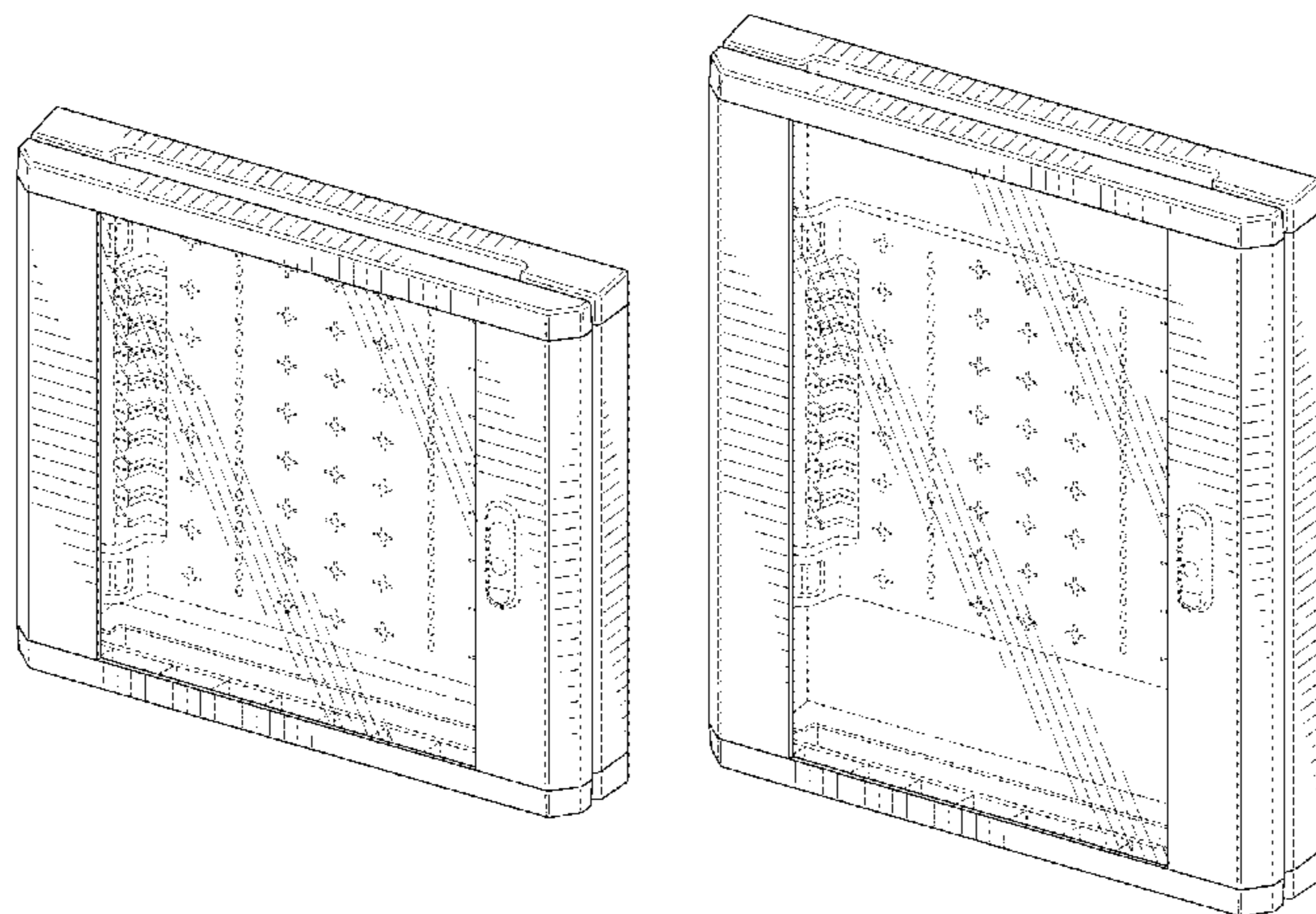
The ornamental design for an enclosure door, as shown and described.

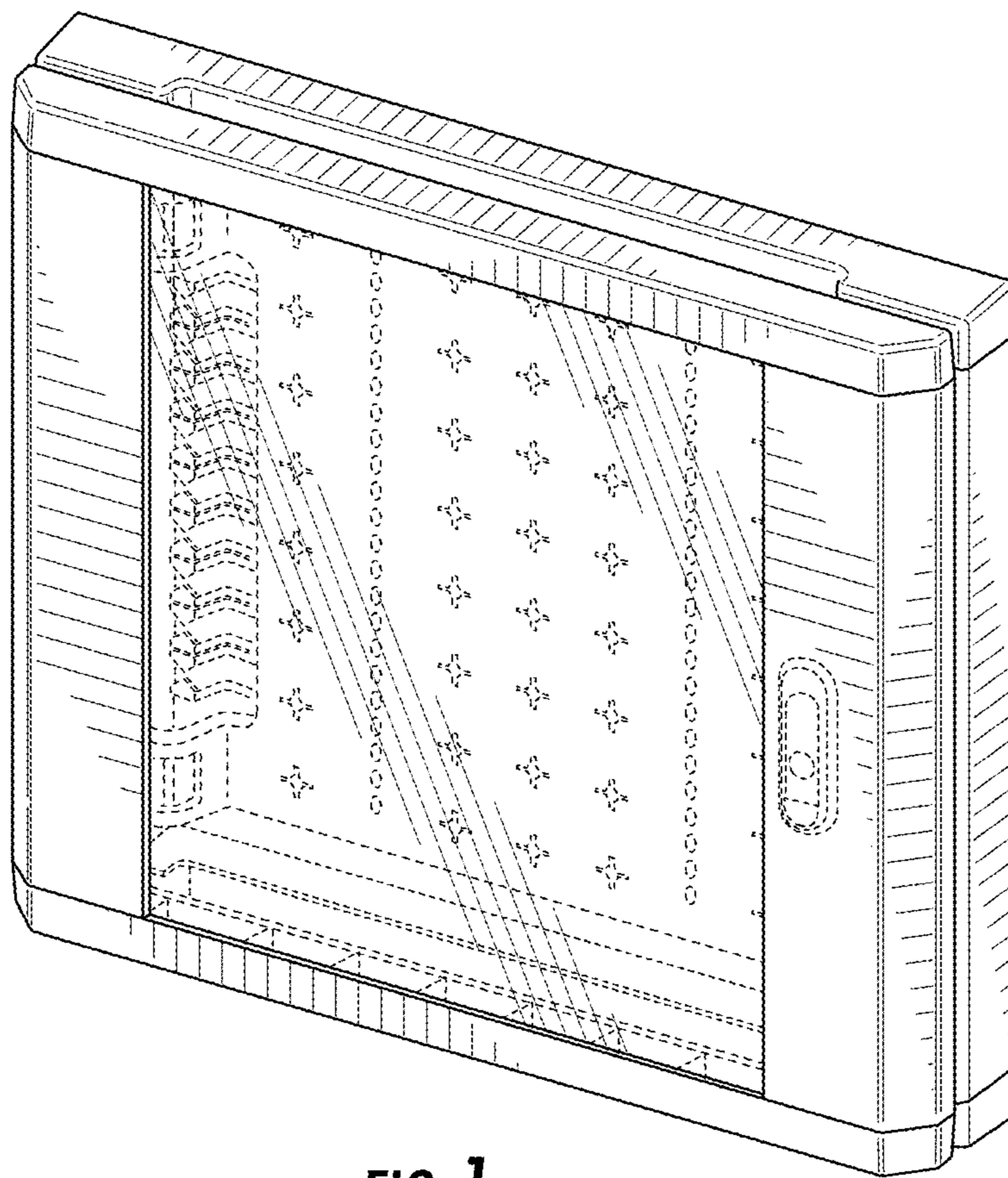

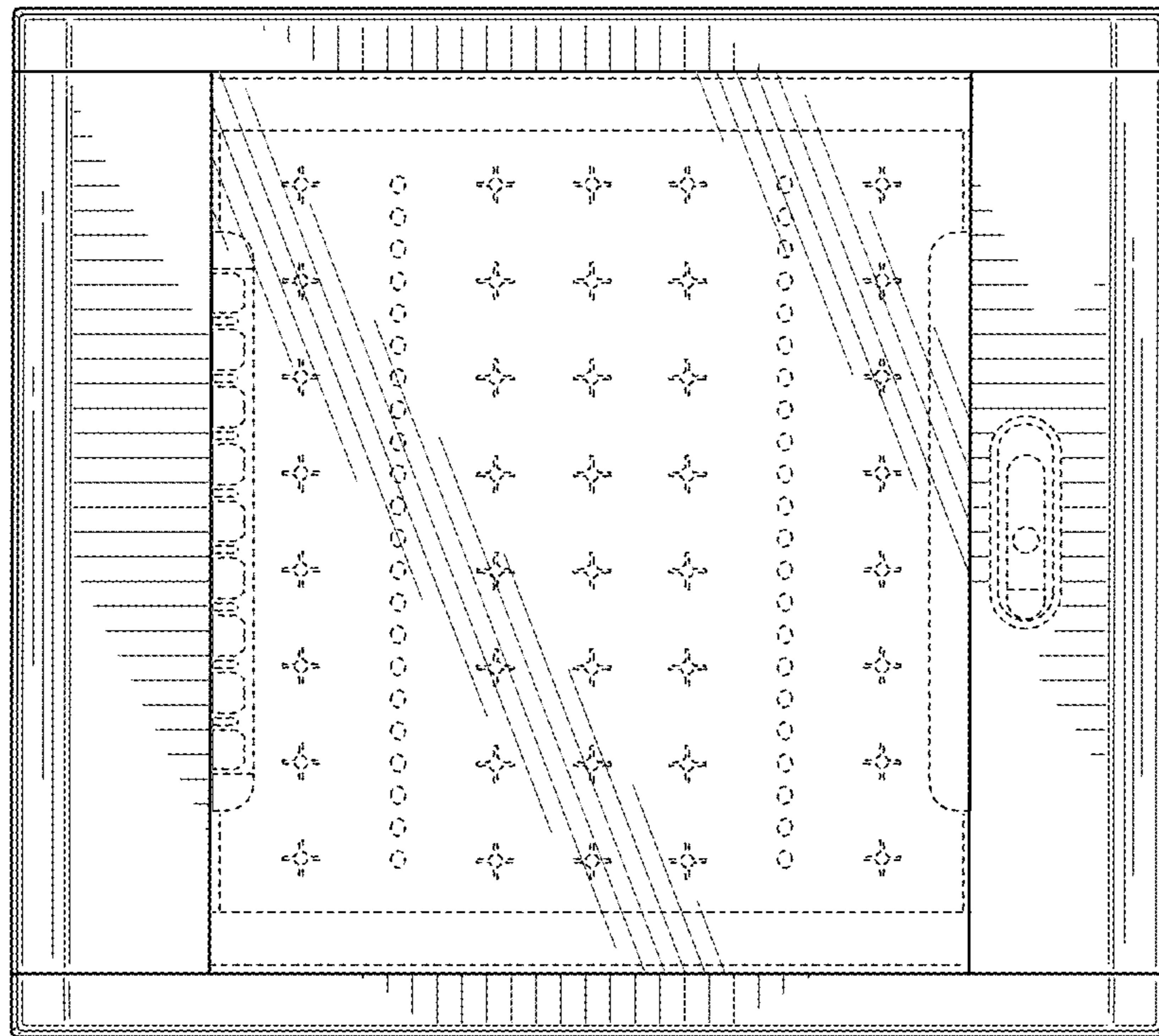

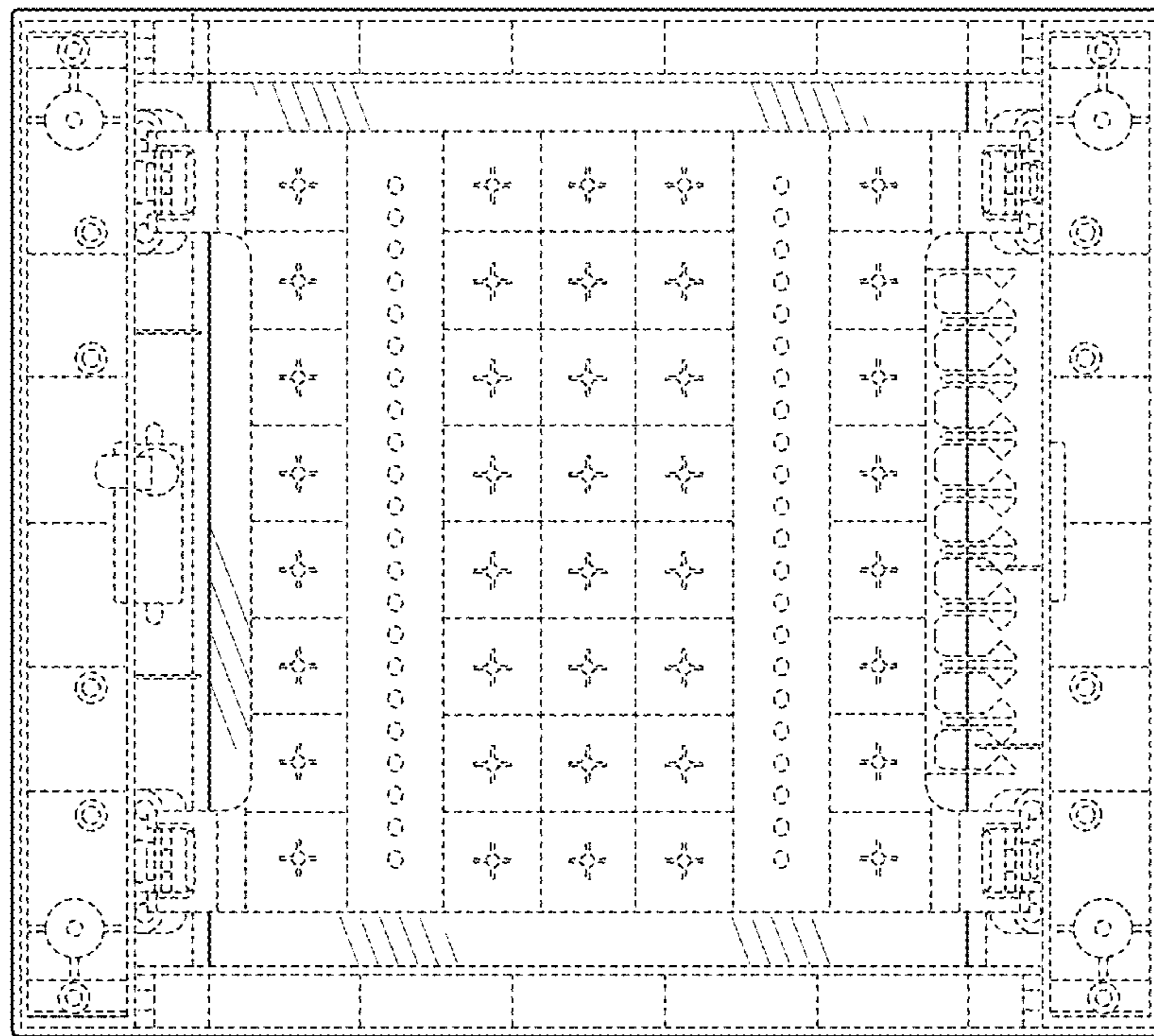

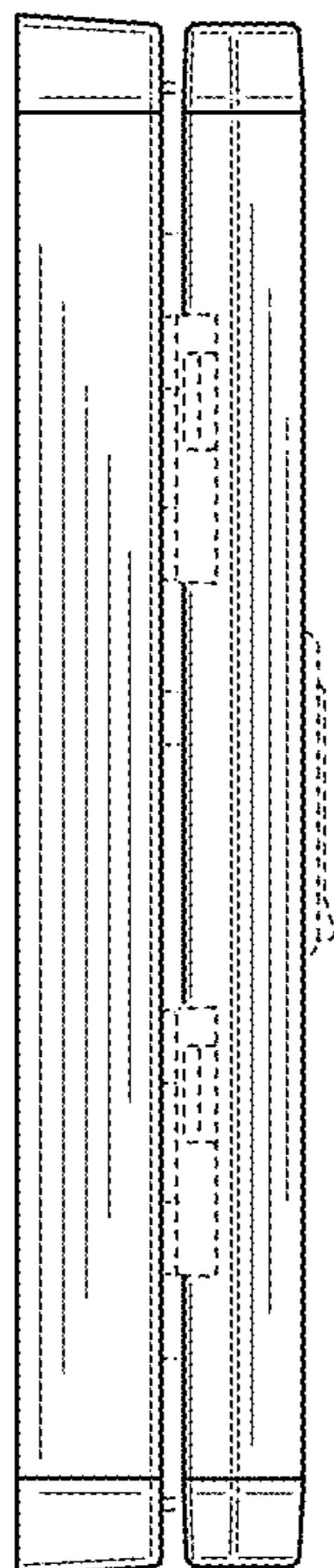

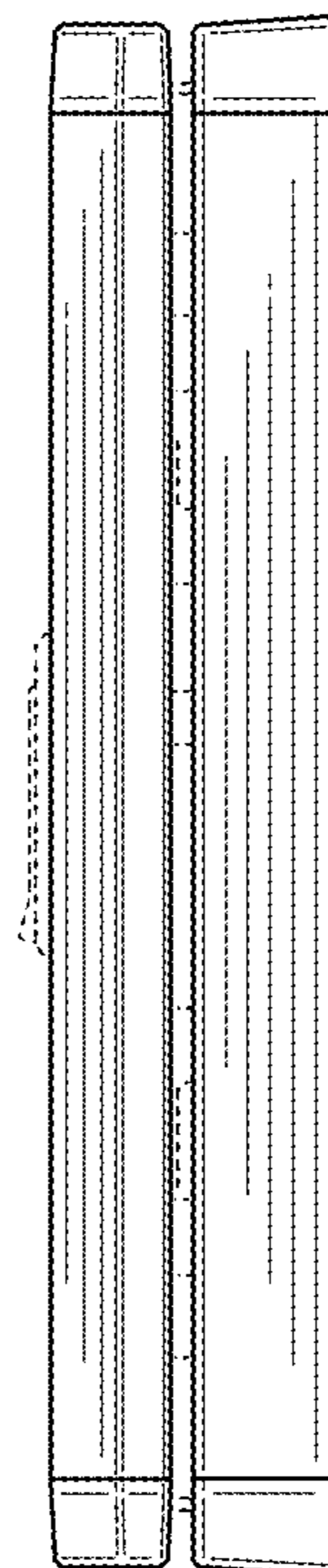

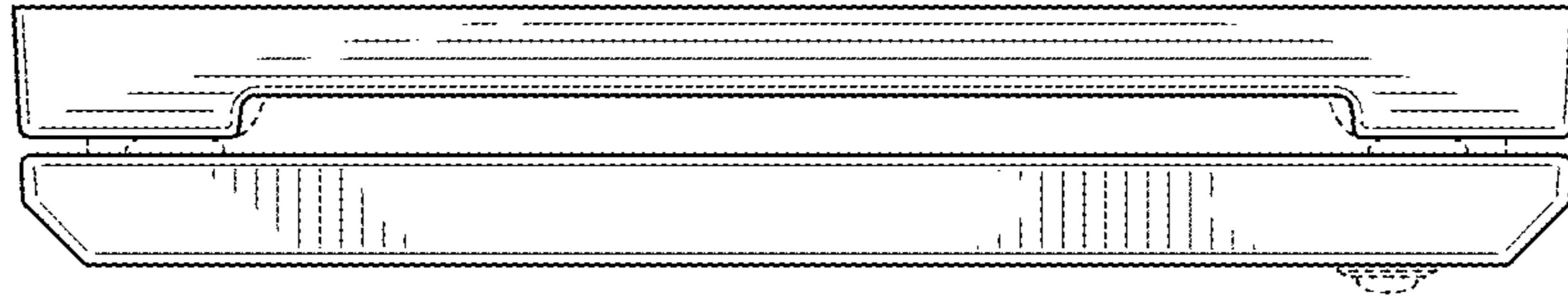

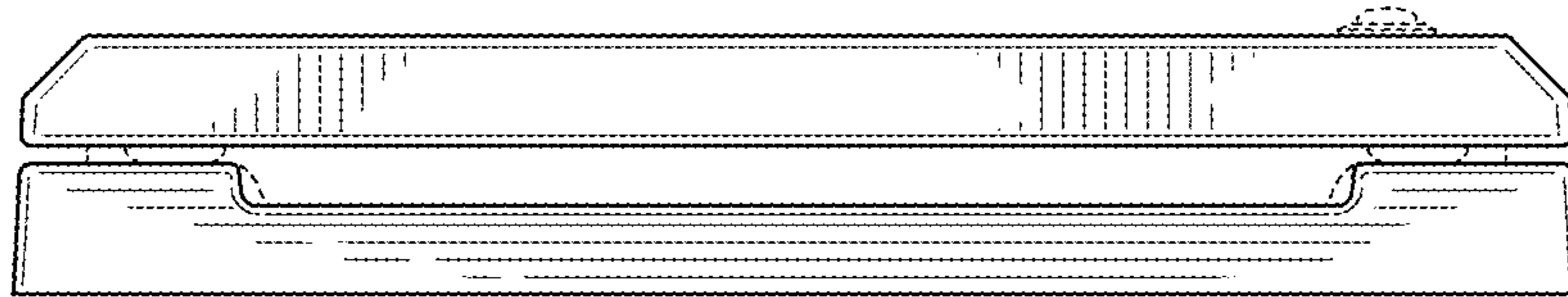

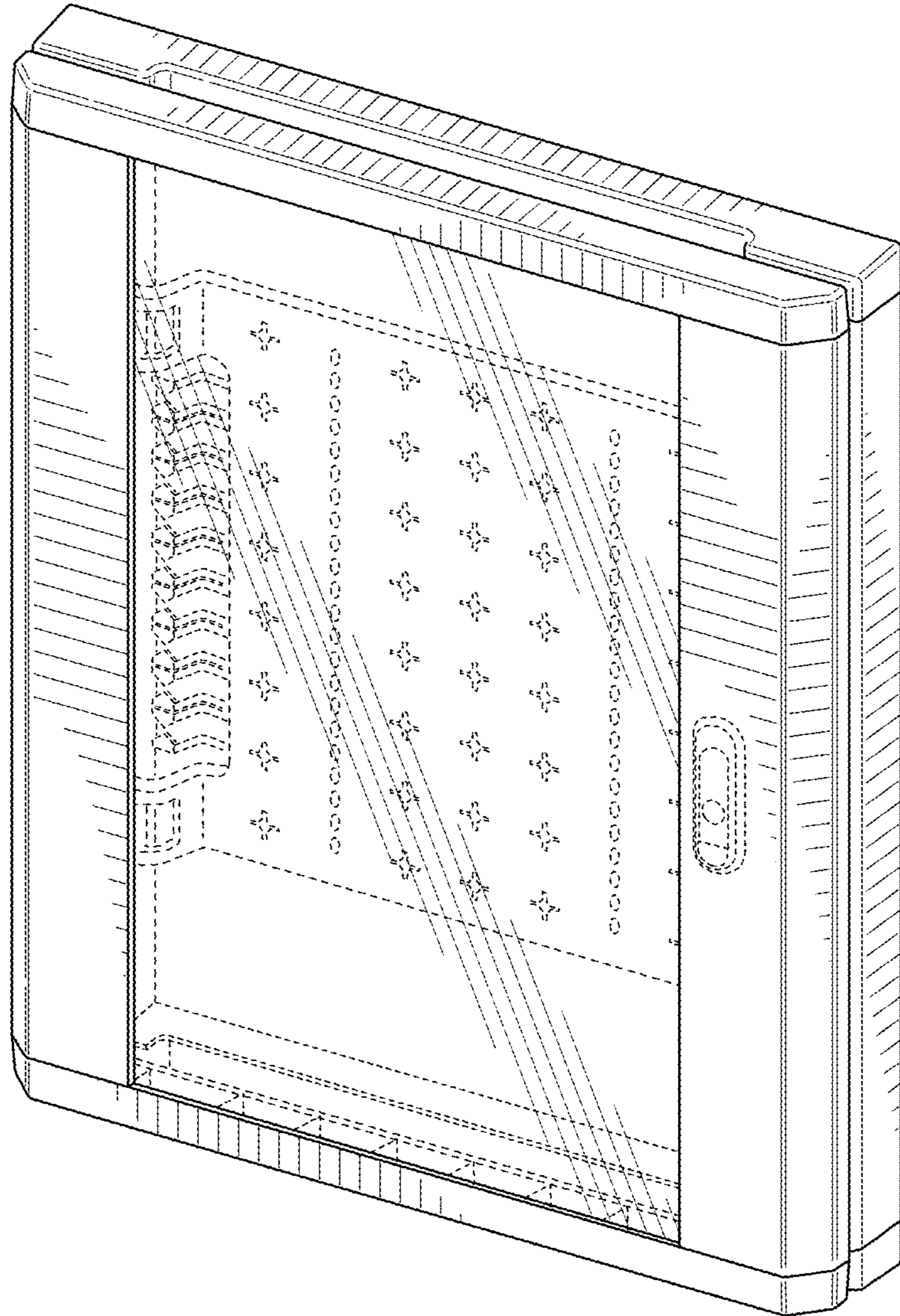

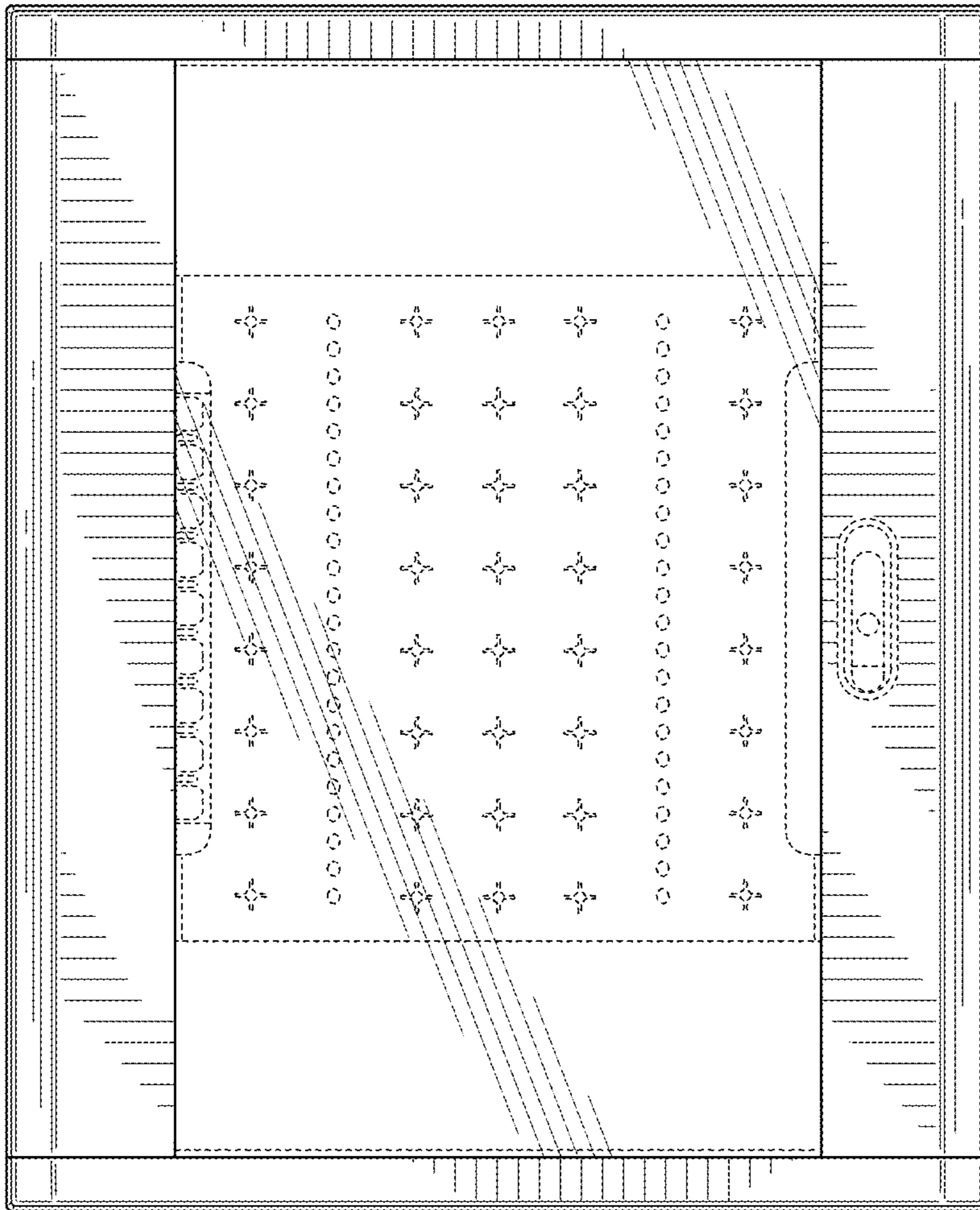

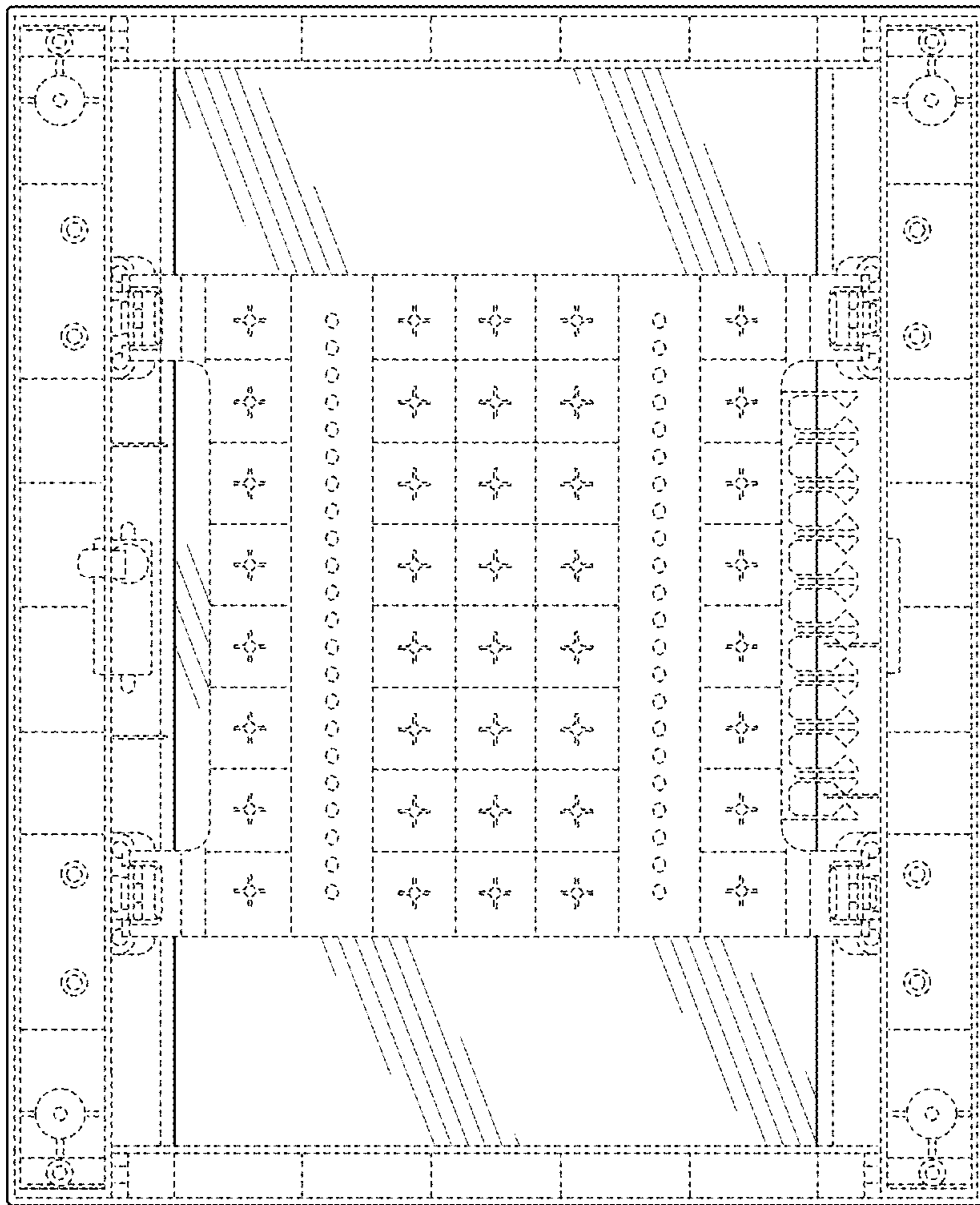

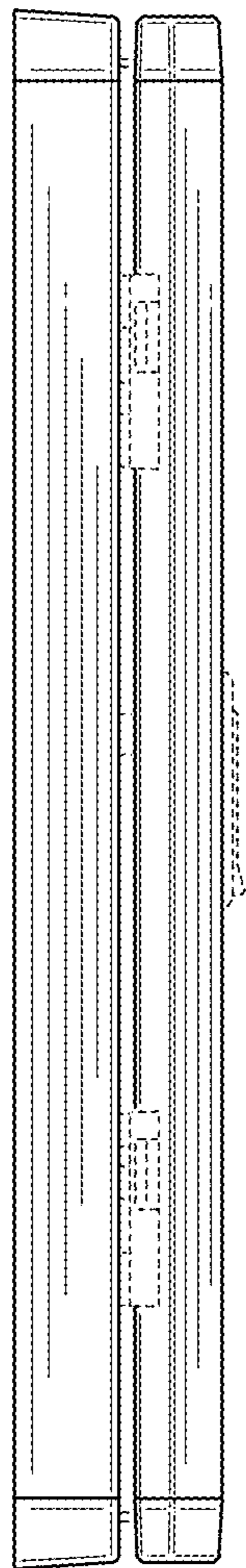

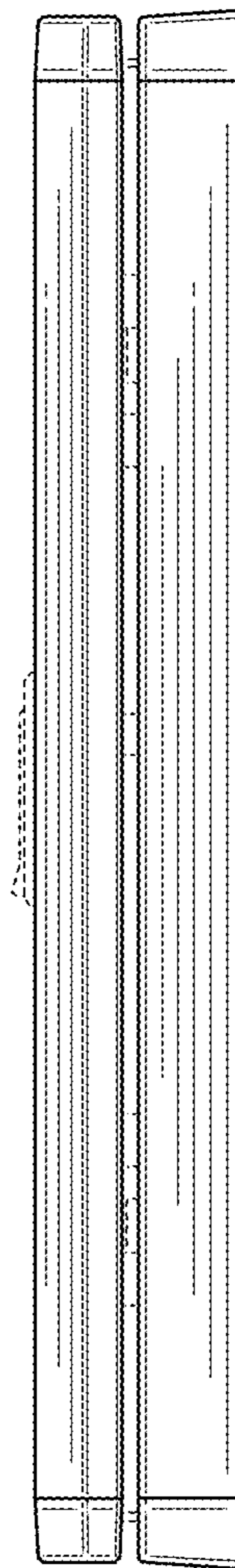

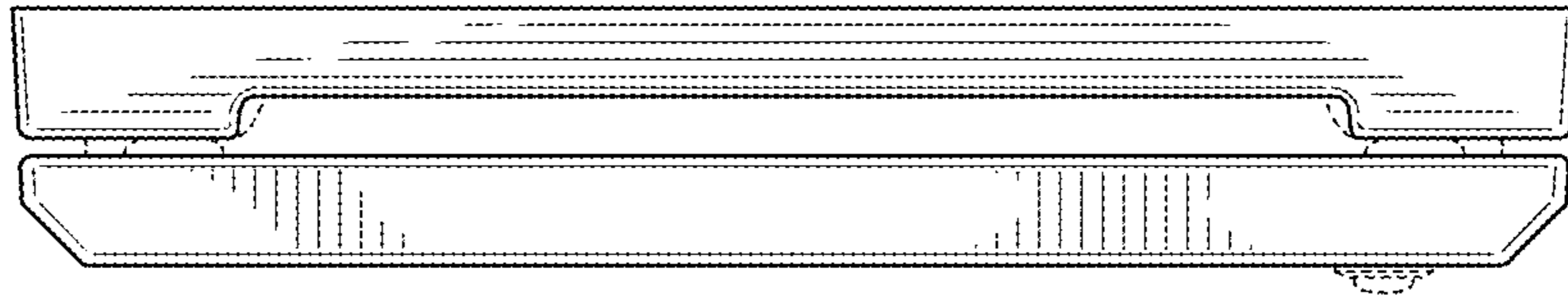

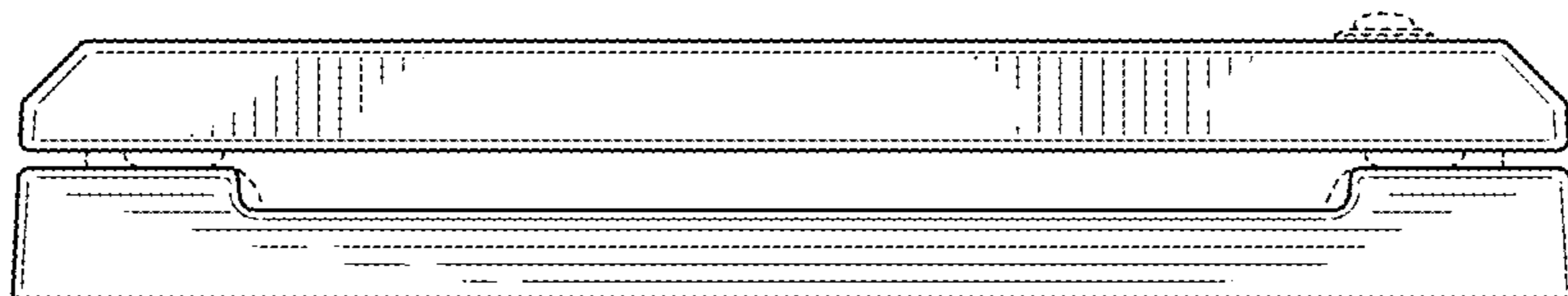

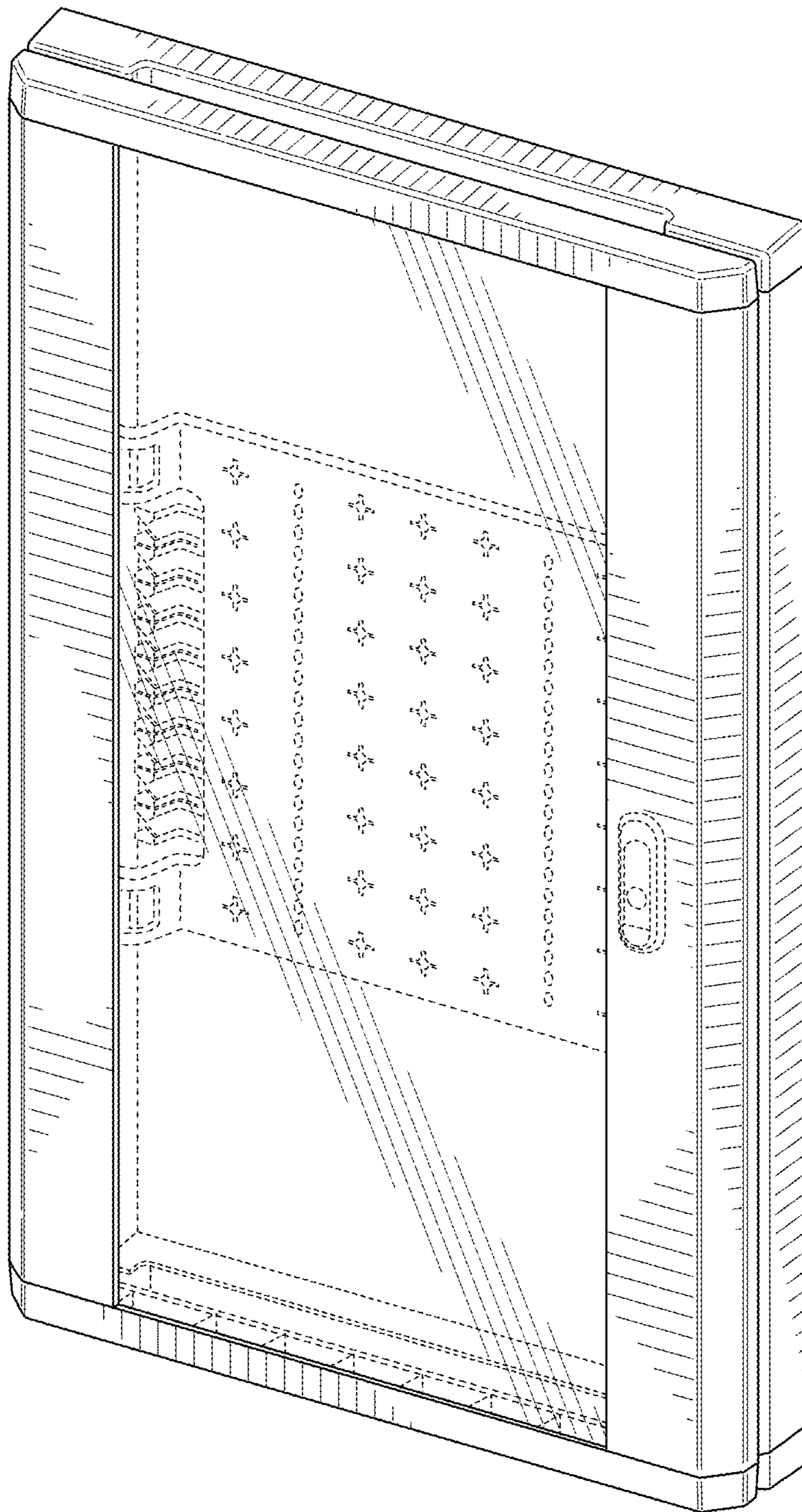

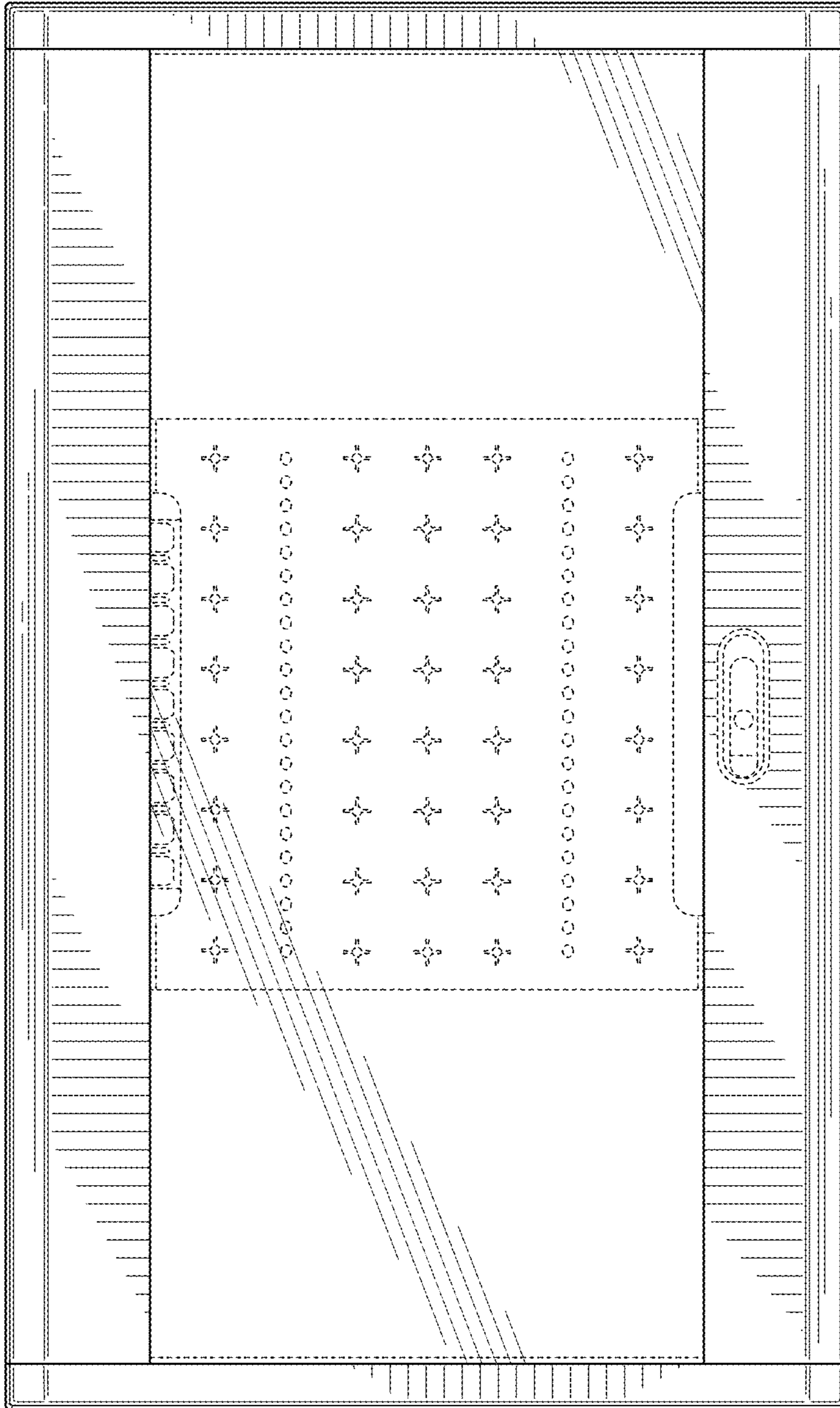

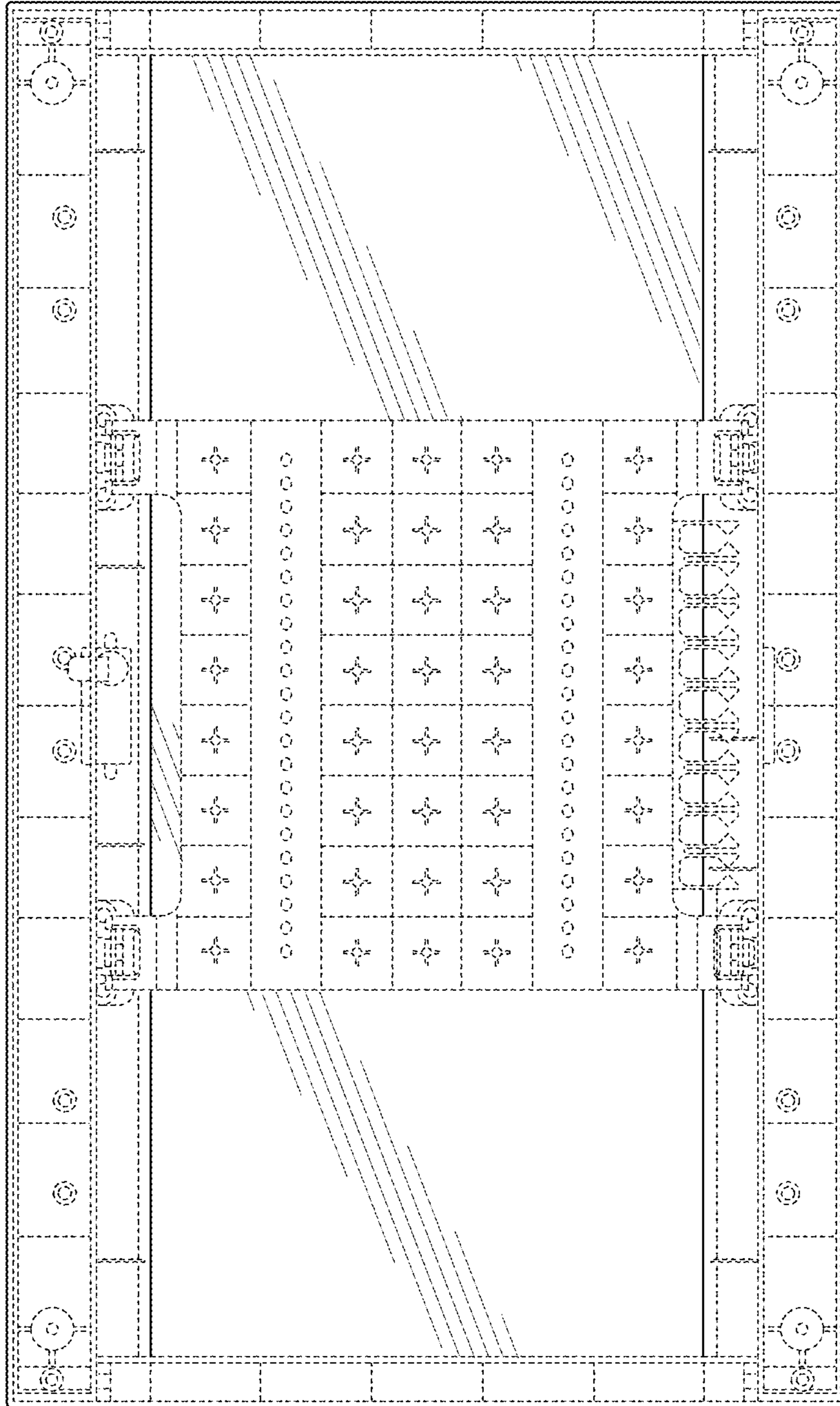

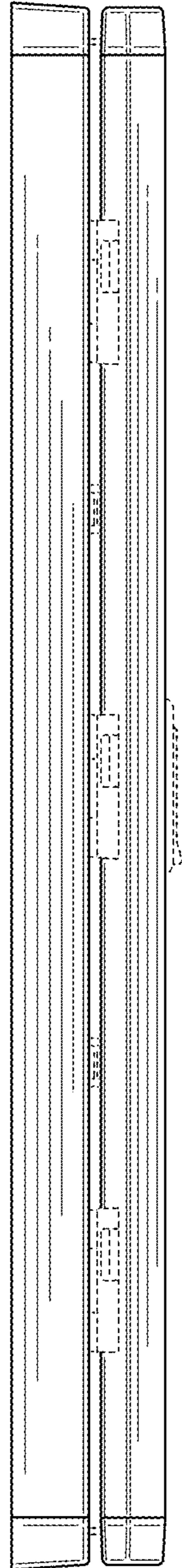

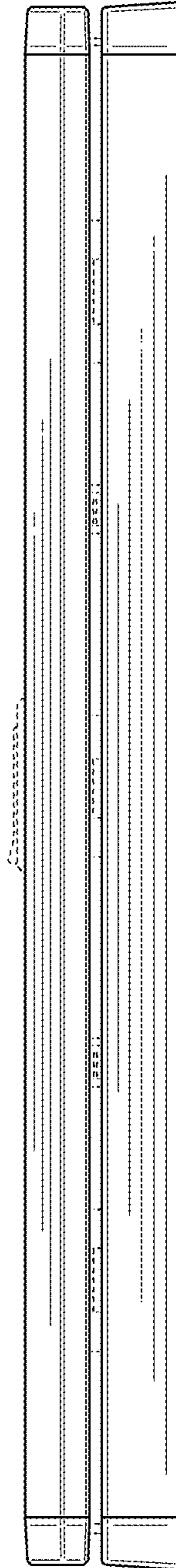

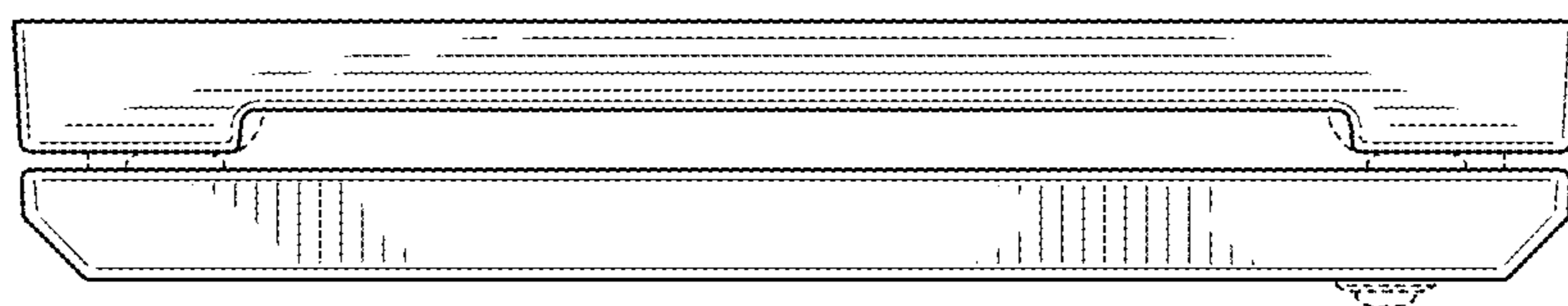

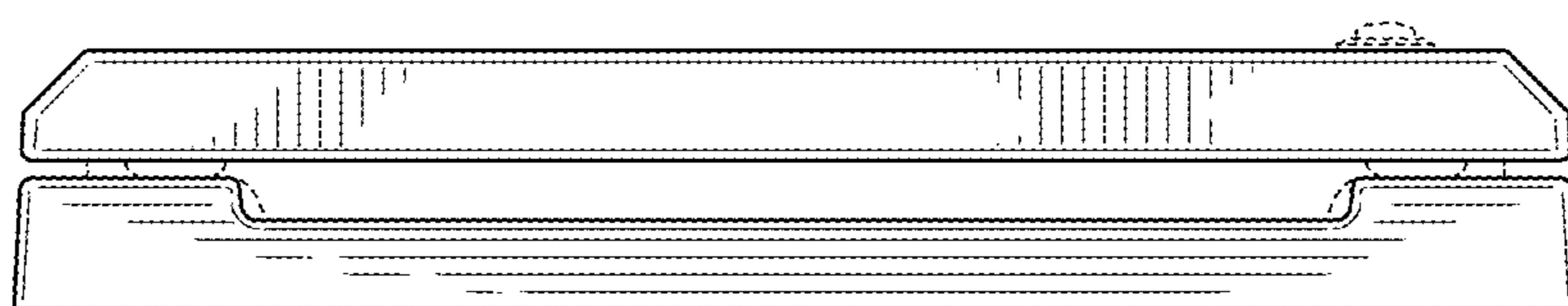
