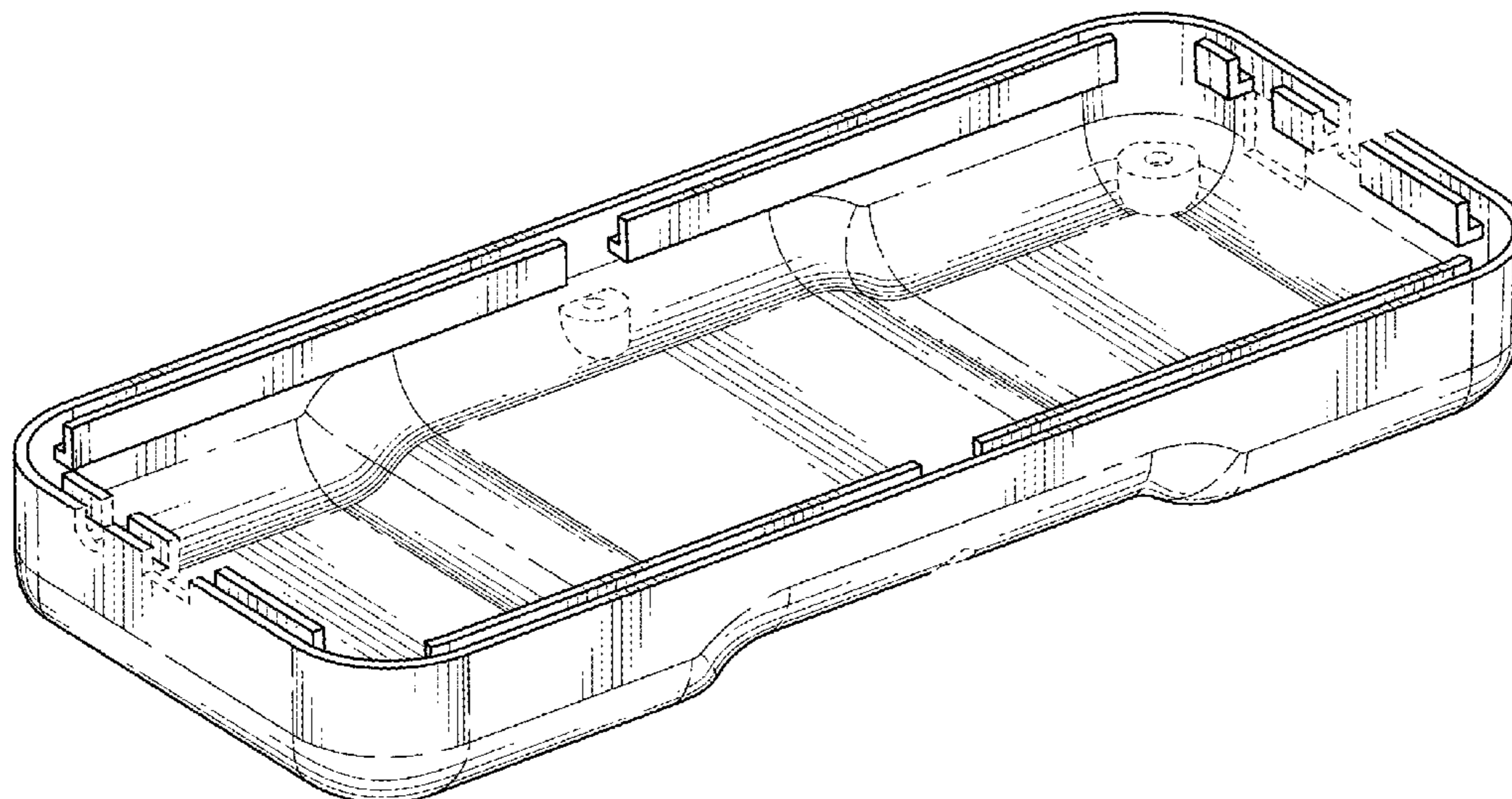
(57) **CLAIM**

We claim the ornamental design for a case for a hand held controller, as shown and described.

DESCRIPTION

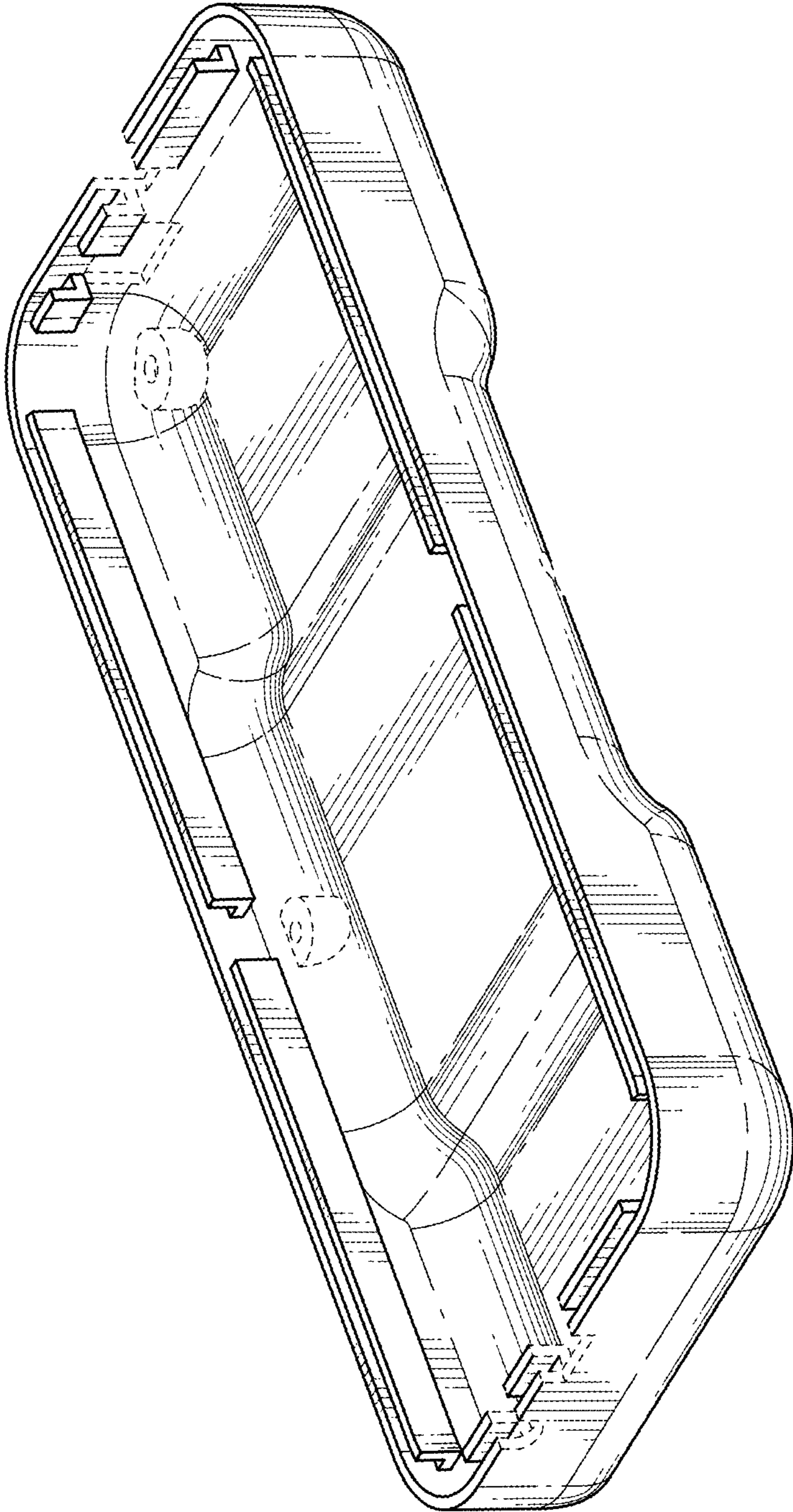

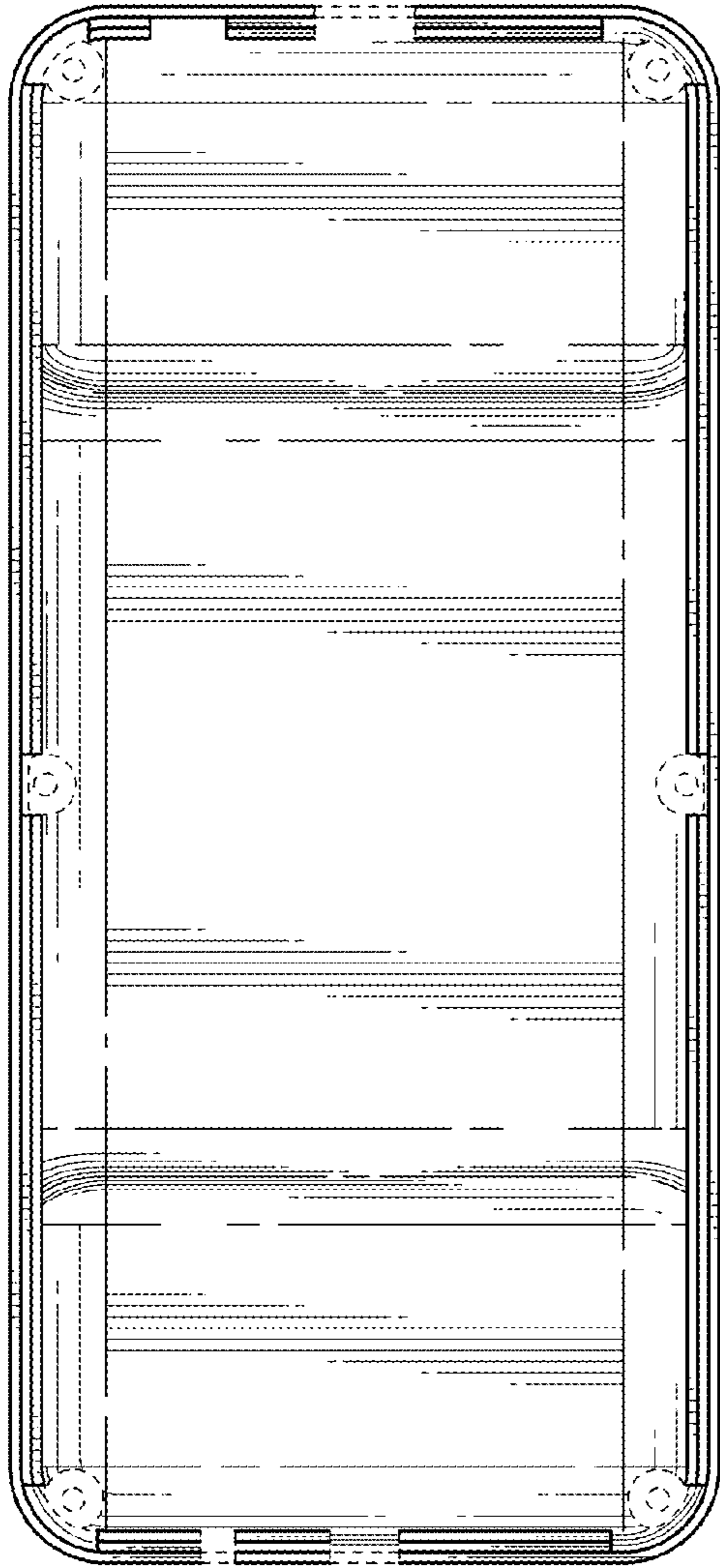

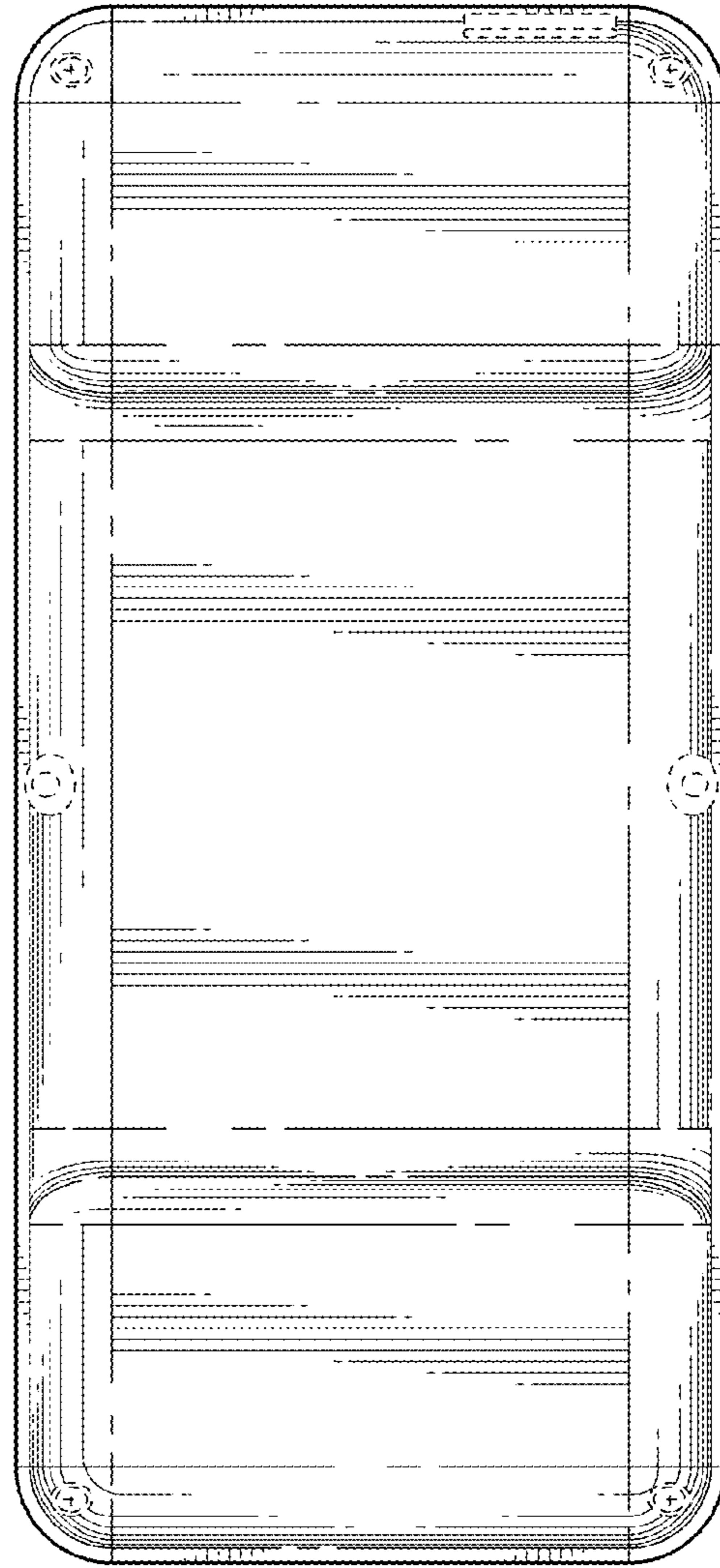

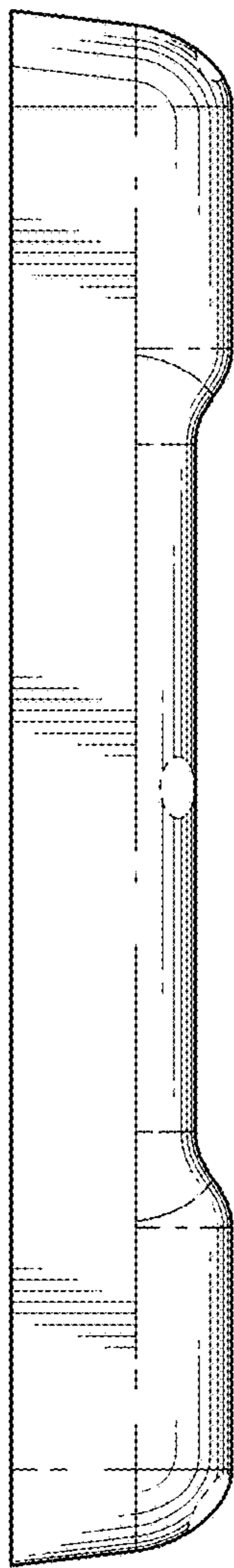

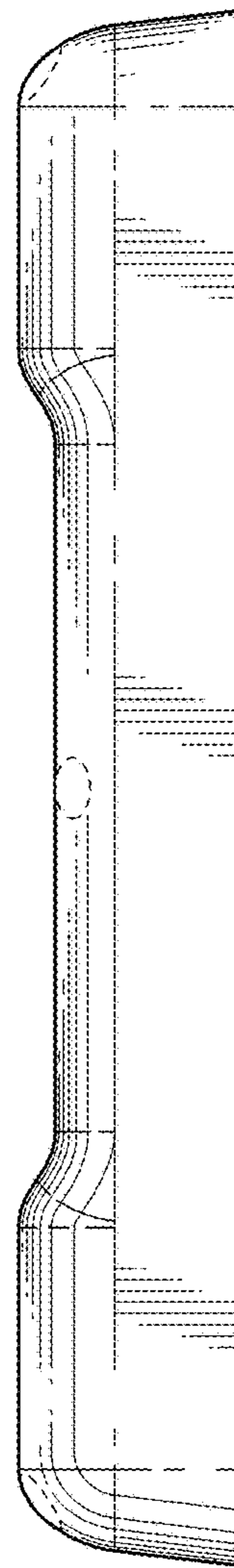

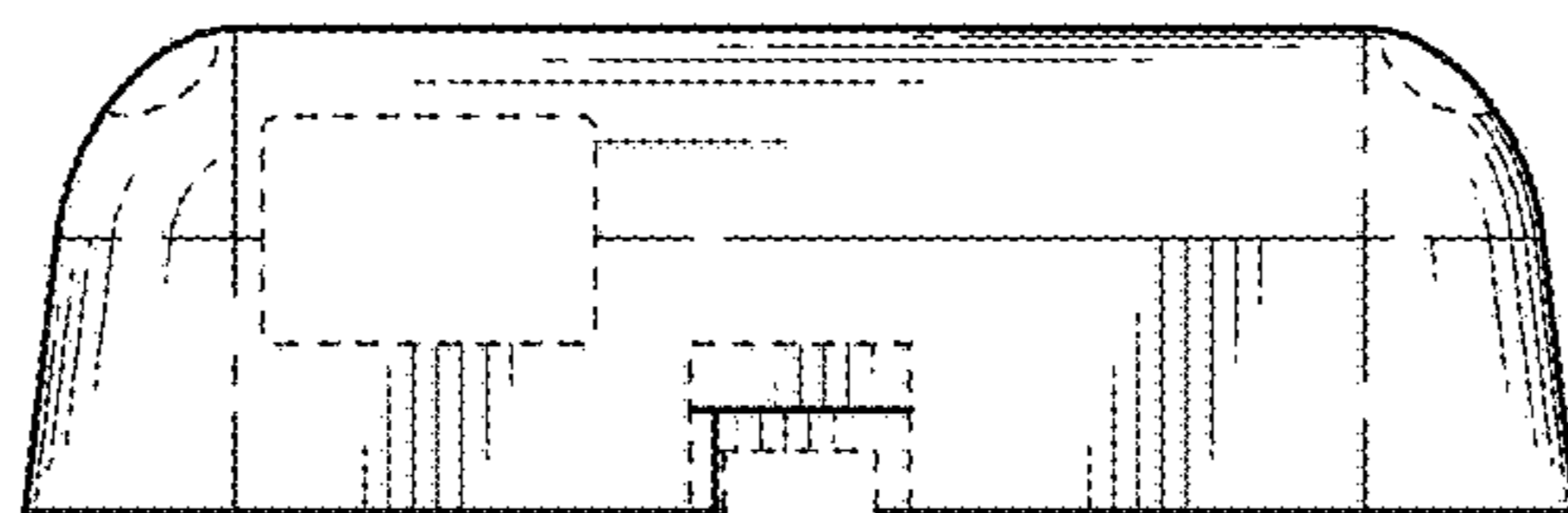
