(57) **CLAIM**

The ornamental design for a display screen with animated graphical user interface, as shown and described.

DESCRIPTION

FIG. 4 is a fourth image in a series of images for a display screen with animated graphical user interface showing our new design;

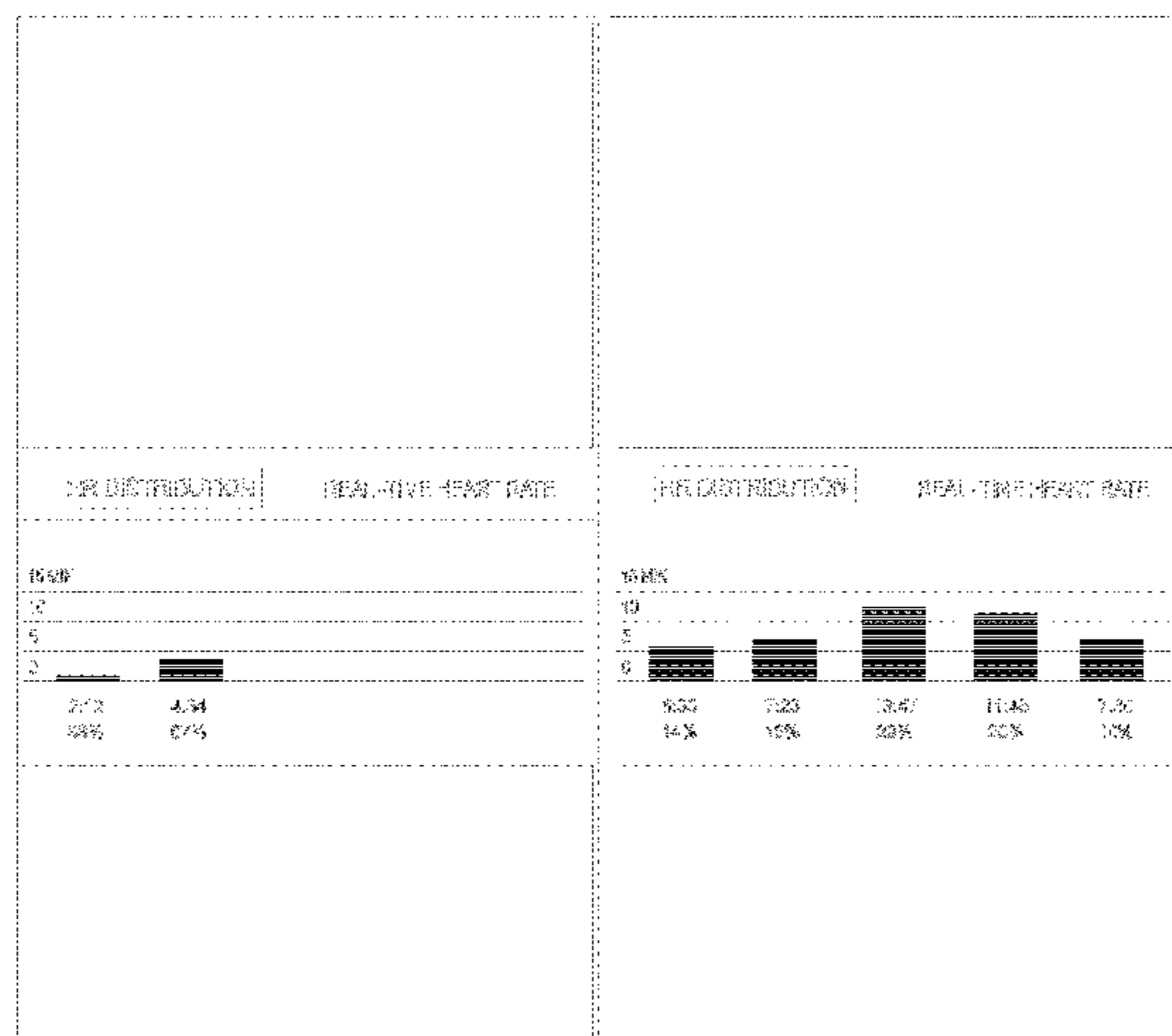
FIG. 5 is a fifth image in a series of images for a display screen with animated graphical user interface showing our new design;

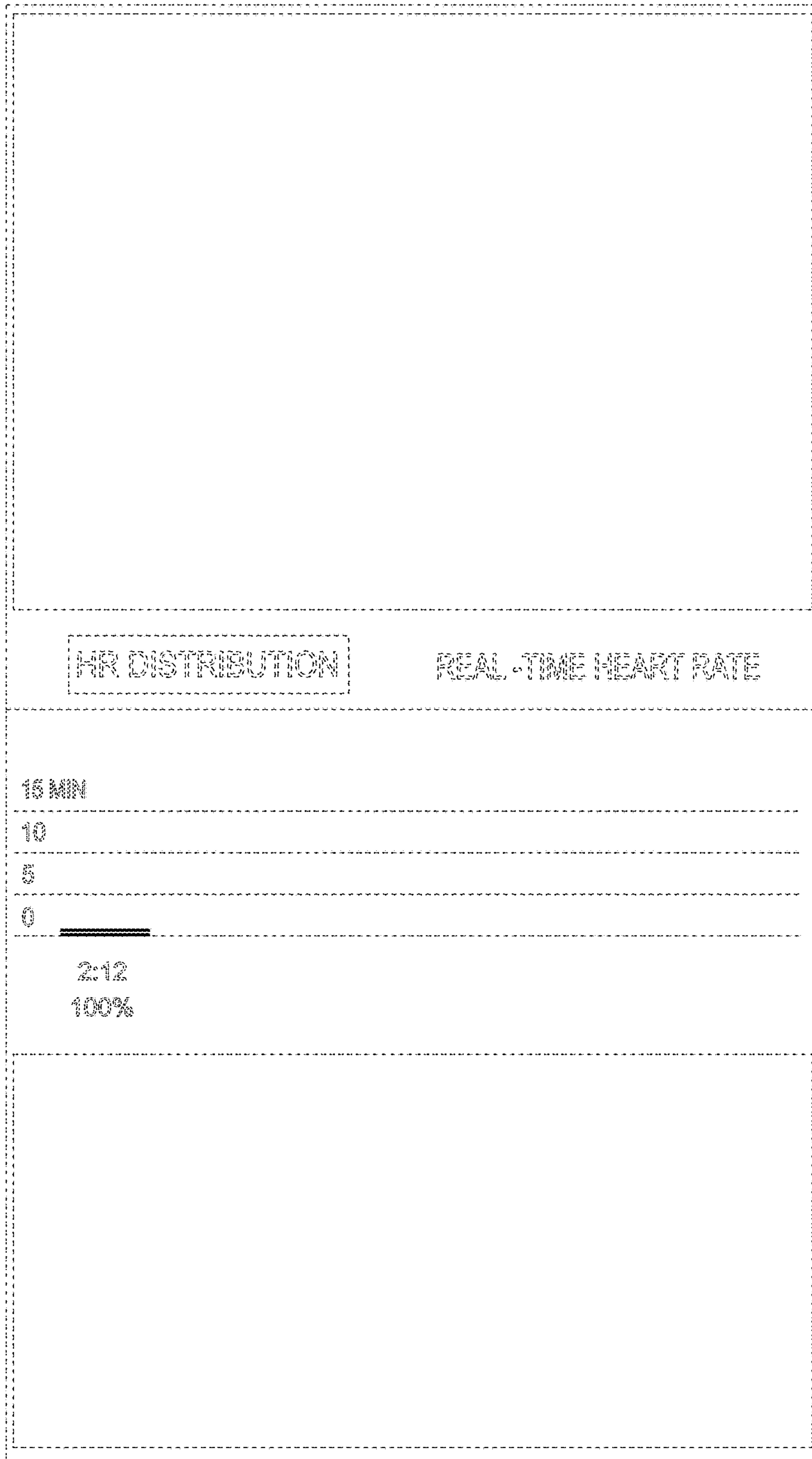

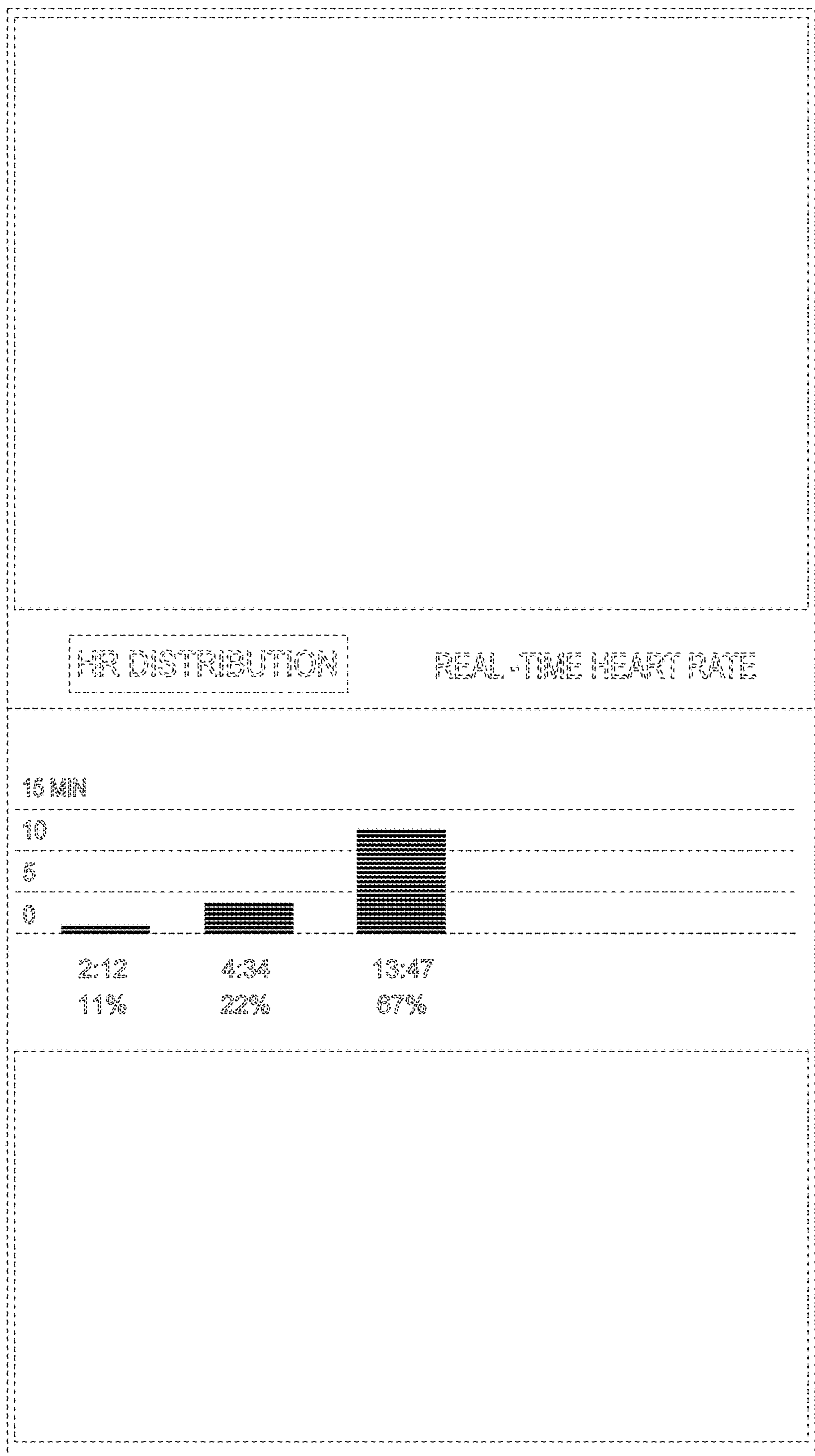

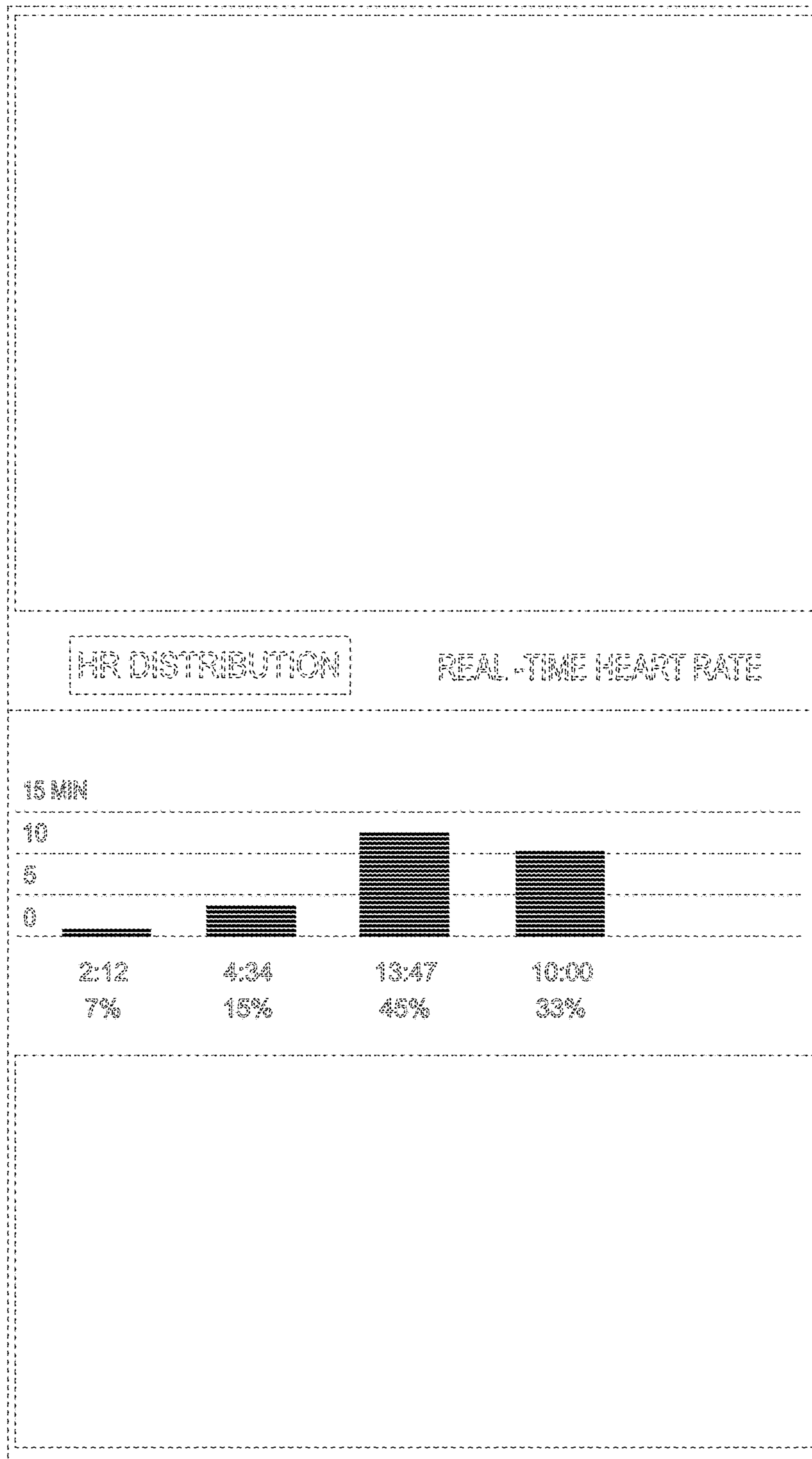

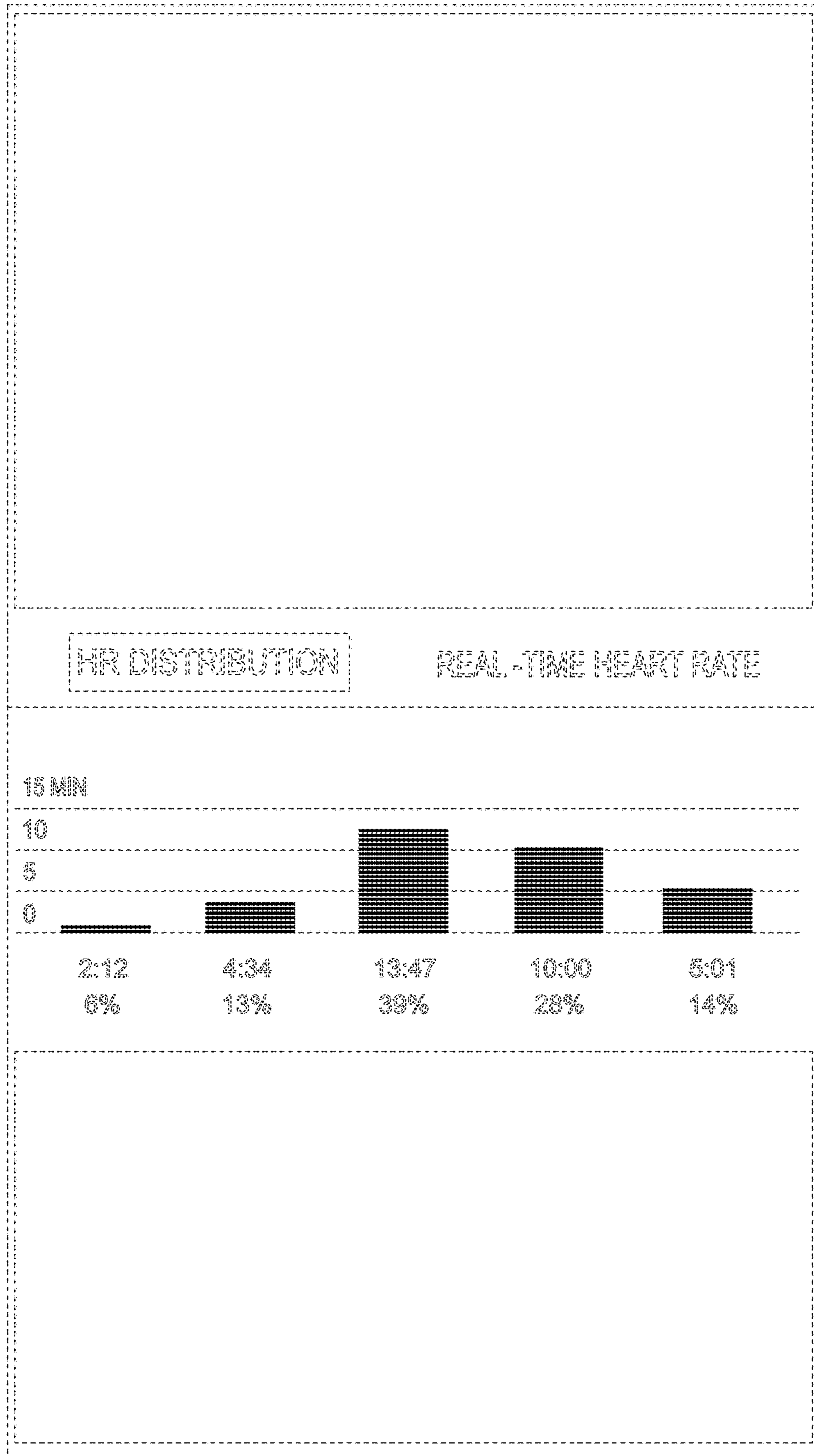

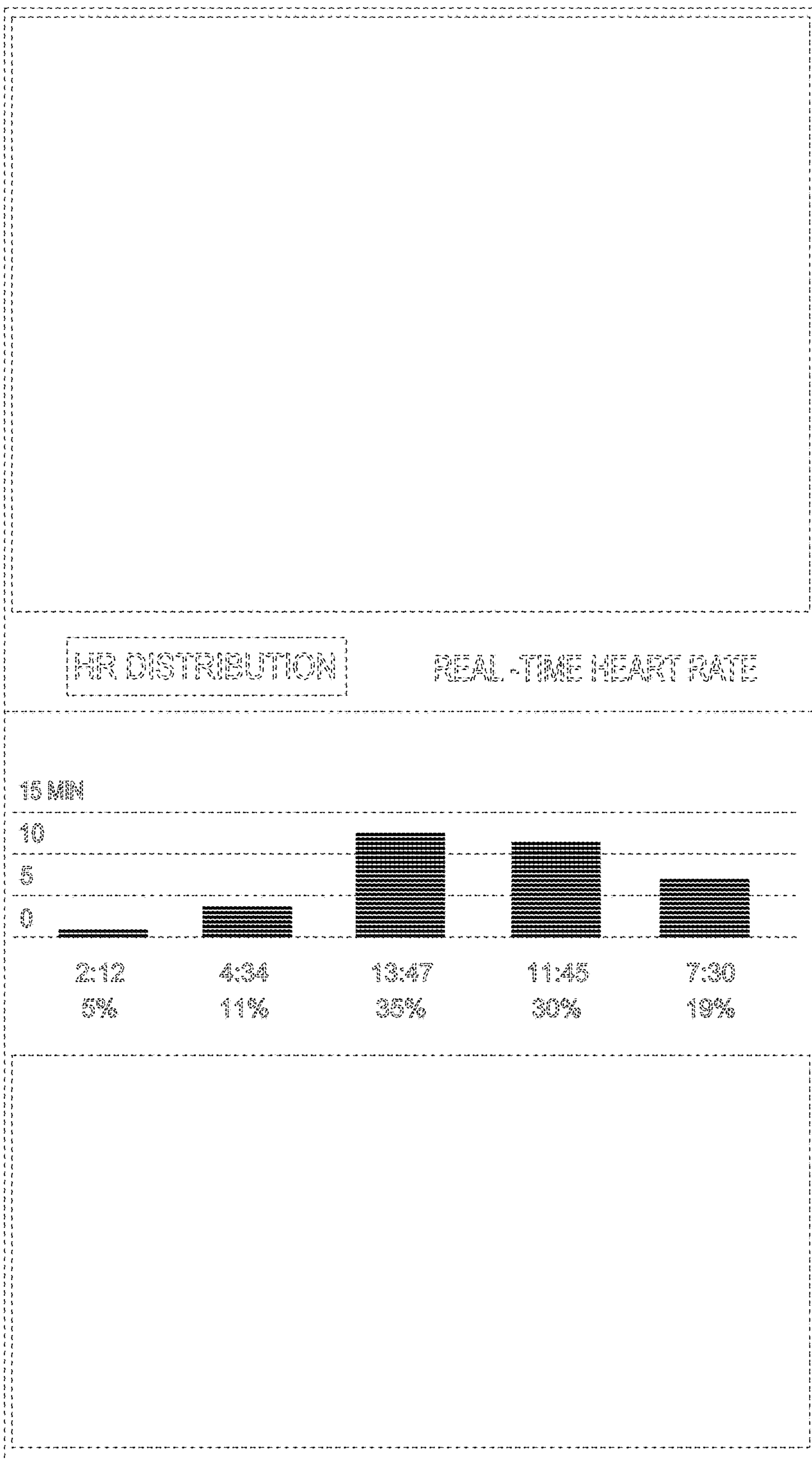

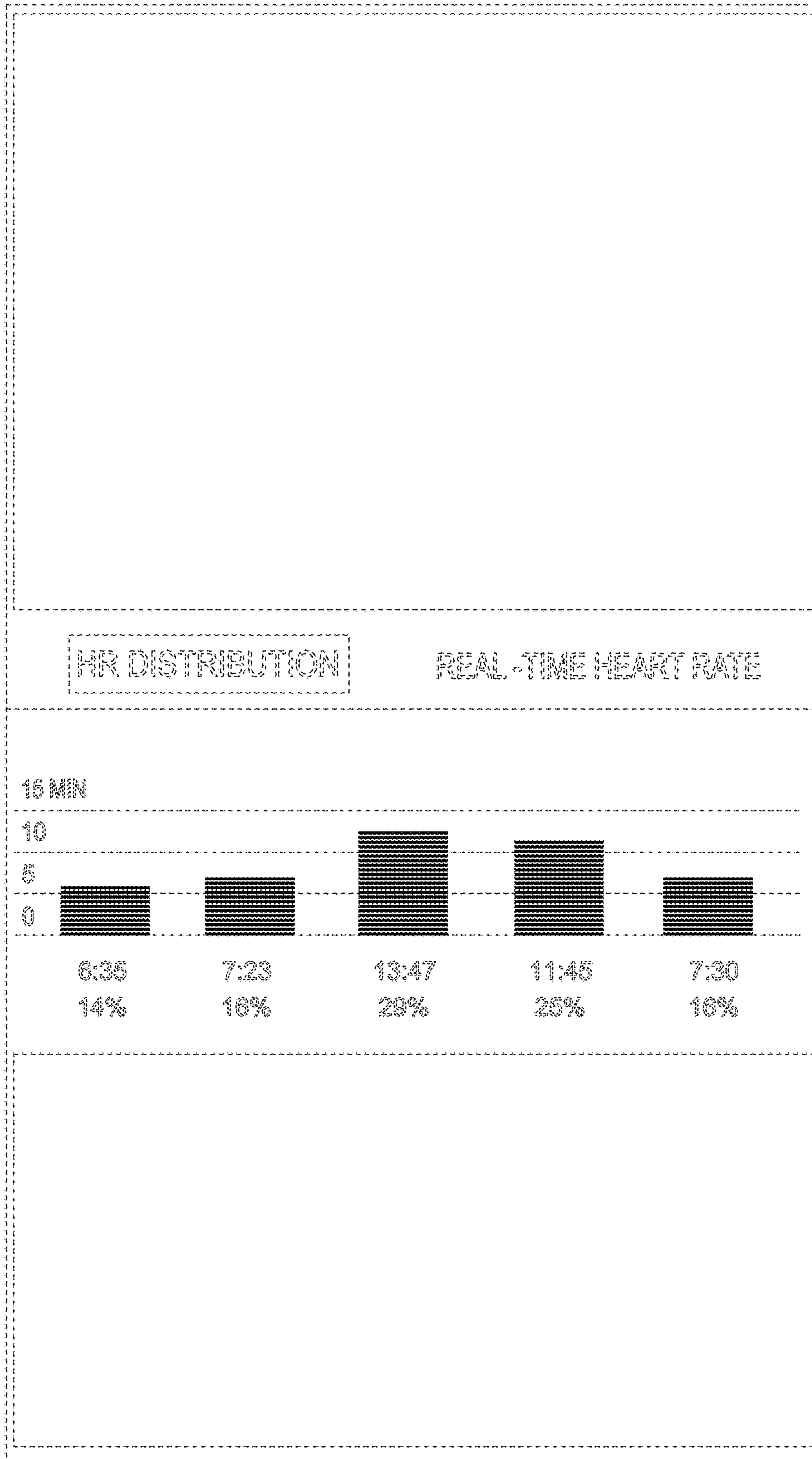
