FIG. 4 is a fourth image thereof;

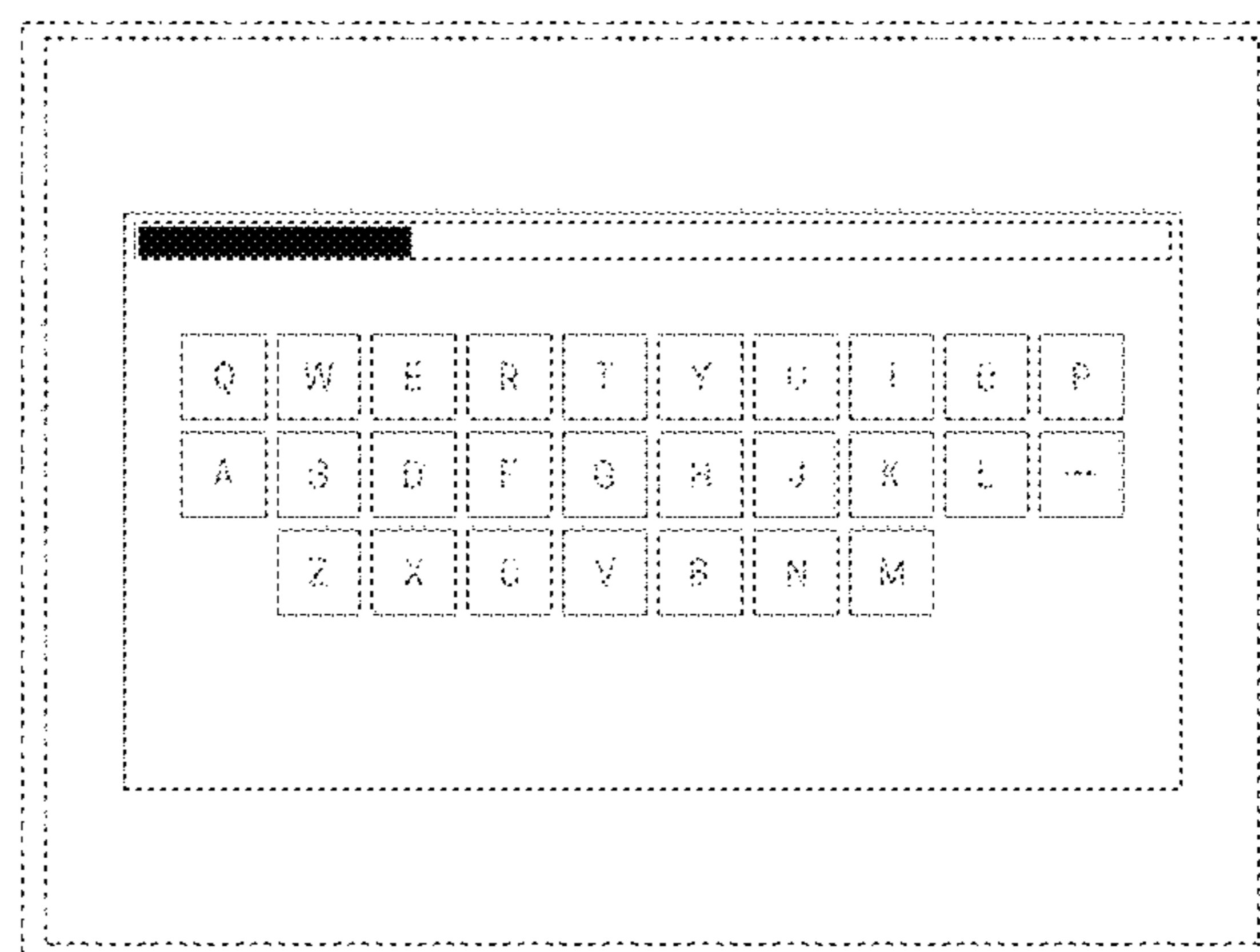
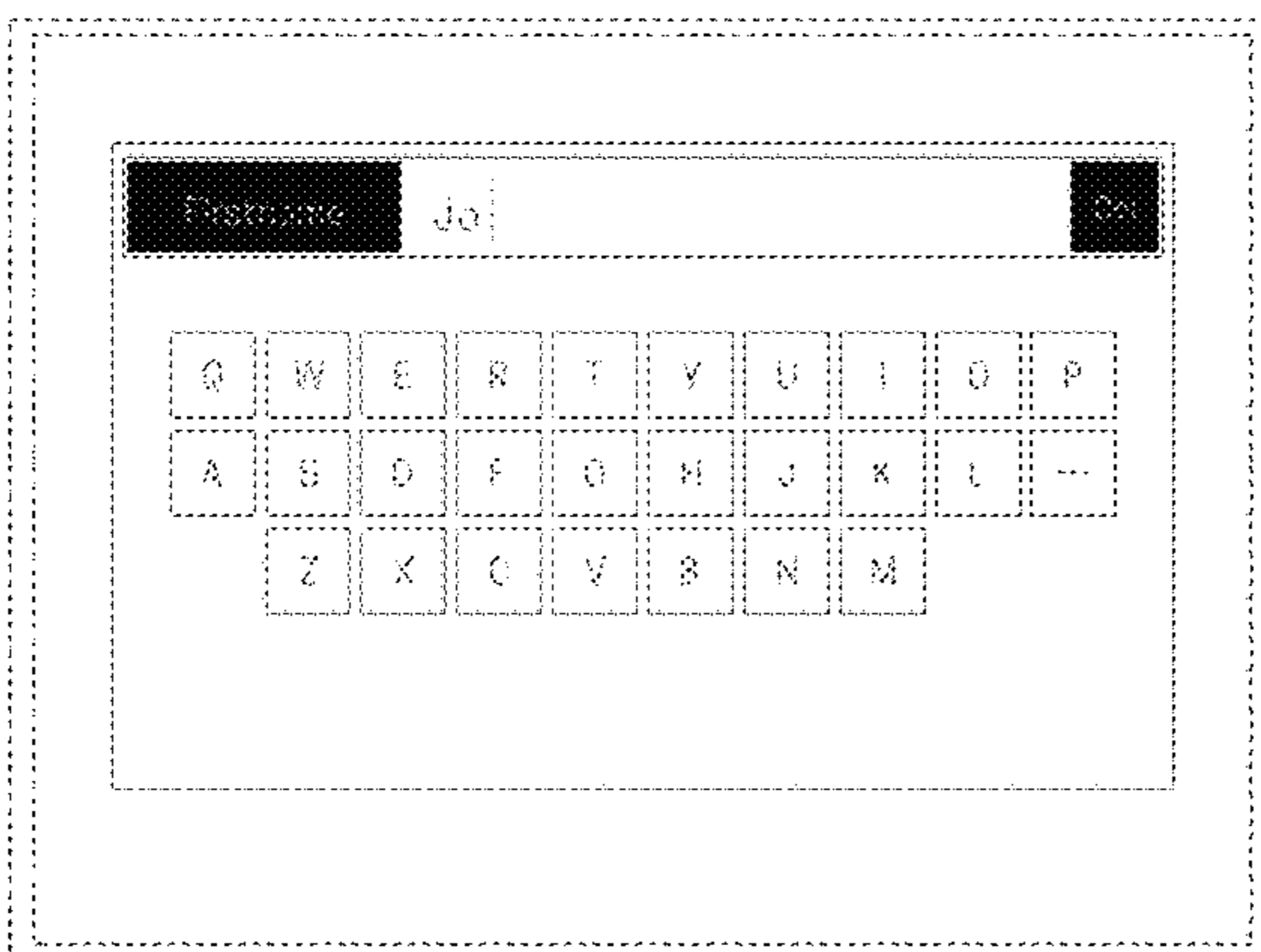
FIG. 5 is a fifth image thereof; and,

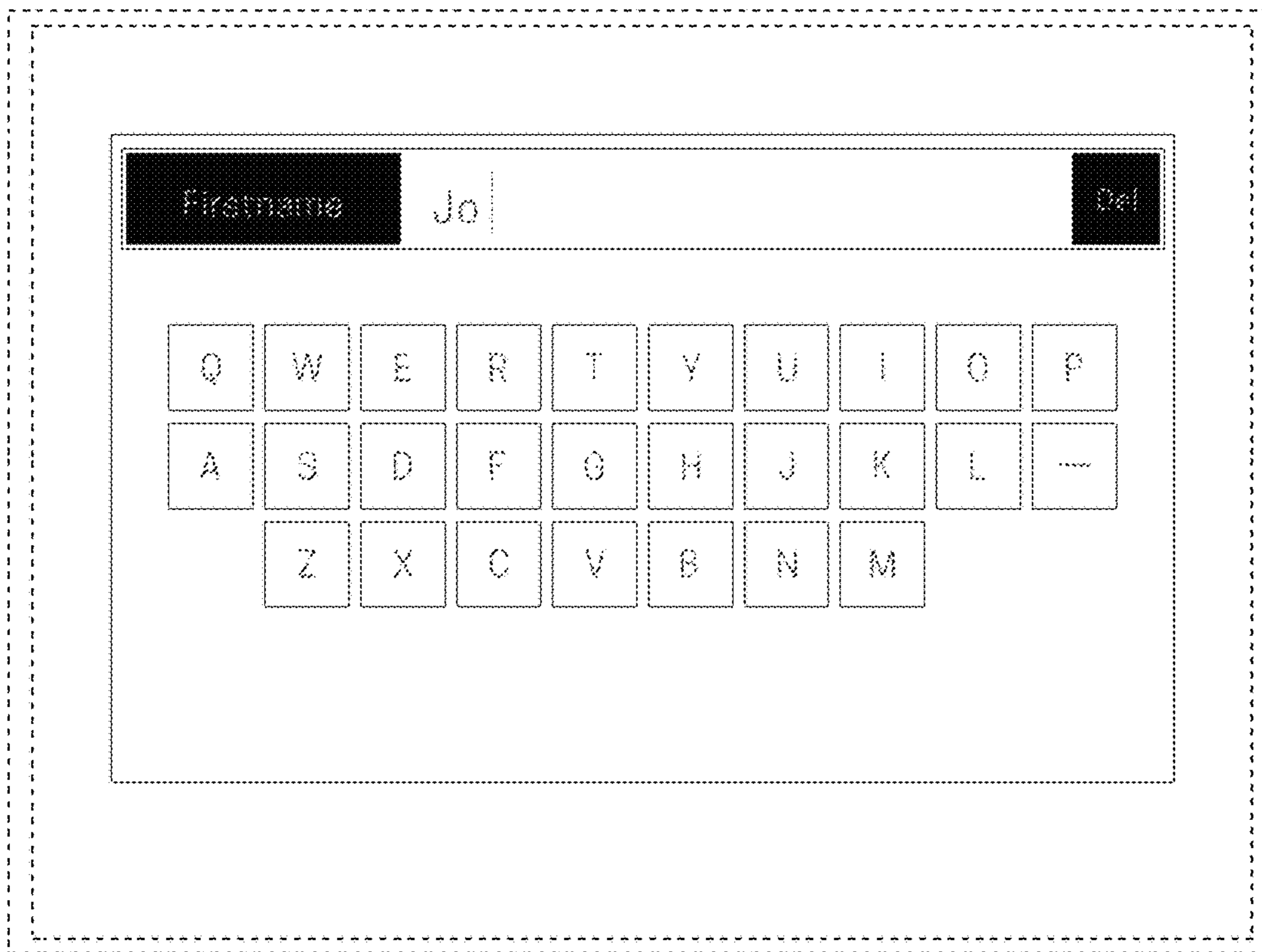

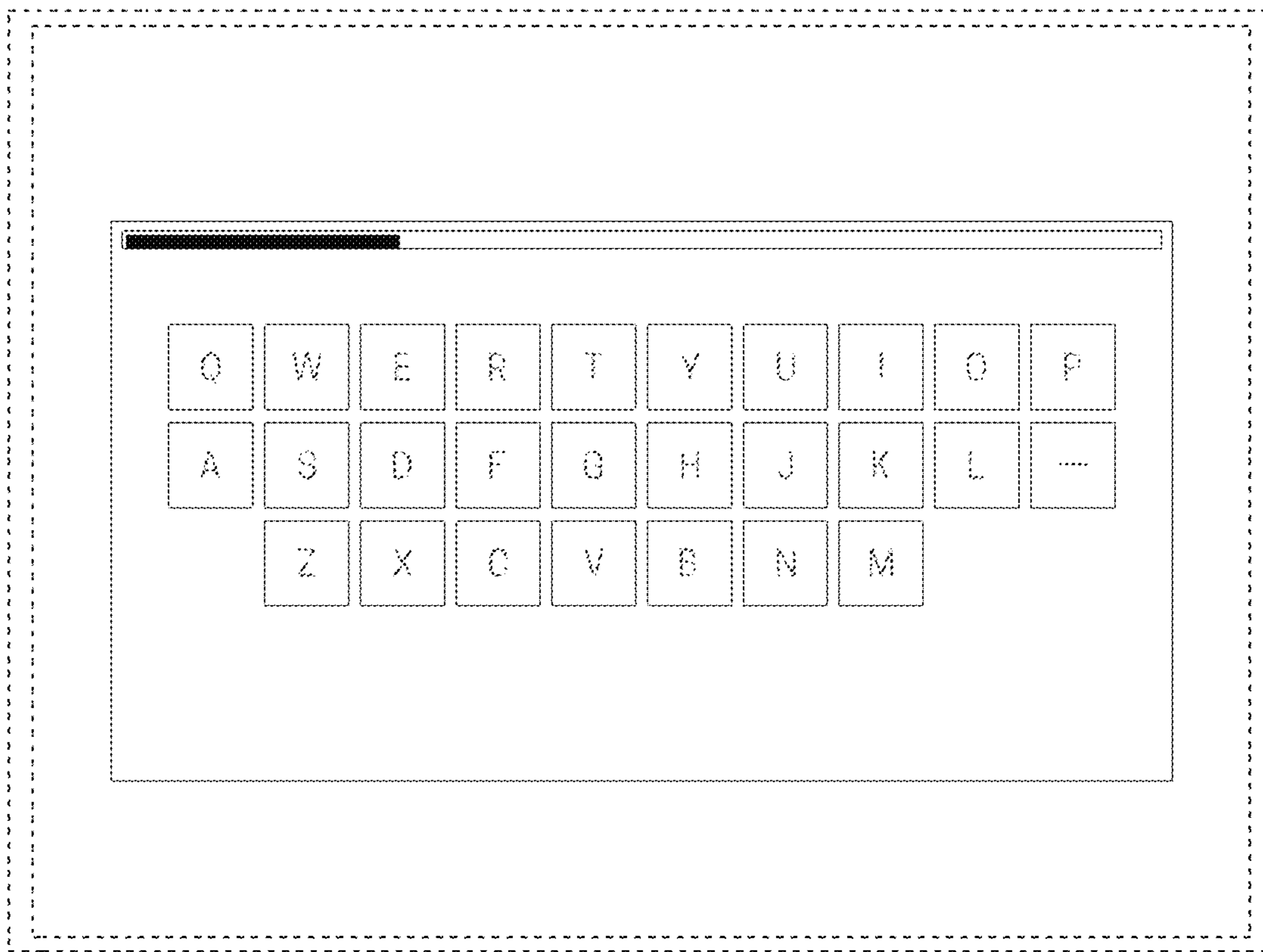

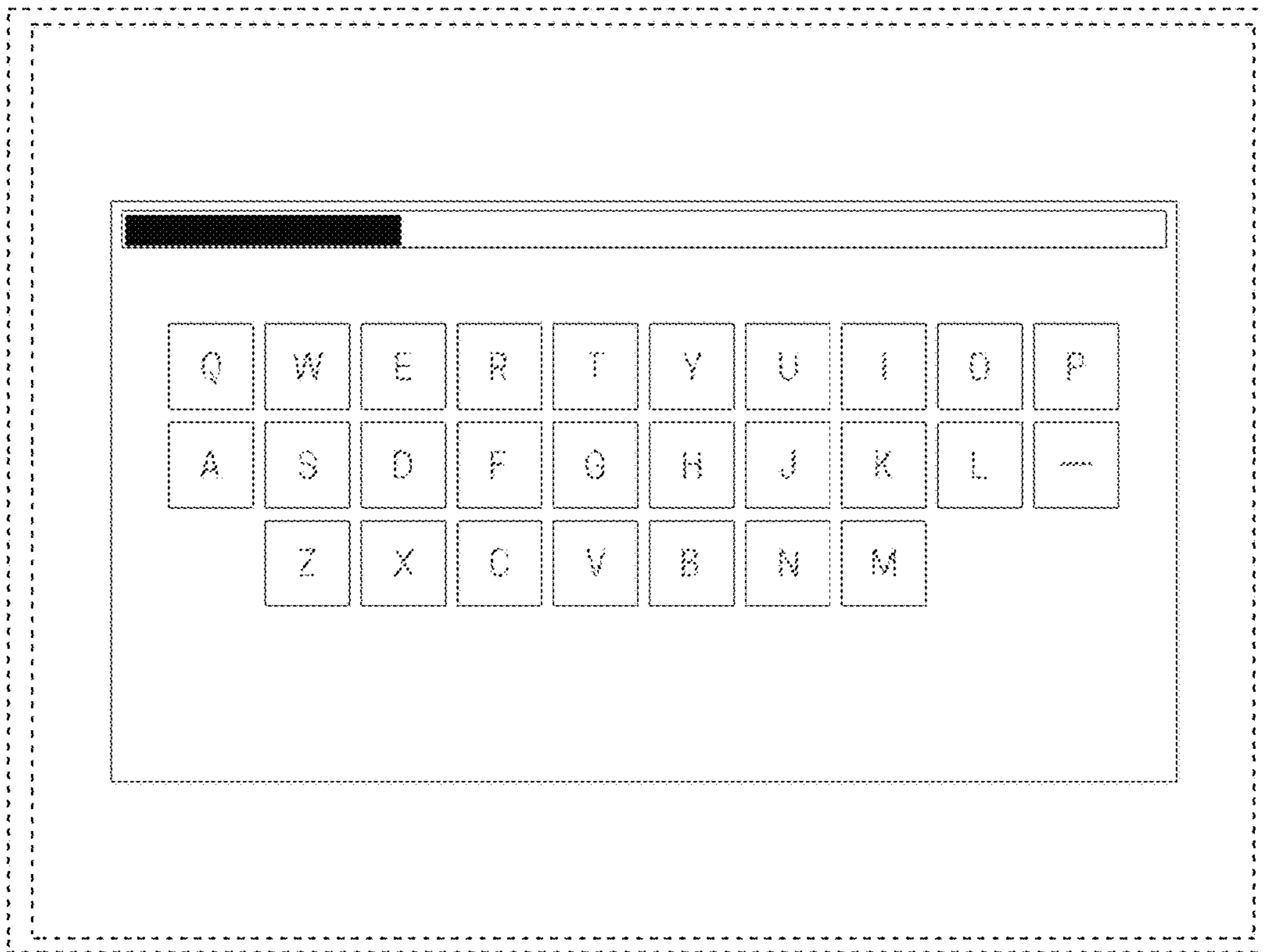

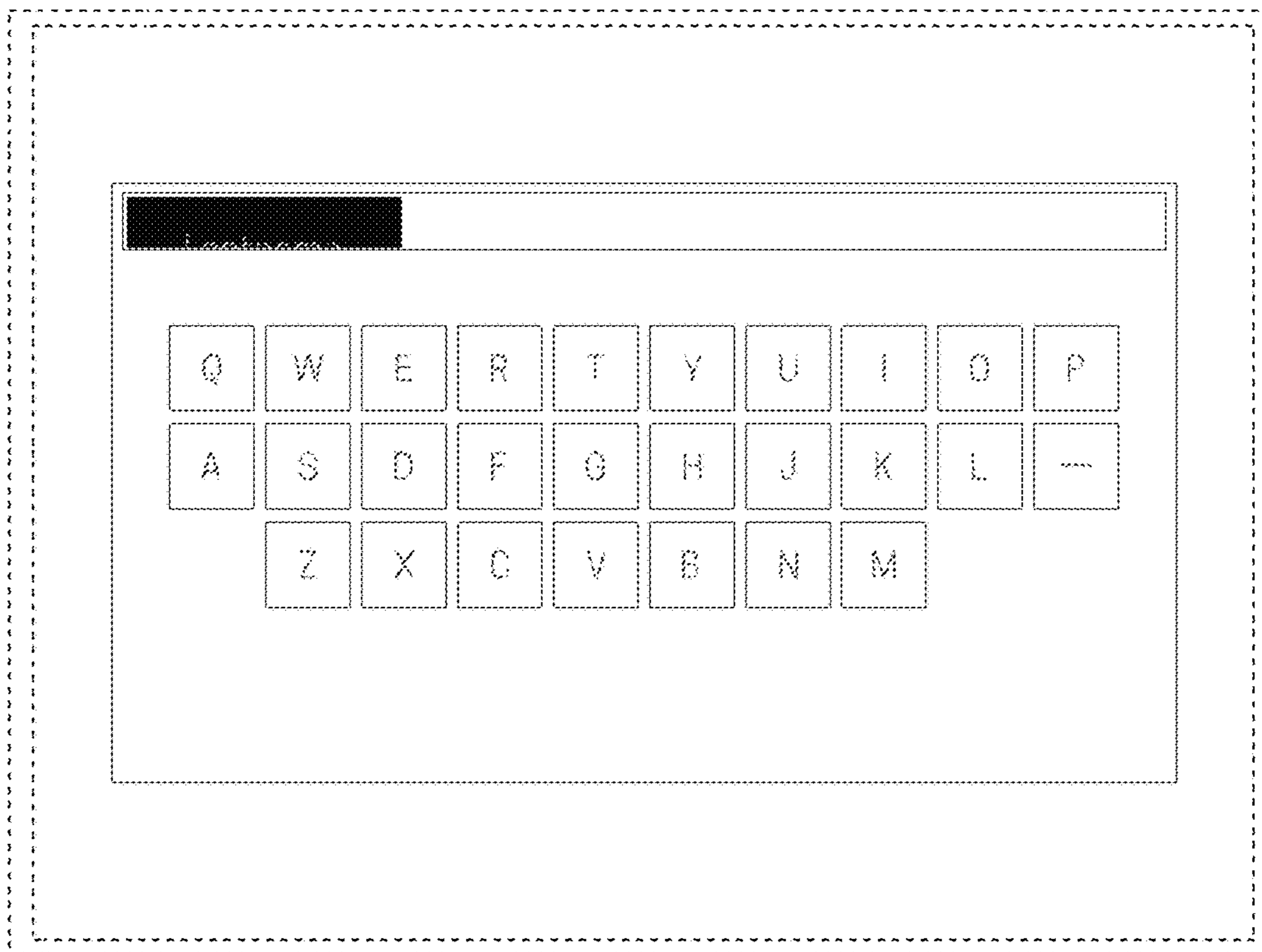

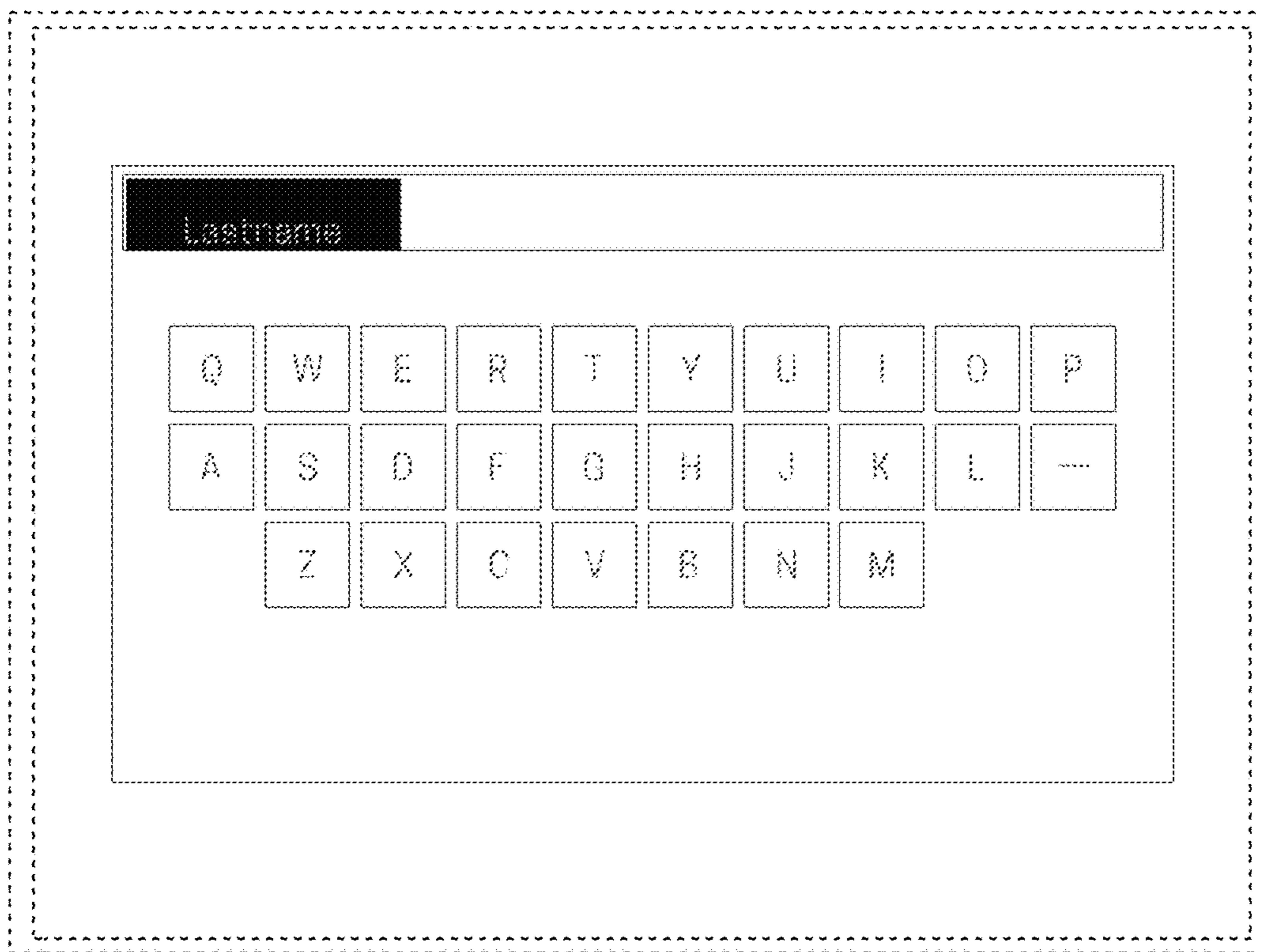

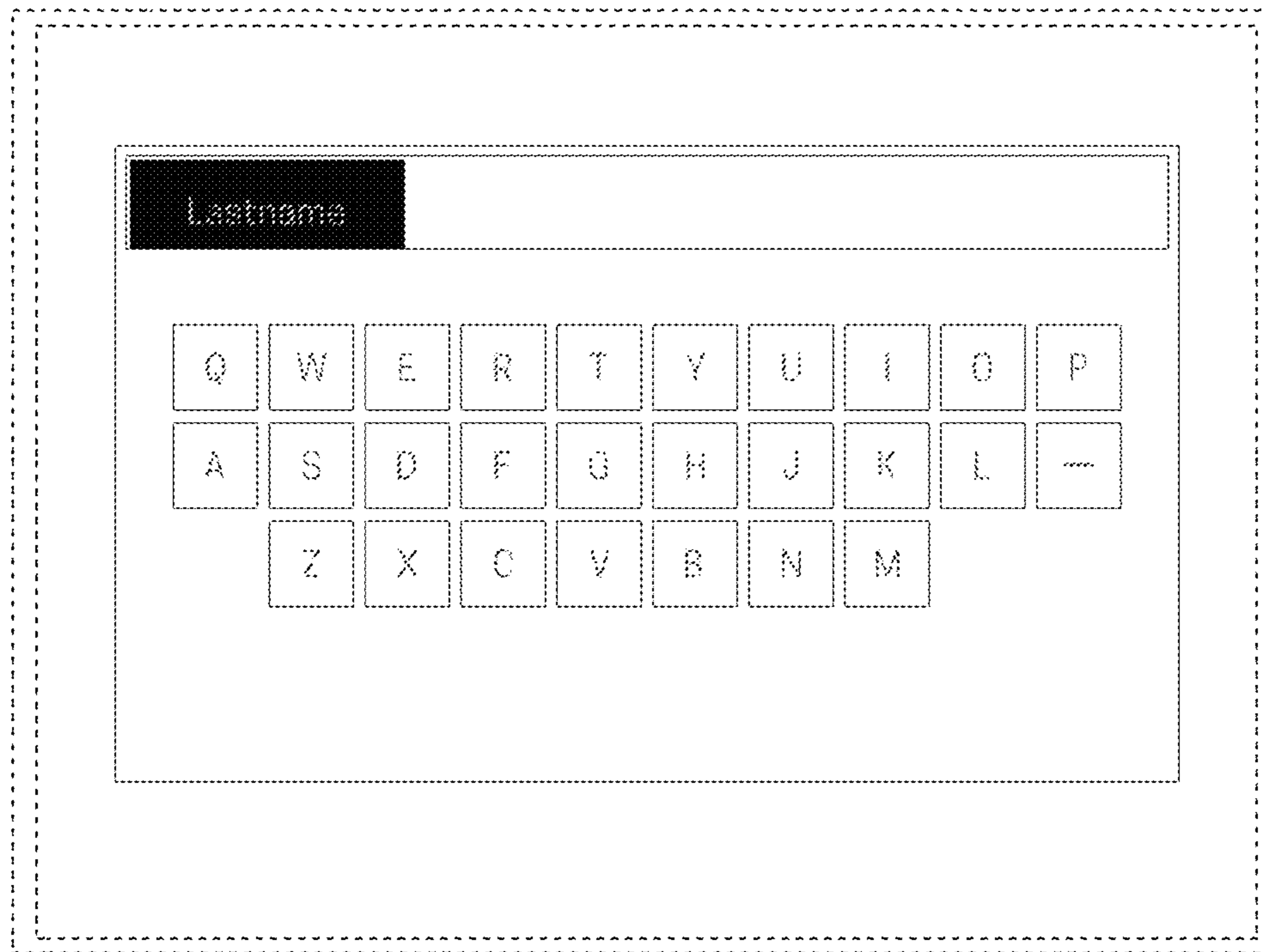
