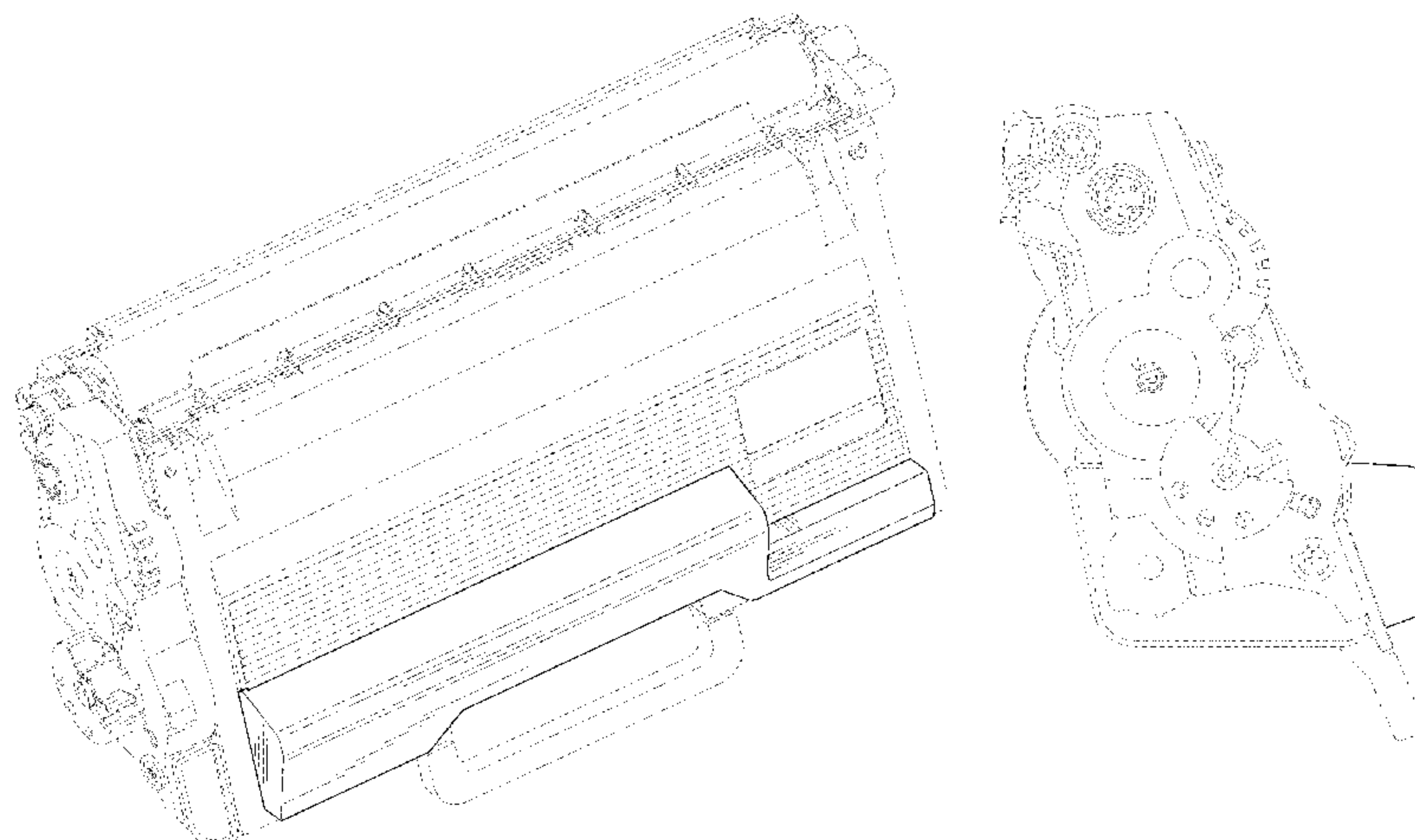
(57) **CLAIM**

The ornamental design for a toner cartridge, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, left-side perspective view of a toner cartridge showing the new design;
FIG. 2 is a front view thereof;

FIG. 4 is a left-side view thereof;
FIG. 5 is a right-side view thereof;
FIG. 6 is a rear view thereof;
FIG. 7 is a bottom view thereof;

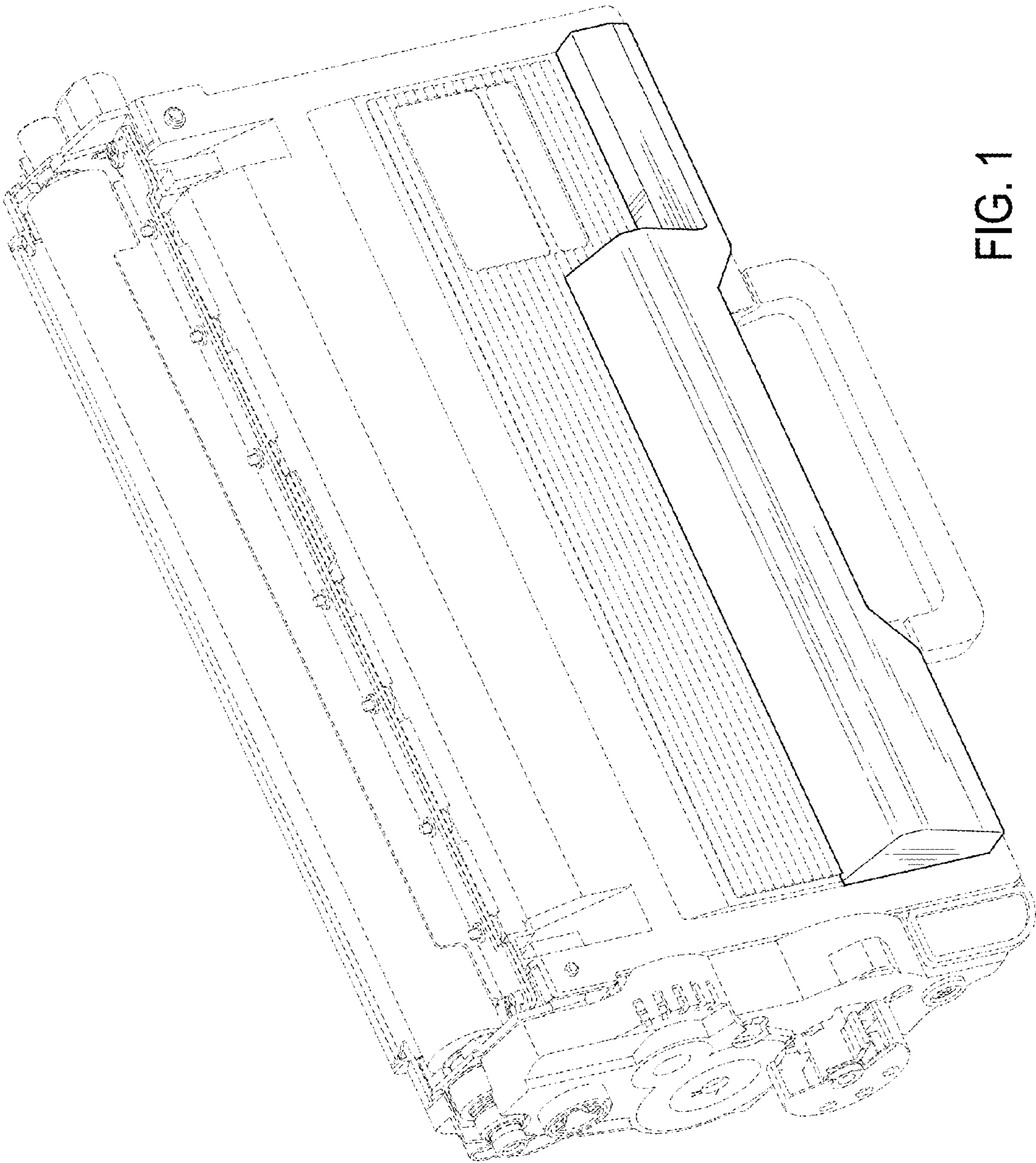

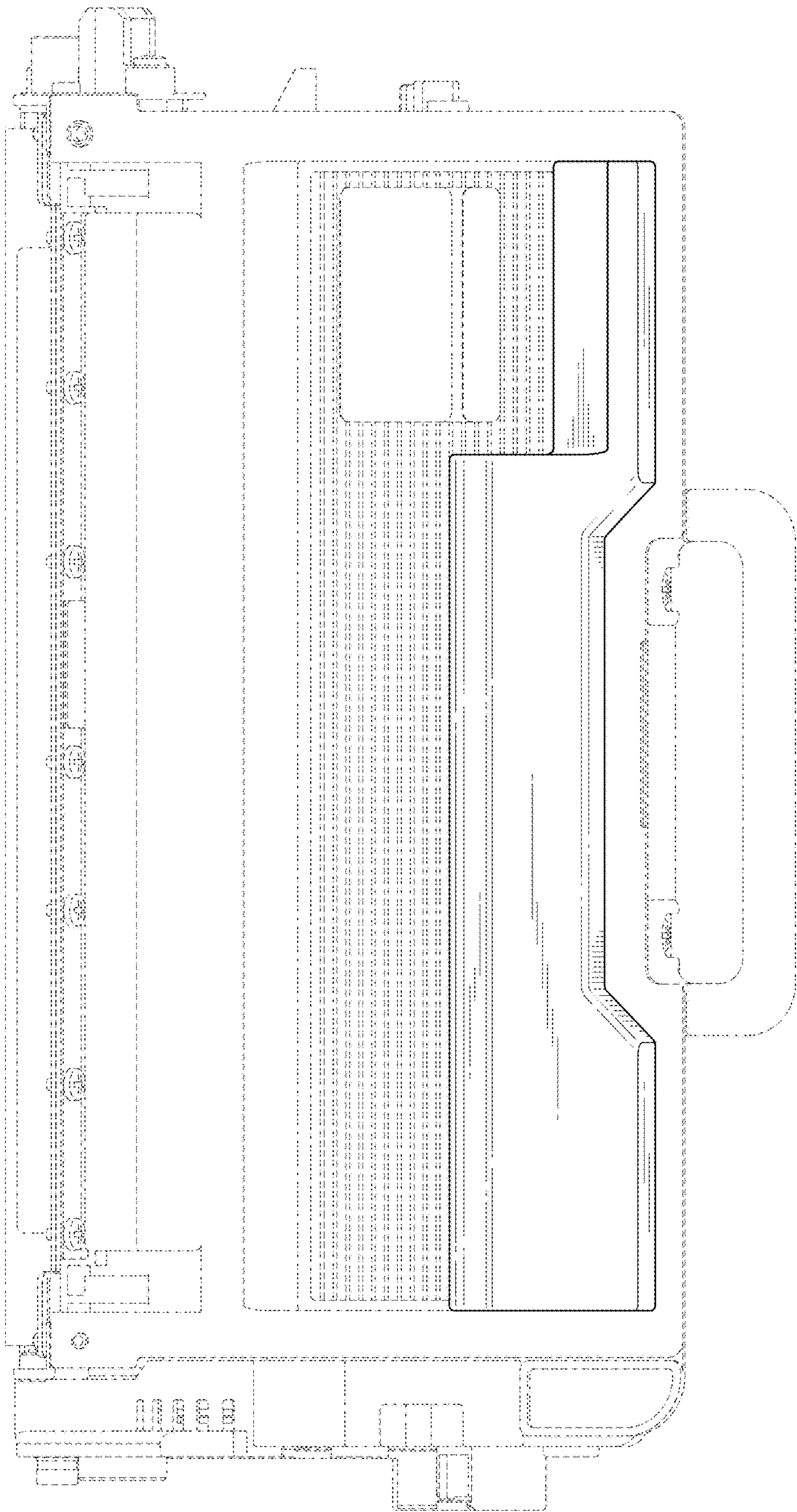

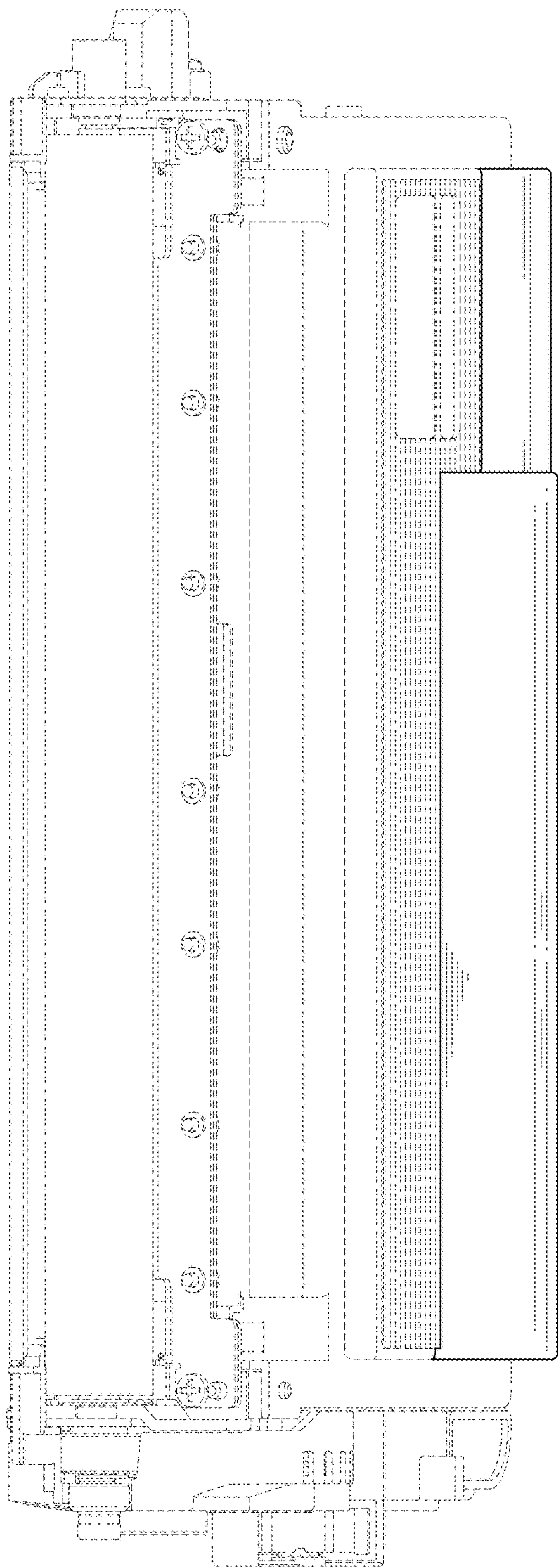

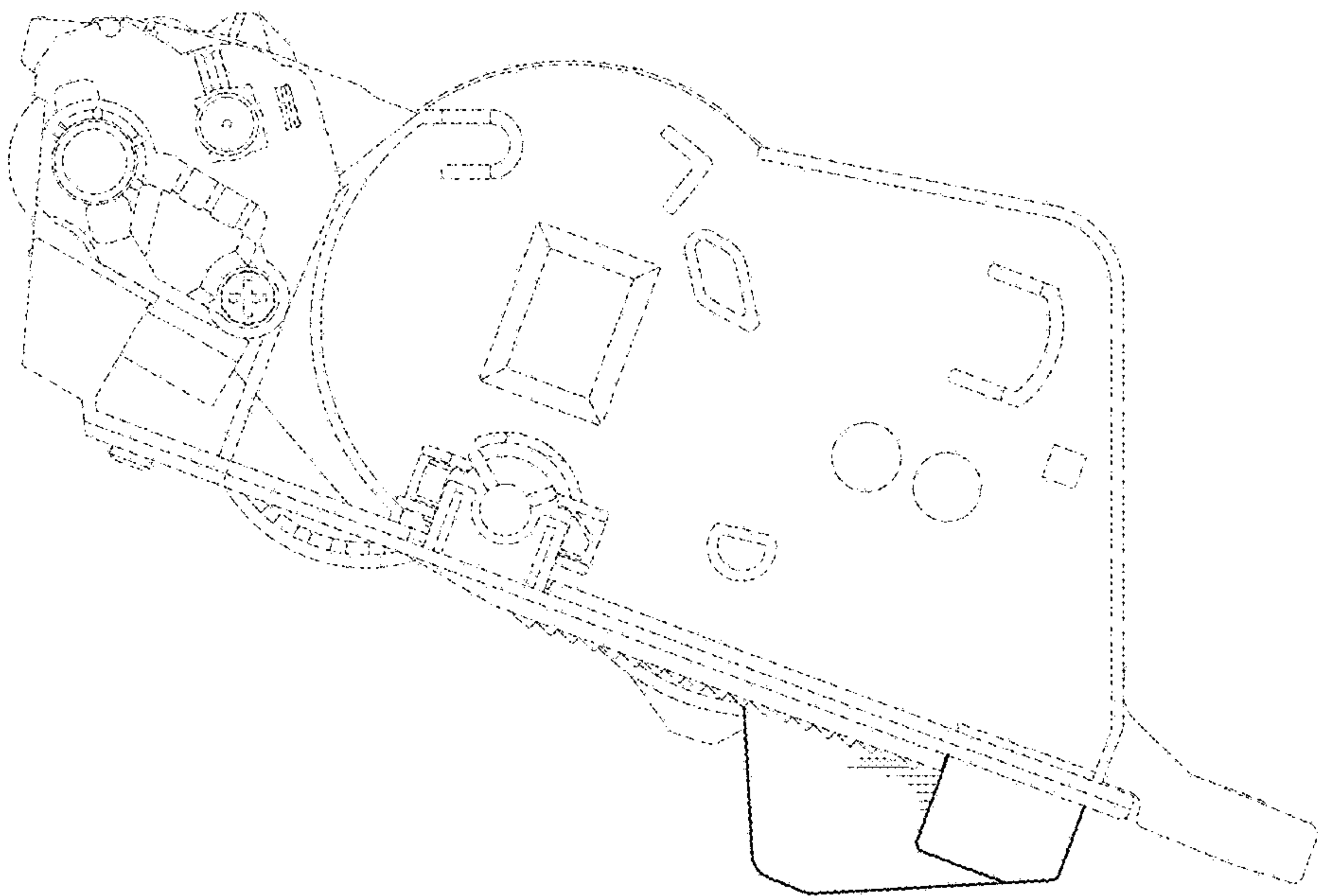

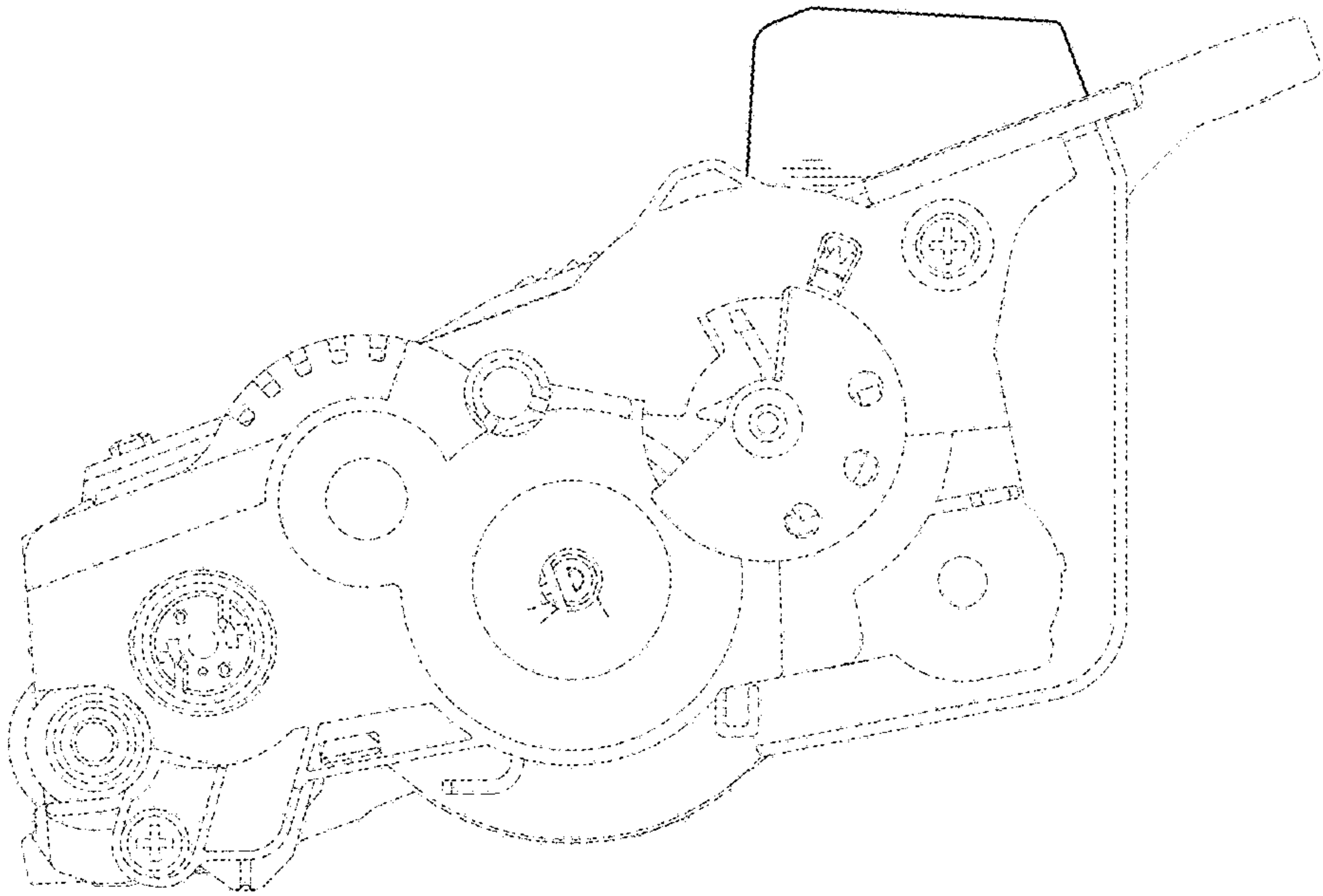

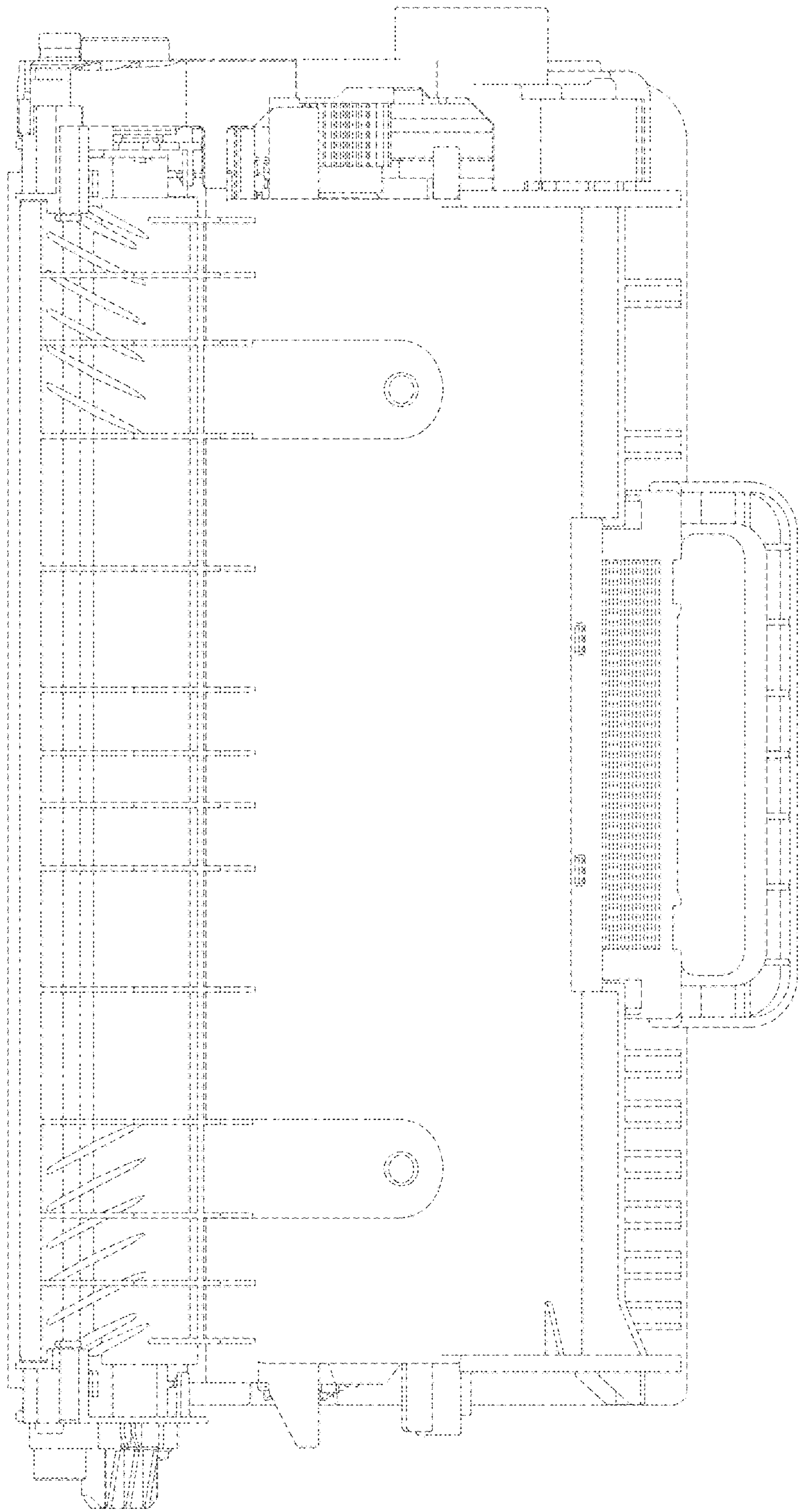

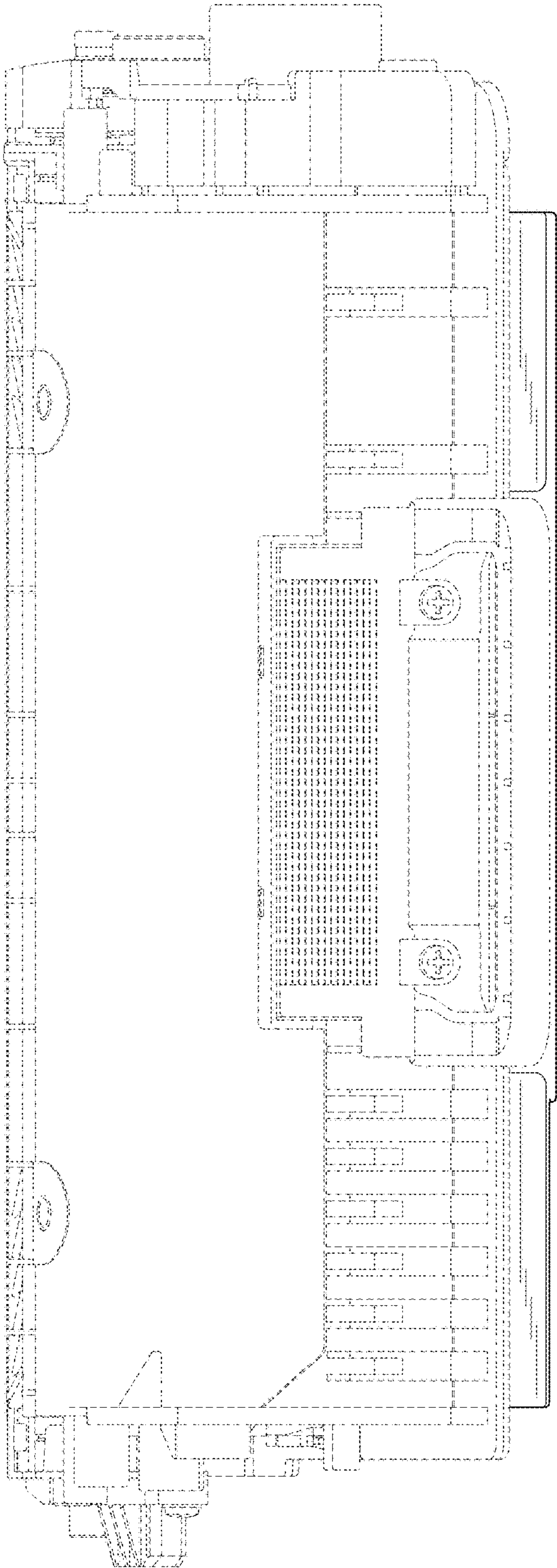

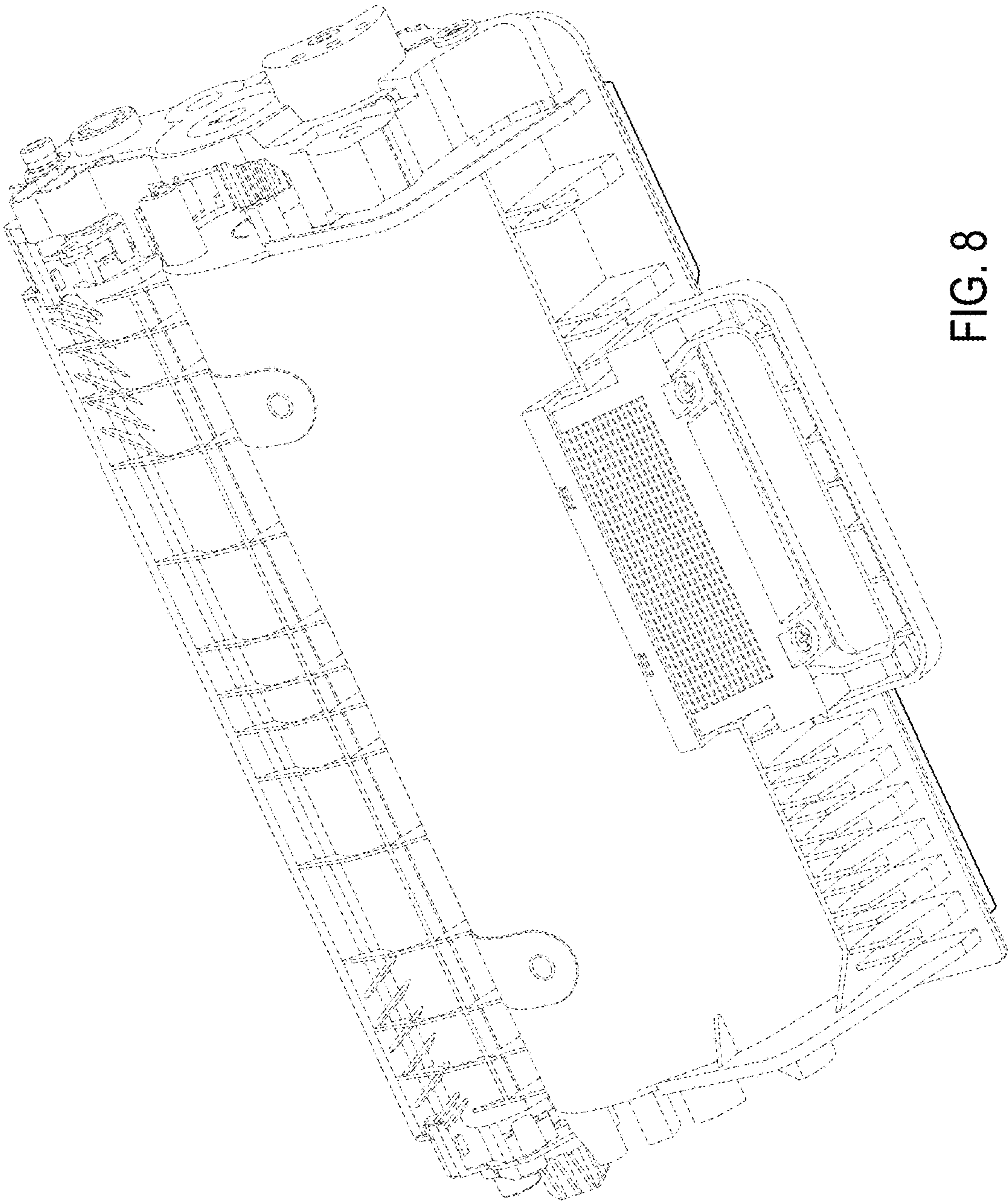

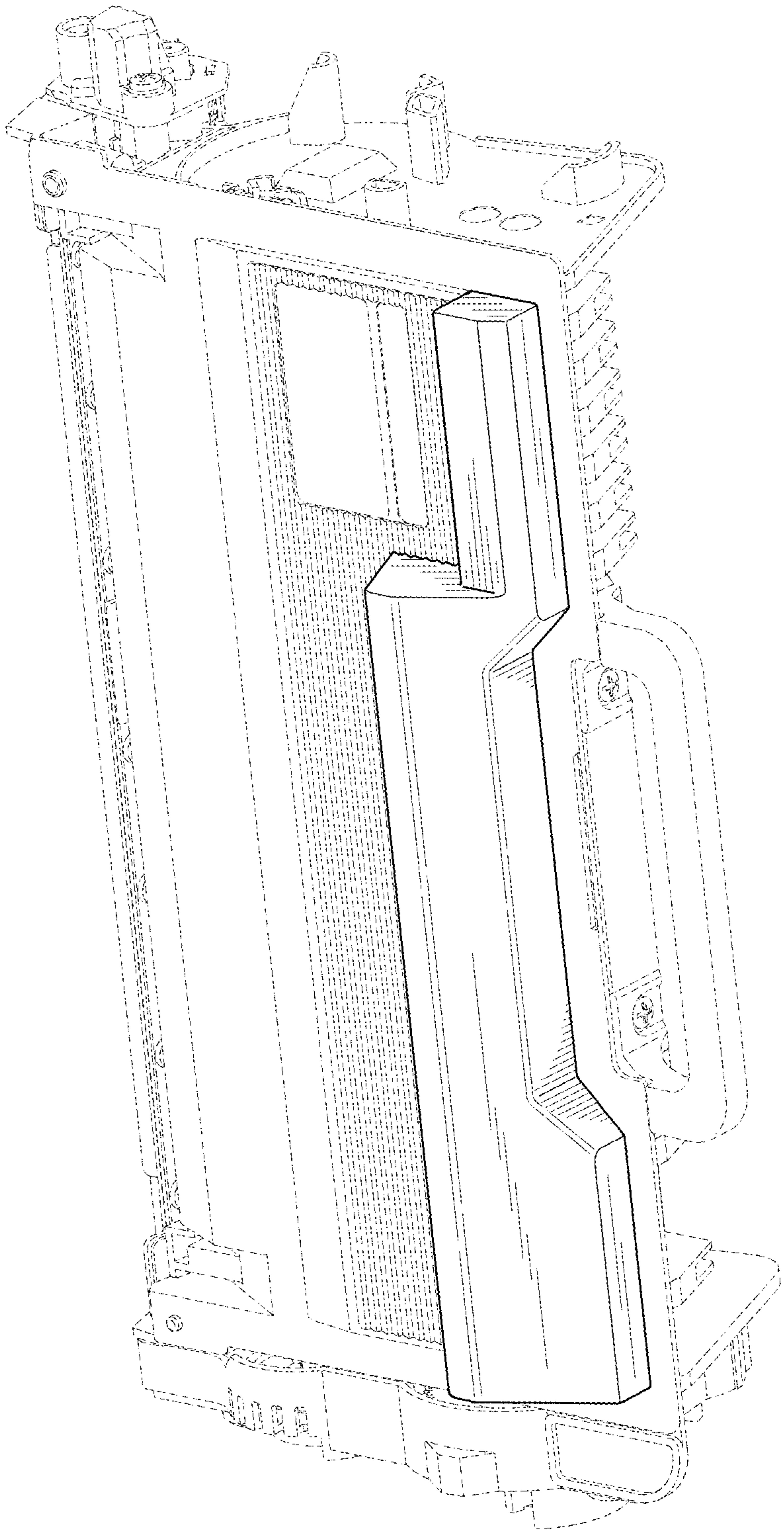
