**DESCRIPTION**

FIG. 1 is a front perspective view of a dartboard game; FIG. 2 is a front elevation view of FIG. 1; FIG. 3 is a rear elevation view of FIG. 1; FIG. 4 is a left side elevation view of FIG. 1; FIG. 5 is a right side elevation view of FIG. 1; FIG. 6 is a top plan view of FIG. 1; and, FIG. 7 is a bottom plan view of FIG. 1.

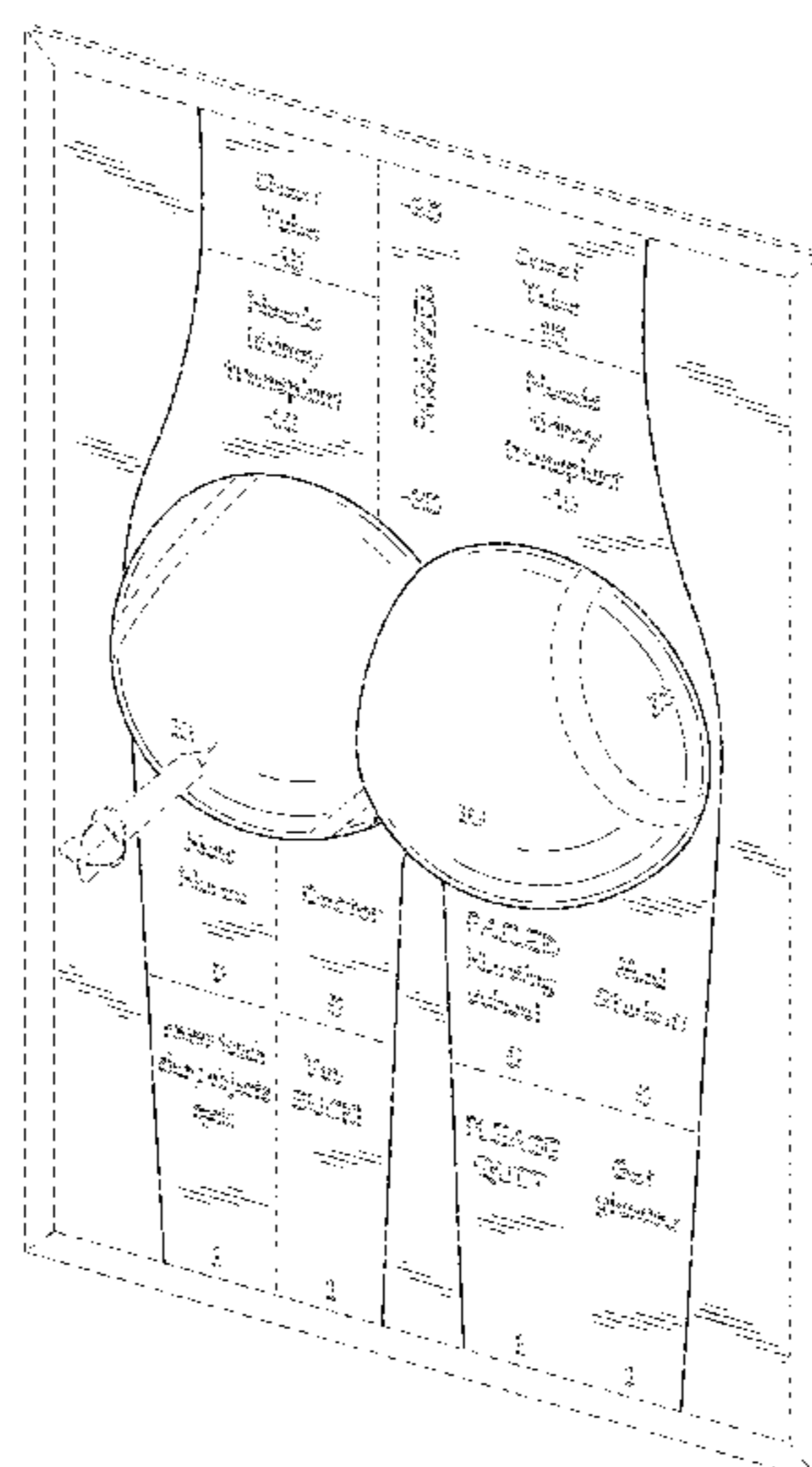
The broken lines shown in the drawings depict portions of the dartboard game that form no part of the claimed design.

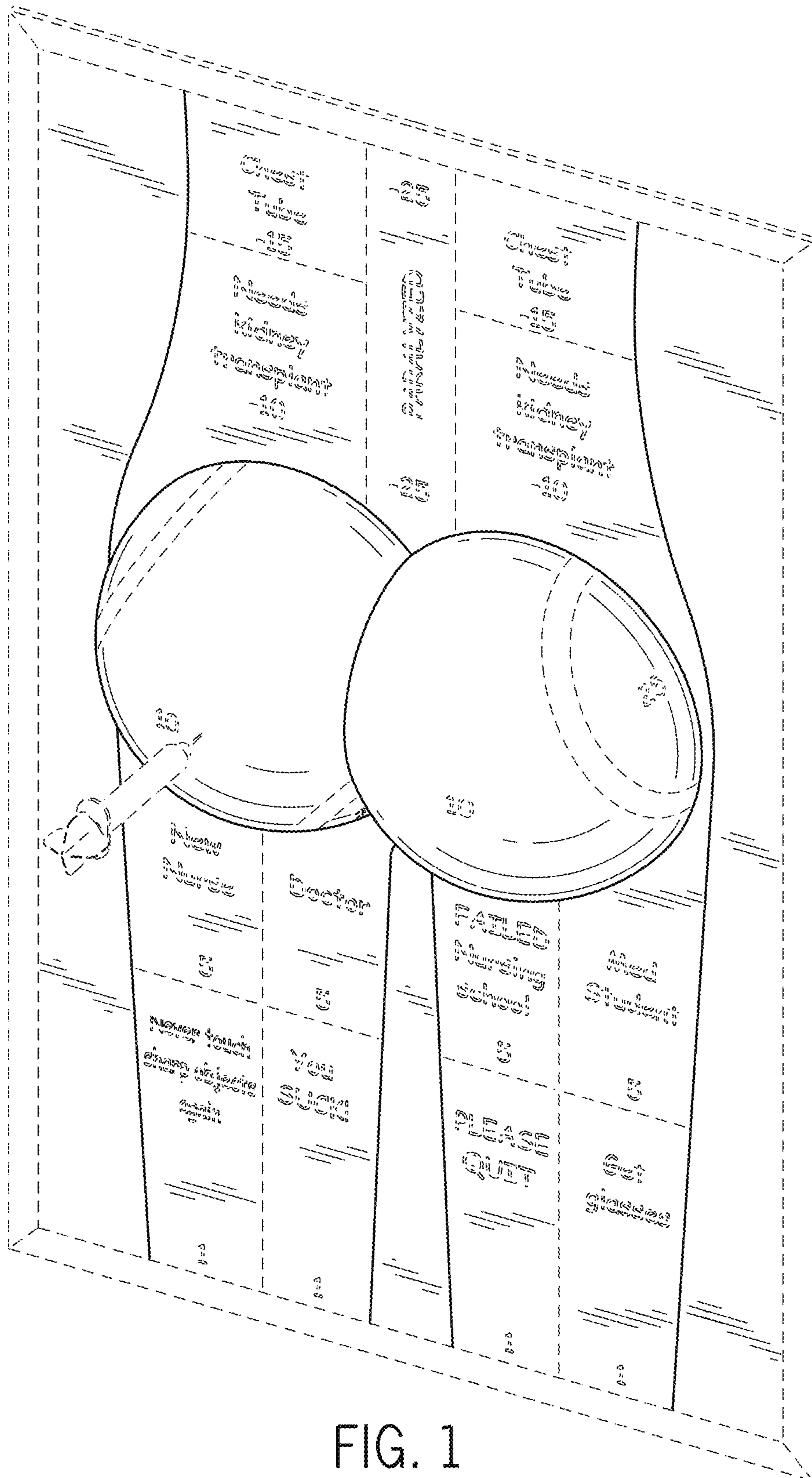

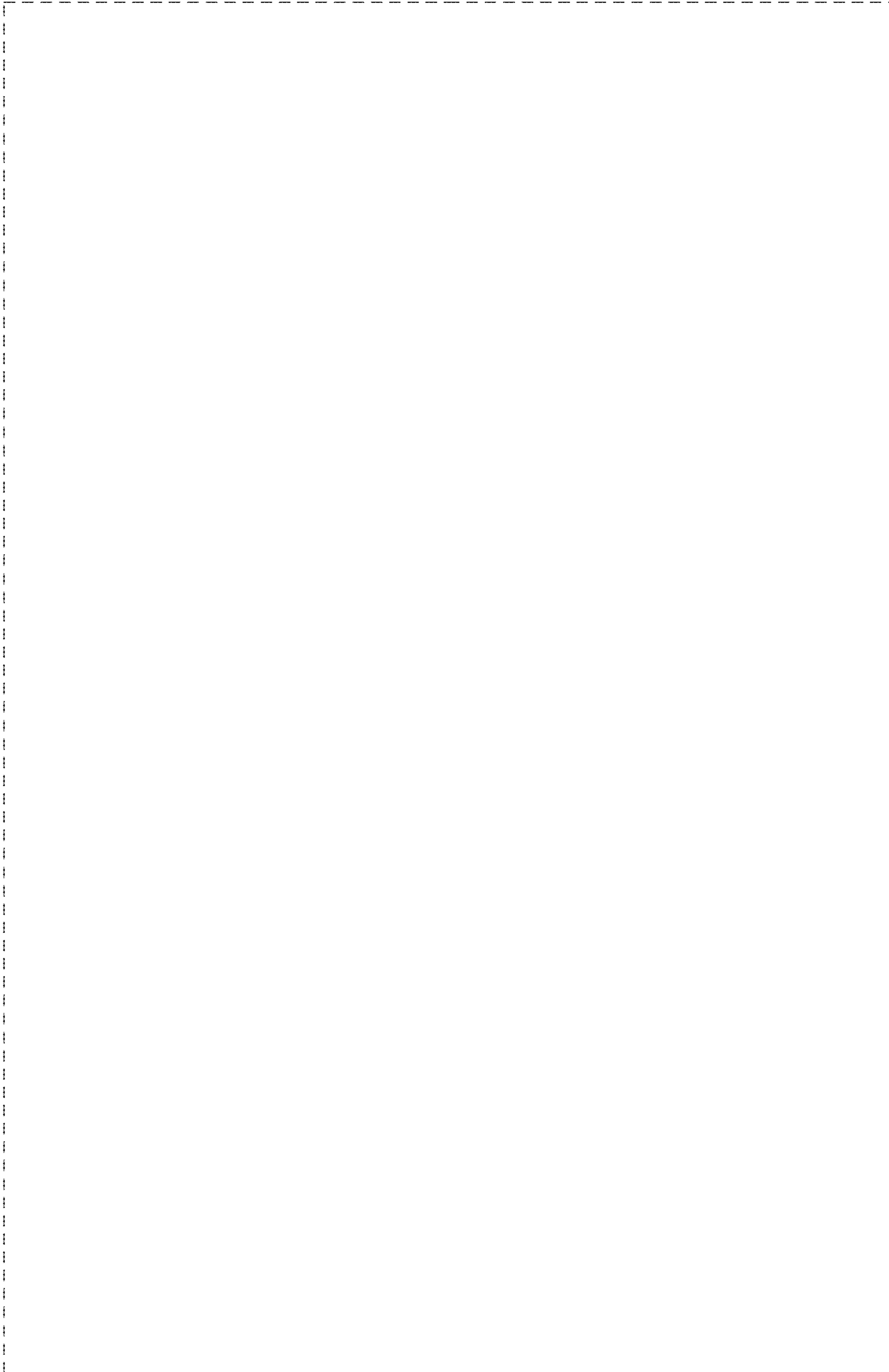

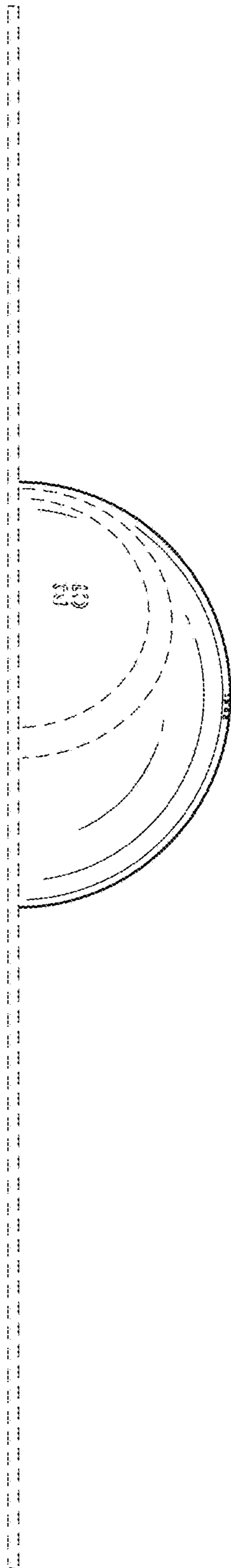

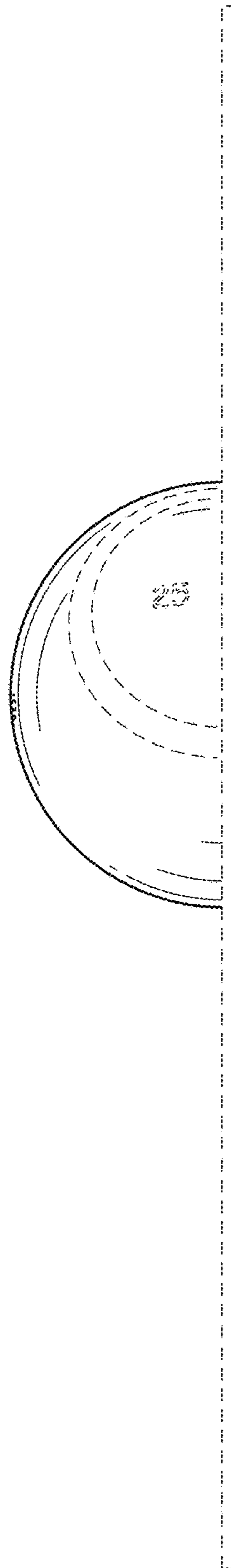

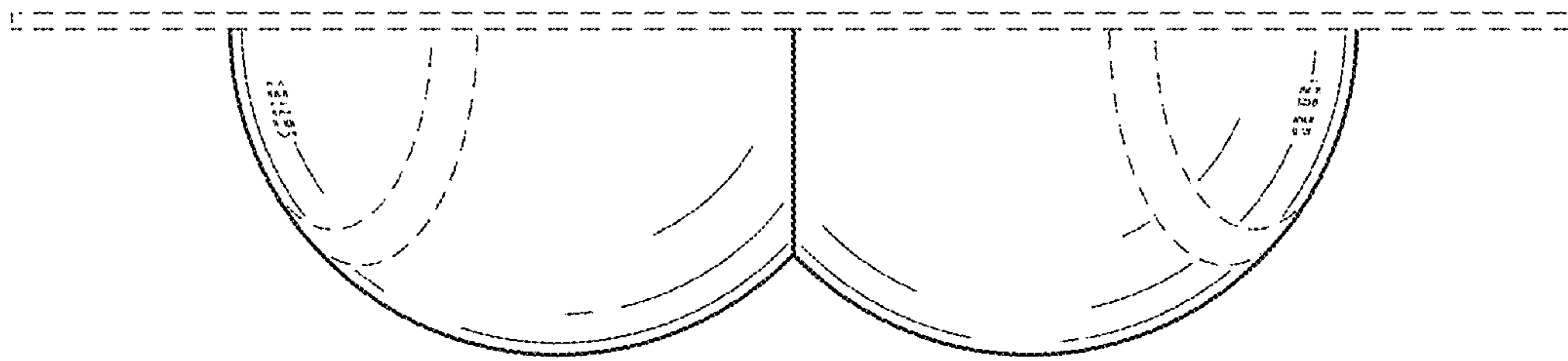

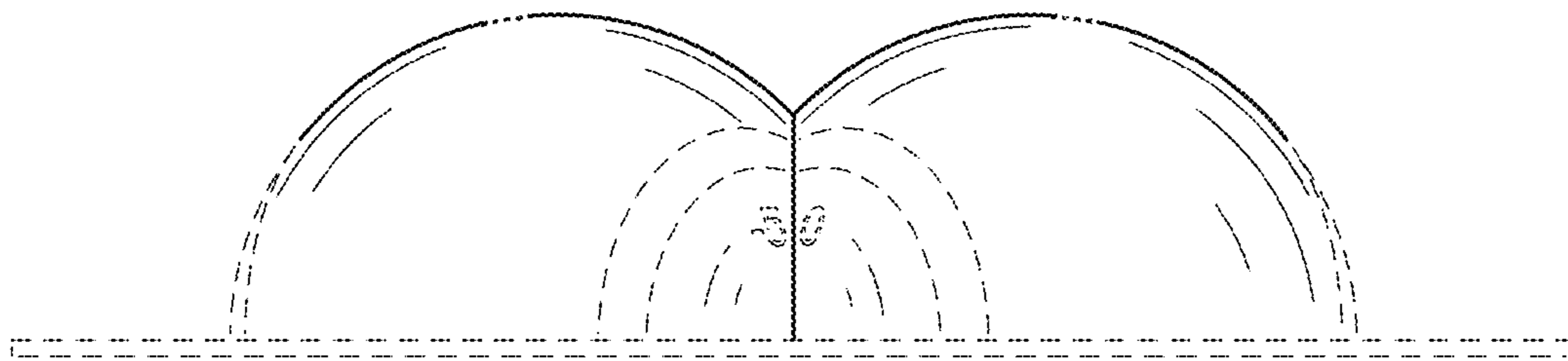
