(57) **CLAIM**

The ornamental design for a water float, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a water float showing, in particular, the ornamental design thereof.

FIG. 5 is a left side view of the water float of FIG. 1; and,

FIG. 6 is a top plan view of the water float of FIG. 1.

The bottom of the water float is flat and devoid of surface ornamentation.

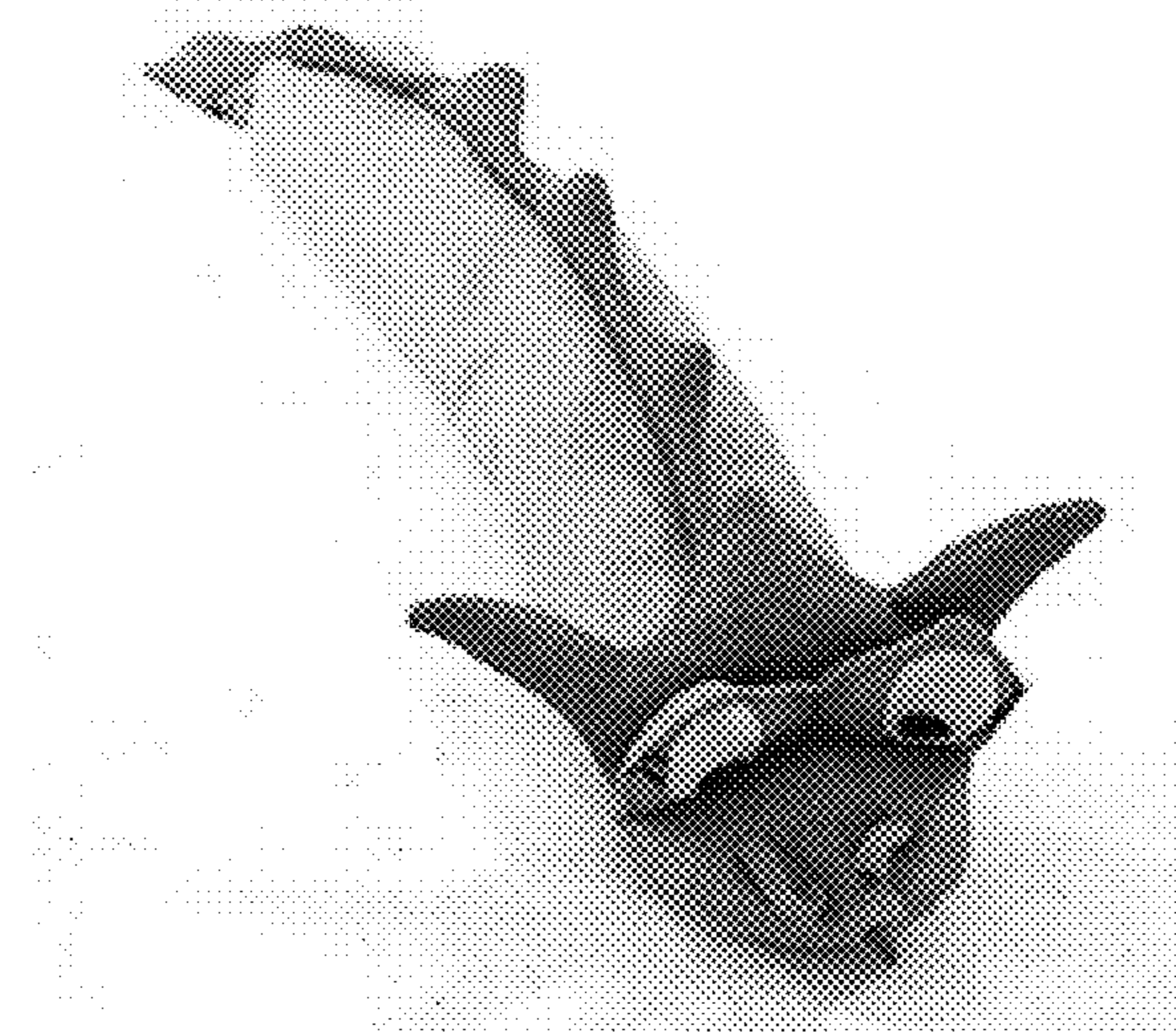

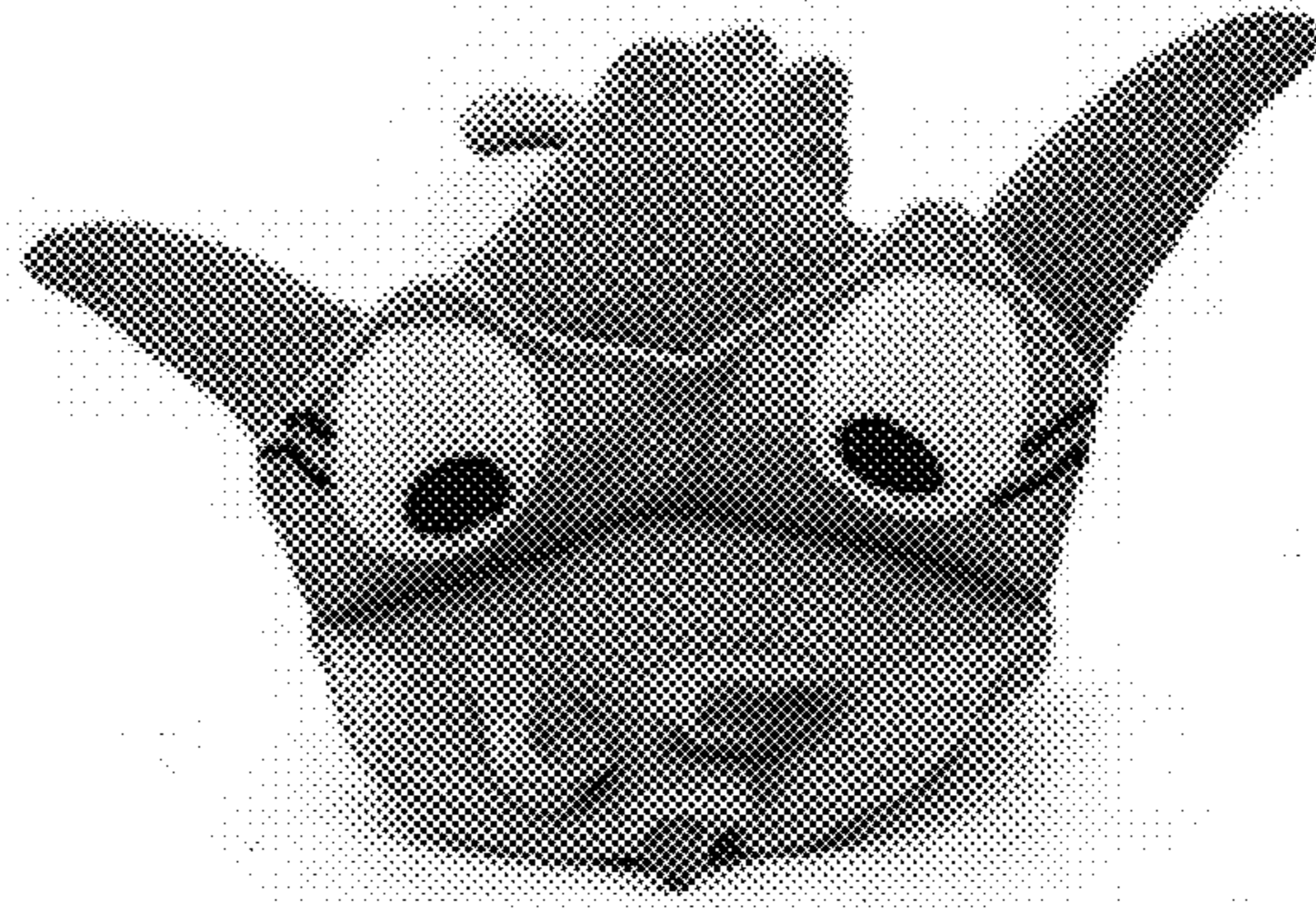

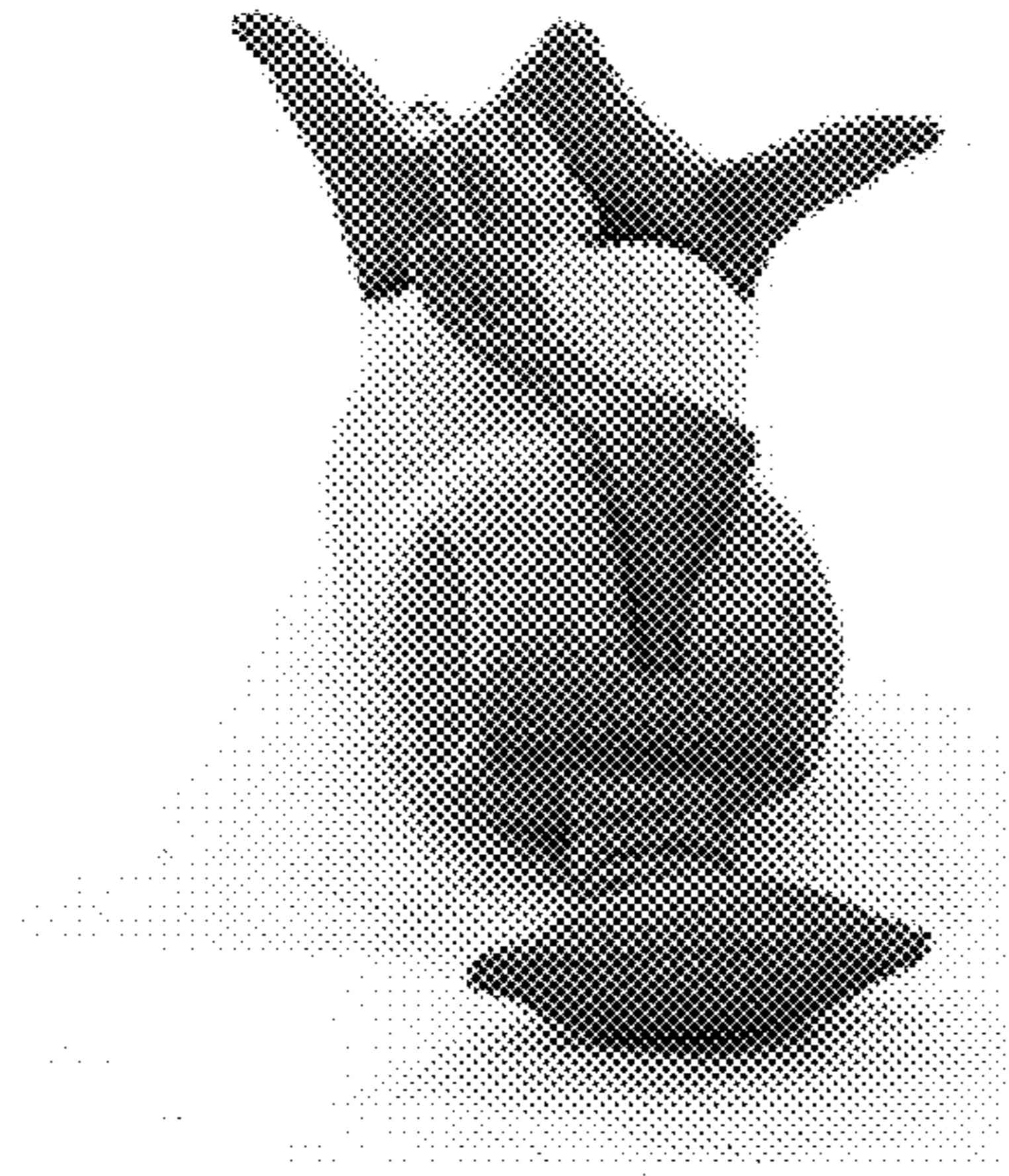

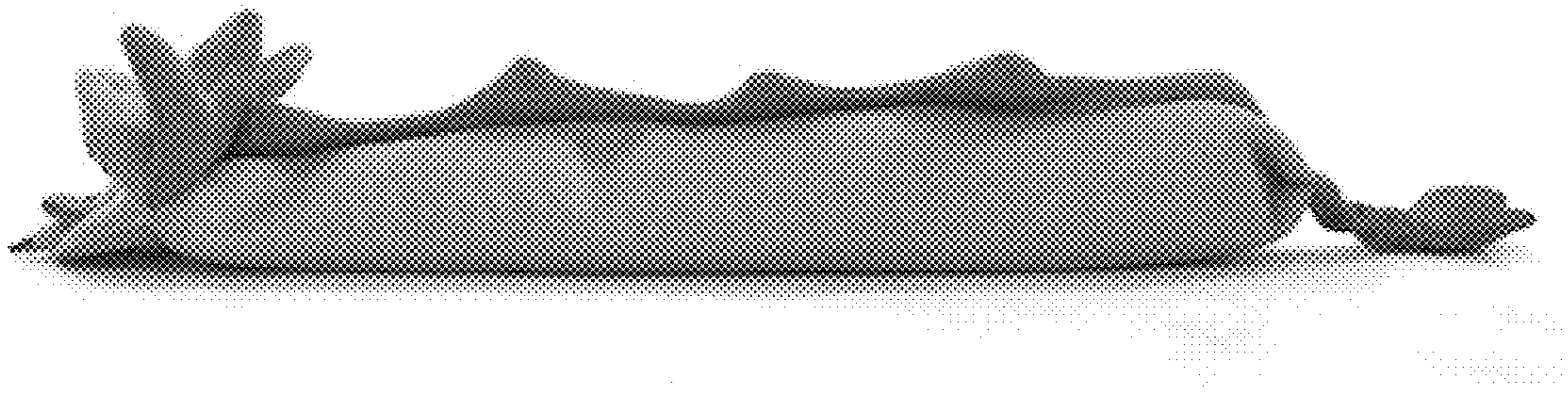

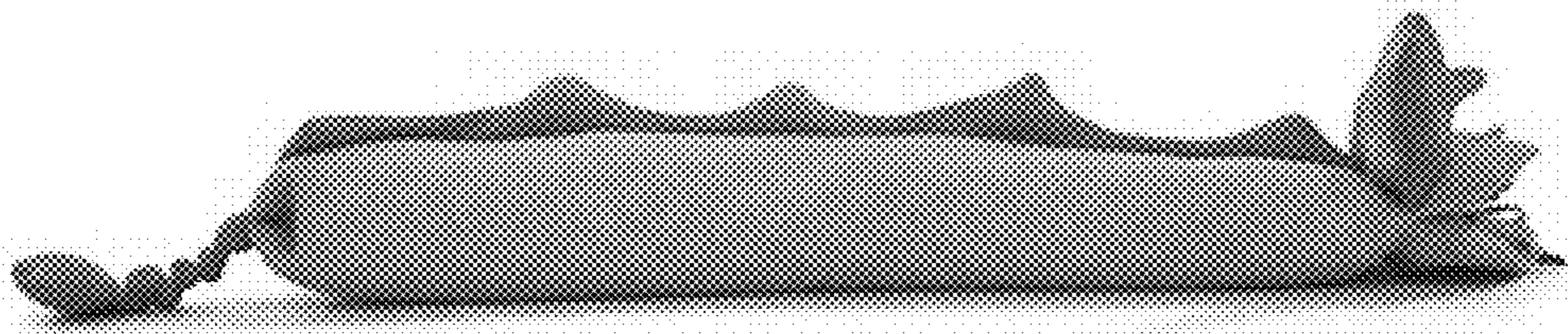

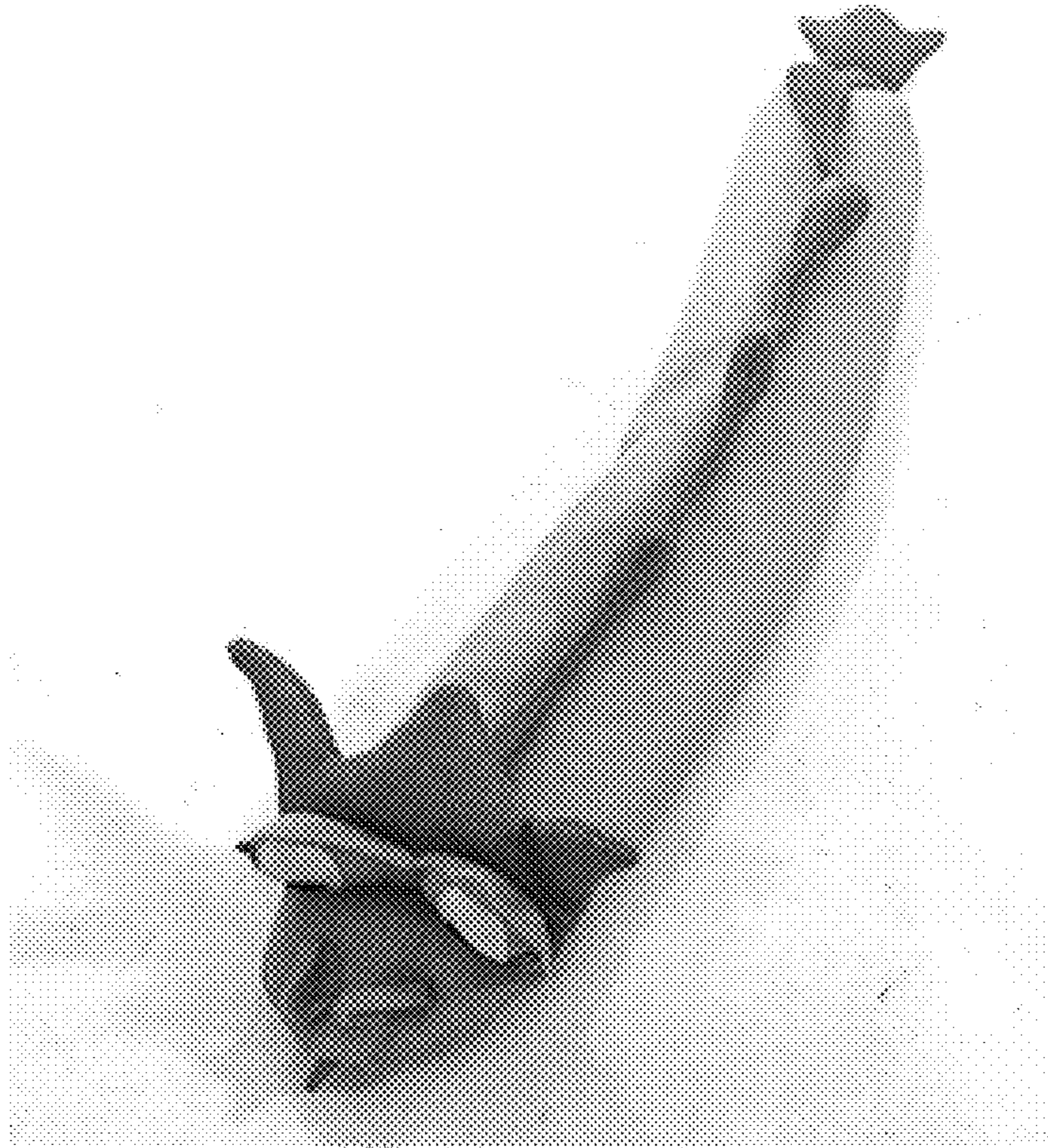
