**DESCRIPTION**

FIG. 21 illustrates a top view of a bath positioner with attachment suction cups according to a second embodiment thereof;

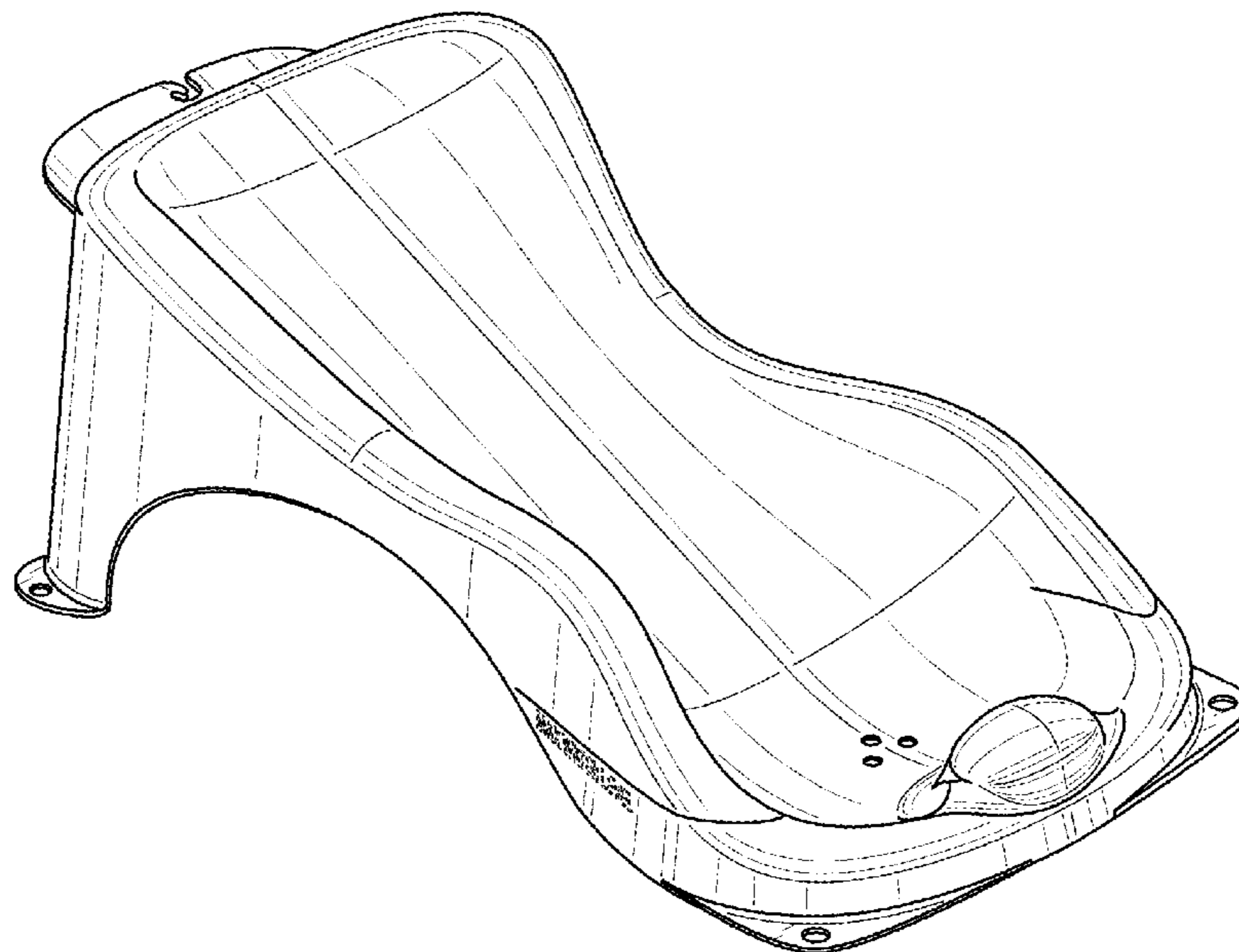
FIG. 22 illustrates a bottom view of FIG. 21;

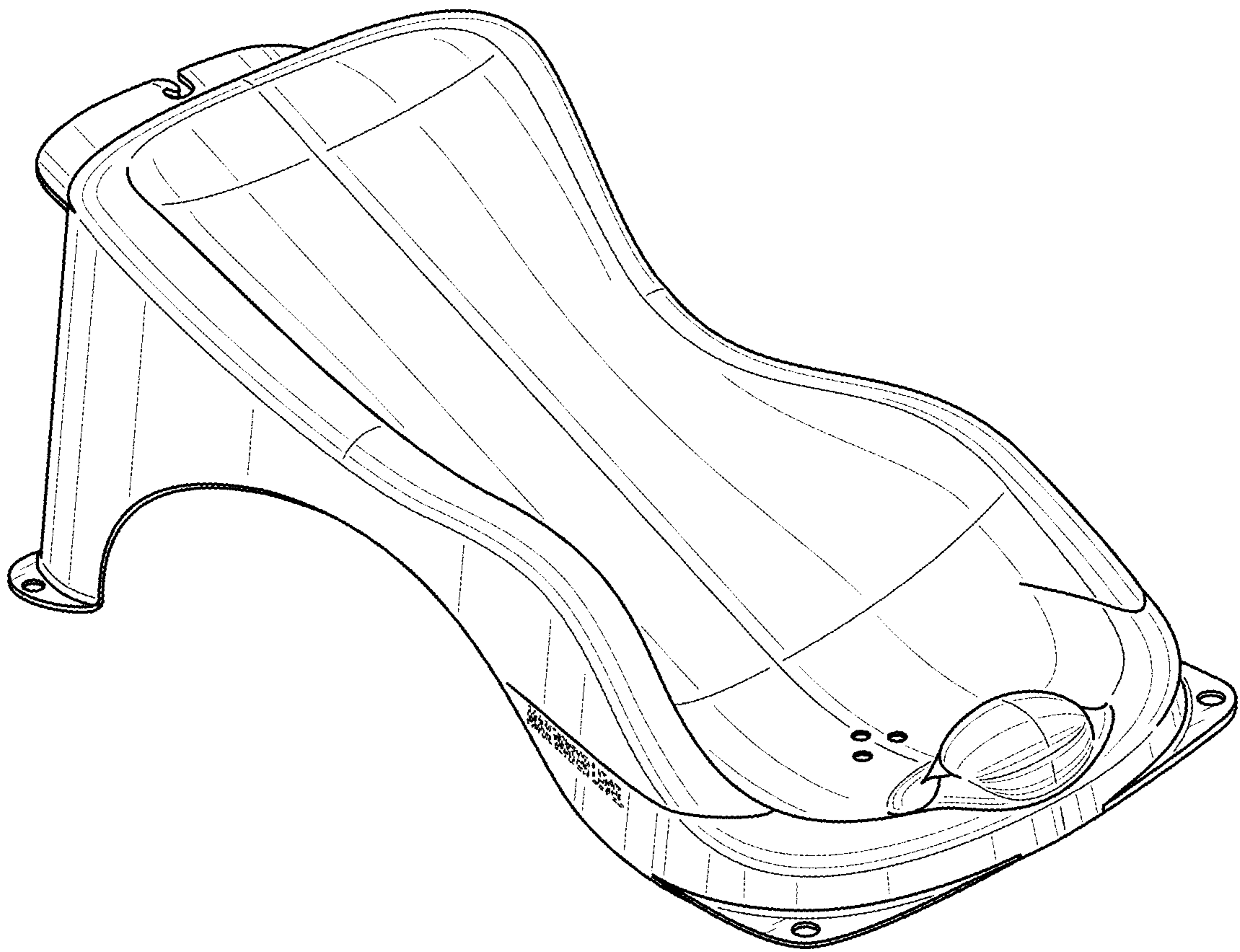

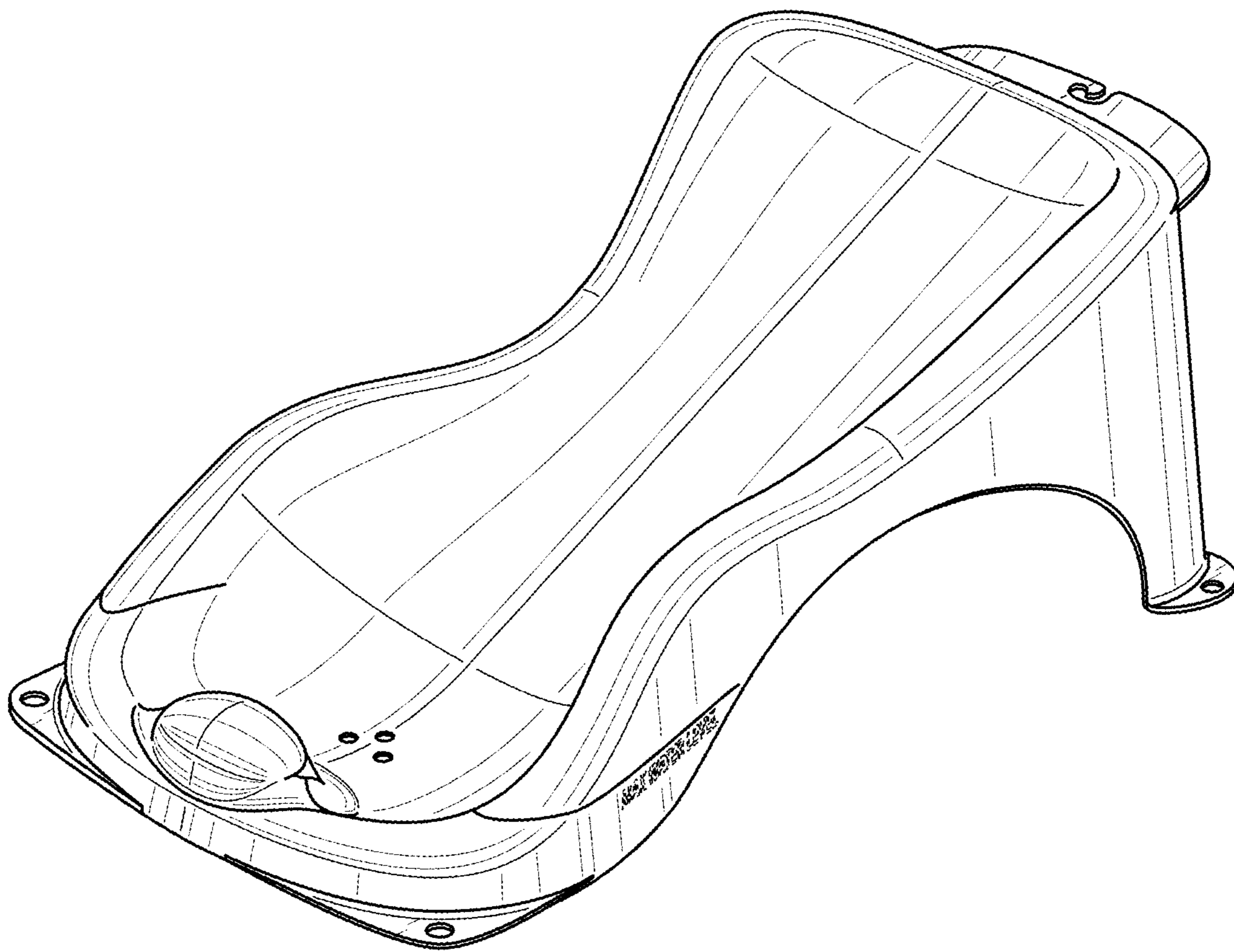

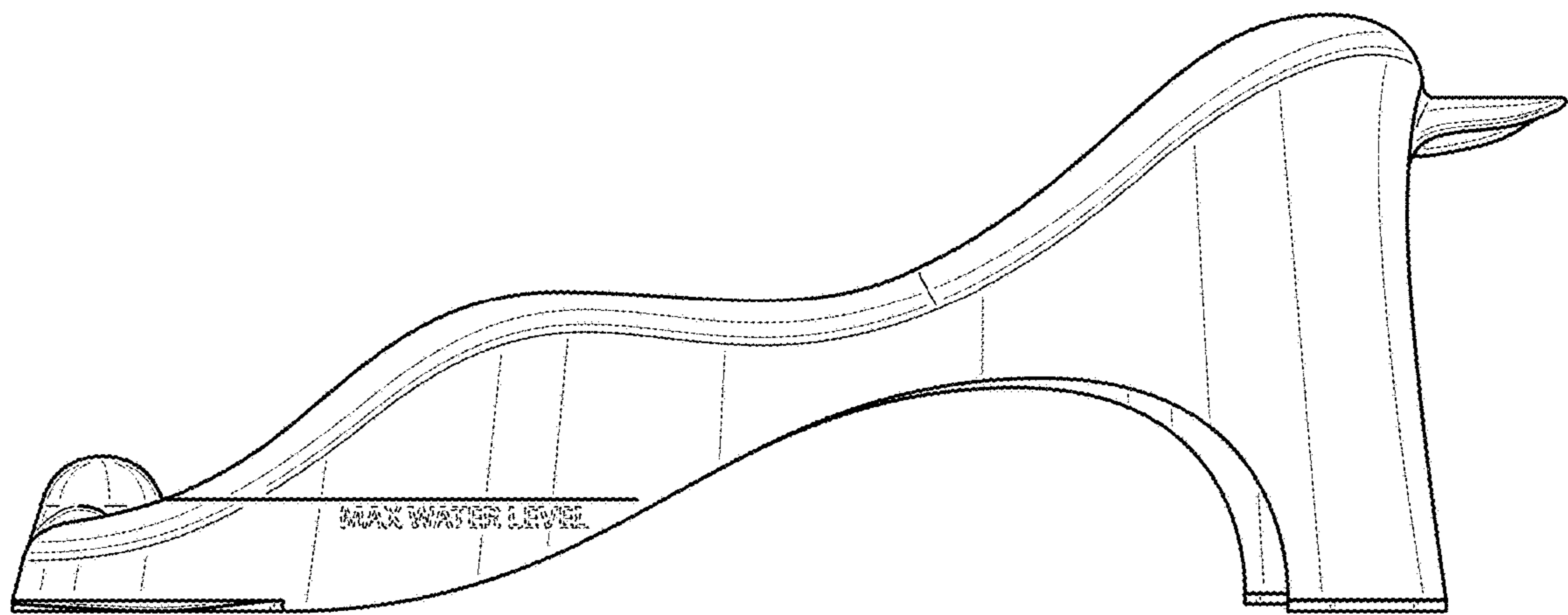

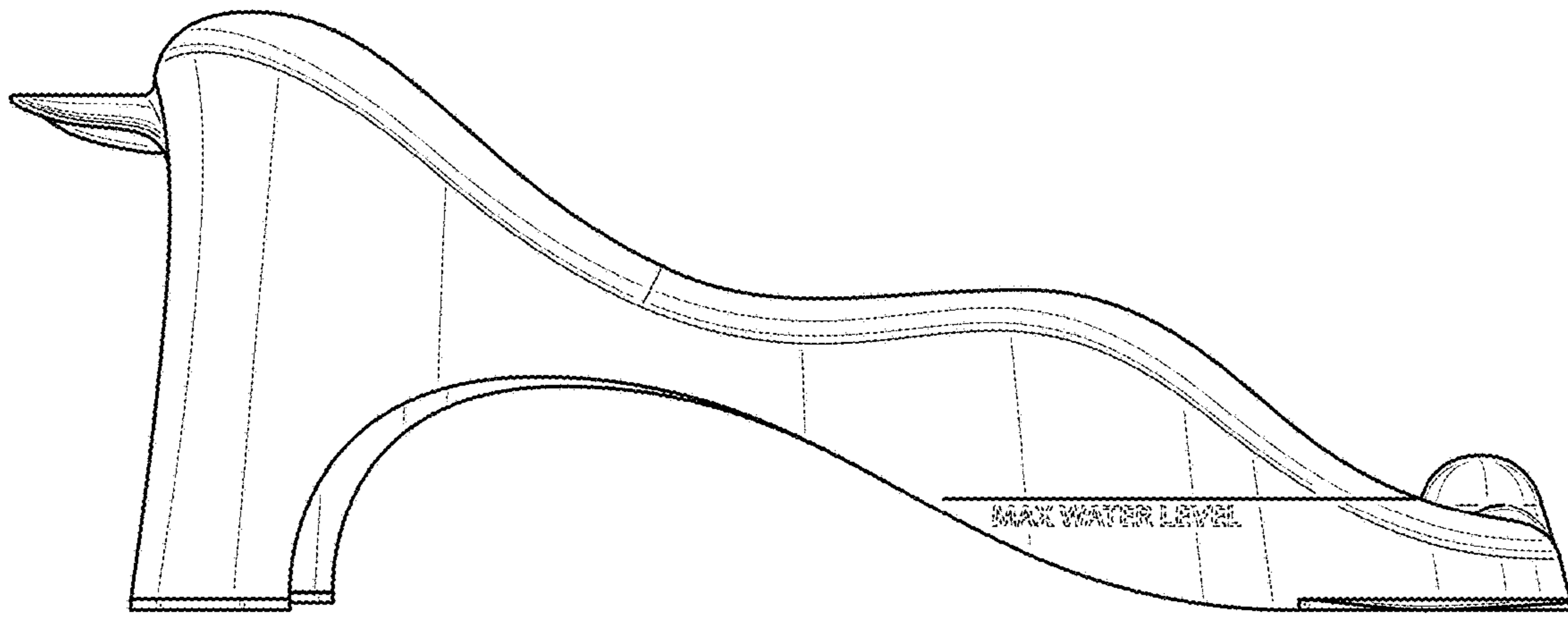

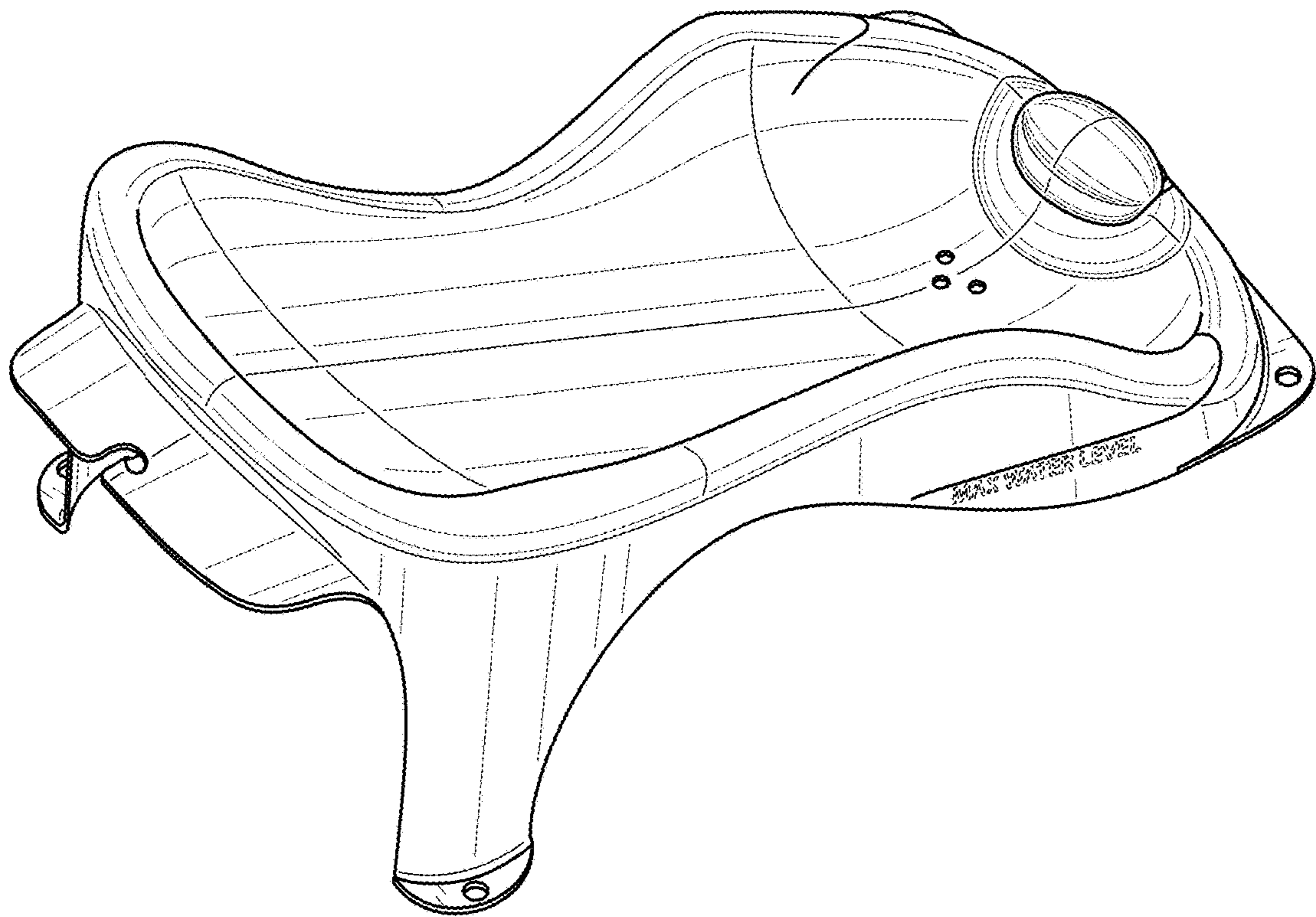

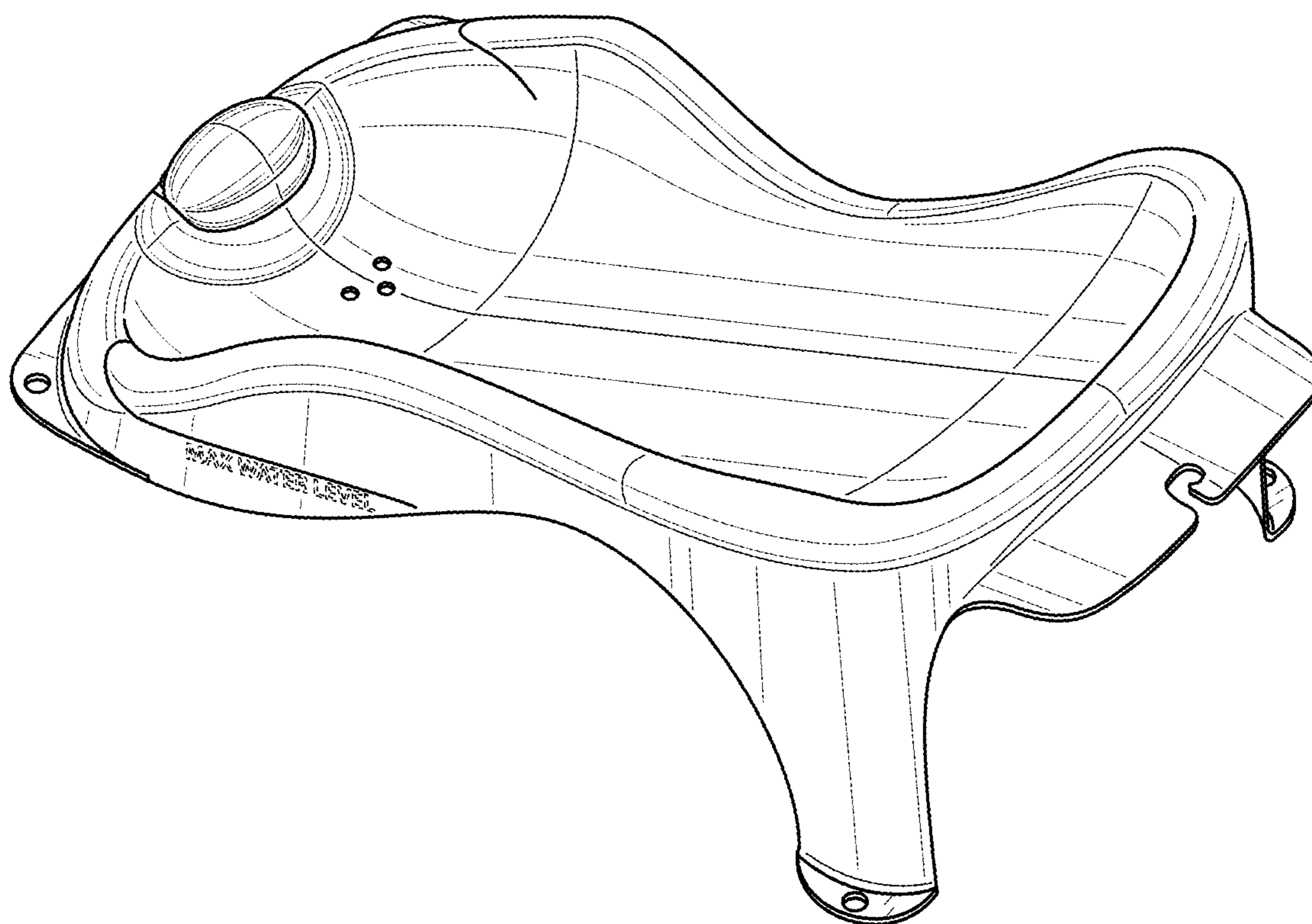

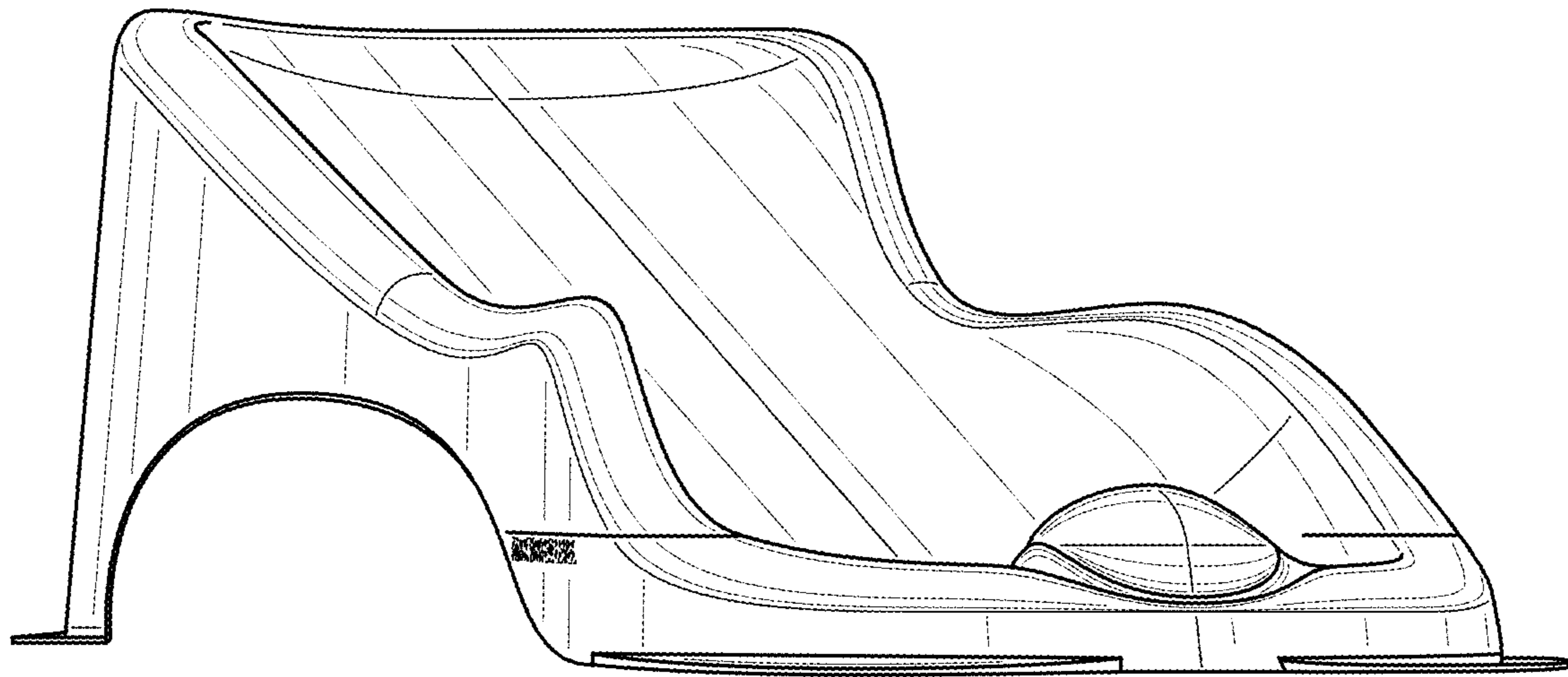

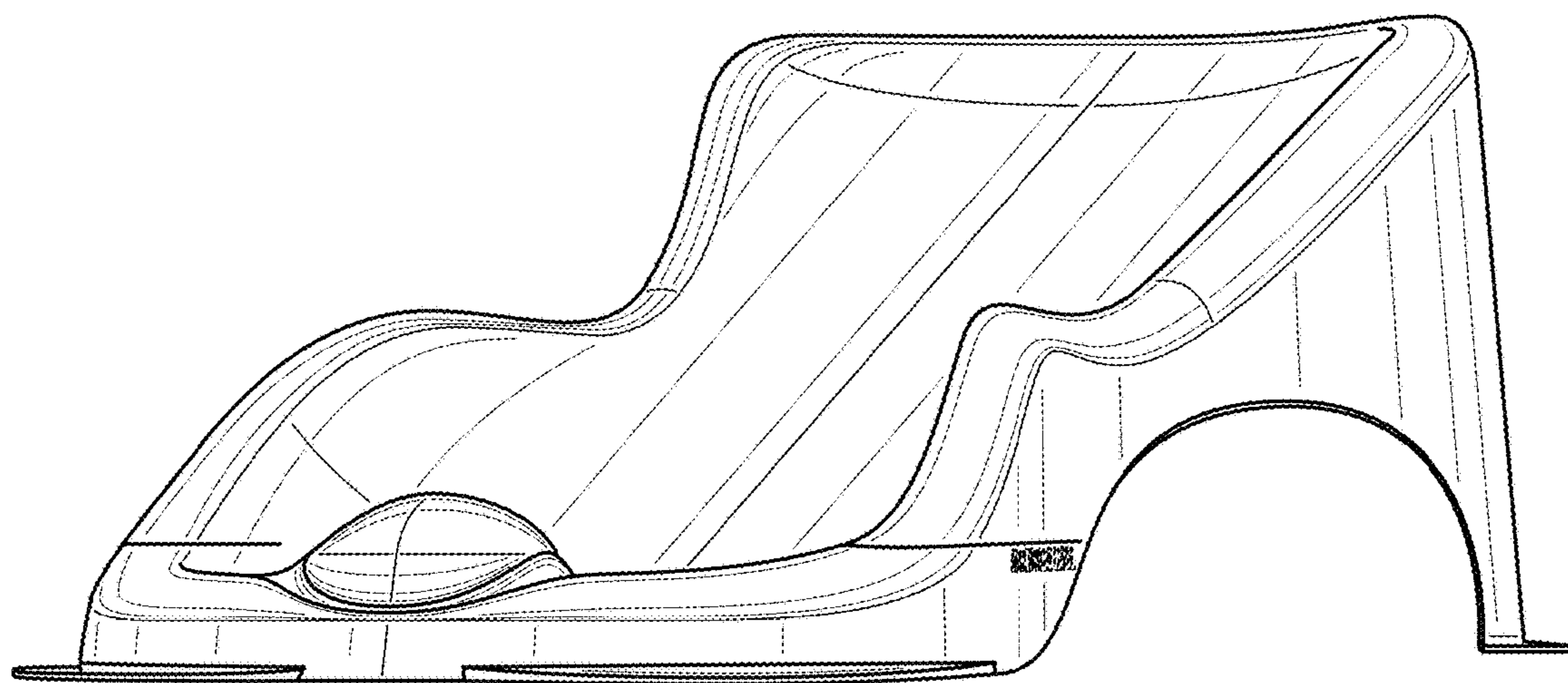

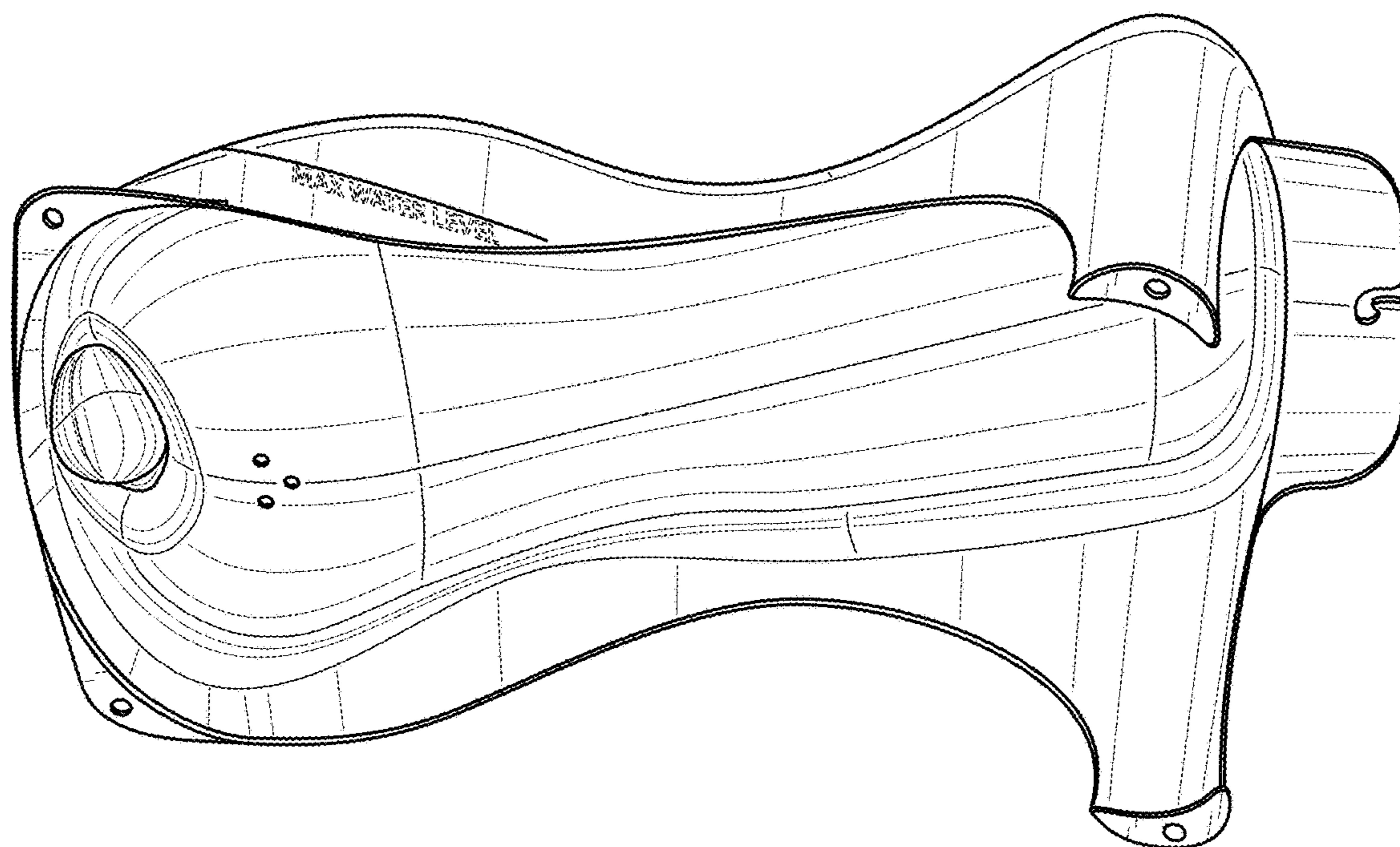

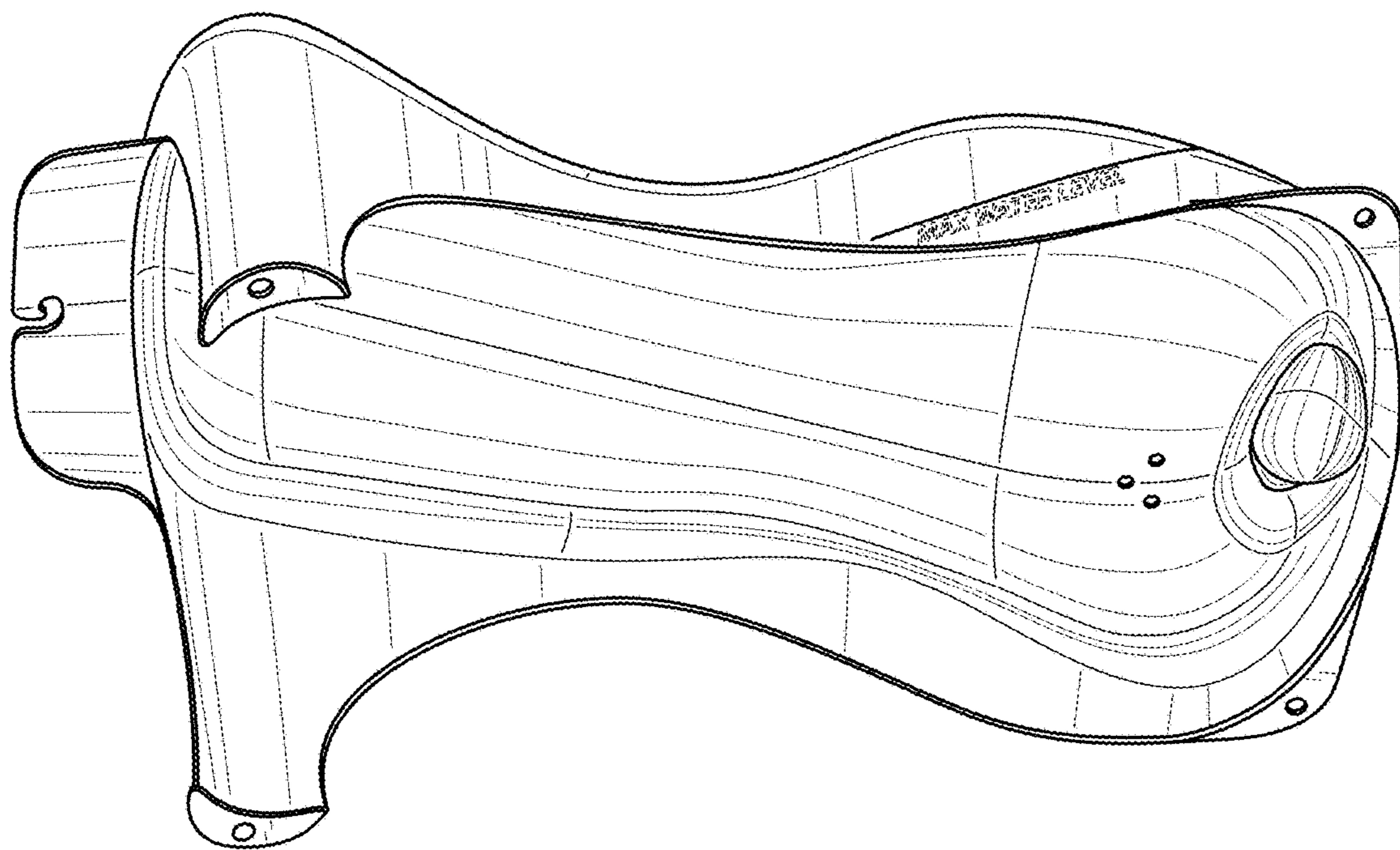

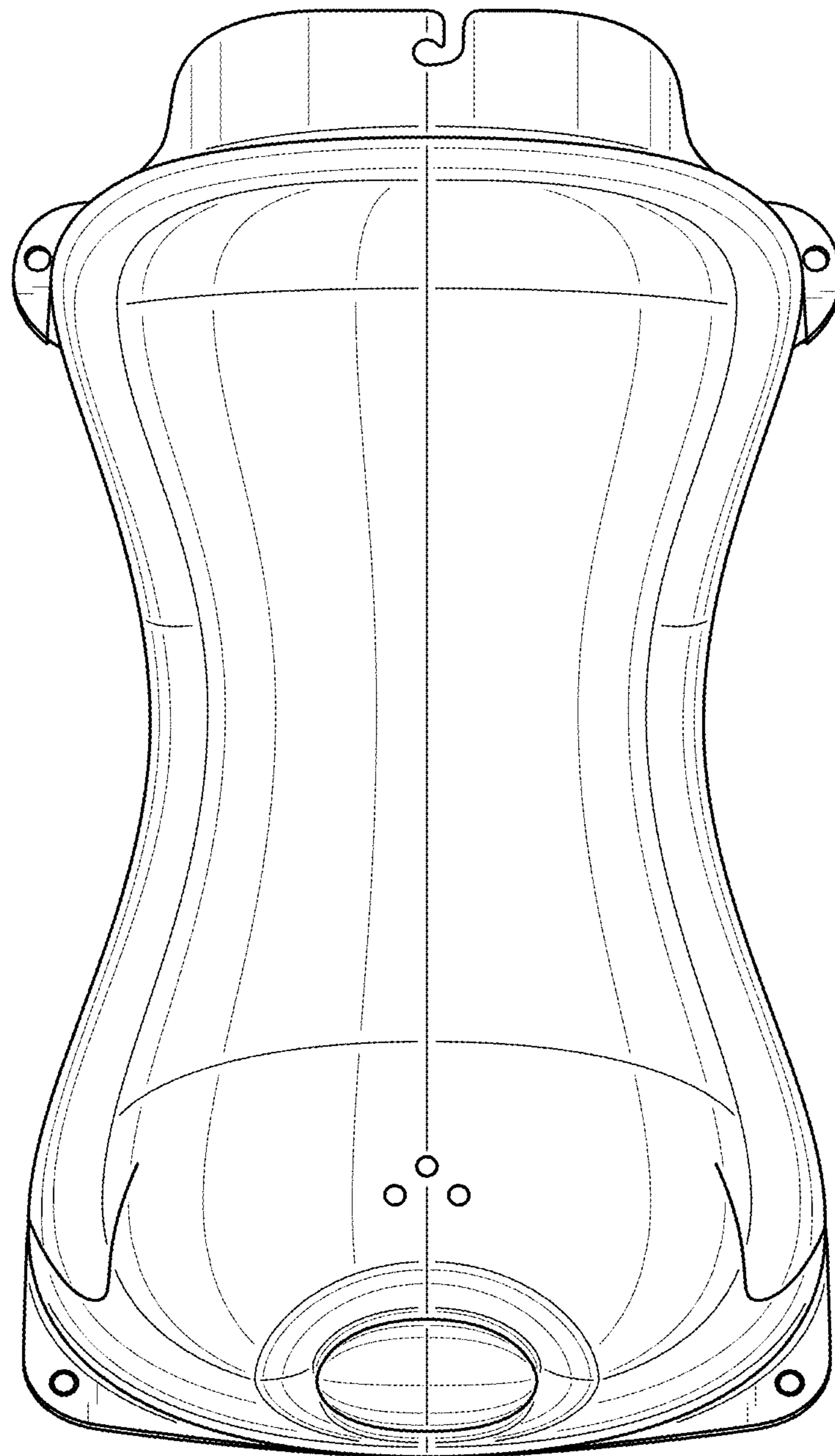

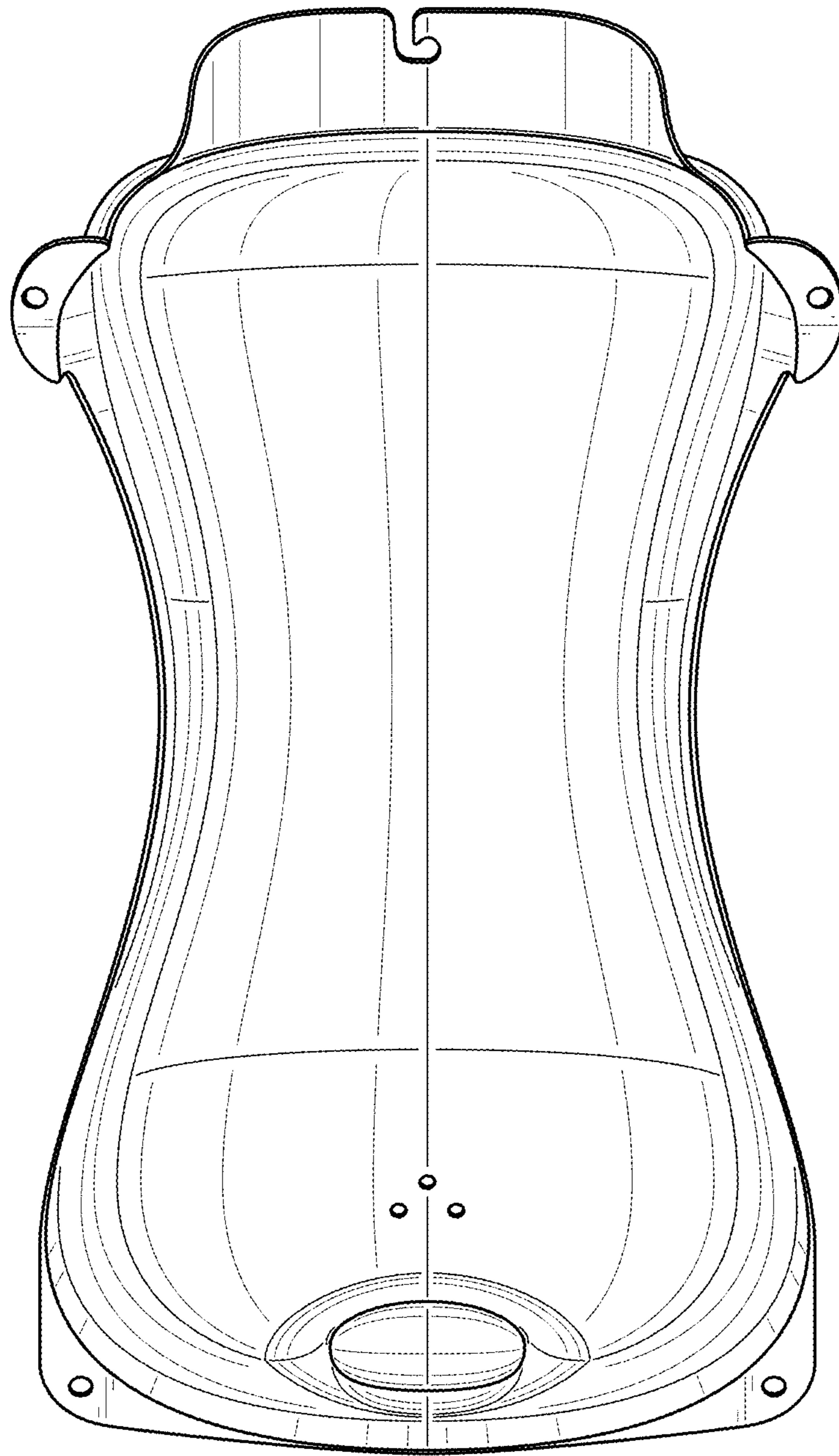

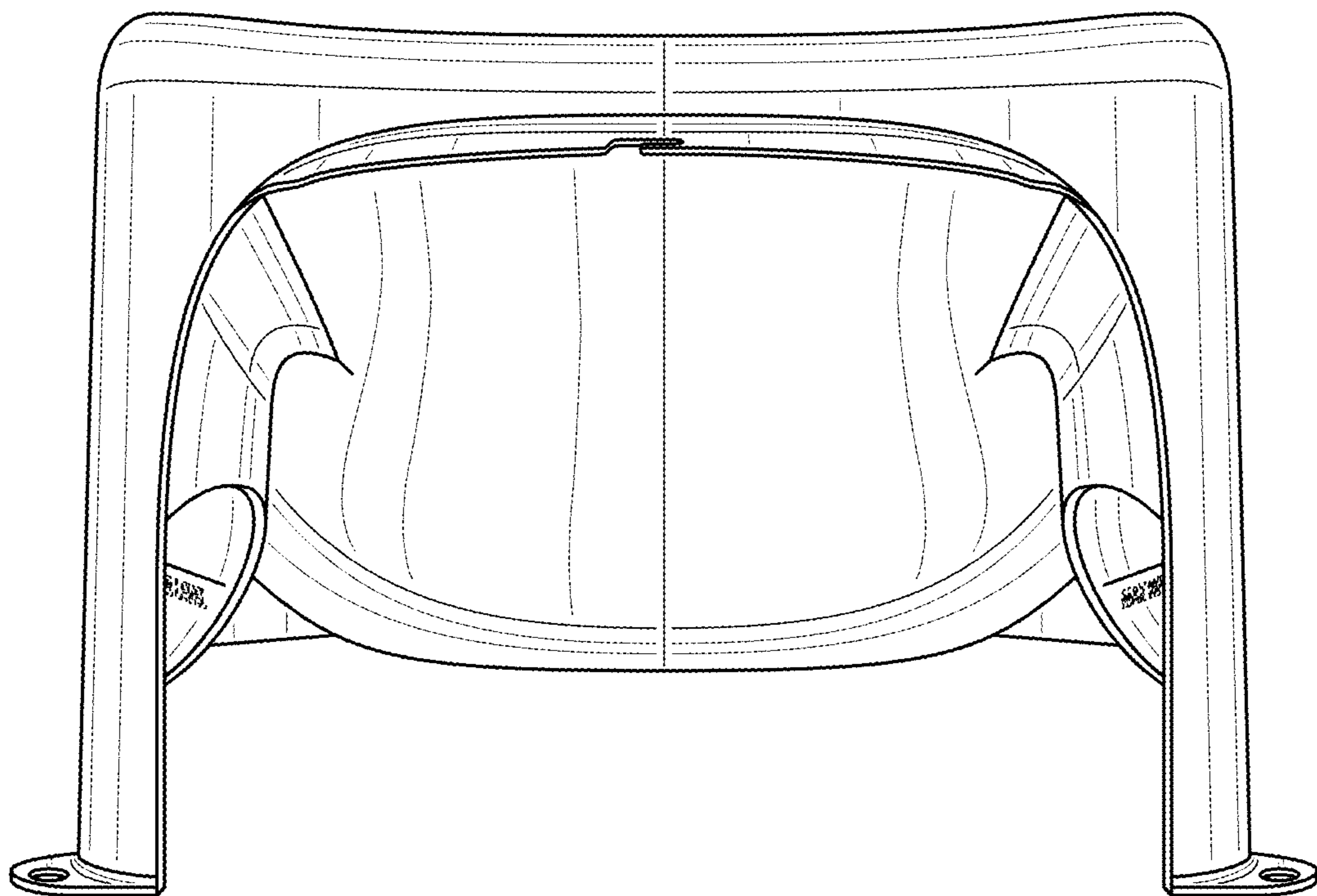

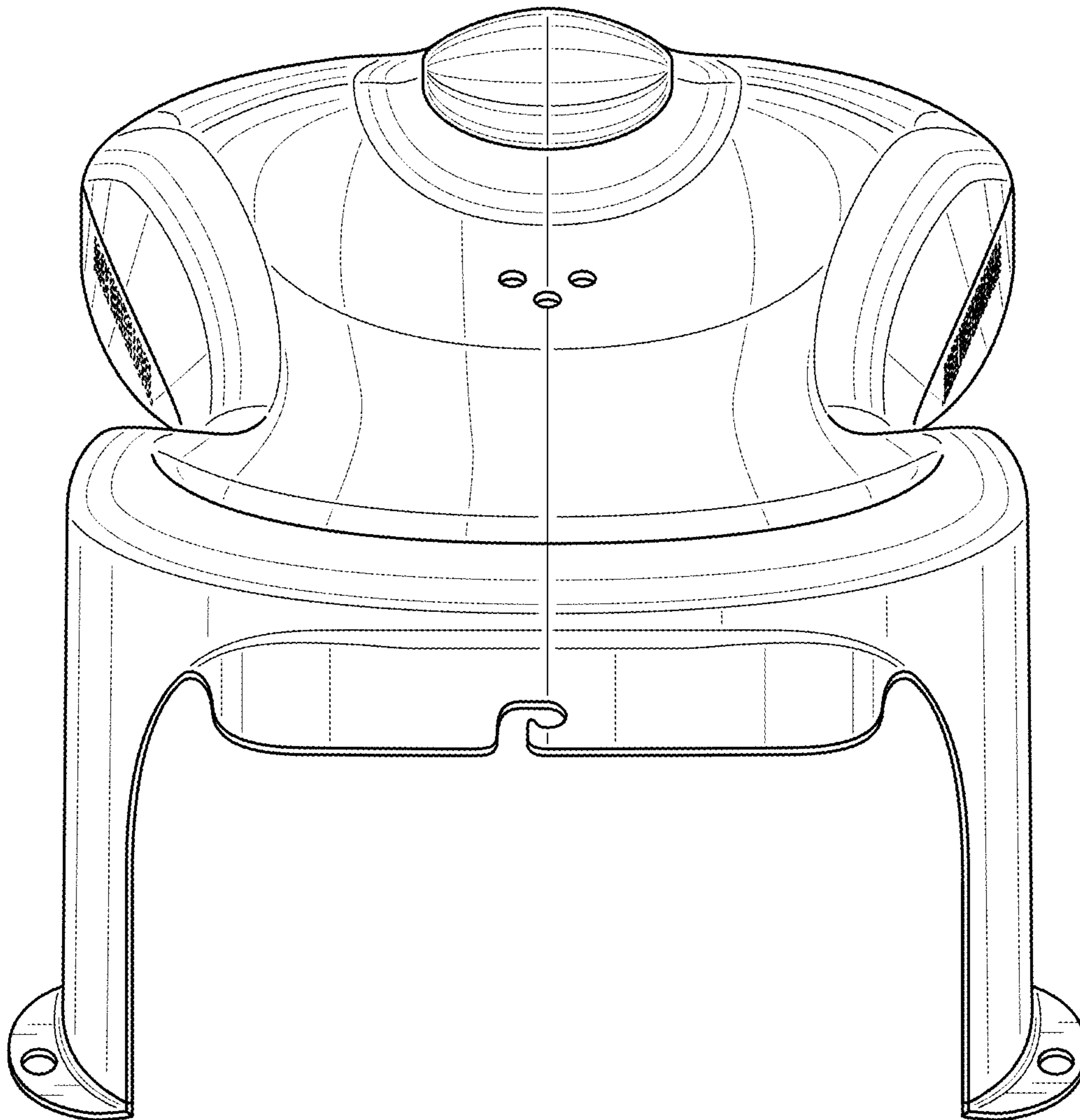

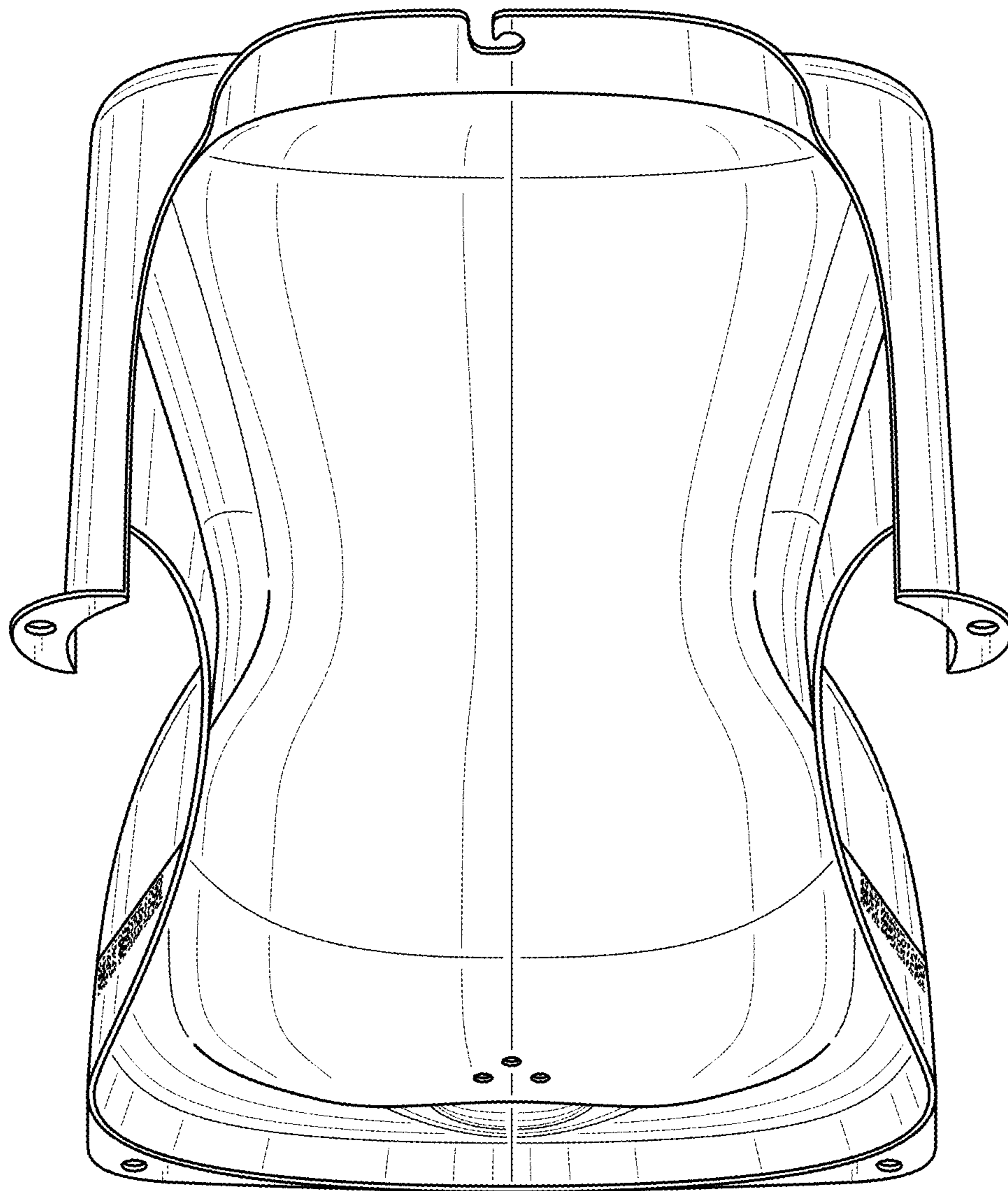

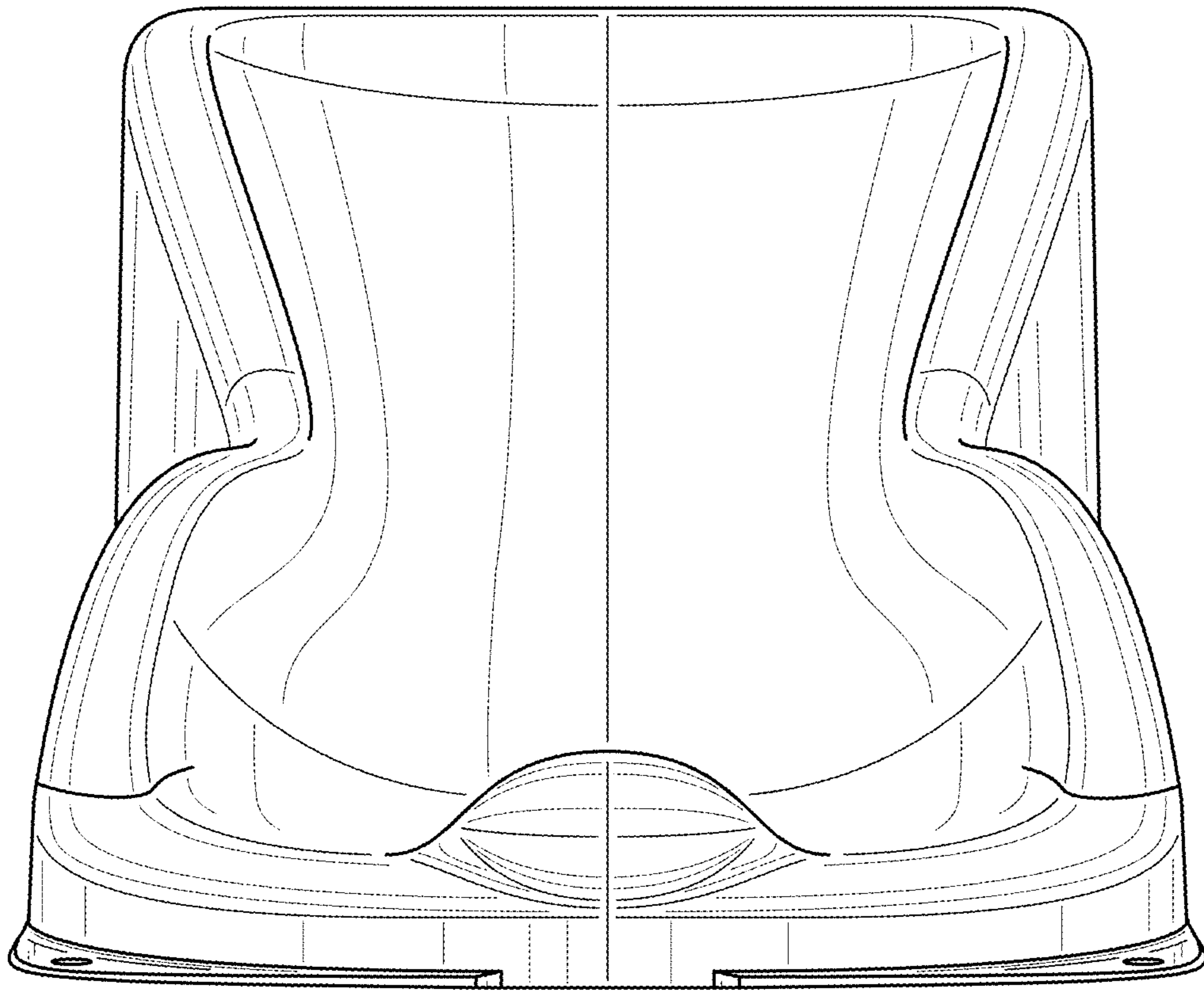

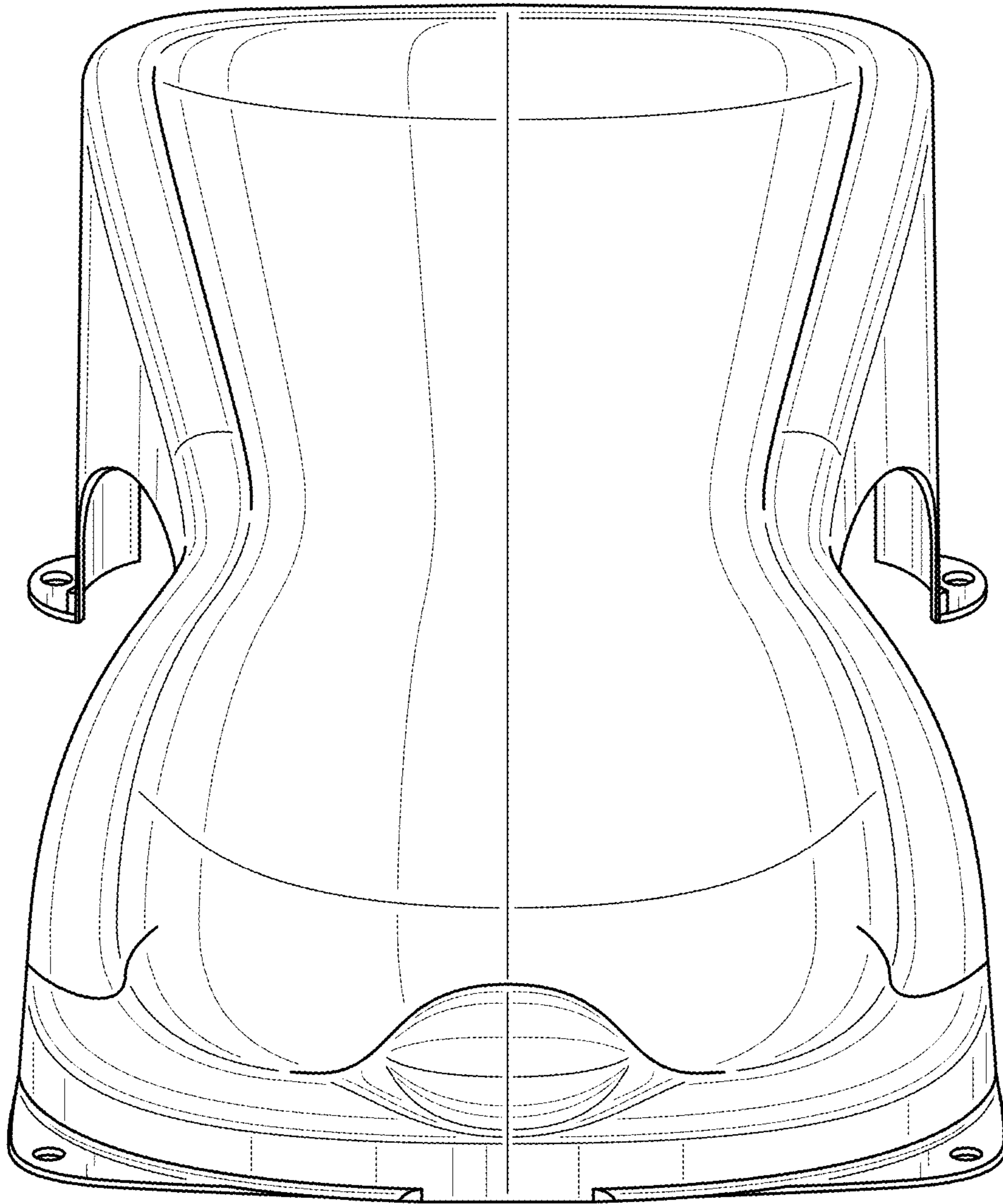

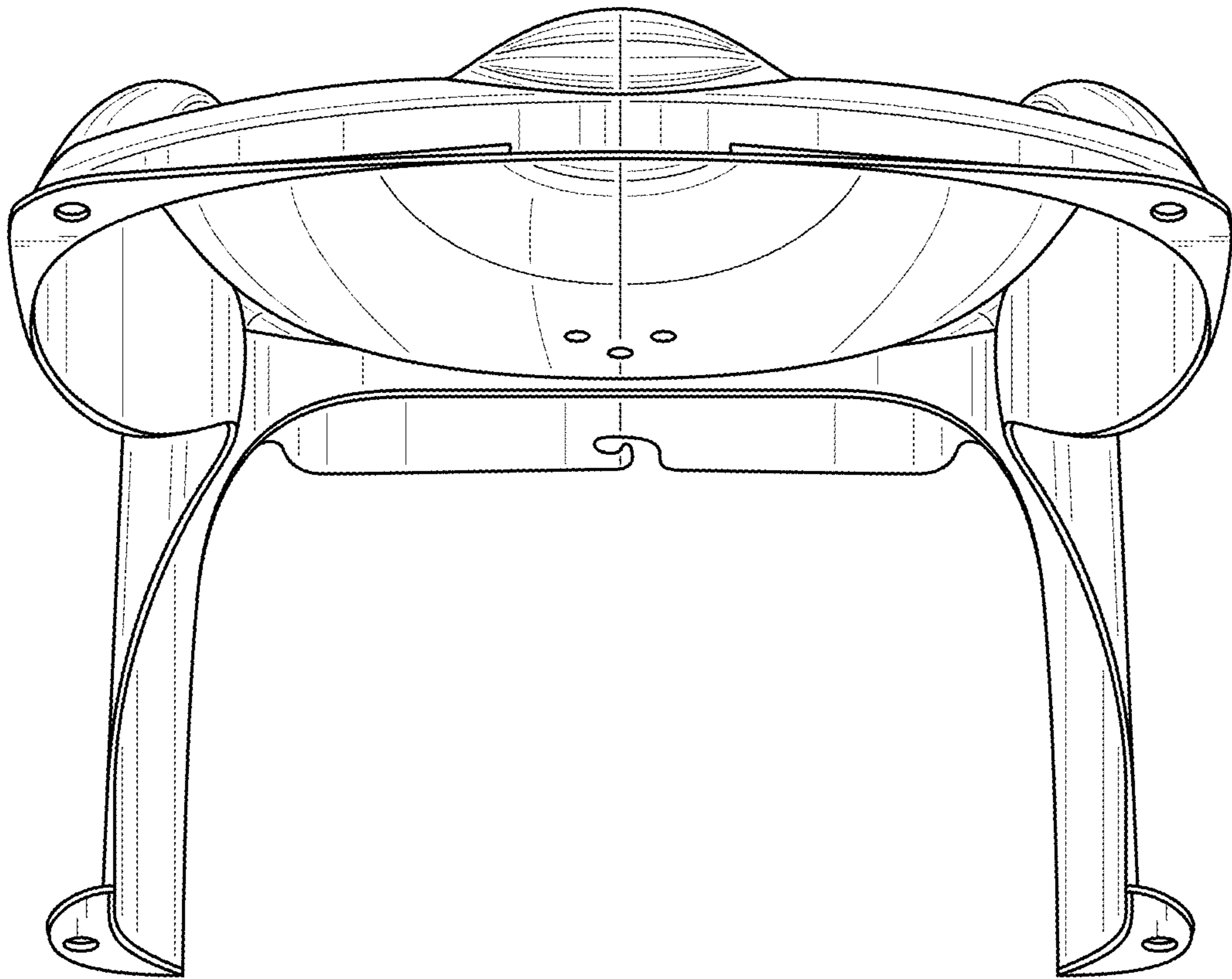

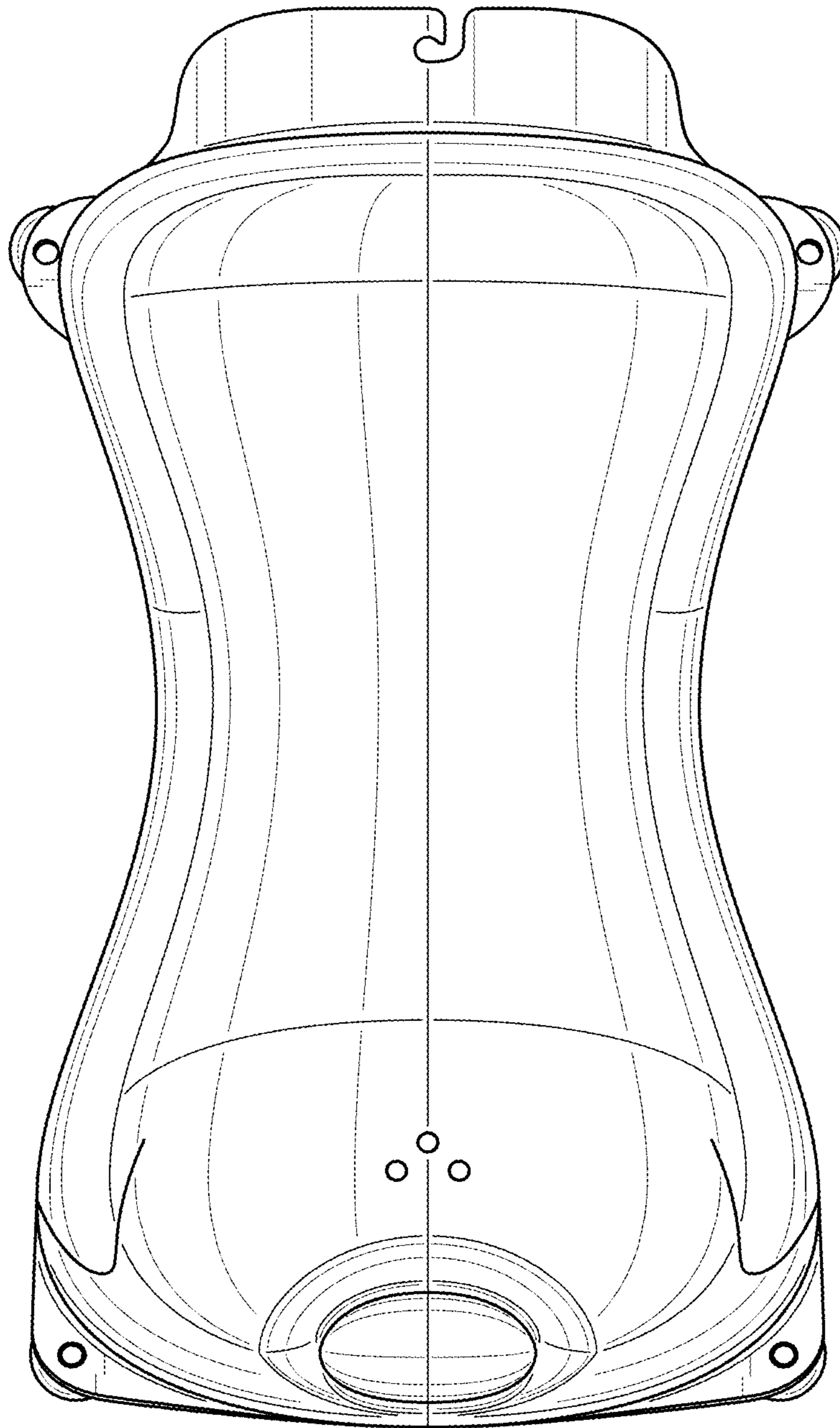

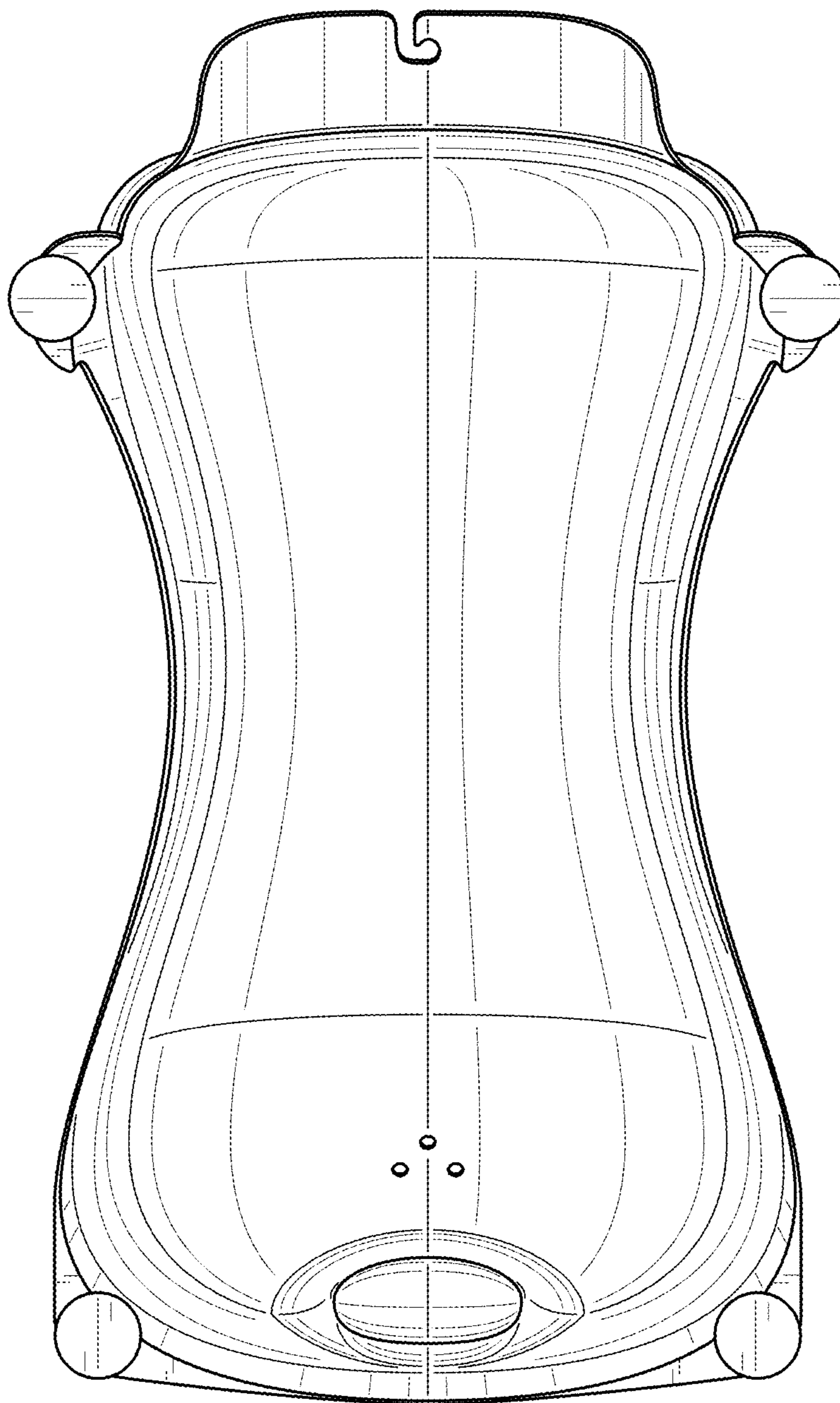

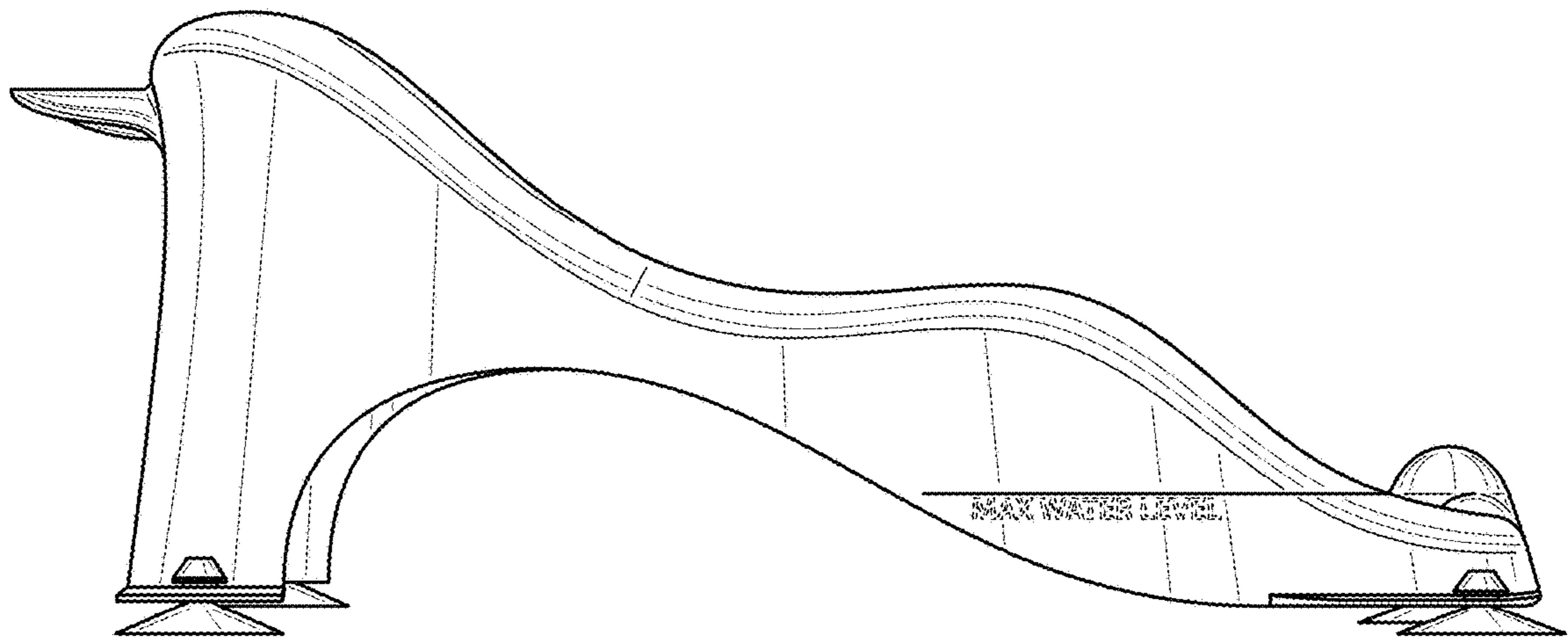

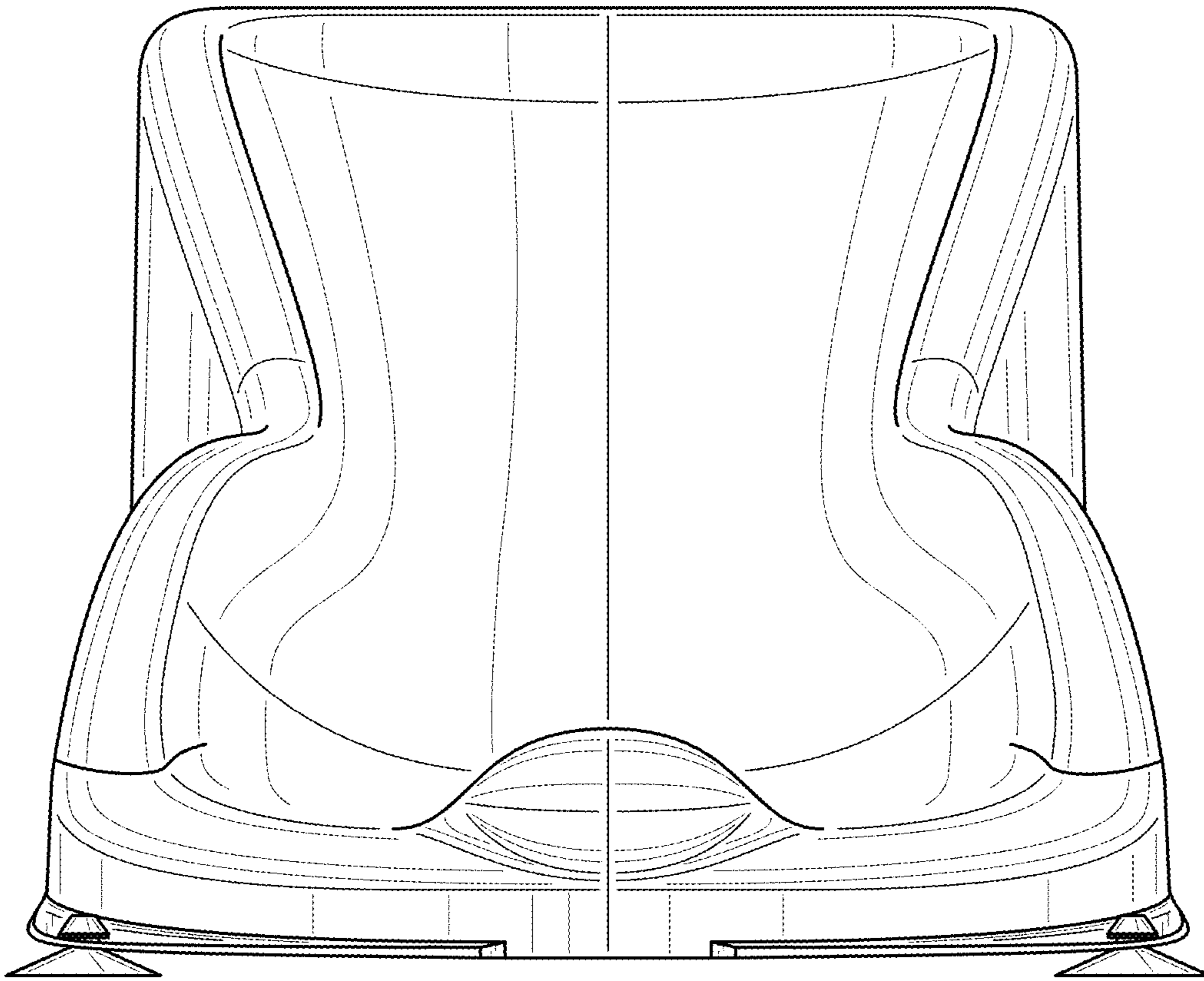

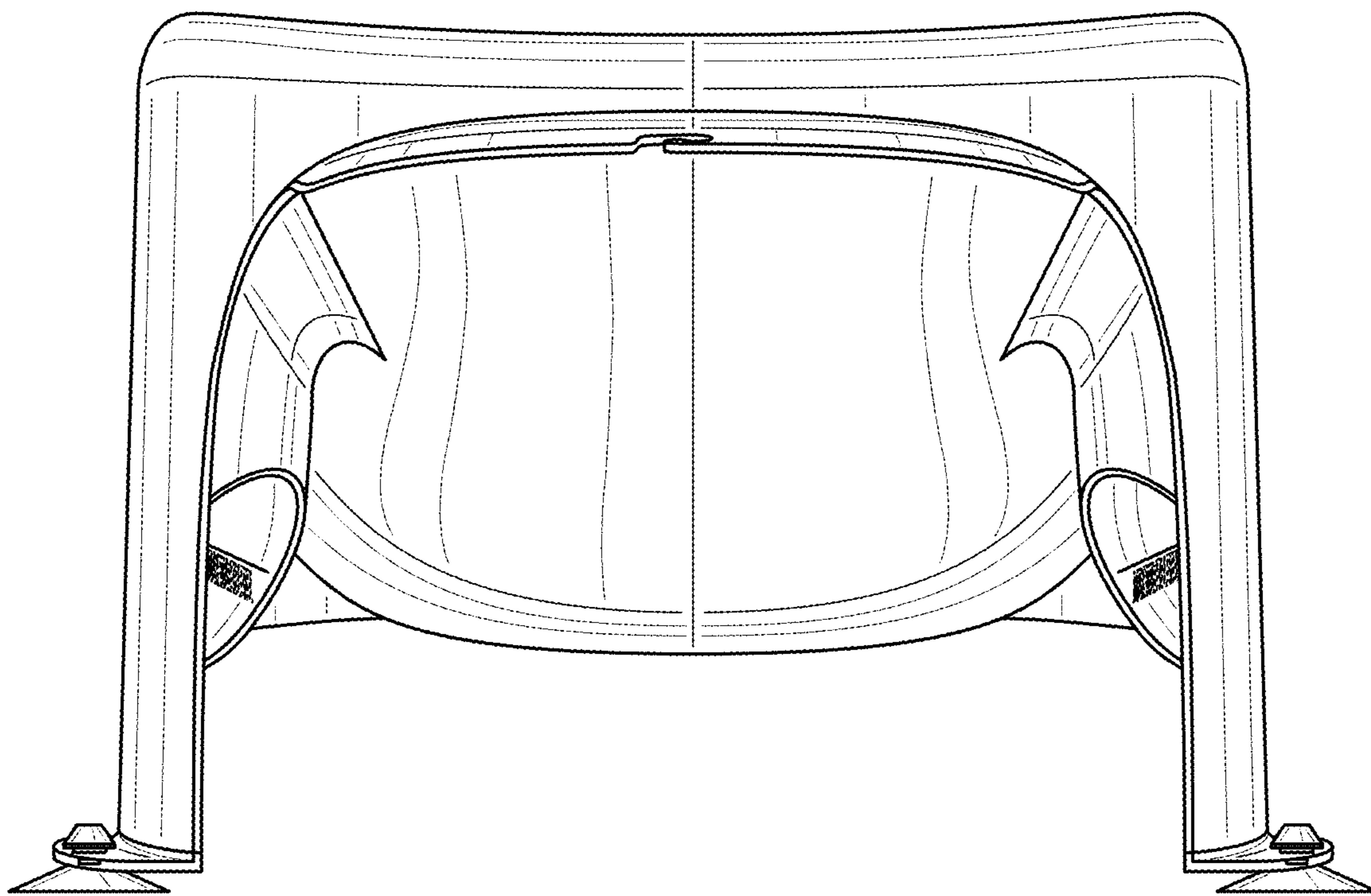
