DESCRIPTION

FIG. 1 is a top perspective view of a small volume sampling device showing my new design;

FIG. 2 is a left side elevation view of the small volume sampling device of FIG. 1;

FIG. 3 is a side elevation view of the small volume sampling device of FIG. 1 with a 90 degree rotation about the center axis in relation to FIG. 2;

FIG. 4 is a right side elevation view of the small volume sampling device of FIG. 1;

FIG. 5 is a side elevation view of the small volume sampling device of FIG. 1 with a 90 degree rotation about the center axis in relation to FIG. 4;

FIG. 6 is a top plan view of the small volume sampling device of FIG. 1; and,

FIG. 7 is a bottom plan view of the small volume sampling device of FIG. 1.

The broken lines showing the internal cavity of the small volume sampling device and the volume quantity indicia form no part of the claimed design.

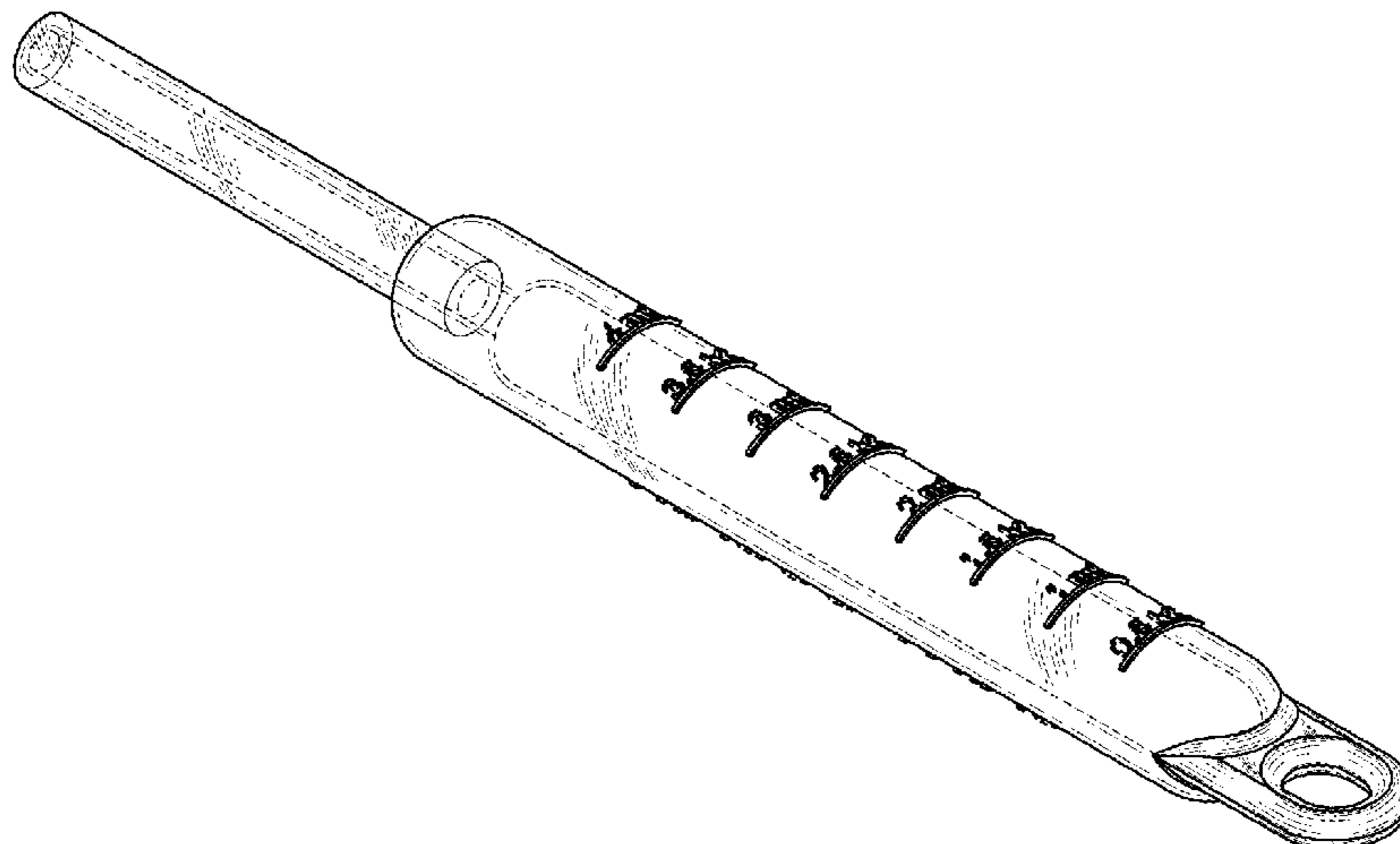

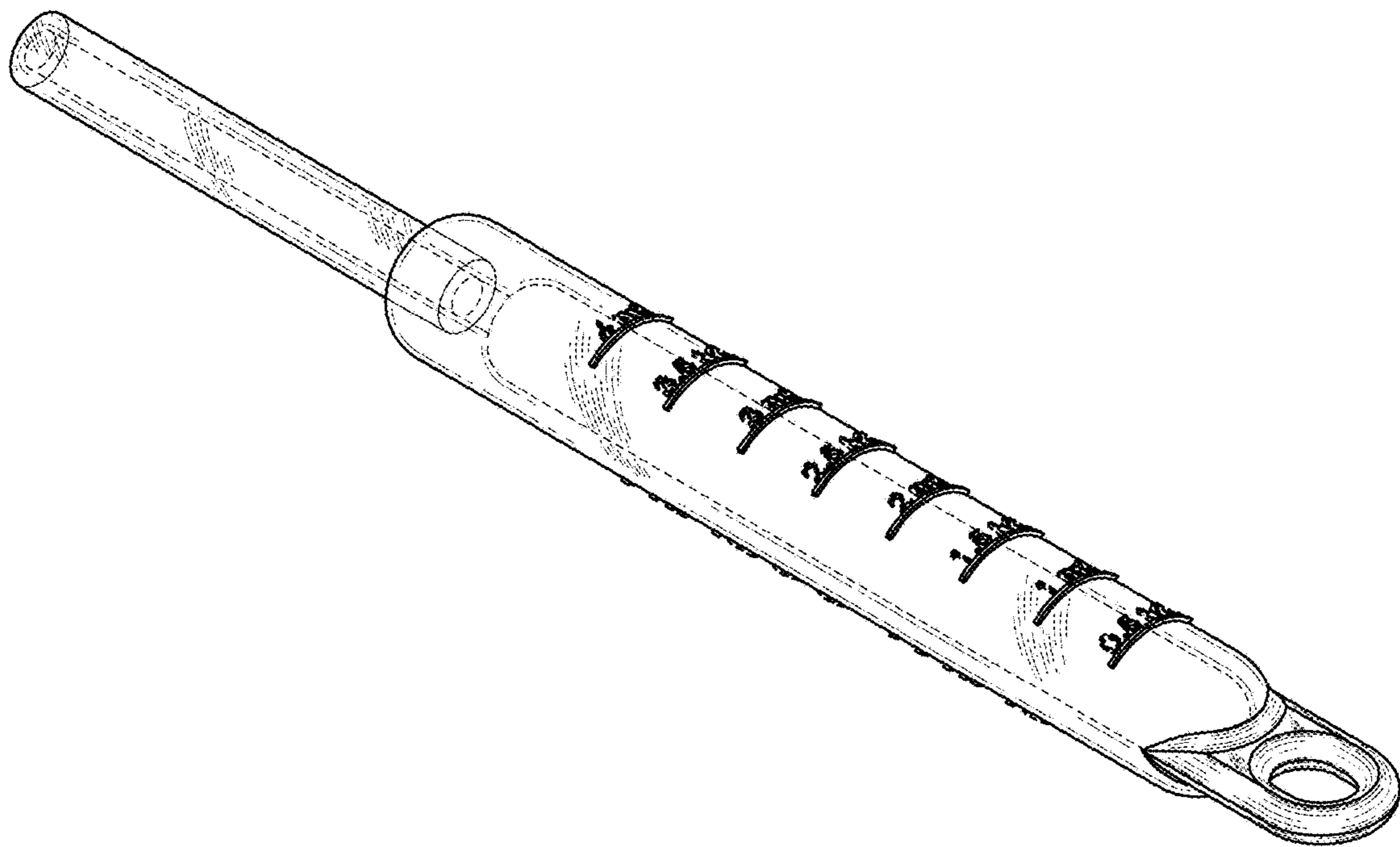

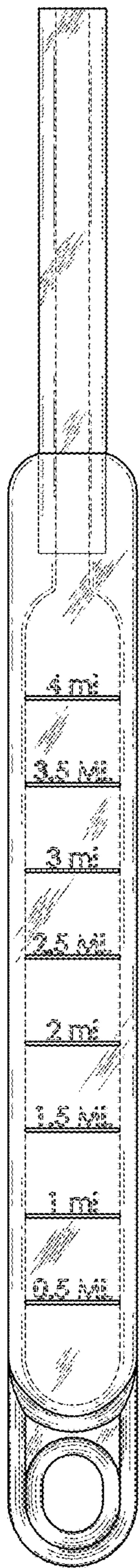

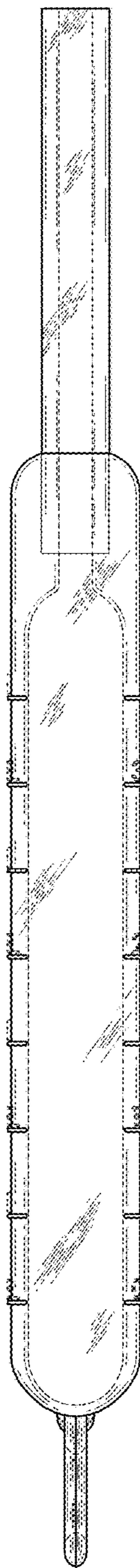

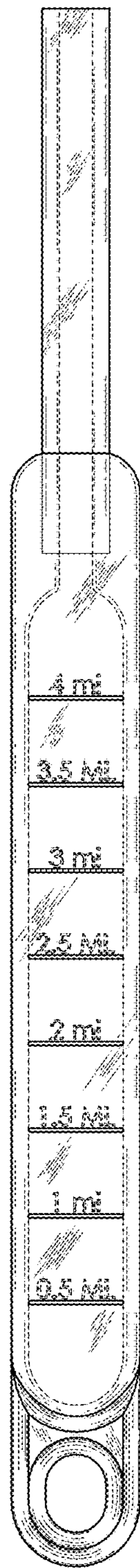

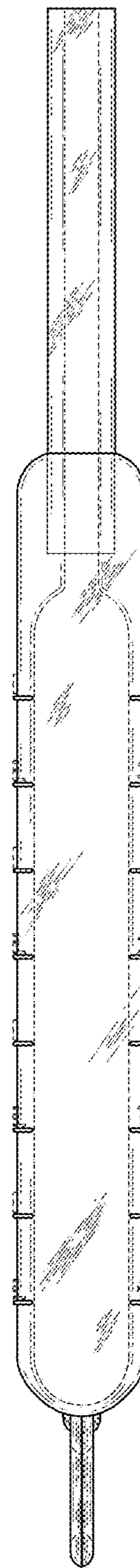

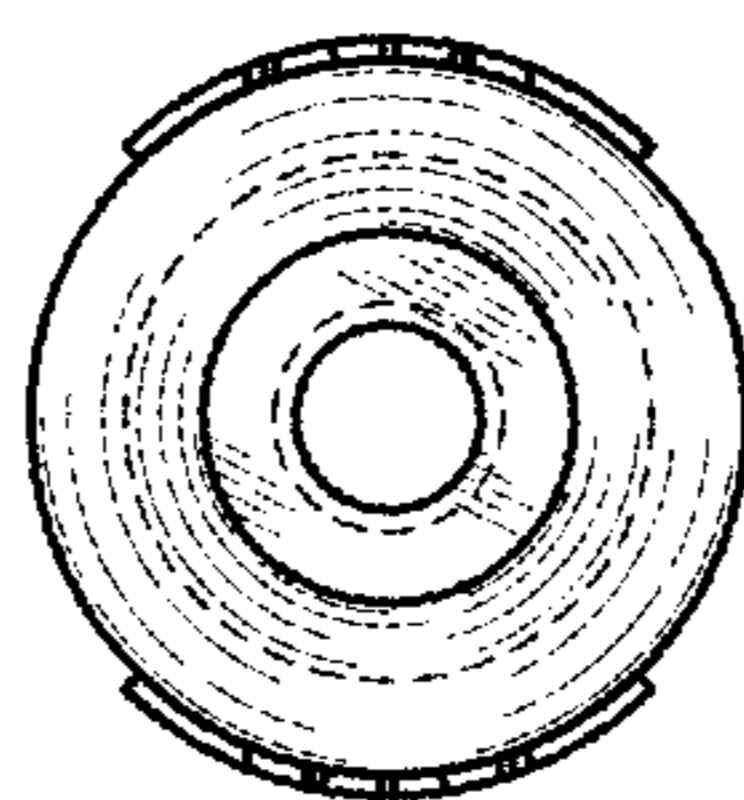

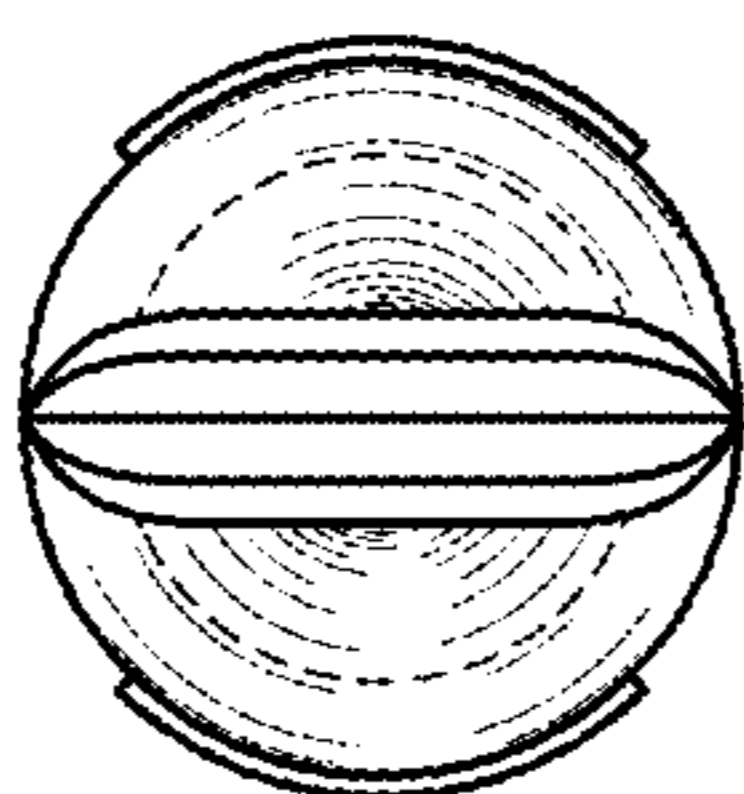
