(57) **CLAIM**

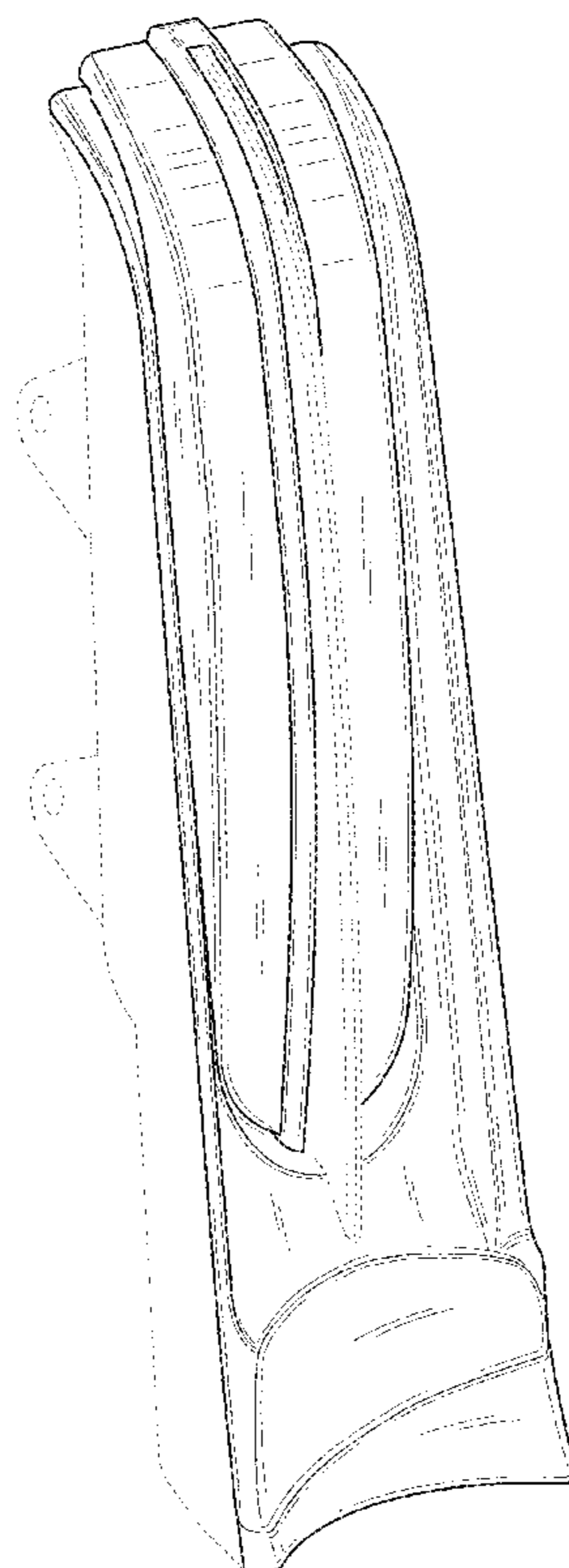
The ornamental design for a motorcycle rear lighting accessory, as shown and described.

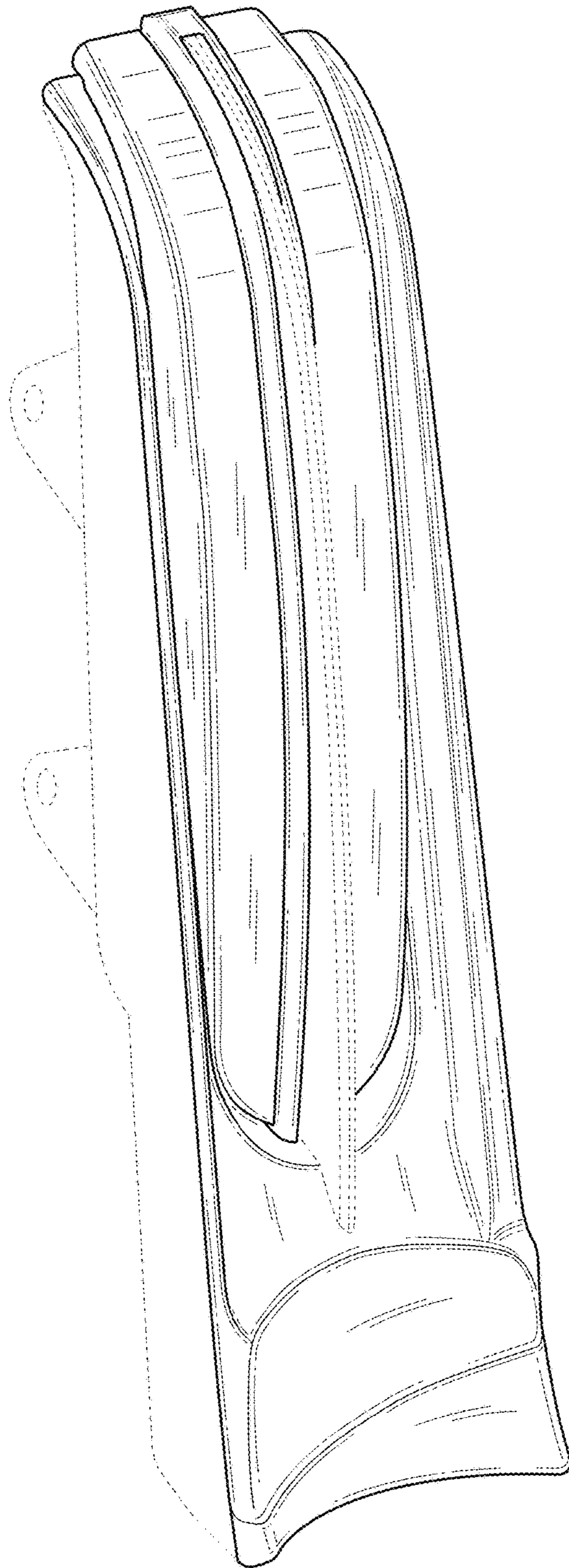

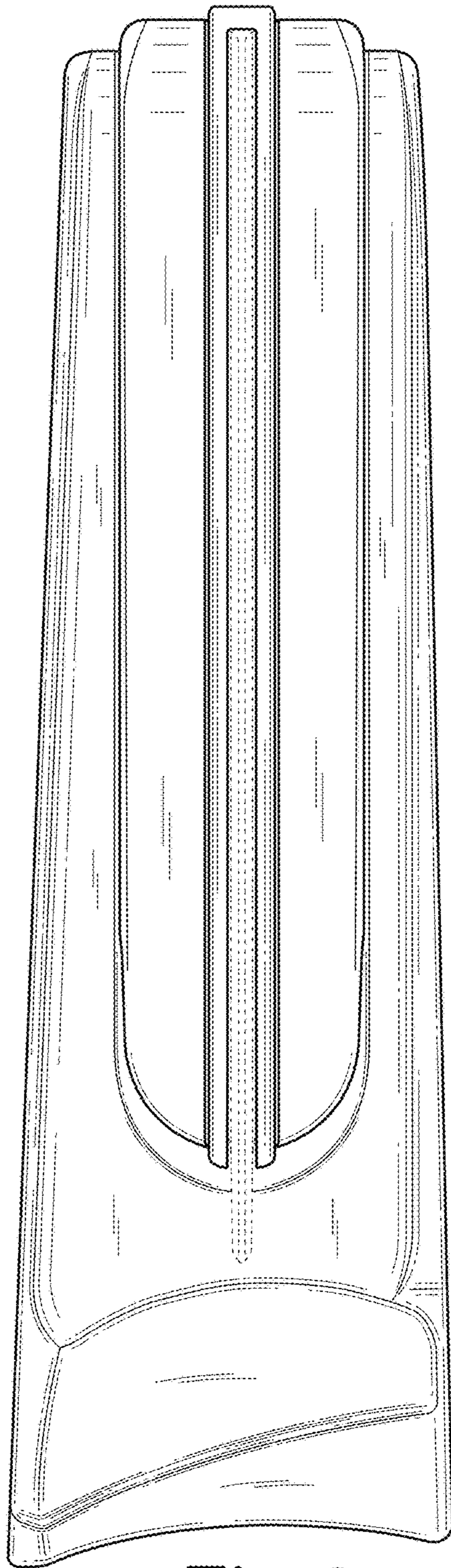

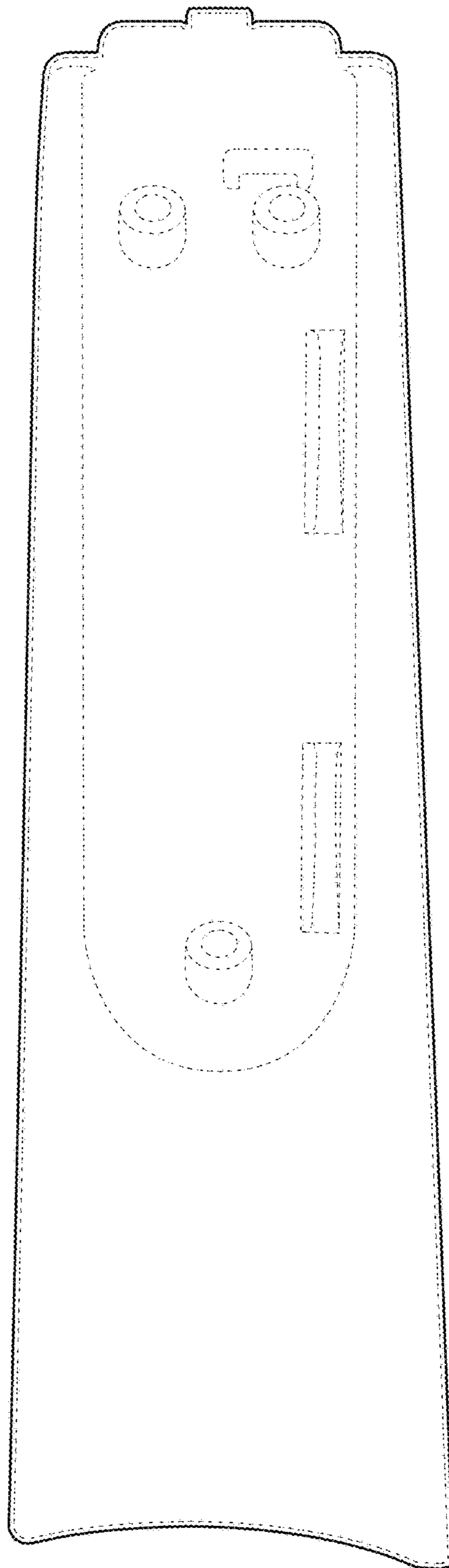

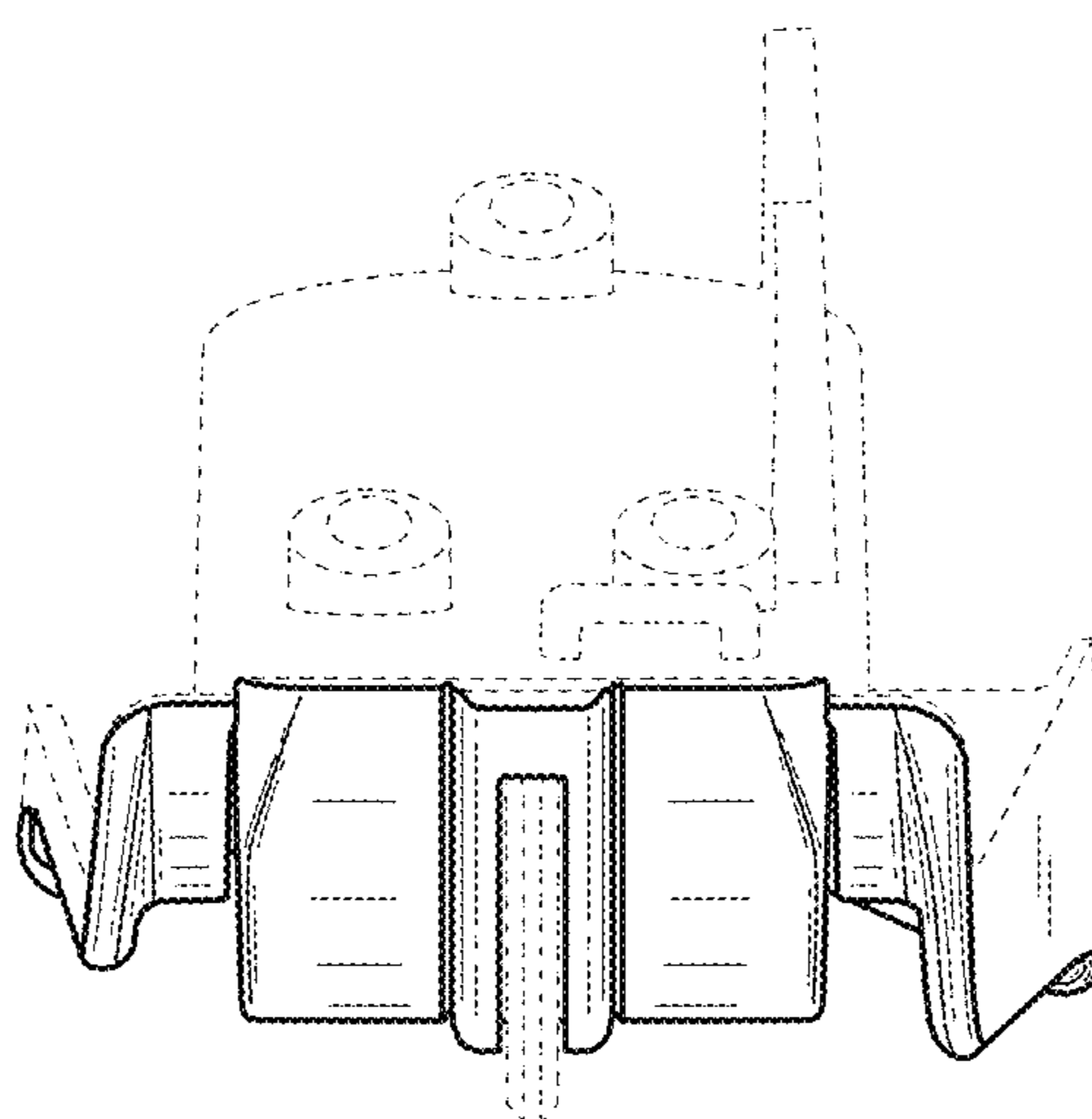

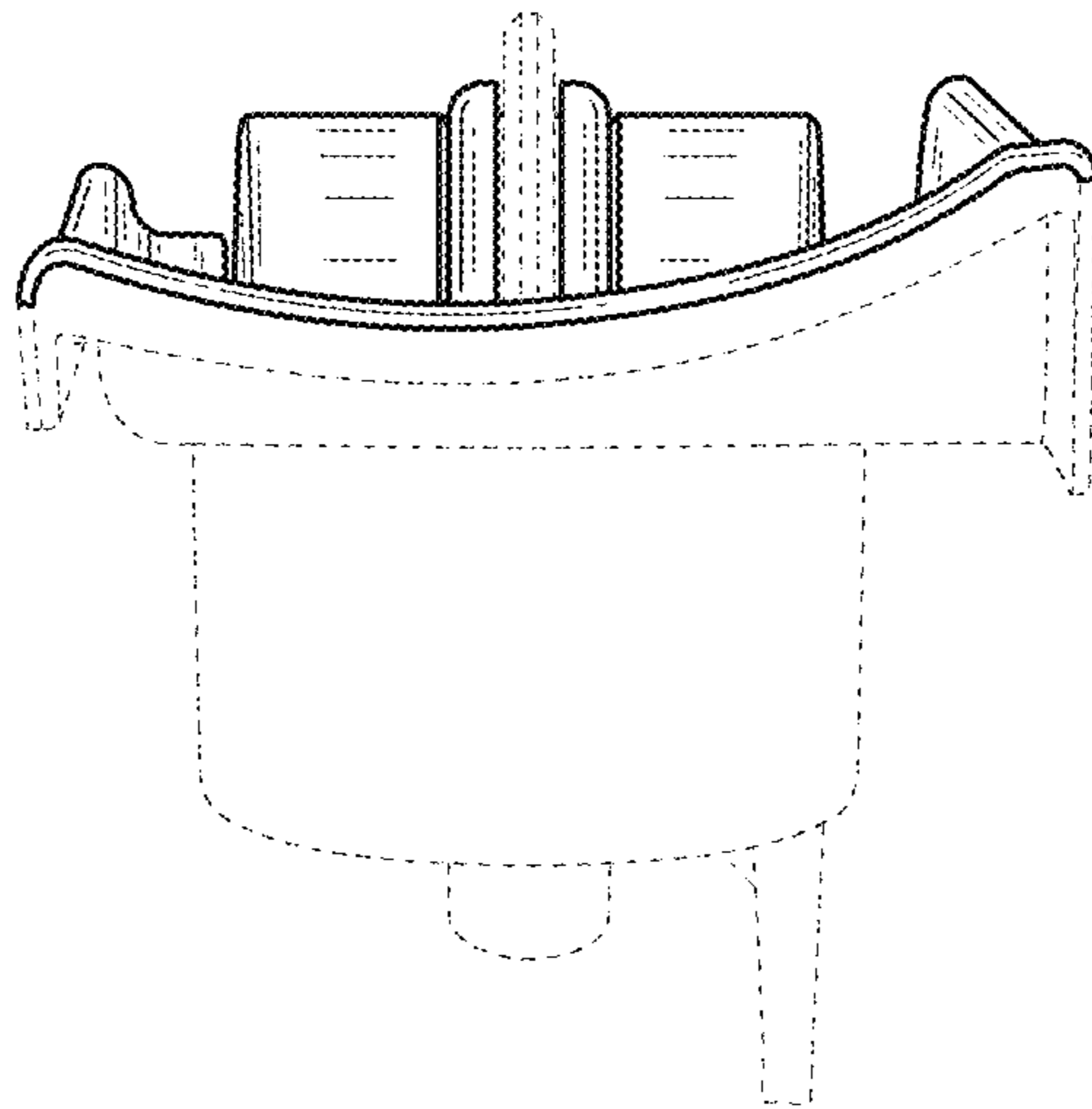

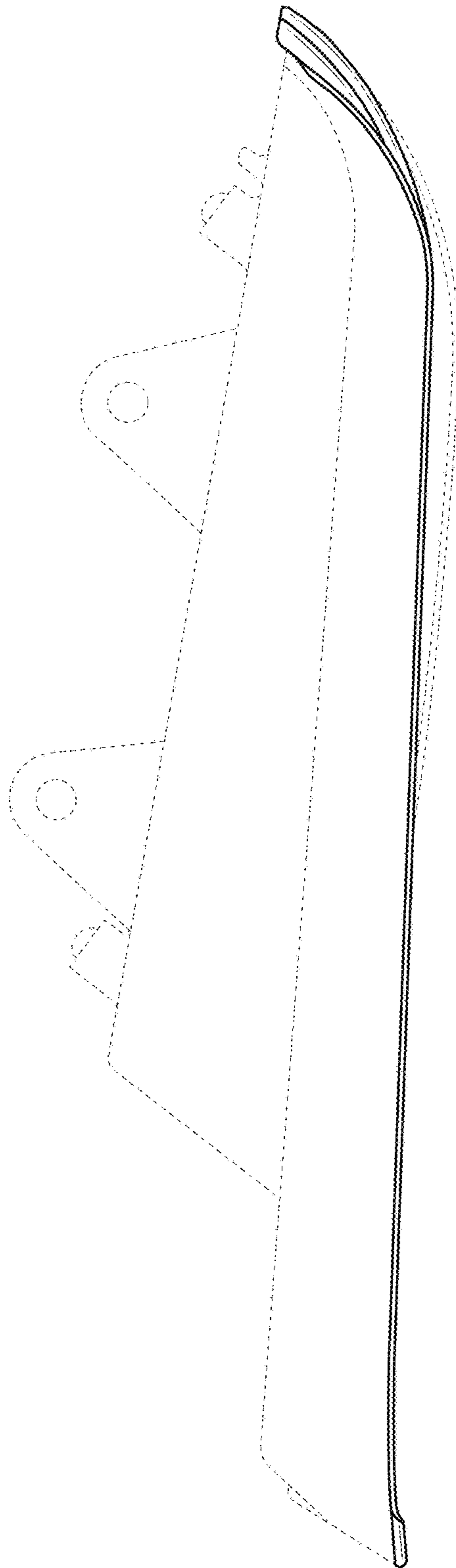

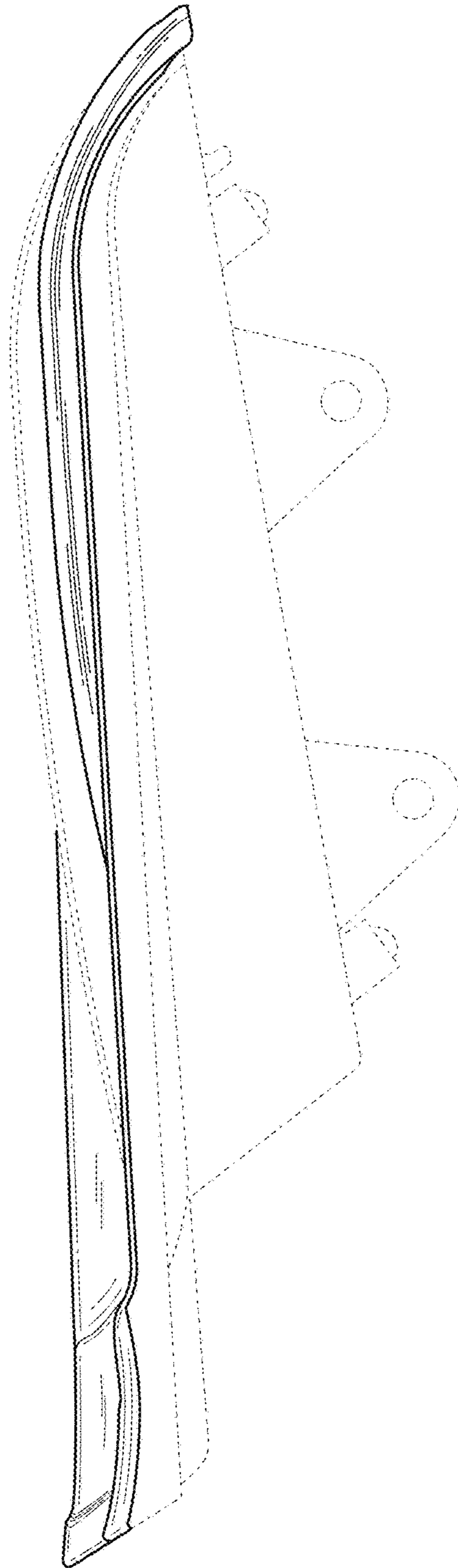
