(57) **CLAIM**

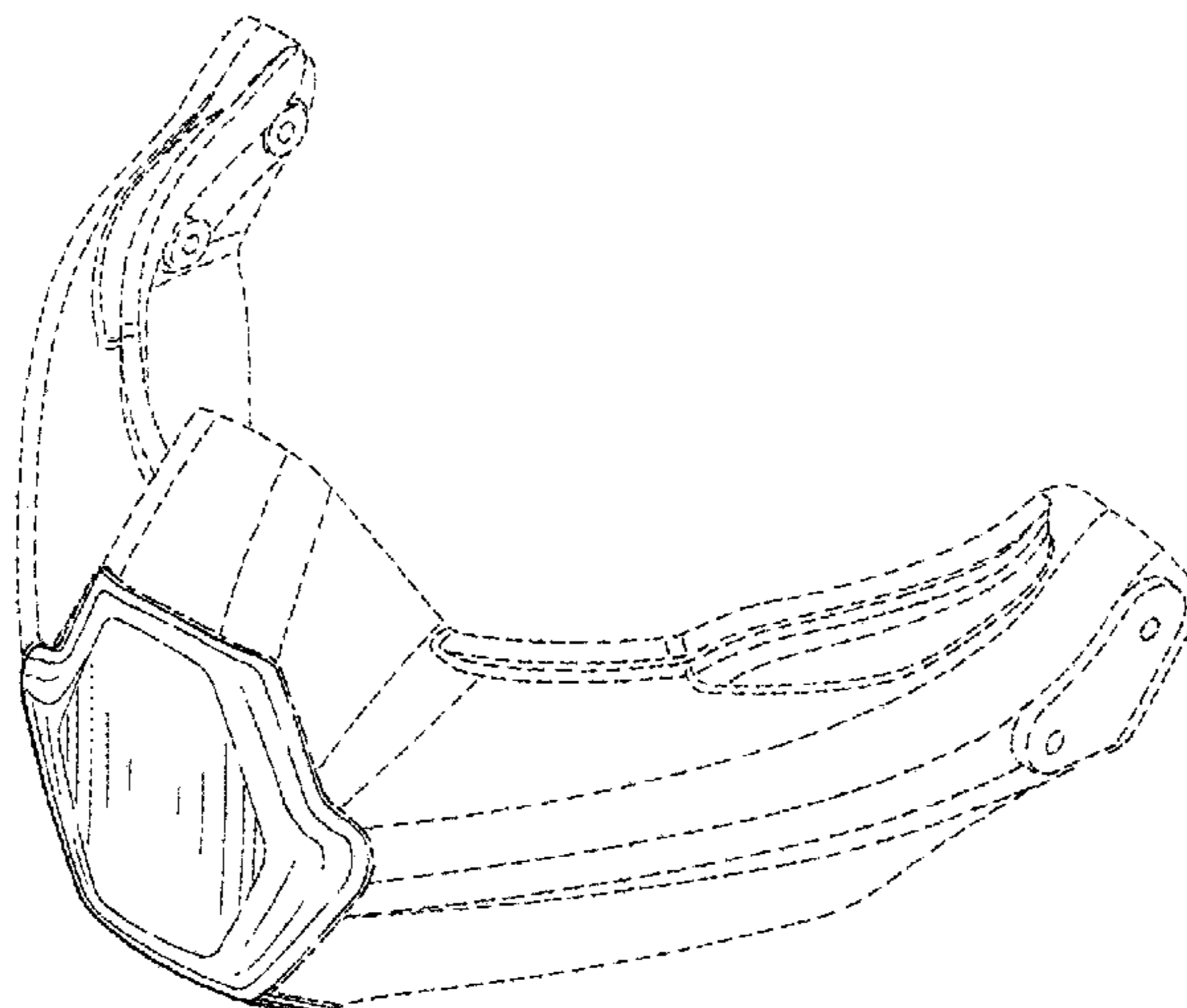
The ornamental design for a mandible guard, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front, right side perspective view of a mandible guard showing our new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a left side elevational view thereof; FIG. 5 is a right side elevational view thereof; FIG. 6 is a top plan view thereof; and, FIG. 7 is a bottom plan view thereof.

The dashed broken lines shown in the drawings show portions of the mandible guard that form no part of the claimed design. The dash-dot broken lines shown in the drawings depict boundaries of the claimed design and form no part of the claimed design.

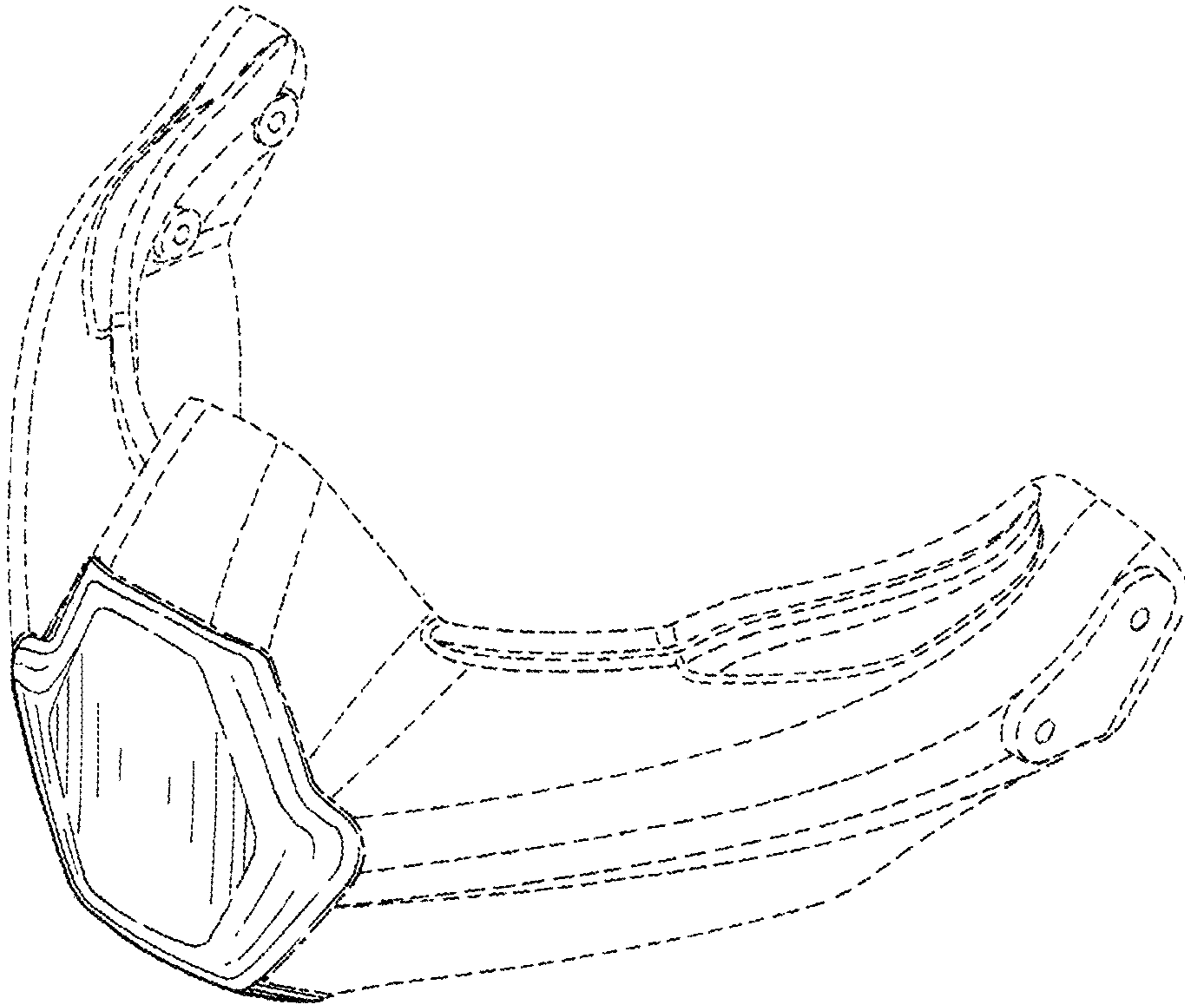

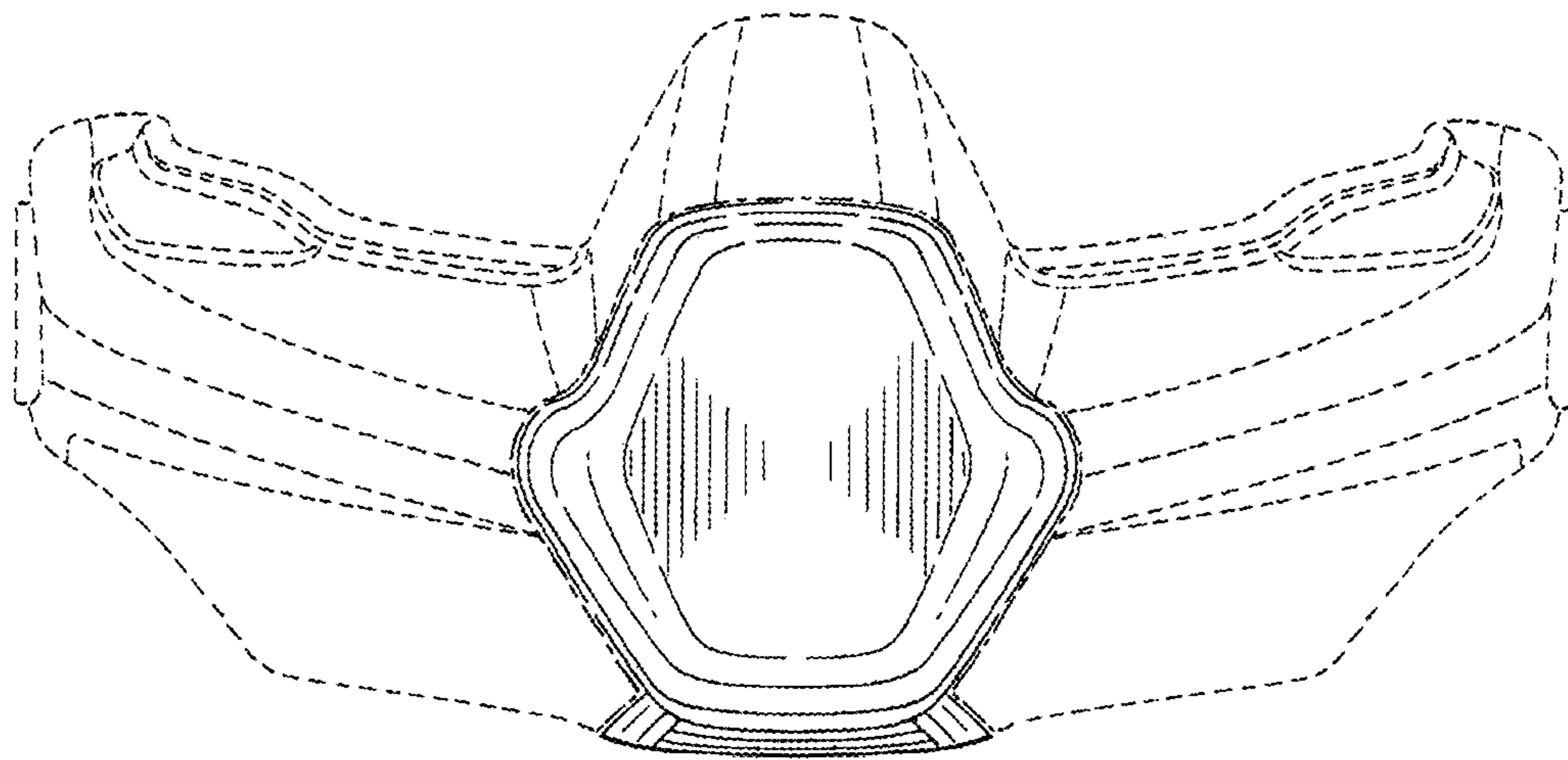

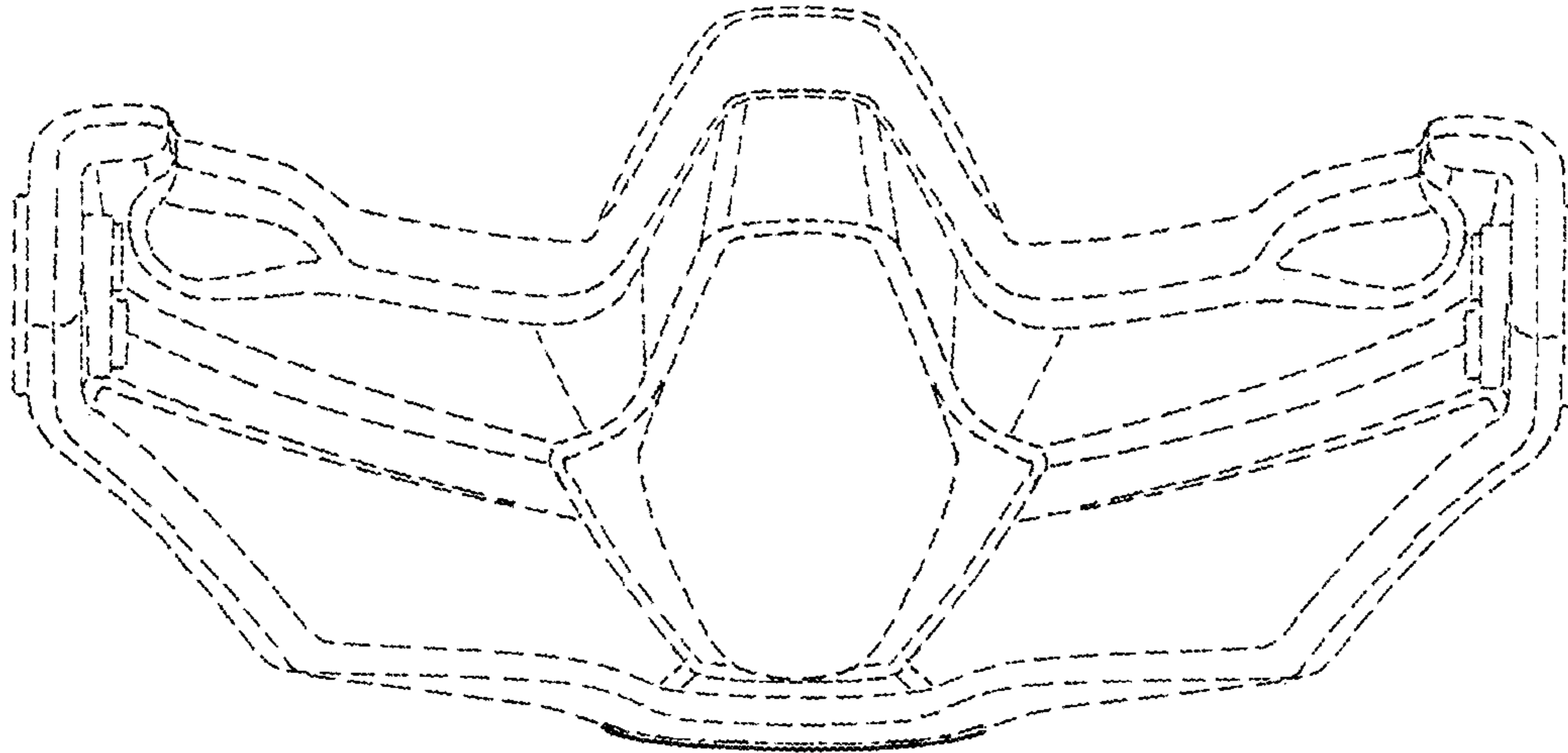

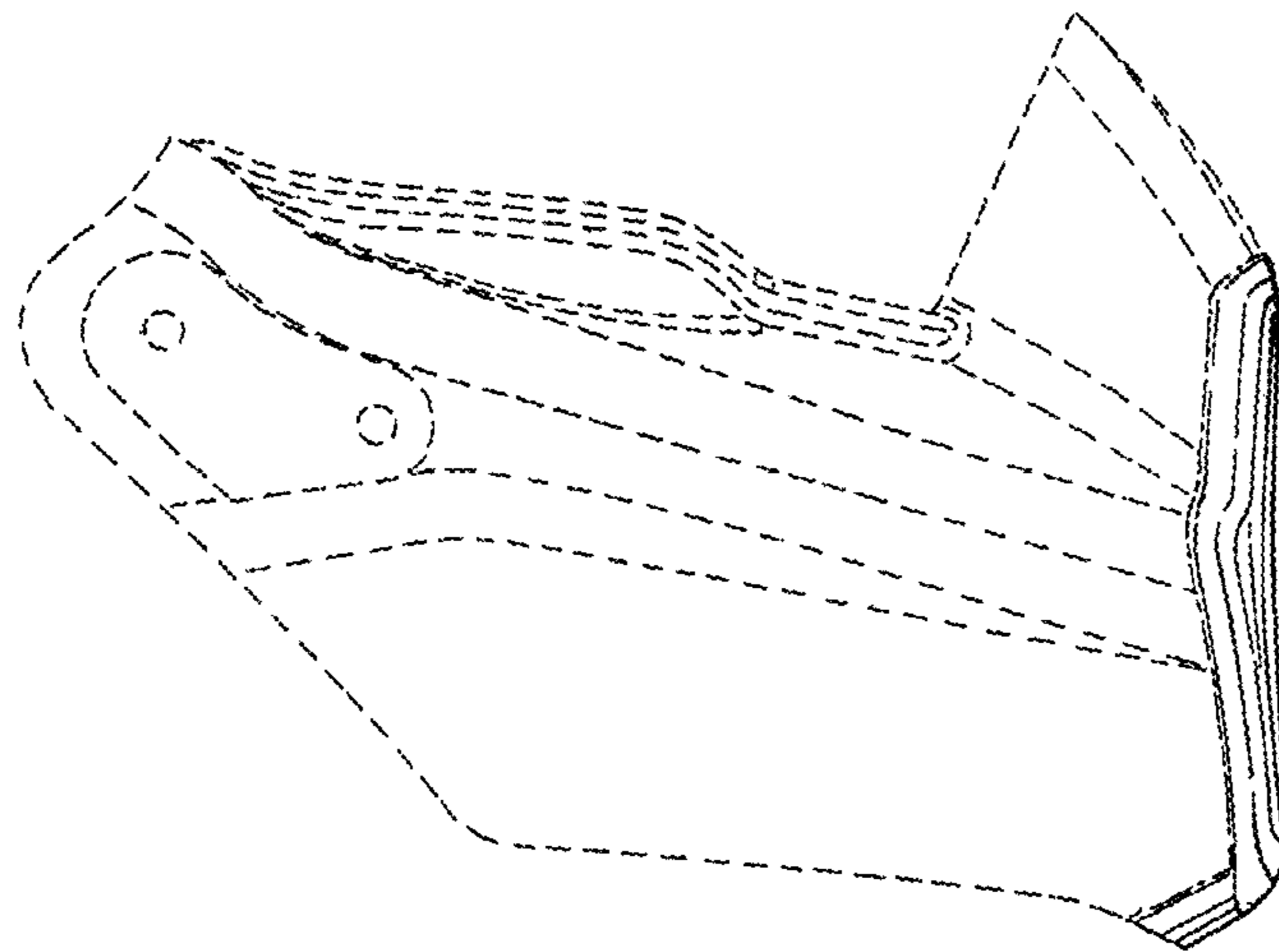

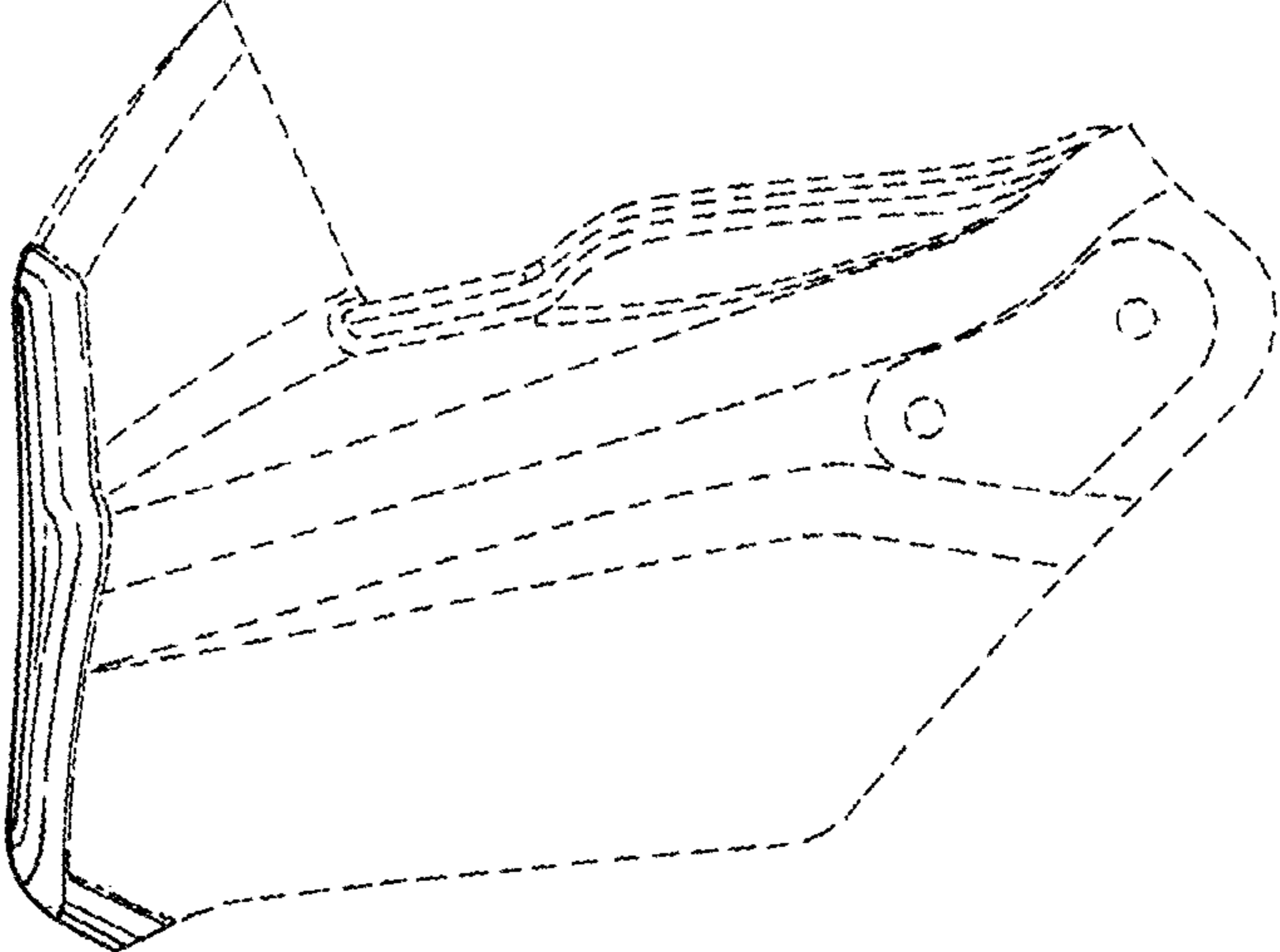

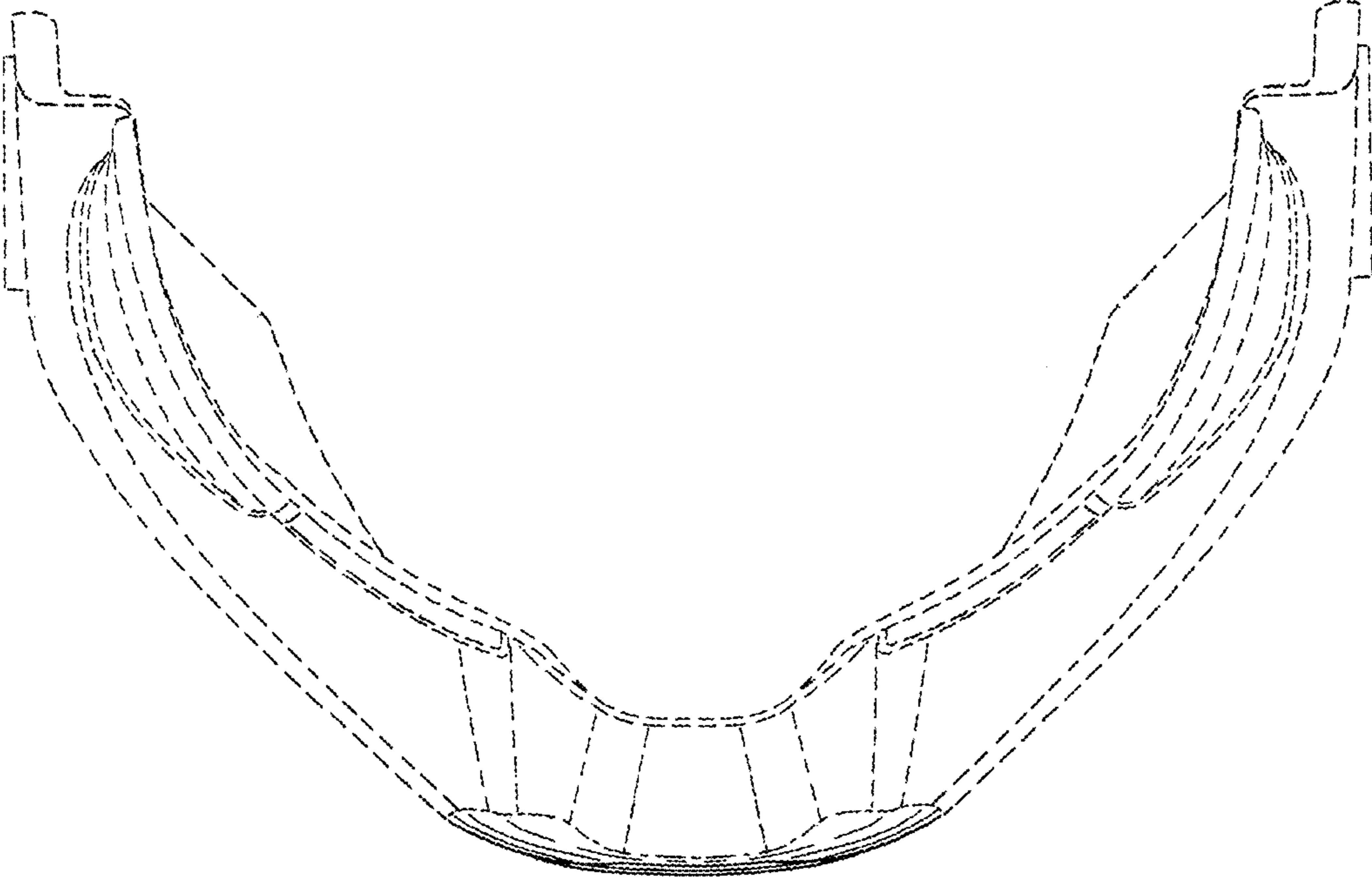

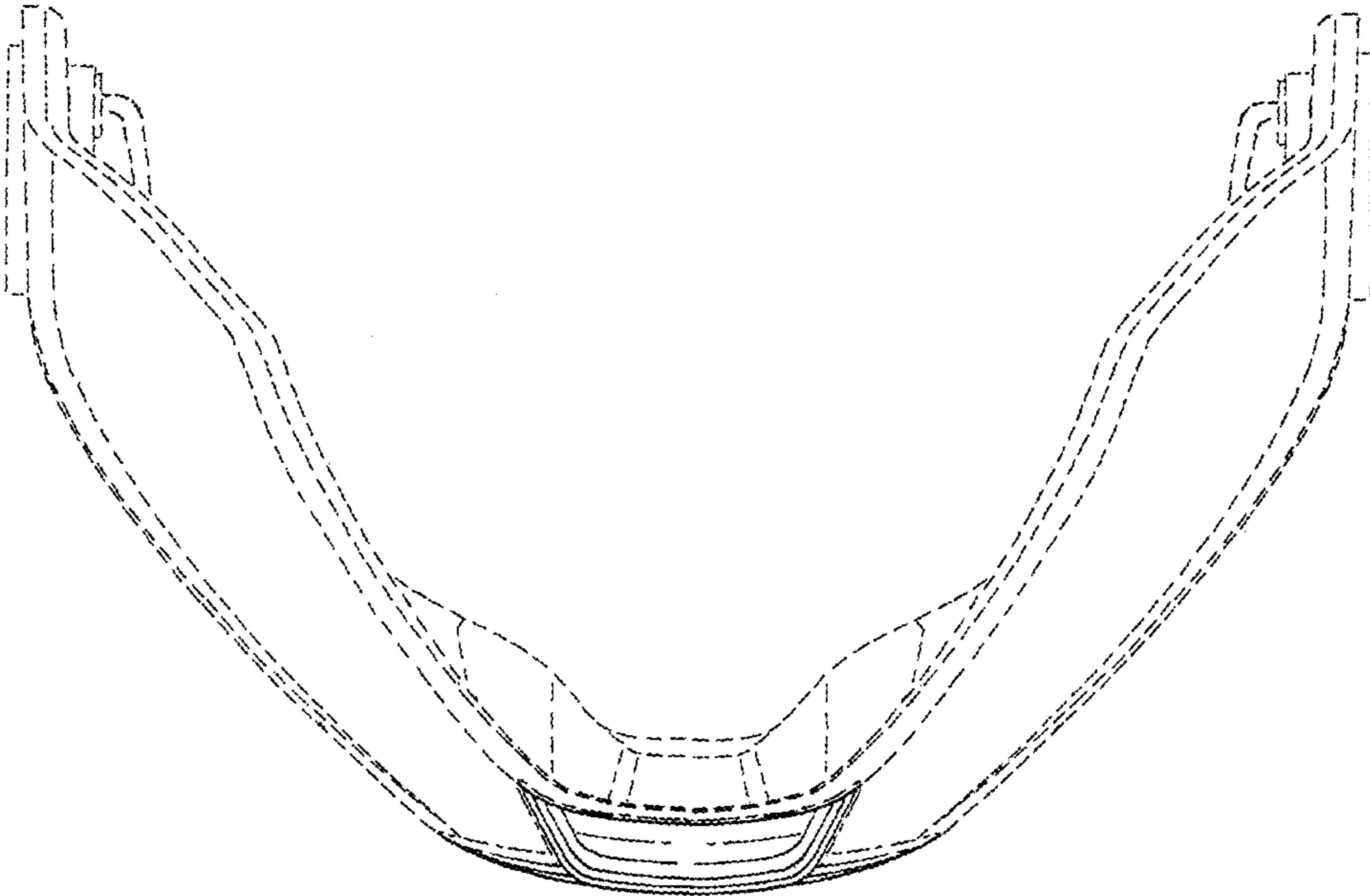
