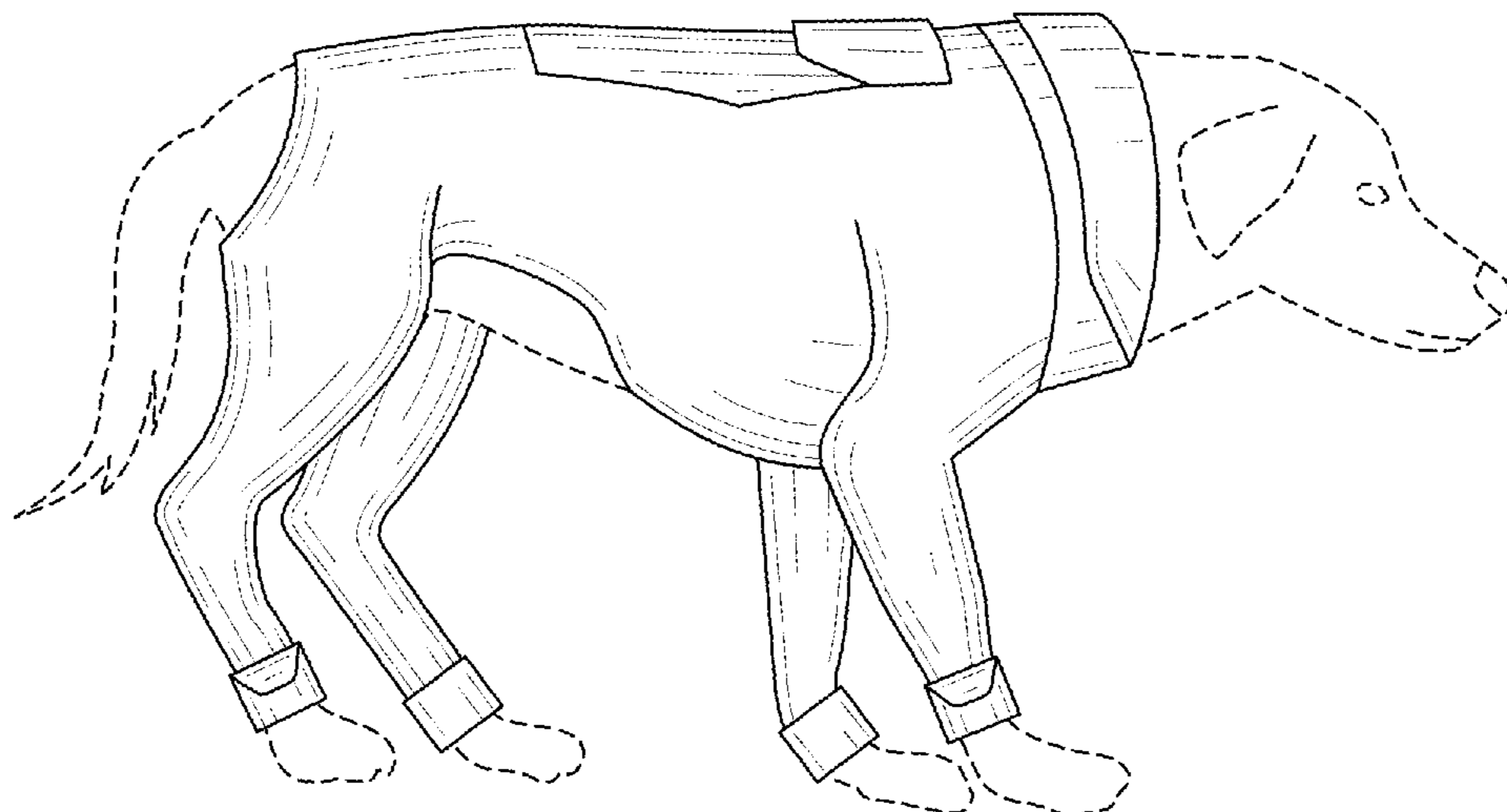
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a right side elevational view of a therapeutic animal jacket, showing my new design;

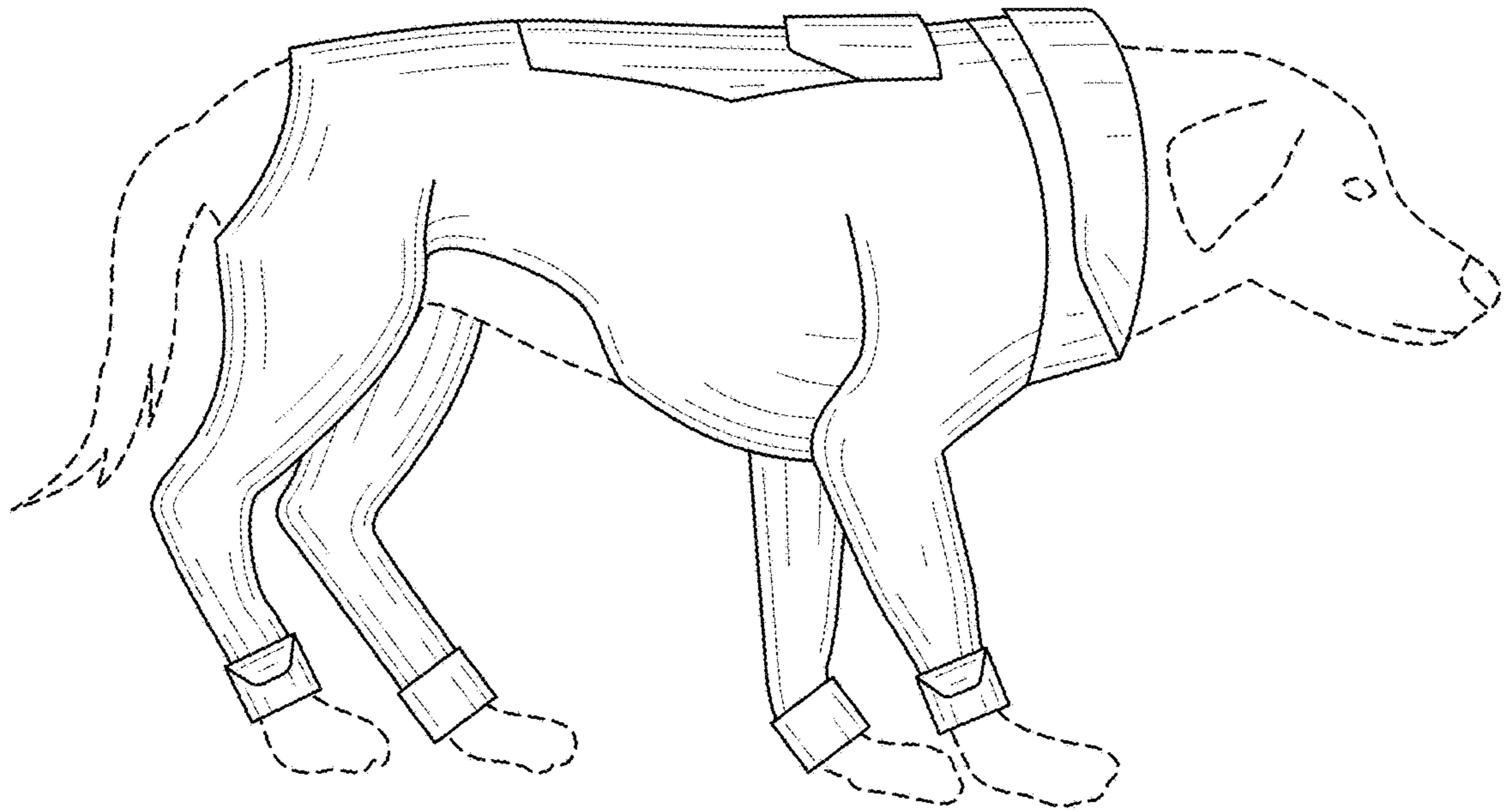

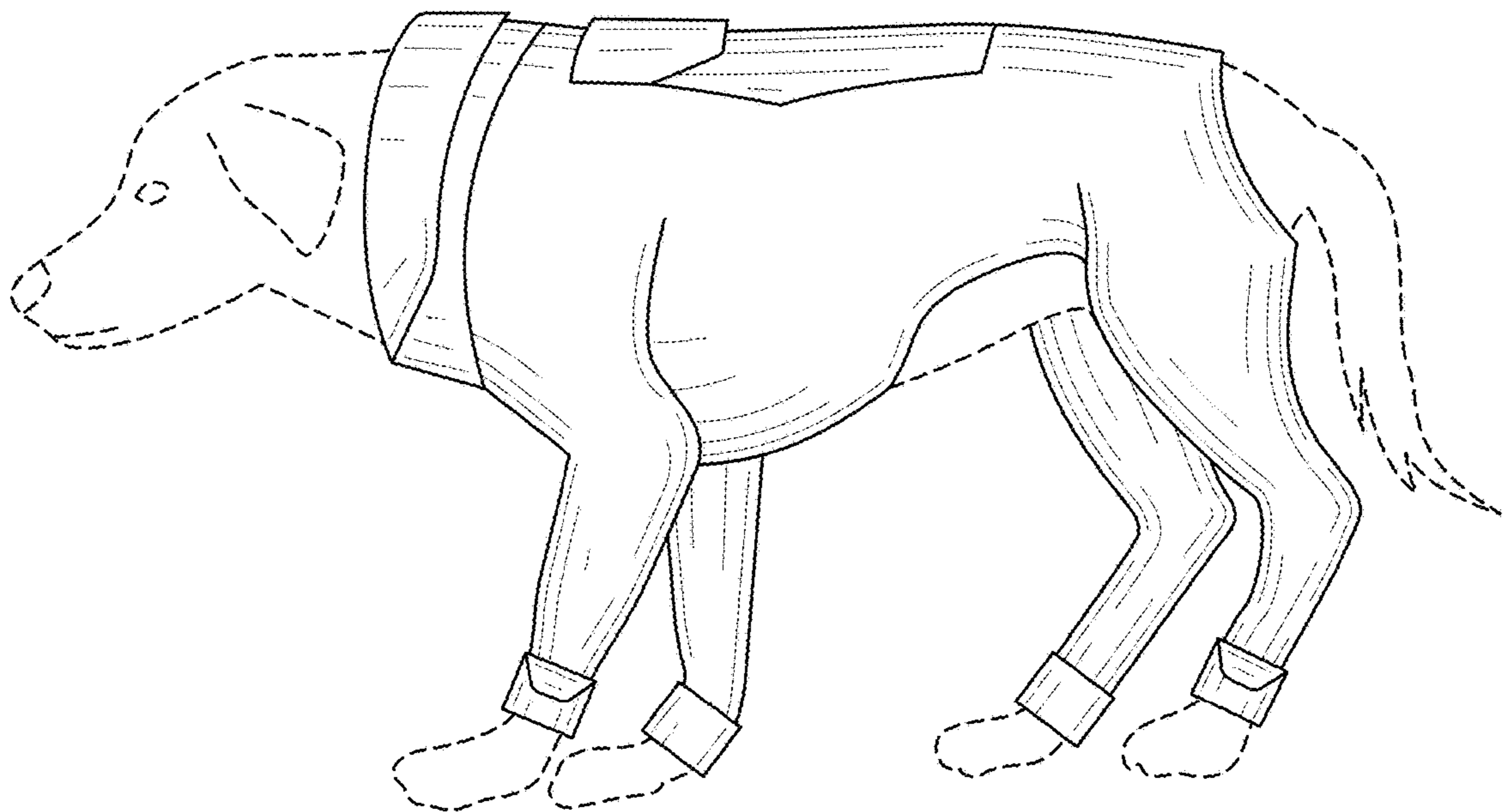

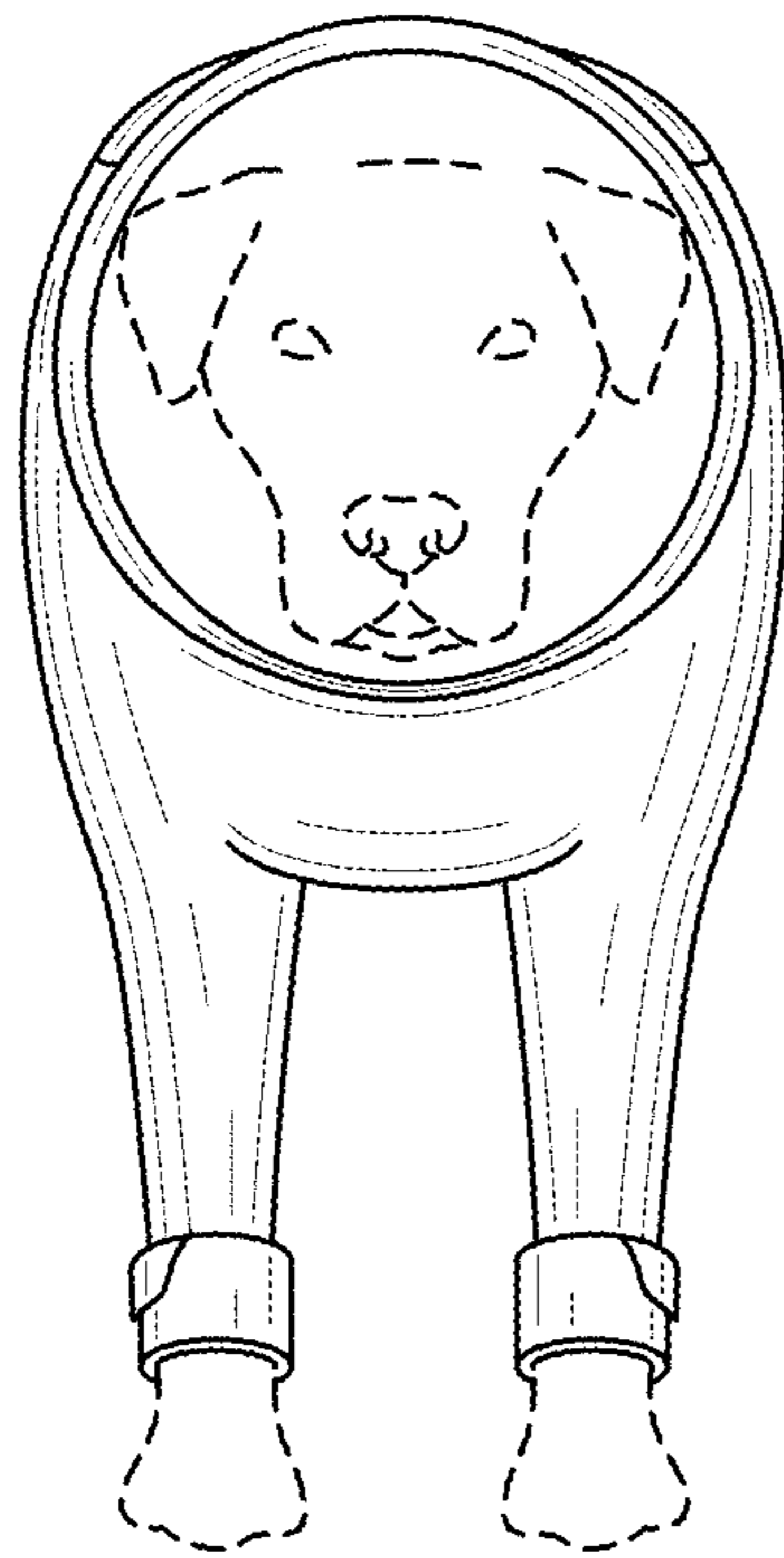

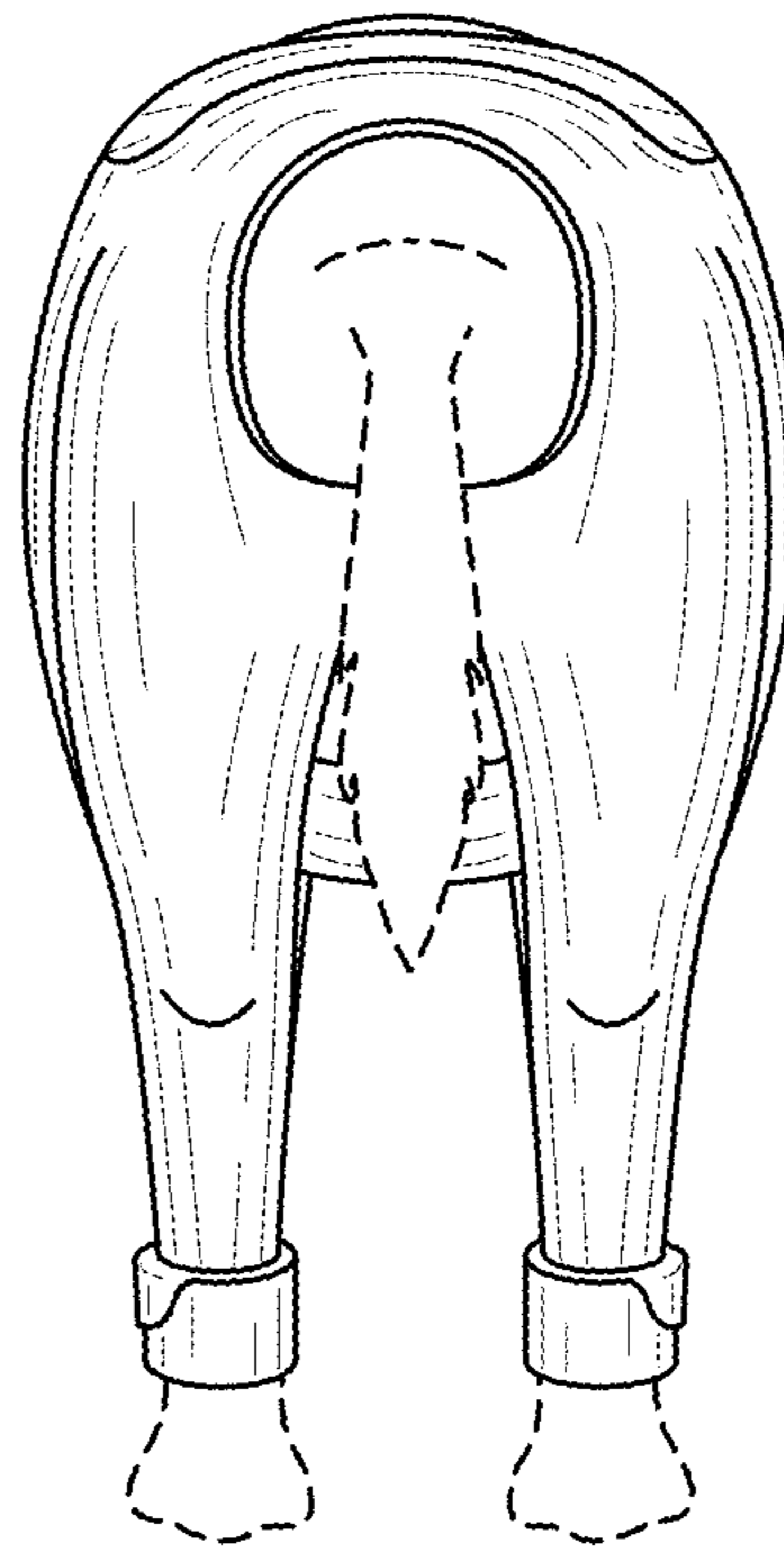

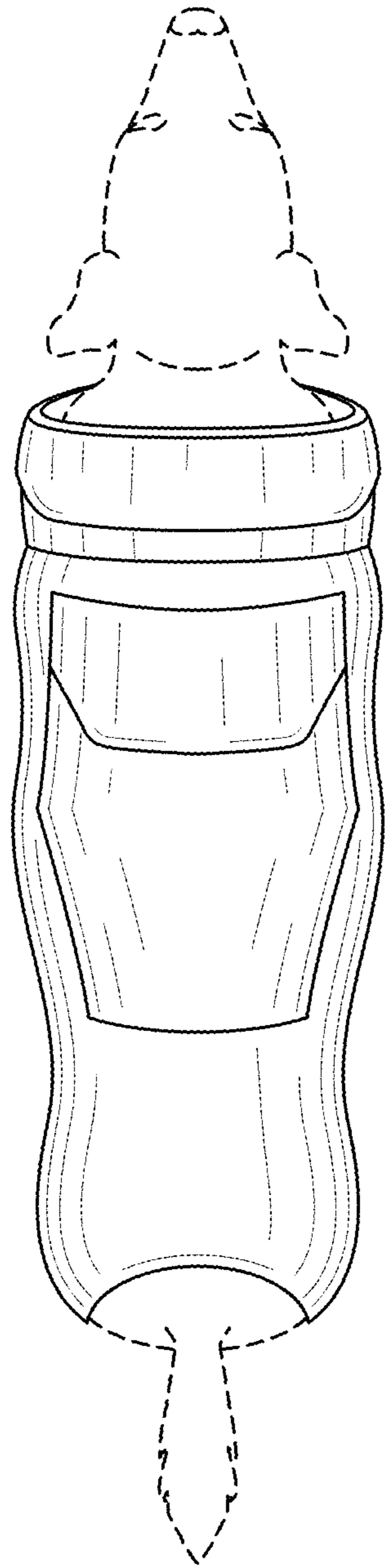

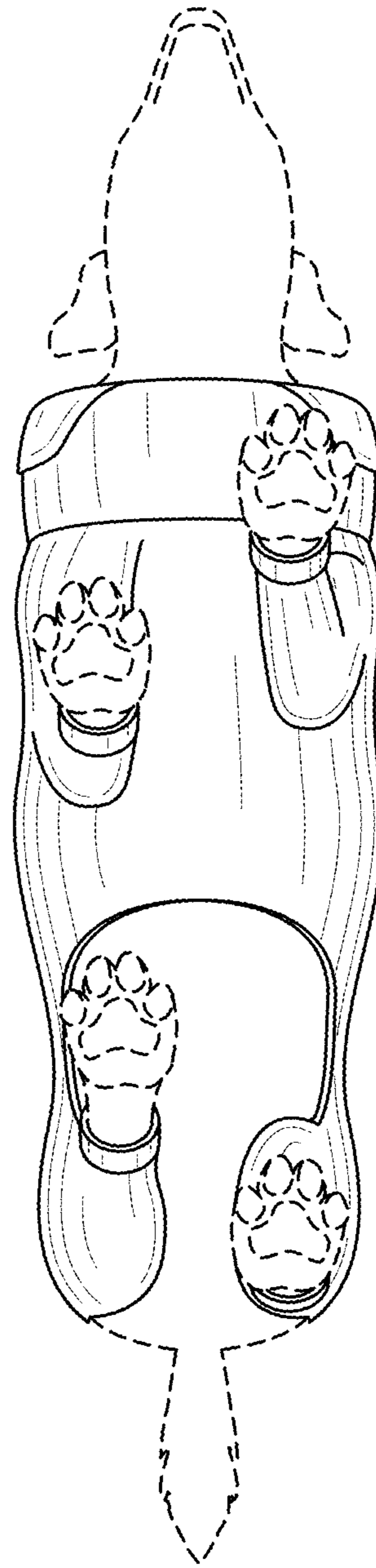
