DESCRIPTION

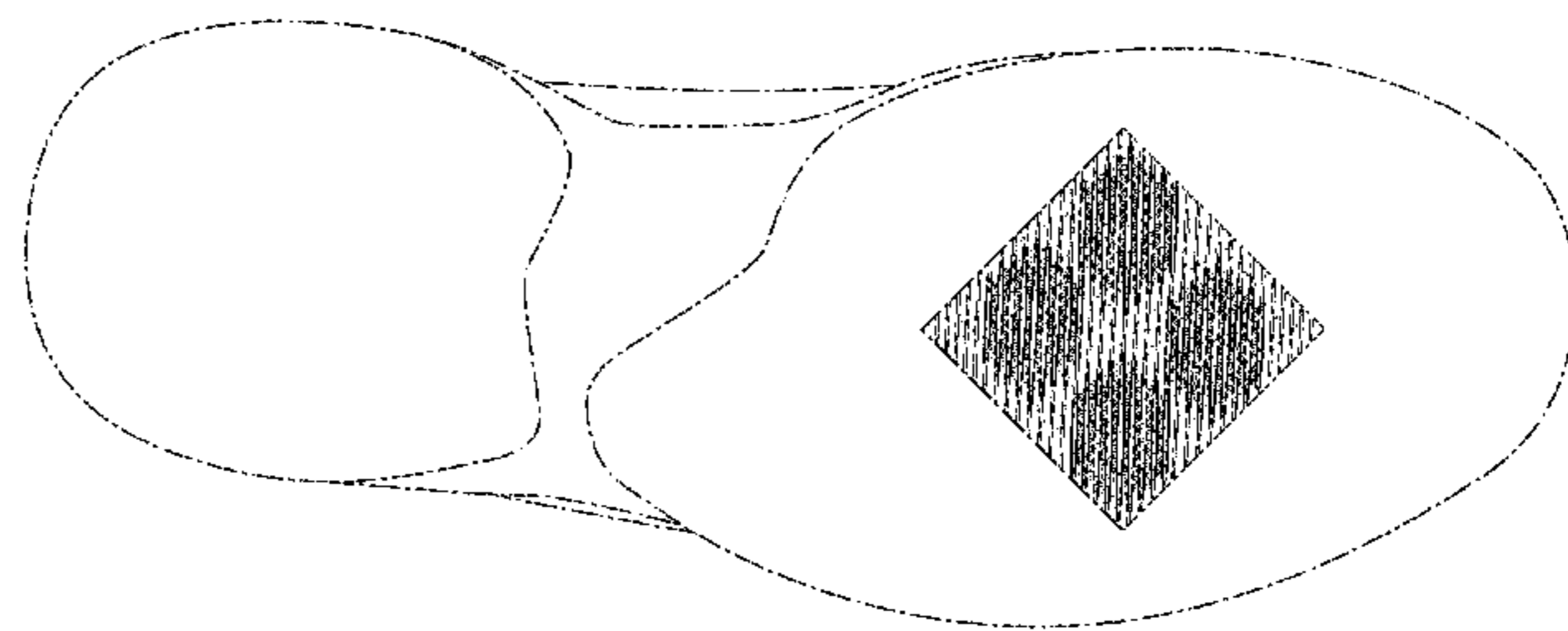
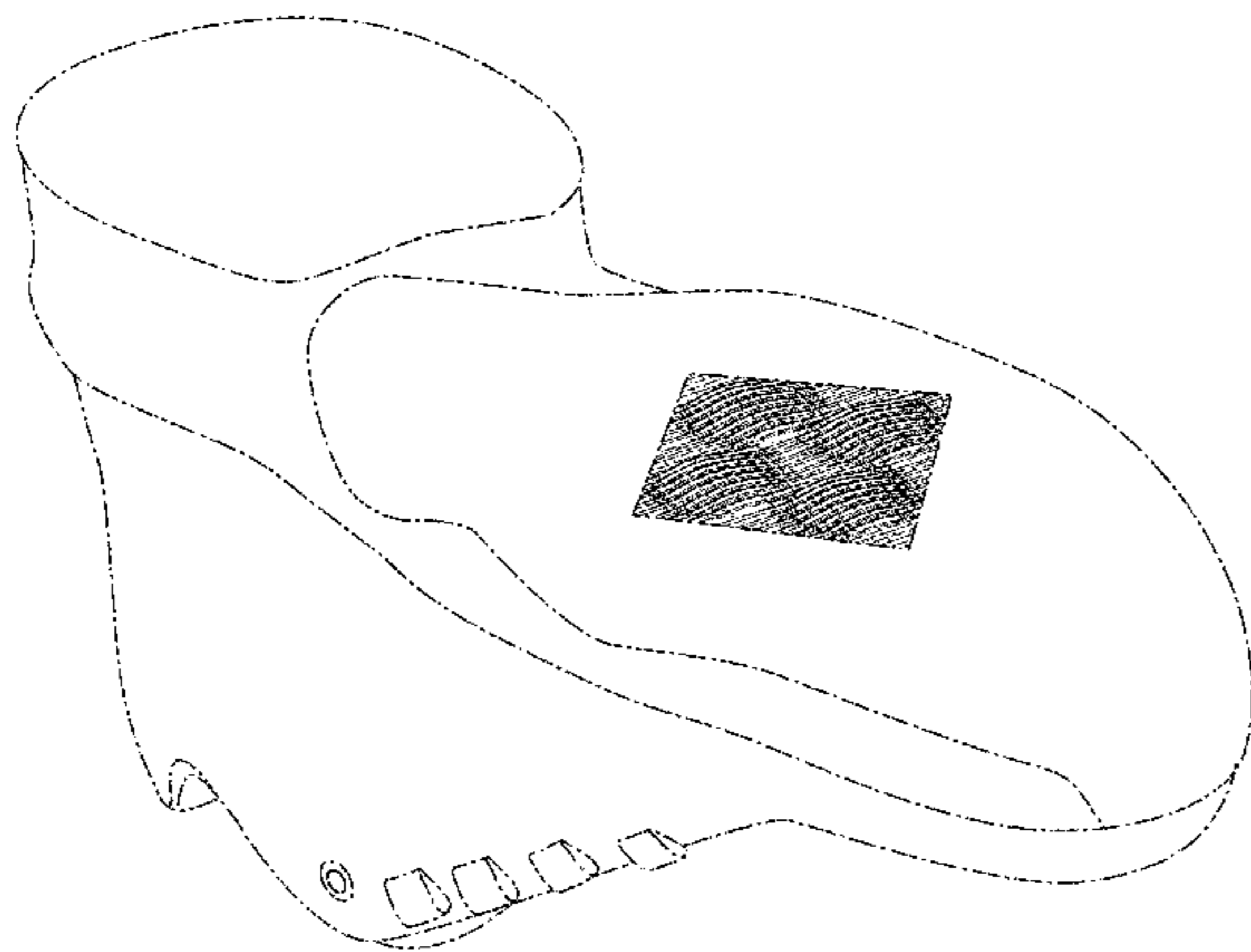
FIG. 1 is a front bottom perspective view of a shoe outsole showing my new design;

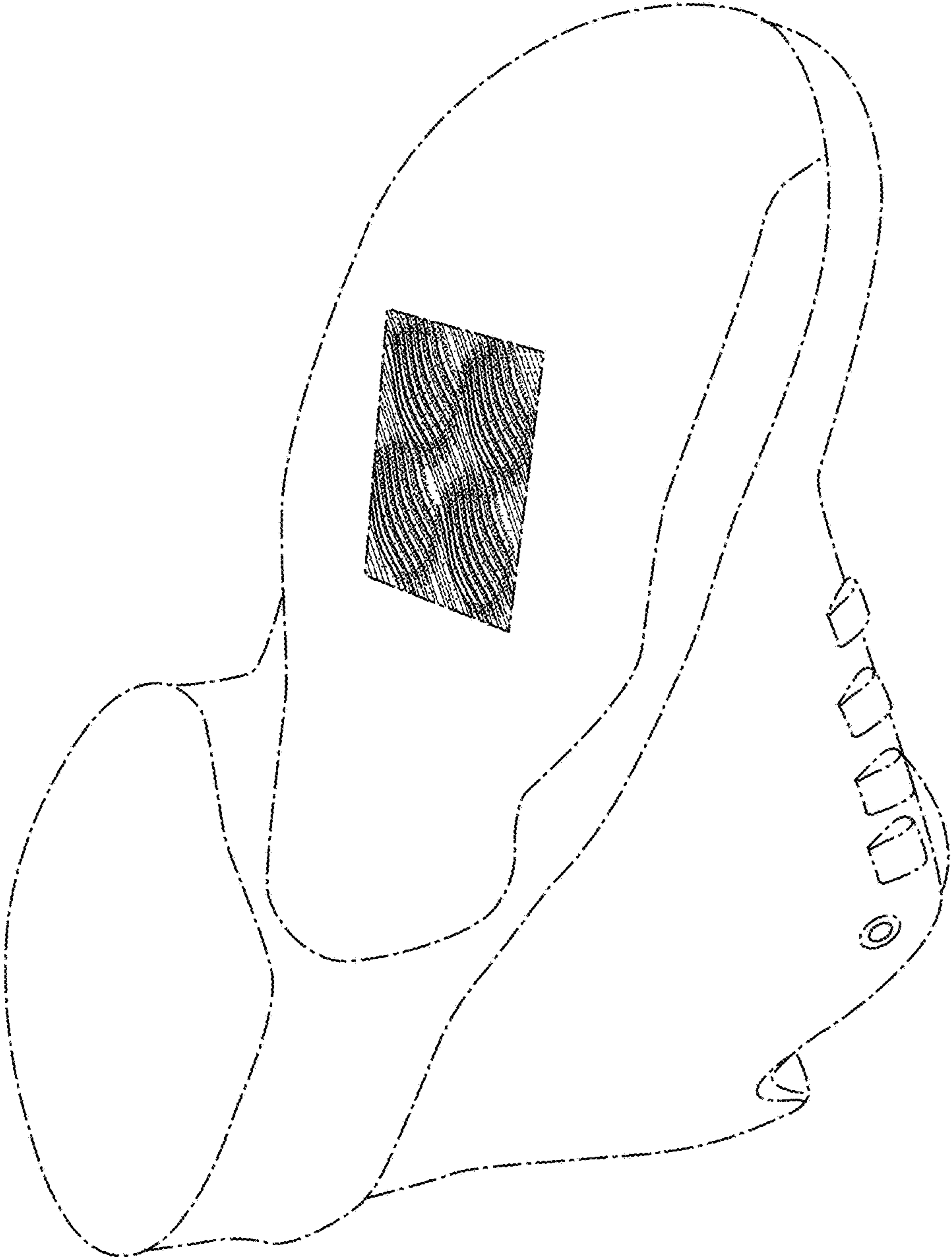

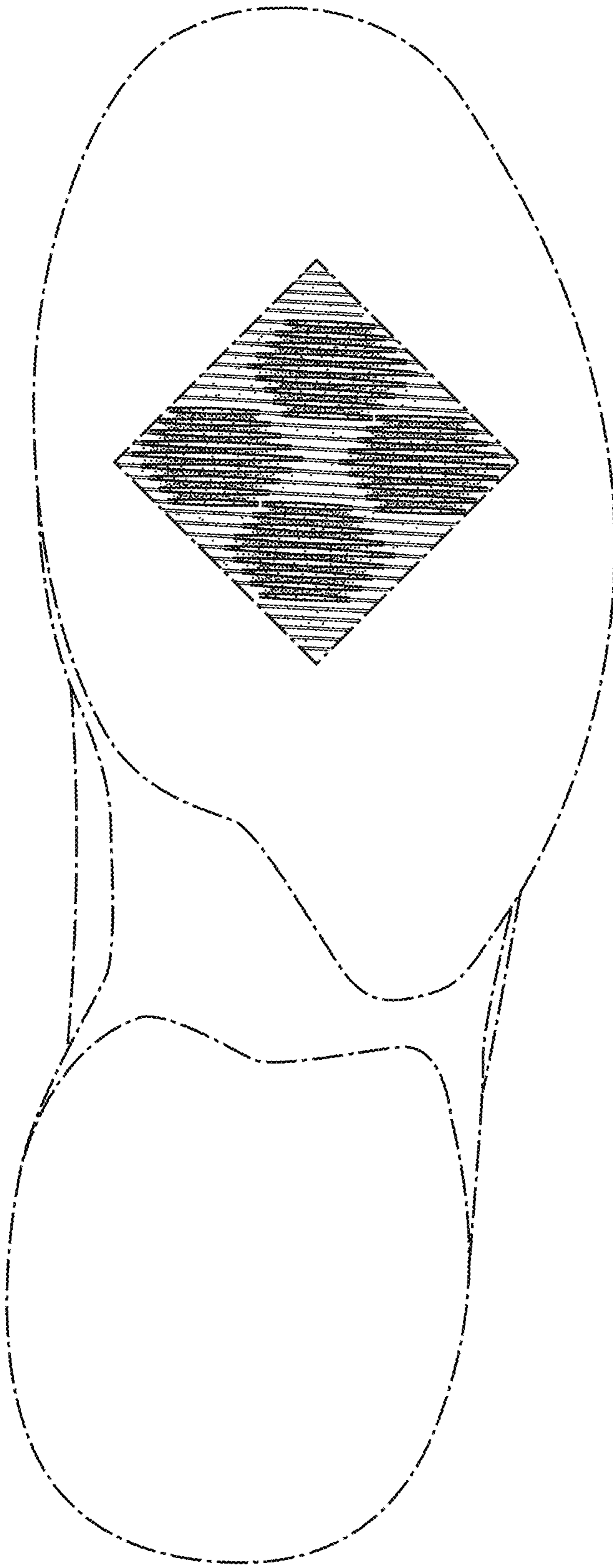

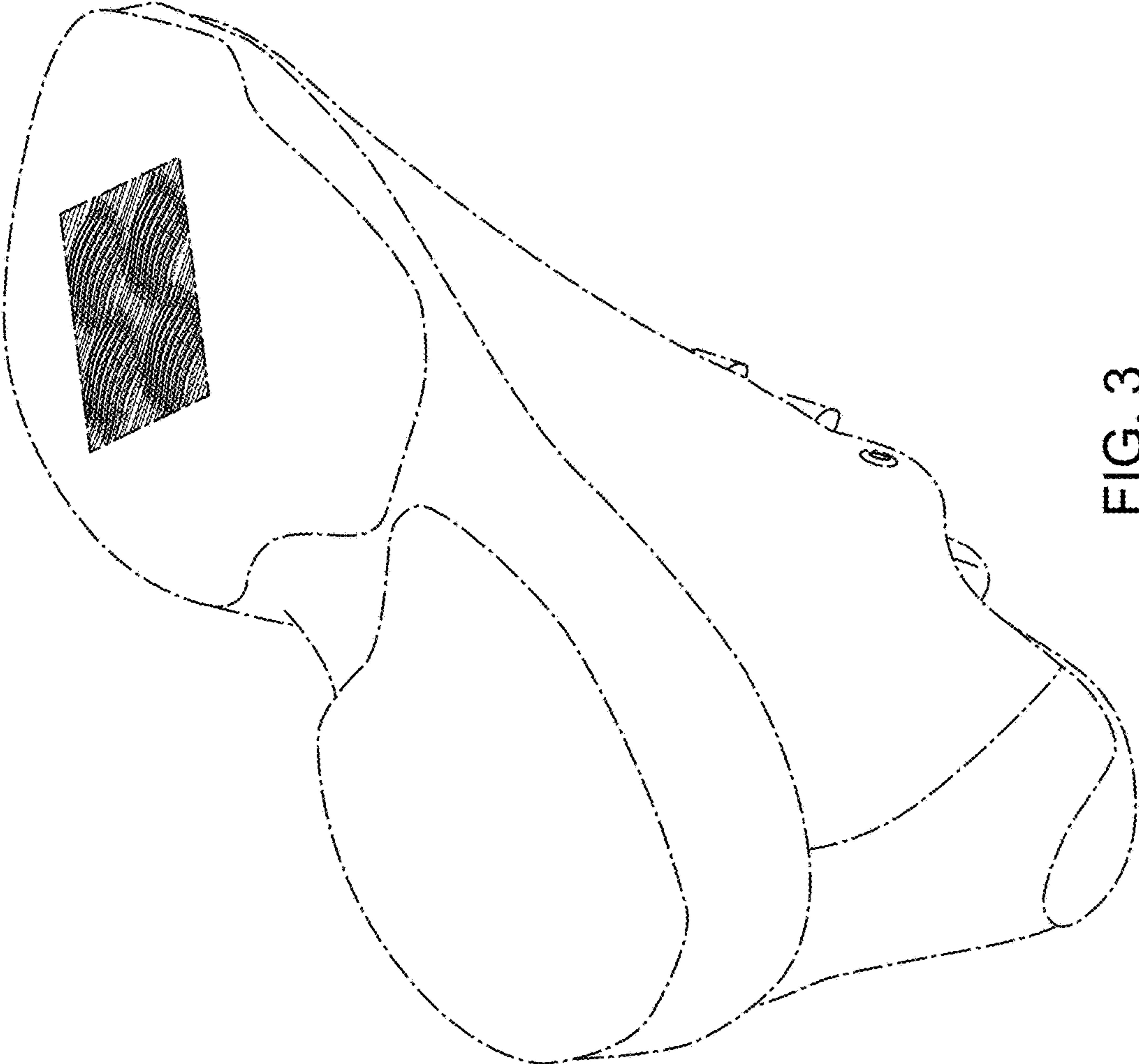
