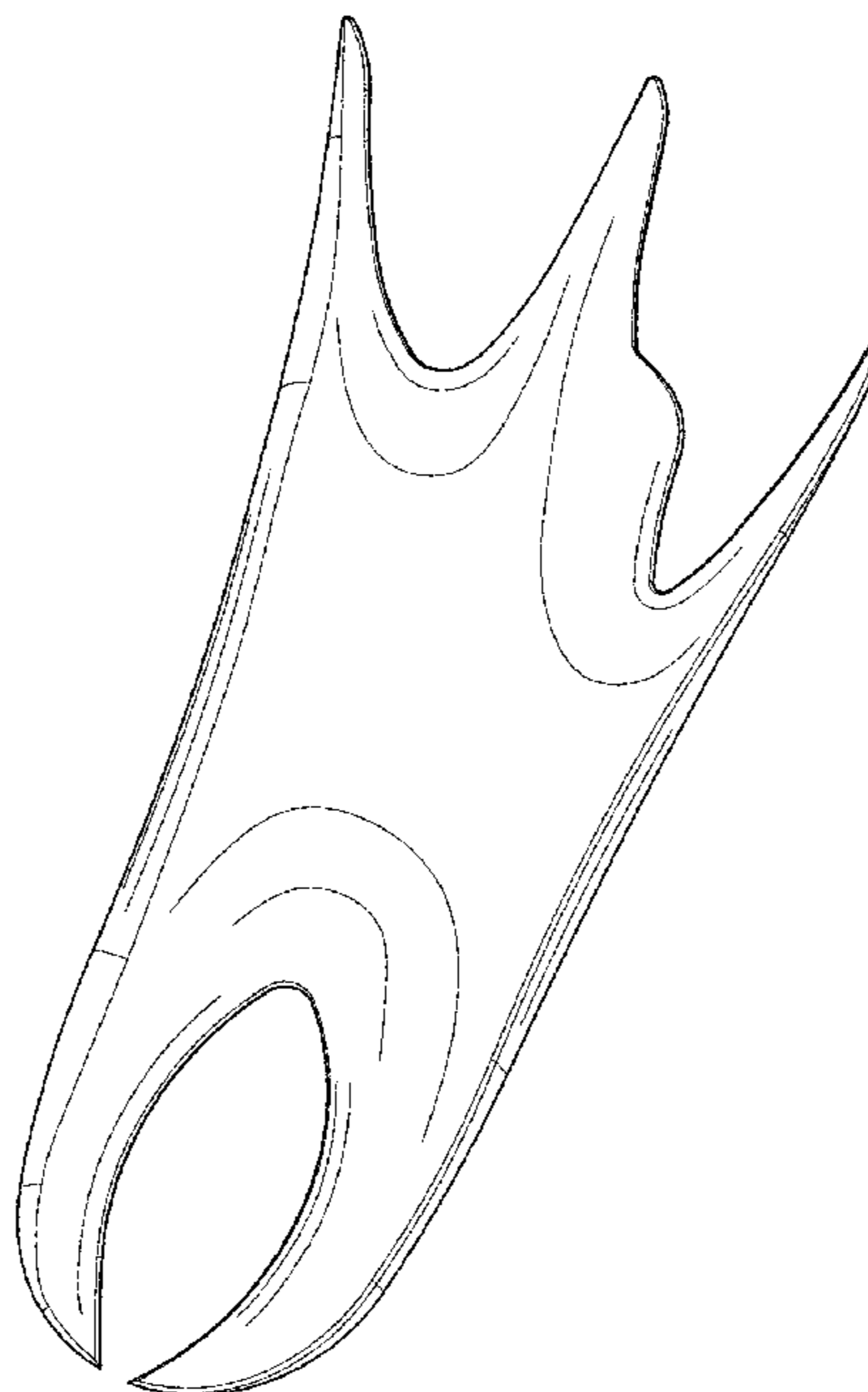
FIG. 1 is a perspective view of an insole, showing my new design;

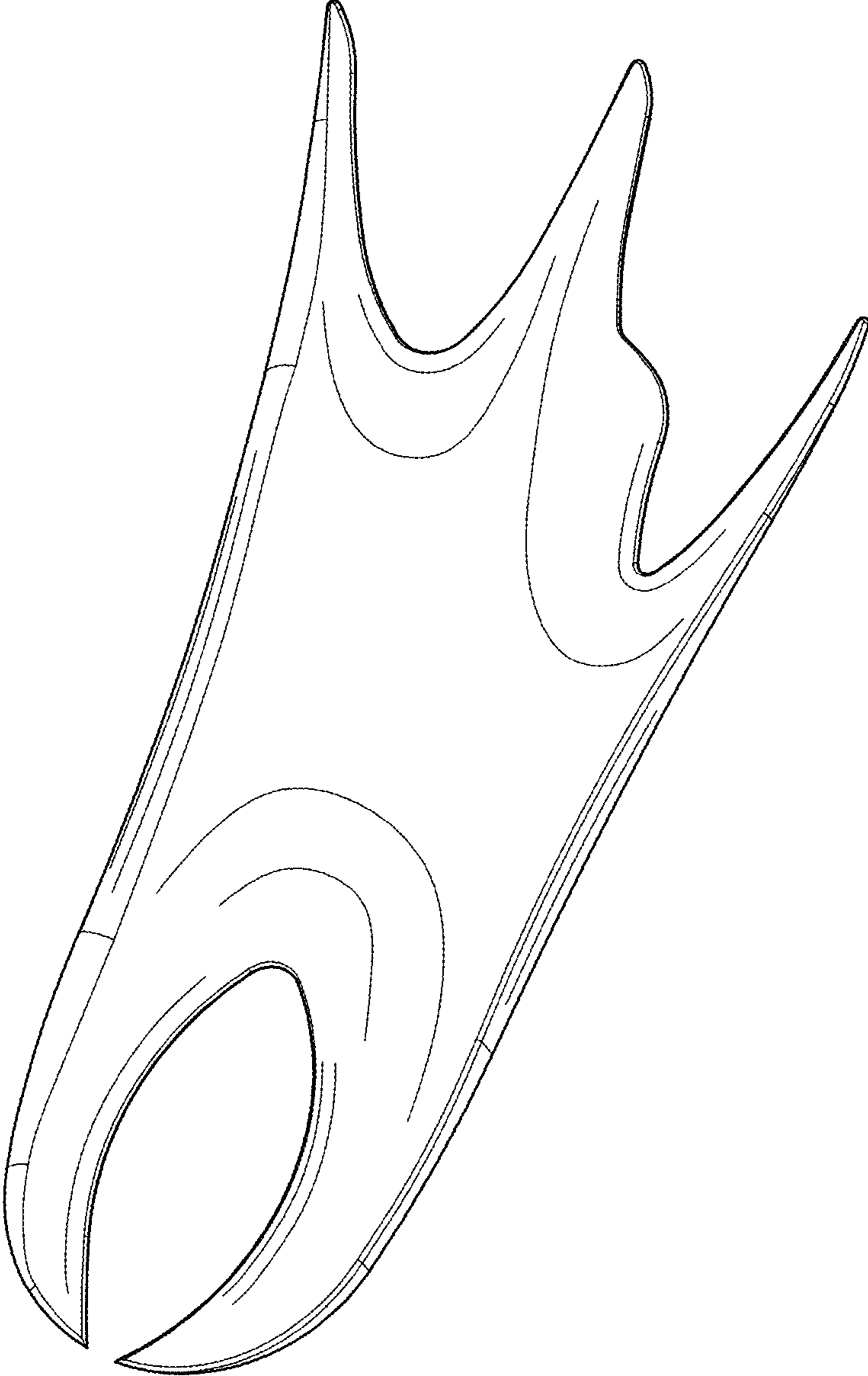

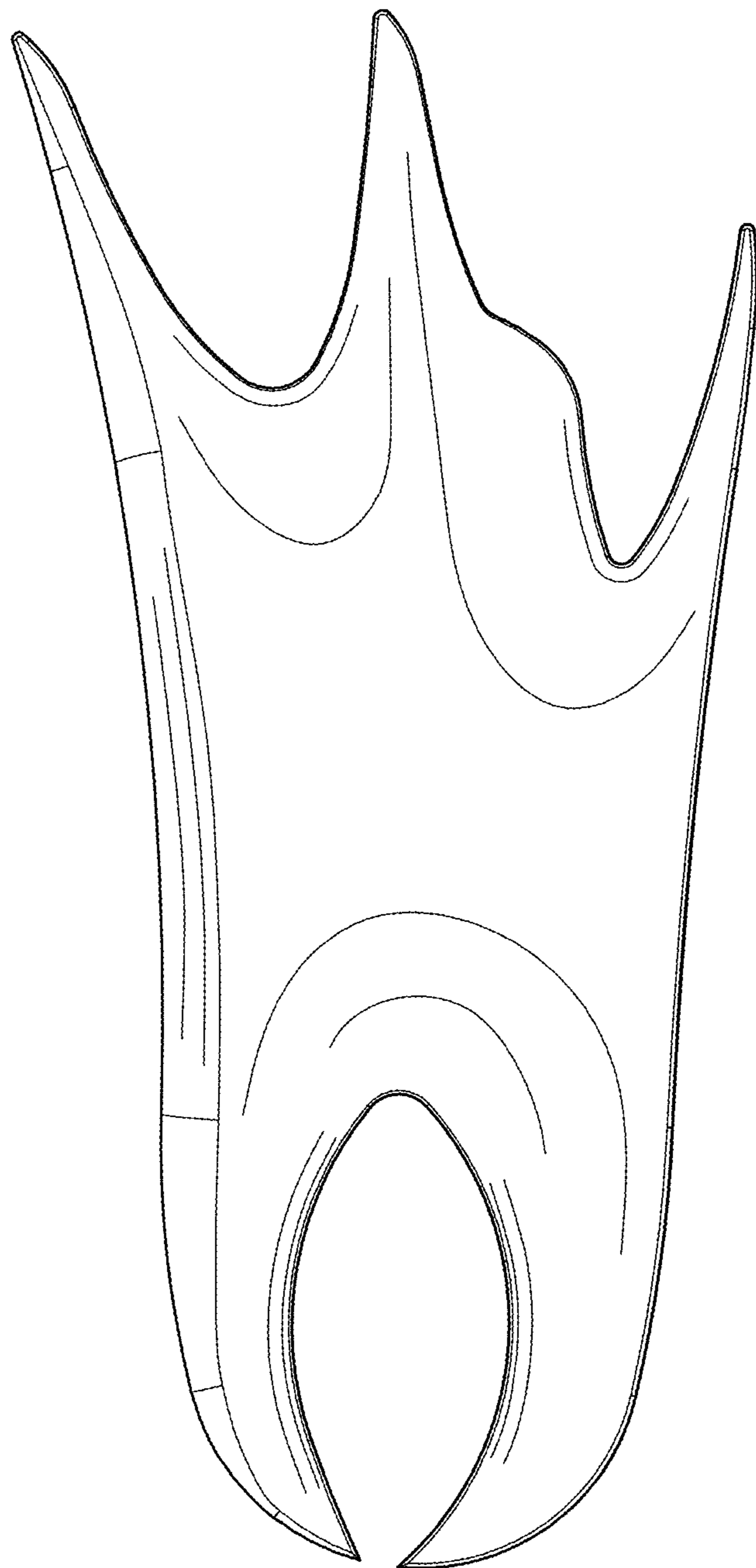

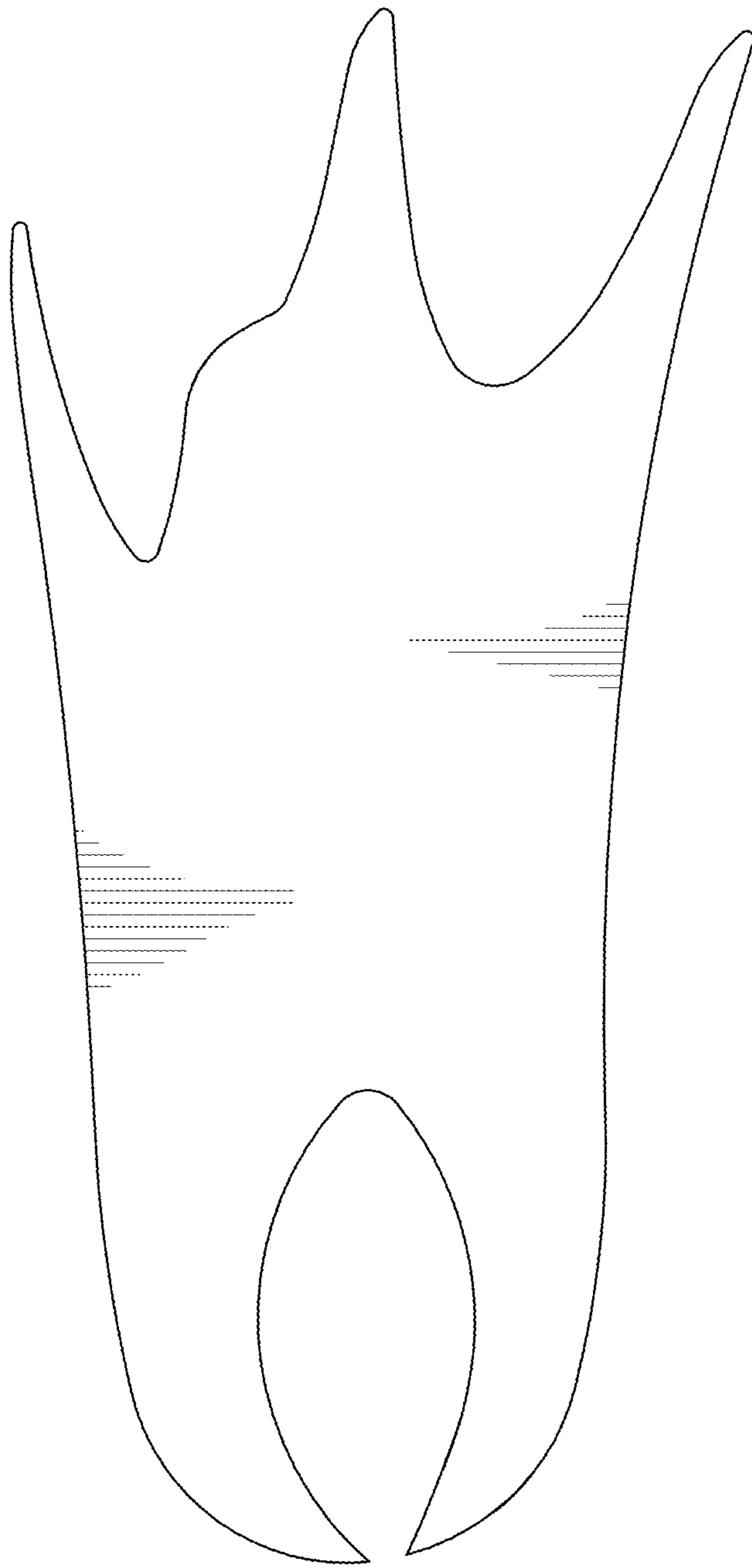

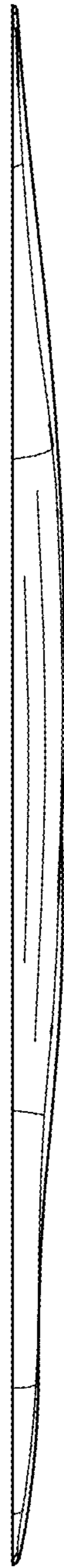

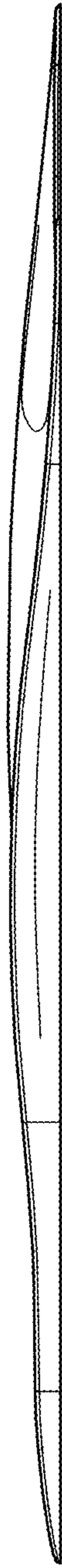

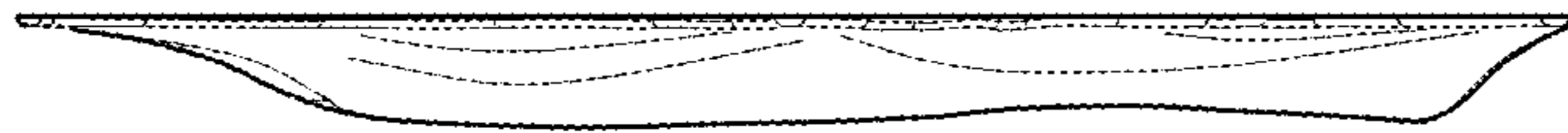

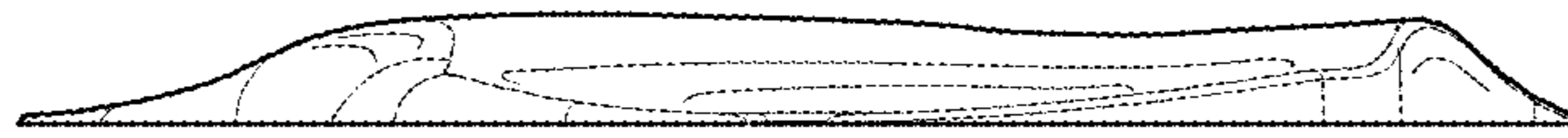
