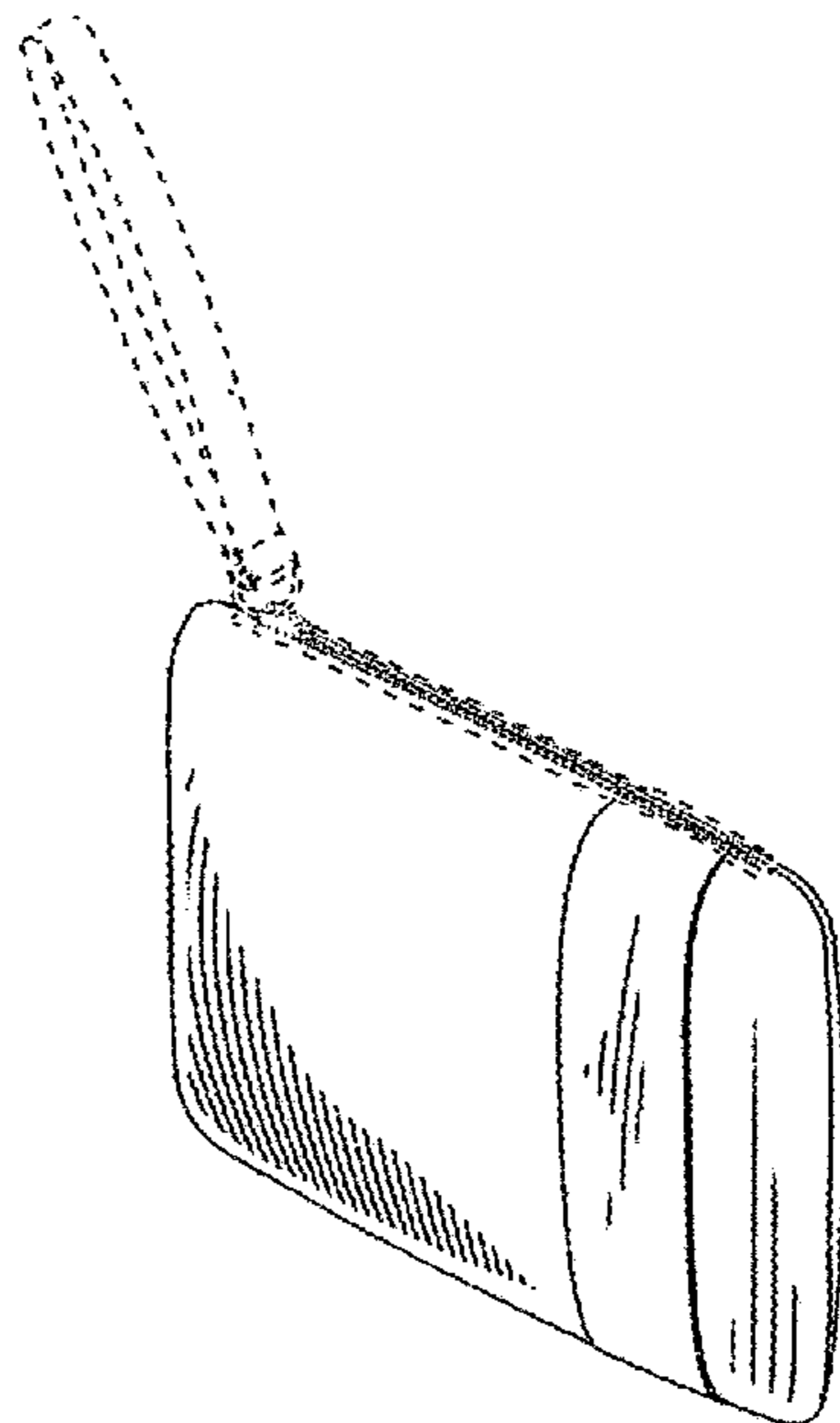
(57) **CLAIM**

The ornamental design for a purse, as shown and described.

DESCRIPTION

FIG. 1 is an isometric view of a purse showing my new design;
FIG. 2 is a front view of the purse, the rear view being a mirror image therefore;
FIG. 3 is a left side view of the purse;
FIG. 4 is a right side view of the purse;
FIG. 5 is a top plan view of the purse; and,
FIG. 6 is a bottom plan view of the purse.
The dash-dash broken lines illustrating a wristlet loop form no part of the claimed design.
The broken lines on the top of the design illustrate unclaimed stitching.

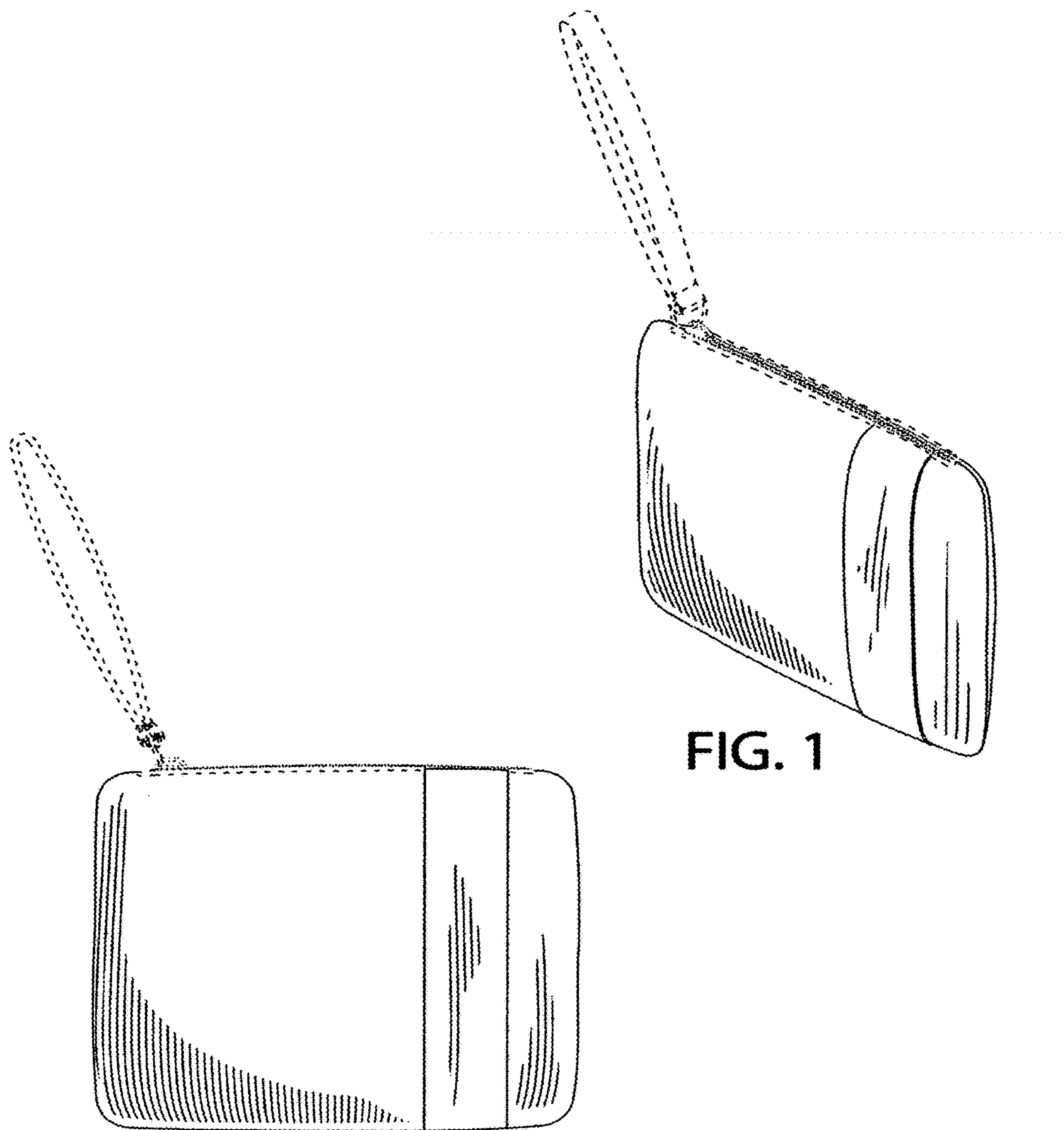

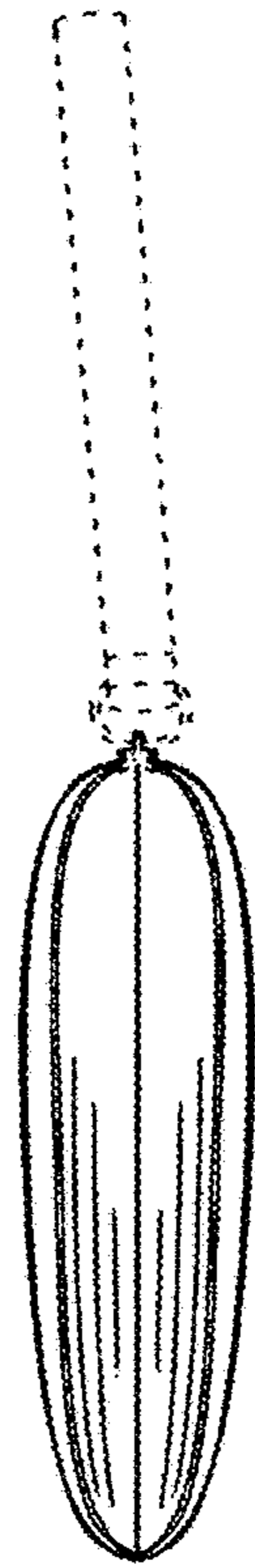

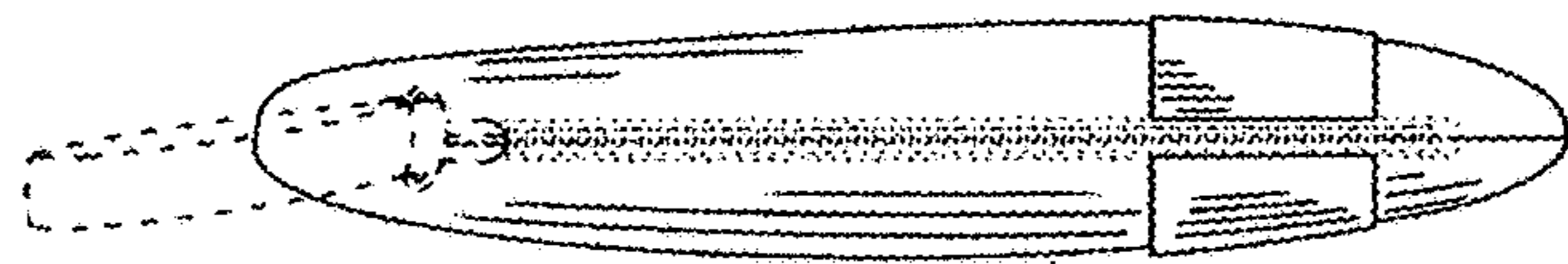

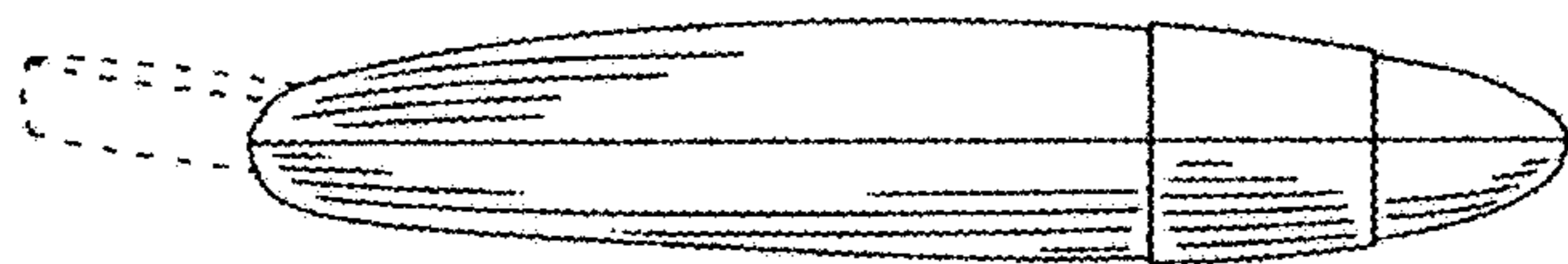
