FIG. 4 is a top view thereof.

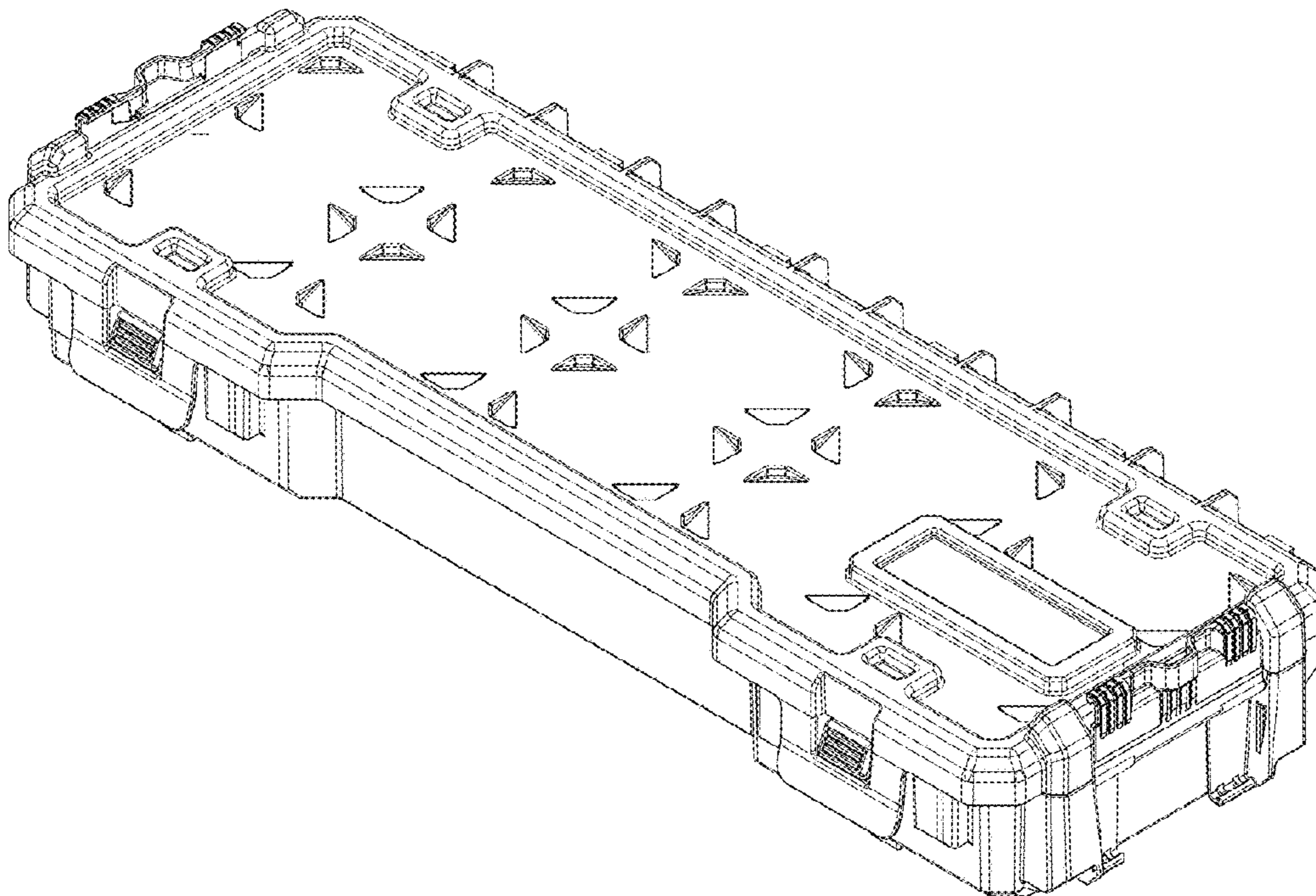
FIG. 5 is a bottom view thereof.

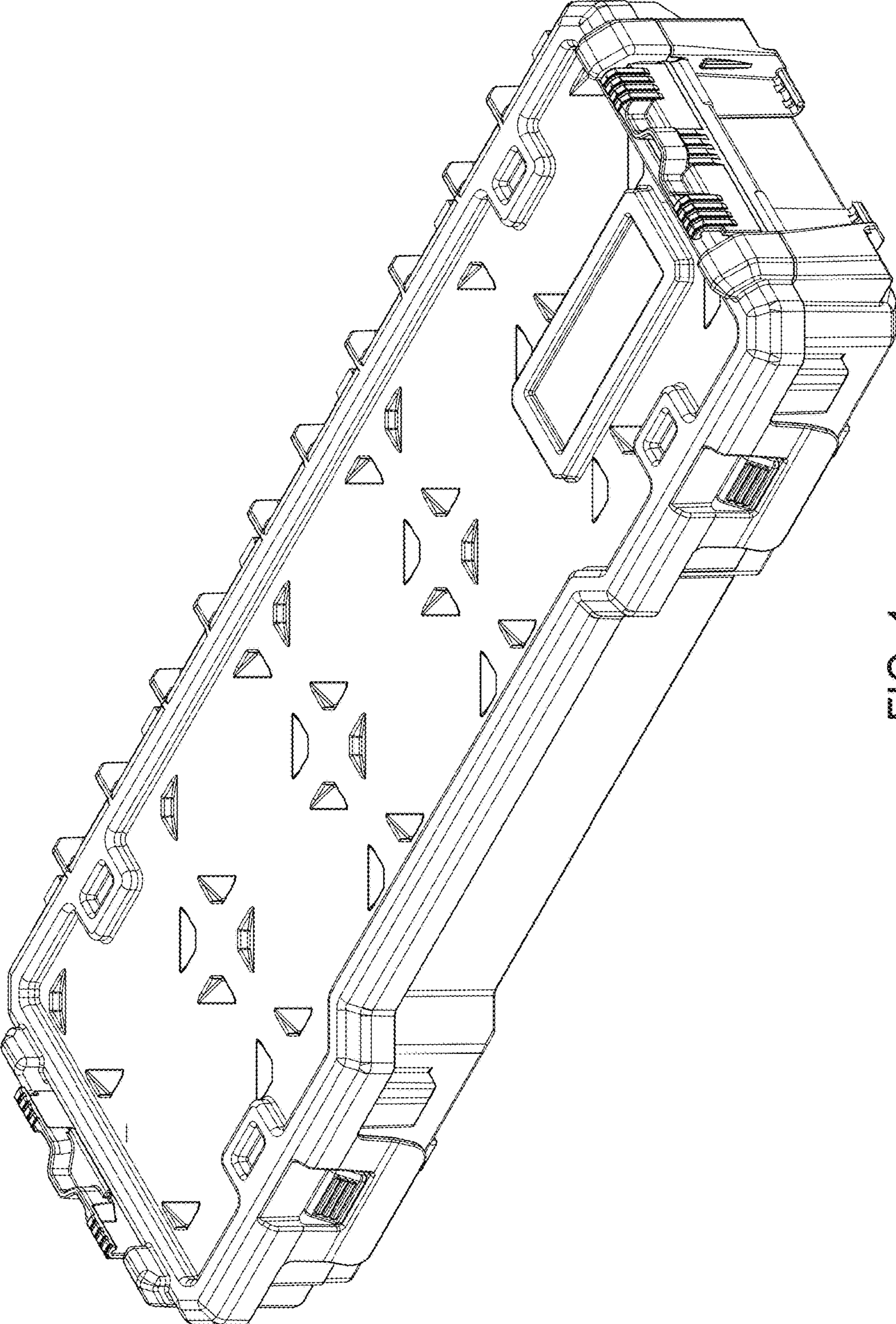

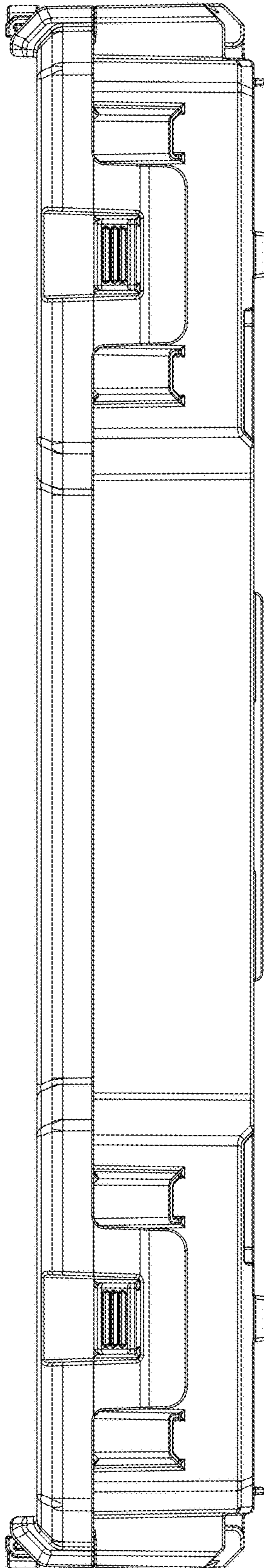

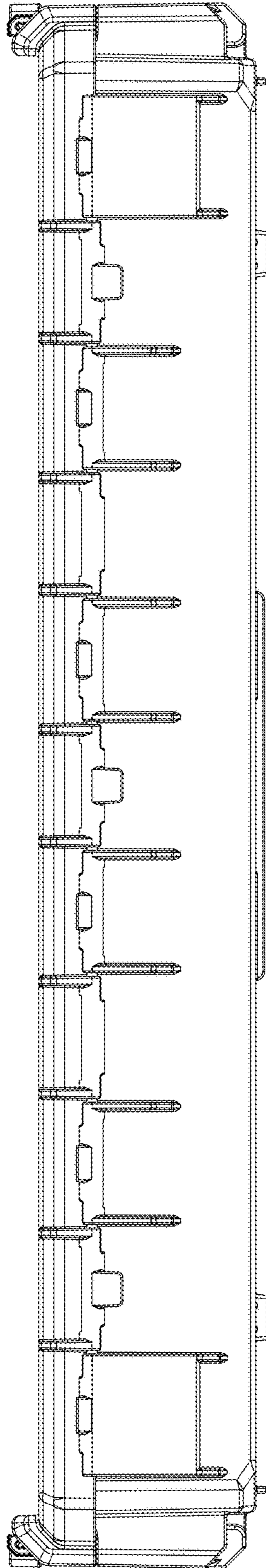

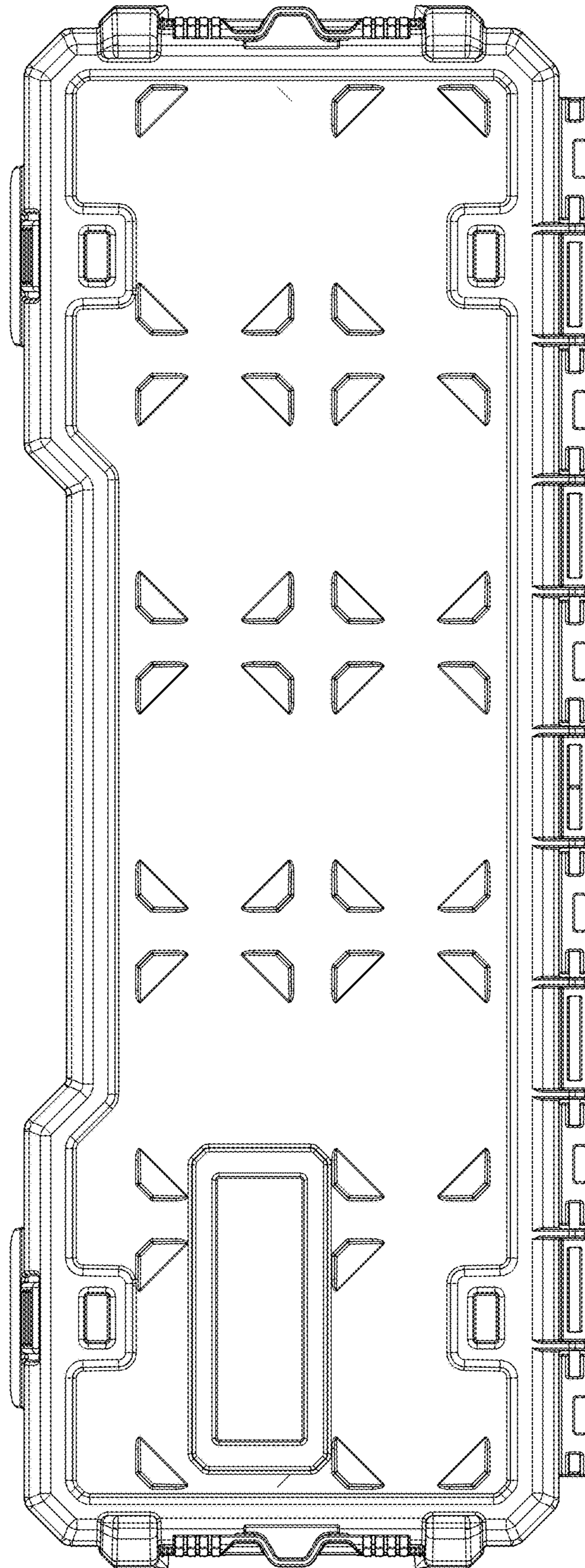

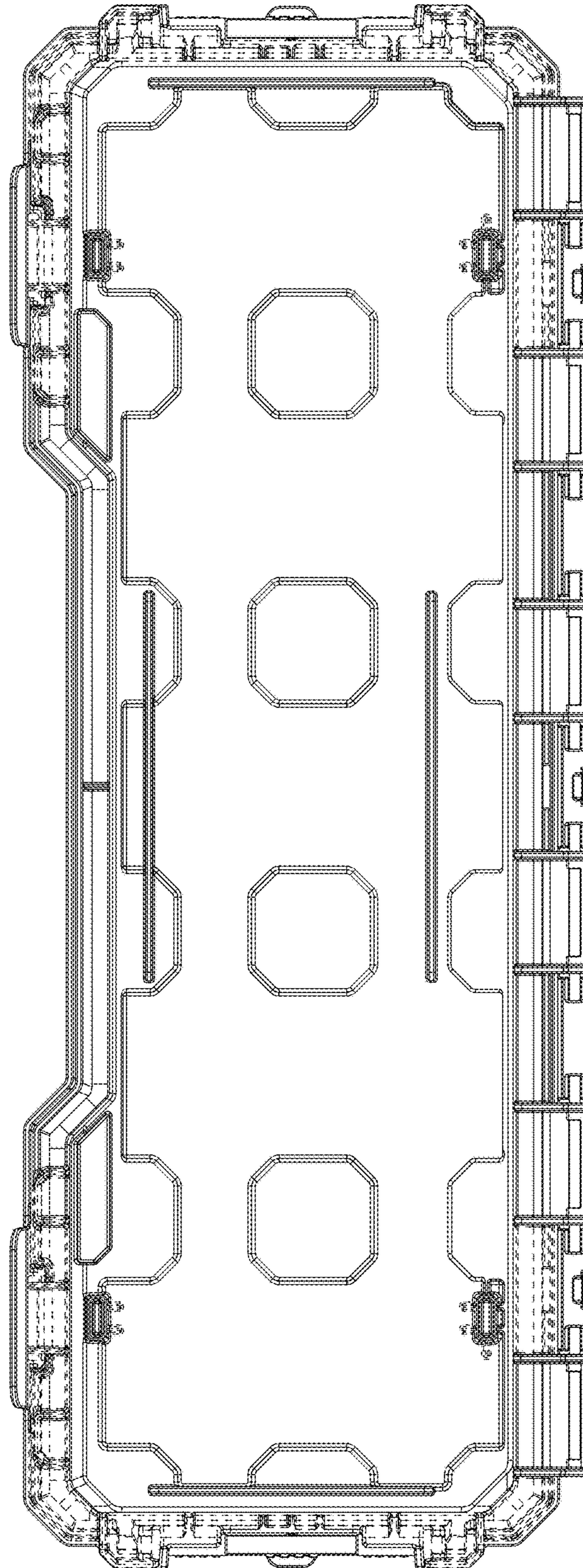

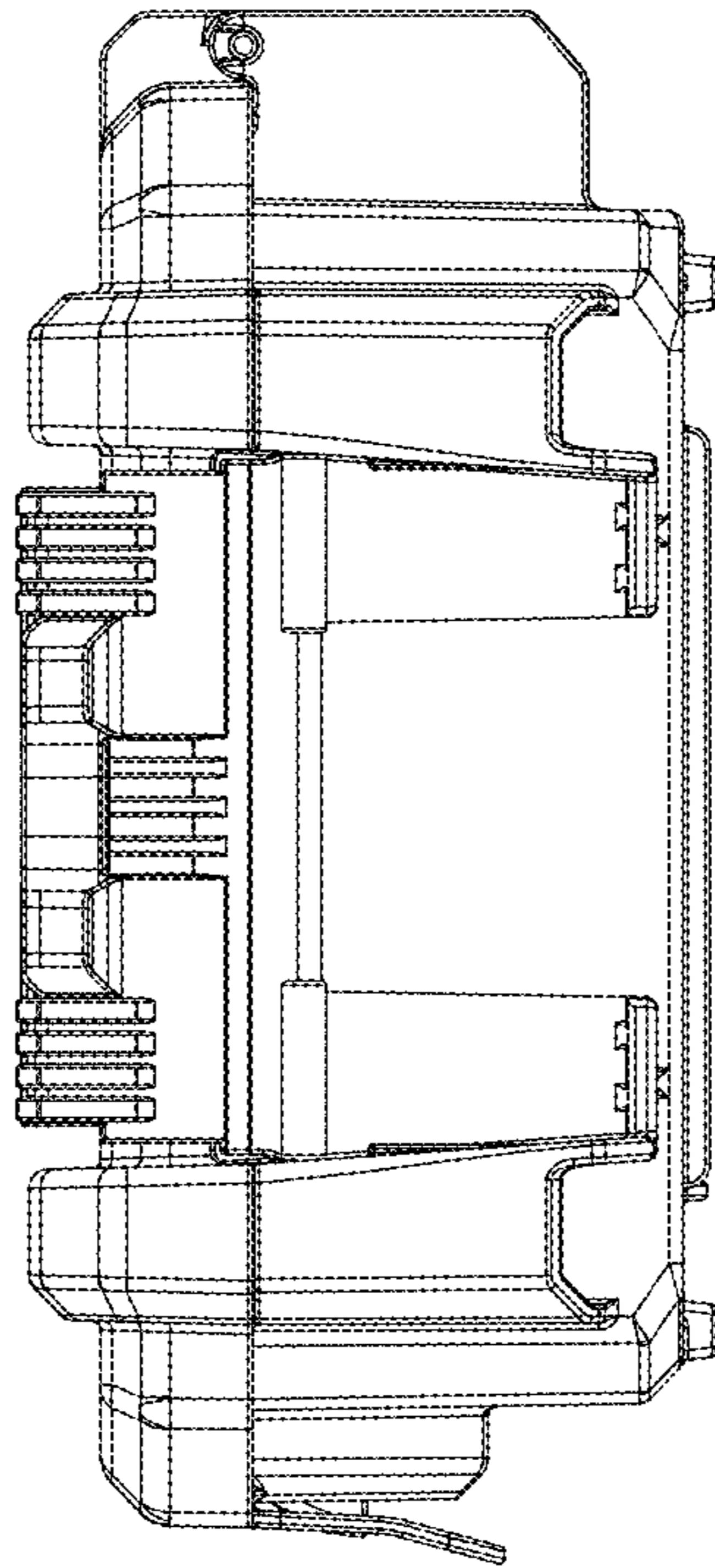

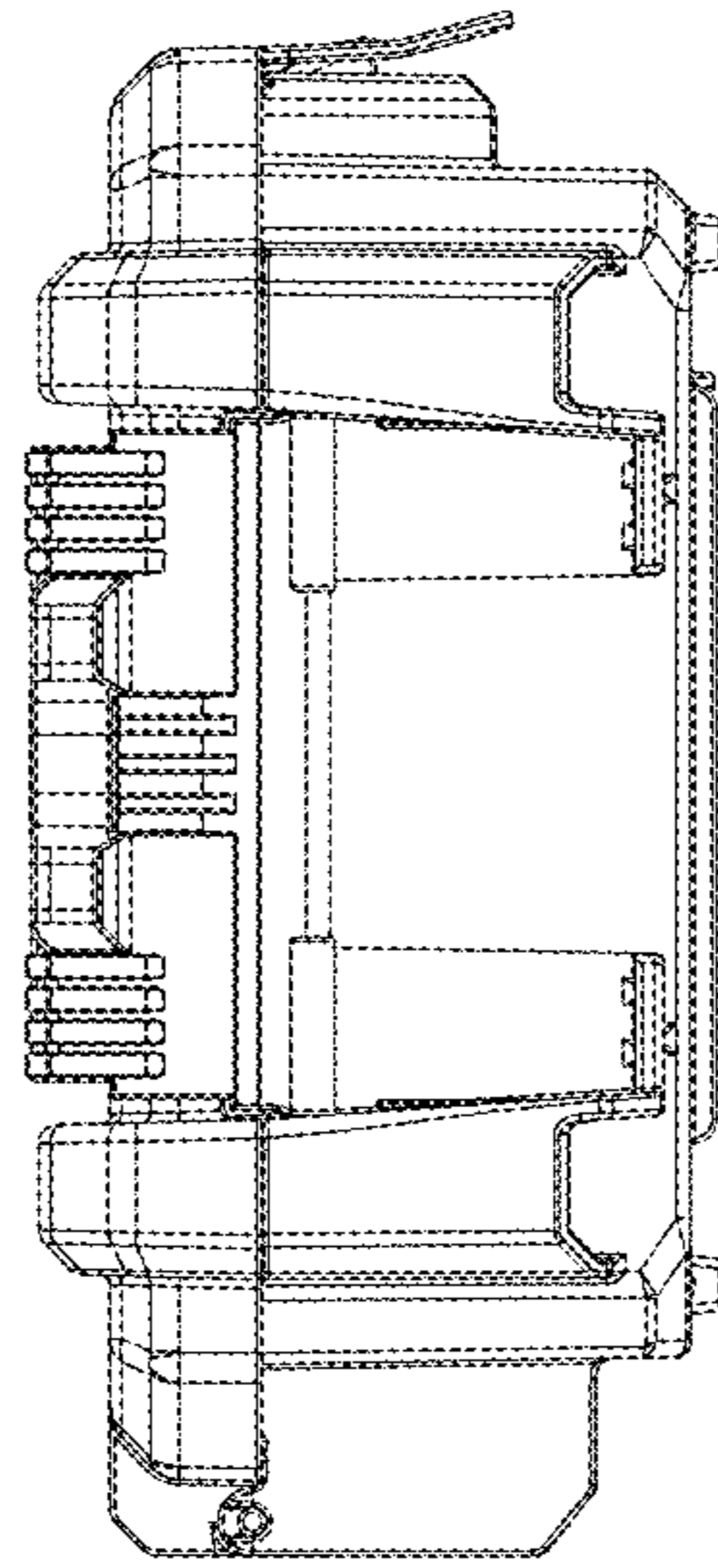
