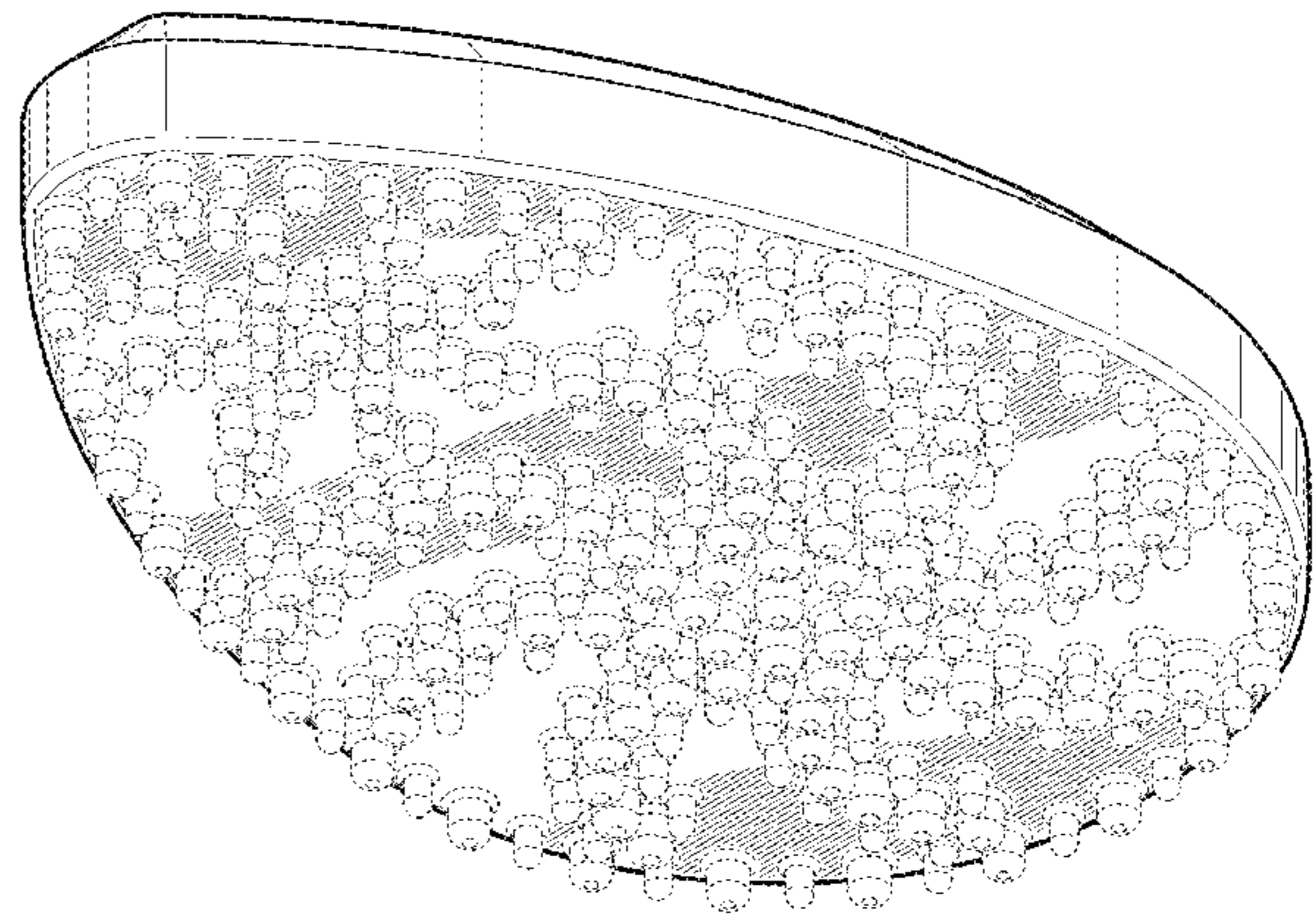
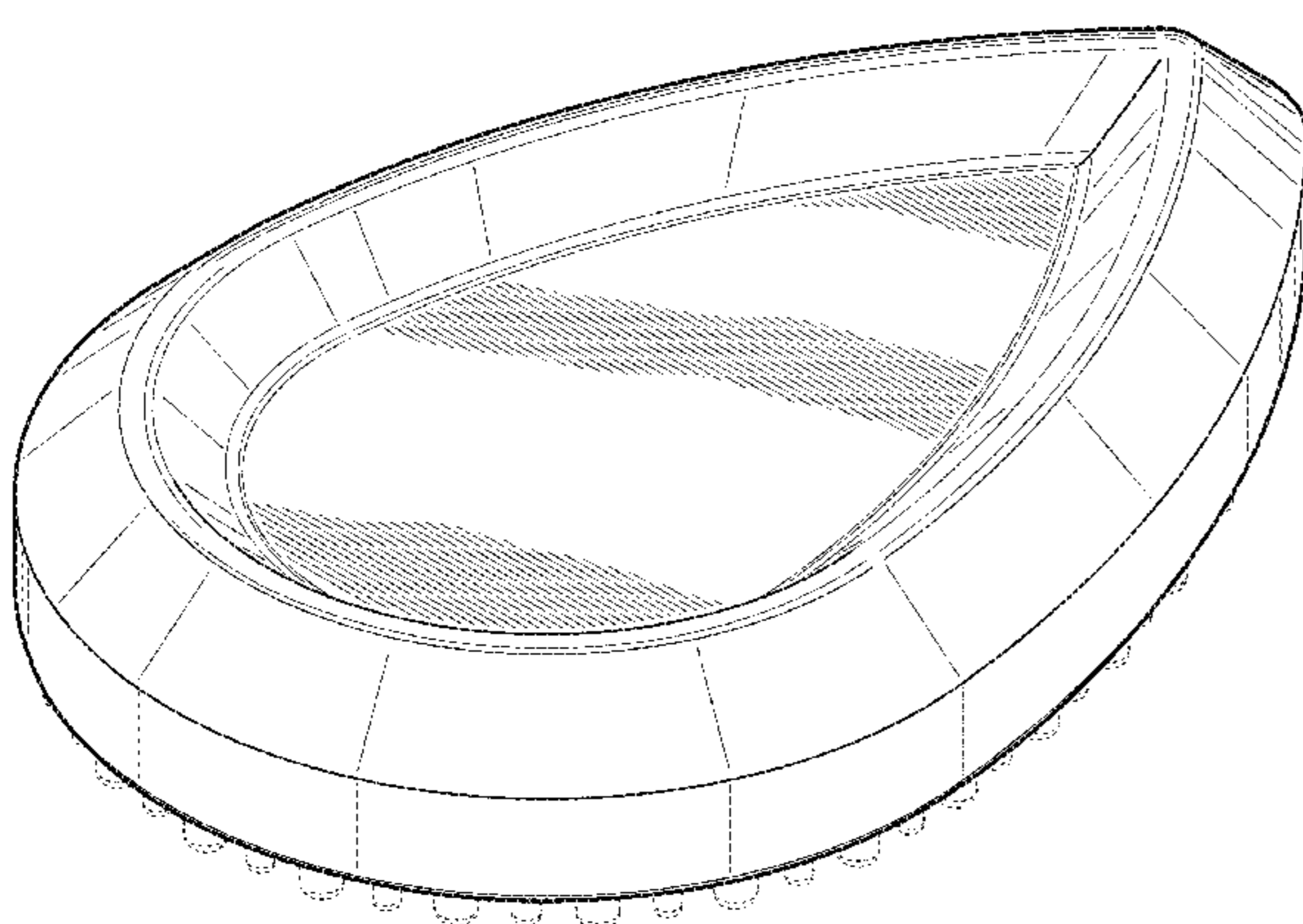
(57) **CLAIM**

The ornamental design for a skin brush, as shown and described.

DESCRIPTION

FIG. 1 is a top left rear perspective view of a skin brush; FIG. 2 is a bottom right front perspective view of a skin brush; FIG. 3 is a left side elevational view of a skin brush design; FIG. 4 is a rear elevational view of a skin brush; FIG. 5 is a right side elevational view of a skin brush; FIG. 6 is a front elevational view of a skin brush; FIG. 7 is a top plan view of a skin brush; and, FIG. 8 is a bottom plan view of a skin brush. Dashed lines represent unclaimed environment and form no part of the claimed design.

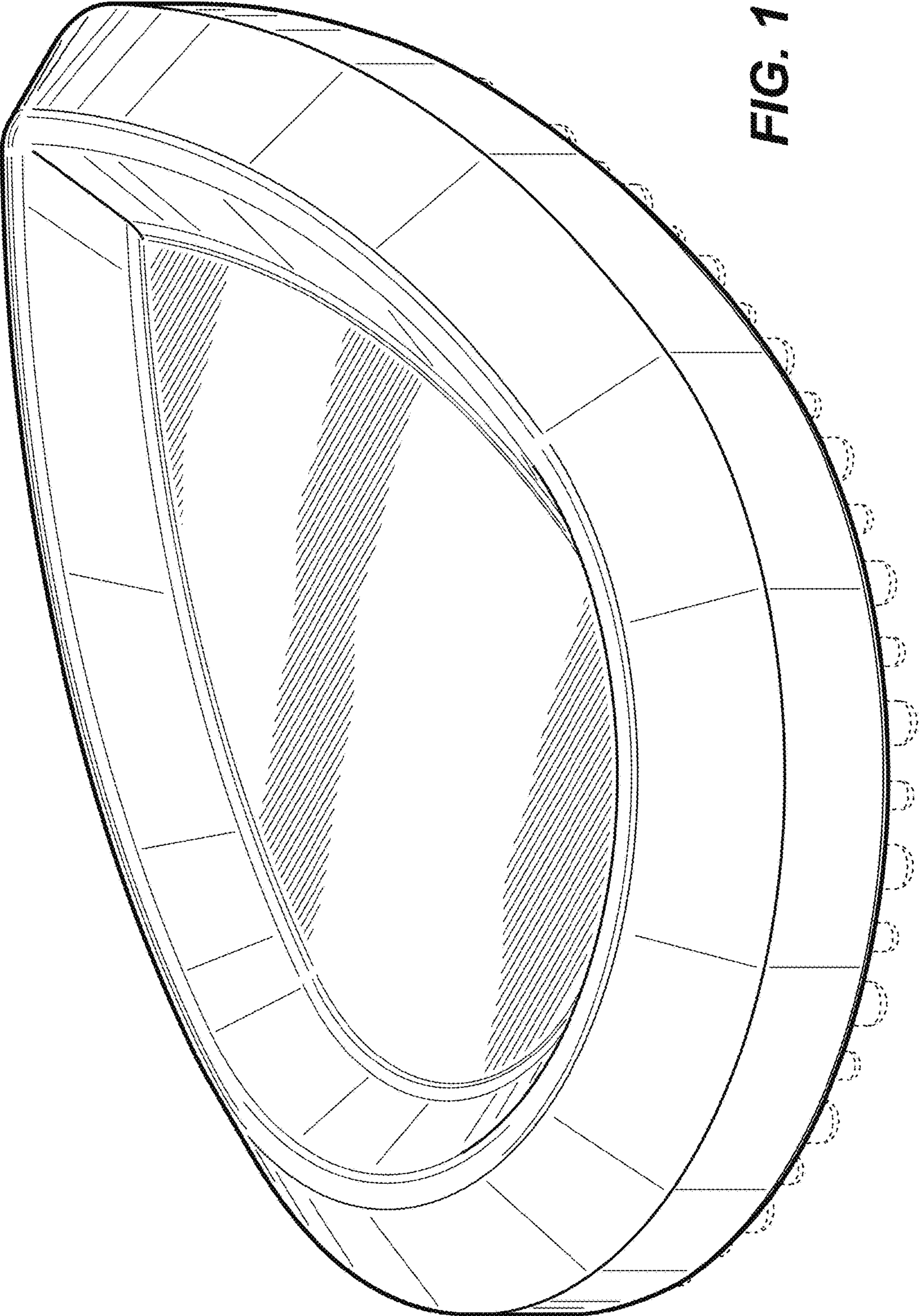

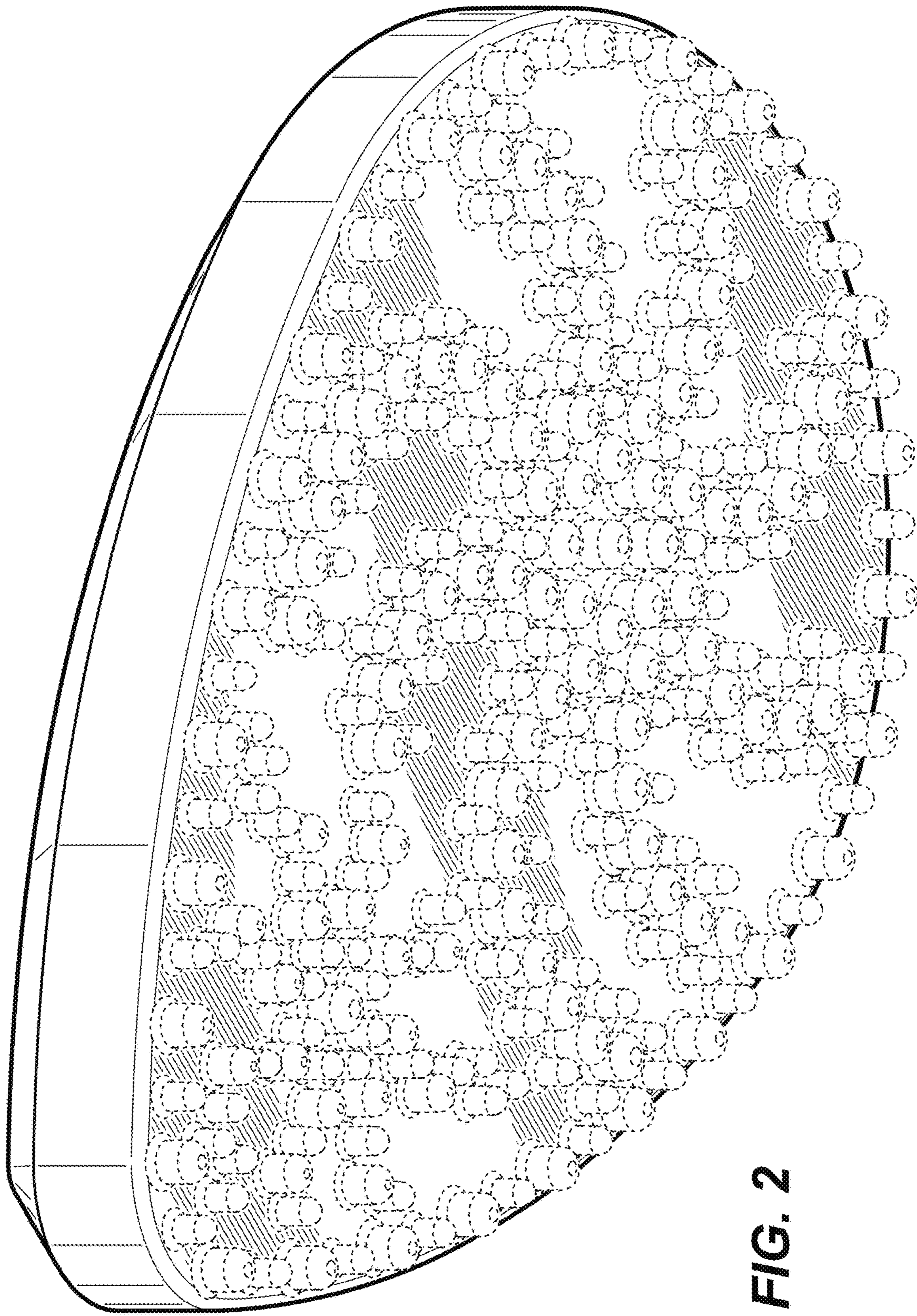

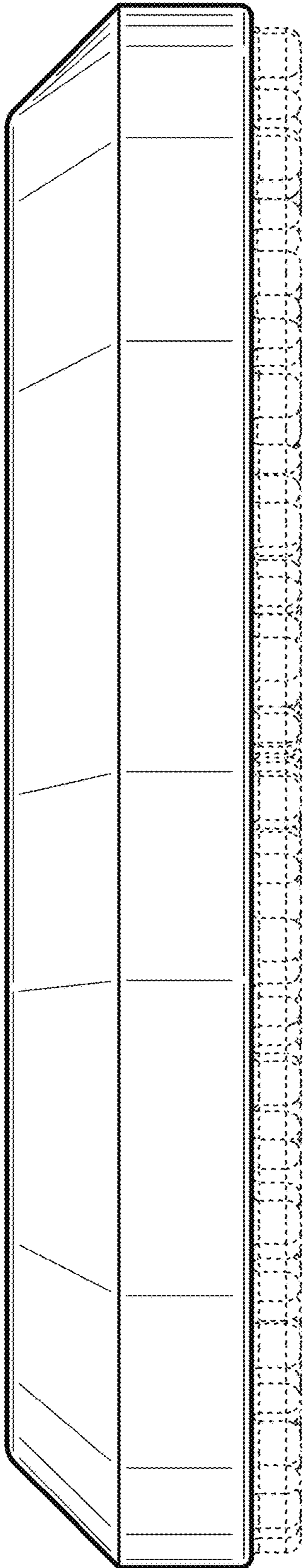

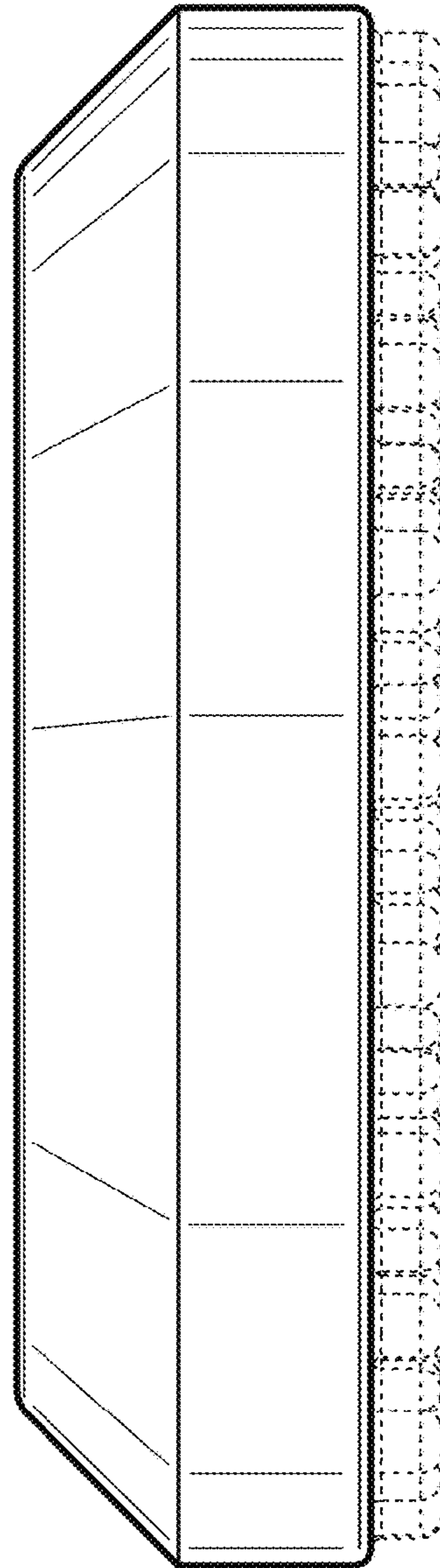

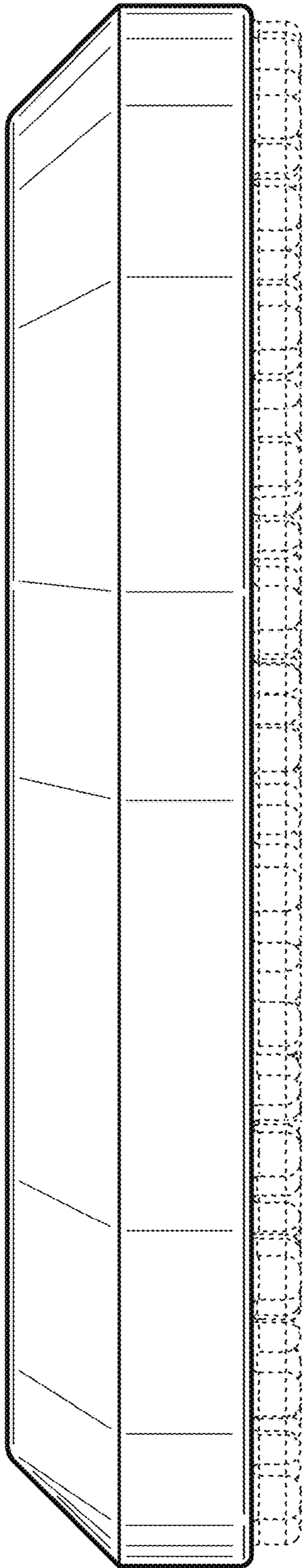

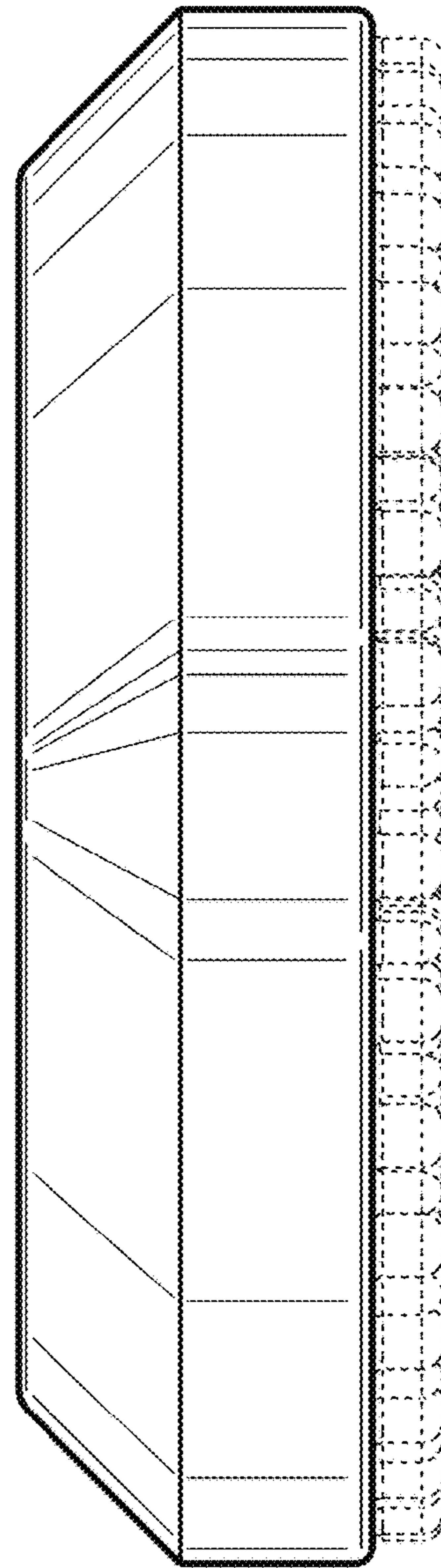

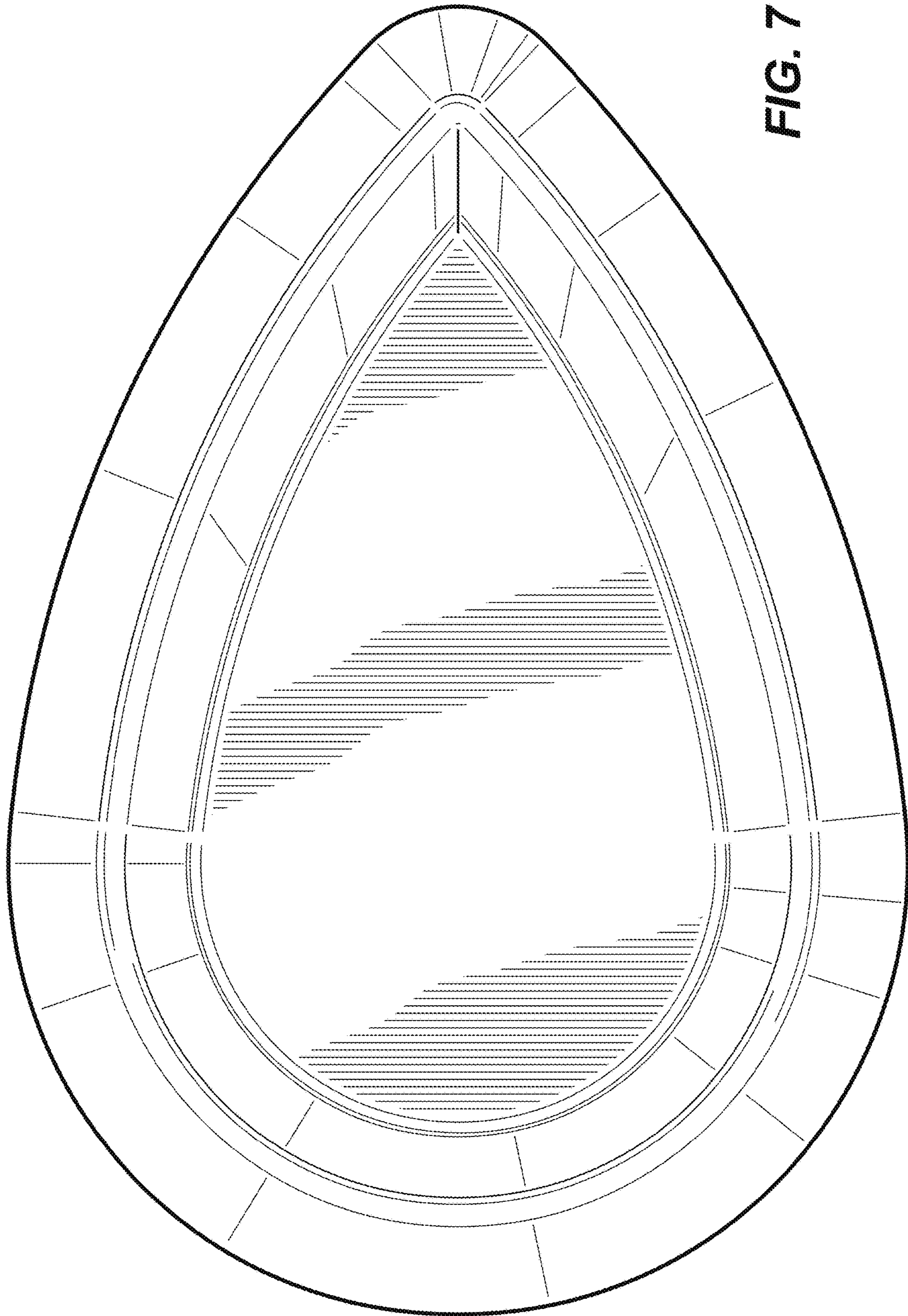

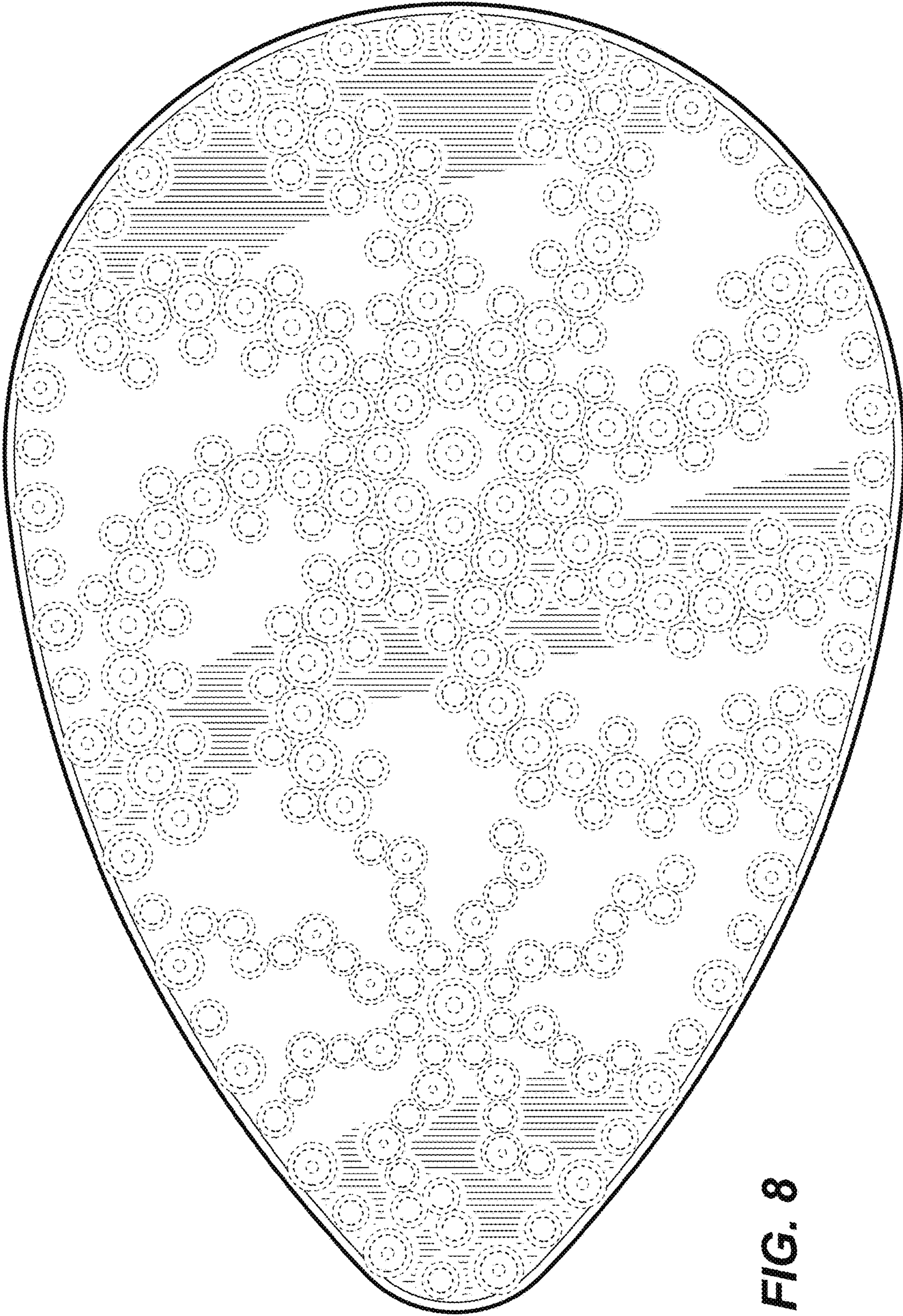
