(57) **CLAIM**

I claim the ornamental design for a hospital bed side rail cover, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of the hospital bed side rail cover showing the new design;

FIG. 2 is a bottom perspective view thereof;

FIG. 3 is a top plan view thereof;

FIG. 4 is a bottom plan view thereof;

FIG. 5 is a right side view thereof;

FIG. 6 is a left side view thereof;

FIG. 7 is right end view thereof;

FIG. 8 is a left end view thereof;

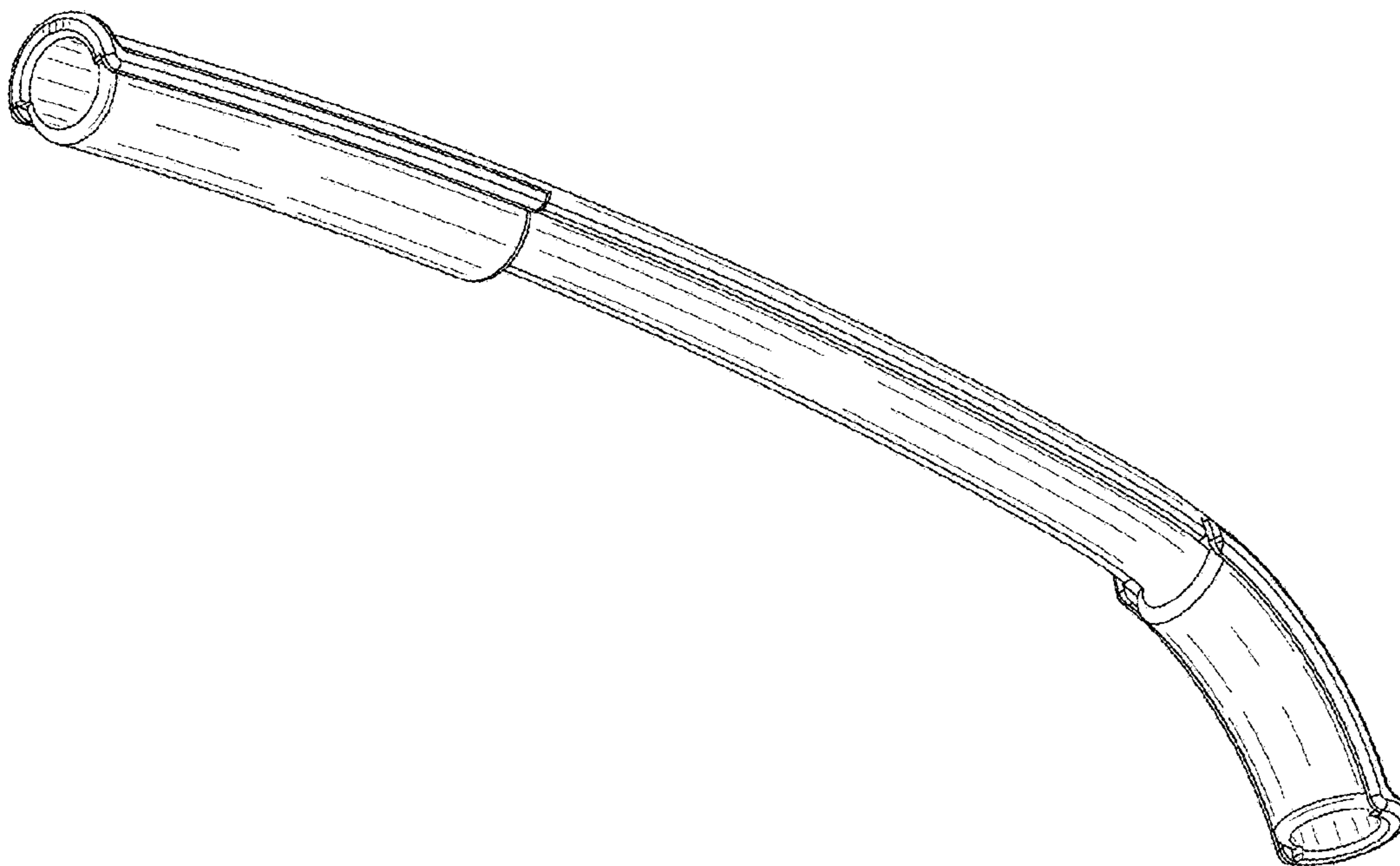
FIG. 9 is a second top perspective view thereof, shown at a reduced scale, and in an environment of use; and,

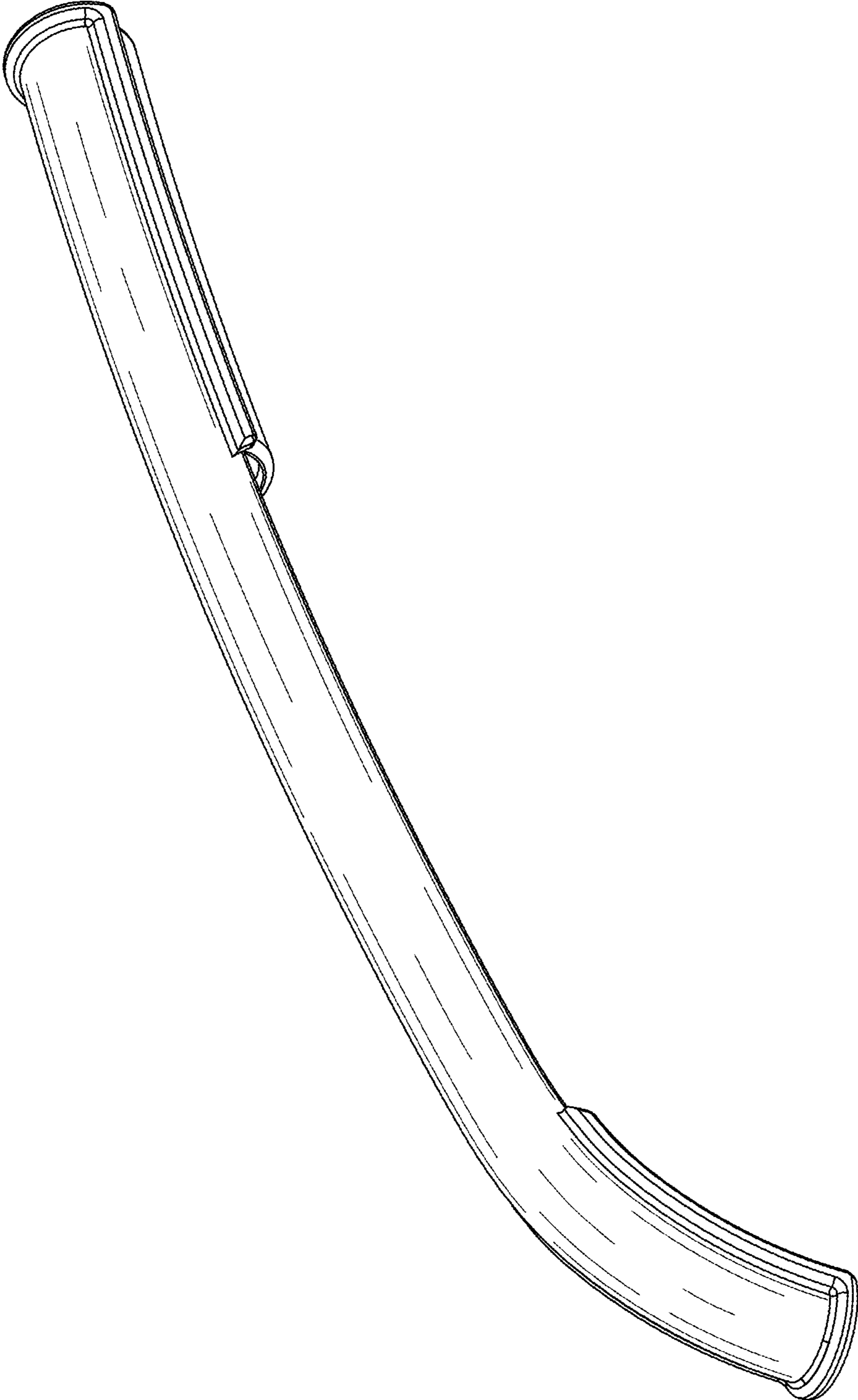

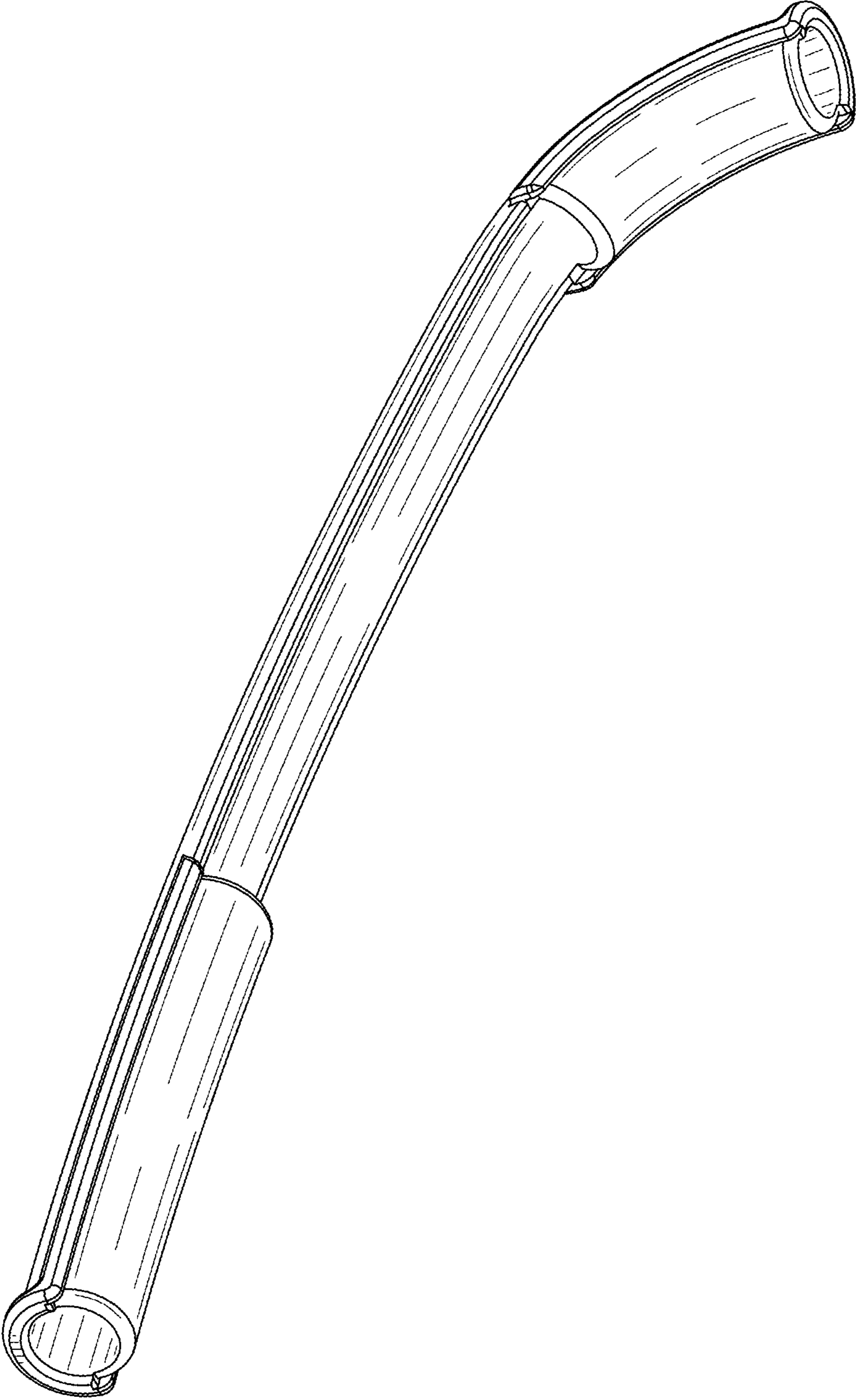

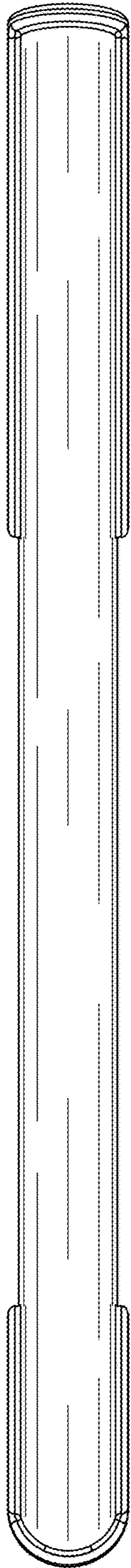

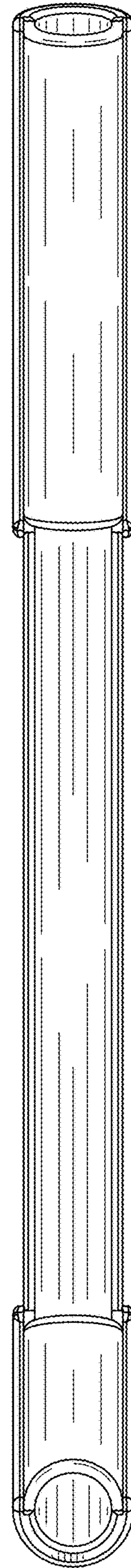

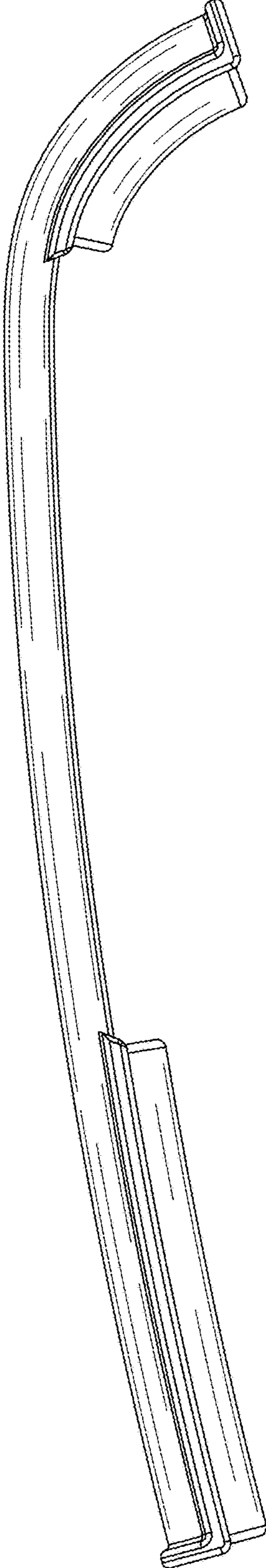

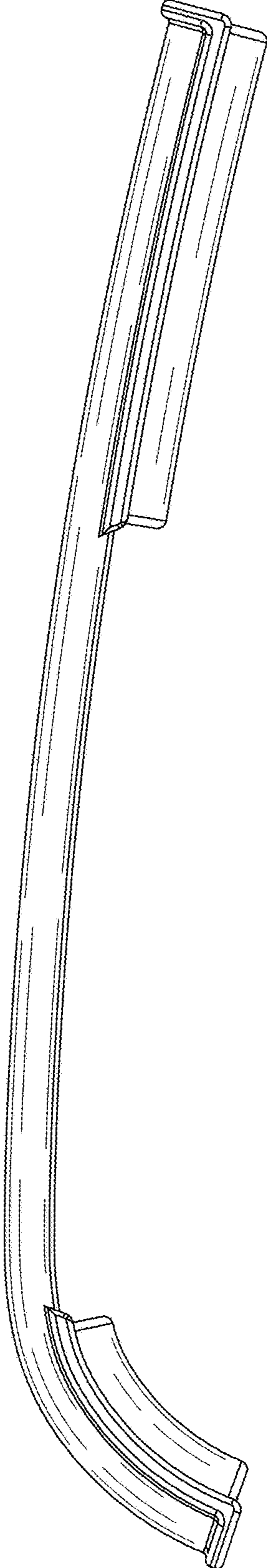

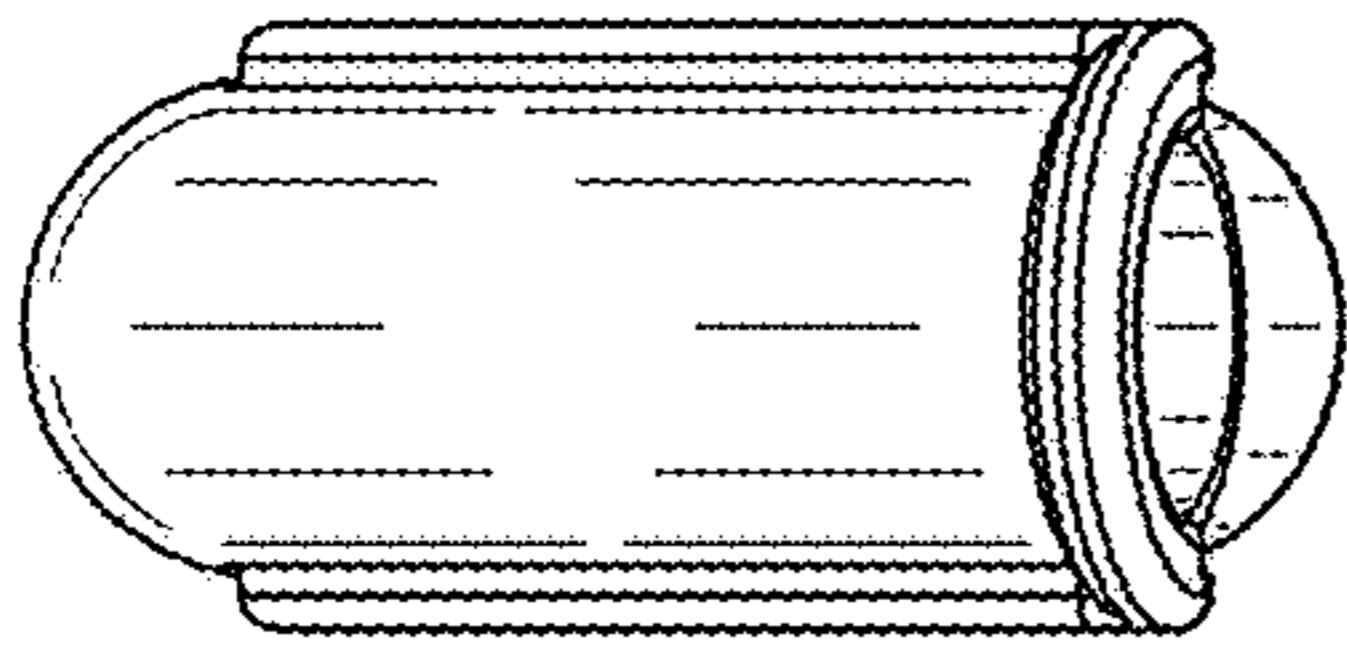

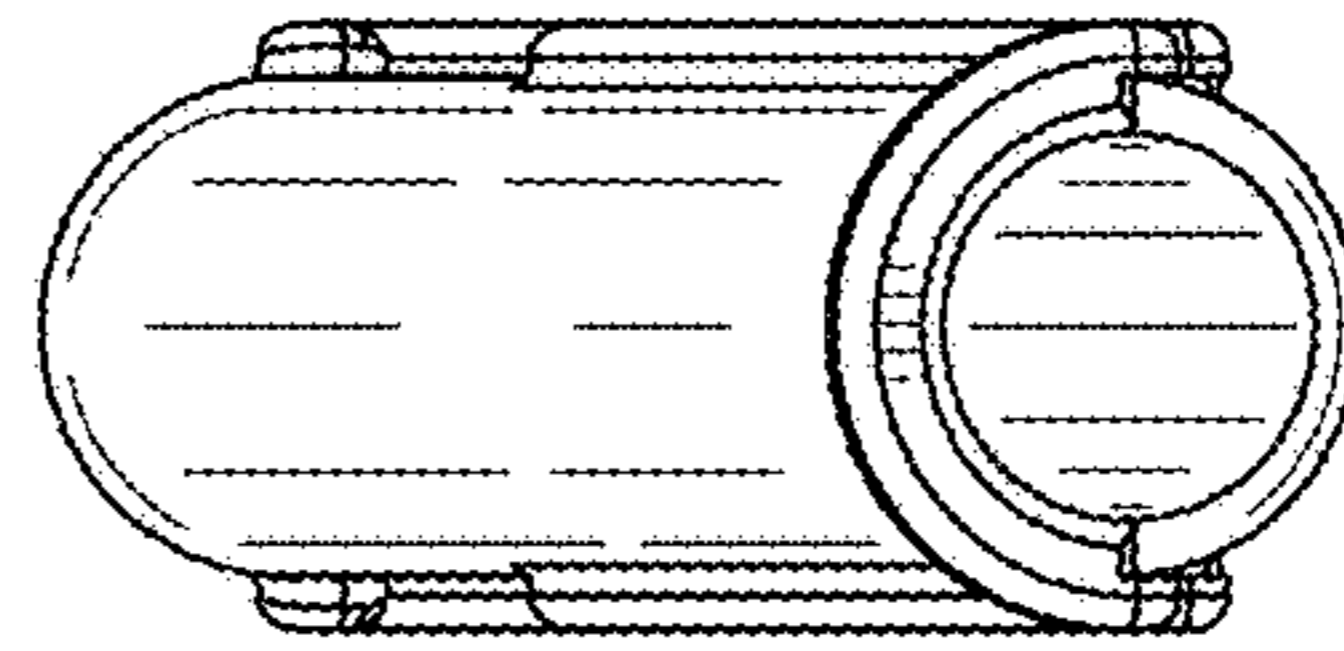

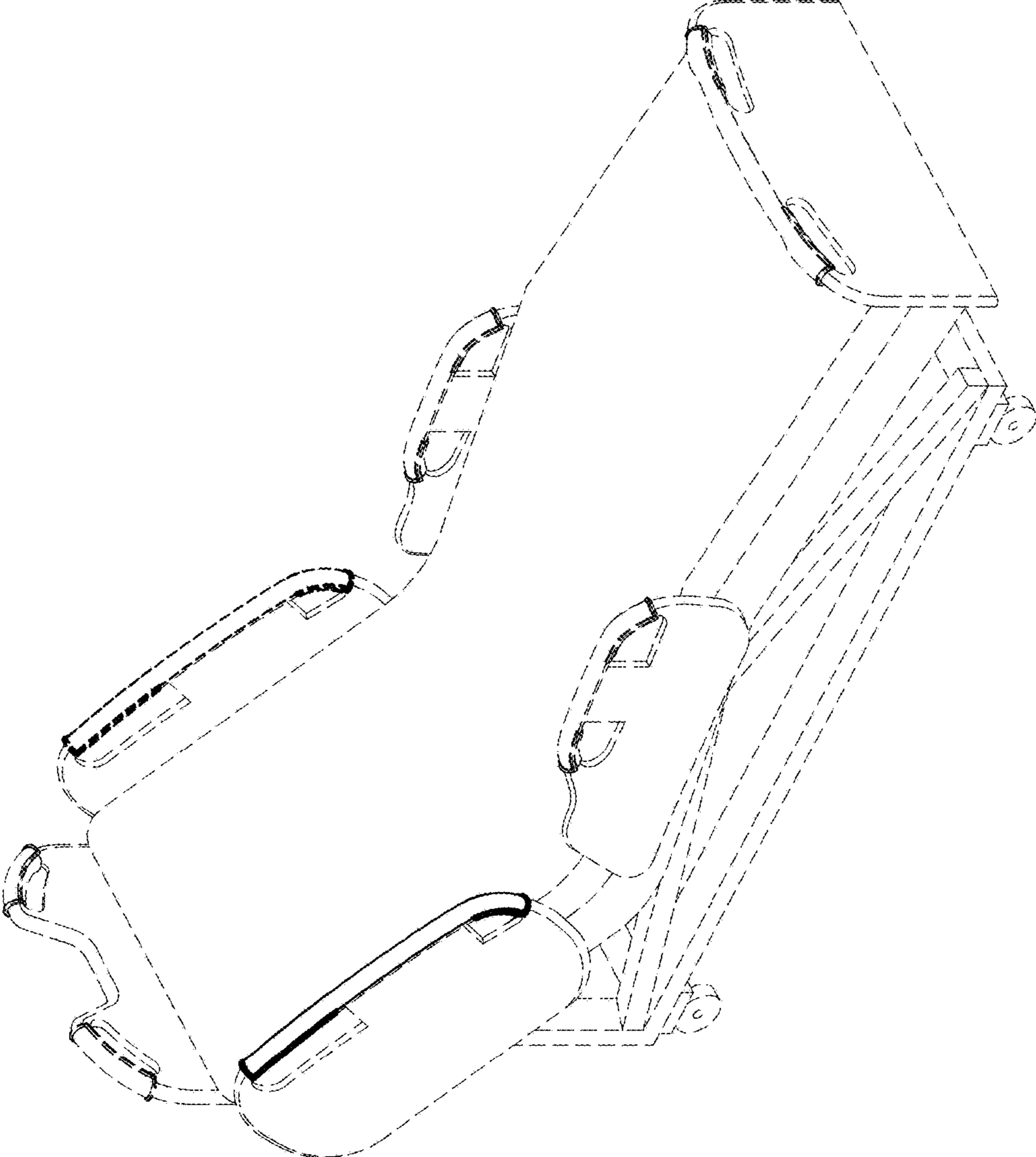

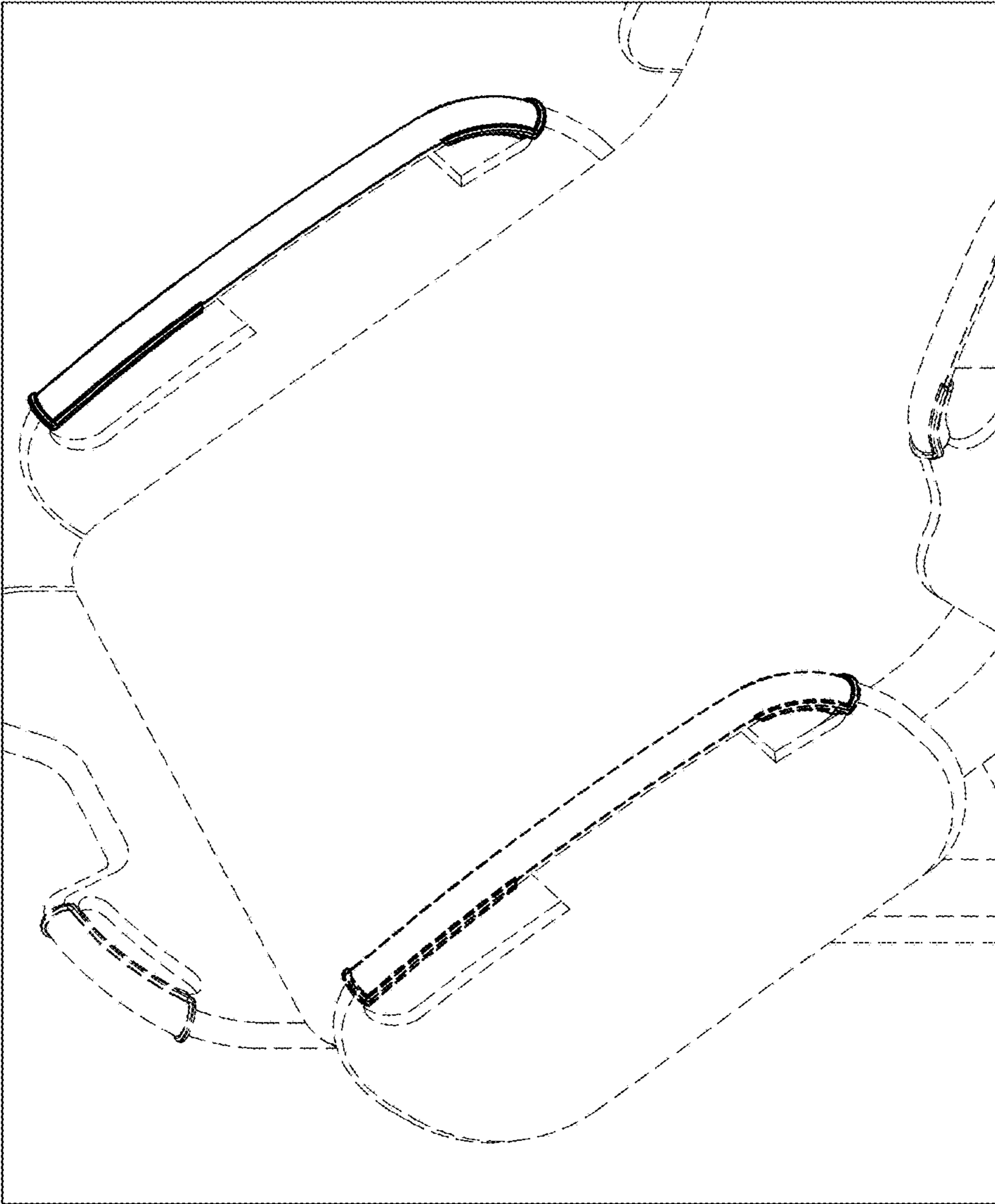
