 FIG. 7 is a rear view thereof, with the top of the plate facing up.

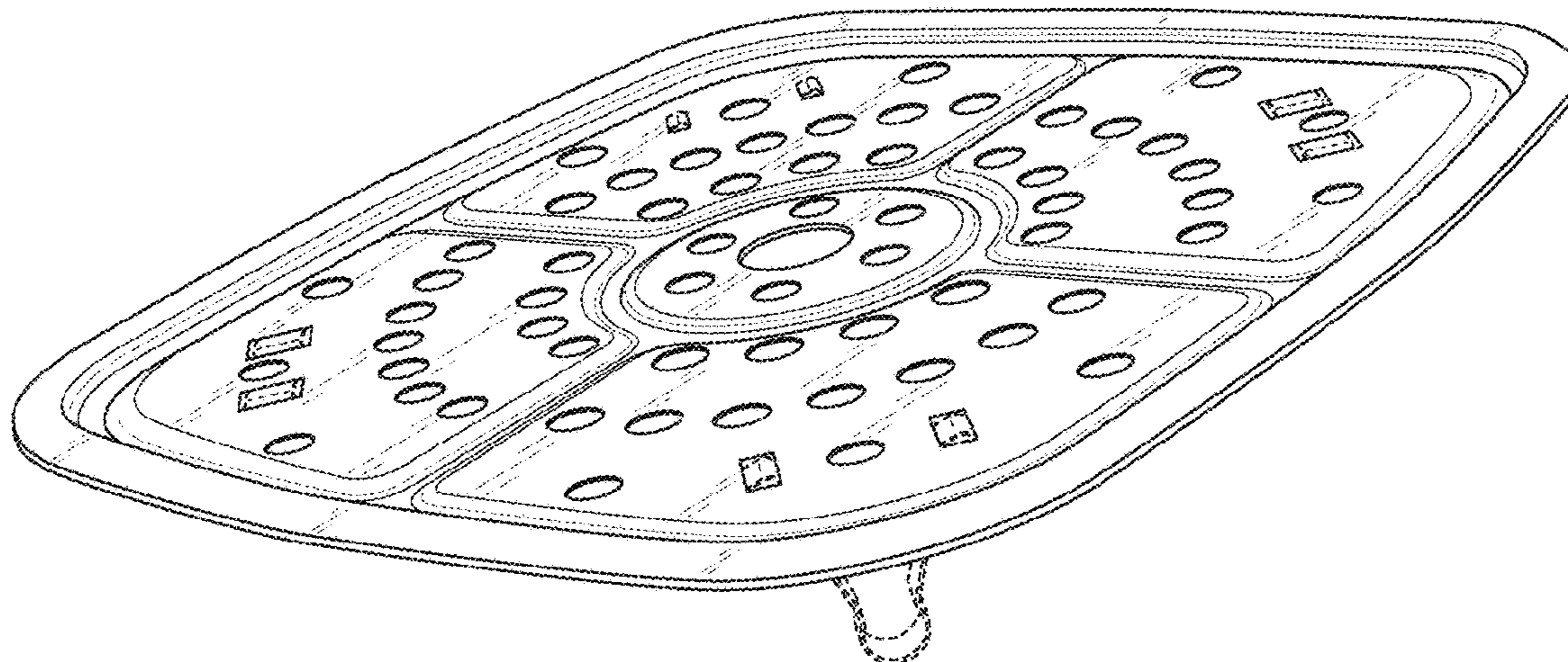

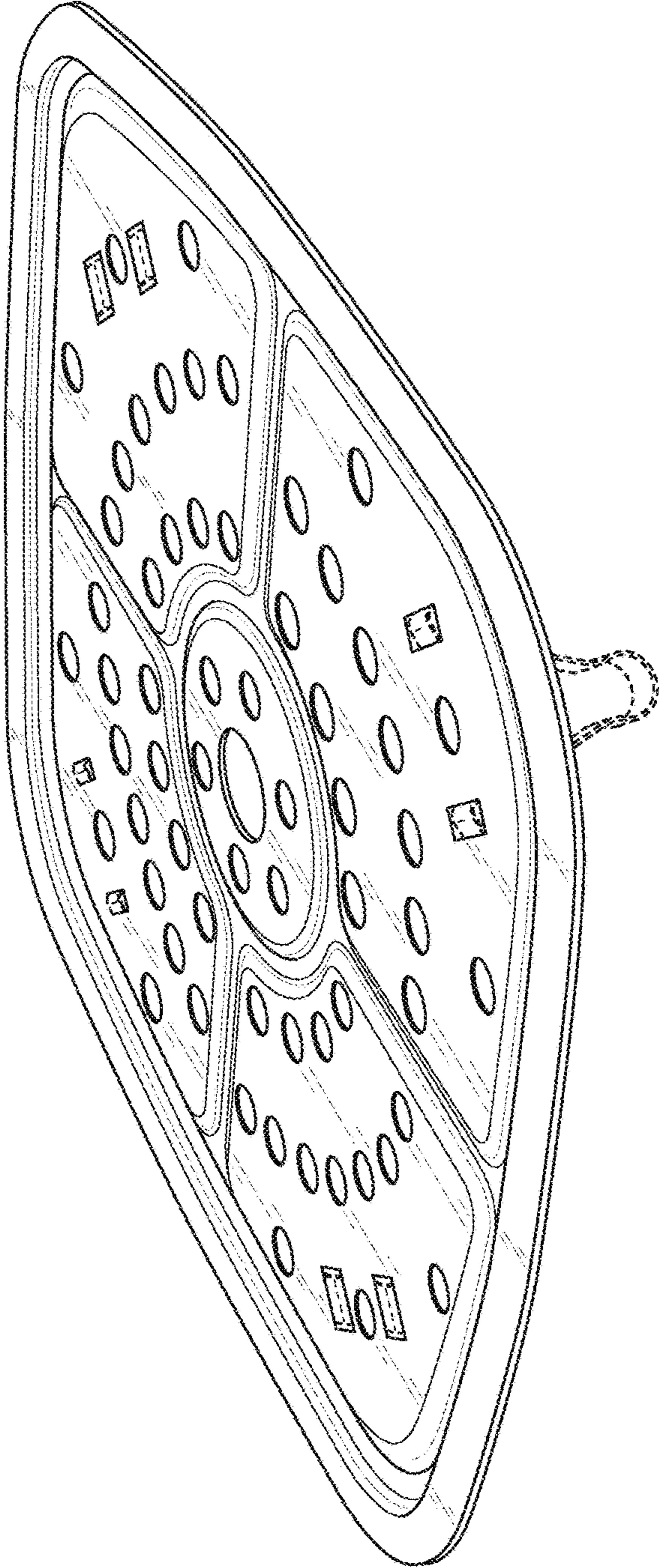

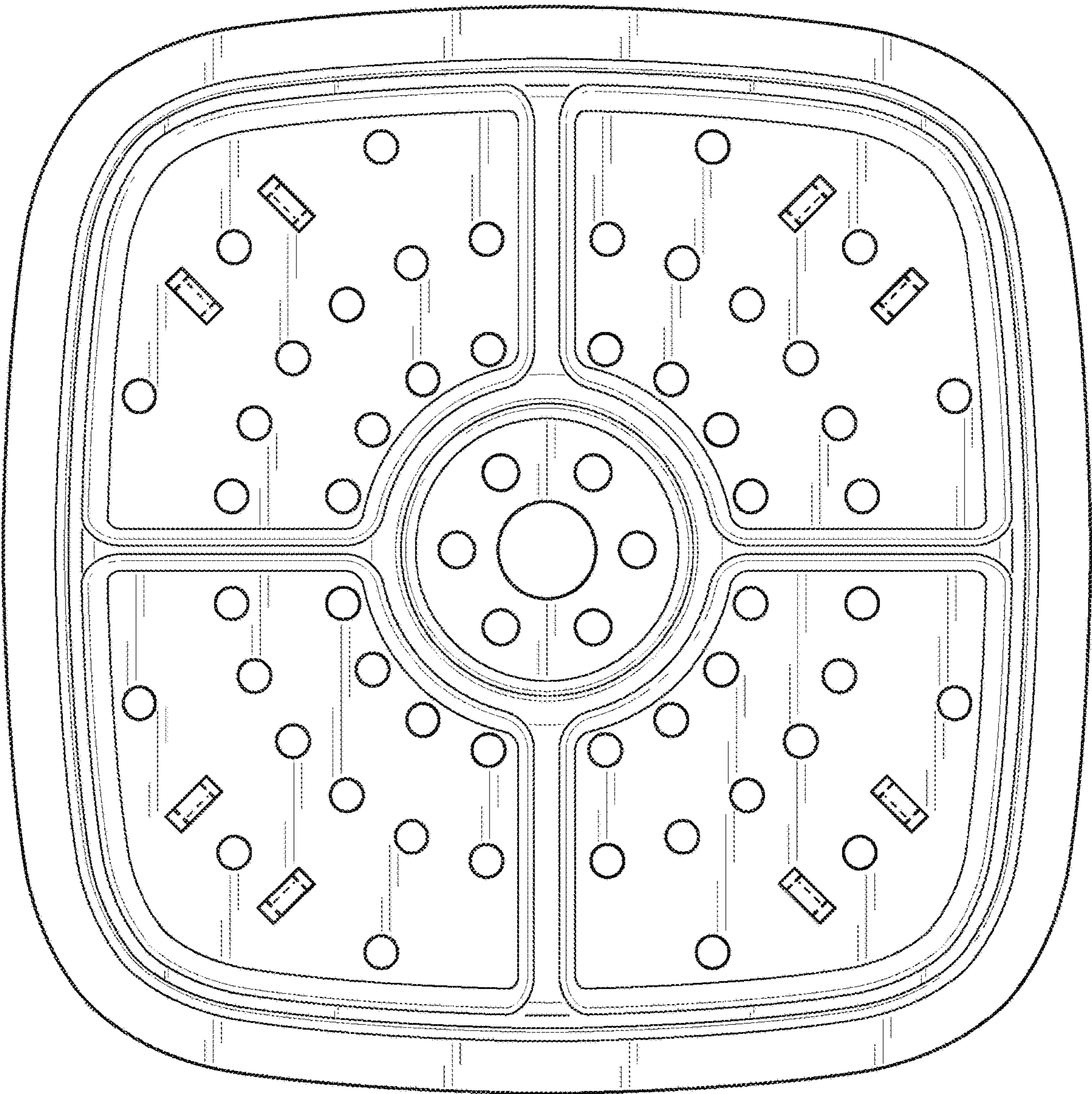

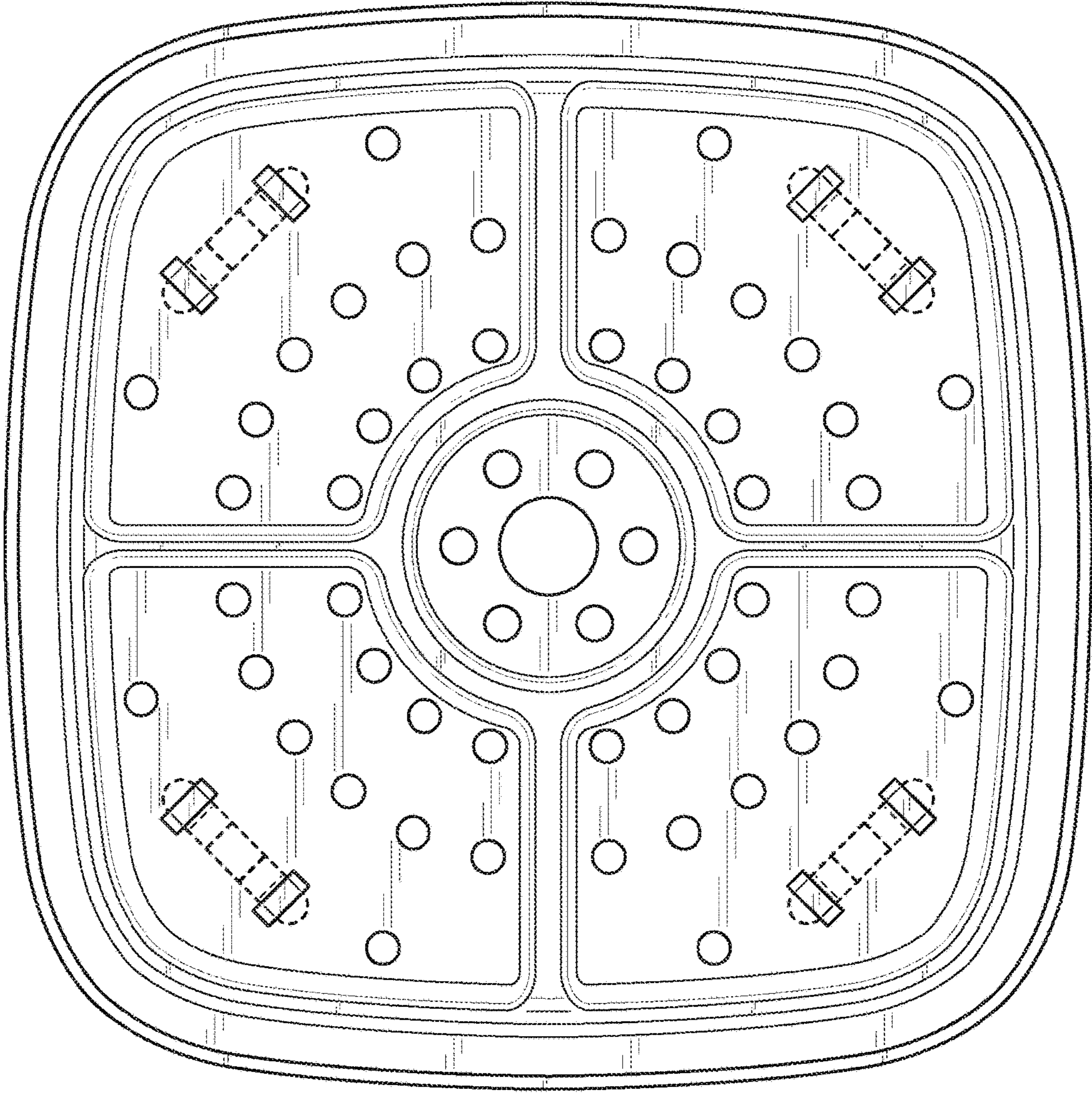

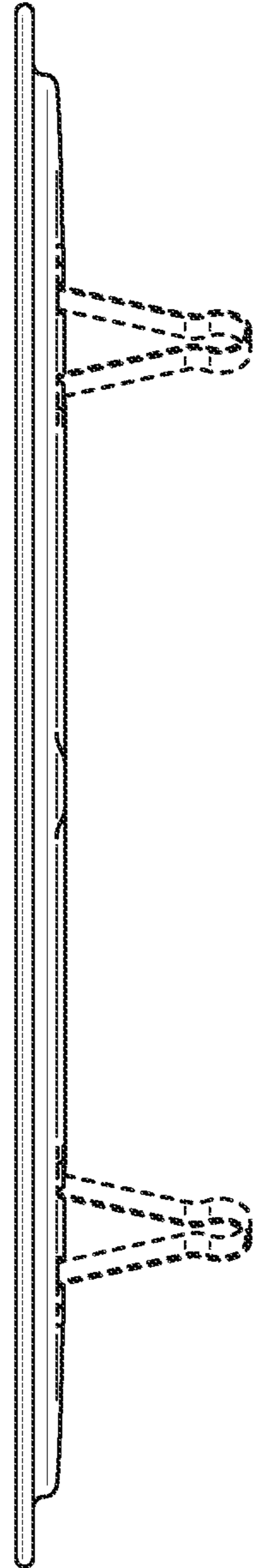

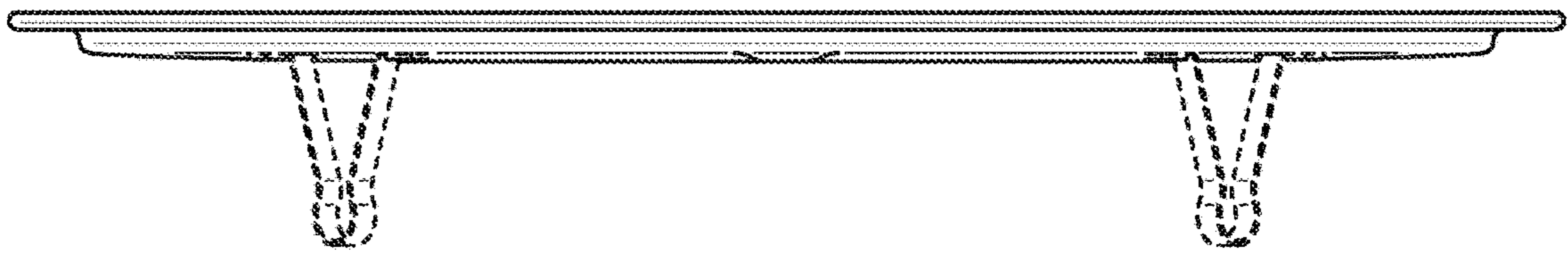
