The ornamental design for beverageware, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a first embodiment of a beverageware showing my new design in use with an exemplary lid;

FIG. 2 is a front view thereof with the exemplary lid removed for ease of illustration; the rear view being a mirror image thereof;

FIG. 3 is a right side view of FIG. 2; the left side view being a mirror image thereof;

FIG. 4 is a top view of FIG. 2;

FIG. 5 is a bottom view thereof;

FIG. 6 is a front perspective view of a second embodiment of a beverageware in use with an exemplary lid;

FIG. 7 is a front view thereof with the exemplary lid removed for ease of illustration; the rear view being a mirror image thereof;

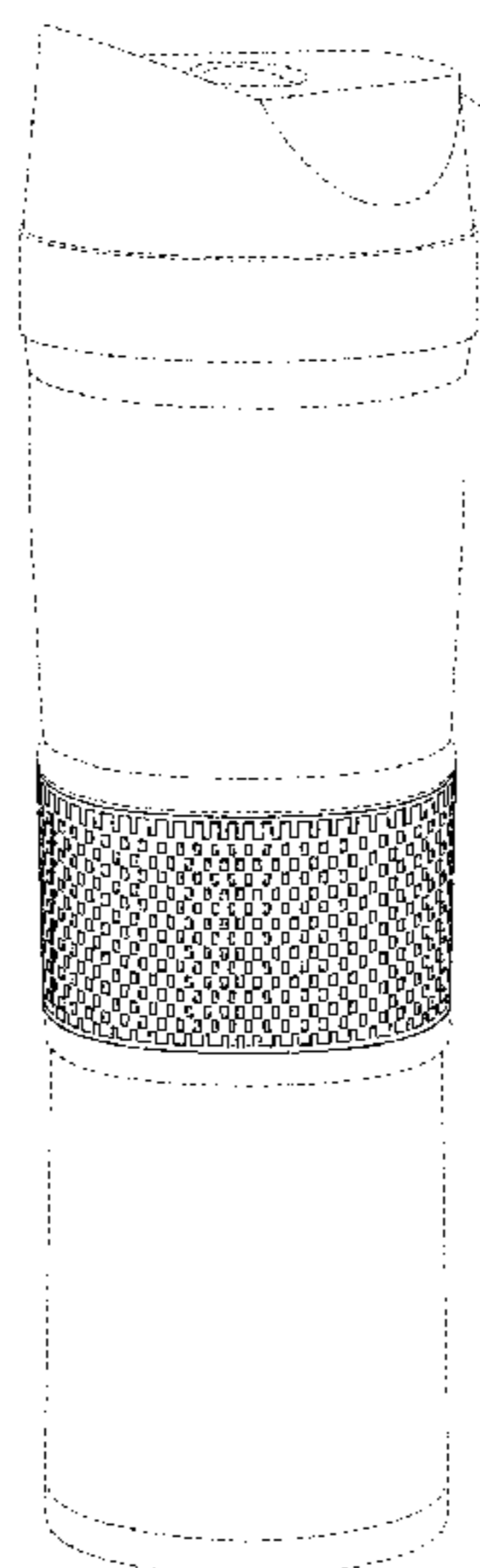
FIG. 8 is a right side view of FIG. 7; the left side view being a mirror image thereof;

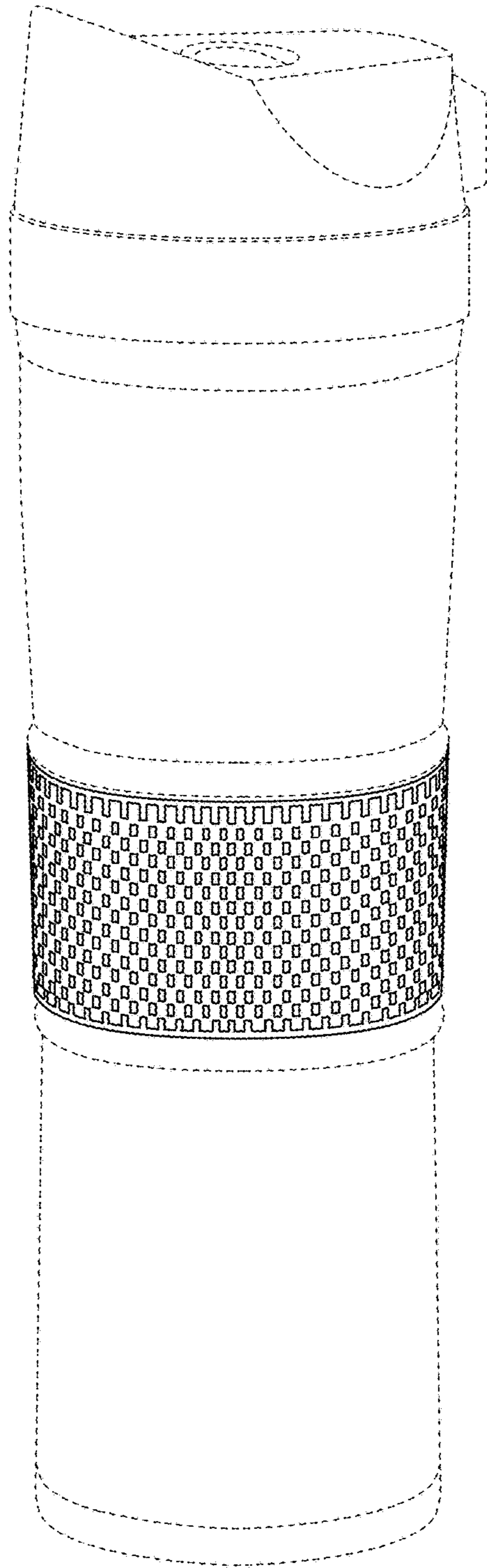

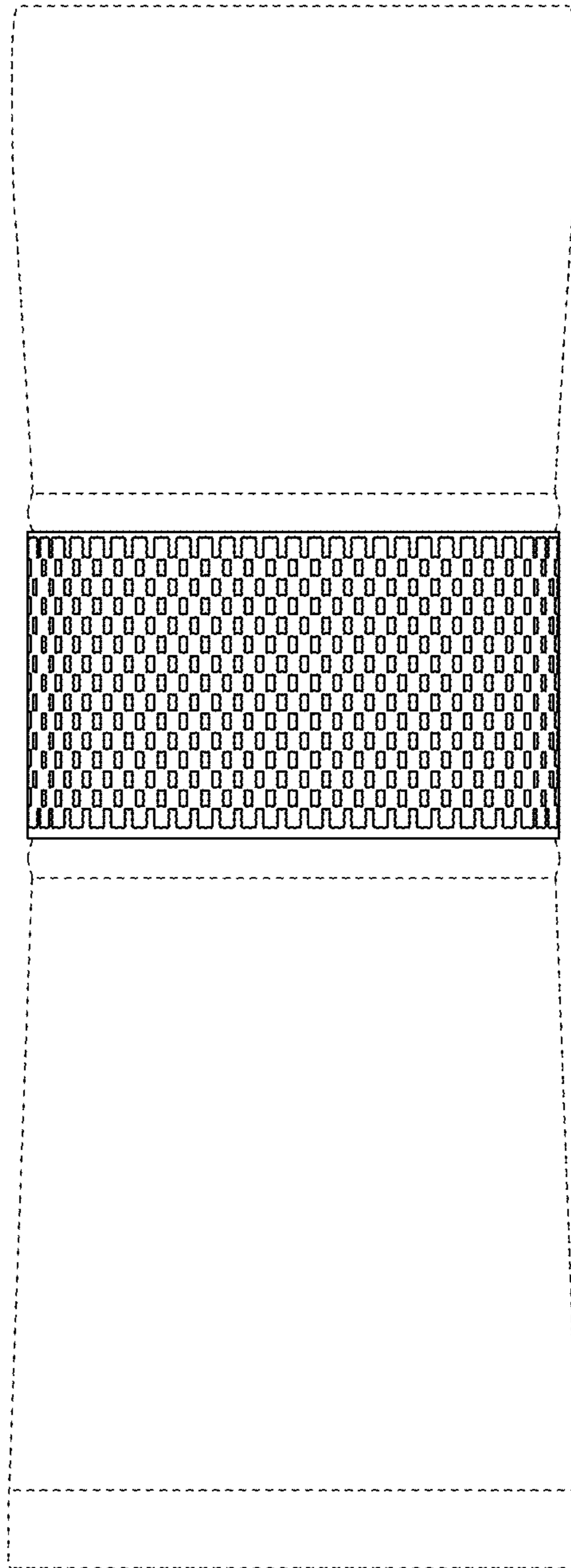

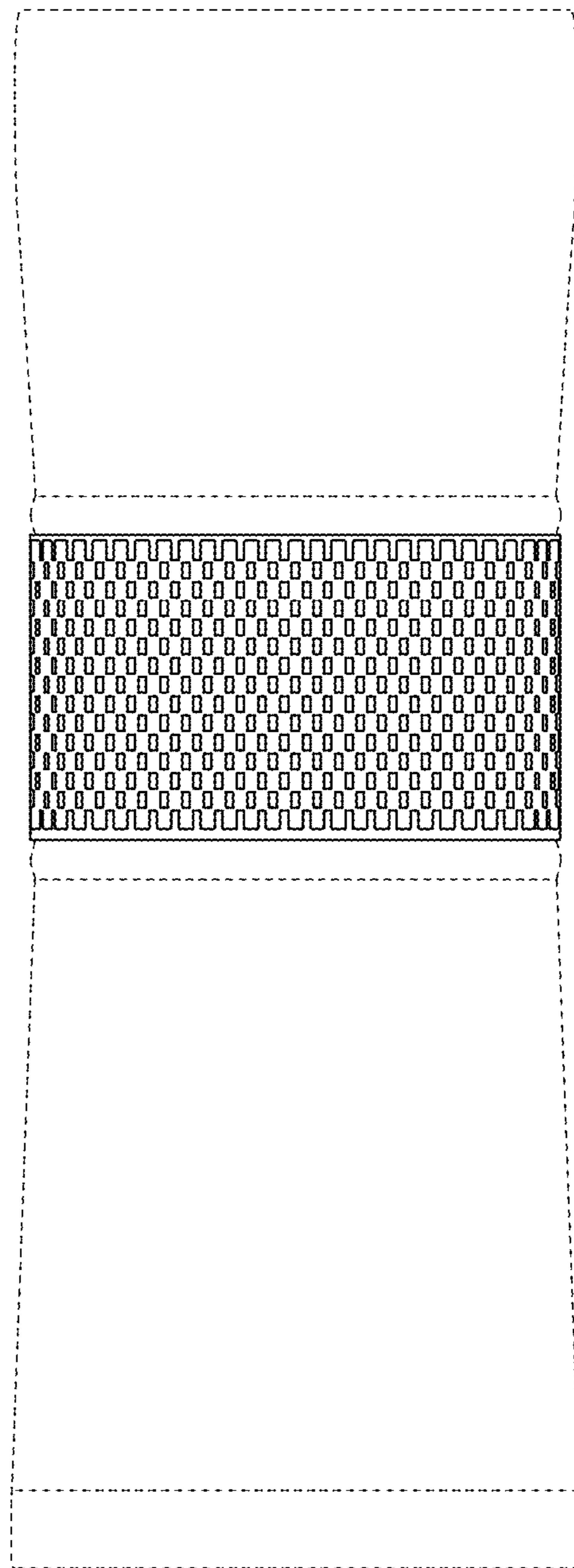

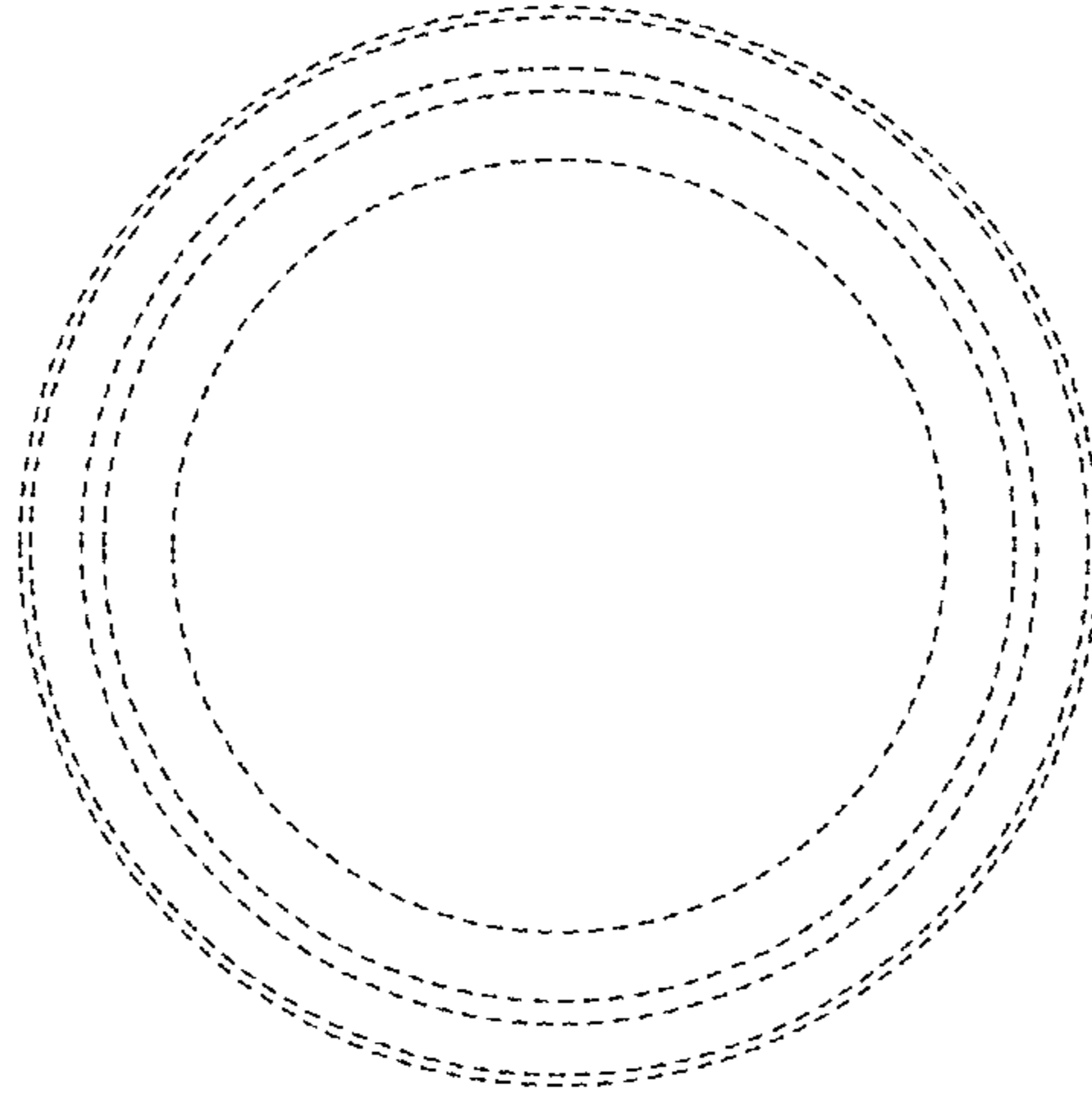

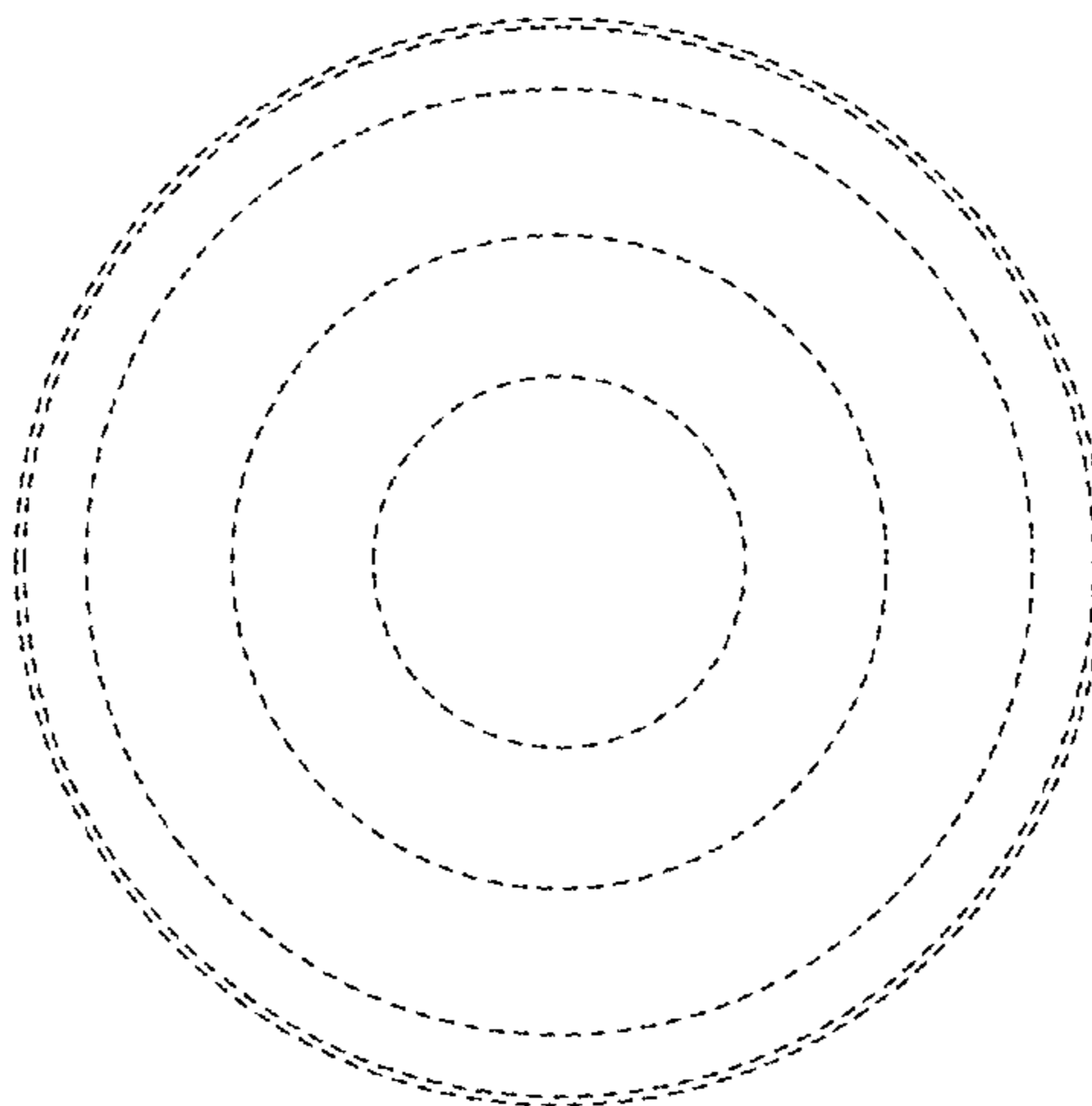

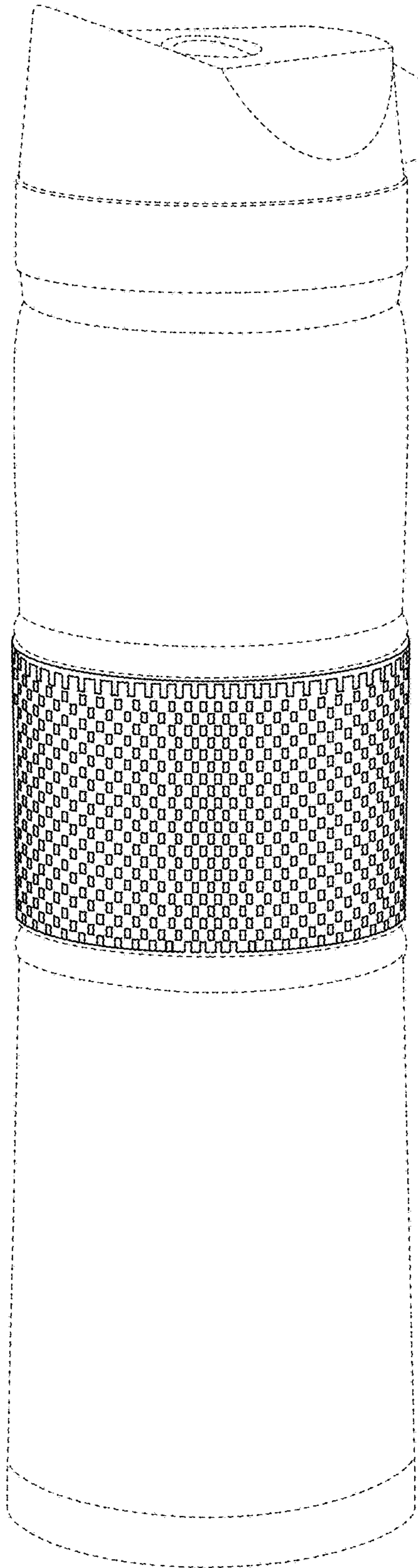

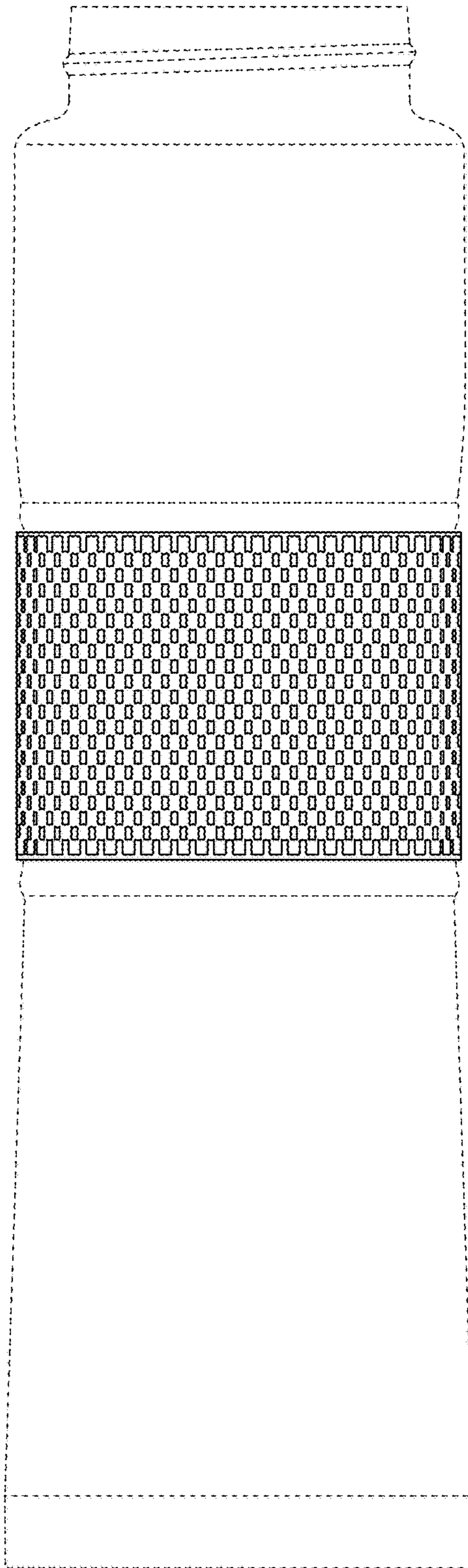

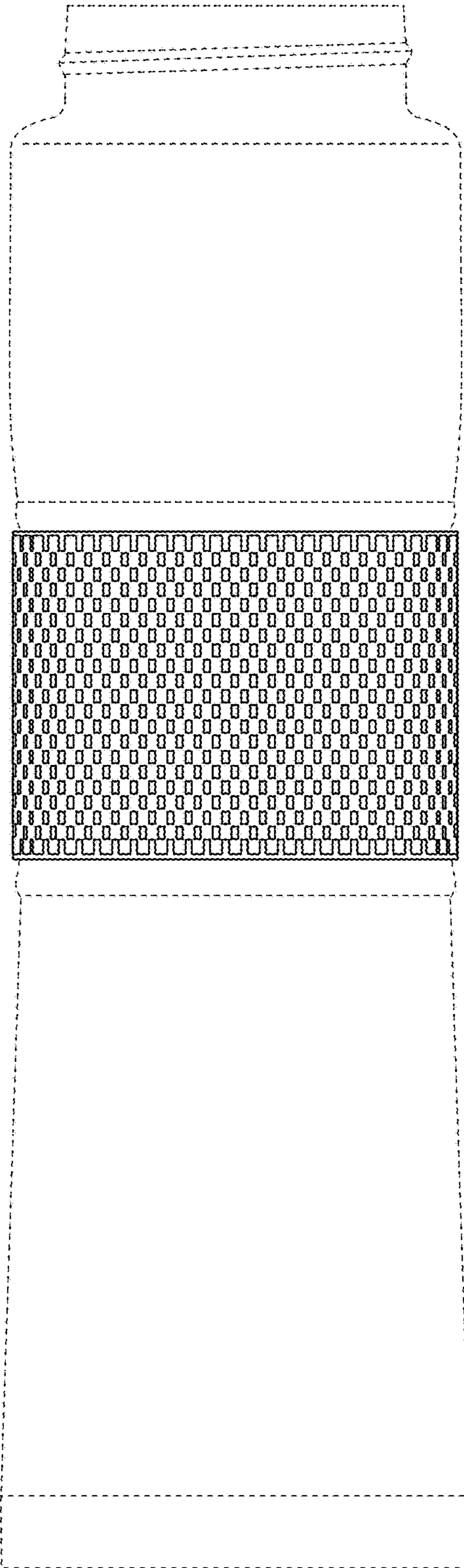

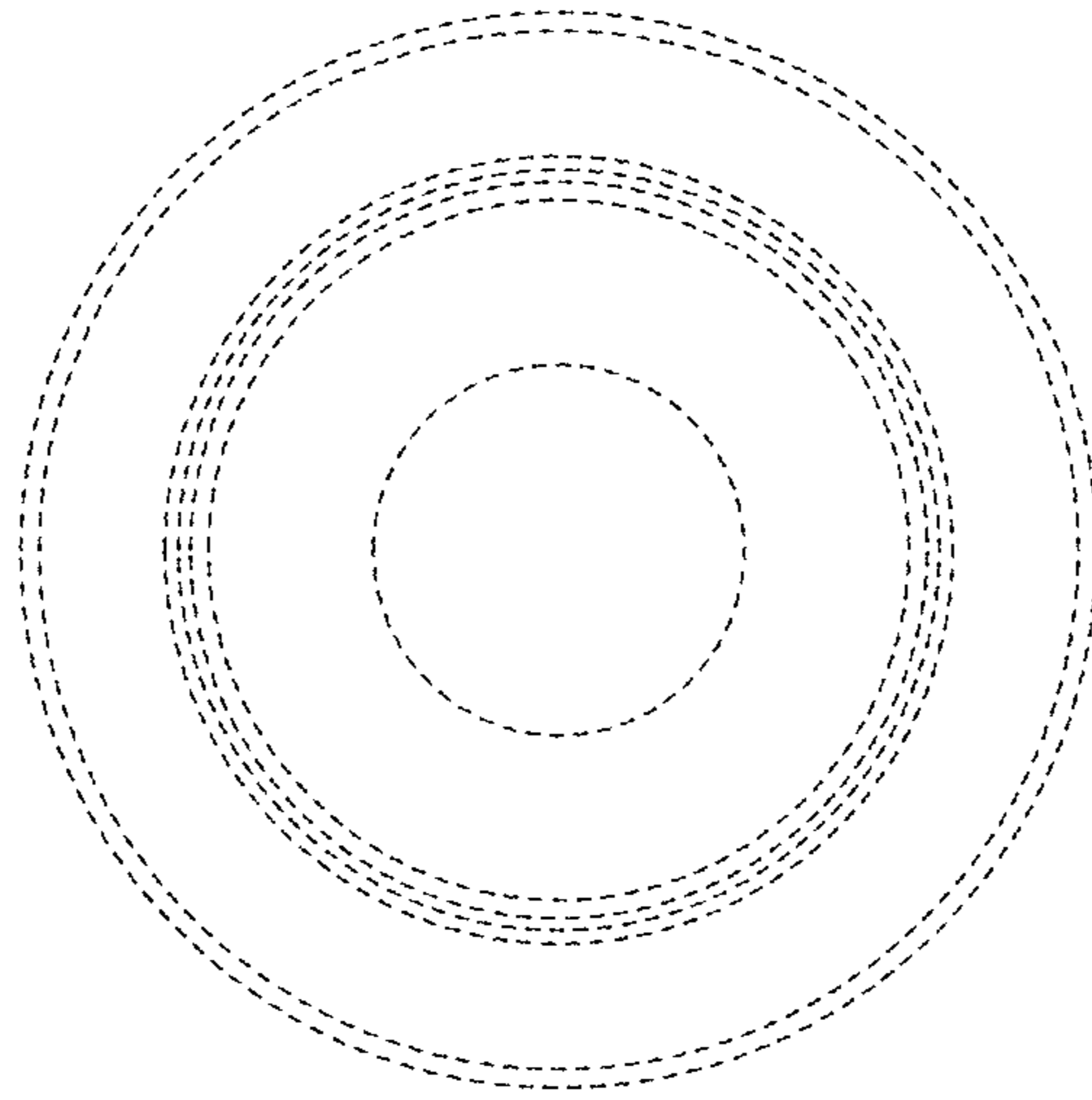

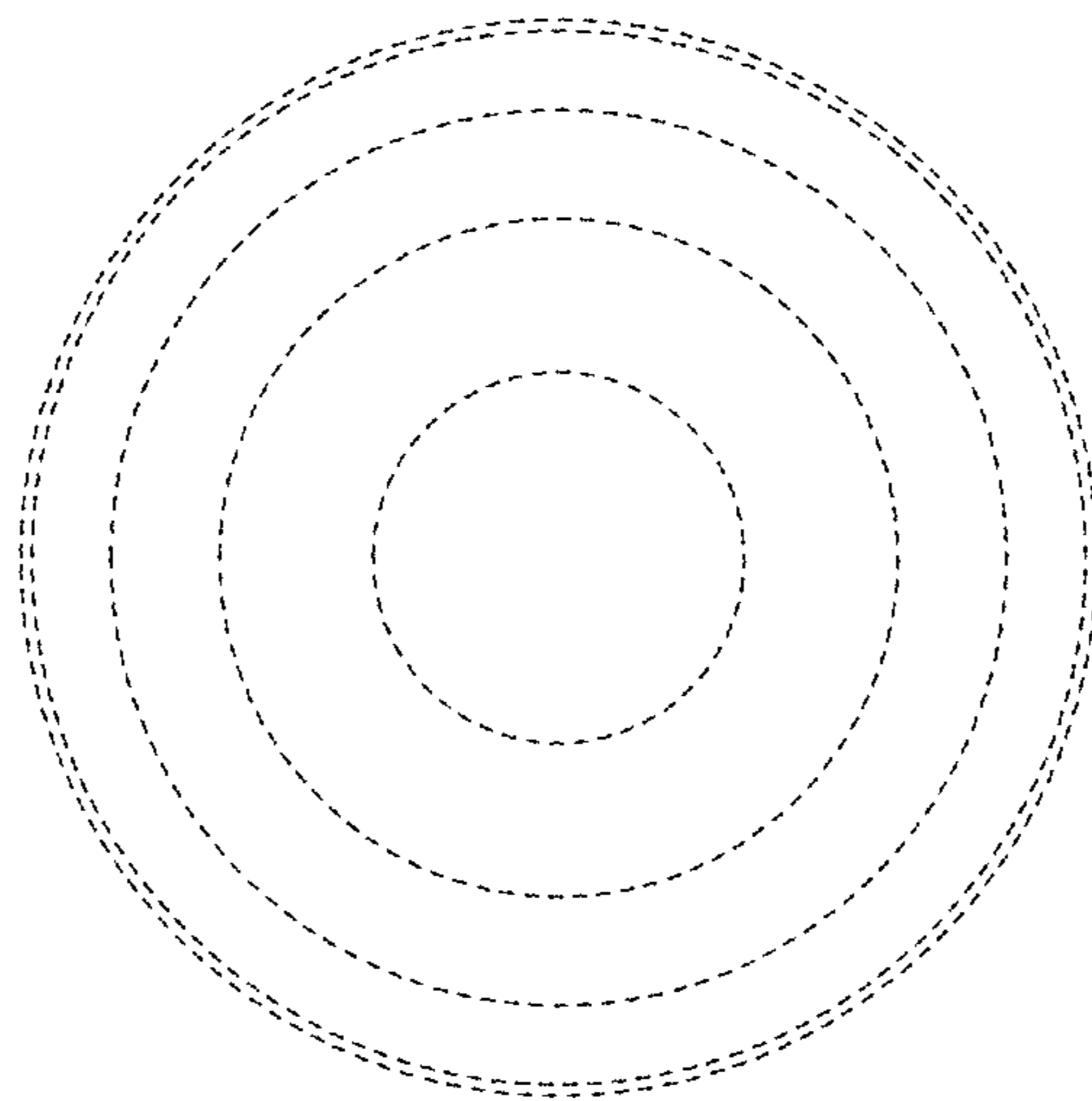
