The ornamental design of a handle for a spoon or other kitchen utensils, as shown and described.

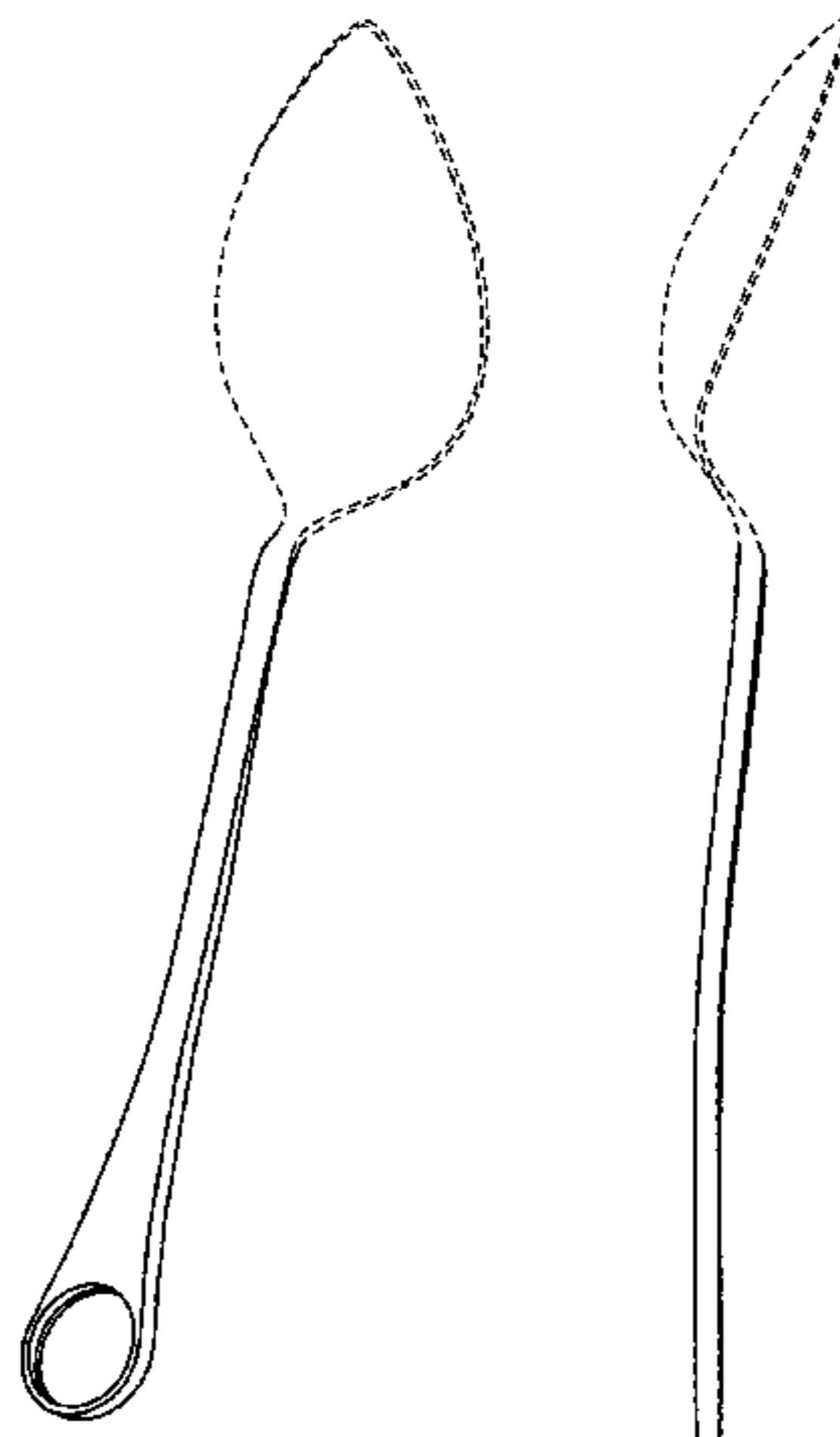
**DESCRIPTION**

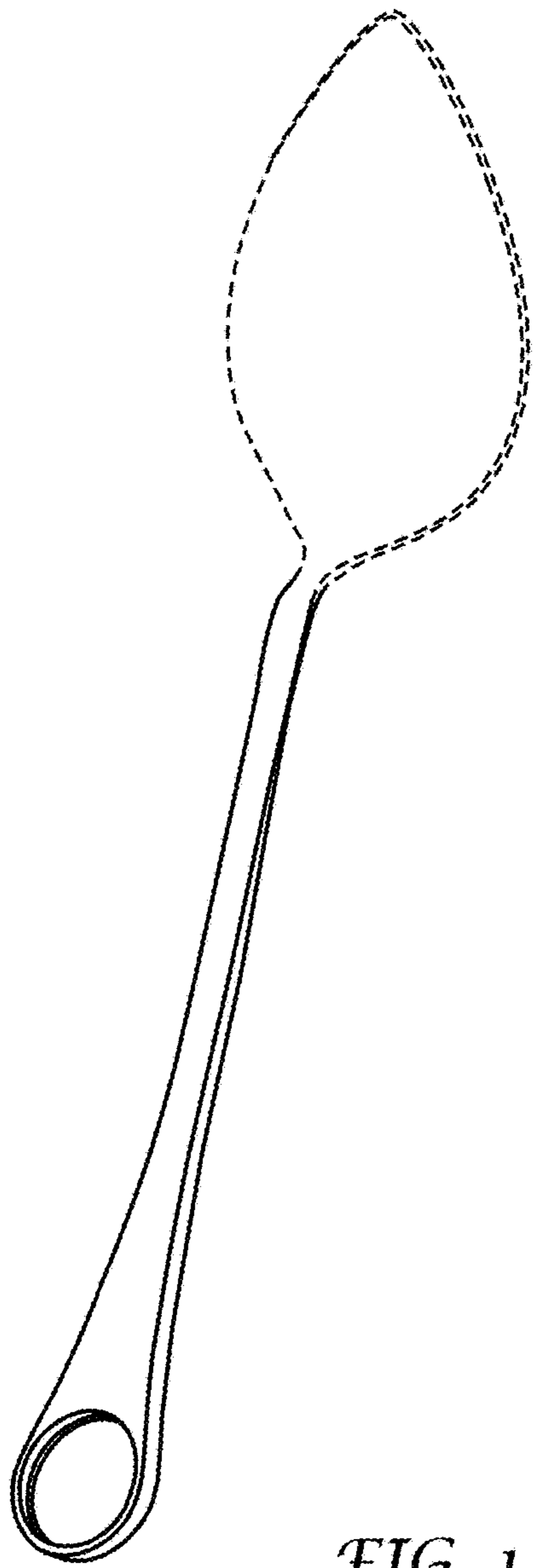
FIG. 1 is a perspective view of a handle for a spoon or other kitchen utensils showing my new design;  
FIG. 2 is a top plan view thereof;  
FIG. 3 is a left side elevation view thereof, the right side being a mirror image;  
FIG. 4 is a bottom plan view thereof; and,  
FIG. 5 is a perspective view of the handle shown with inset artwork.

My design of a handle for a spoon or other kitchen utensils includes a recess intended for inserting artwork.

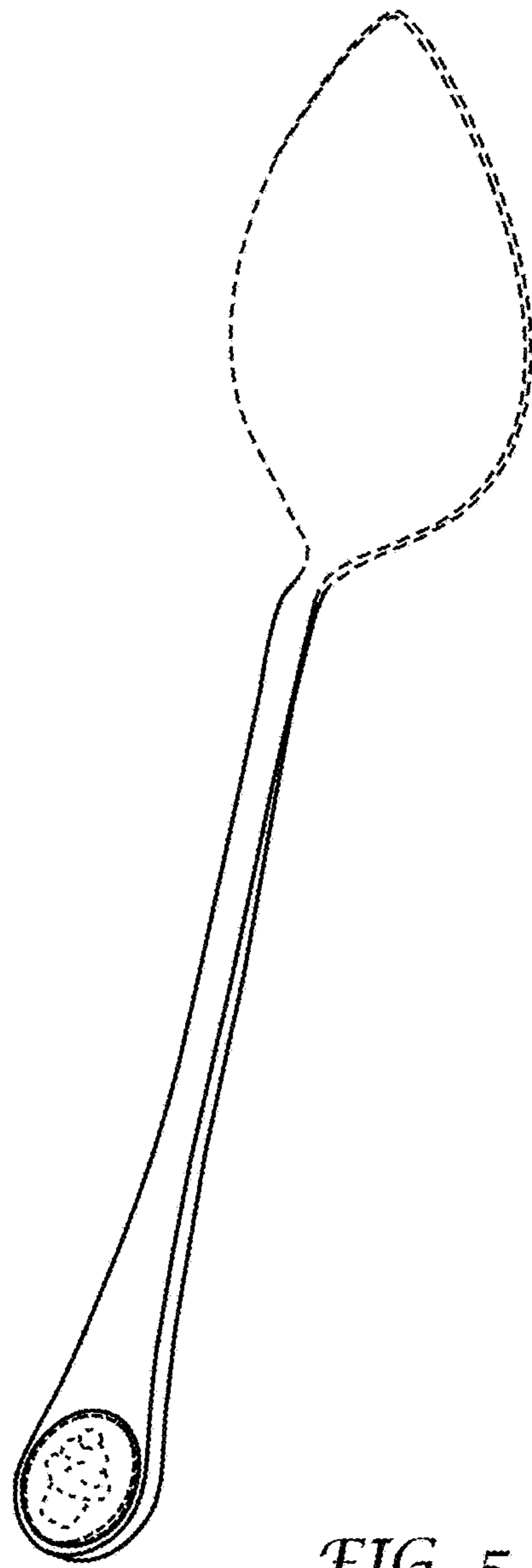
Elements shown in broken lines form no part of the claimed design.

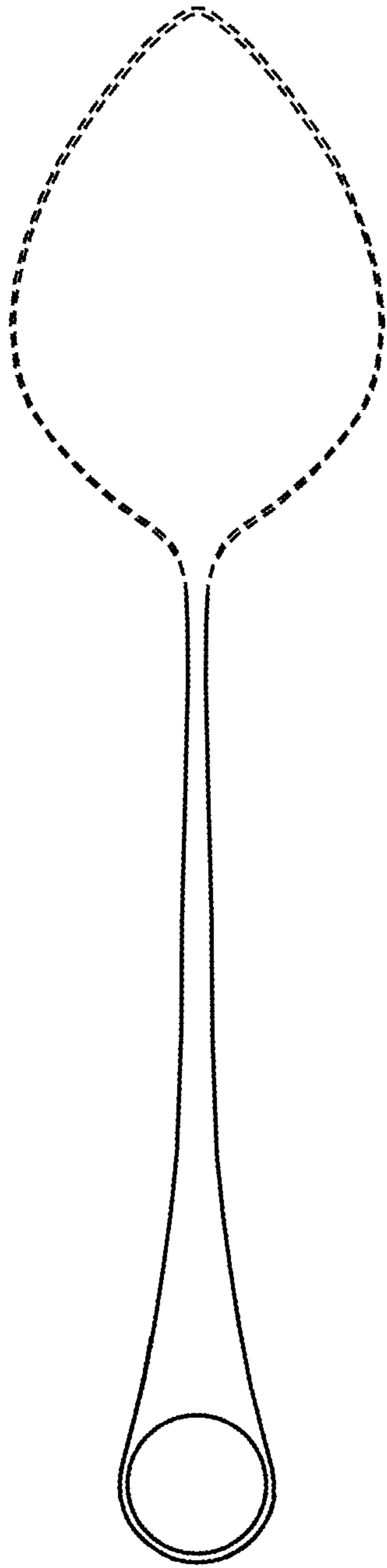




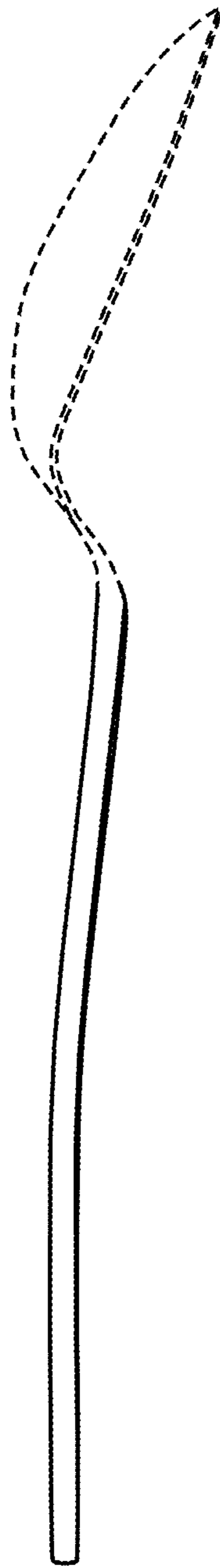

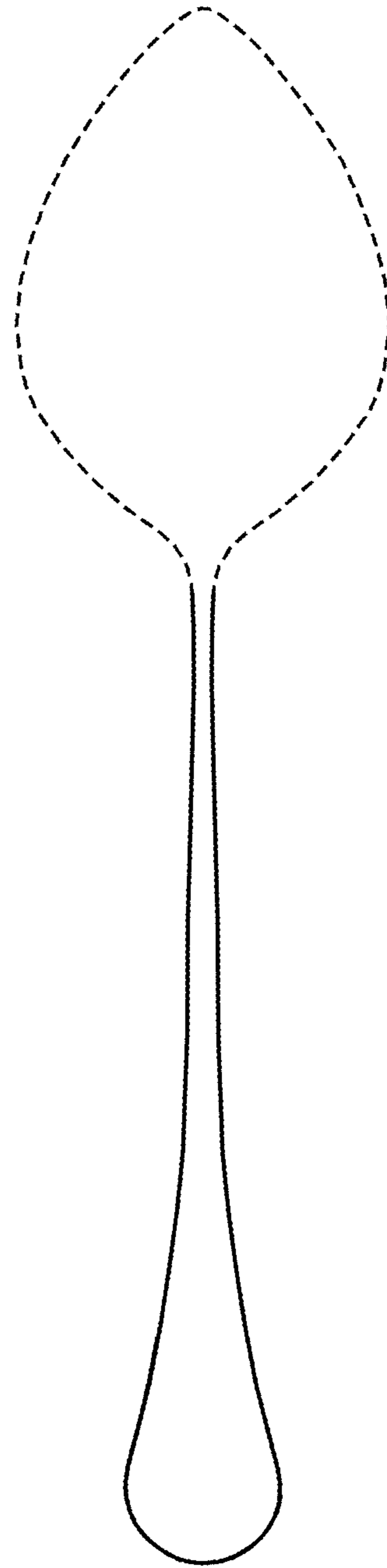
