FIG. 4 is a rear elevation view of the first embodiment of the breaching tool.

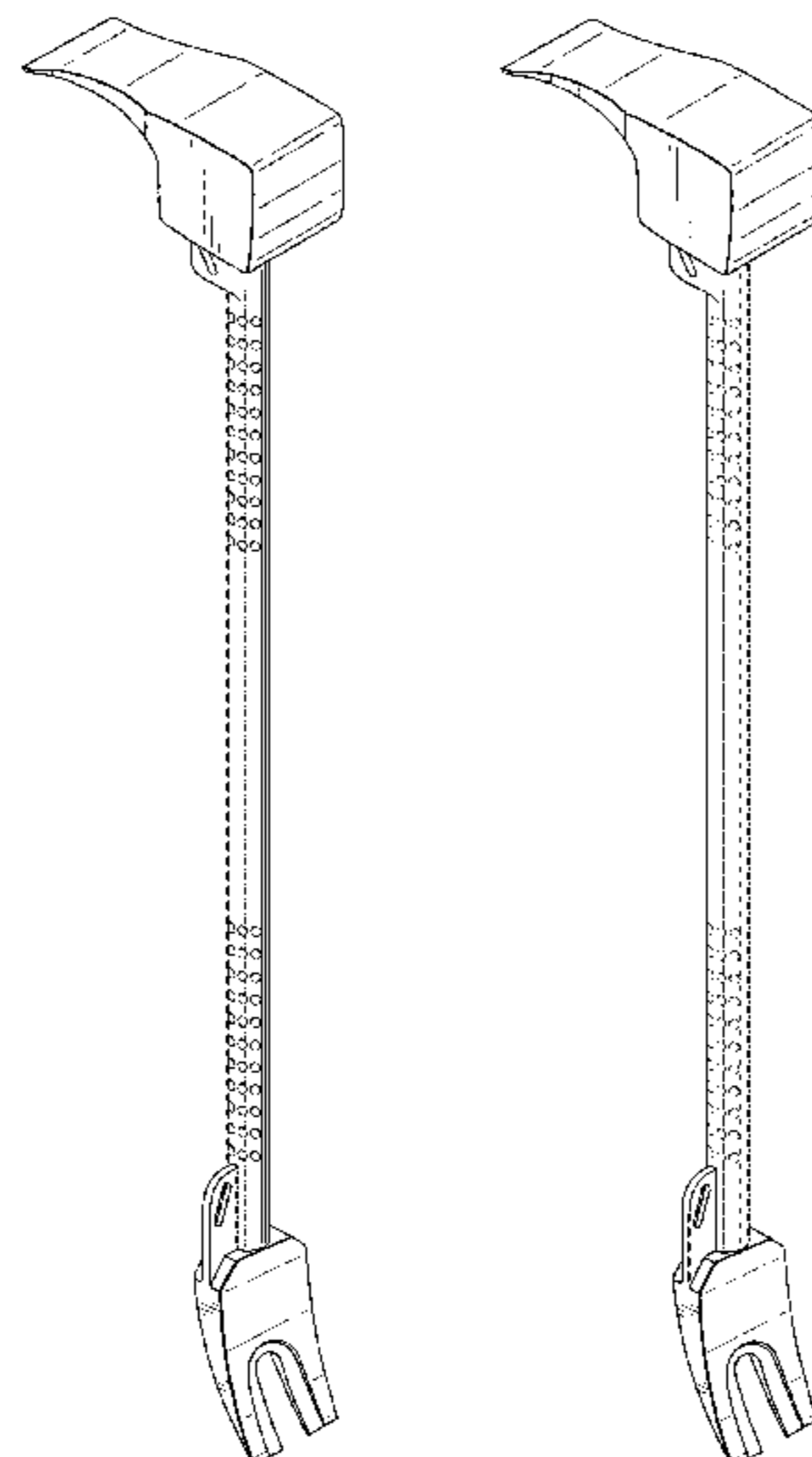
FIG. 5 is a second side elevation view, on the opposite of the first side, of the first embodiment of the breaching tool.

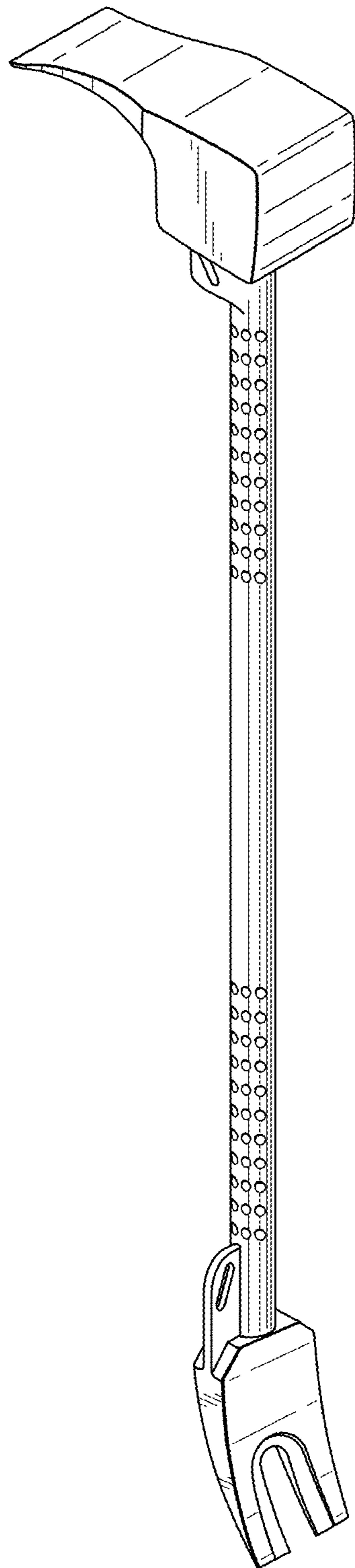

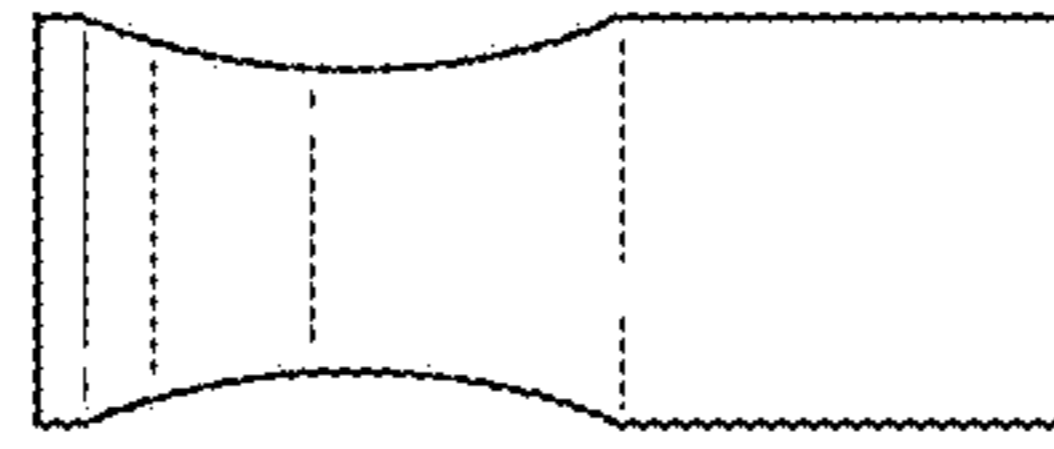

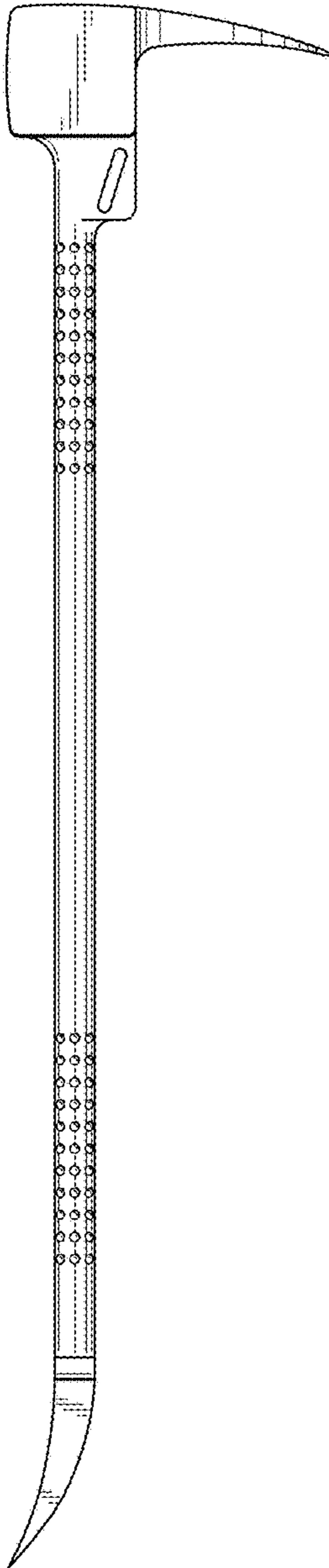

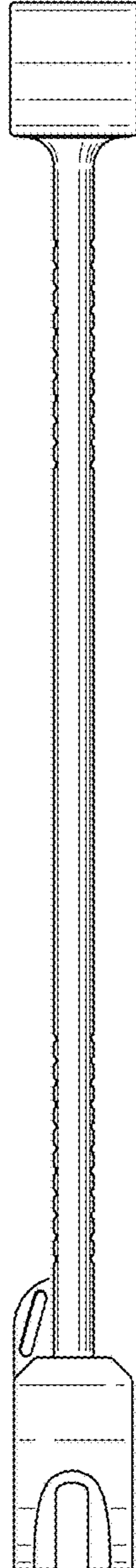

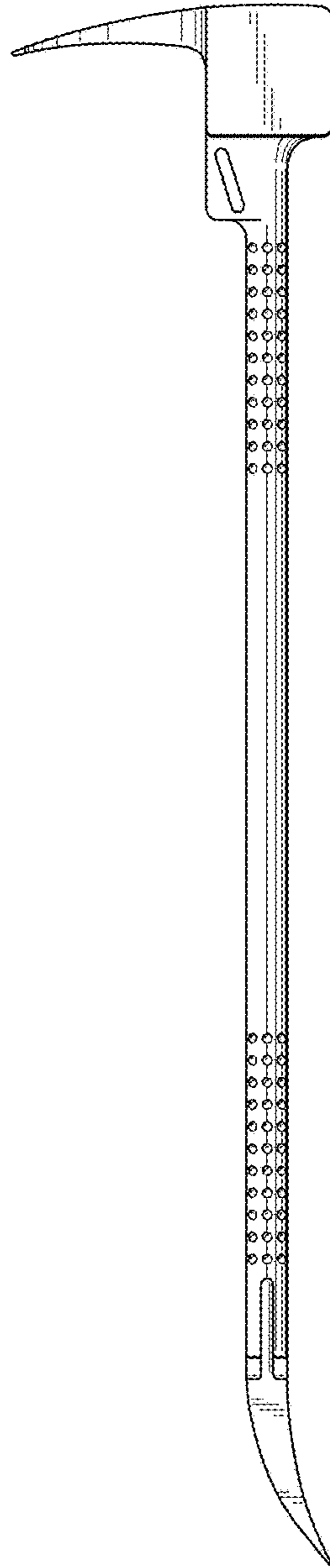

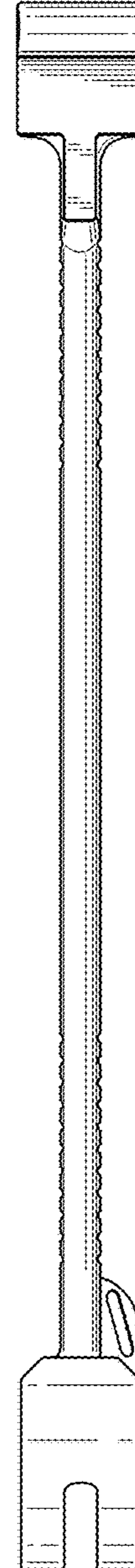
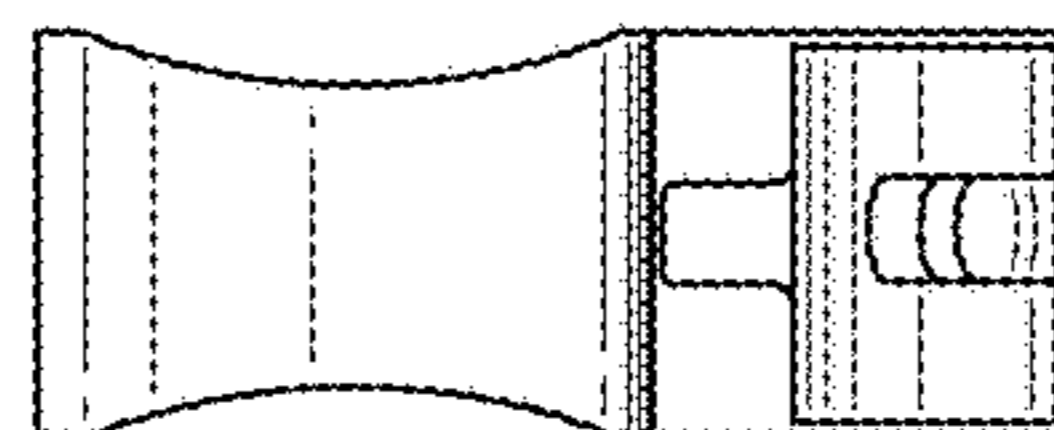
