(57) **CLAIM**

The ornamental design for a shelf bracket, as shown and described.

**DESCRIPTION**

**1. Shelf Bracket**

**1.1** is a front perspective view of a shelf bracket showing my new design;

**1.2** is a left side perspective view thereof;

**1.3** is rear perspective view thereof;

**1.4** is a front perspective view thereof, wherein the bracket is shown installed longitudinally on the top surface of an environmental board;

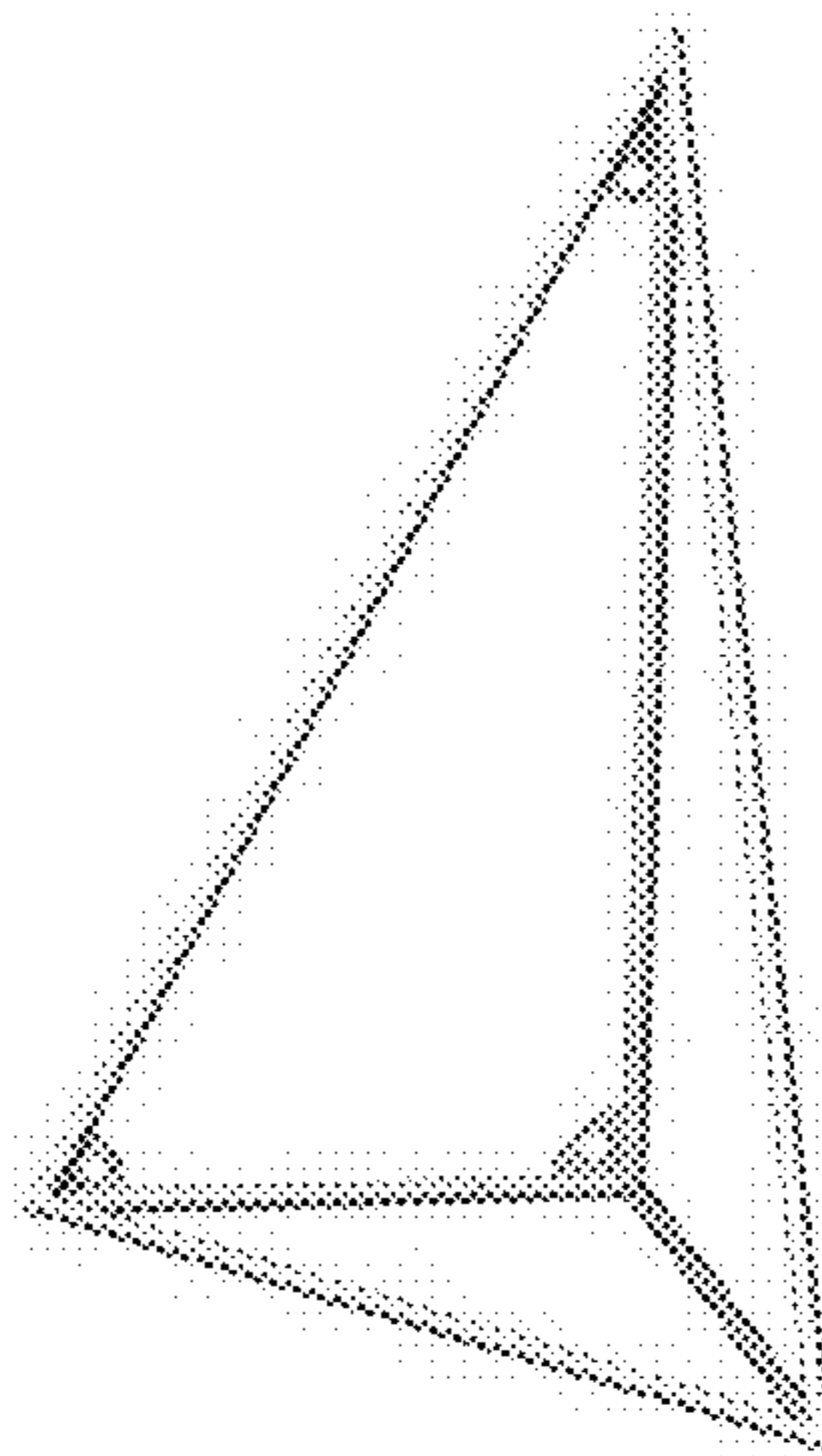
**1.5** is a front perspective view thereof, wherein the bracket is shown installed vertically on the top surface of an environmental board;

**1.6** is a rear perspective view thereof, wherein the bracket is shown installed vertically beneath an environmental board; and

**1.7** is a rear perspective view thereof, wherein the bracket is shown installed longitudinally beneath an environmental board.

The broken lines showing a second bracket and horizontal board is provided for the purpose of illustrating environmental structure and form no part of the claimed design.

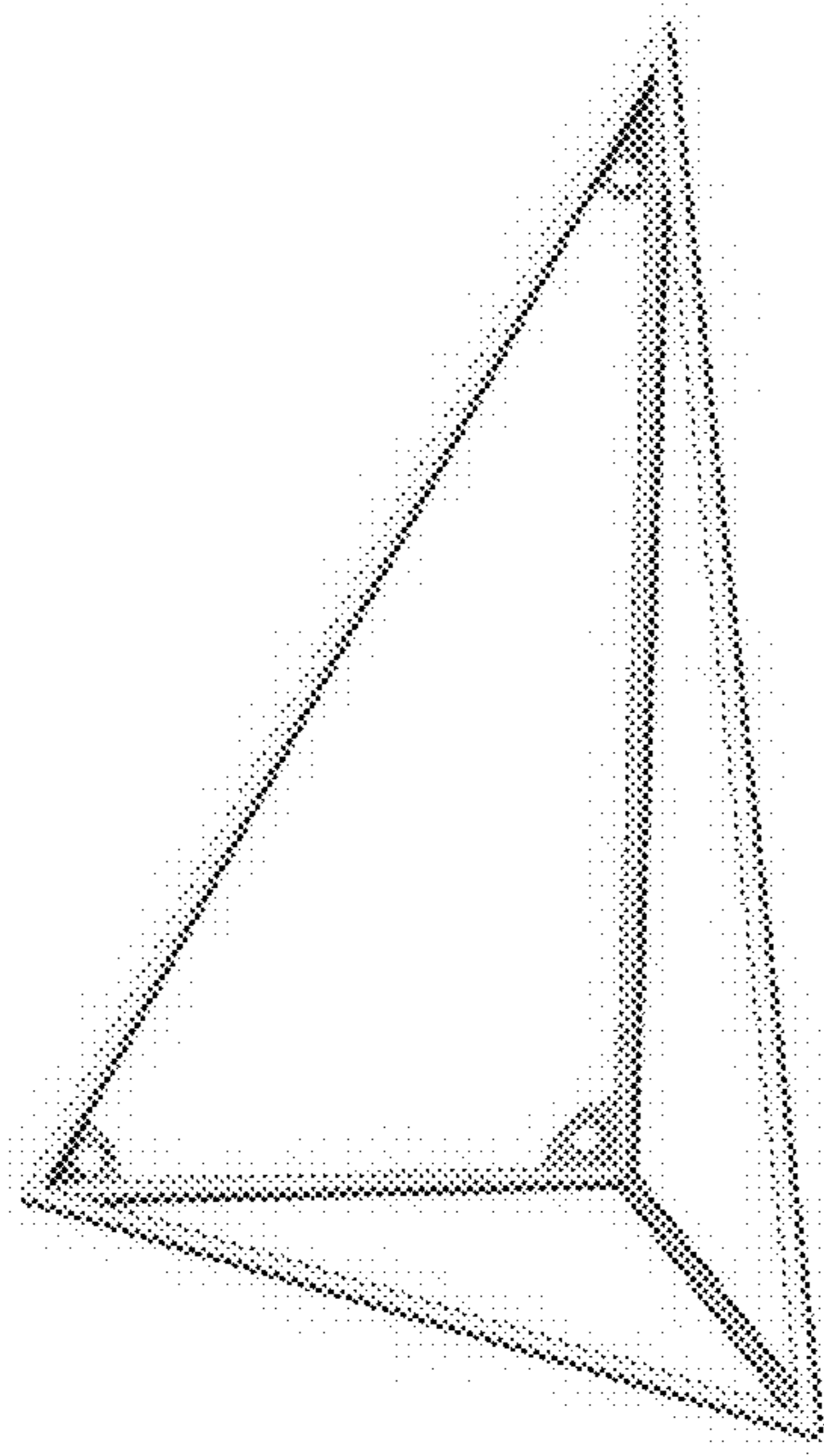

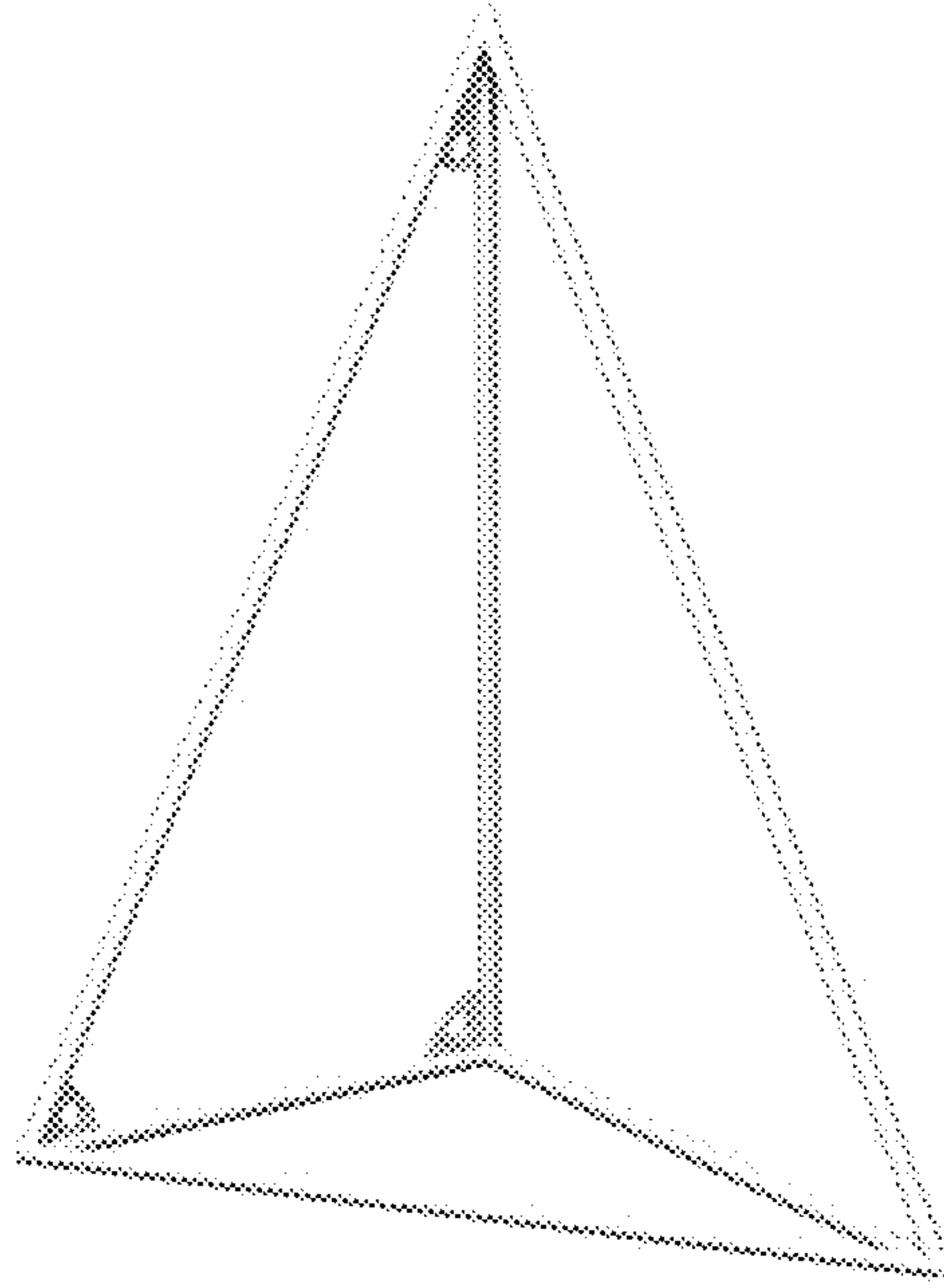

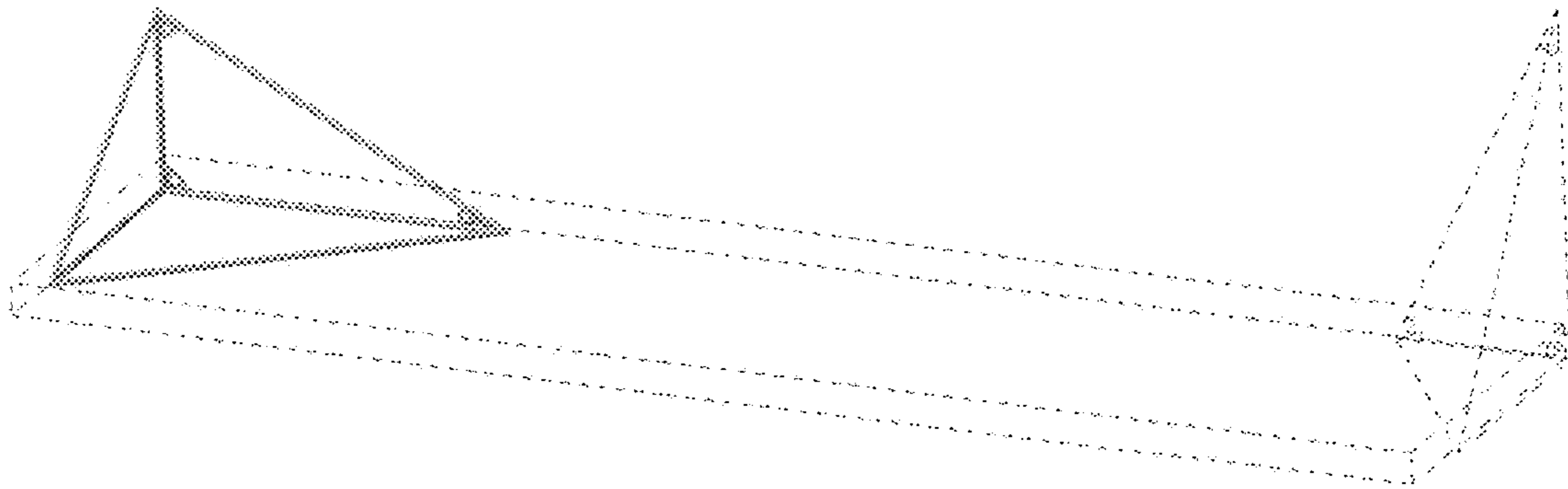

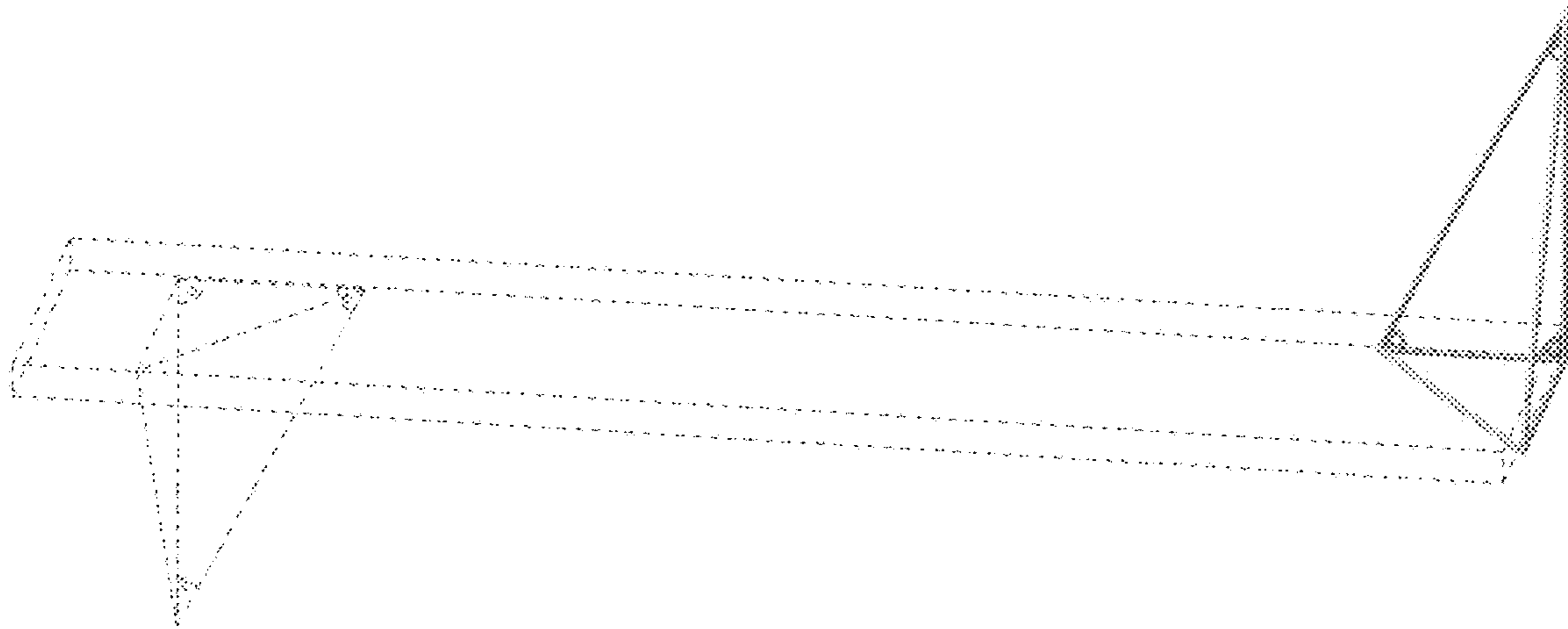

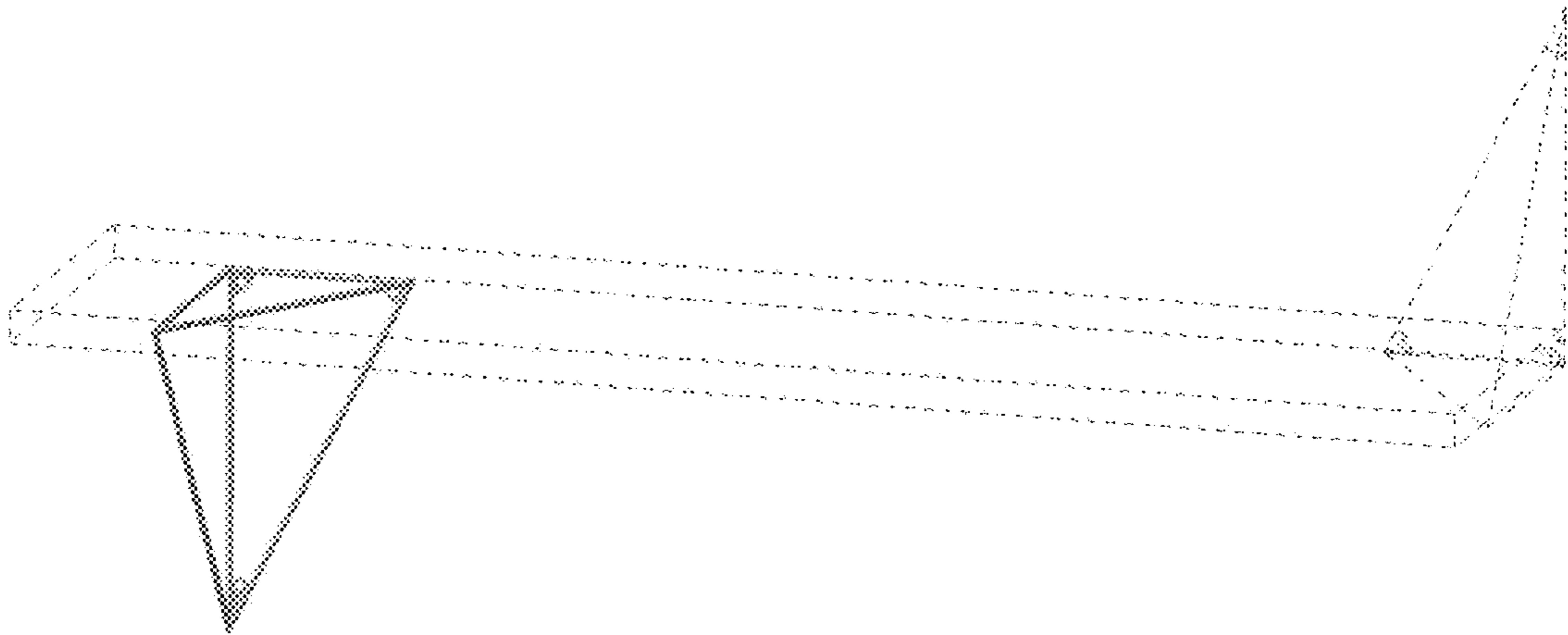
