**DESCRIPTION**

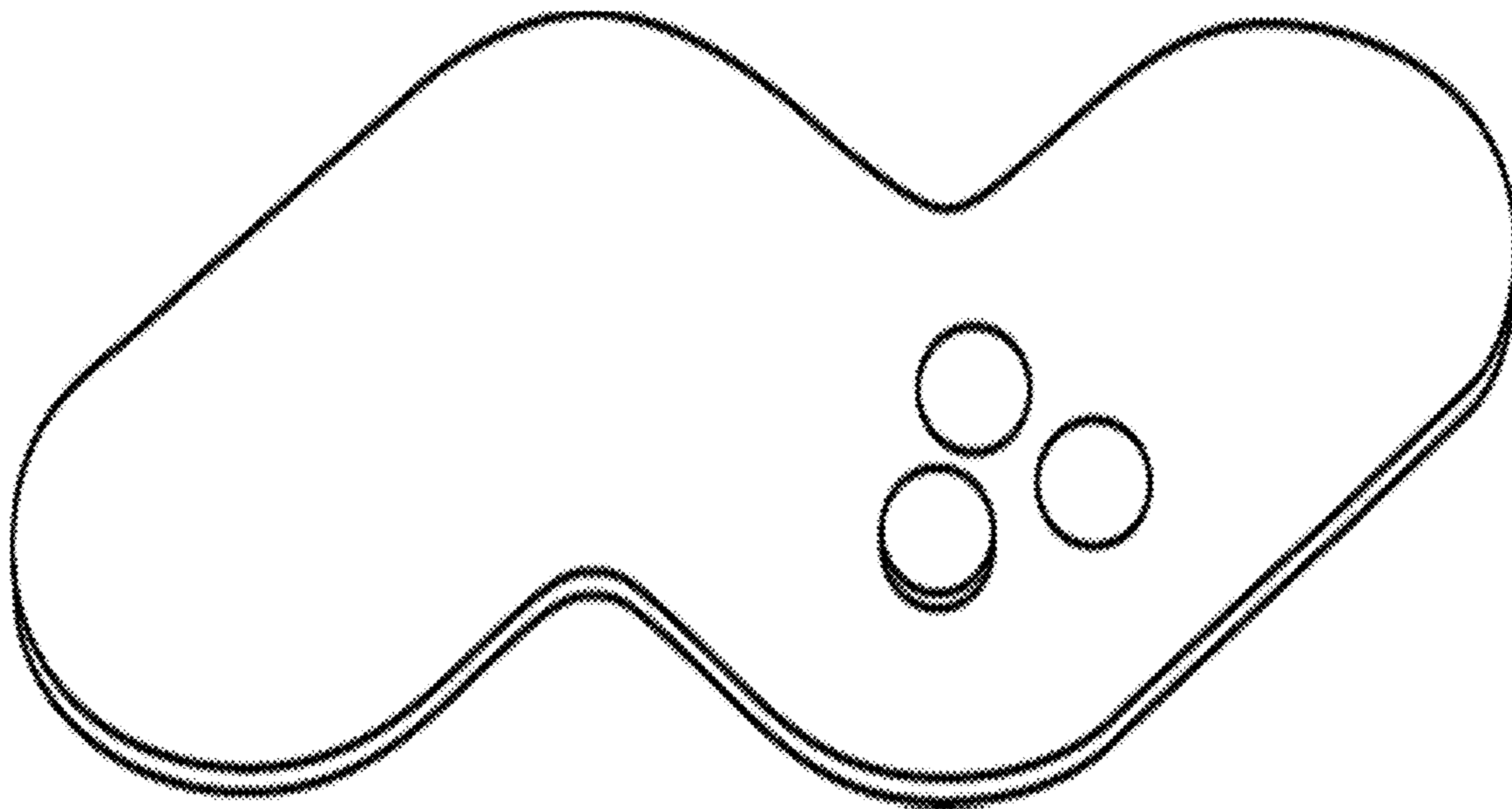
FIG. 1 is the bottom perspective view of the wearable thermometer having three electric pads showing my new design;

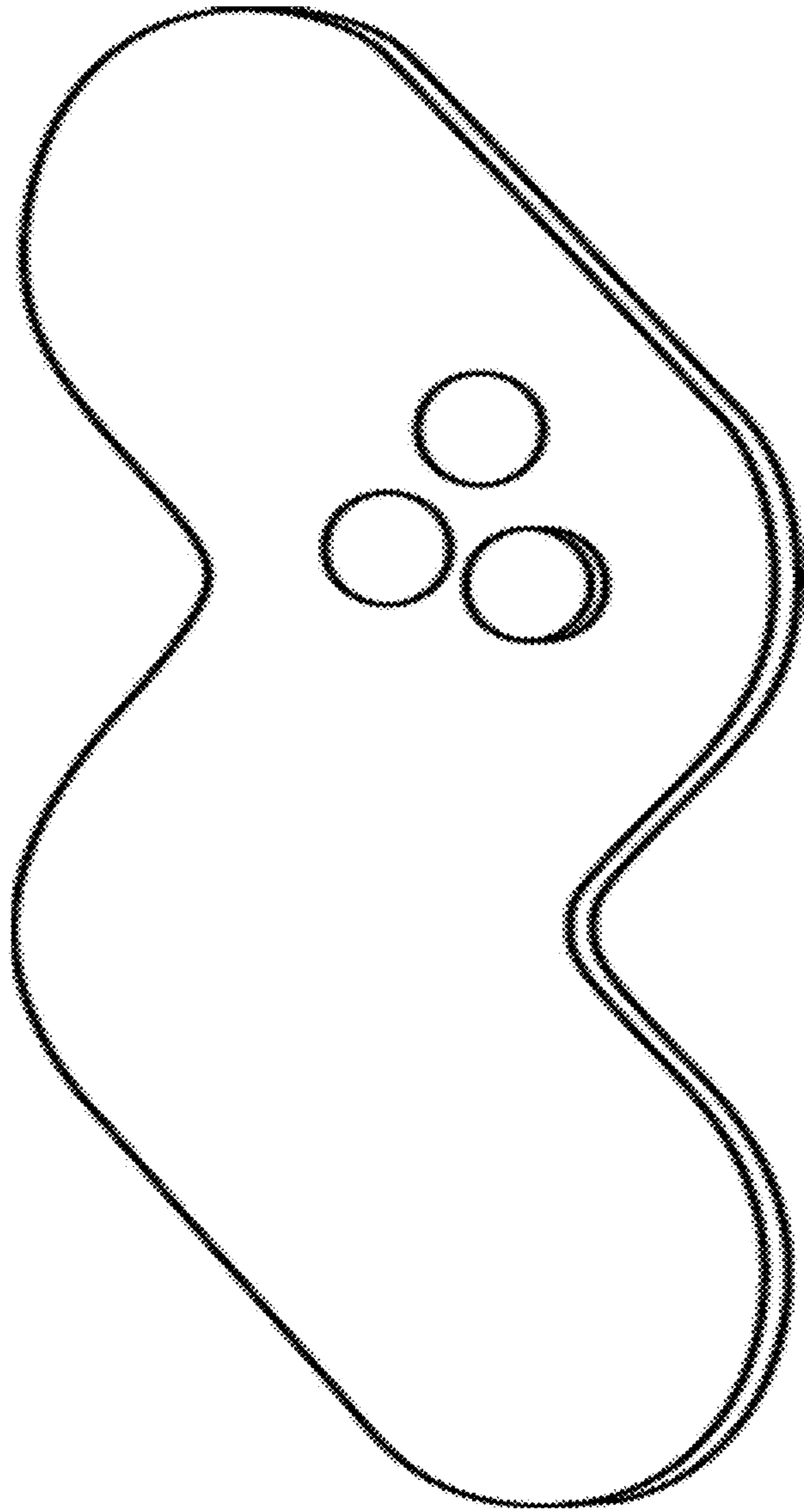

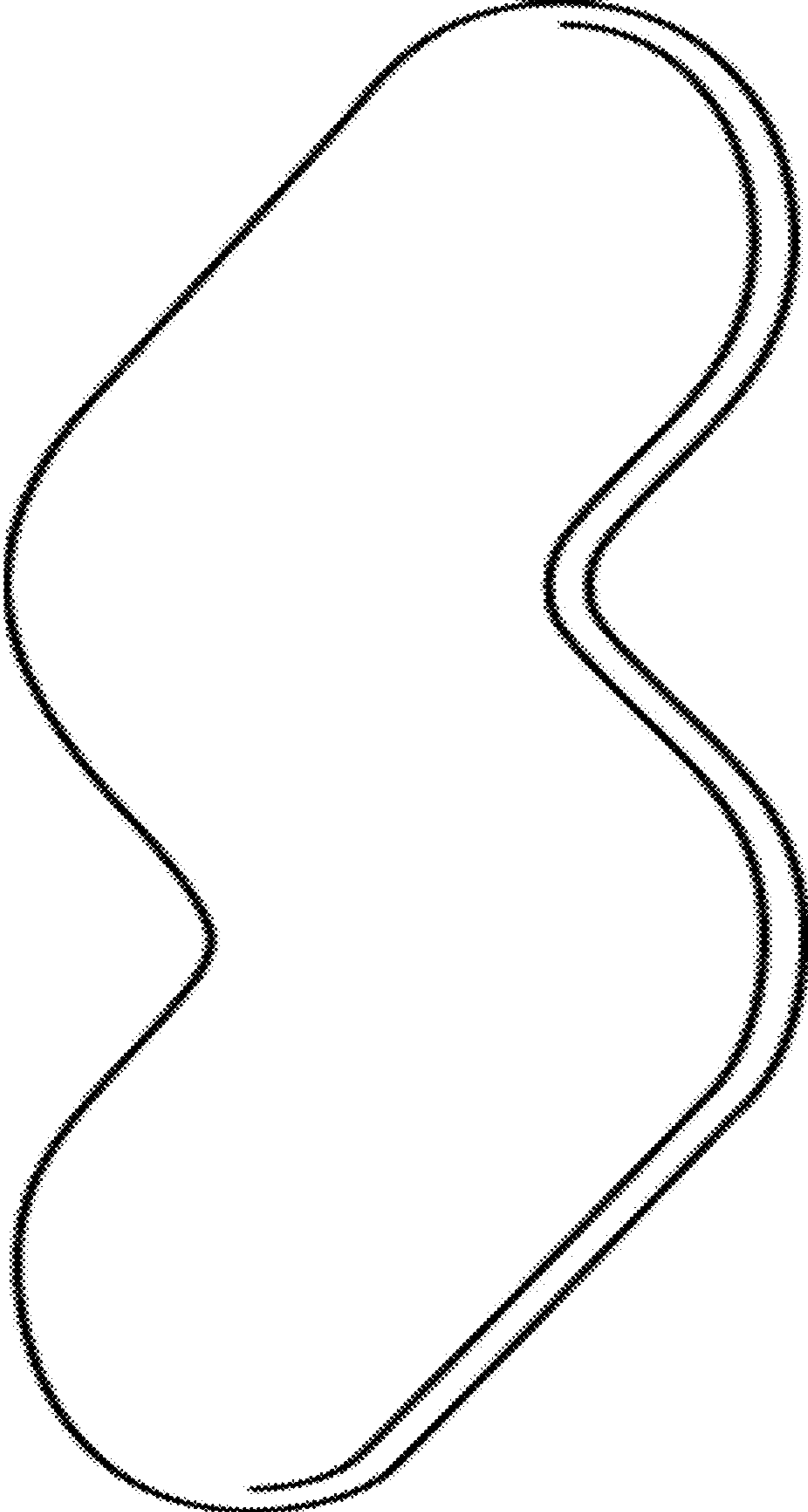

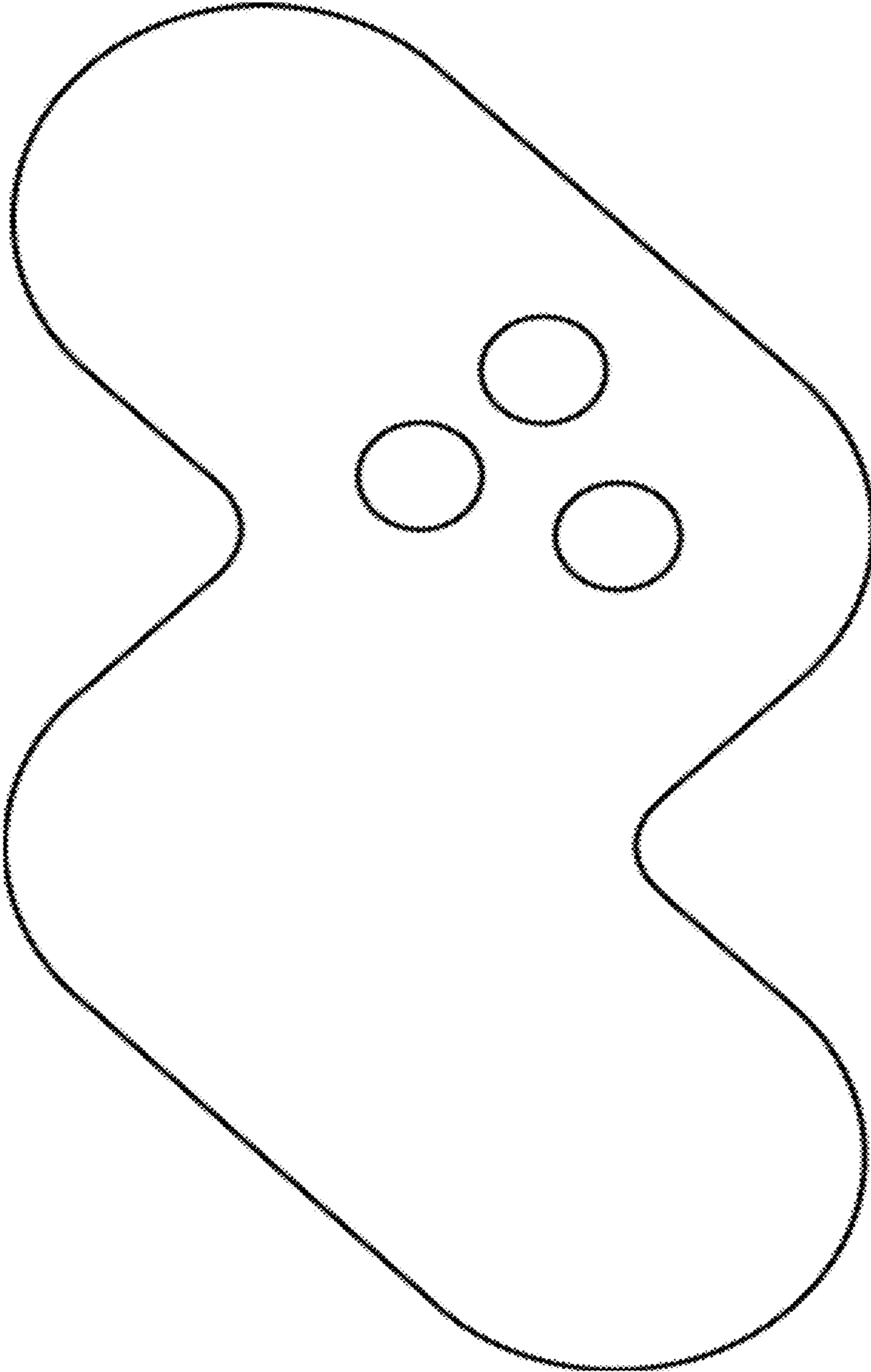

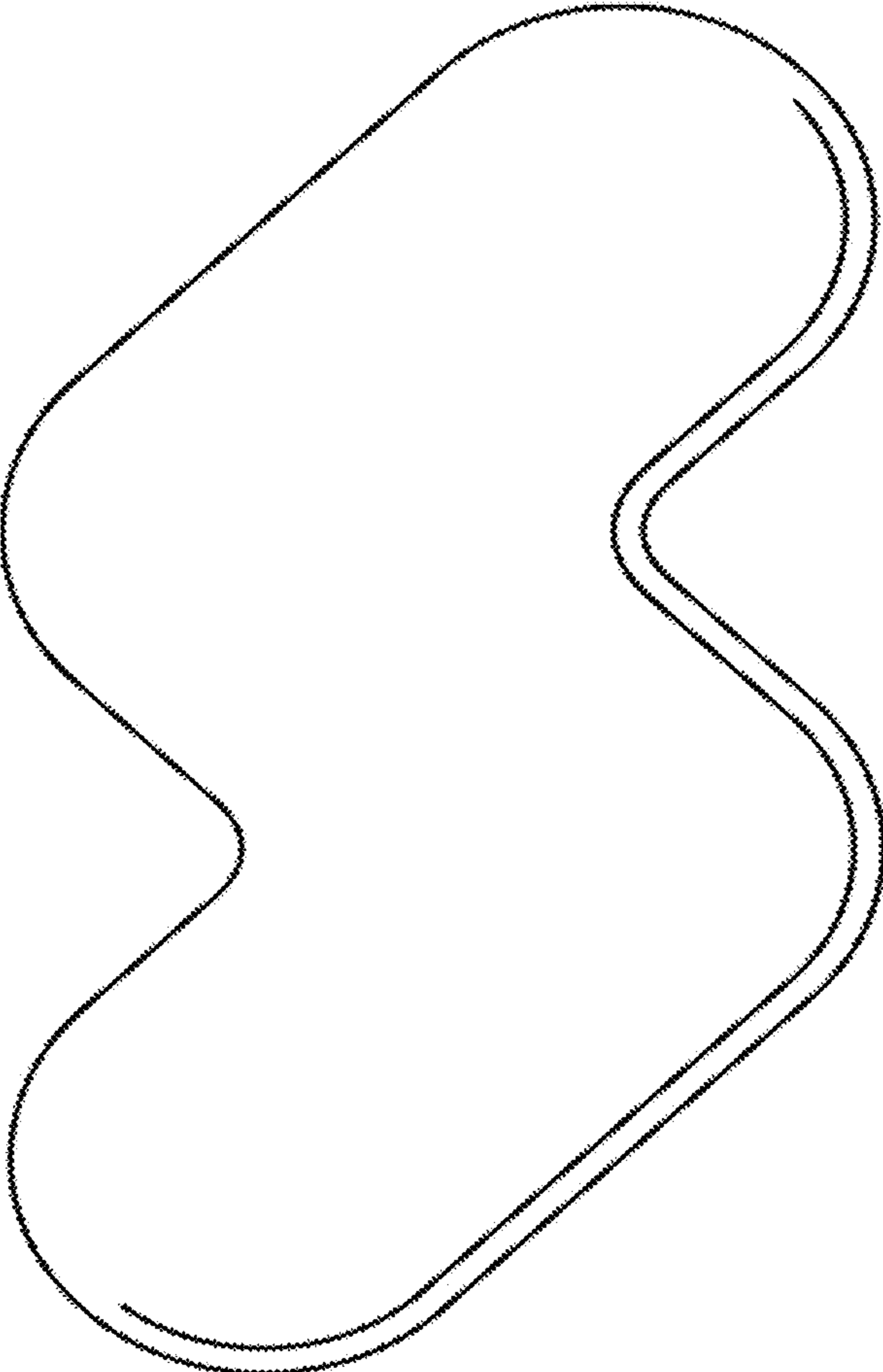
