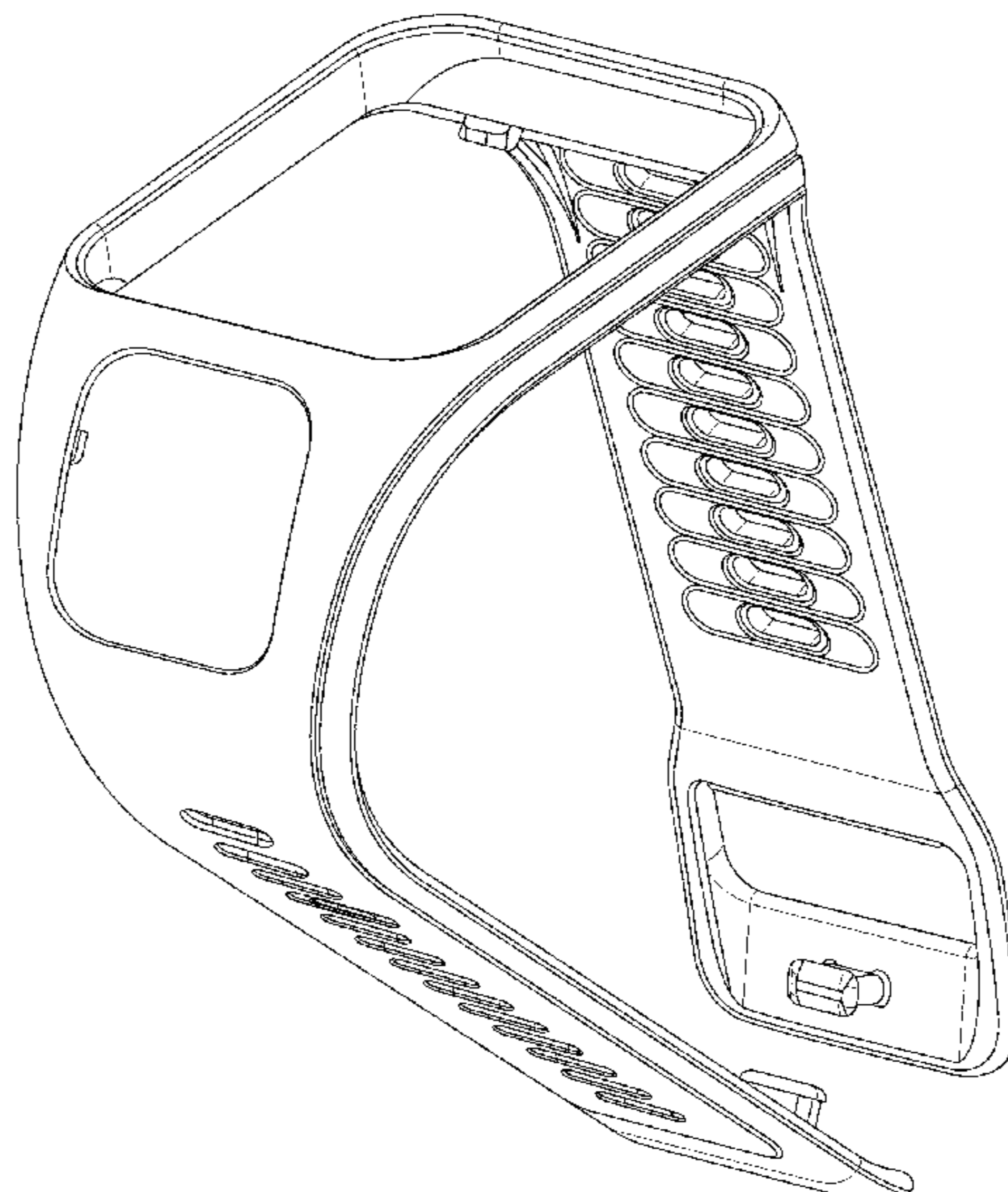
(57) **CLAIM**

The ornamental design for a fitness watch strap, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a fitness watch strap according to the present design.
FIG. 2 is a rear perspective view thereof;
FIG. 3 is a front elevation view thereof;
FIG. 4 is a rear elevation view thereof;
FIG. 5 is a top plan view thereof;
FIG. 6 is a bottom plan view thereof; and,
FIG. 7 is a right side elevation view thereof; the left side elevation view being a mirror image thereof.

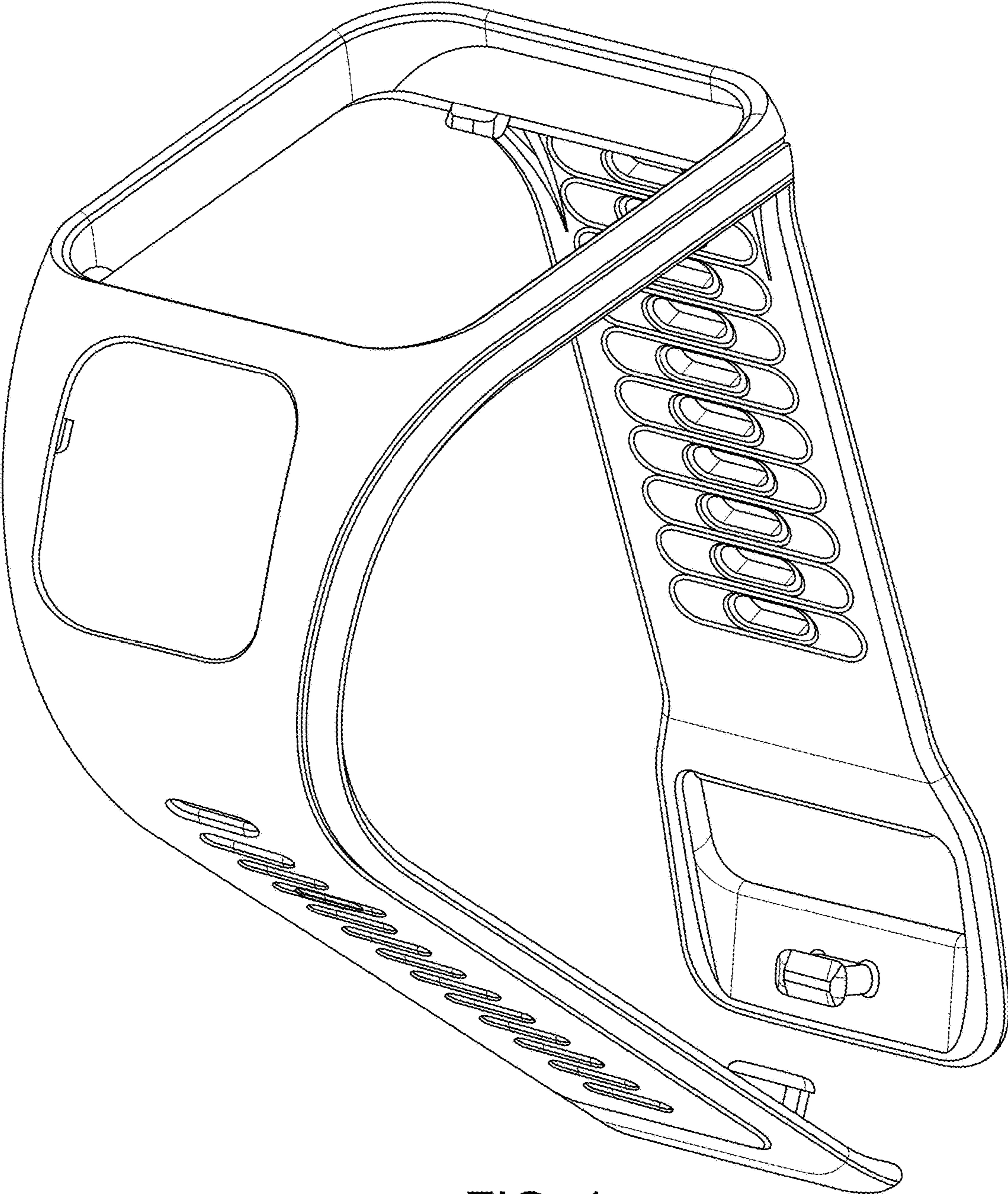

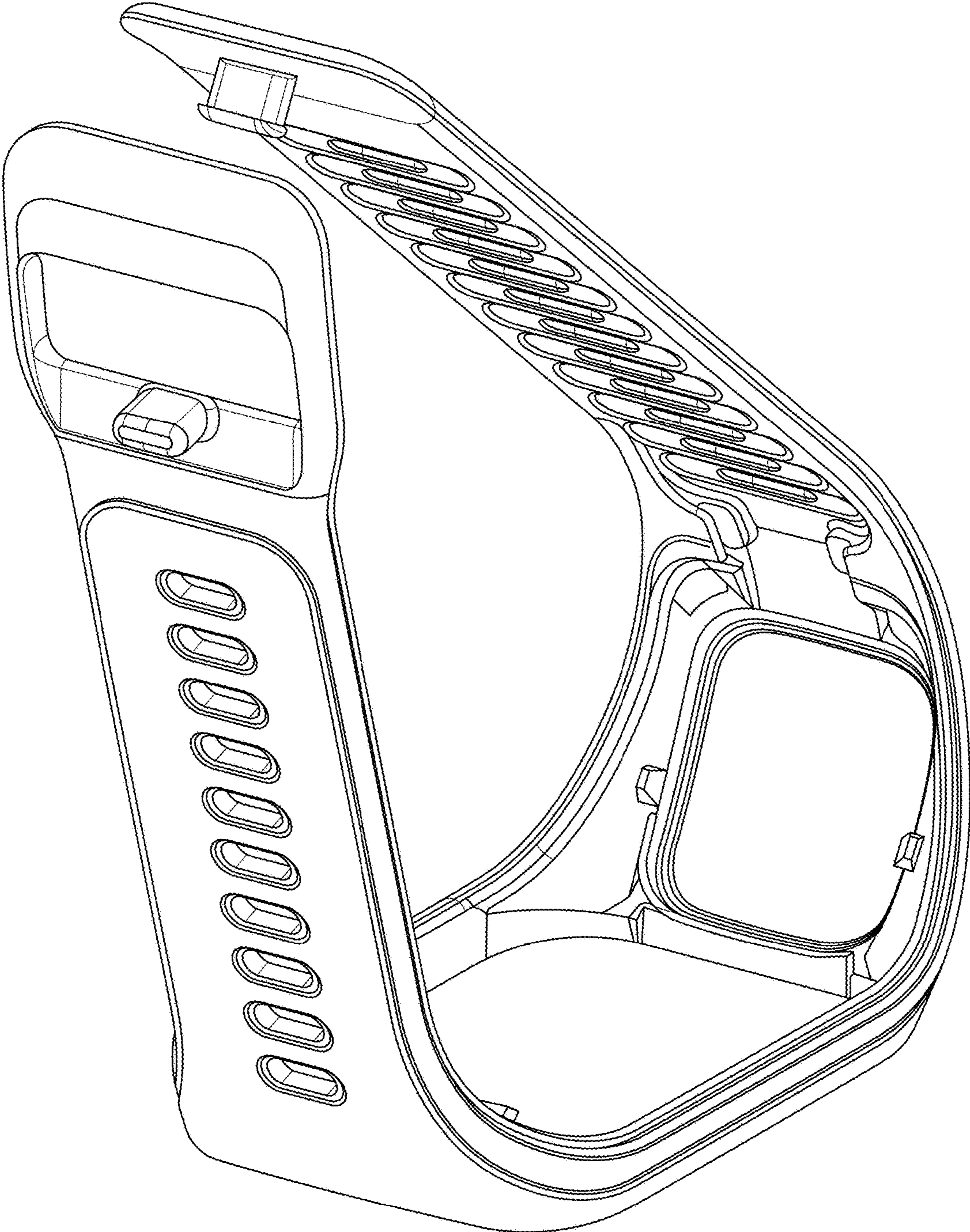

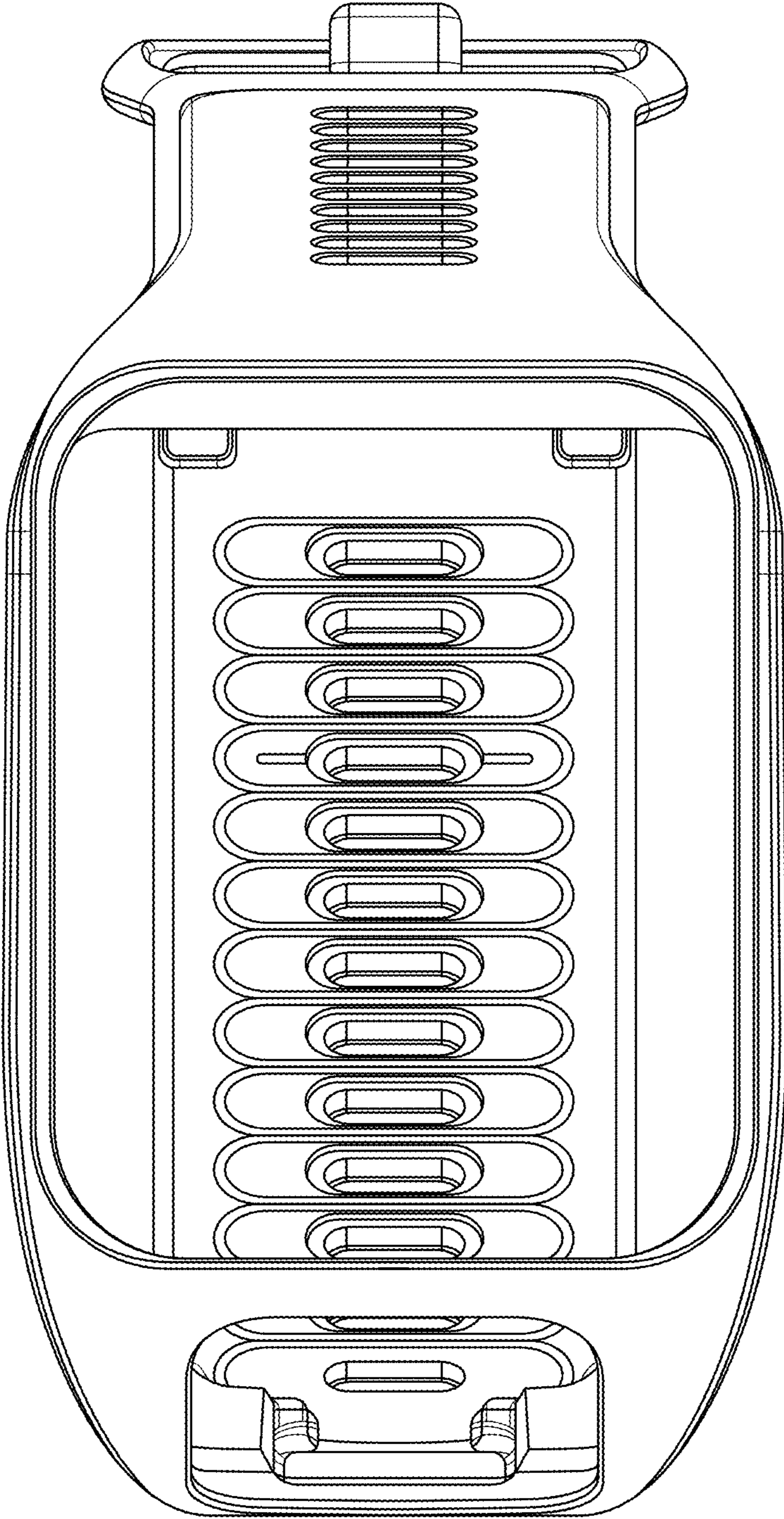

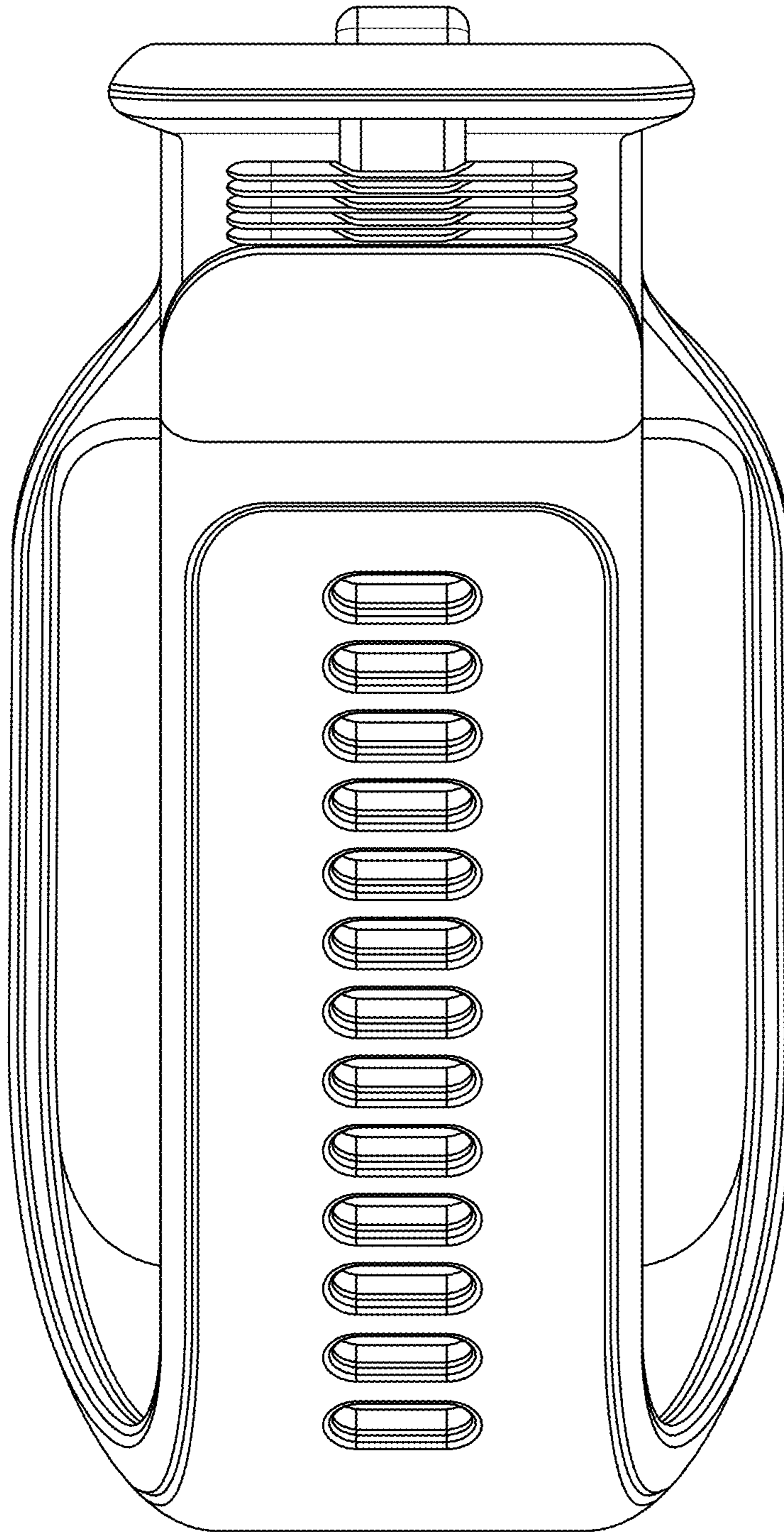

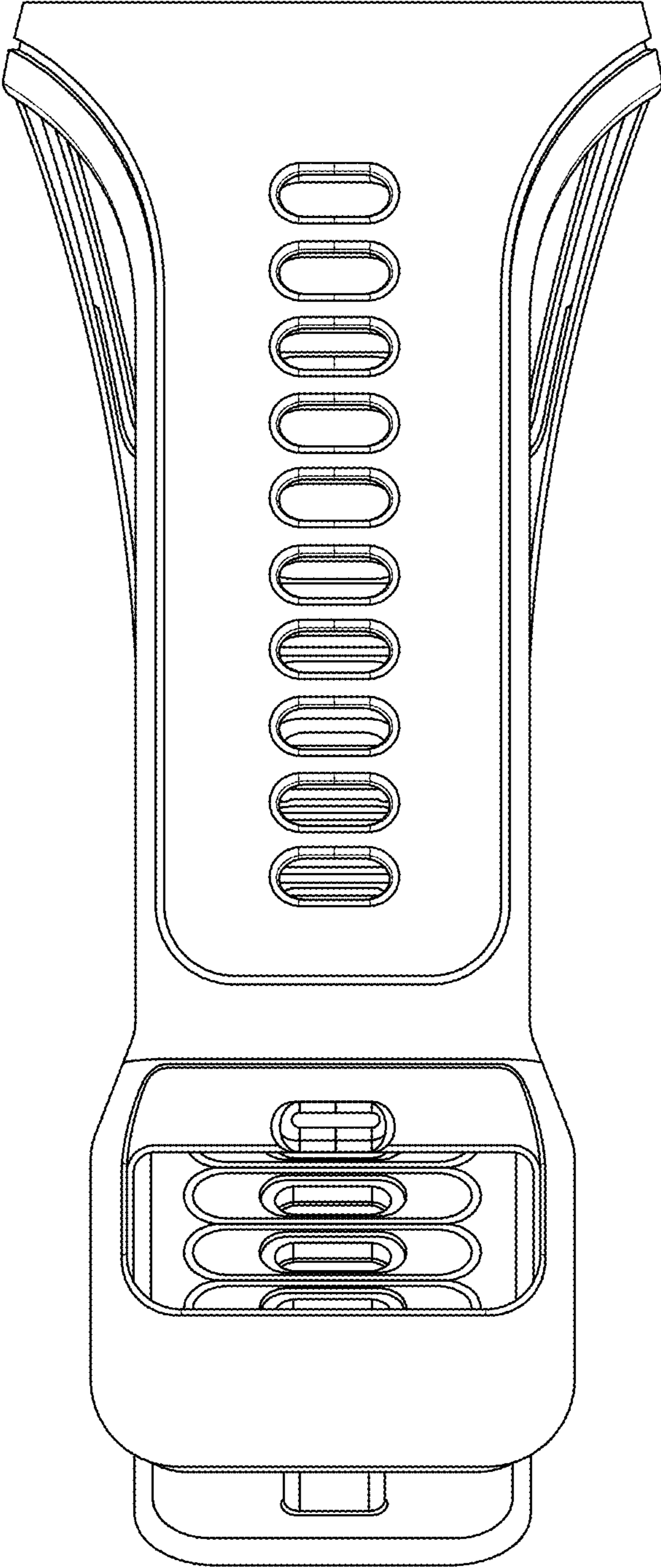

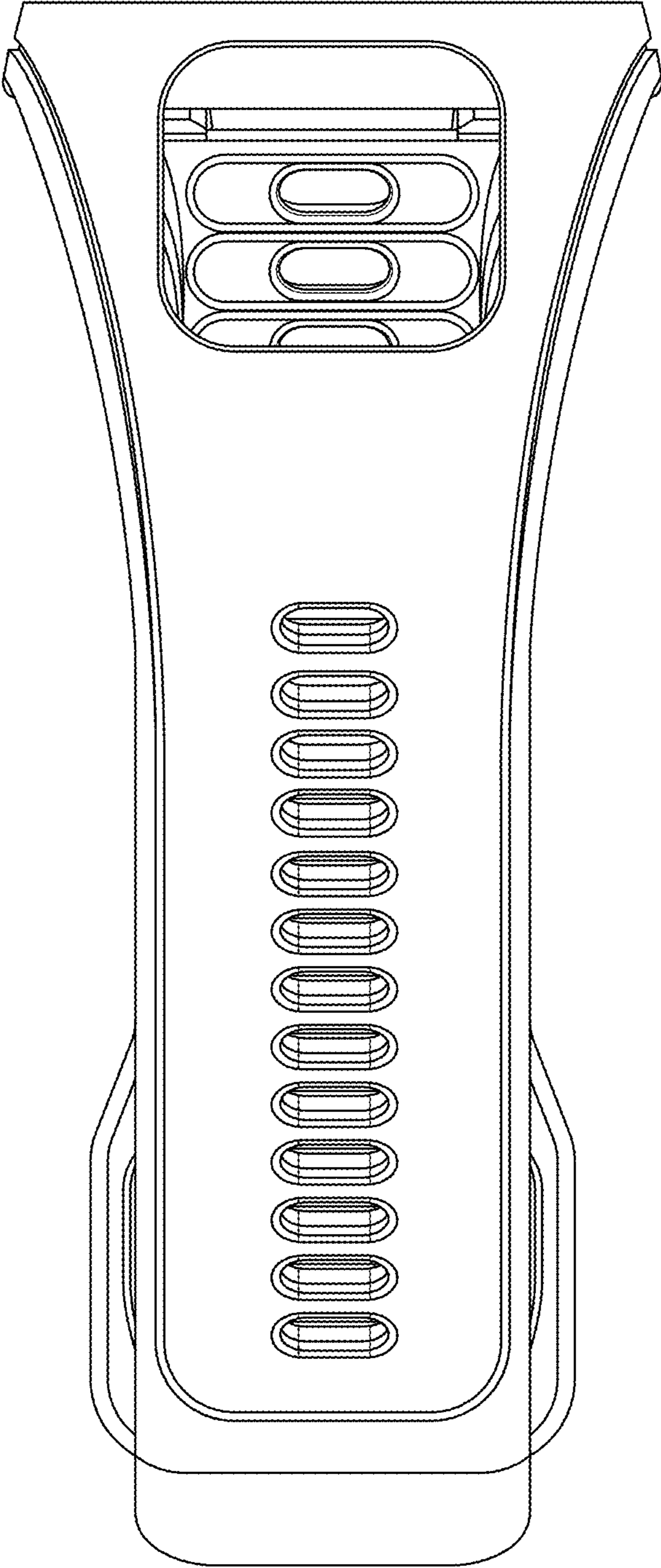

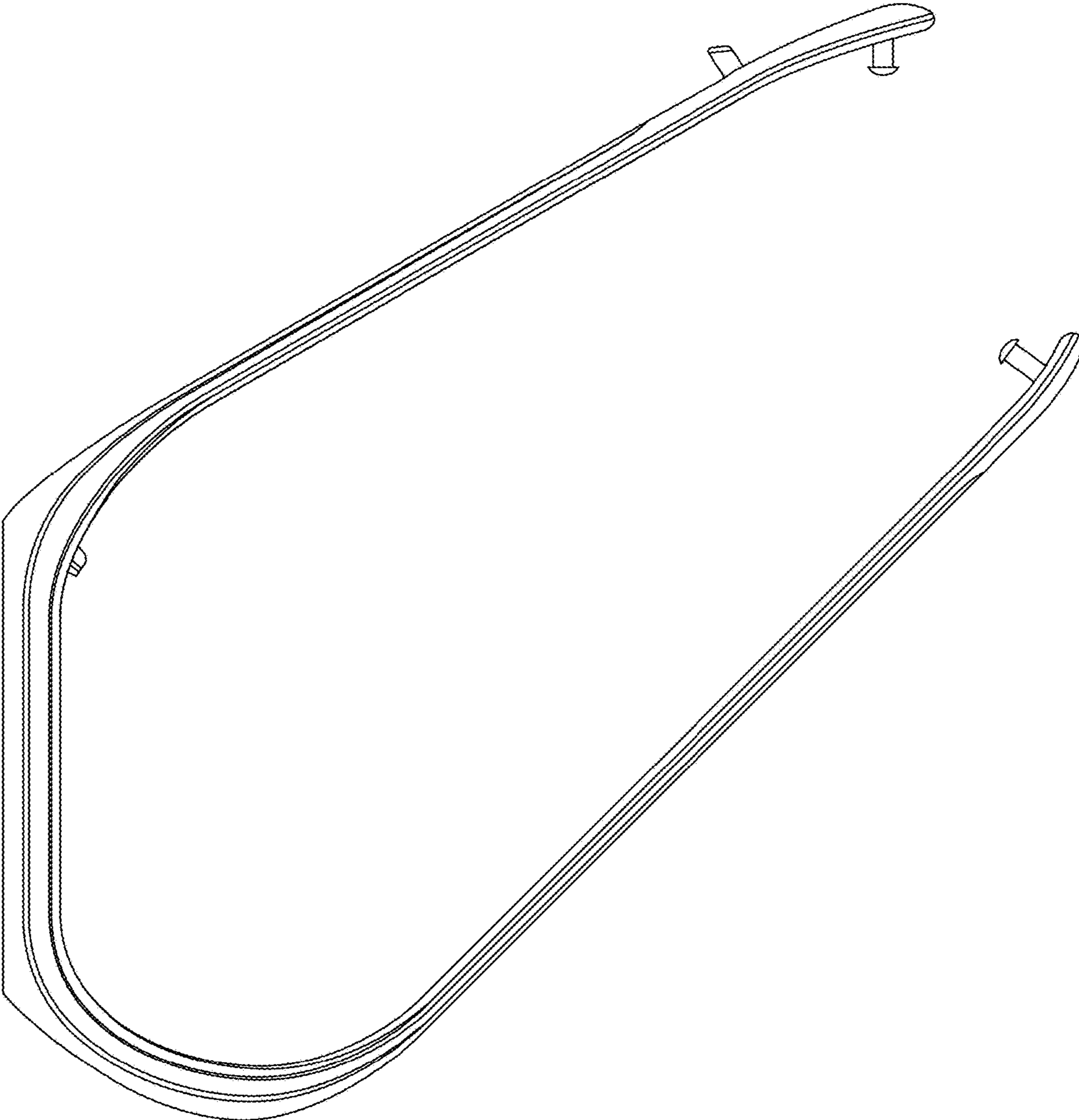
