(57) **CLAIM**

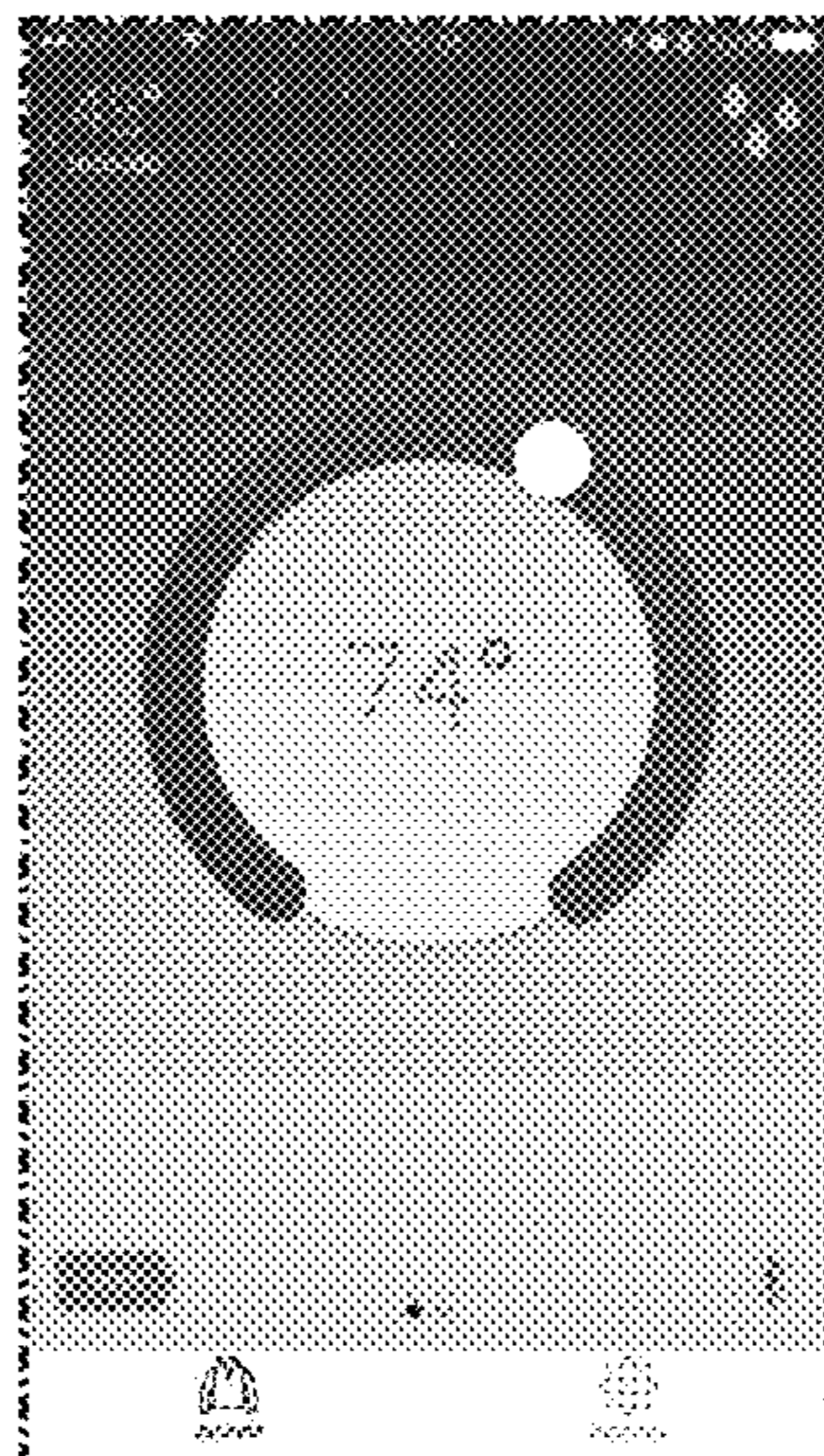
The ornamental design for a portable electronic device display screen or portion thereof with graphical user interface, as shown and described.
