DESCRIPTION

FIG. 1 is a left isometric view of a land clearing tool assembly with a depth control ring and drum interface showing our new design in assembled condition; FIG. 2 is a close-up view of the claimed subject matter in FIG. 1; FIG. 3 is a left rear isometric view thereof; FIG. 4 is a close-up view of the claimed subject matter in FIG. 3; FIG. 5 is a left side view thereof; FIG. 6 is a right side view thereof; FIG. 7 is a front view thereof; FIG. 8 is a close-up view of the claimed subject matter in FIG. 7; FIG. 9 is a rear view thereof; FIG. 10 is a close-up view of the claimed subject matter in FIG. 9; FIG. 11 is a top view thereof; FIG. 12 is a close-up view of the claimed subject matter in FIG. 11; FIG. 13 is a bottom view thereof; FIG. 14 is a close-up view of the claimed subject matter in FIG. 13; FIG. 15 is an enlarged left isometric view of a land clearing tool assembly with a depth control ring and drum interface shown isolated from the drum interface of FIG. 1; FIG. 16 is a left rear isometric view thereof; FIG. 17 is a left side view thereof; FIG. 18 is a right side view thereof; FIG. 19 is a front view thereof; FIG. 20 is a rear view thereof; FIG. 21 is a top view thereof; and, FIG. 22 is a bottom view thereof.
The broken line showing of the tool assembly in FIGS. 1-14, and the broken lines on the surface of the claim in FIGS. 1-22 is included for the purpose of illustrating environmental structure and forms no part of the claimed design.

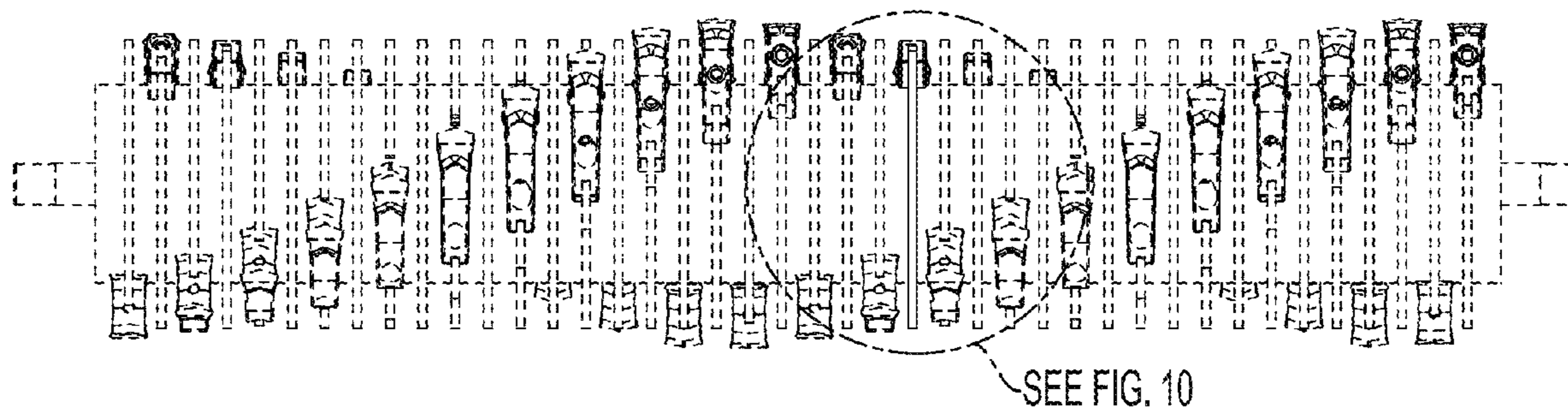

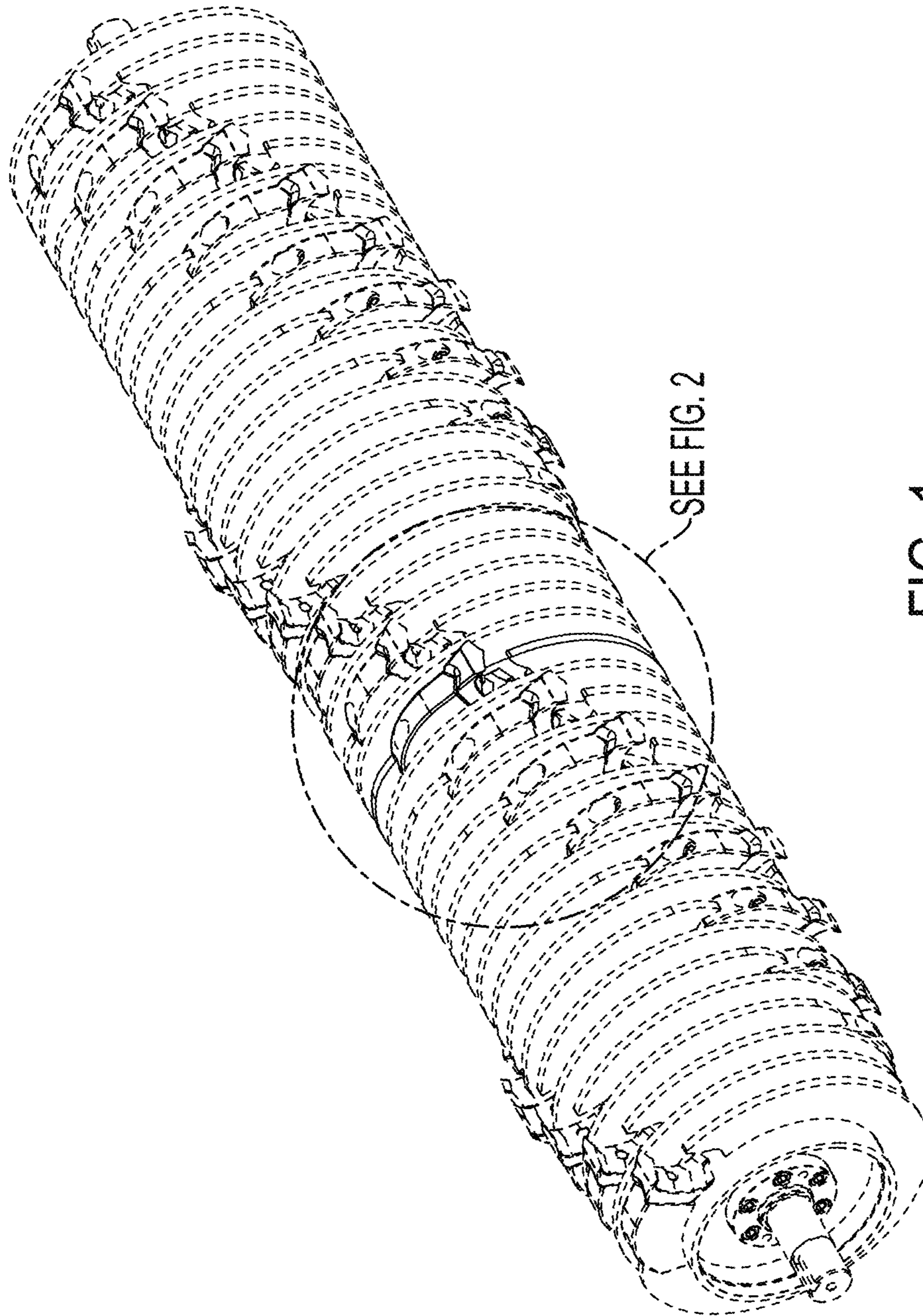

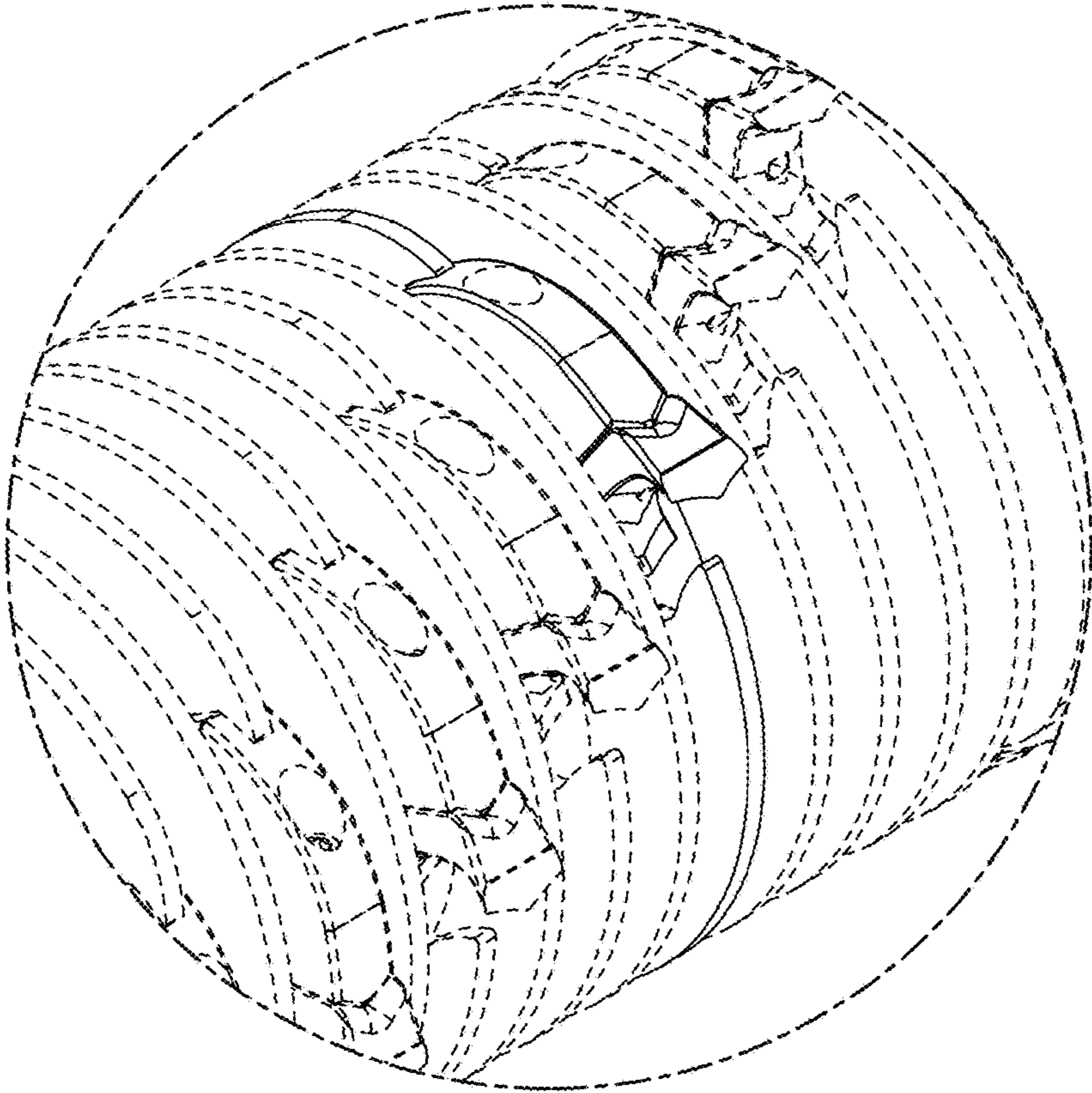

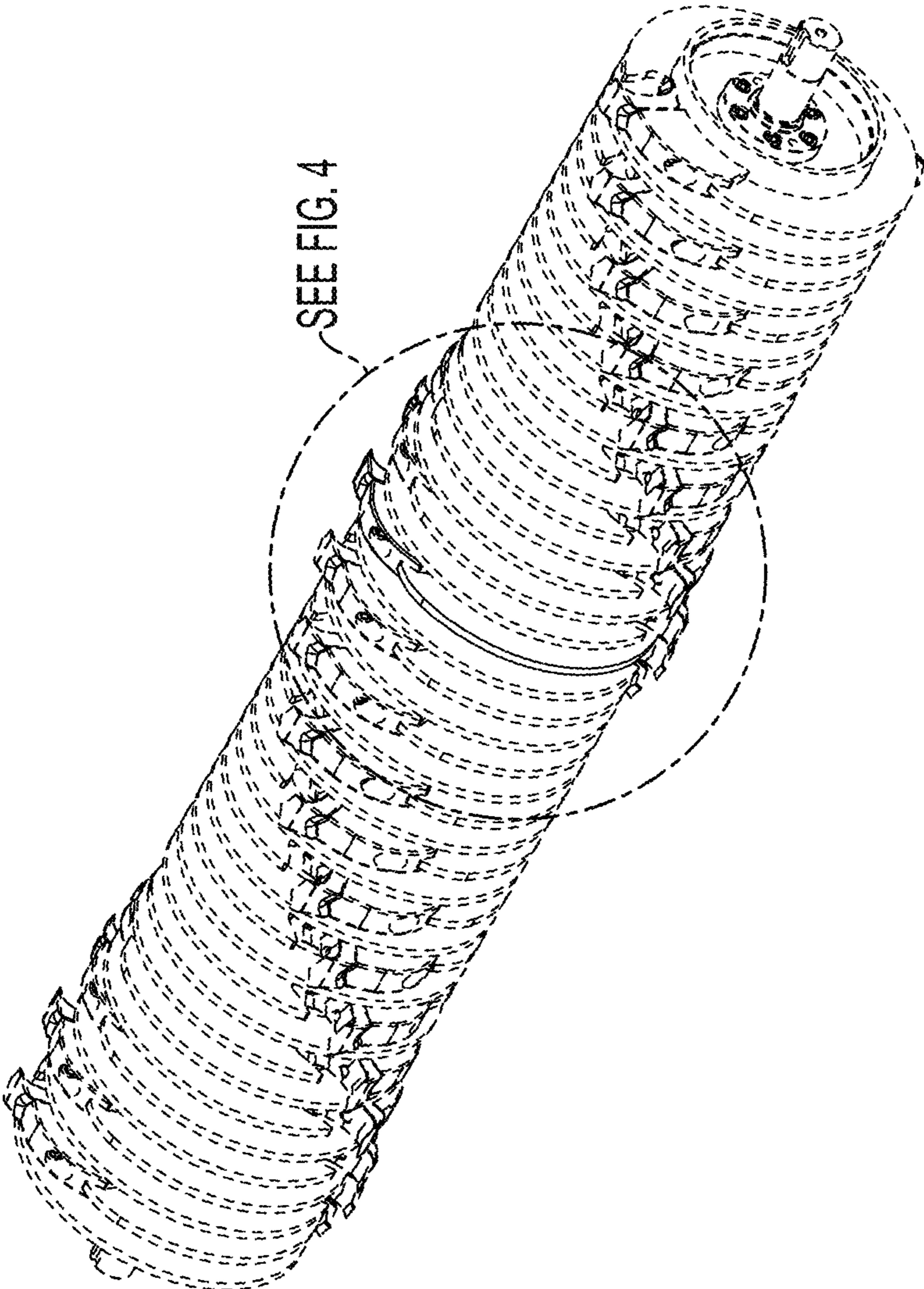

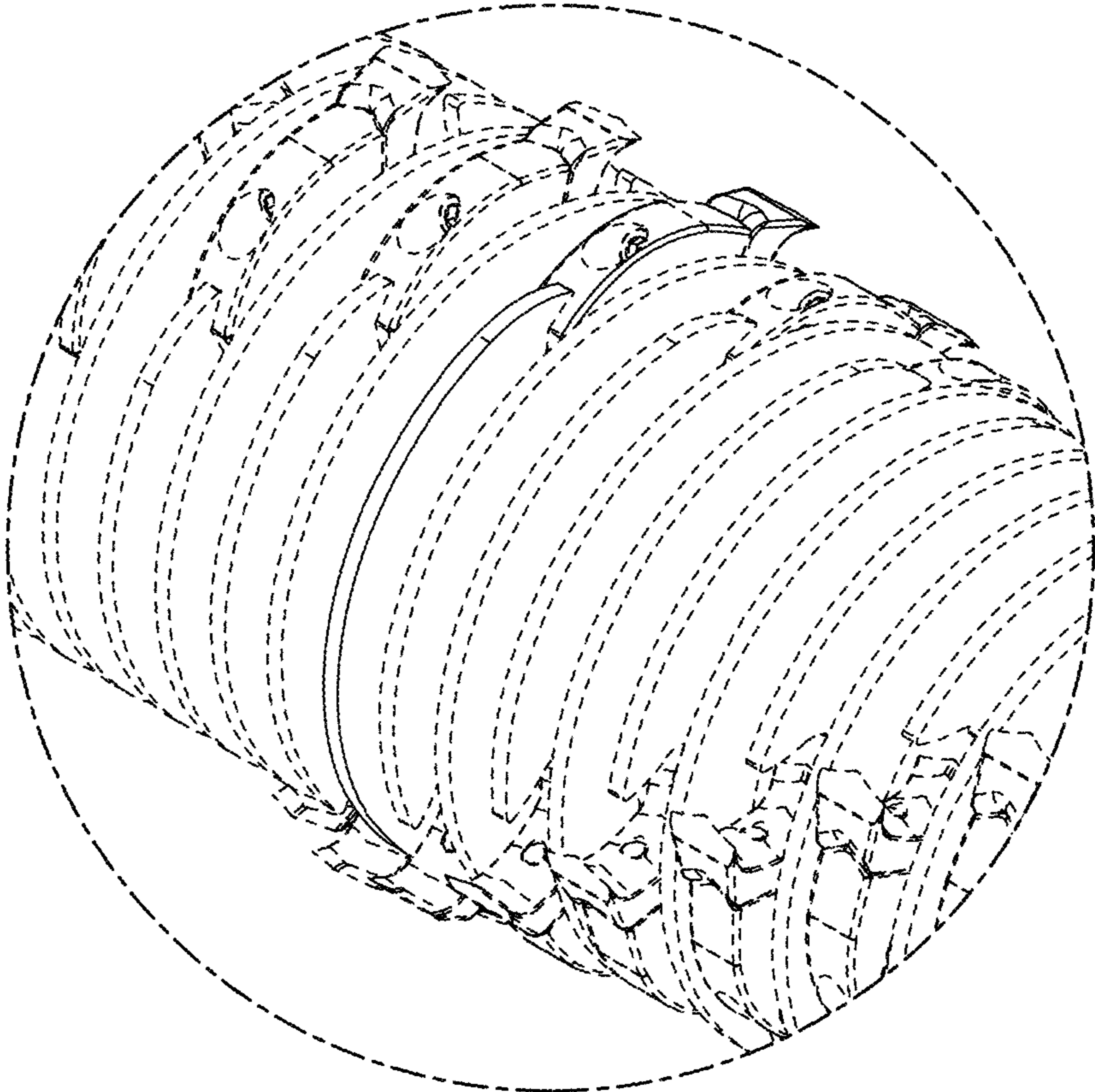

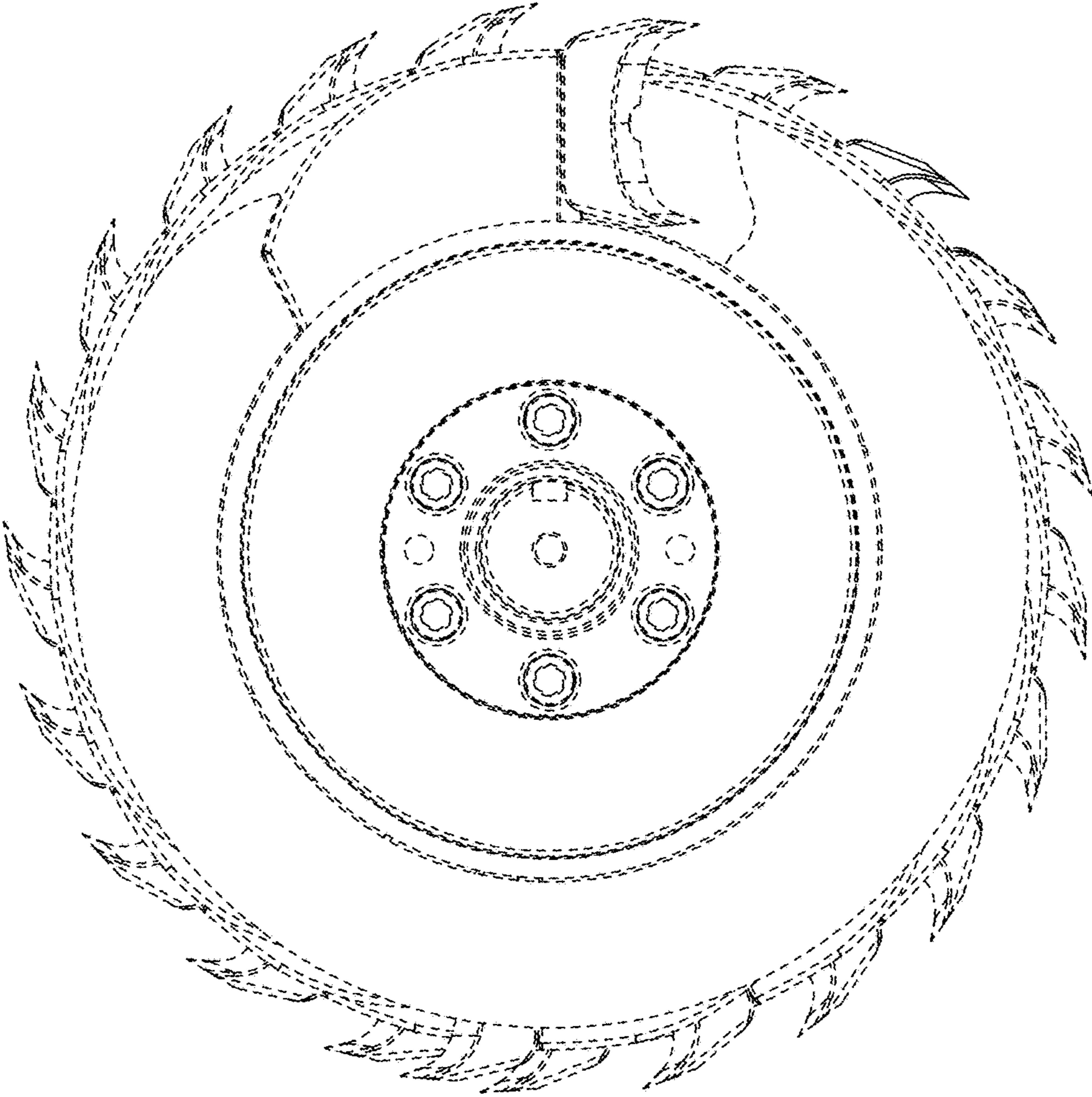

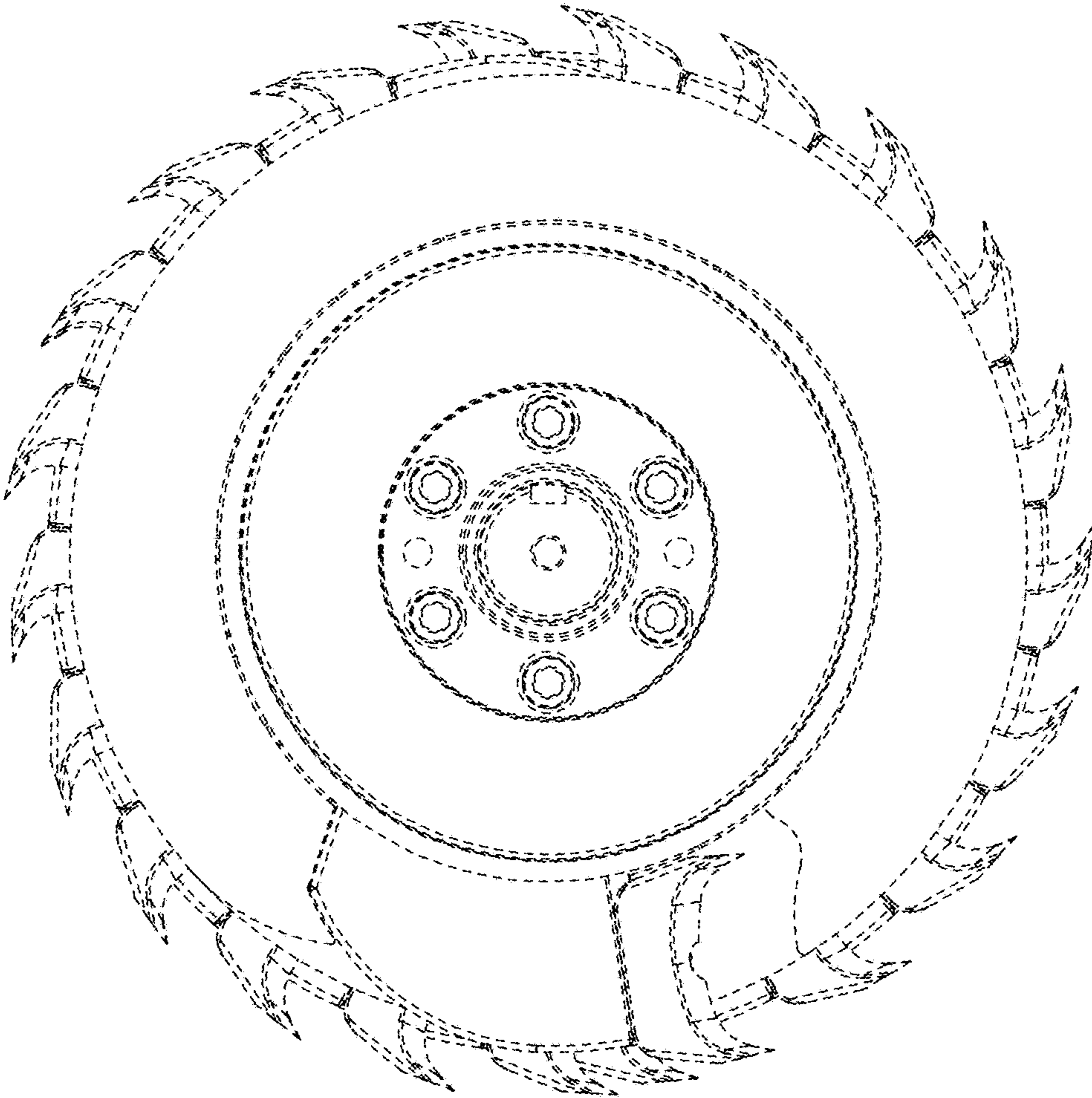

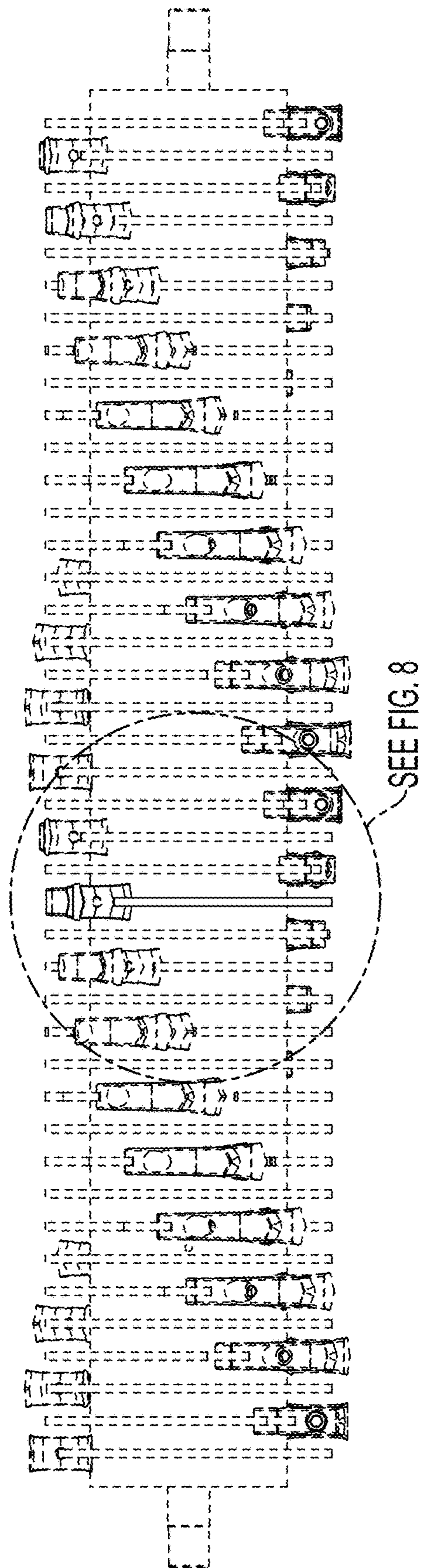

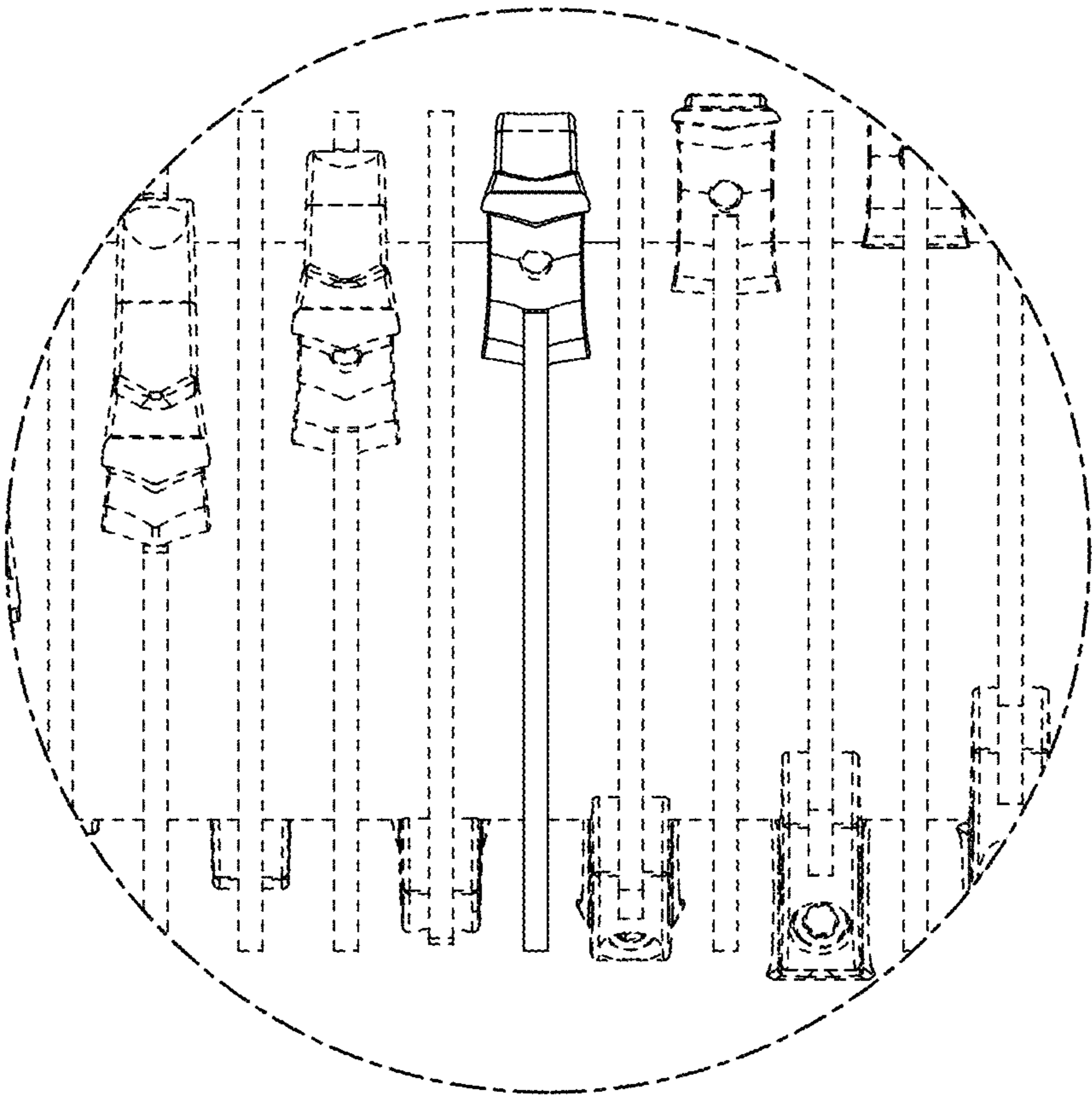
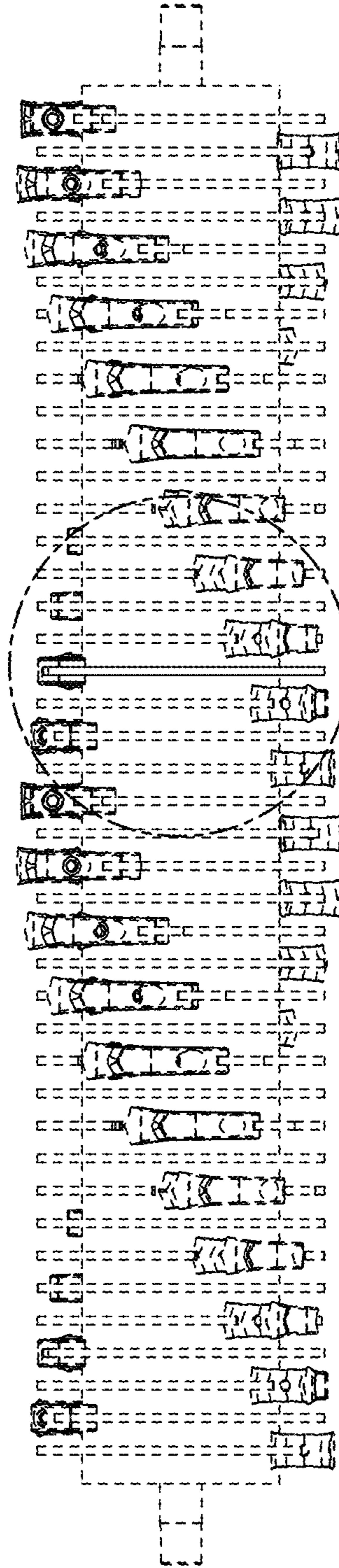

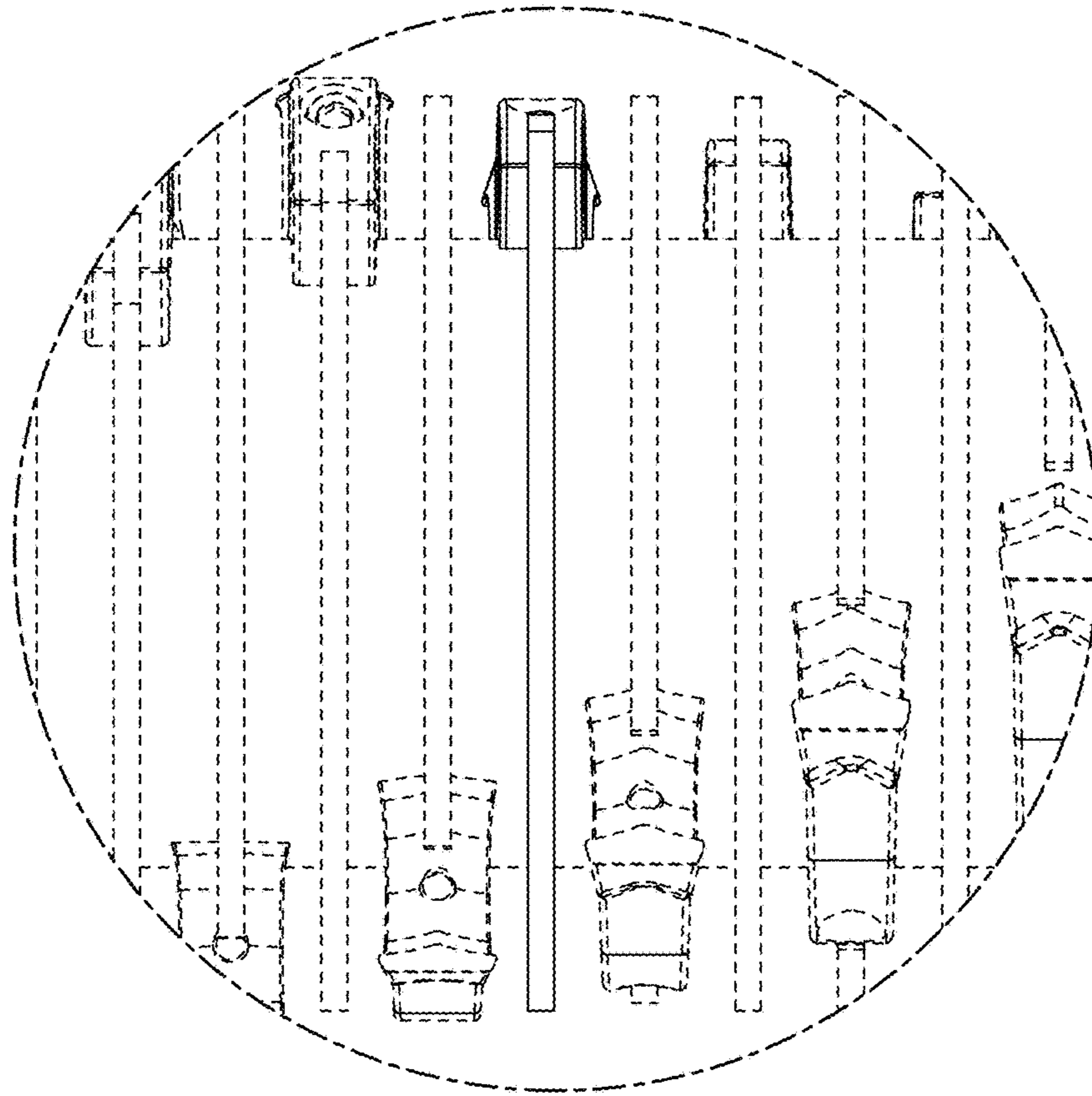
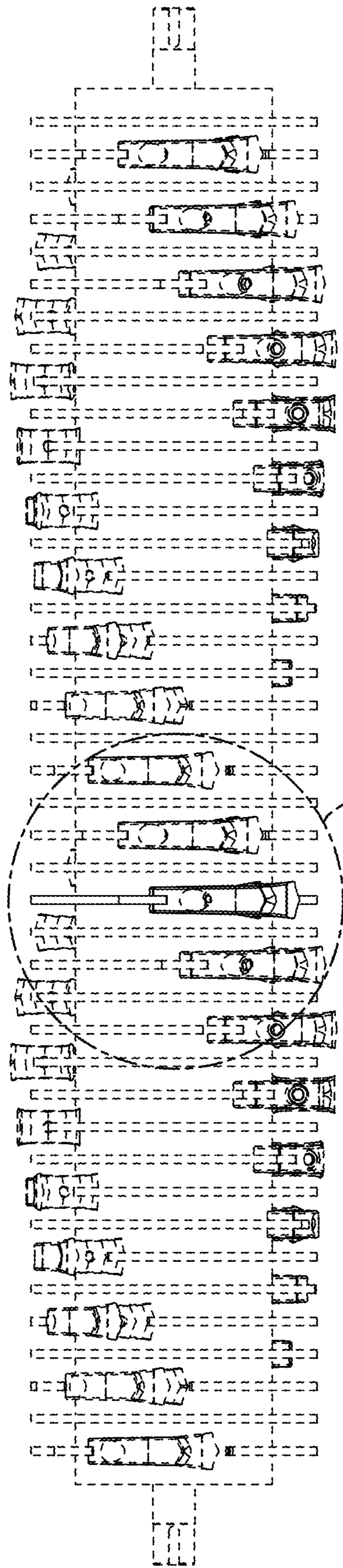

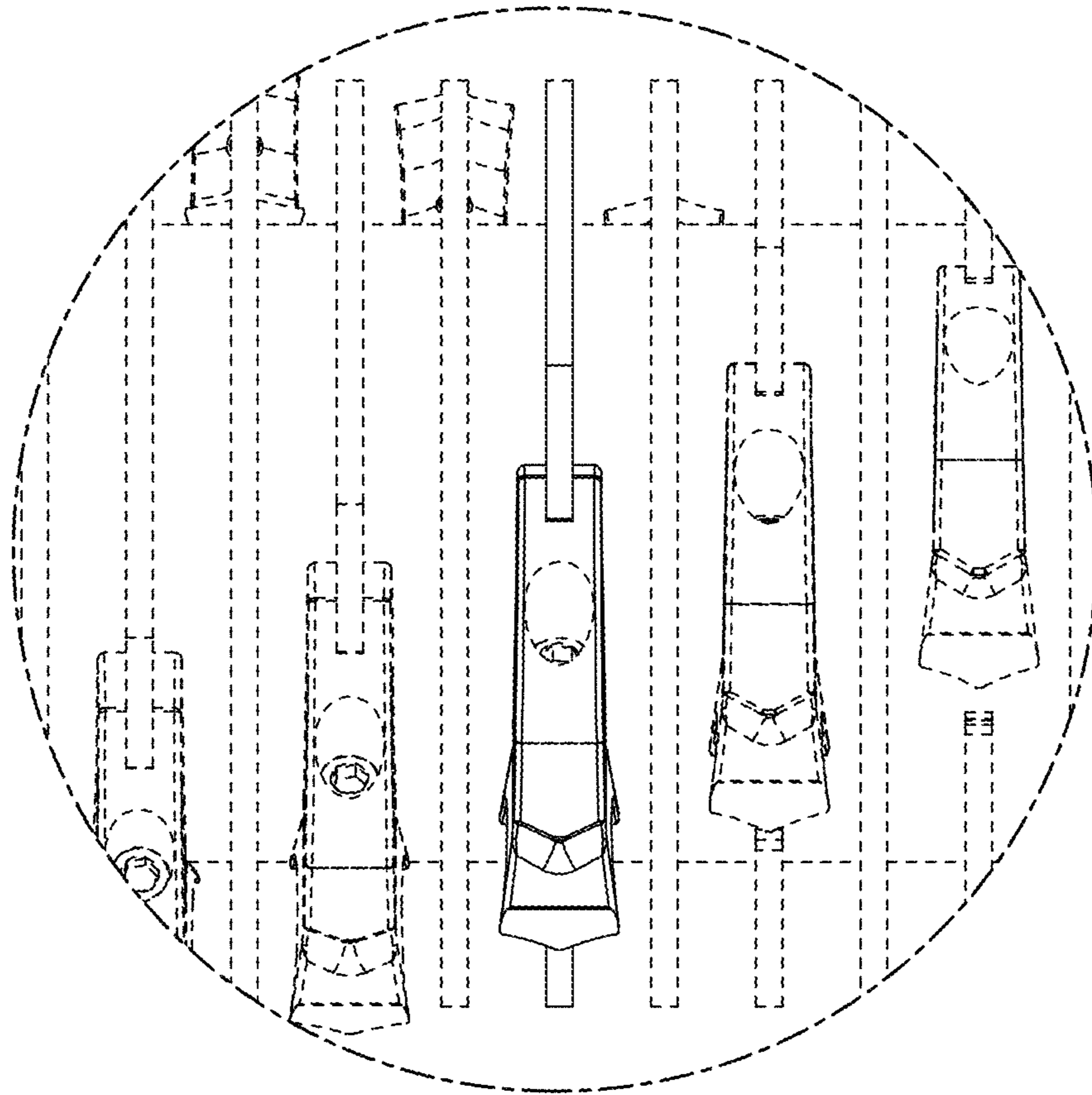

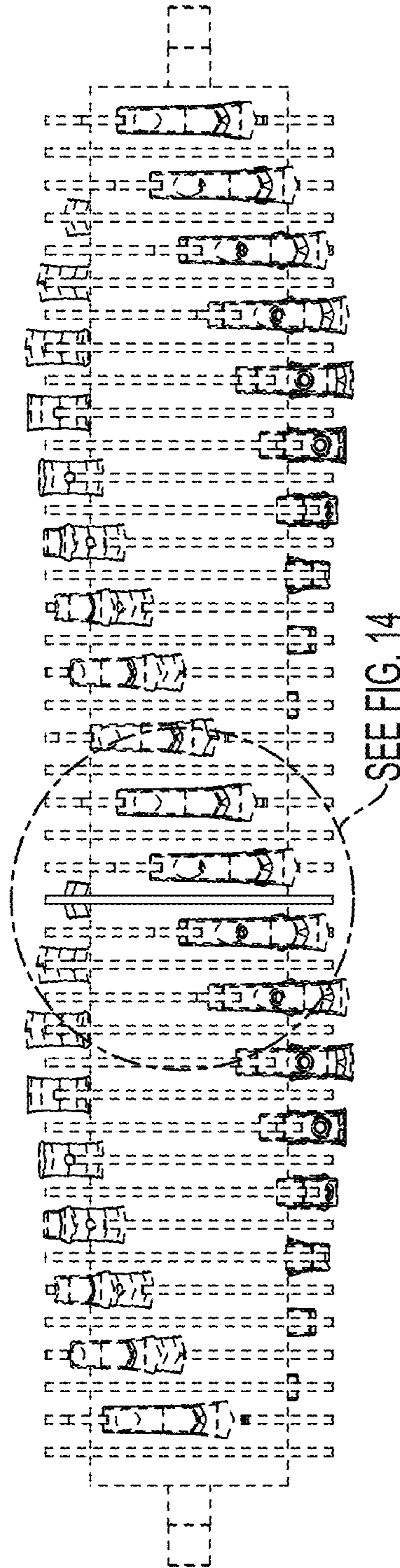

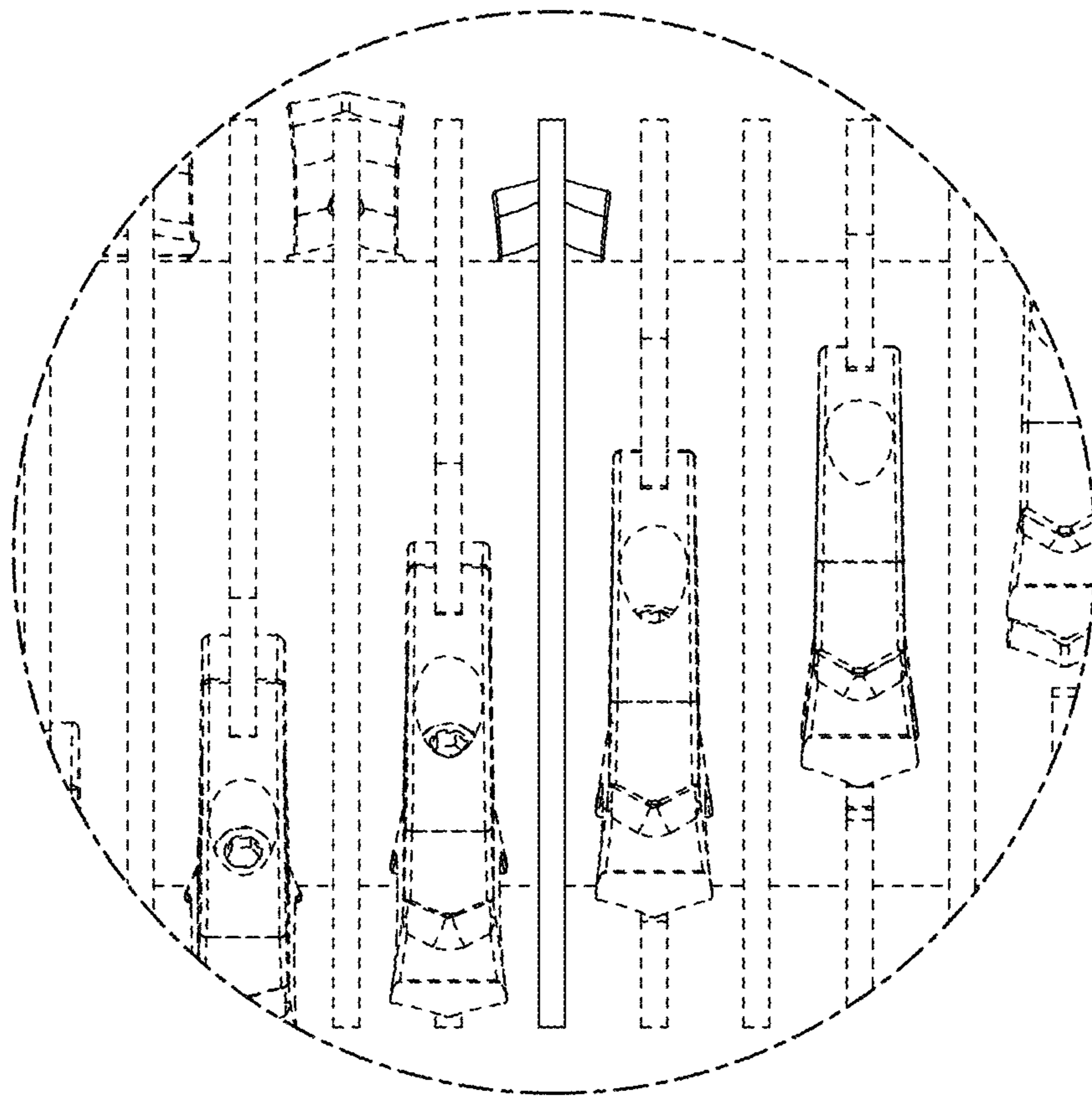

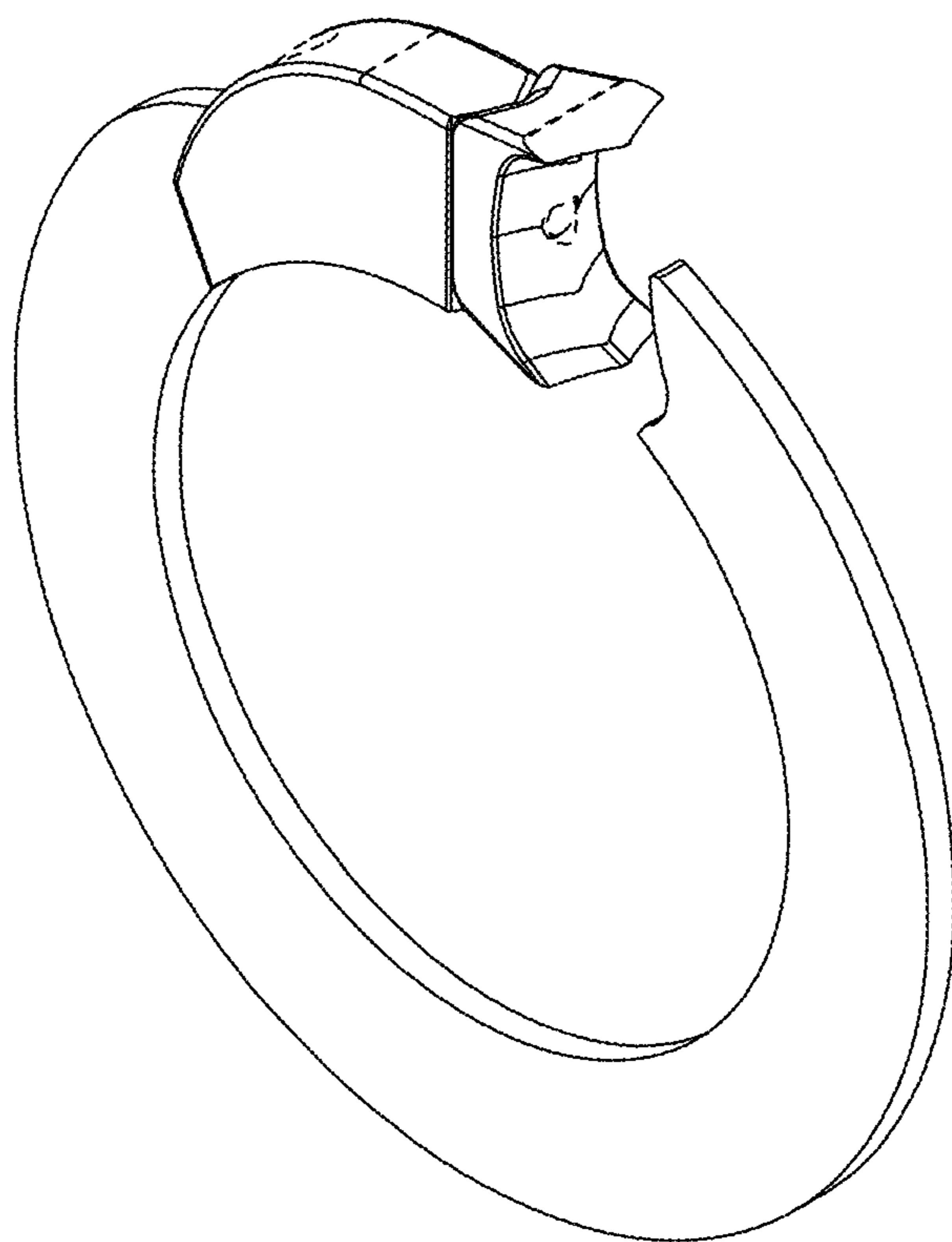

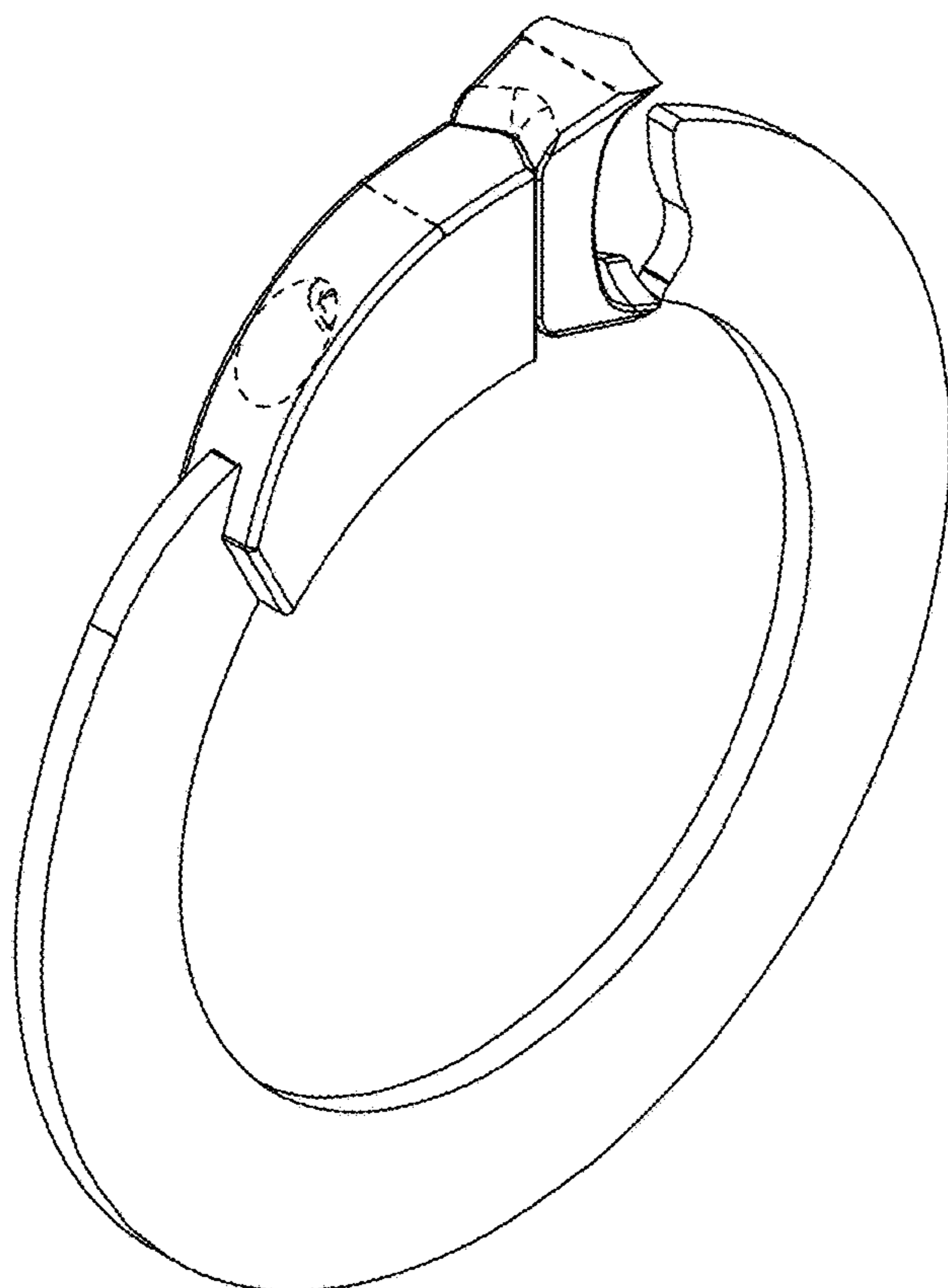

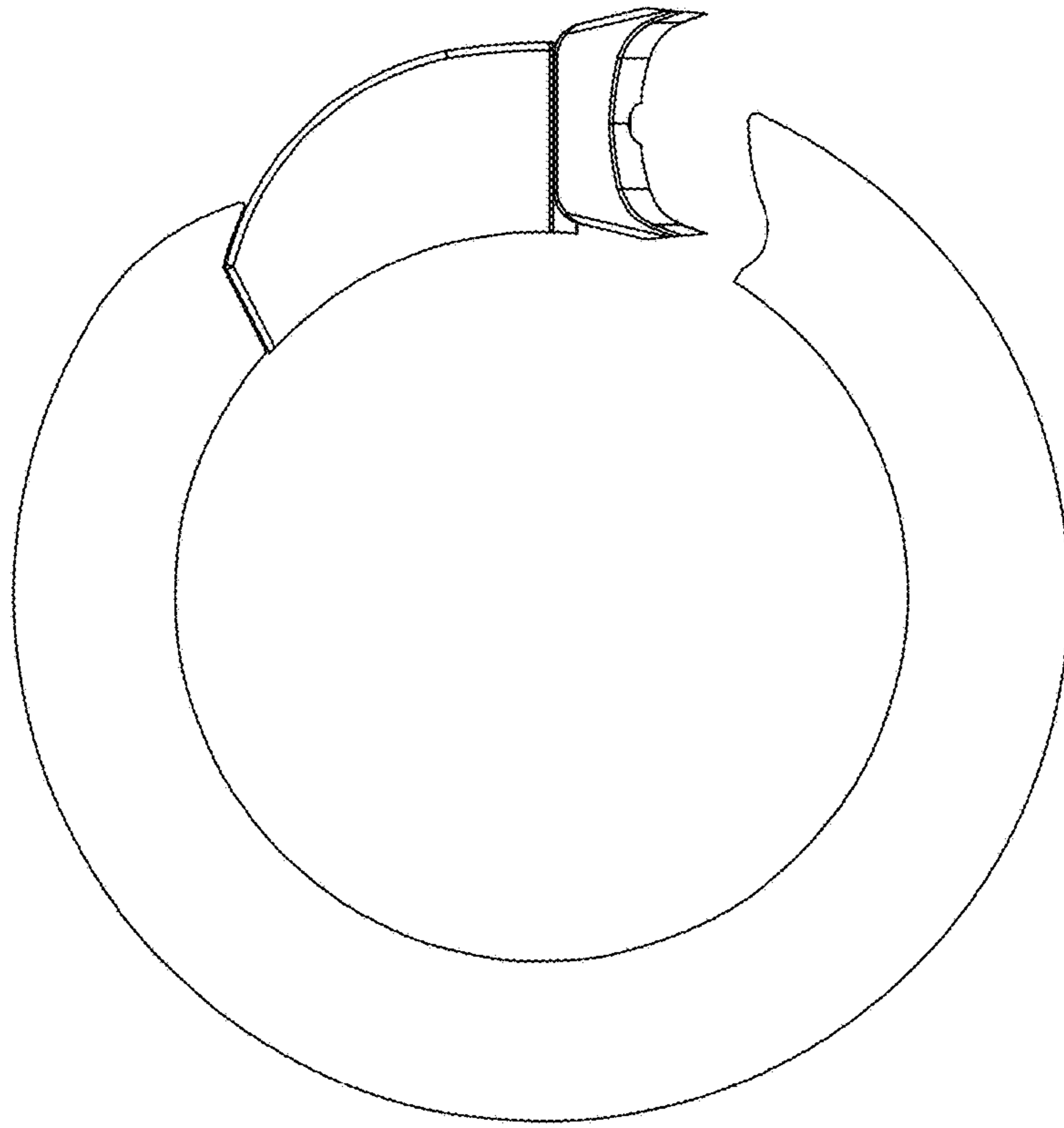

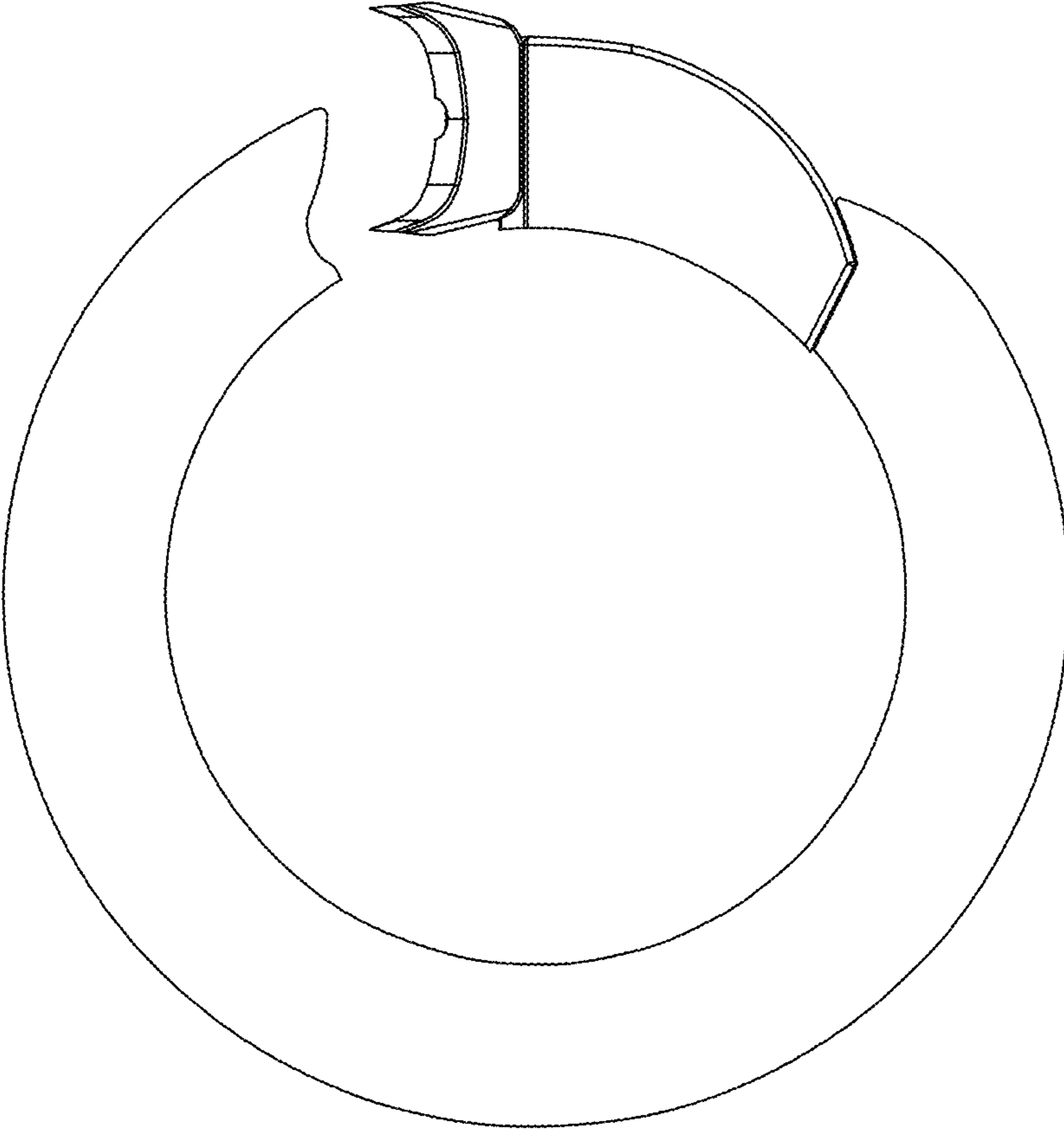

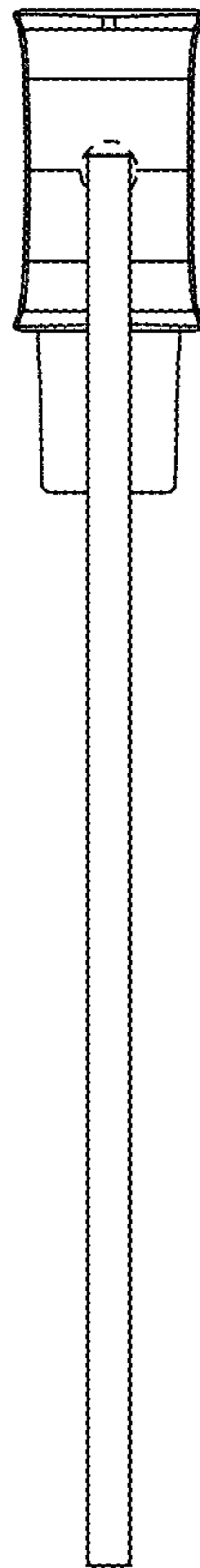

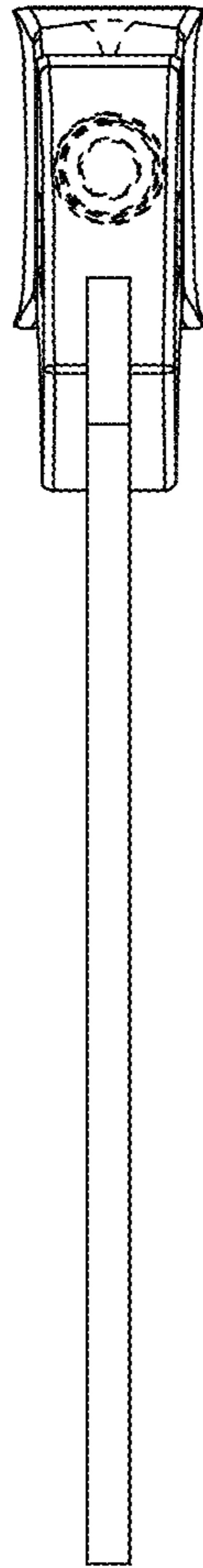

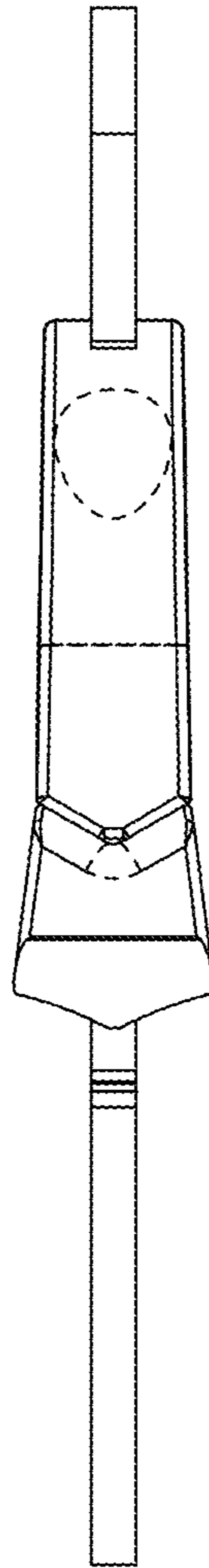

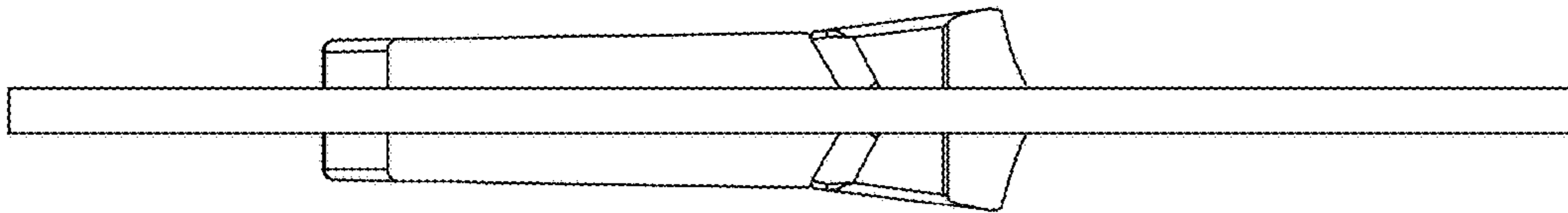
