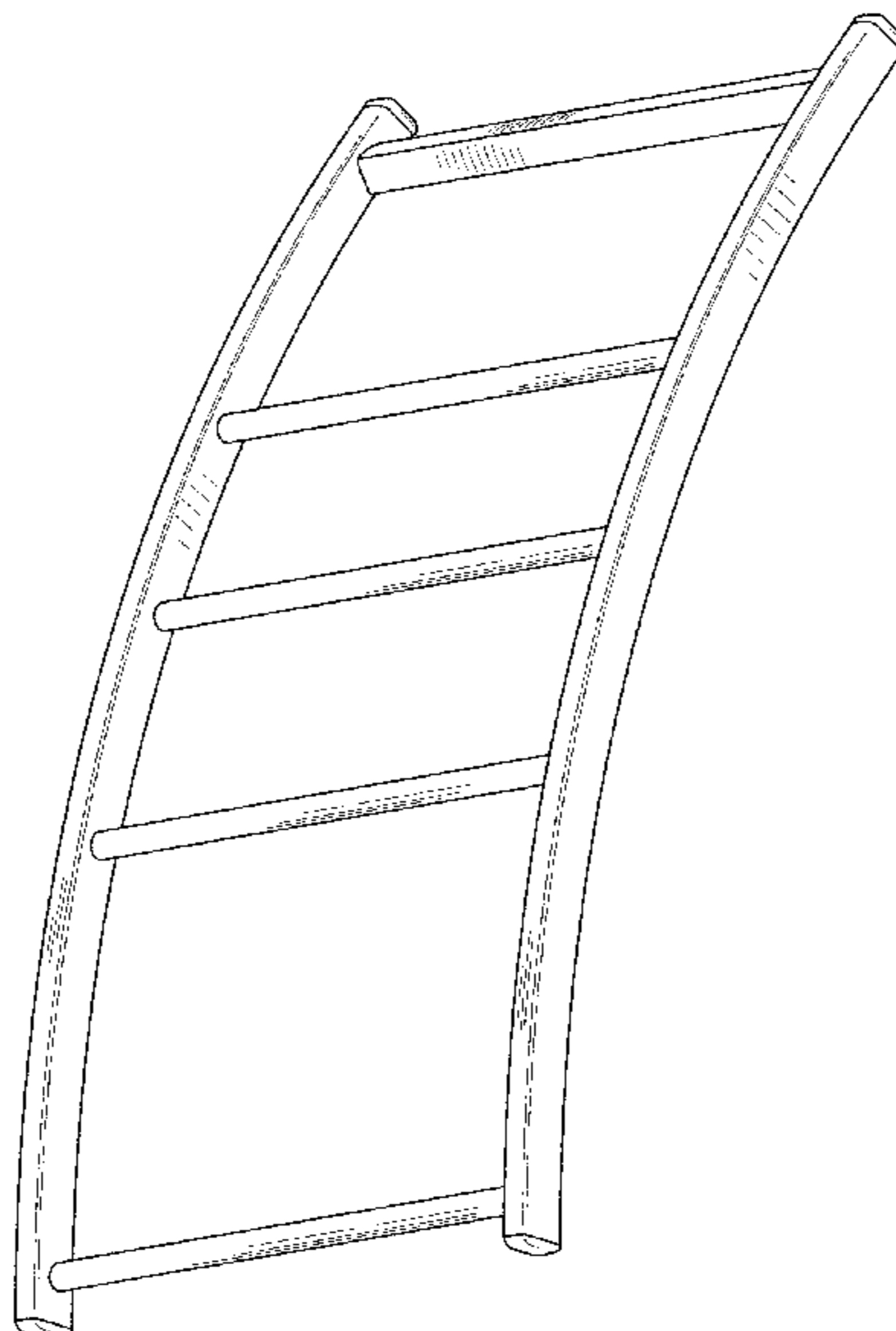
The ornamental design for an exercise apparatus, as shown and described.

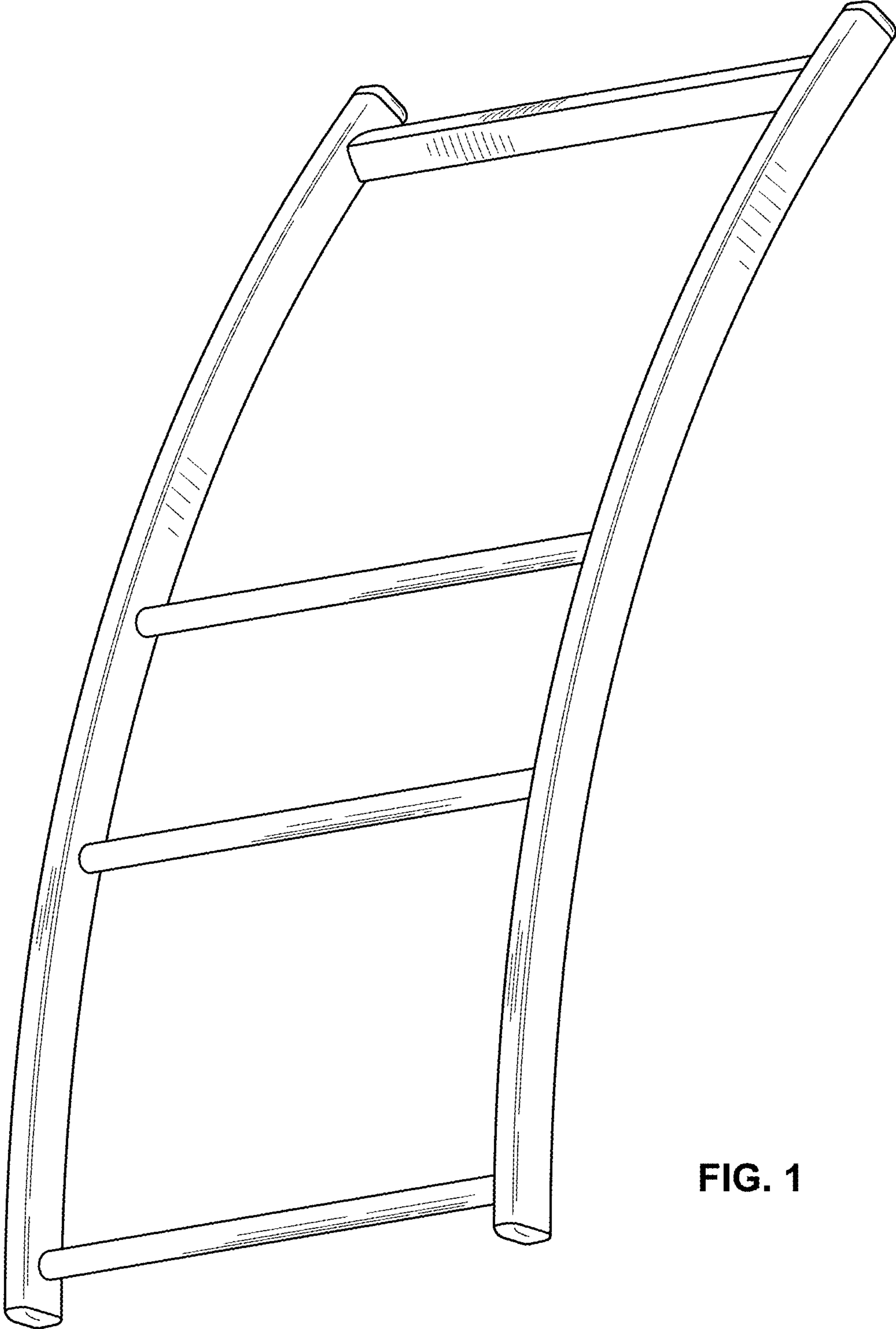

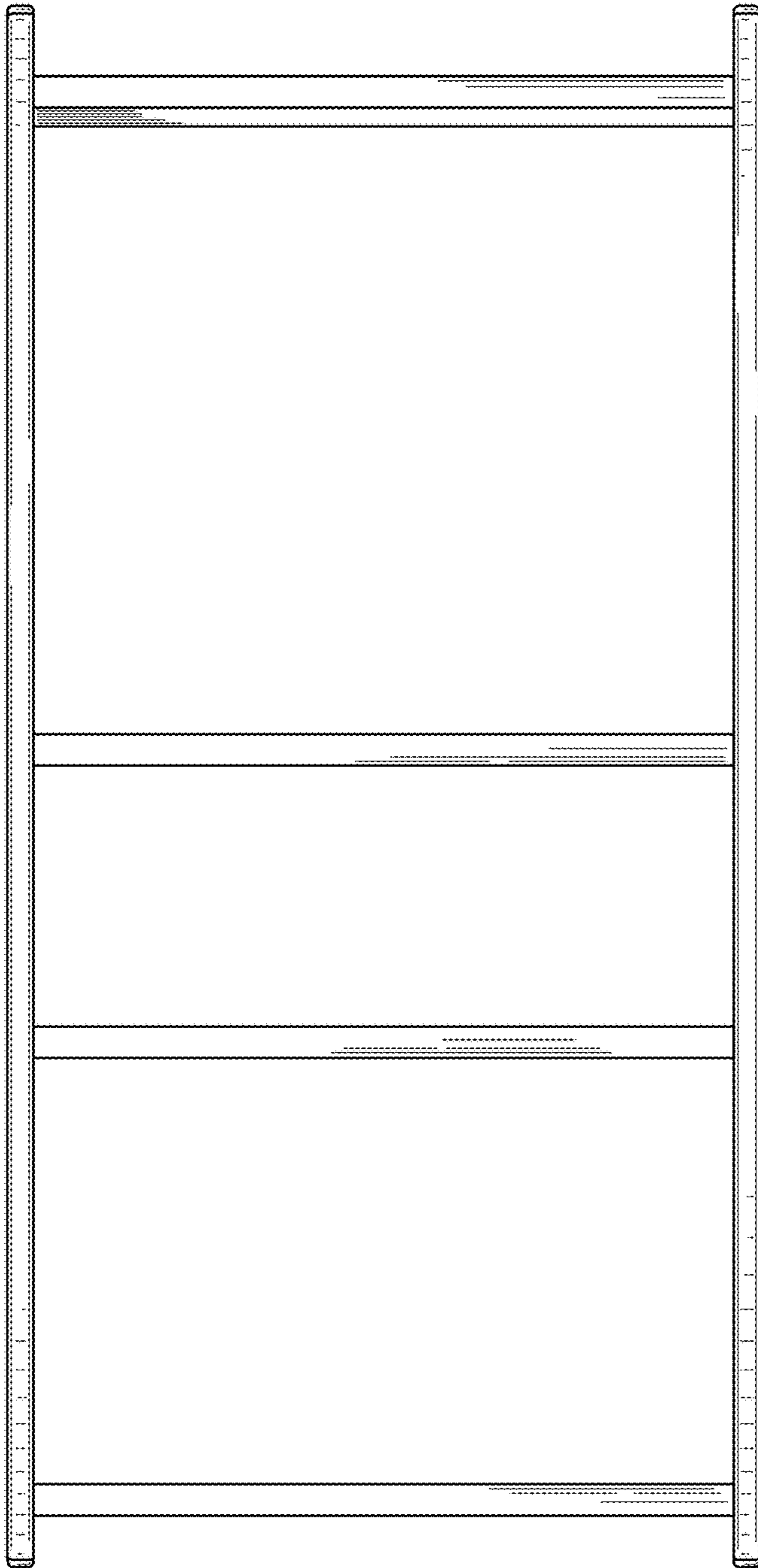

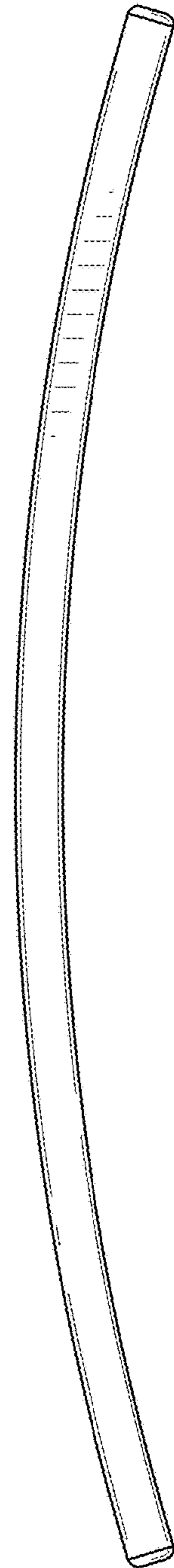

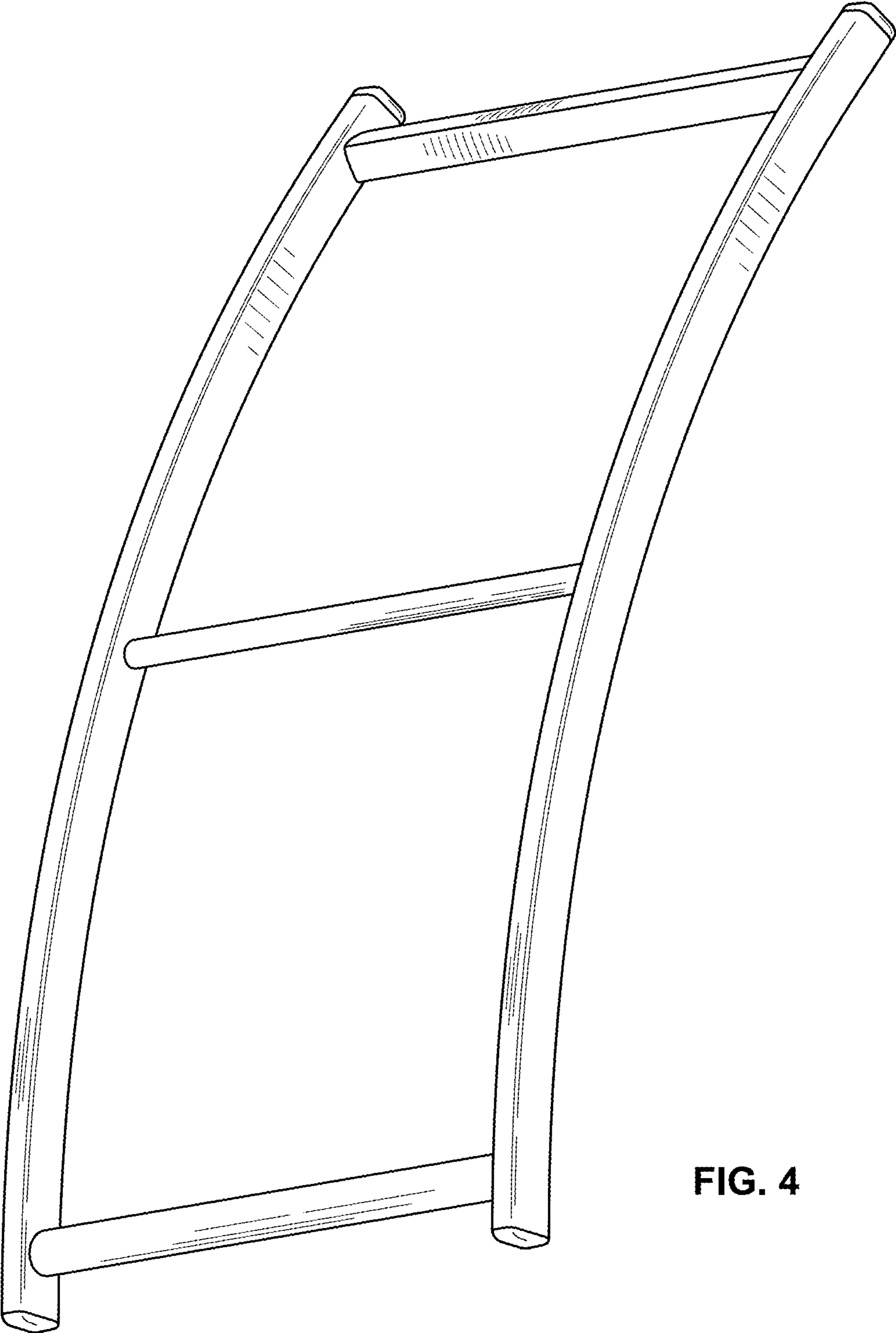

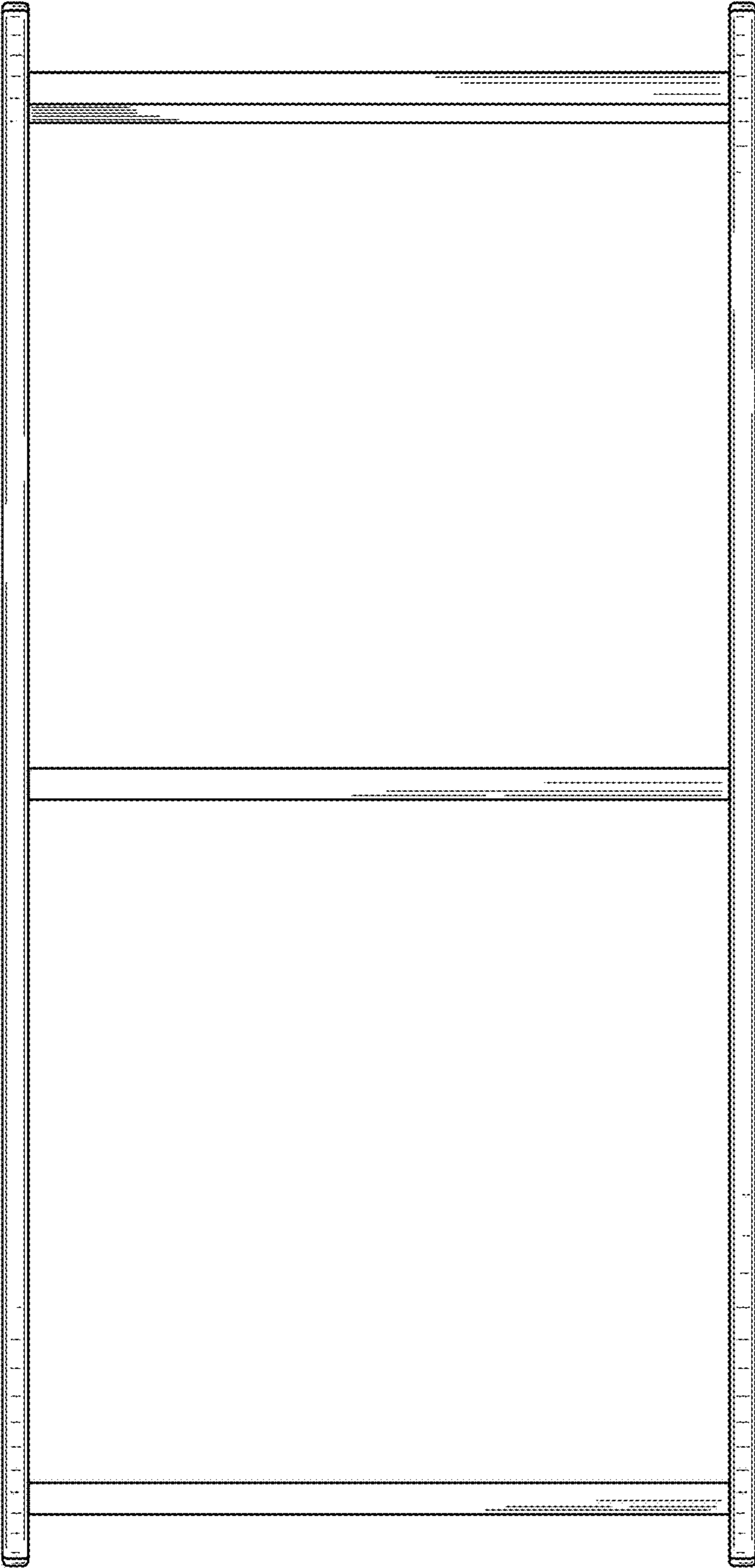

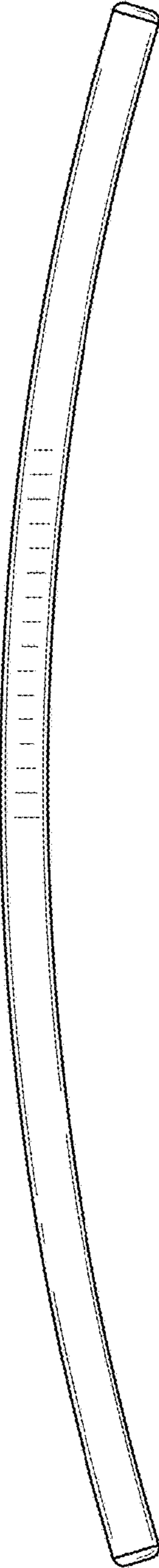

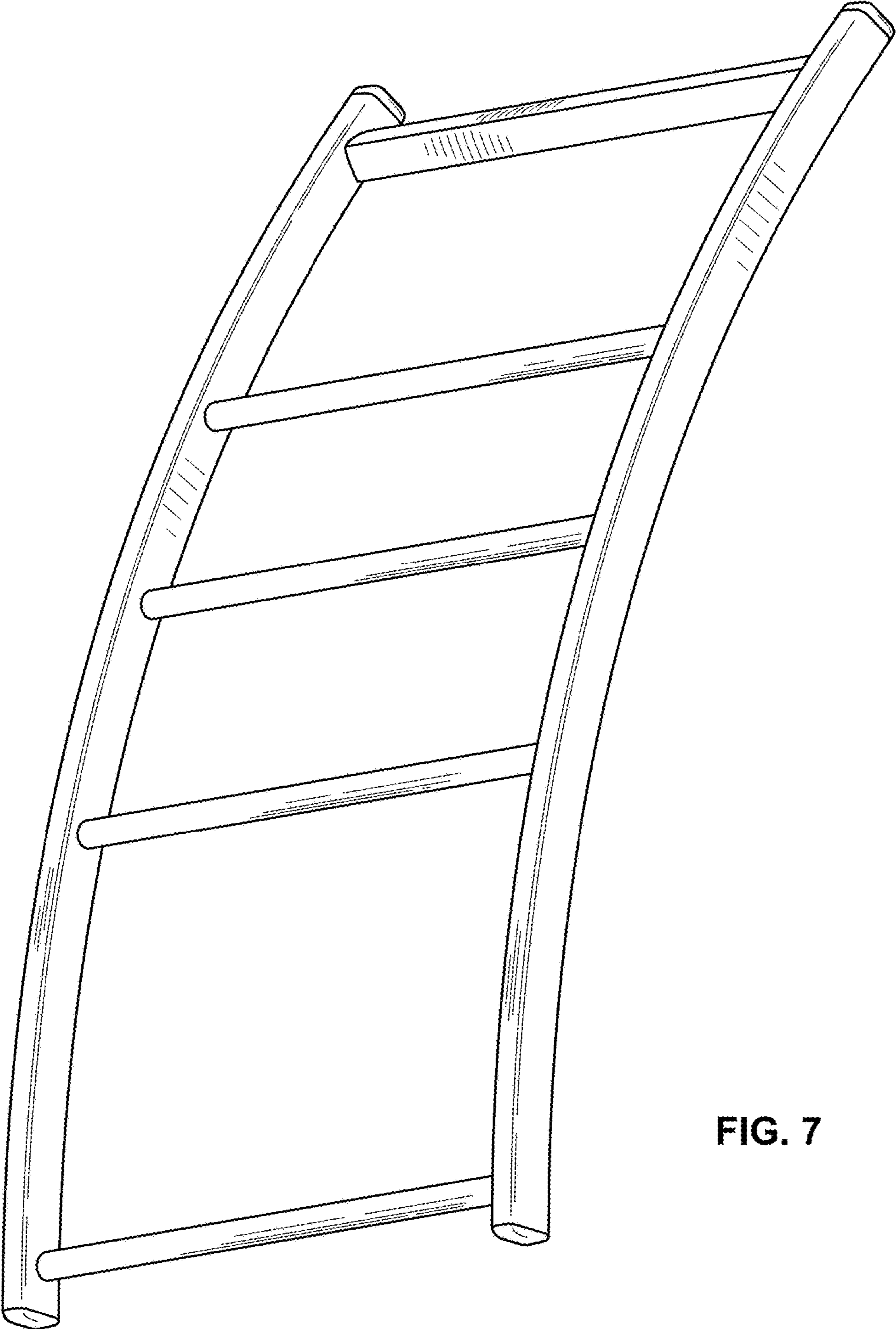

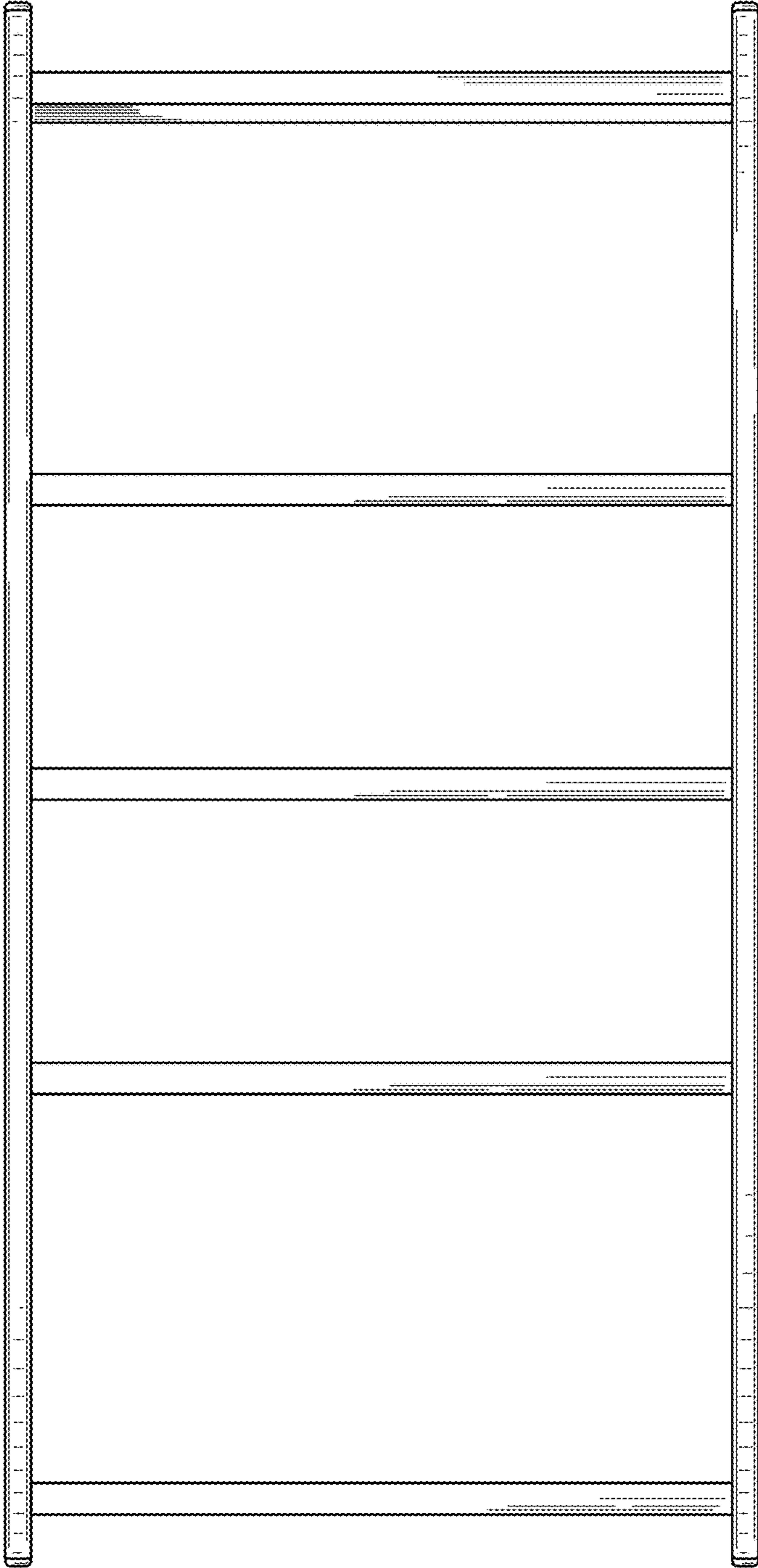

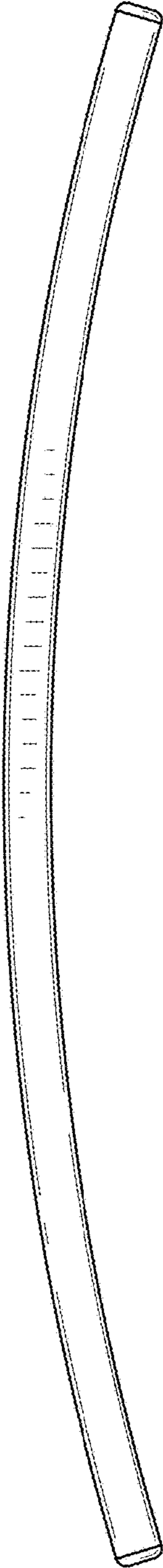
