(57) **CLAIM**

The ornamental design for the patient interface connector for
a patient interface assembly of a respiratory system, as
shown and described.

DESCRIPTION

FIG. 1 is a perspective view showing a patient interface
connector that can be connected to the nasal cannula body,
that embodies the design.

FIG. 2 is a front view of the patient interface connector of
FIG. 1.

FIG. 3 is a rear view of the patient interface connector of
FIG. 1.

FIG. 4 is a right side view of the patient interface connector
of FIG. 1.

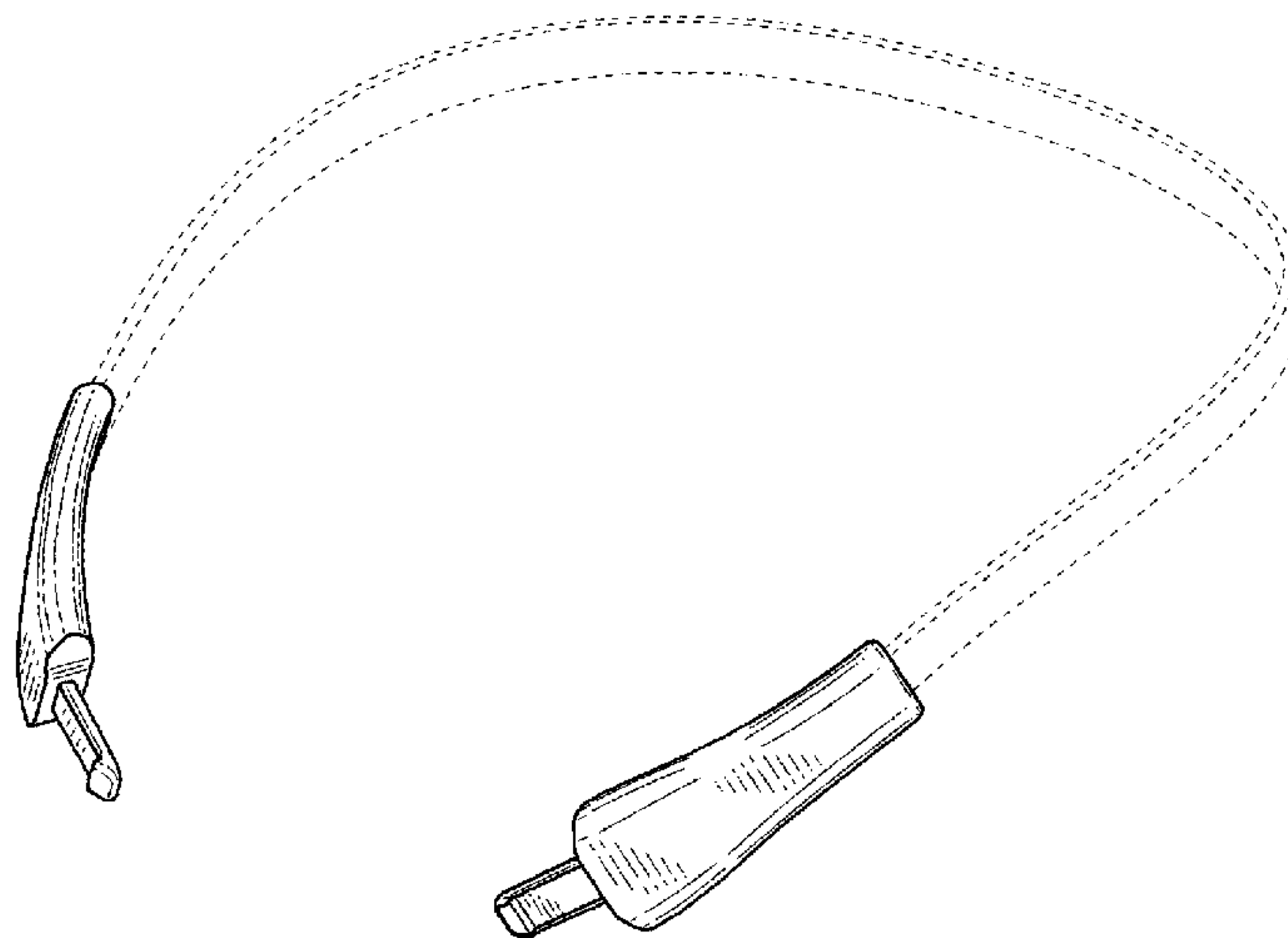
FIG. 5 is a left side view of the patient interface connector

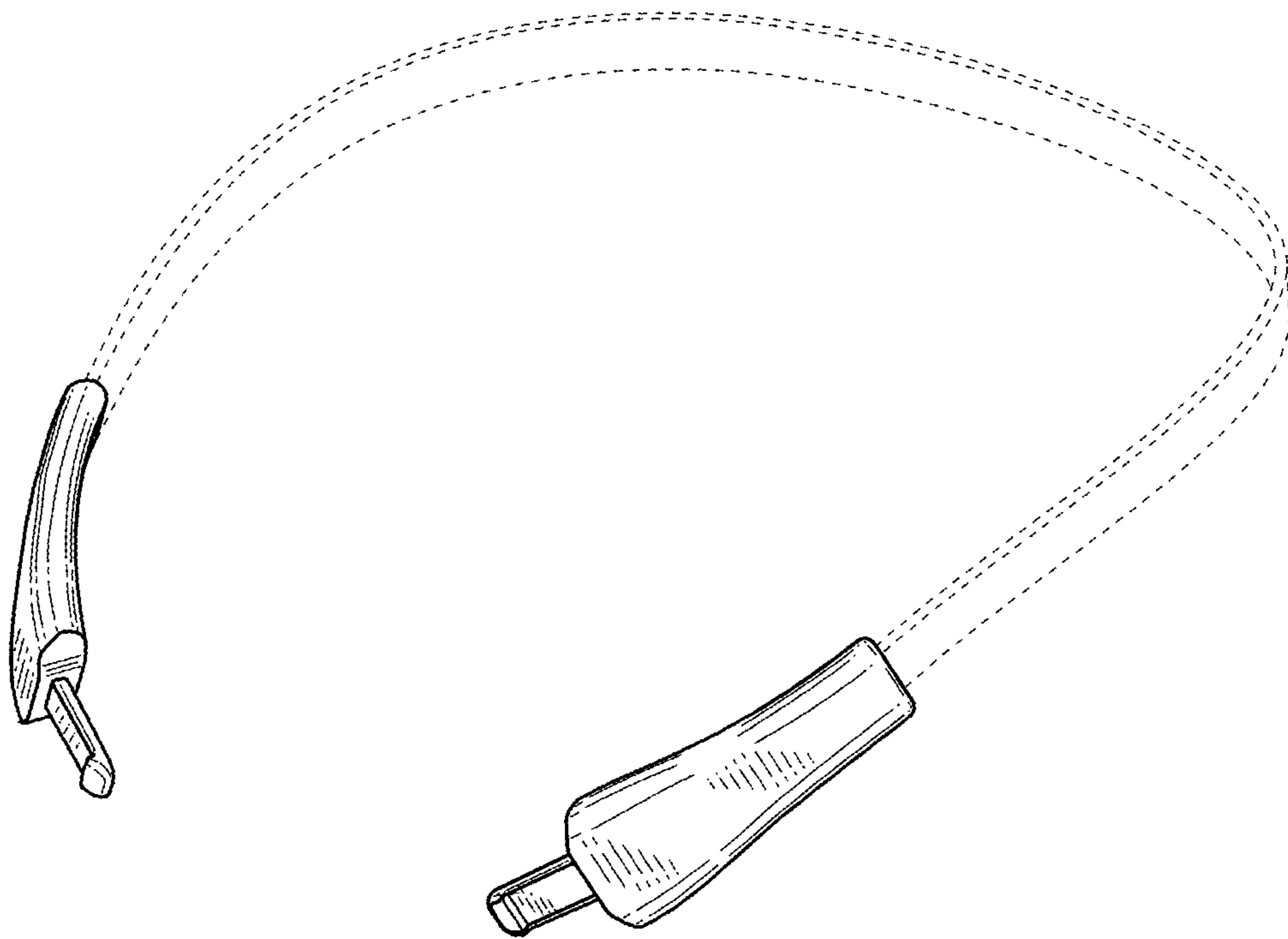

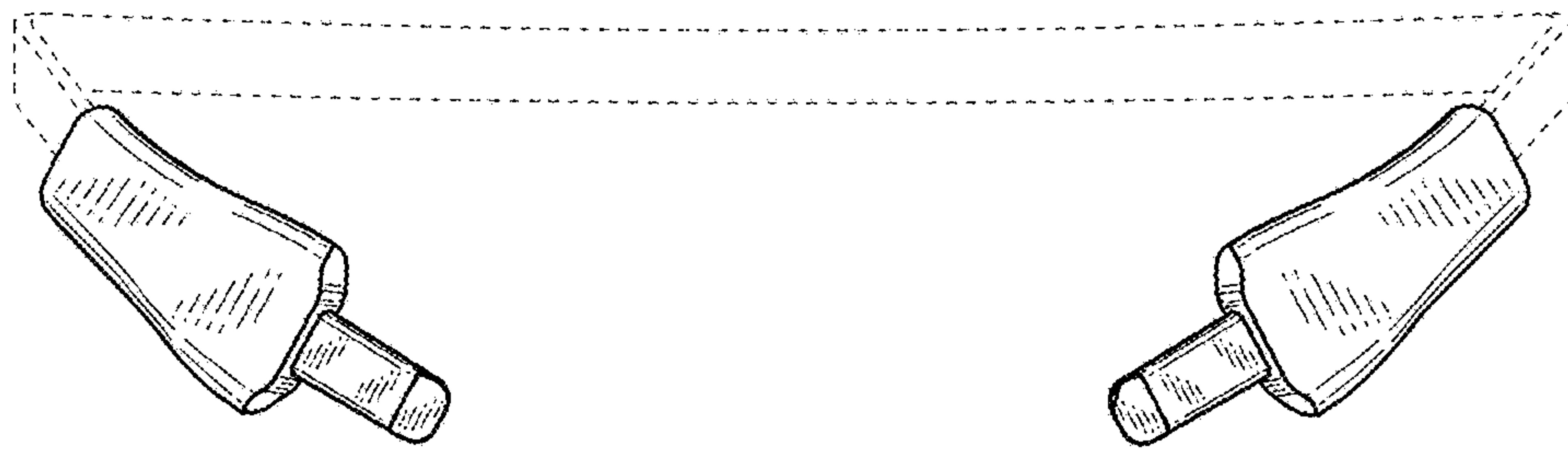

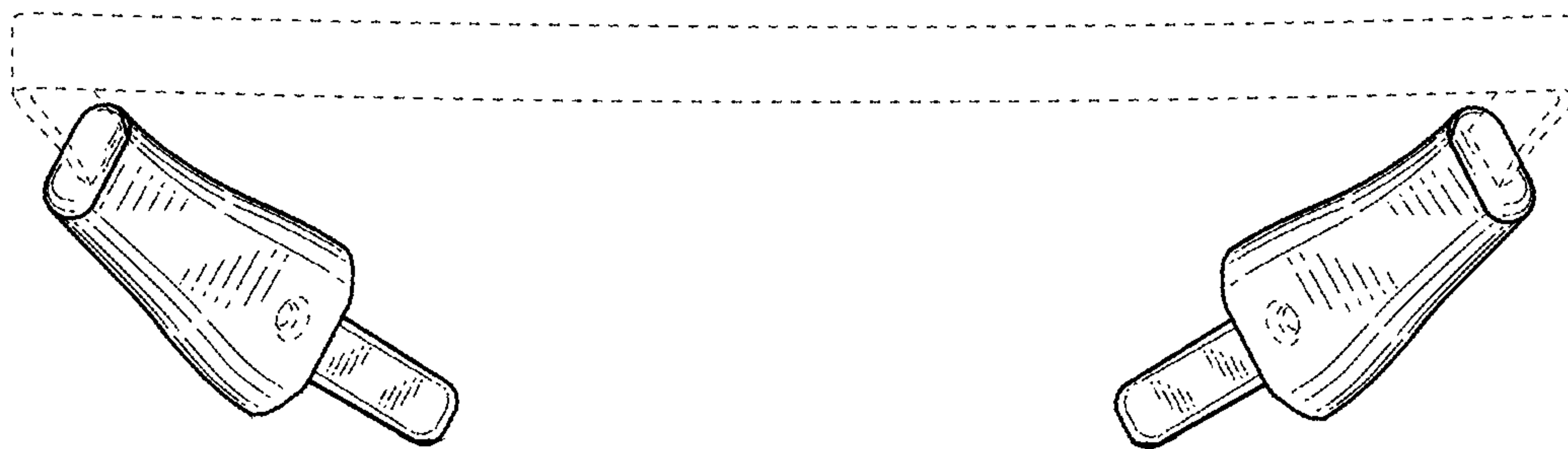

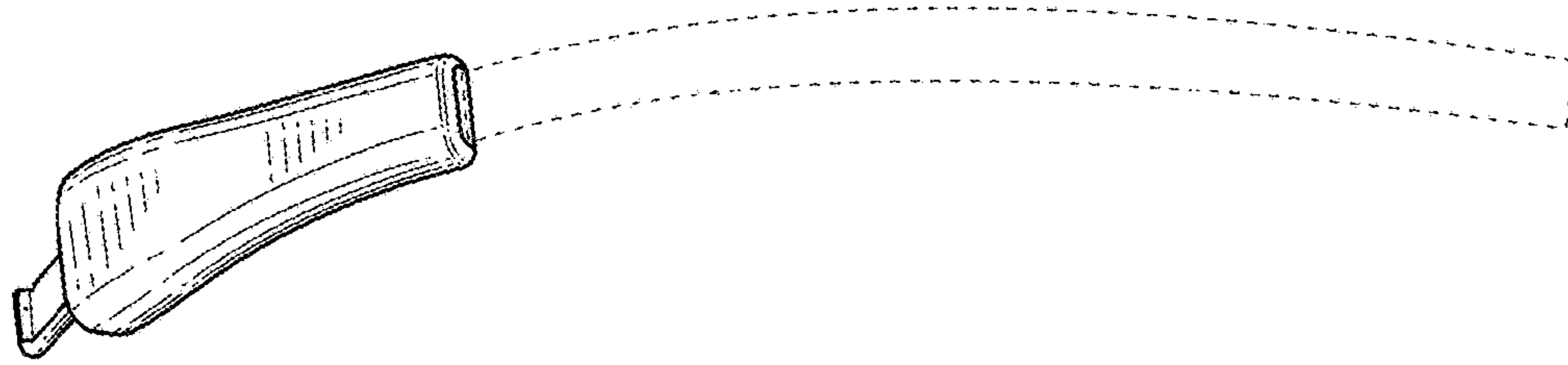

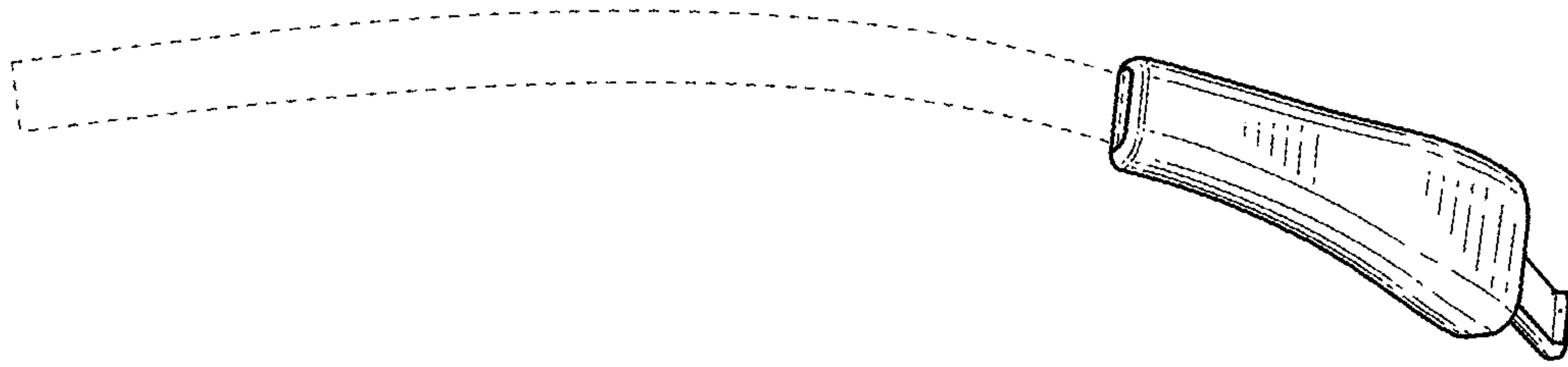

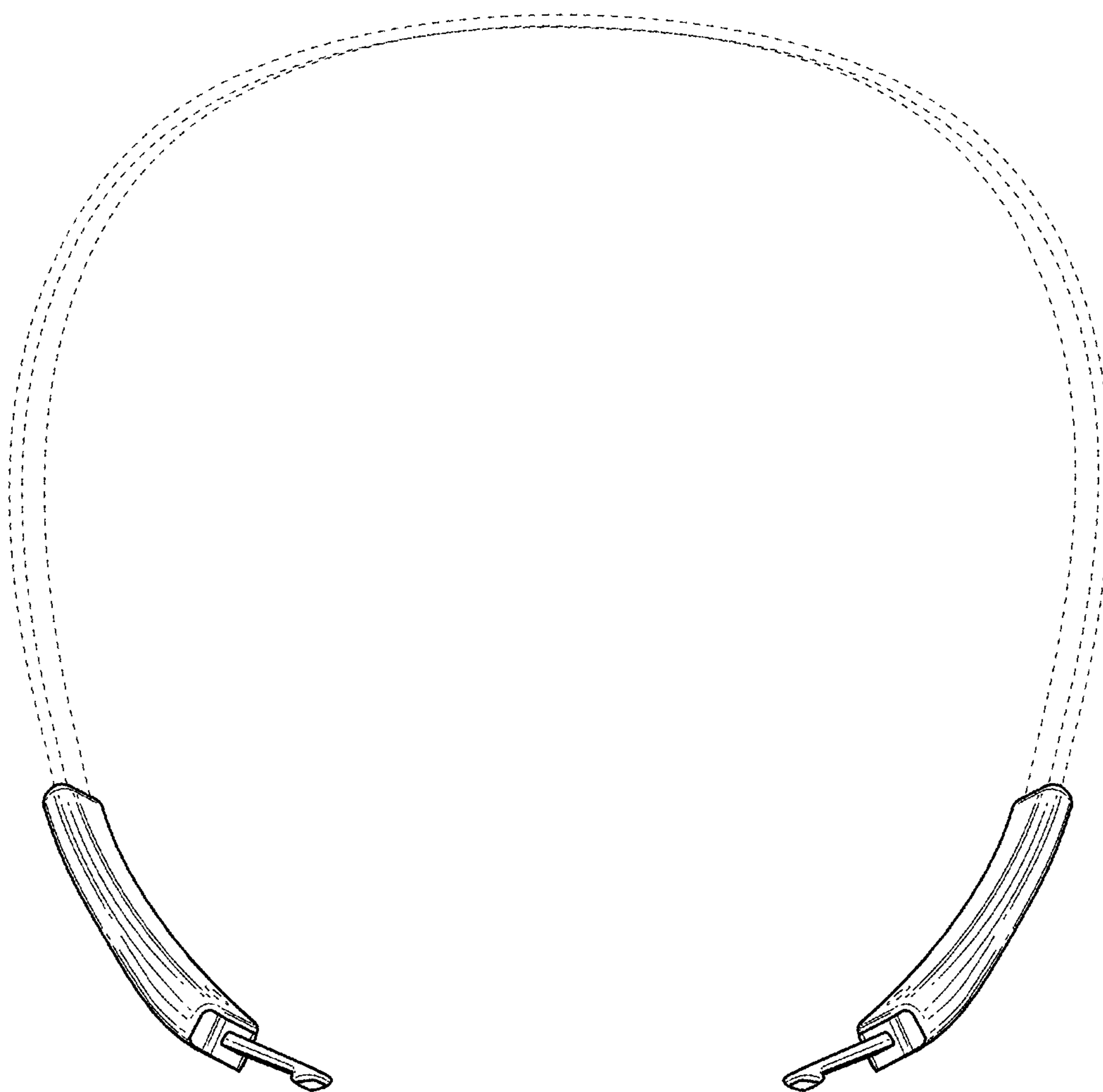
