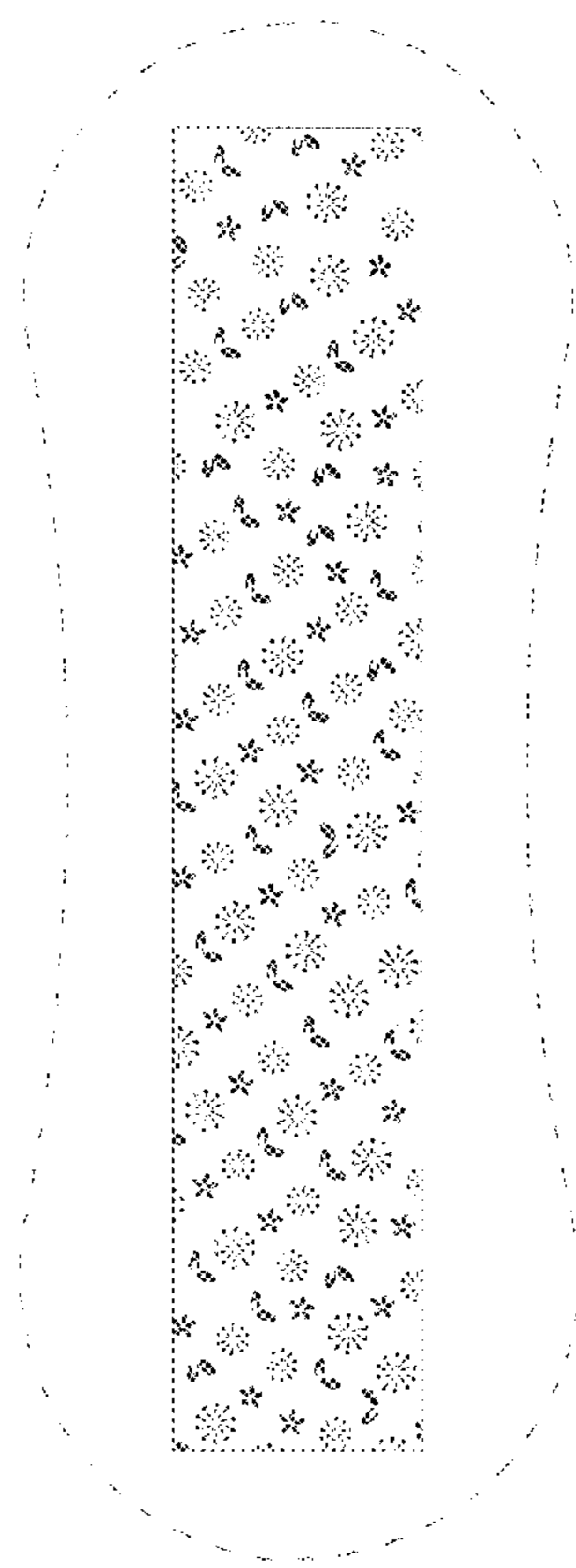
The ornamental design for a femine hygiene product, shown and described.

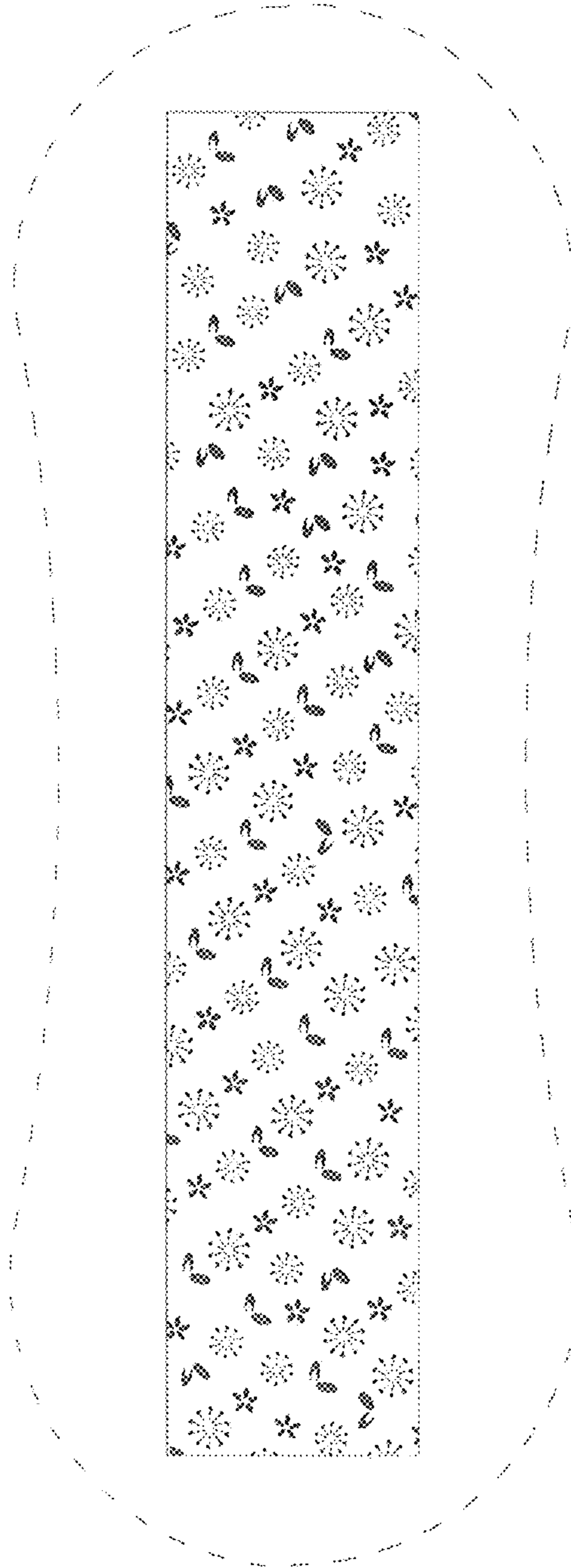

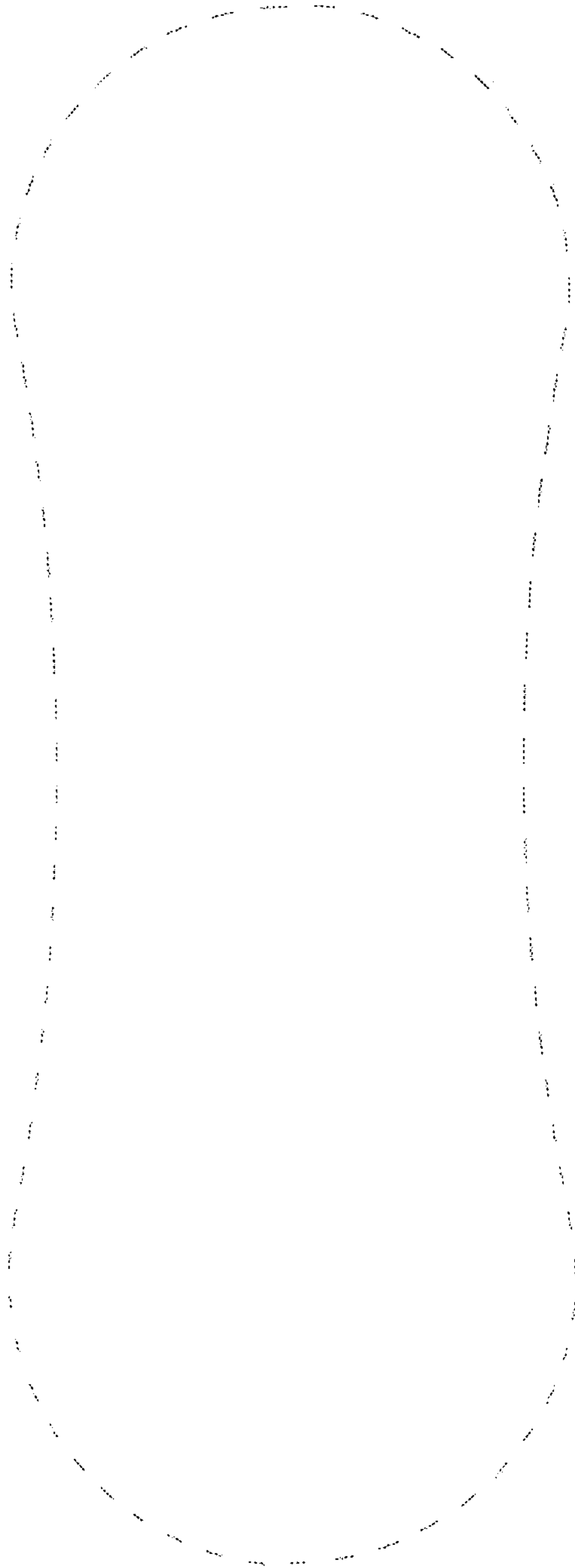

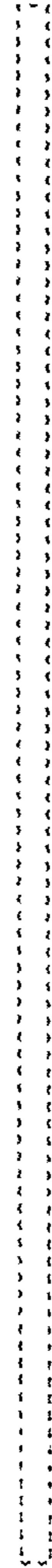
