
CLAIM

The ornamental design for a combined sun and architectural screen, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a combined sun and architectural screen showing our new design; FIG. 2 is a rear view thereof; FIG. 3 is a right side view thereof; FIG. 4 is a left side view thereof; FIG. 5 is a top plan view thereof; FIG. 6 is a bottom plan view thereof; FIG. 7 is an upper right front perspective view thereof; and FIG. 8 is an upper right front perspective view thereof, showing the combined sun and architectural screen in an environment of use.

The broken lines in FIGS. 1 through 8 showing the circular elements and the screen ends represent portions of the combined sun and architectural screen that form no part of the claimed design. The other broken lines in FIG. 8 illustrate environmental subject matter only and form no part of the claimed design.
















