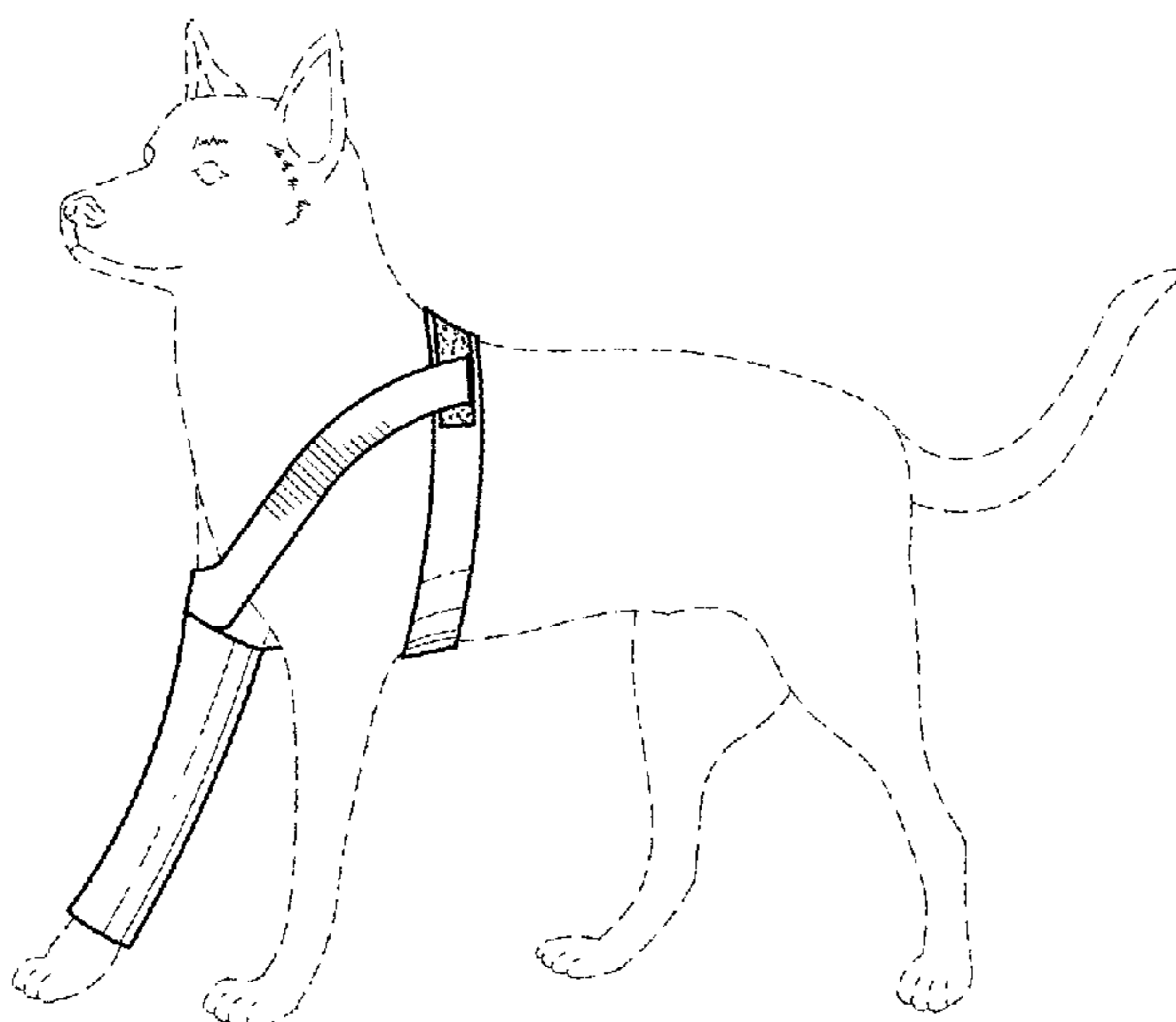
(57) **CLAIM**

The ornamental design for a protective sleeve for animals, as shown and described.

DESCRIPTION

FIG. 1 is a front, right perspective view of a protective sleeve for animals of the present invention shown on a dog; FIG. 2 is a front, left perspective view of the protective sleeve for animals of FIG. 1 shown on a dog; FIG. 3 is a front side elevation view of the protective sleeve for animals of FIG. 1 shown on a dog; FIG. 4 is a top plan view of the protective sleeve for animals of FIG. 1 shown on a dog; FIG. 5 an enlarged right side elevation view of the protective sleeve for animals of FIG. 1 shown removed from the dog to clarity of disclosure; and, FIG. 6 an enlarged left side elevation view of the protective sleeve for animals of FIG. 1. The shaded rectangular features, best seen in FIG. 6 represent hook-and-loop fasteners. In FIGS. 1-4, the broken line showing of a dog depicts environmental subject matter only and form no part of the claimed design. In FIGS. 1, 4, 5 and 6, the broken lines on the protective sleeve depict stitching that forms part of the claimed design.

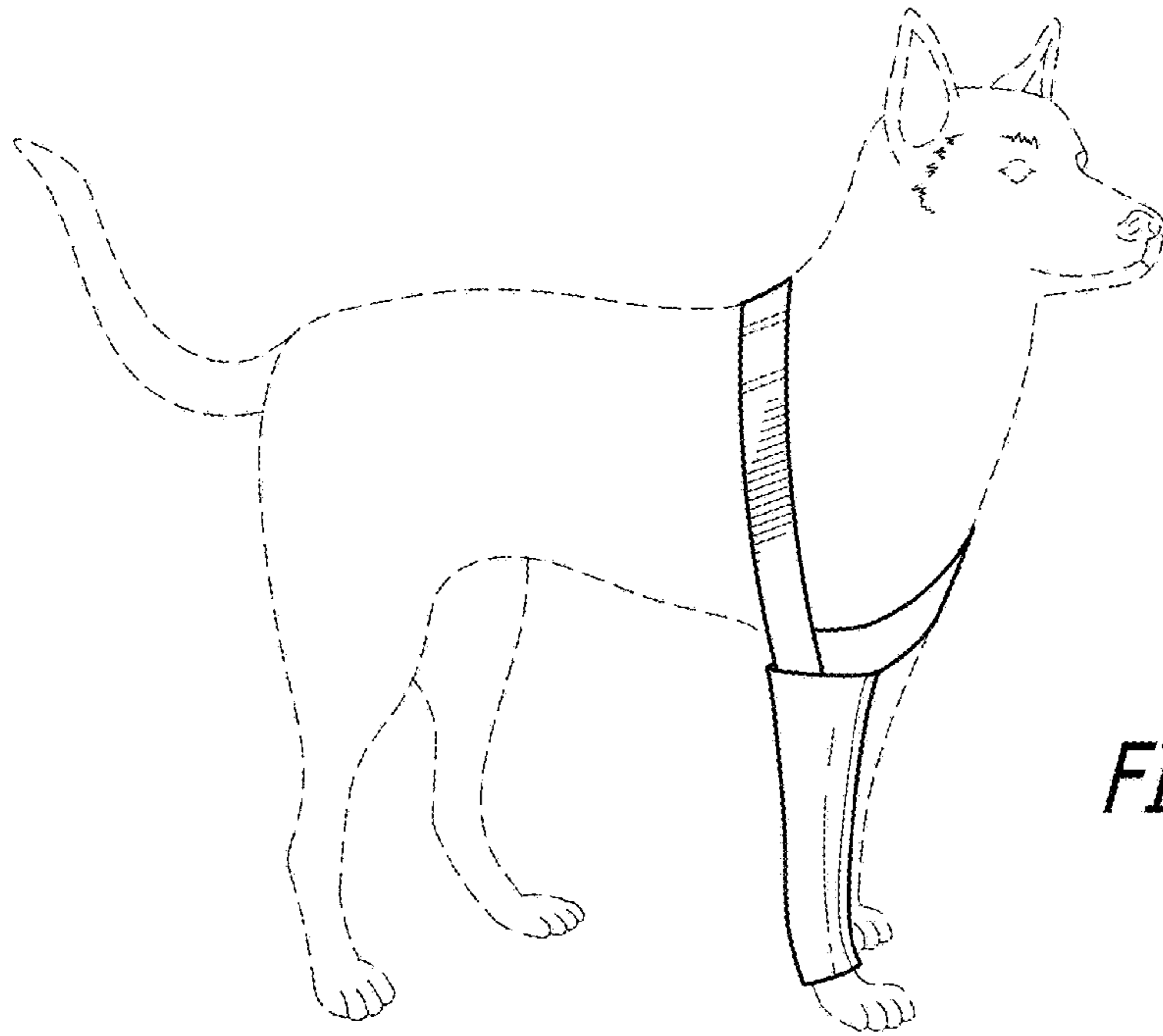

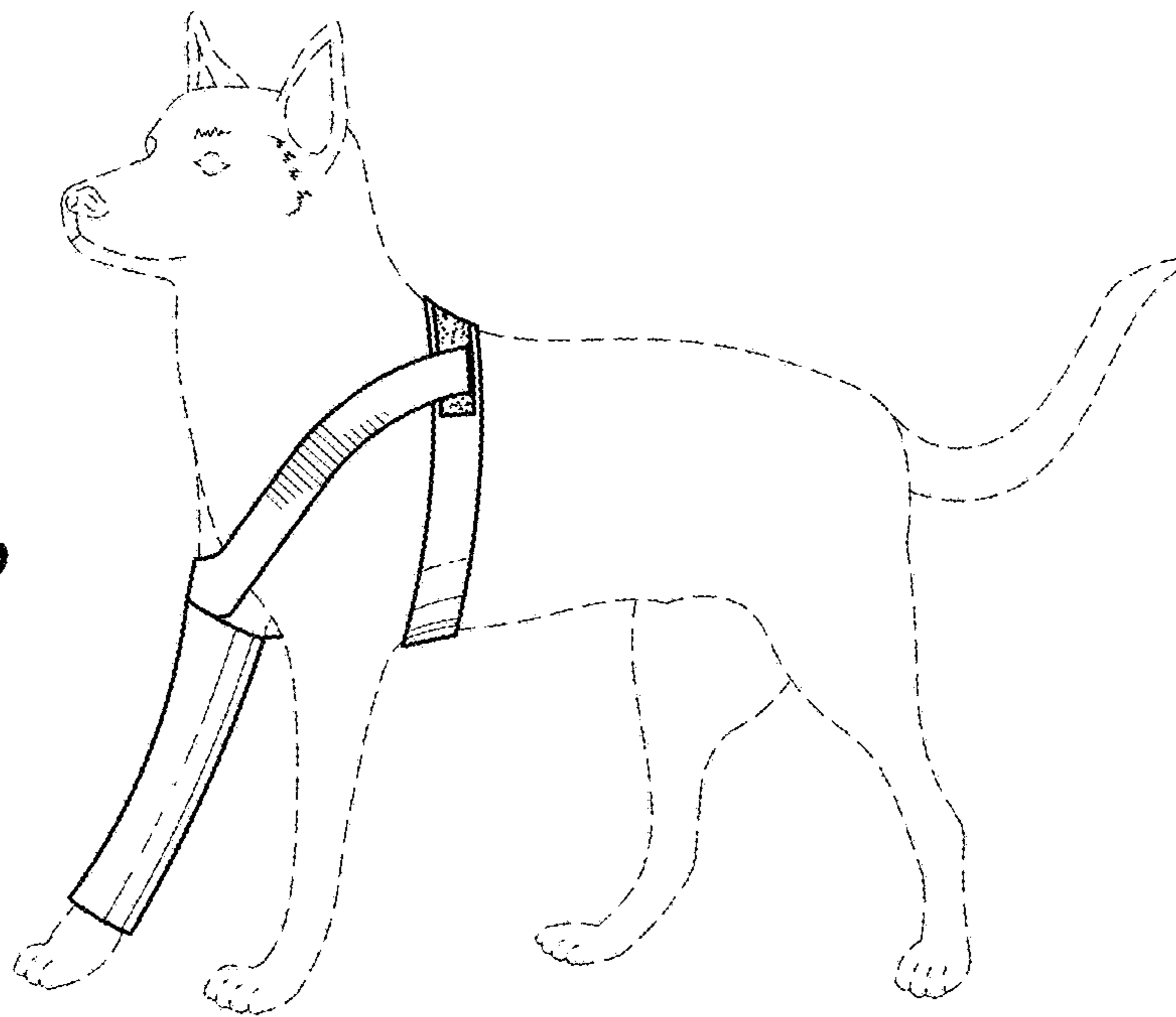

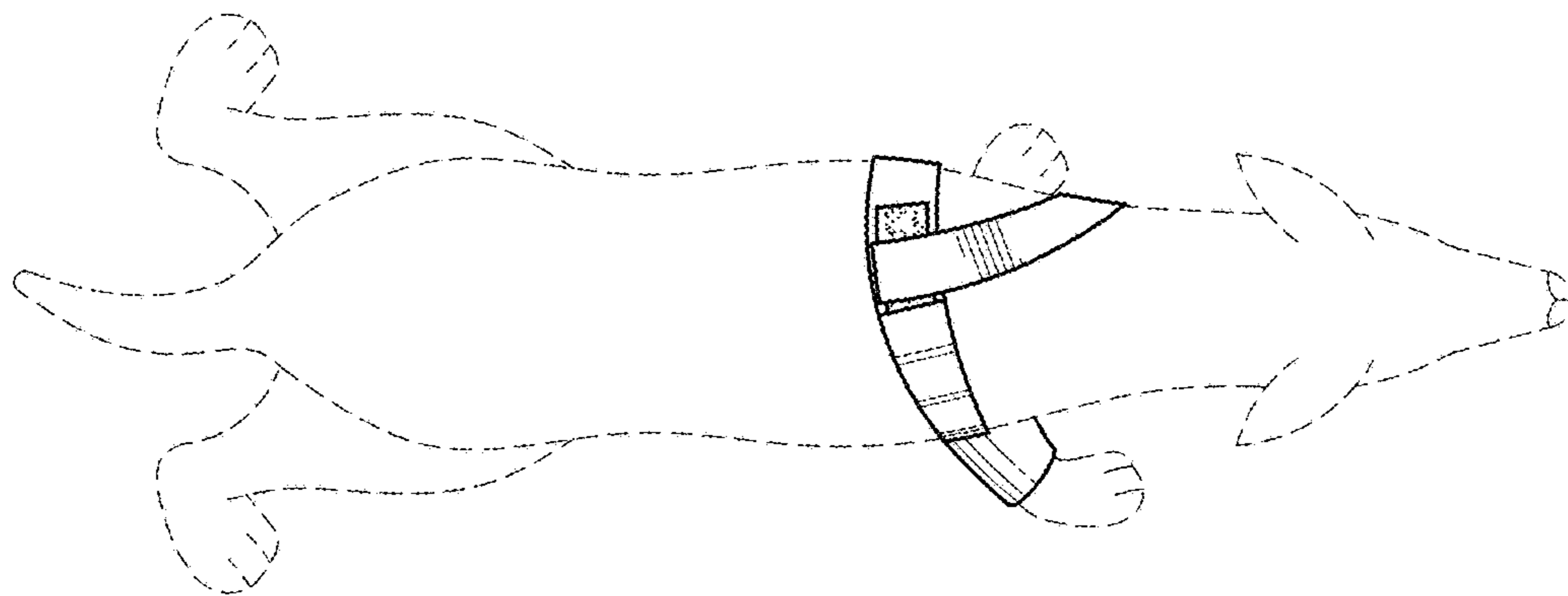
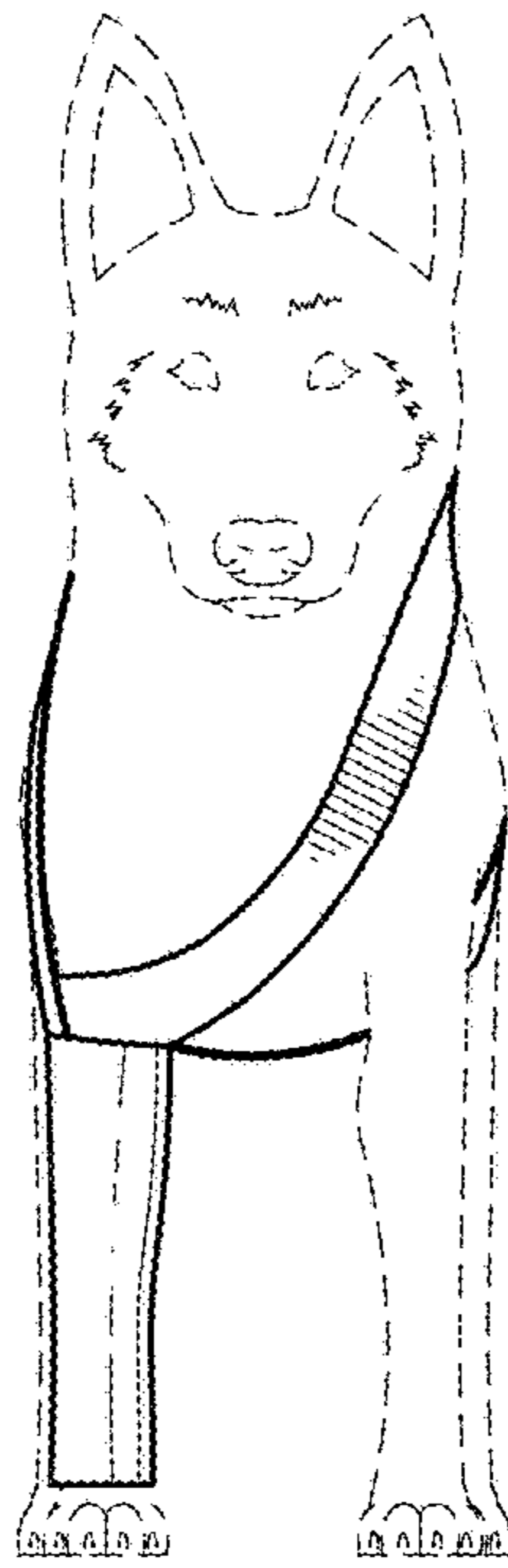

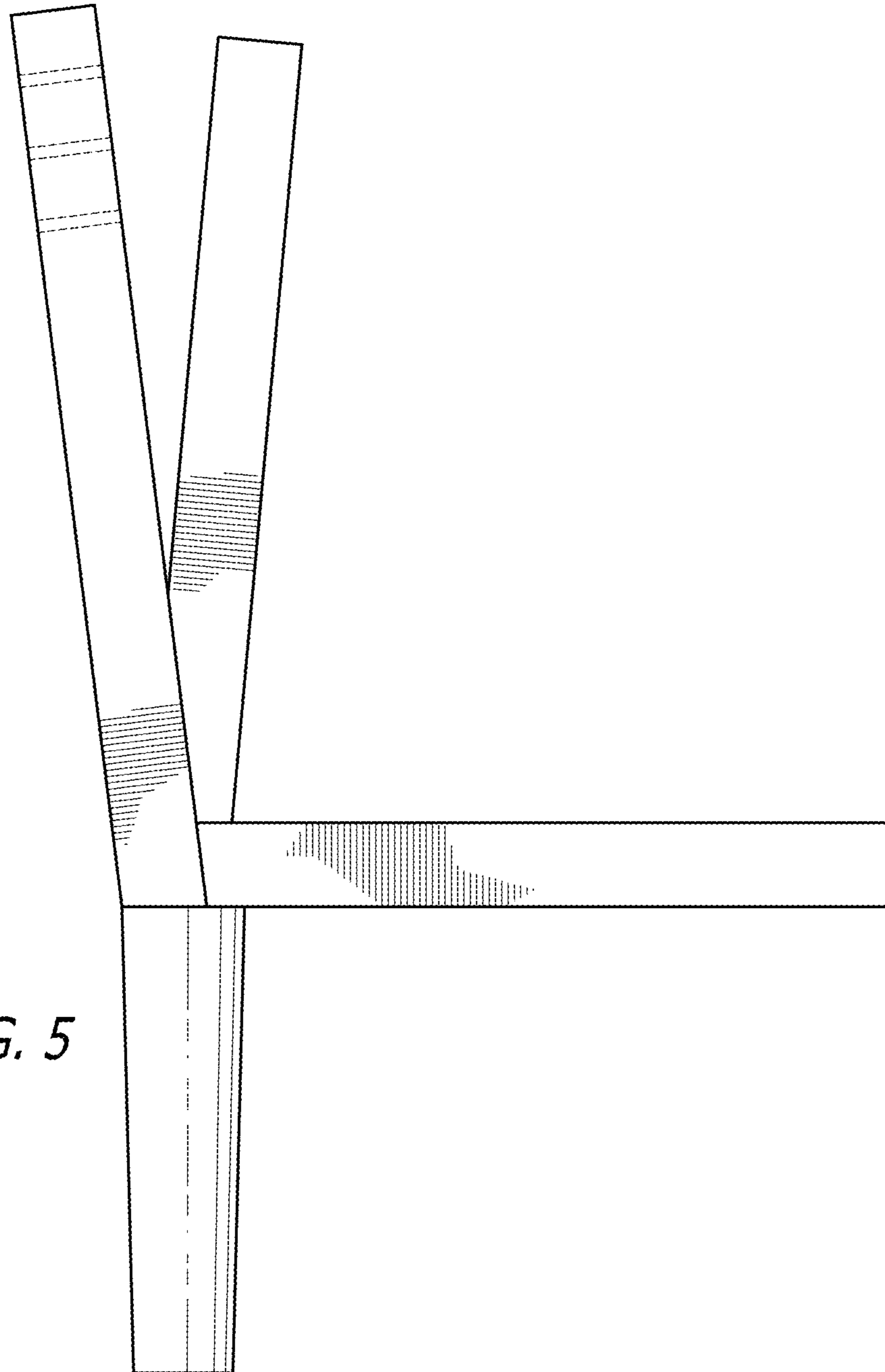

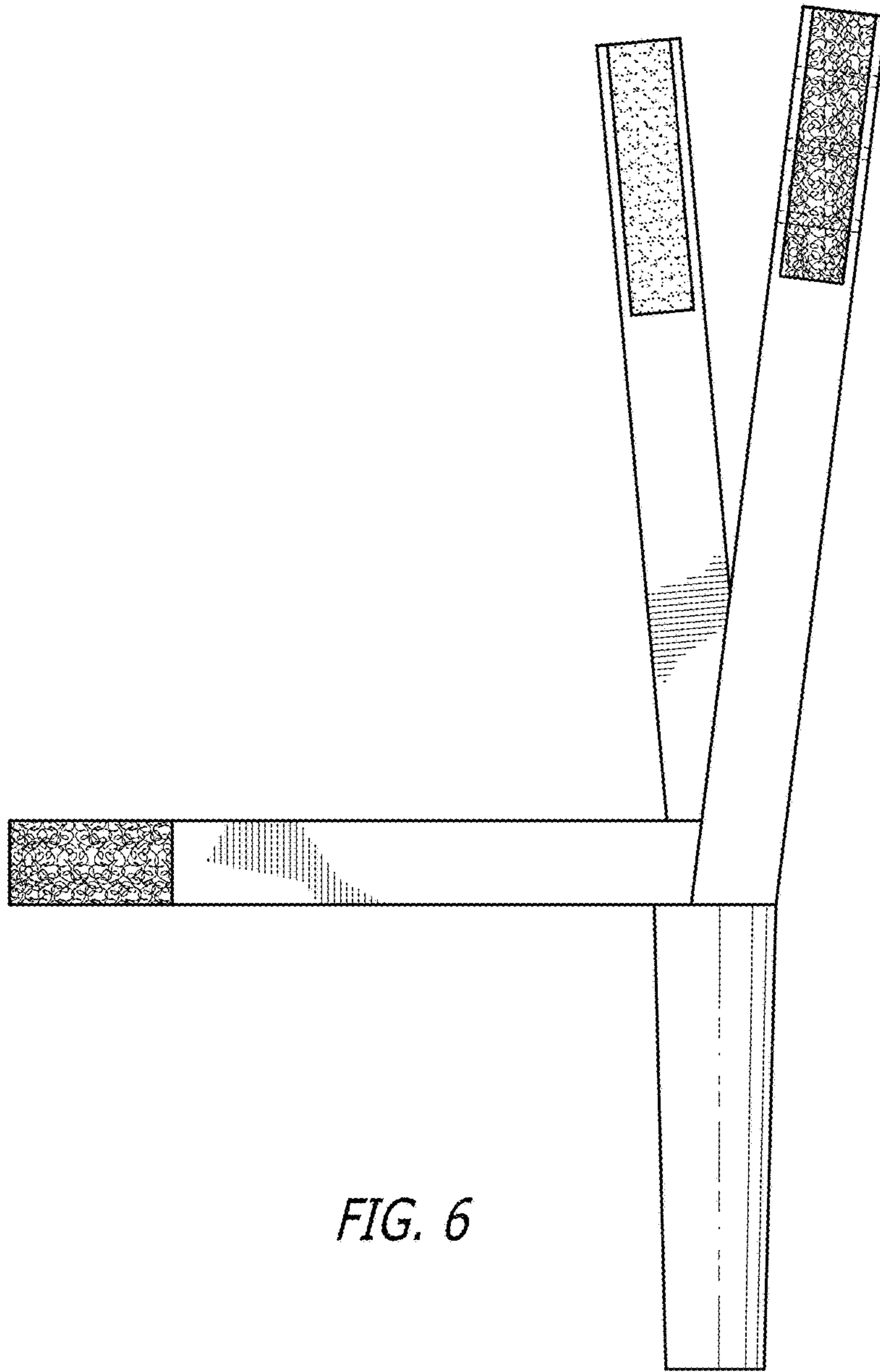
