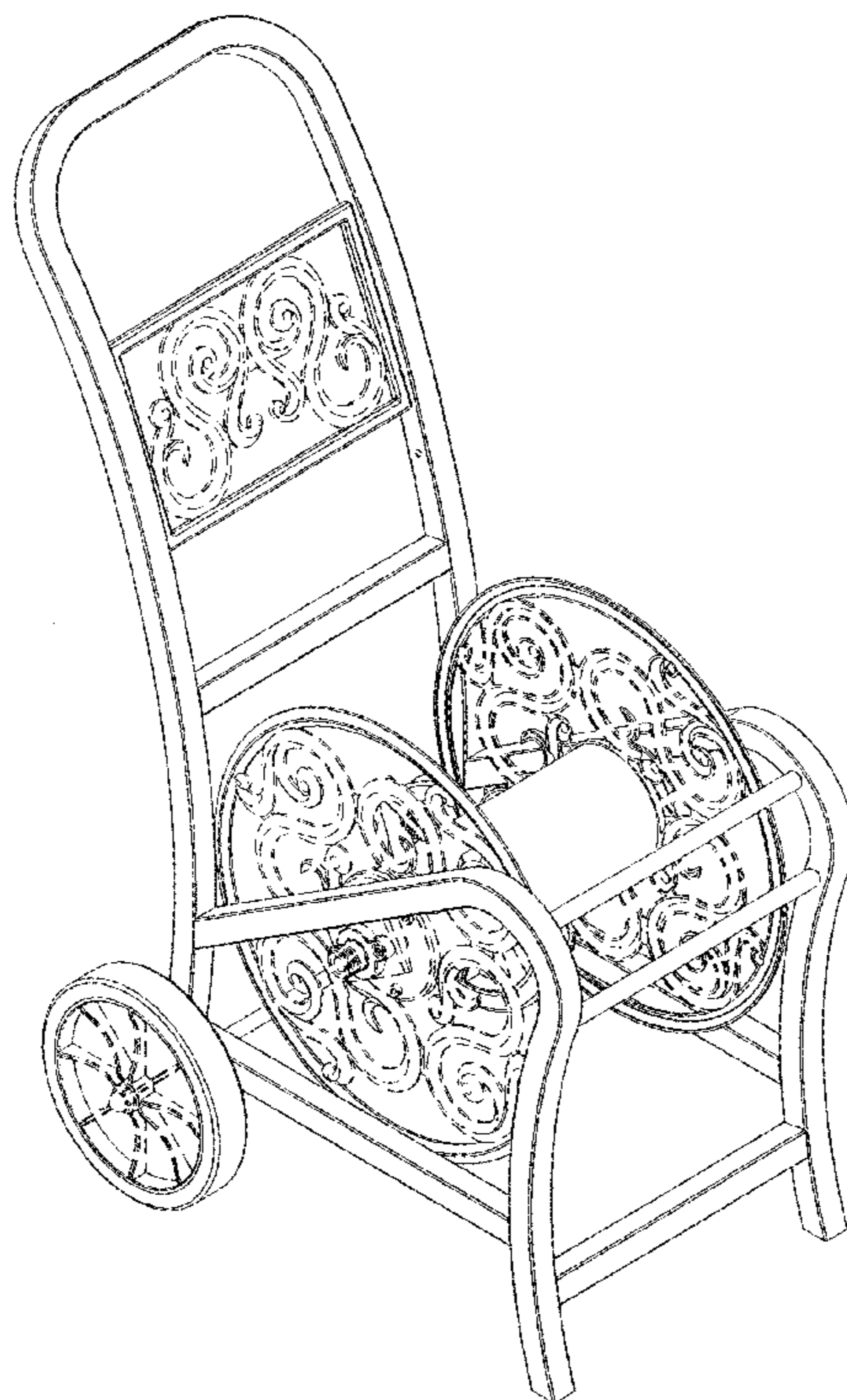
FIG. 1 is a top left perspective view of the hose reel cart of the present invention;

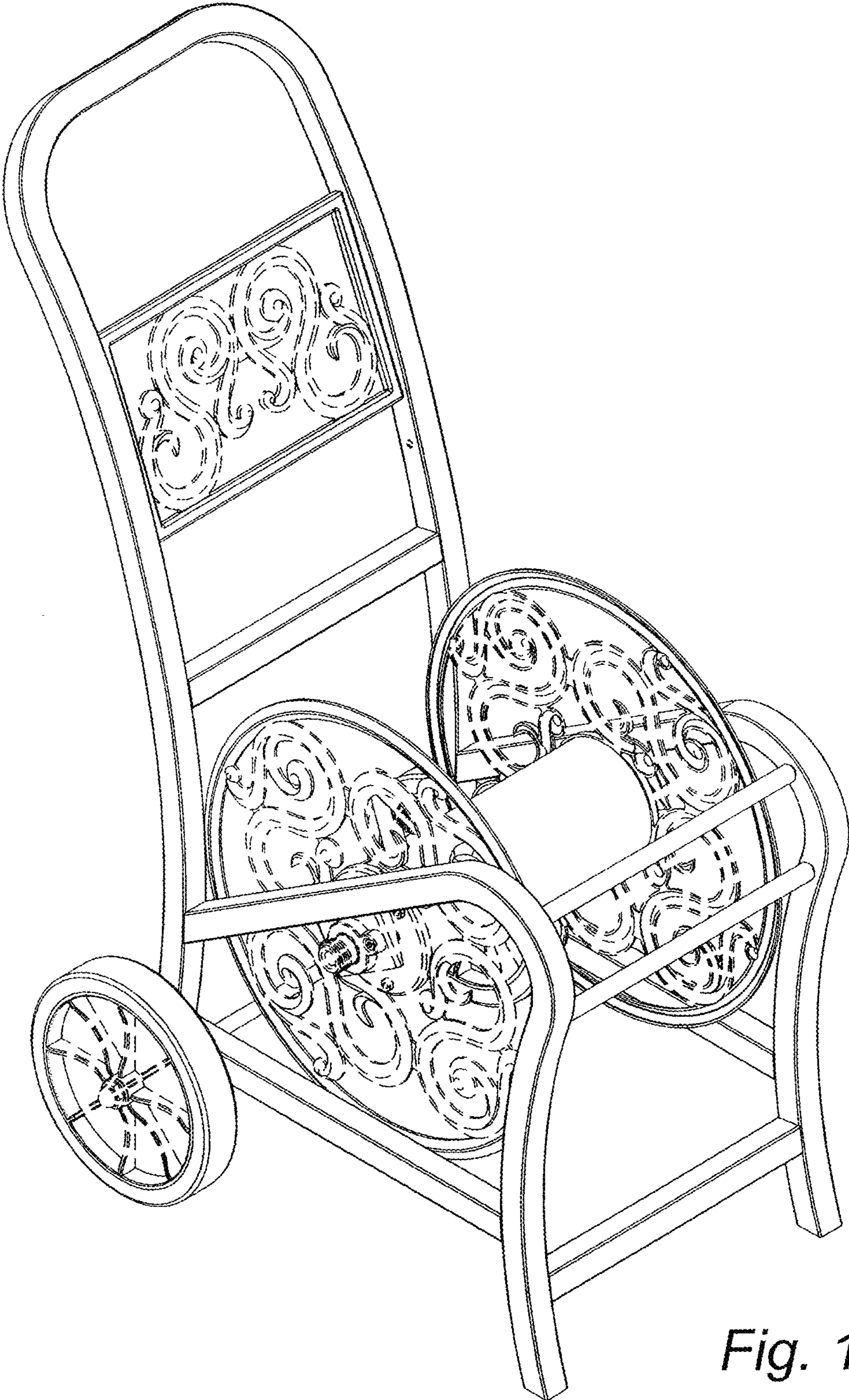

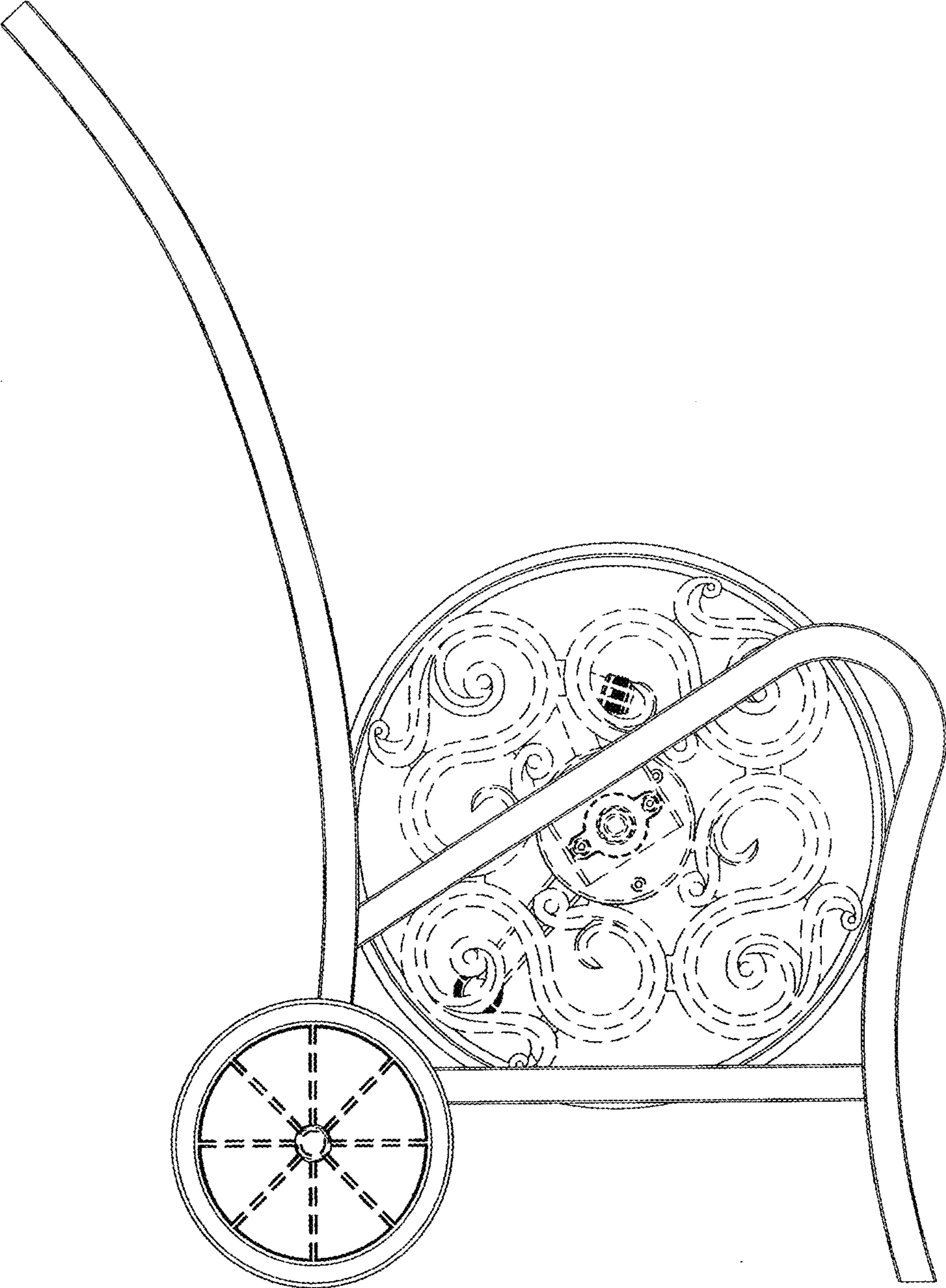

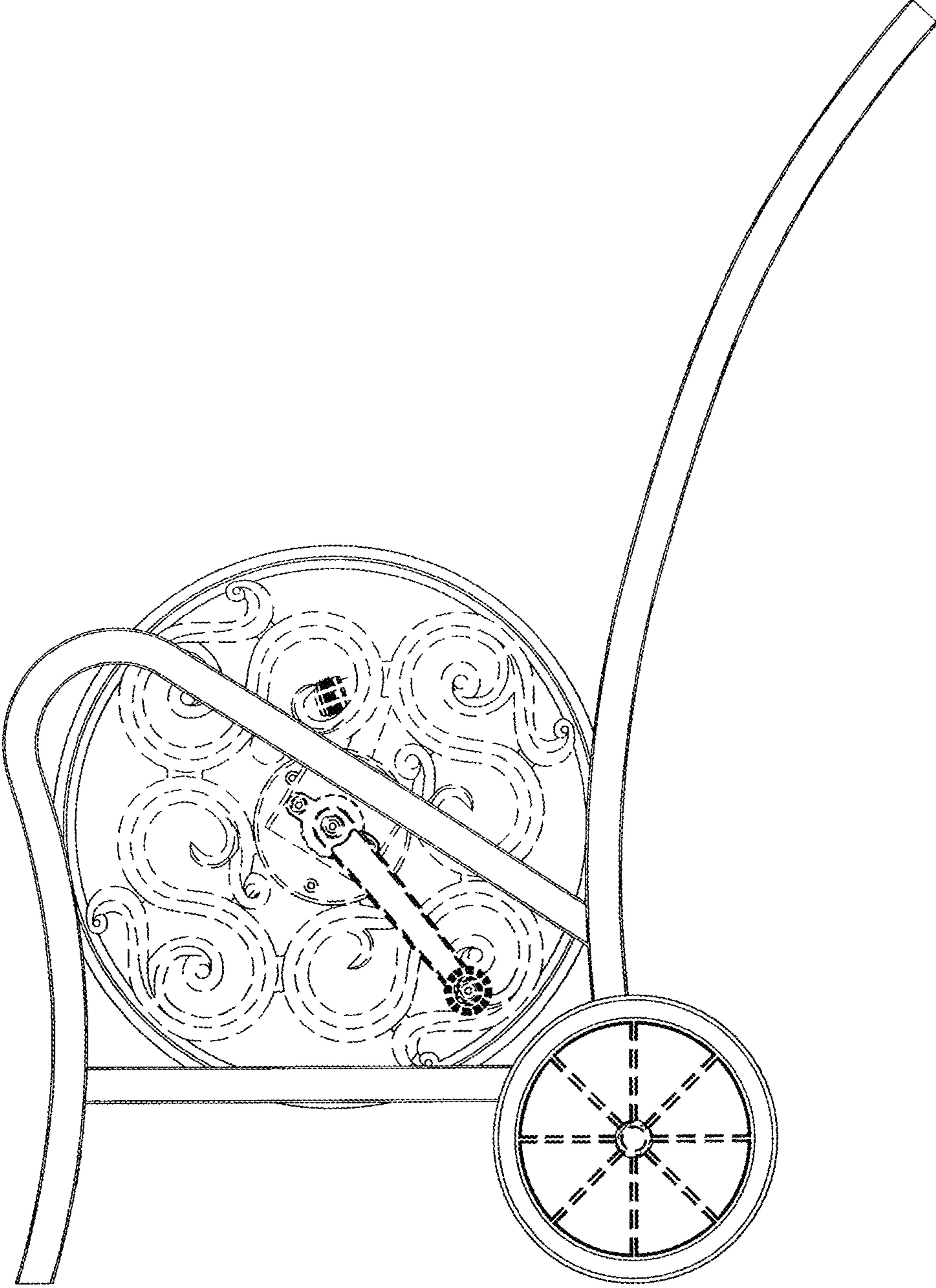

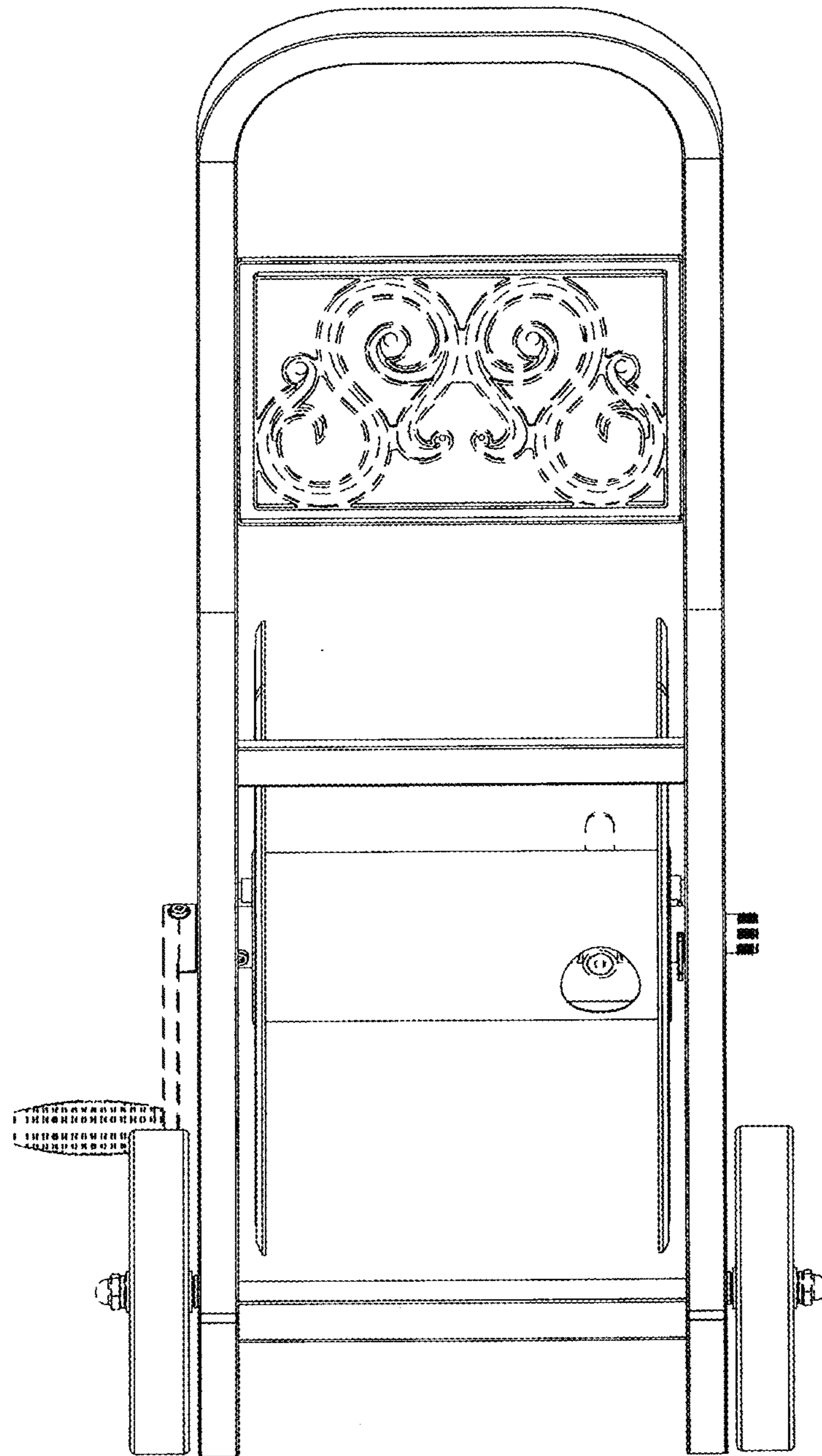

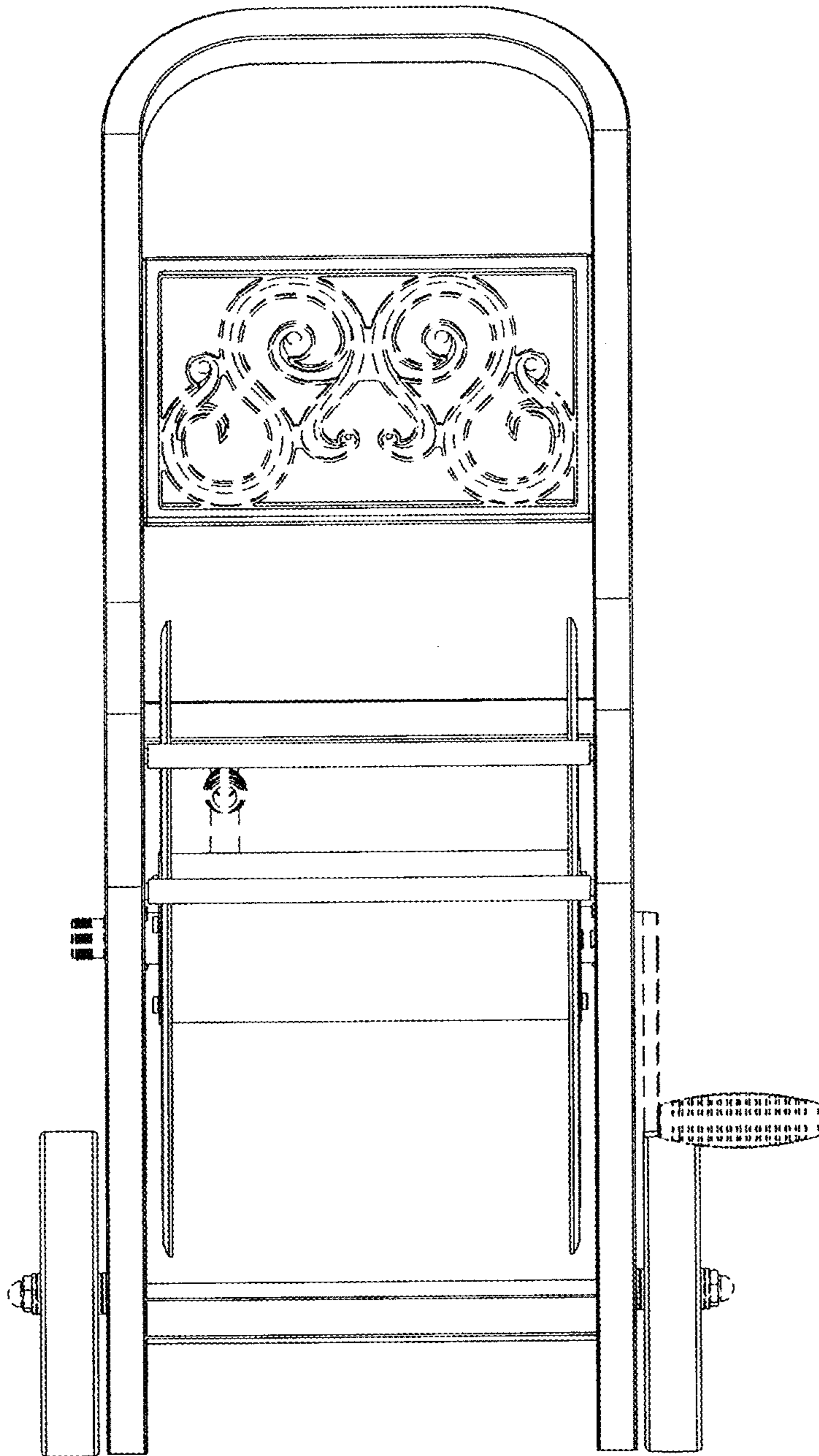

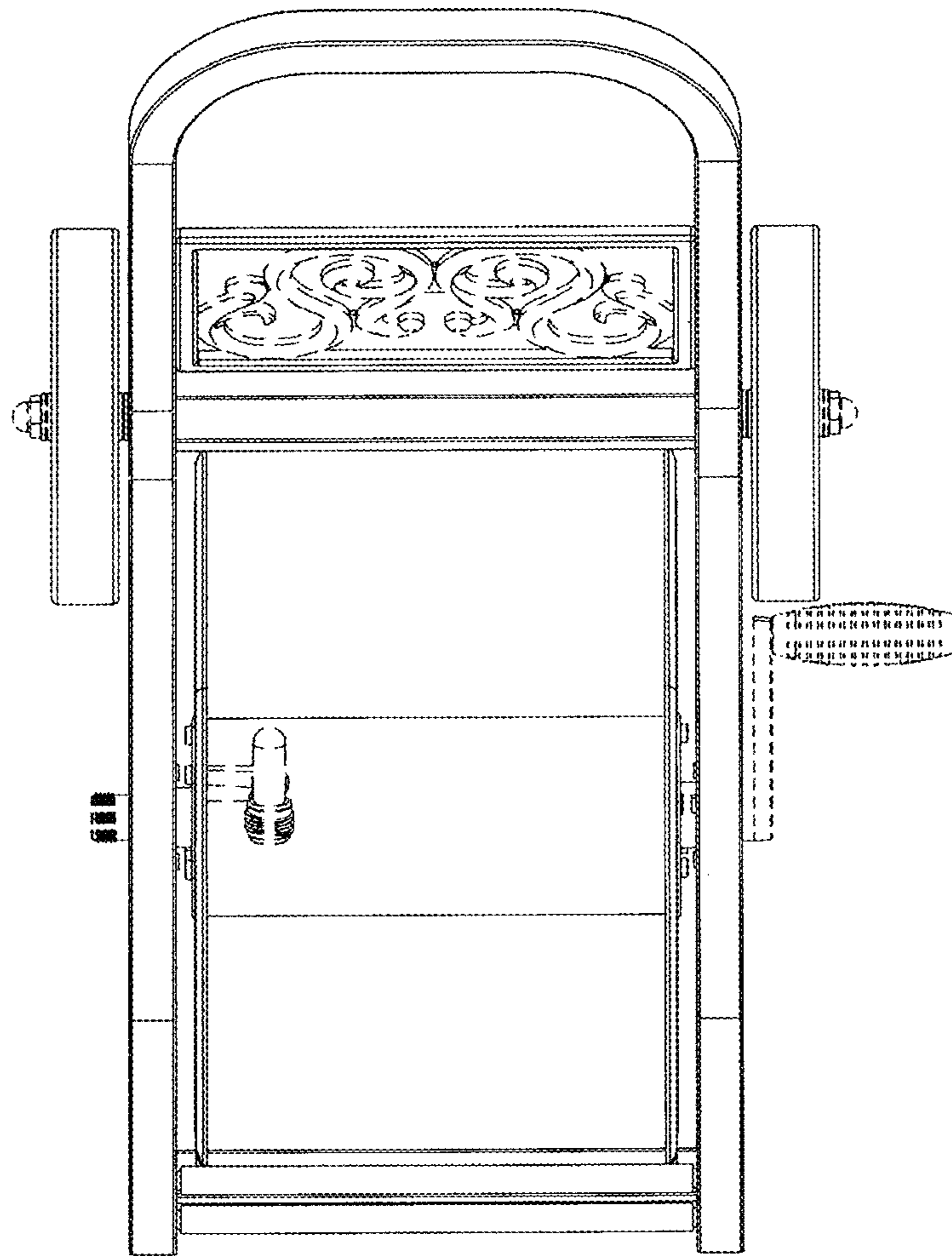

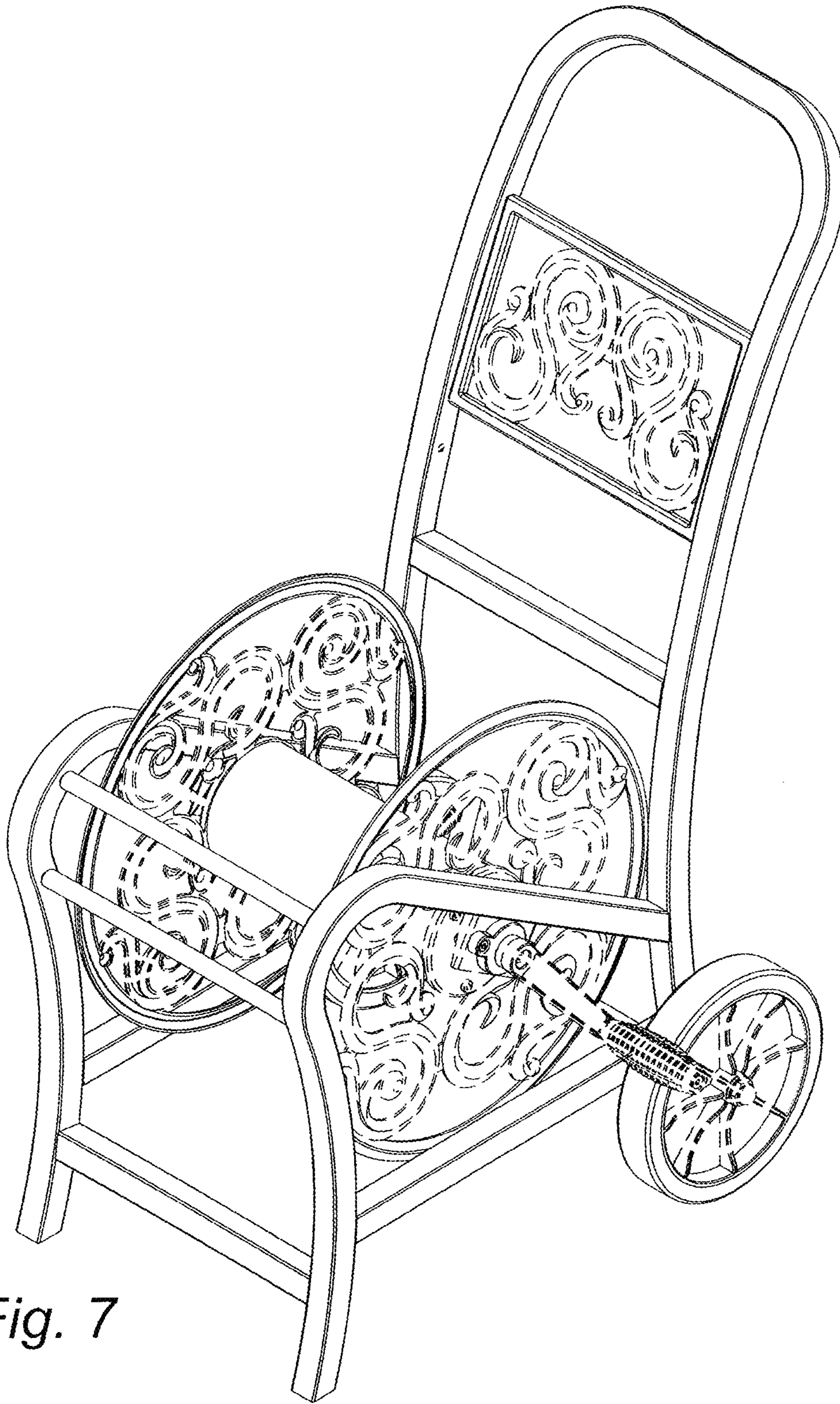

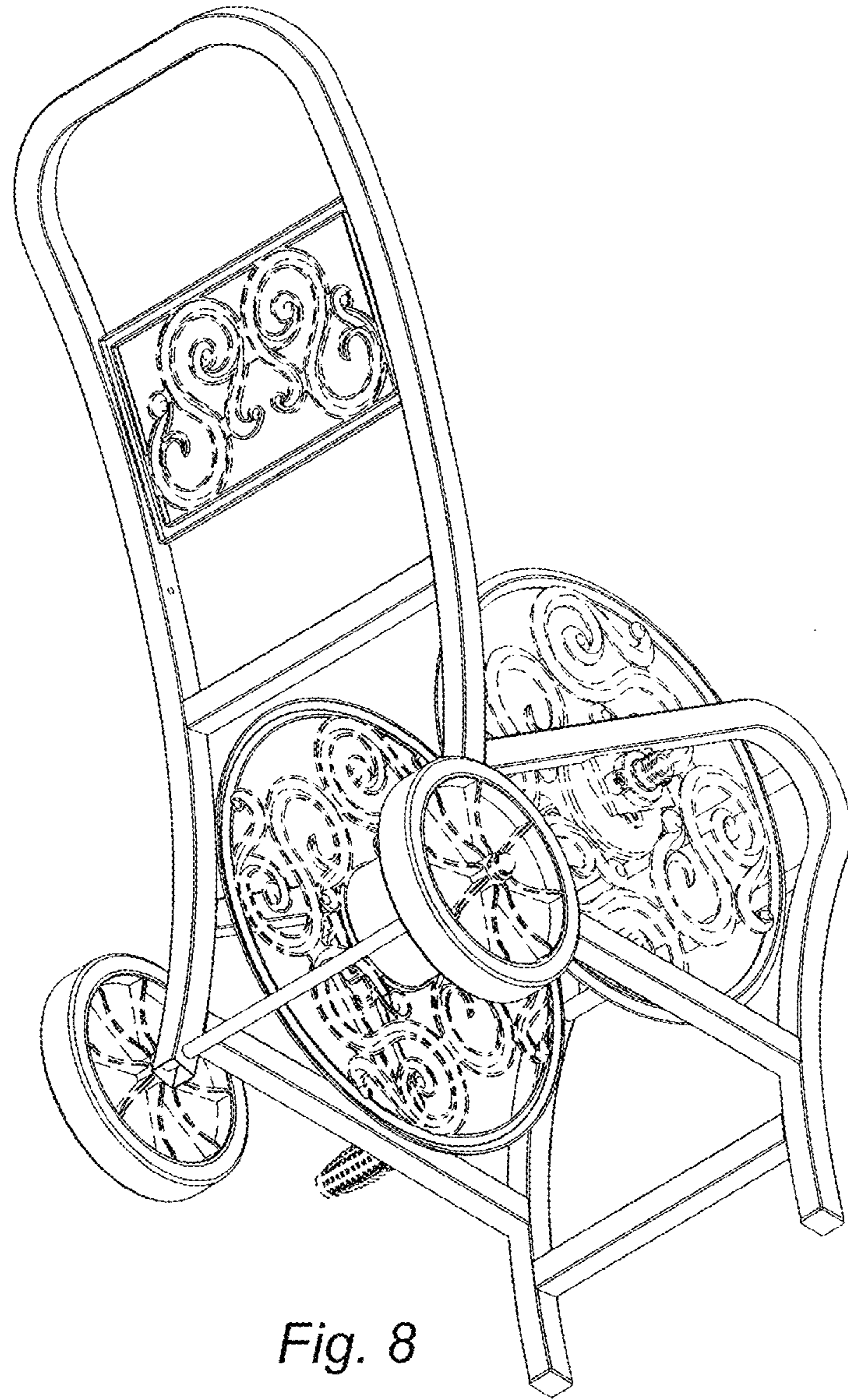
