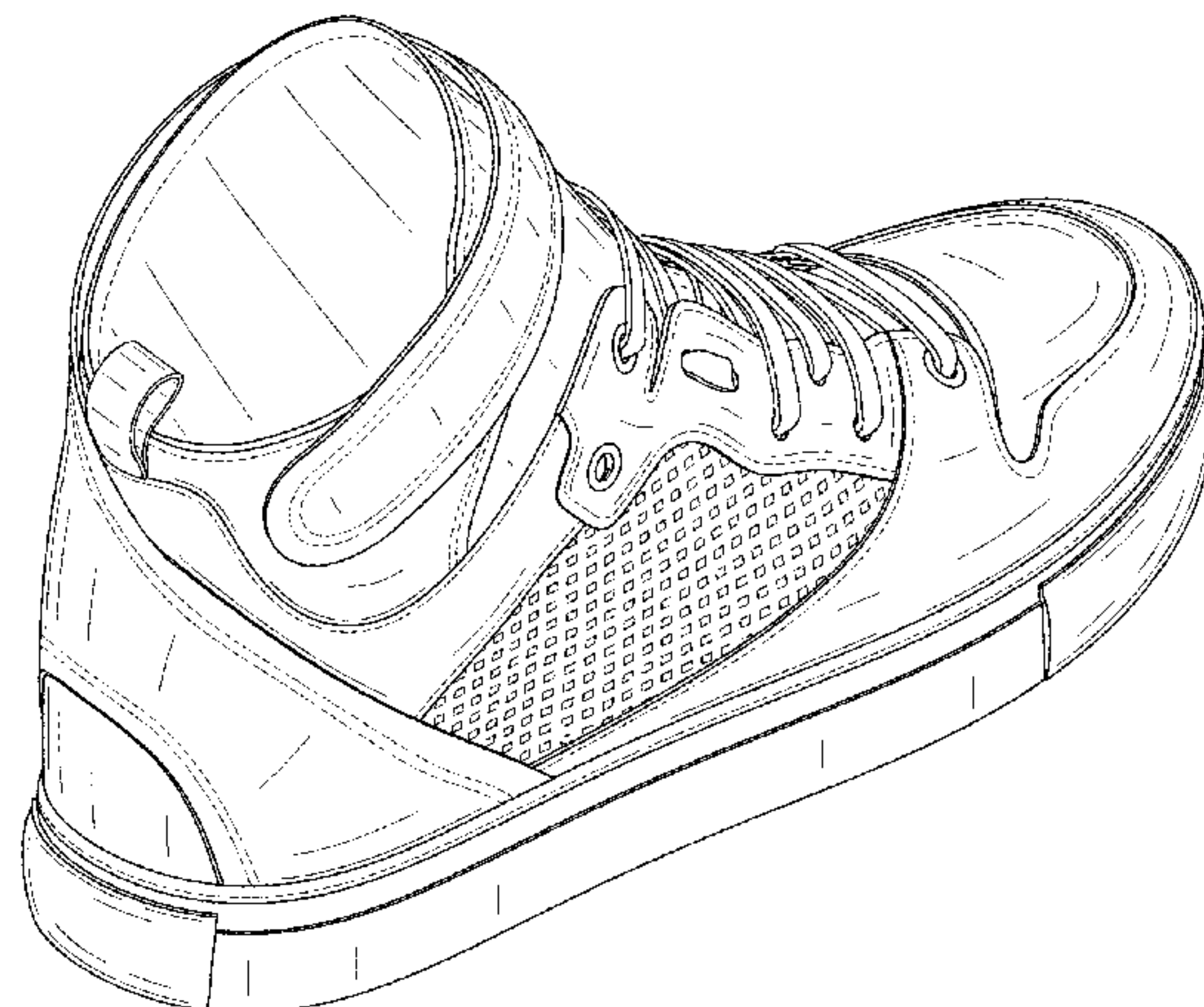
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front right perspective view of a shoe showing my new design;

 FIG. 5 is a top view thereof;
 FIG. 6 is a bottom view thereof;

 FIG. 10 is a rear view thereof.
 The portions of the shoe shown in broken lines represent thread stitching.

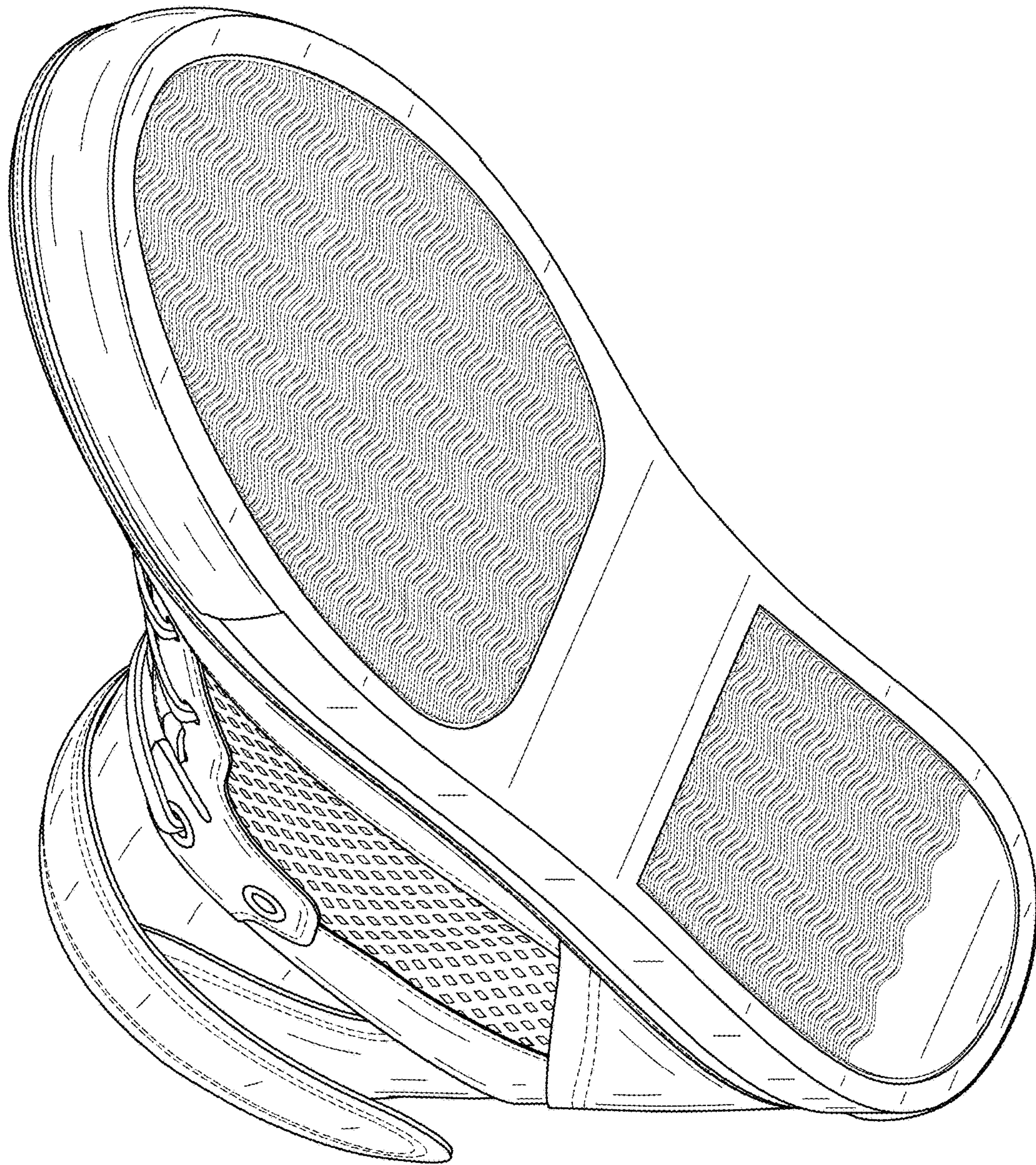

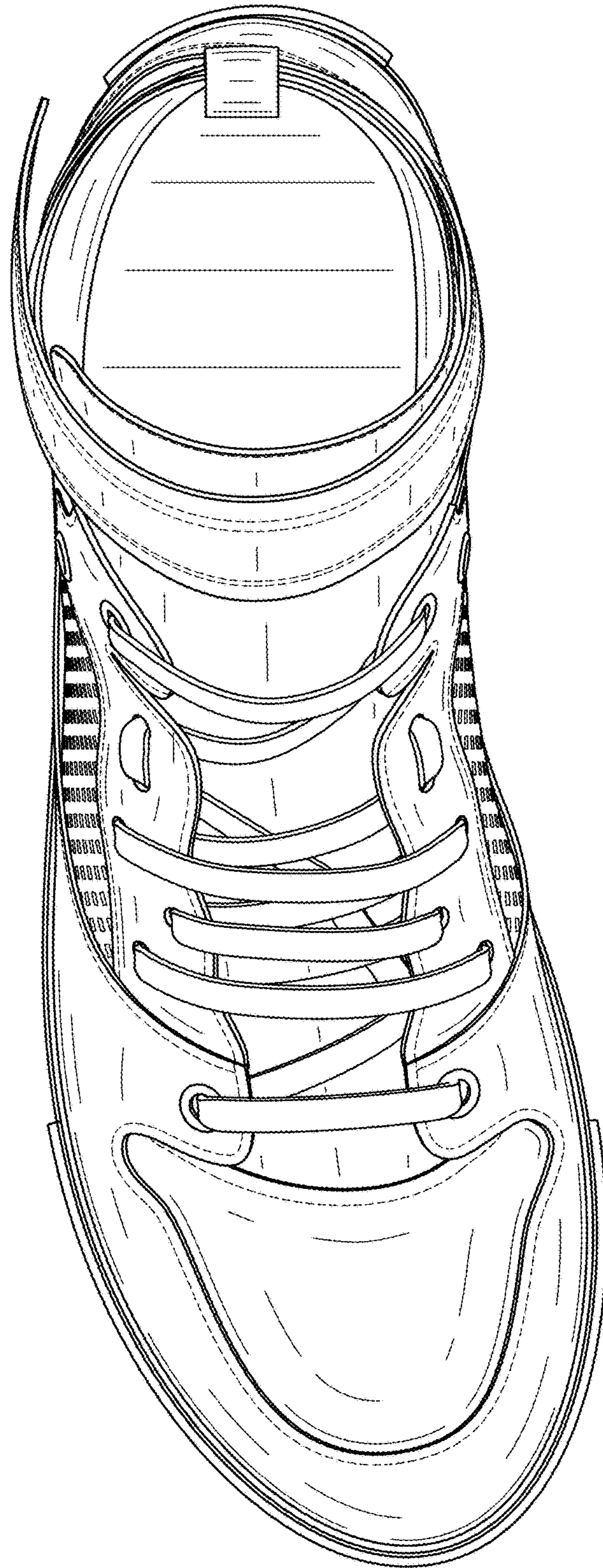

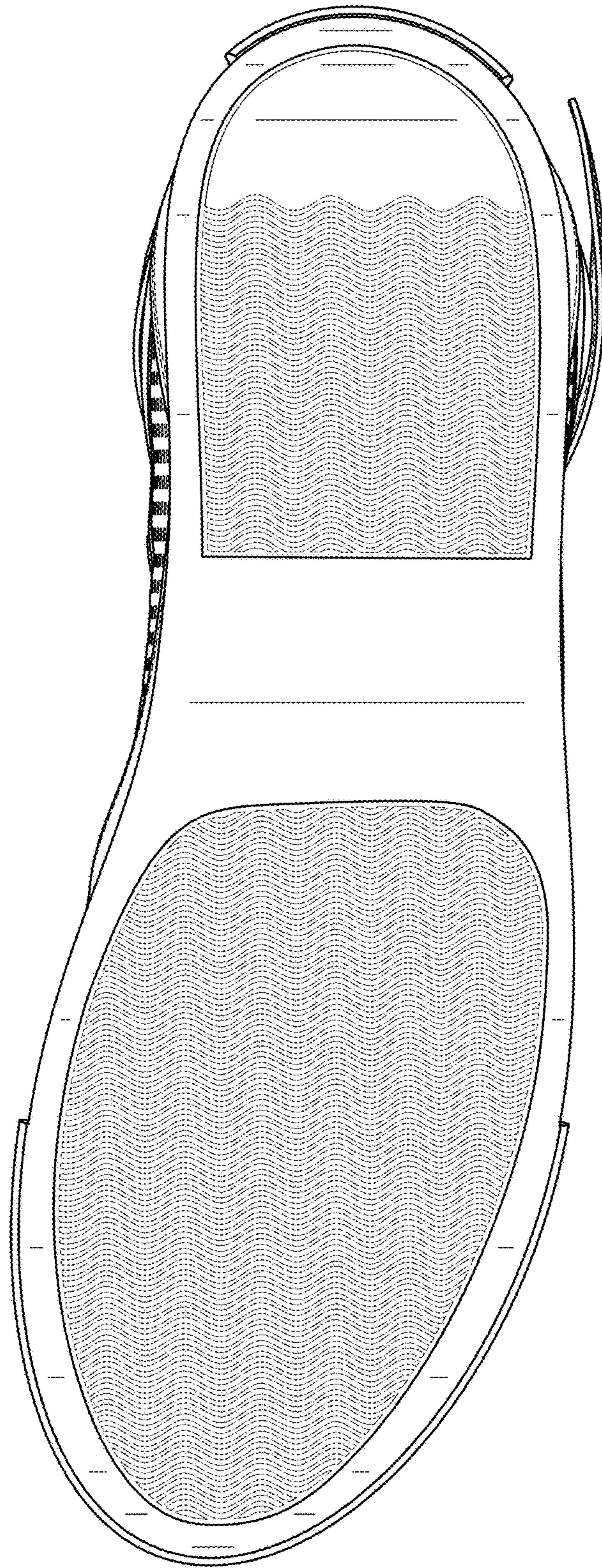

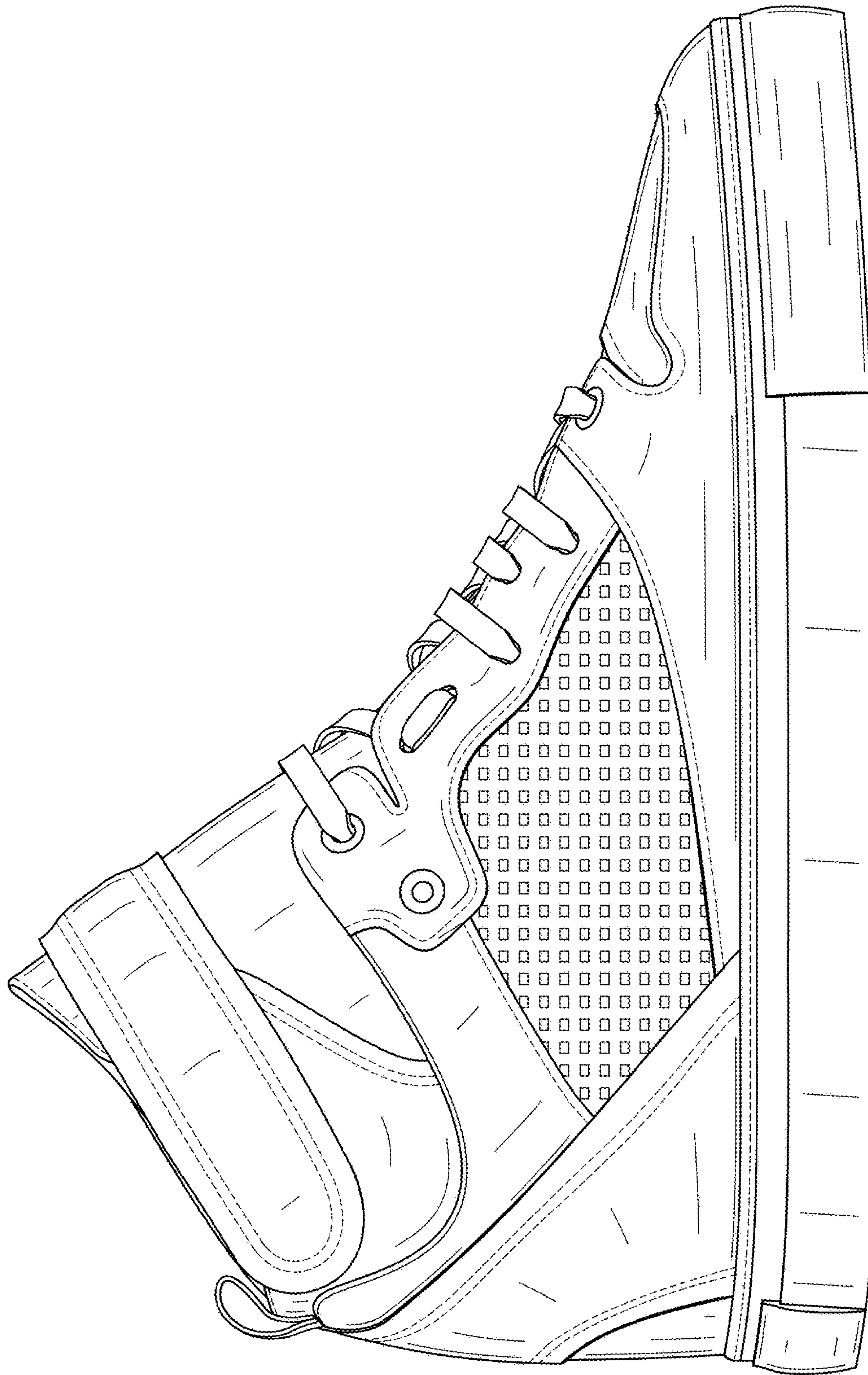

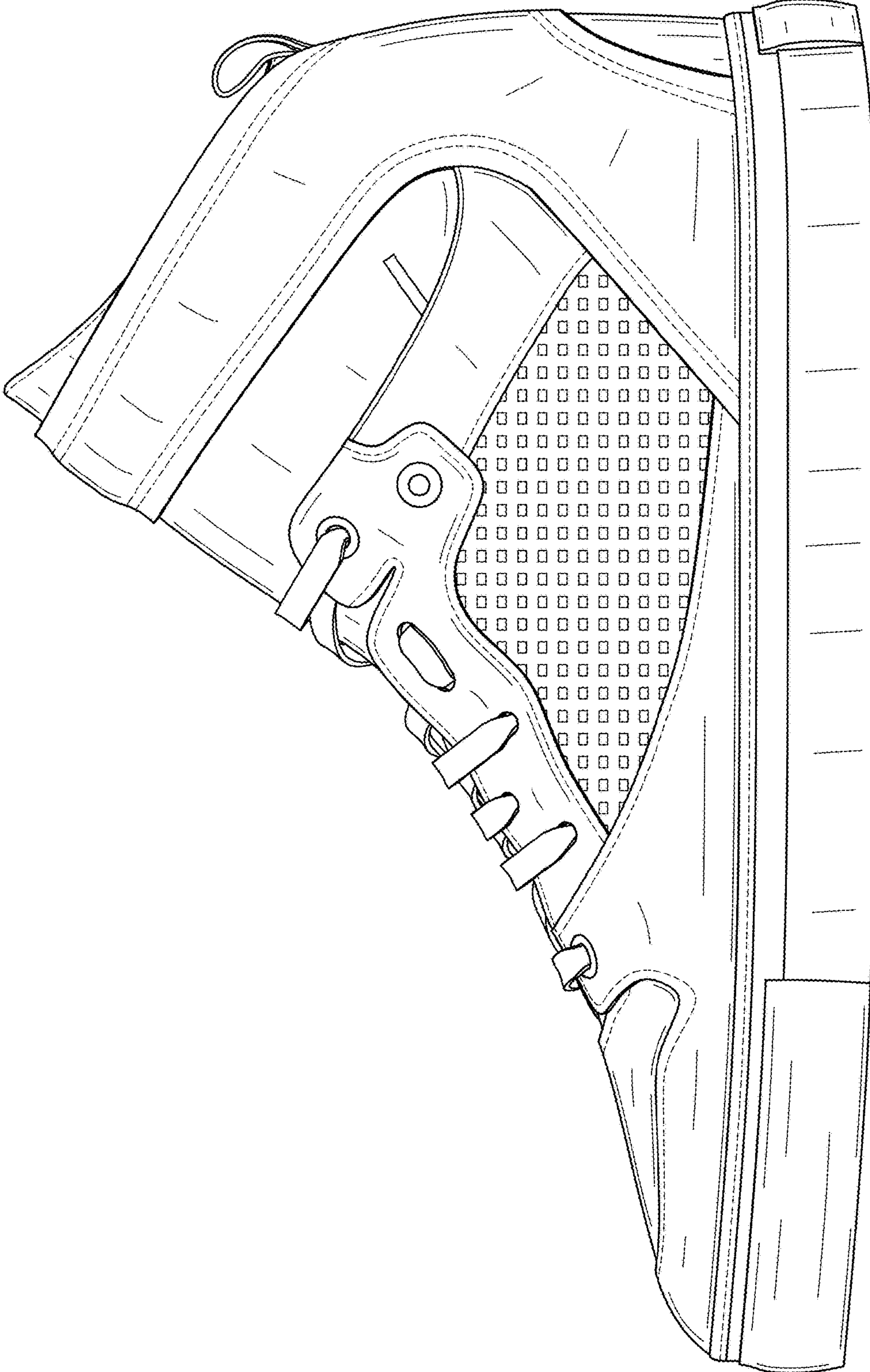

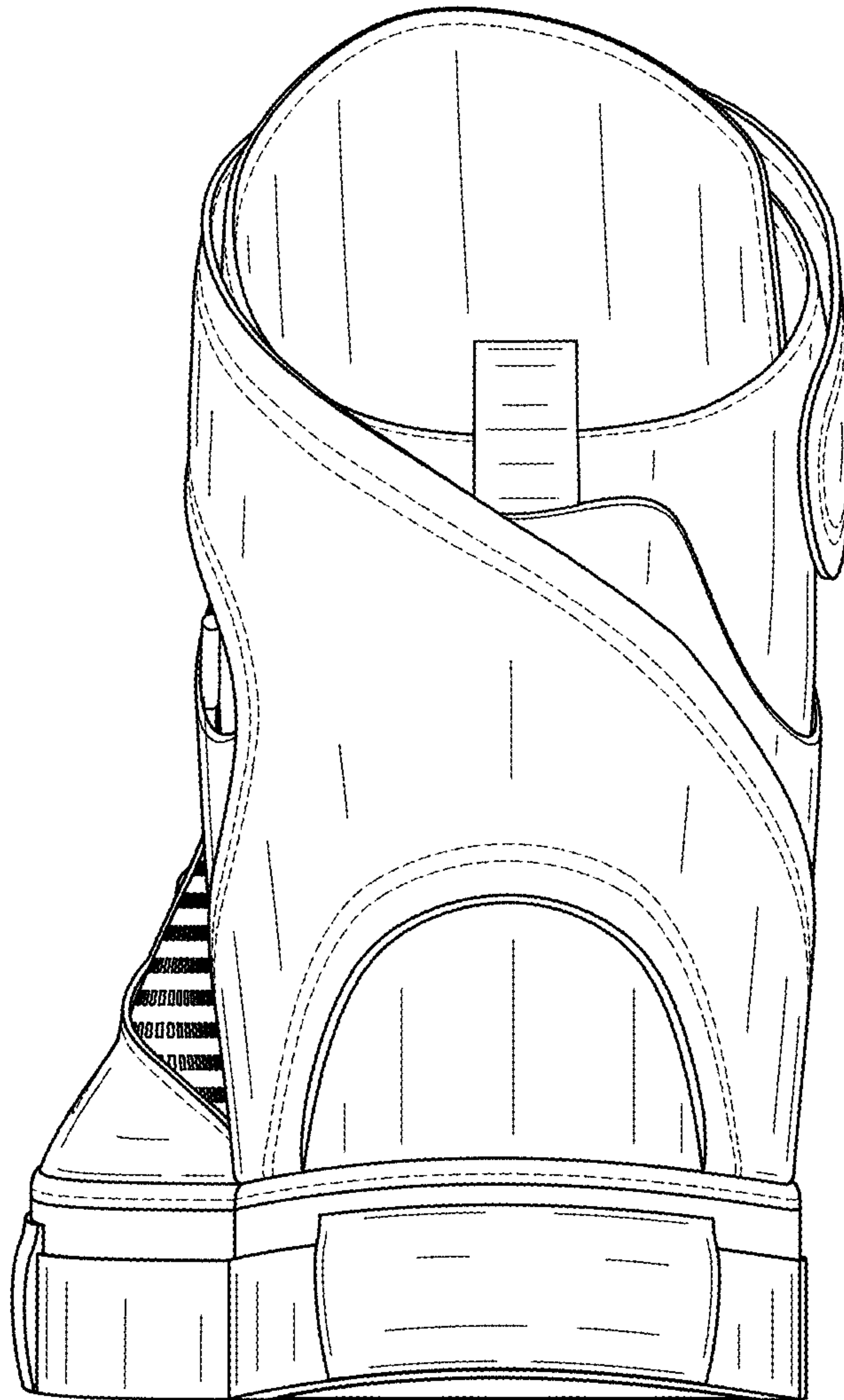
