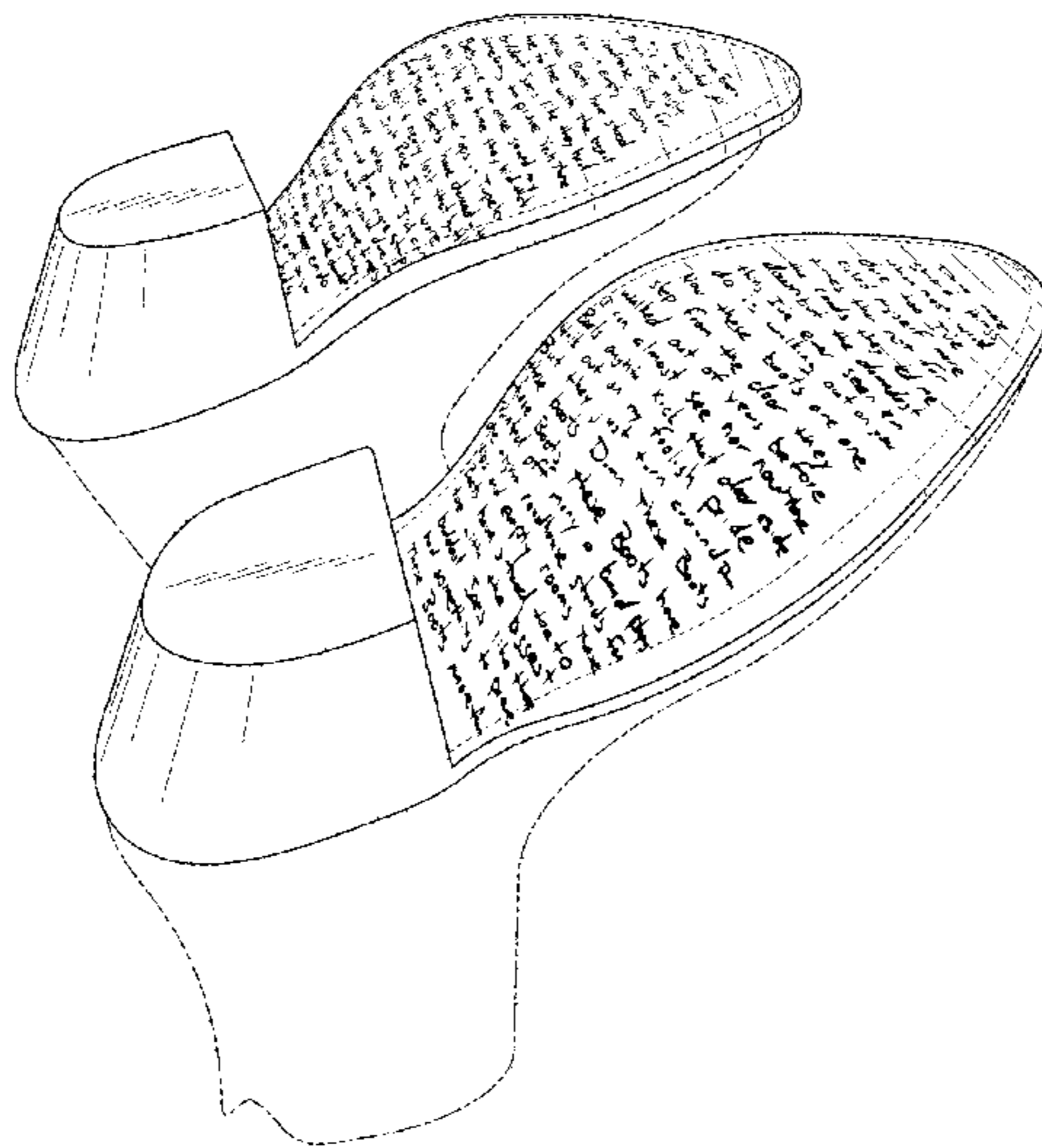
(57) **CLAIM**

The ornamental design for a pair of soles, as shown and described.

DESCRIPTION

FIG. 1 is a bottom perspective view of a pair of soles showing the new design; FIG. 2 is a front side view thereof; and, FIG. 3 is a bottom side view thereof. The dotted line around the wording shows stitching and remains part of the claimed design. The broken line showing of the upper portion of the pair of soles shows unclaimed subject matter for the design in those drawings.

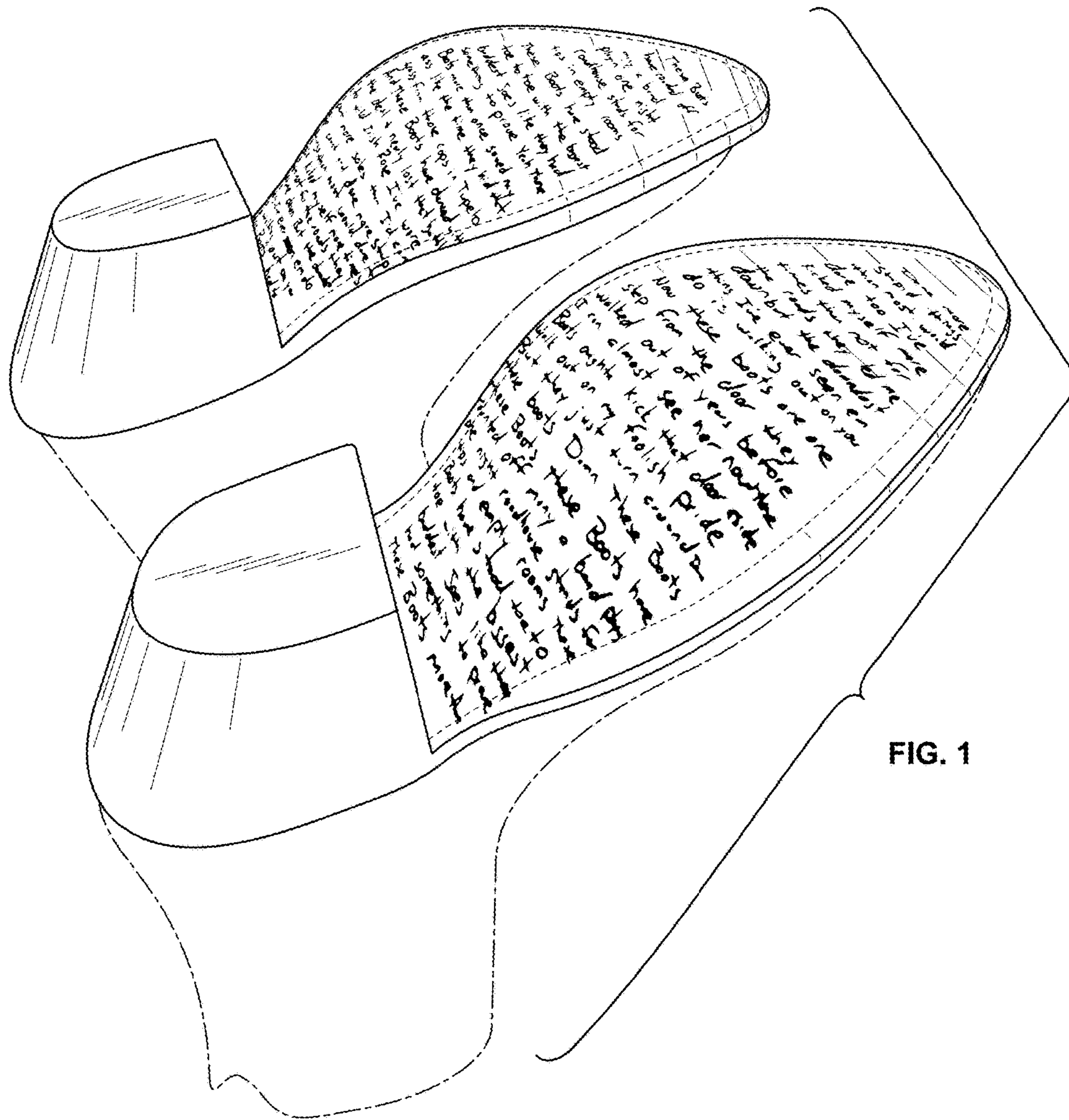

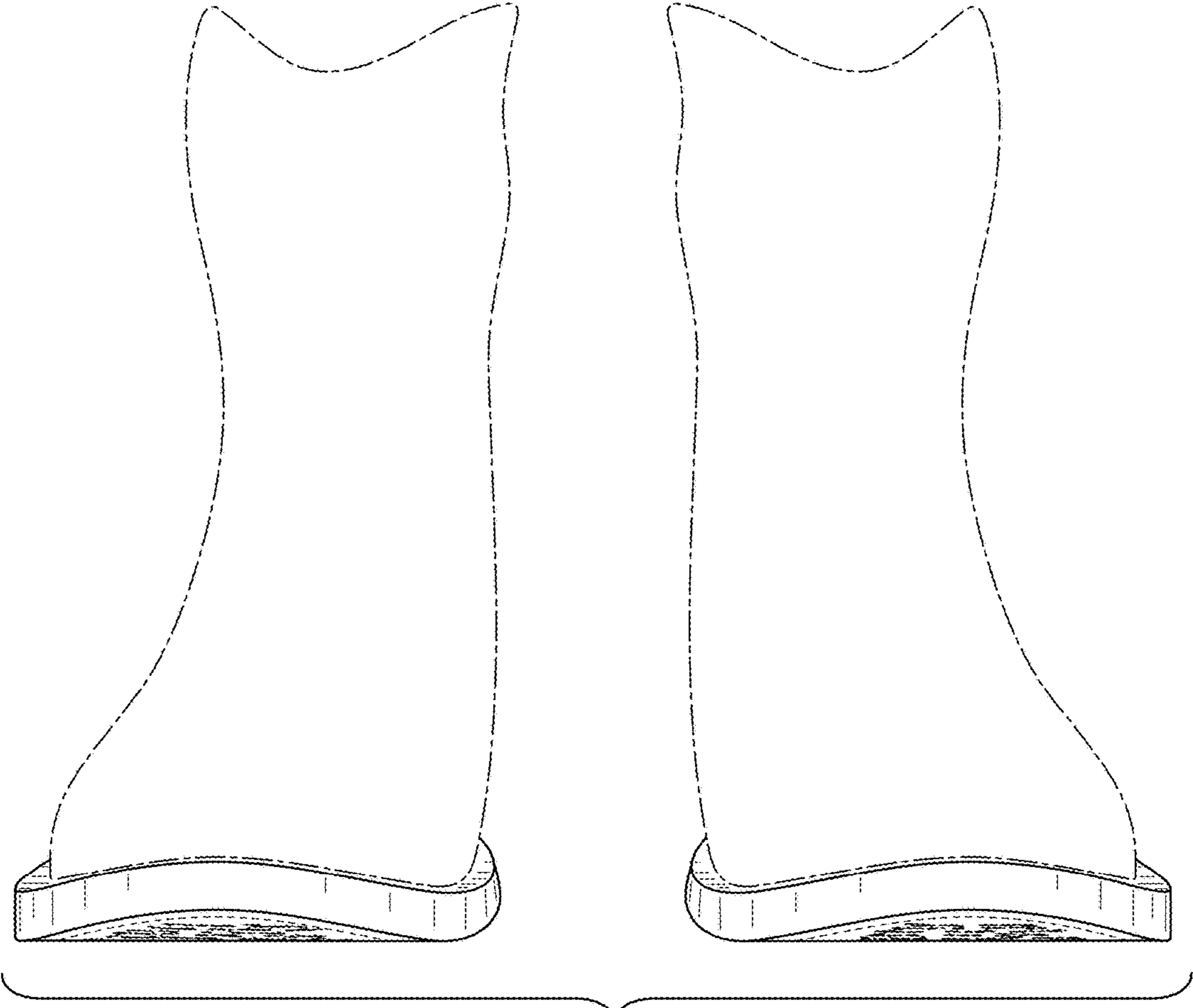

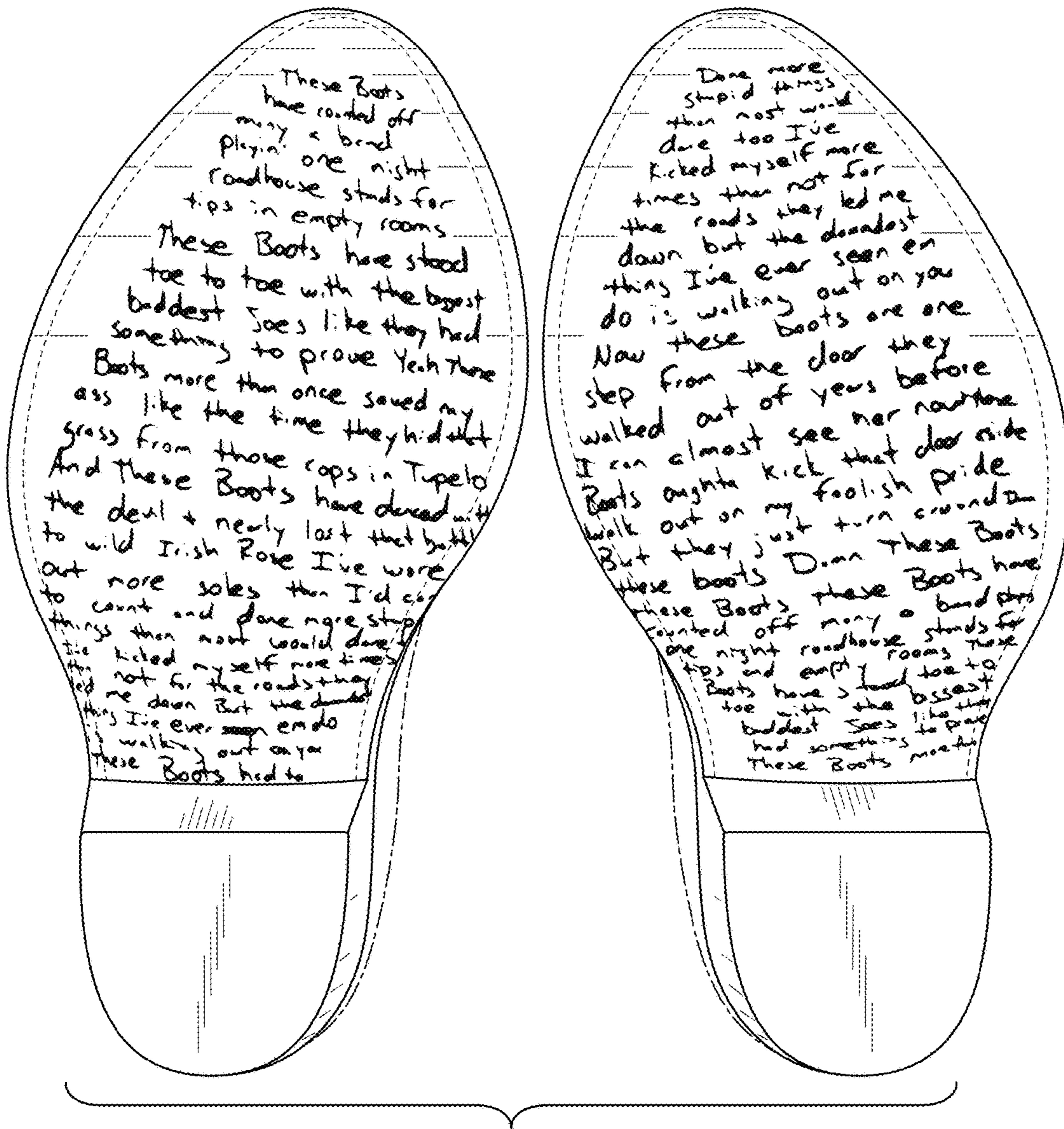
