DESCRIPTION

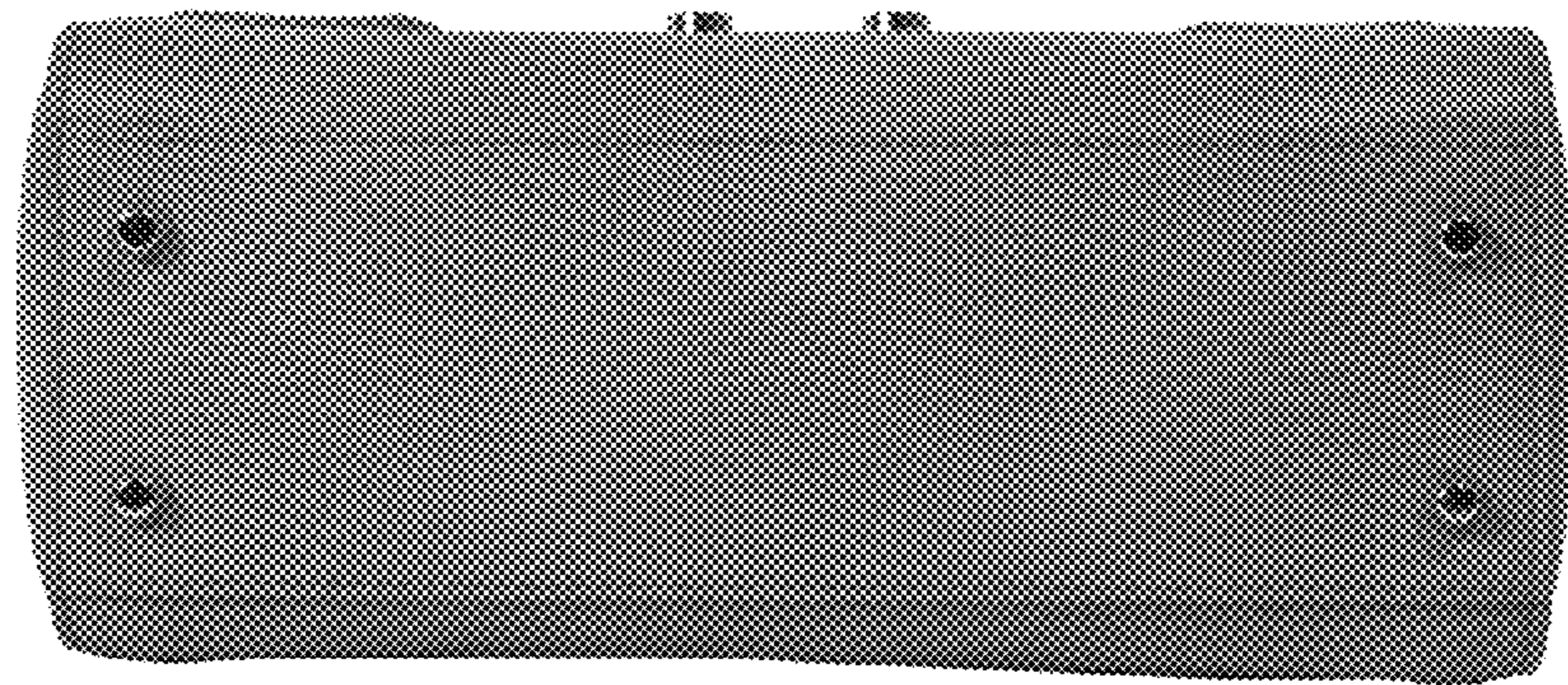
