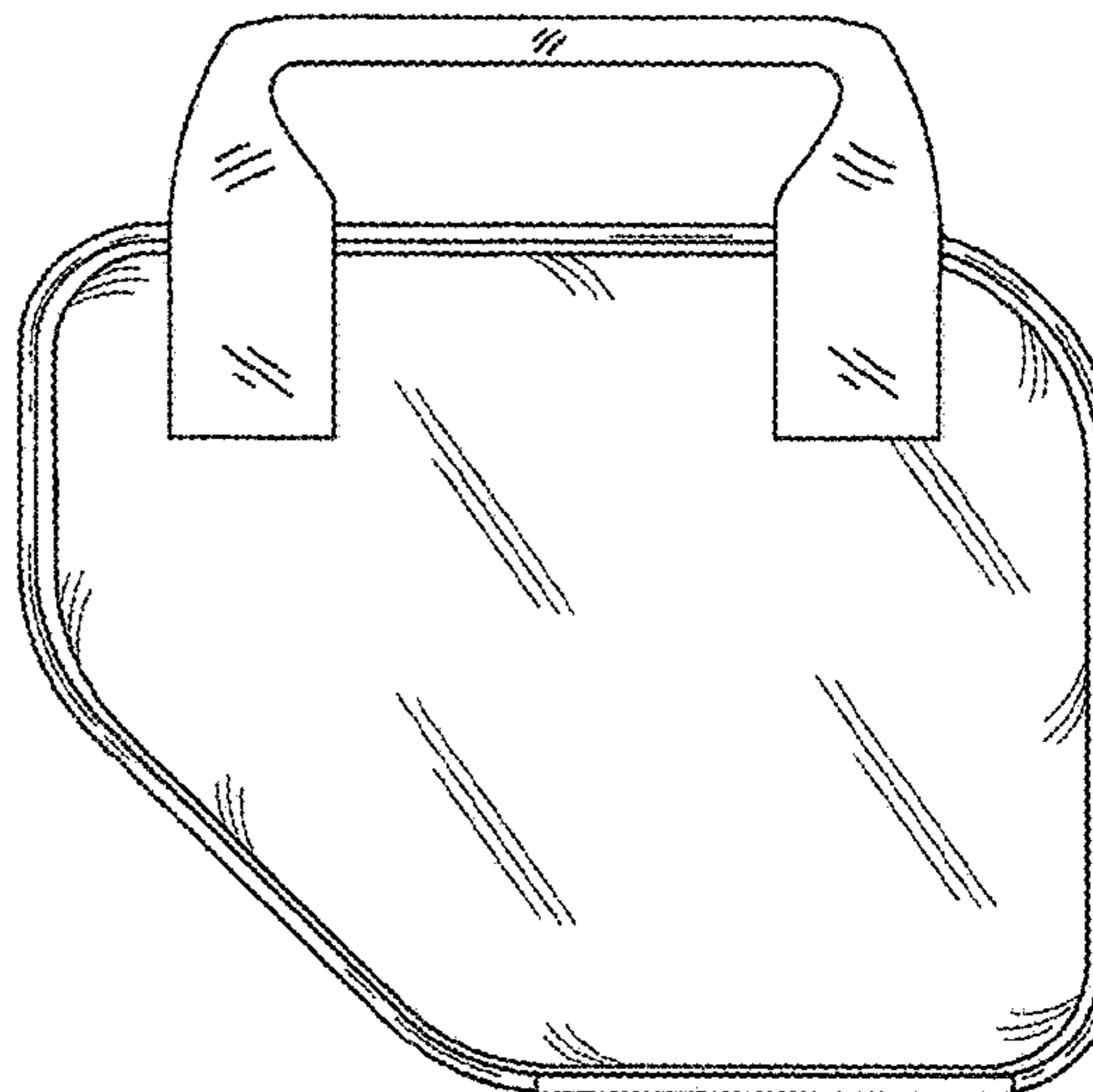
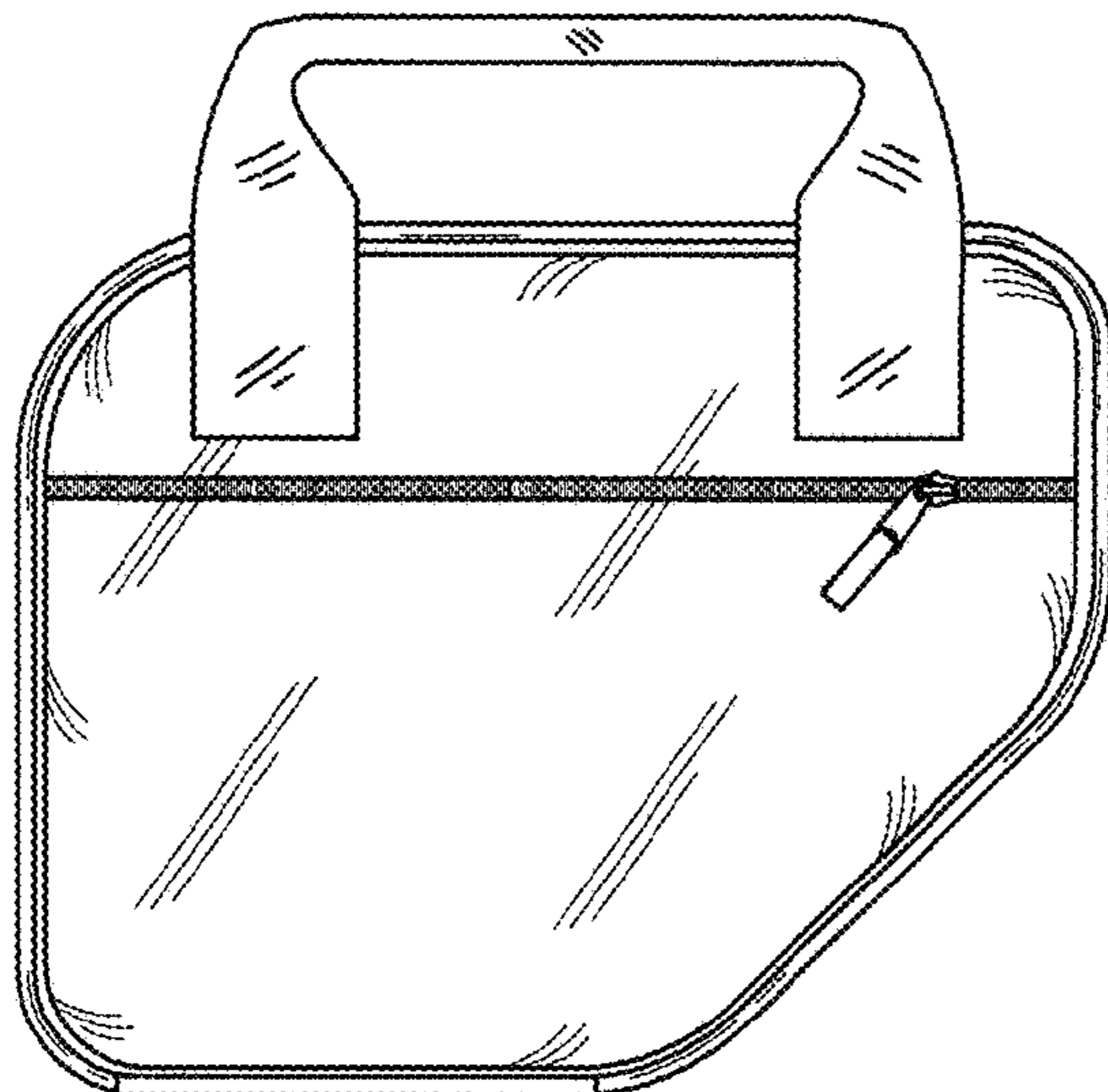
(57) **CLAIM**

The ornamental design for a handgun case with pouch, as shown.

**DESCRIPTION**

FIG. 1 is a front elevation of the handgun case with pouch of the present invention;  
 FIG. 2 is a rear elevation of the handgun case with pouch of FIG. 1;  
 FIG. 3 is a right side elevation of the handgun case with pouch of FIG. 1, the left side elevation being the mirror image of the right side elevation;  
 FIG. 4 is a top plan view of the handgun case with pouch of FIG. 1; and,  
 FIG. 5 is a bottom plan view of the handgun case with pouch of FIG. 1.

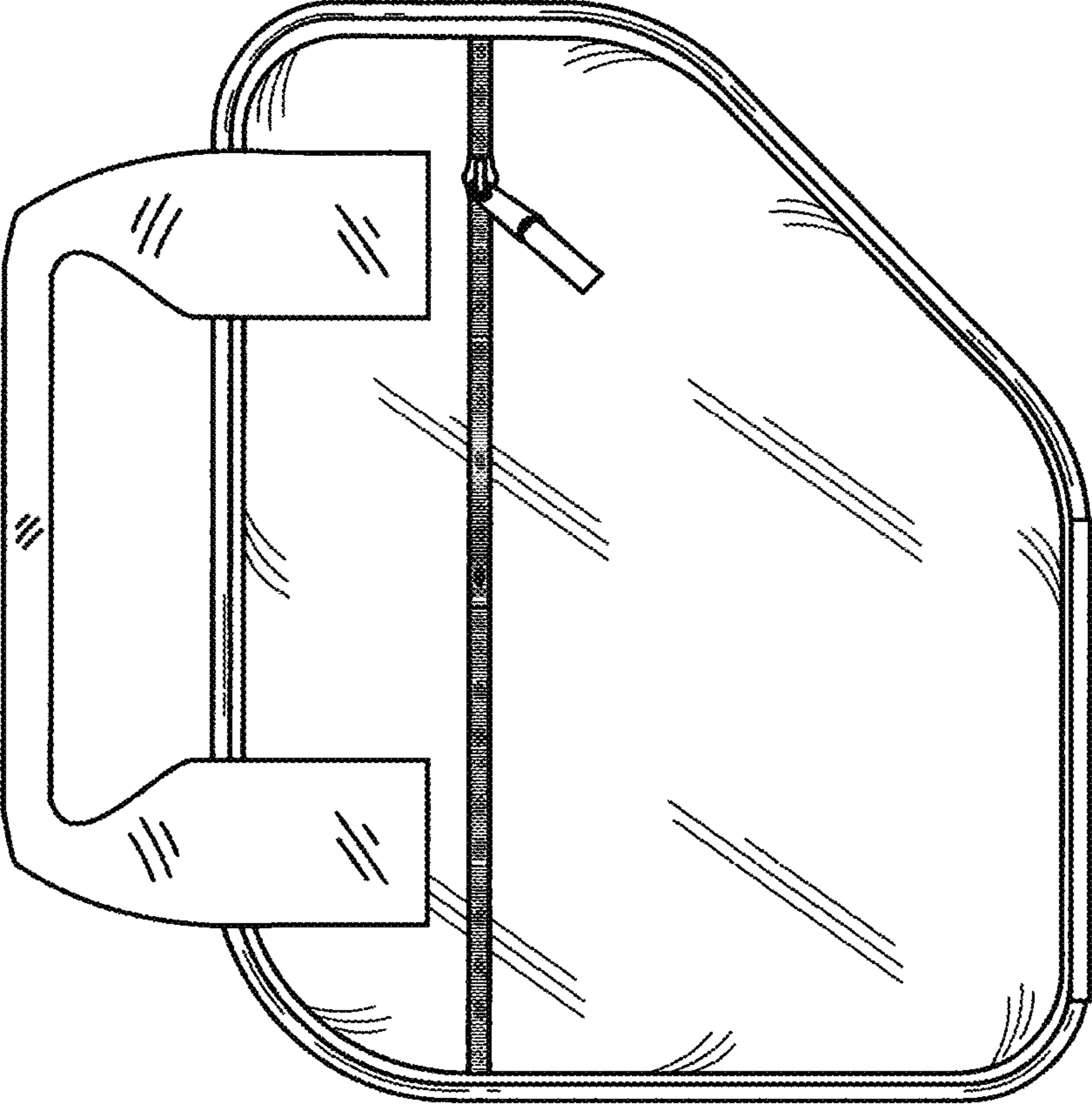

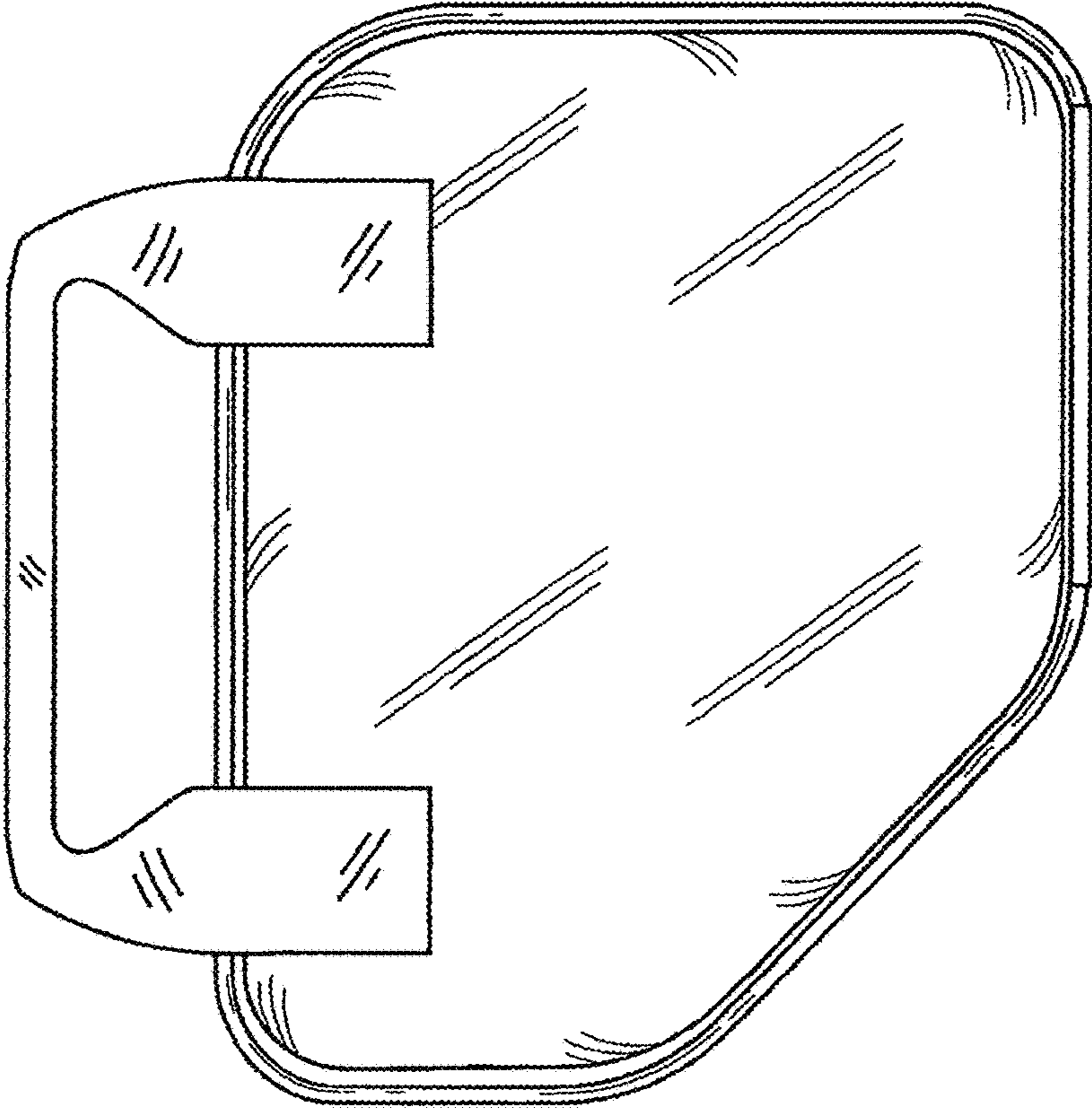

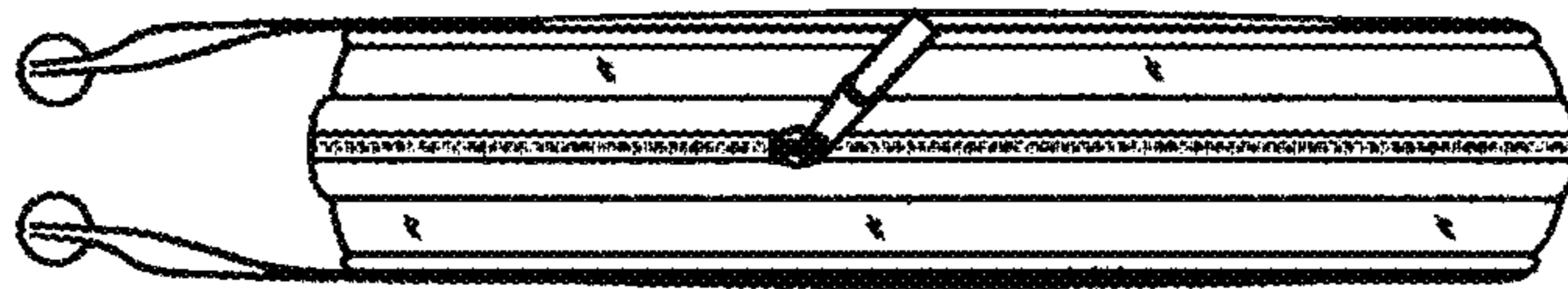

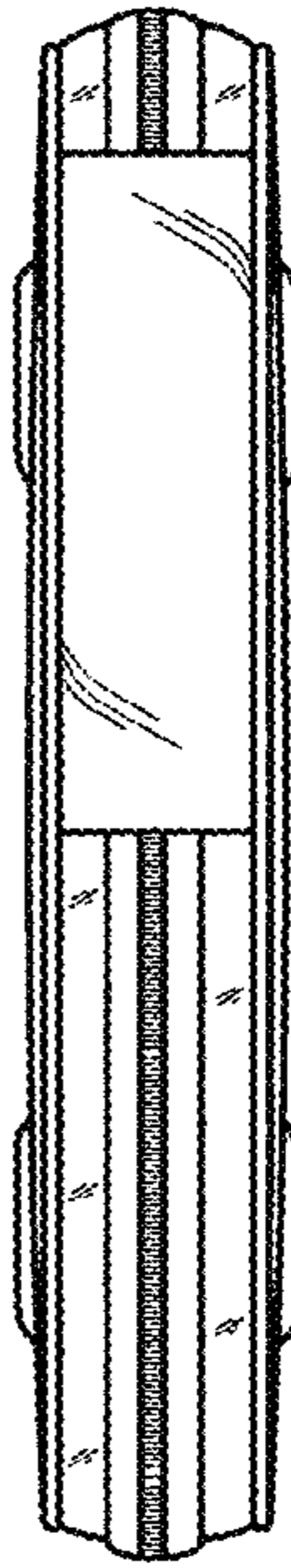
