**DESCRIPTION**

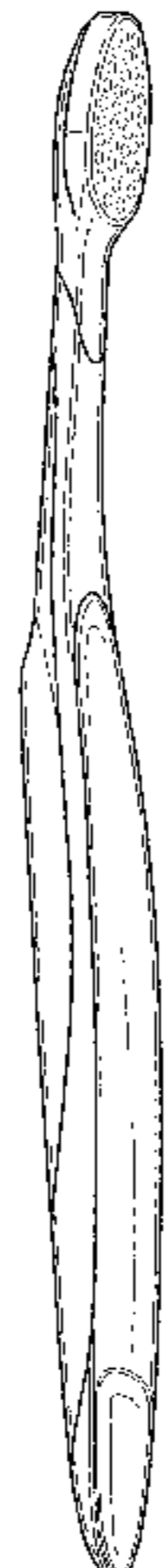
FIG. 1 is a front perspective view from top and left side of the toothbrush handle;

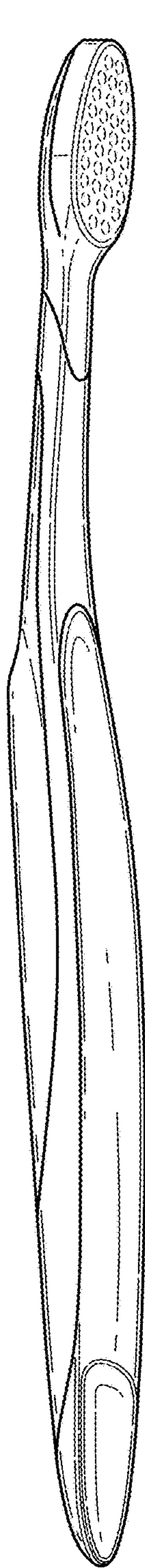

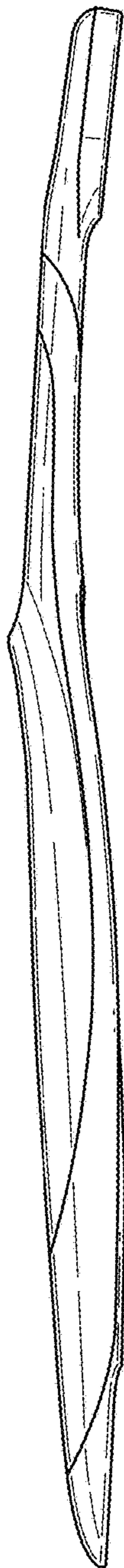

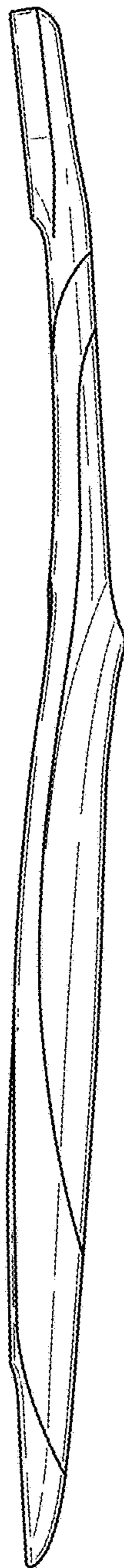

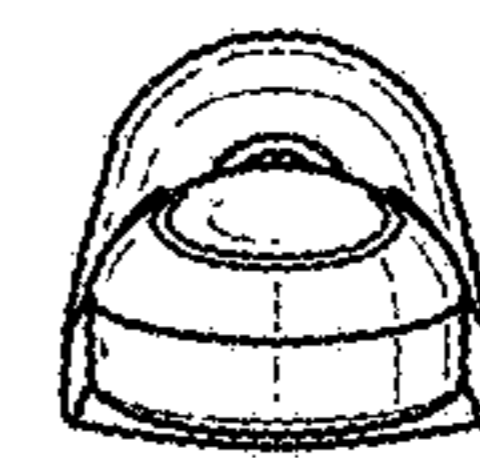

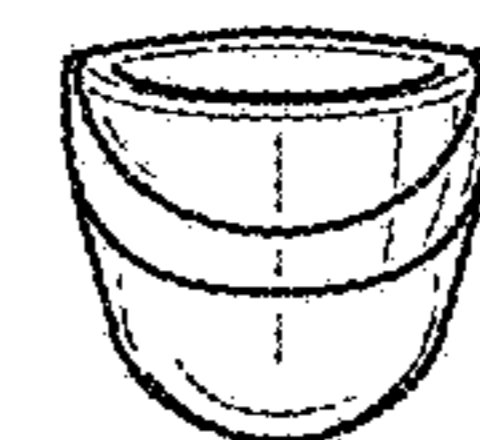
