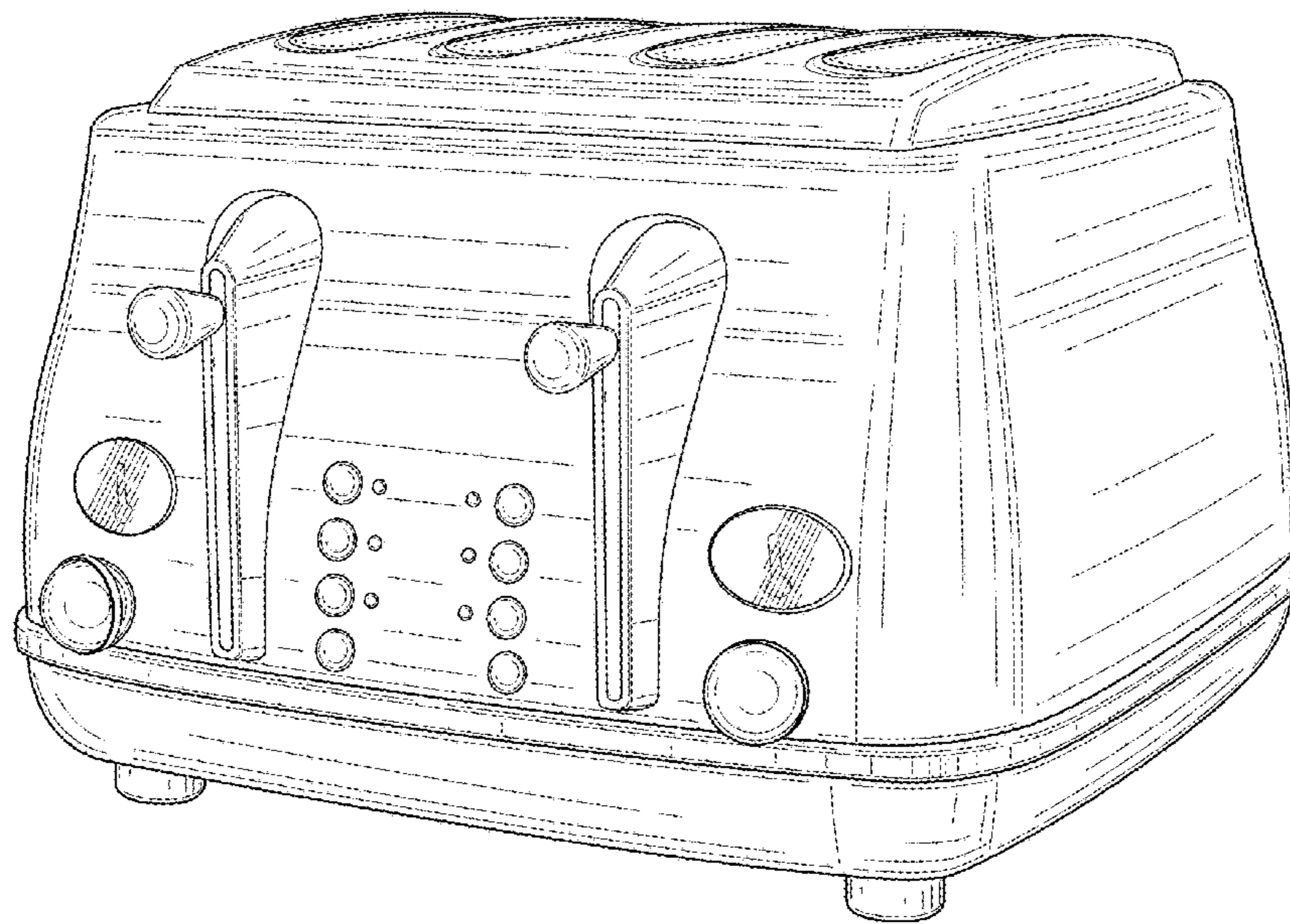
(57) **CLAIM**

We claim, the ornamental design for a toaster, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a toaster, showing our new design;  
FIG. 2 is a front view thereof;

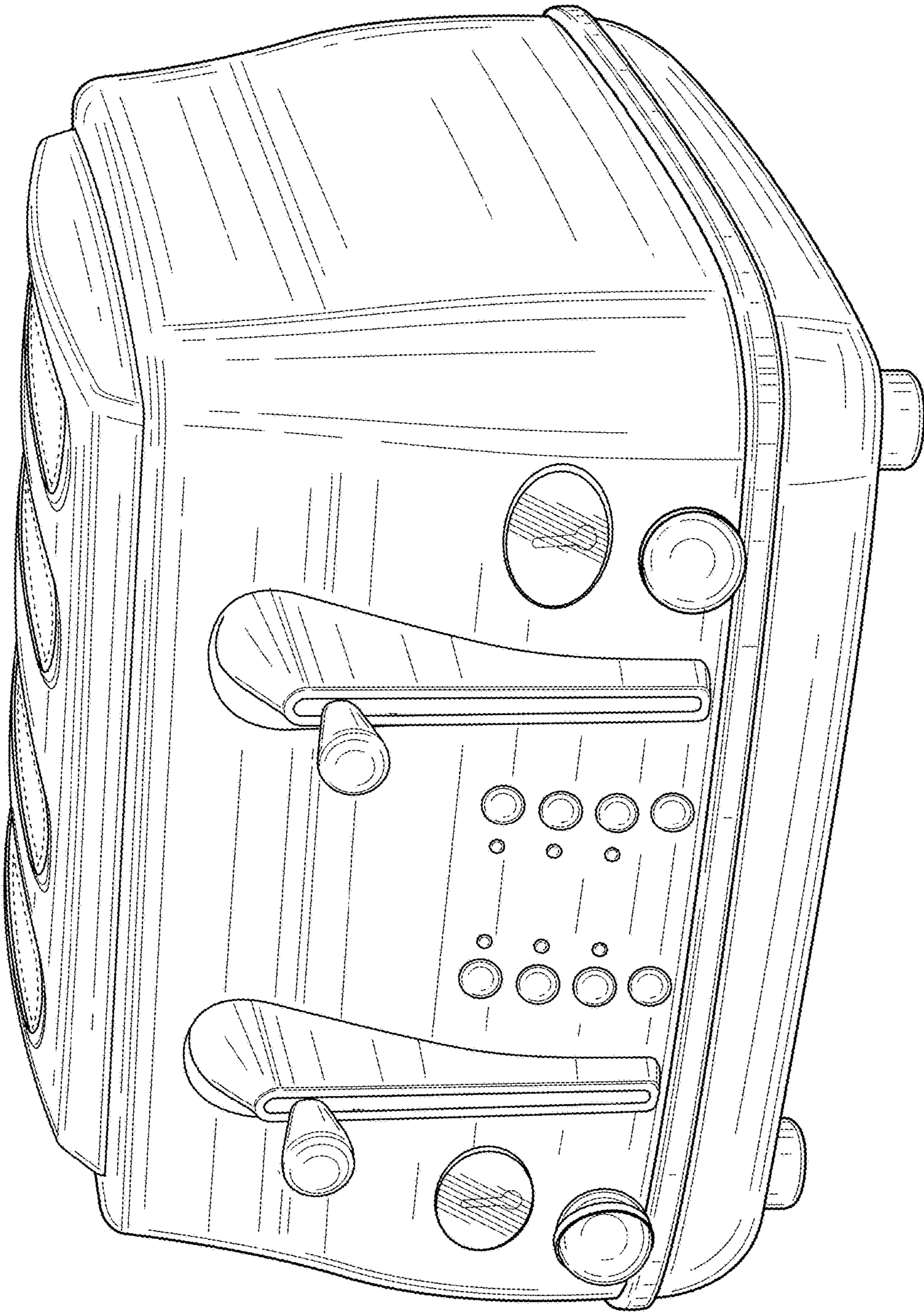

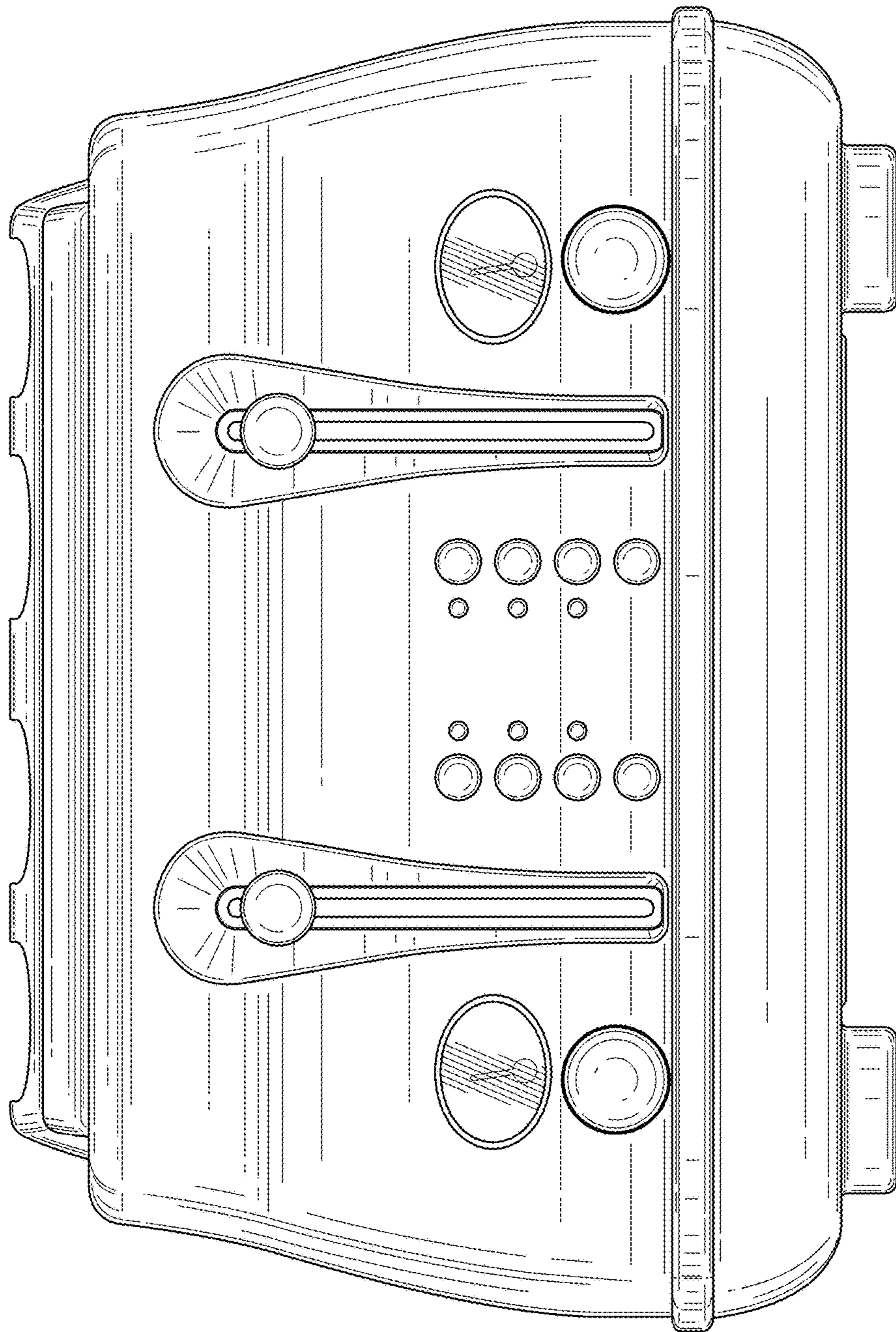

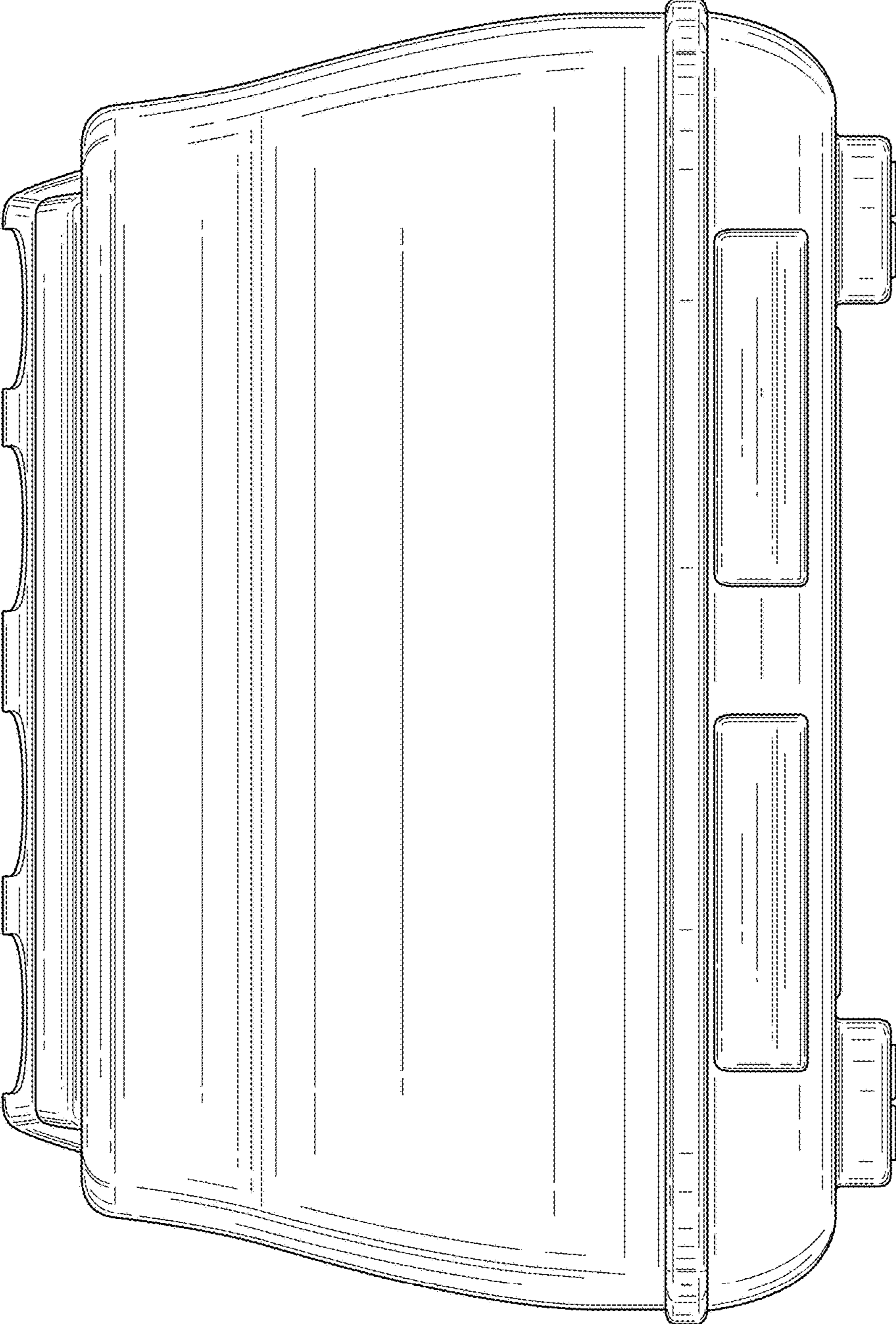

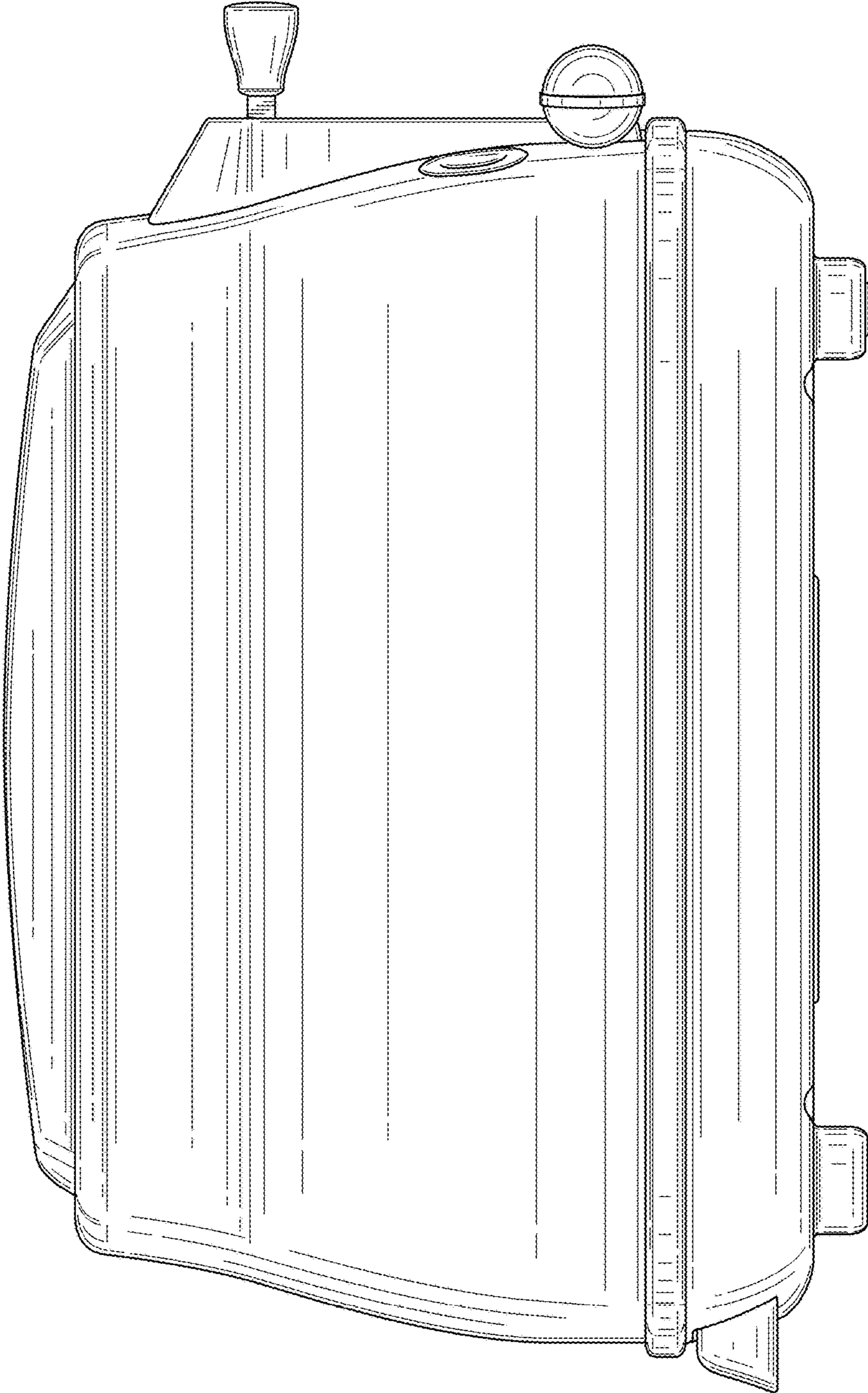

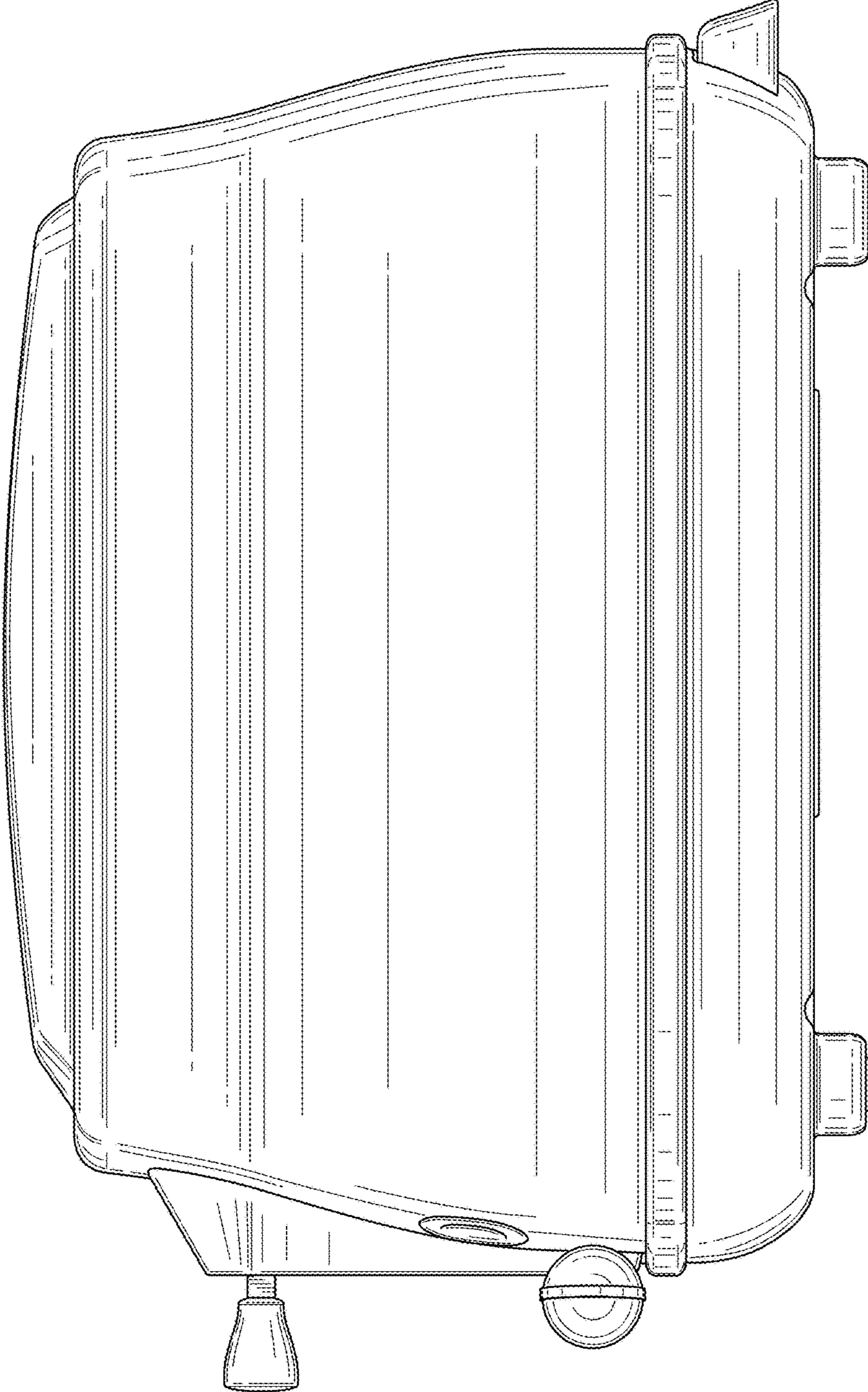

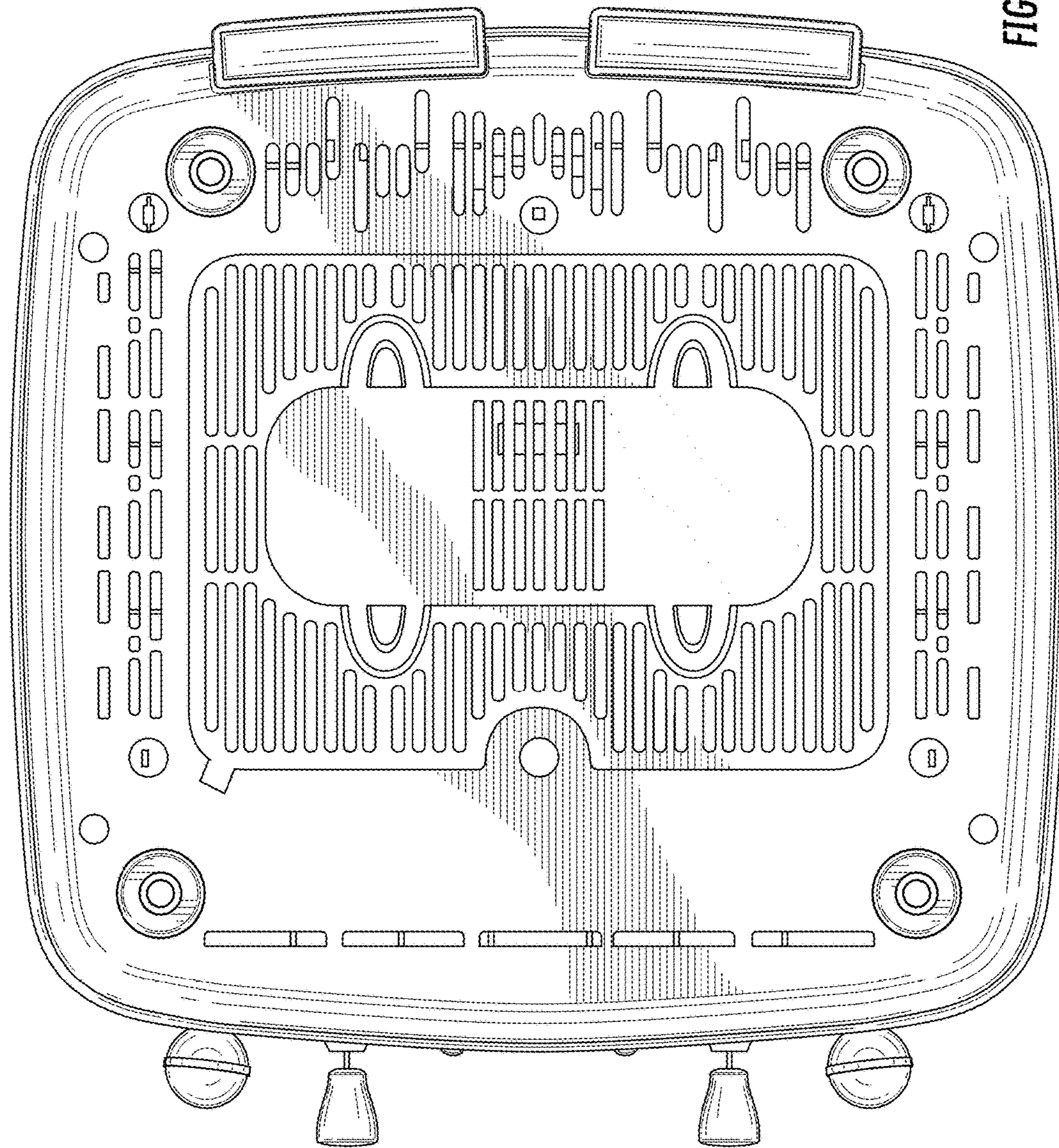

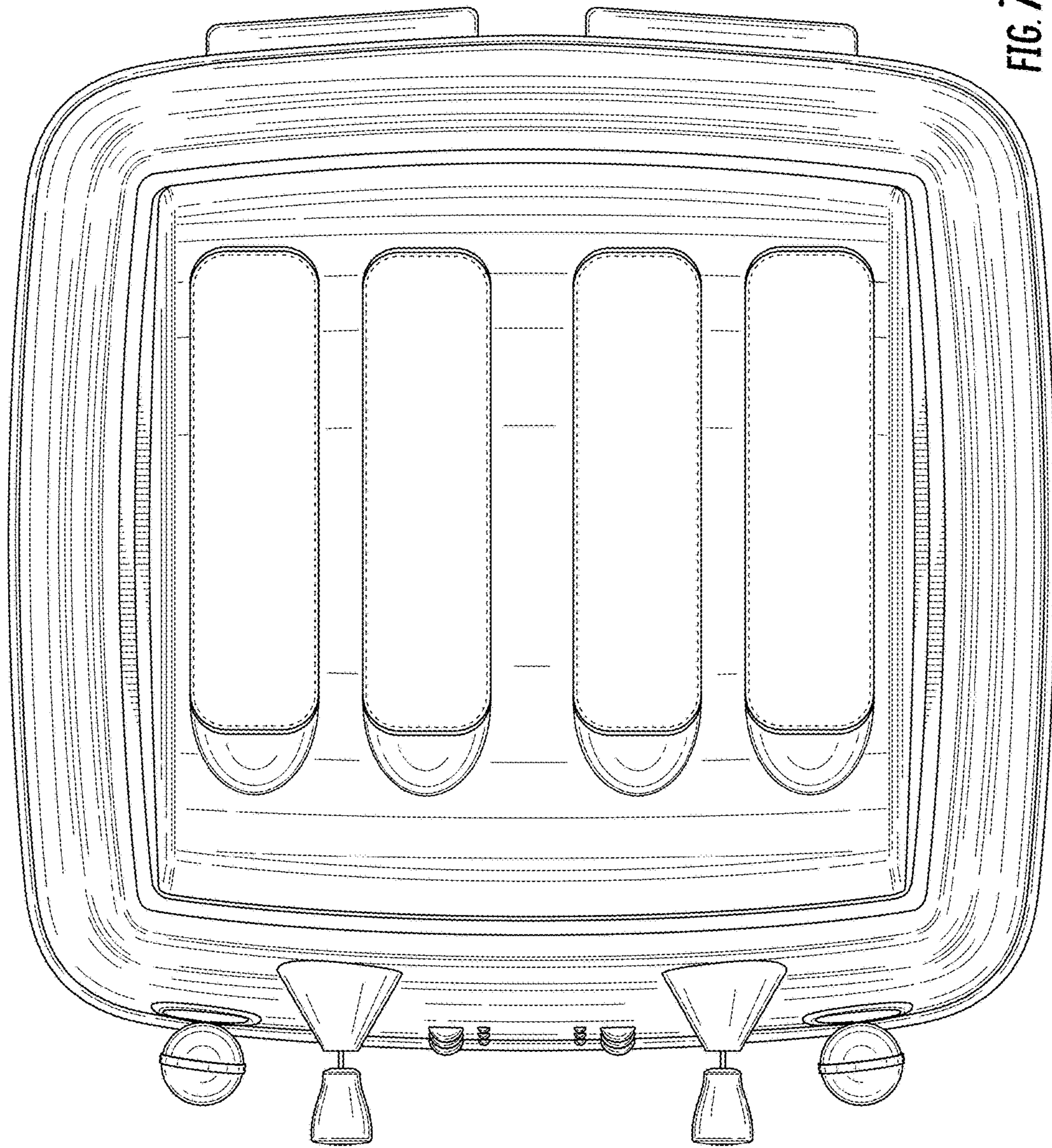
