FIG. 3 is a second side view thereof, opposite the first side view;

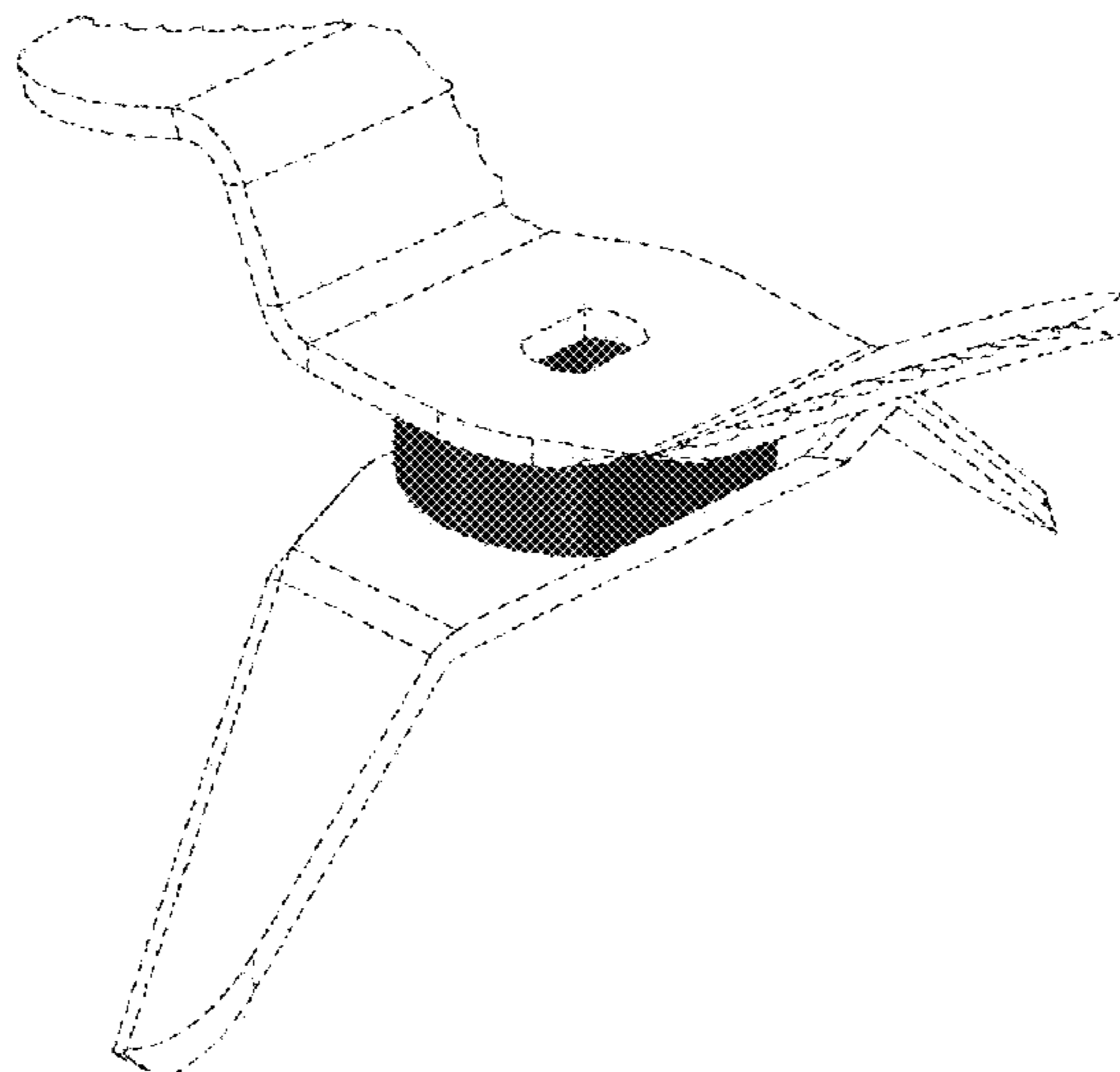
FIG. 4 is a third side view thereof;

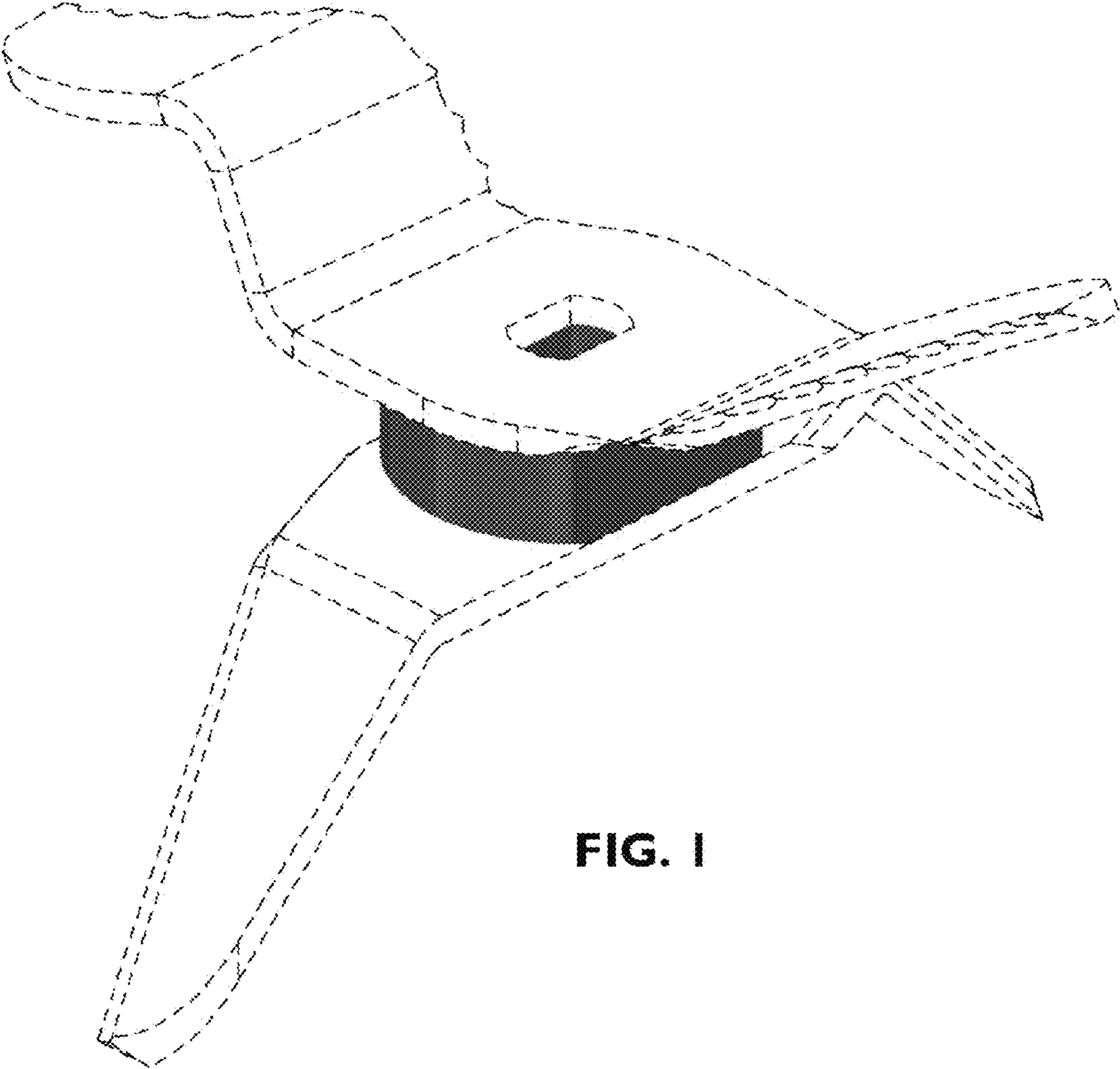

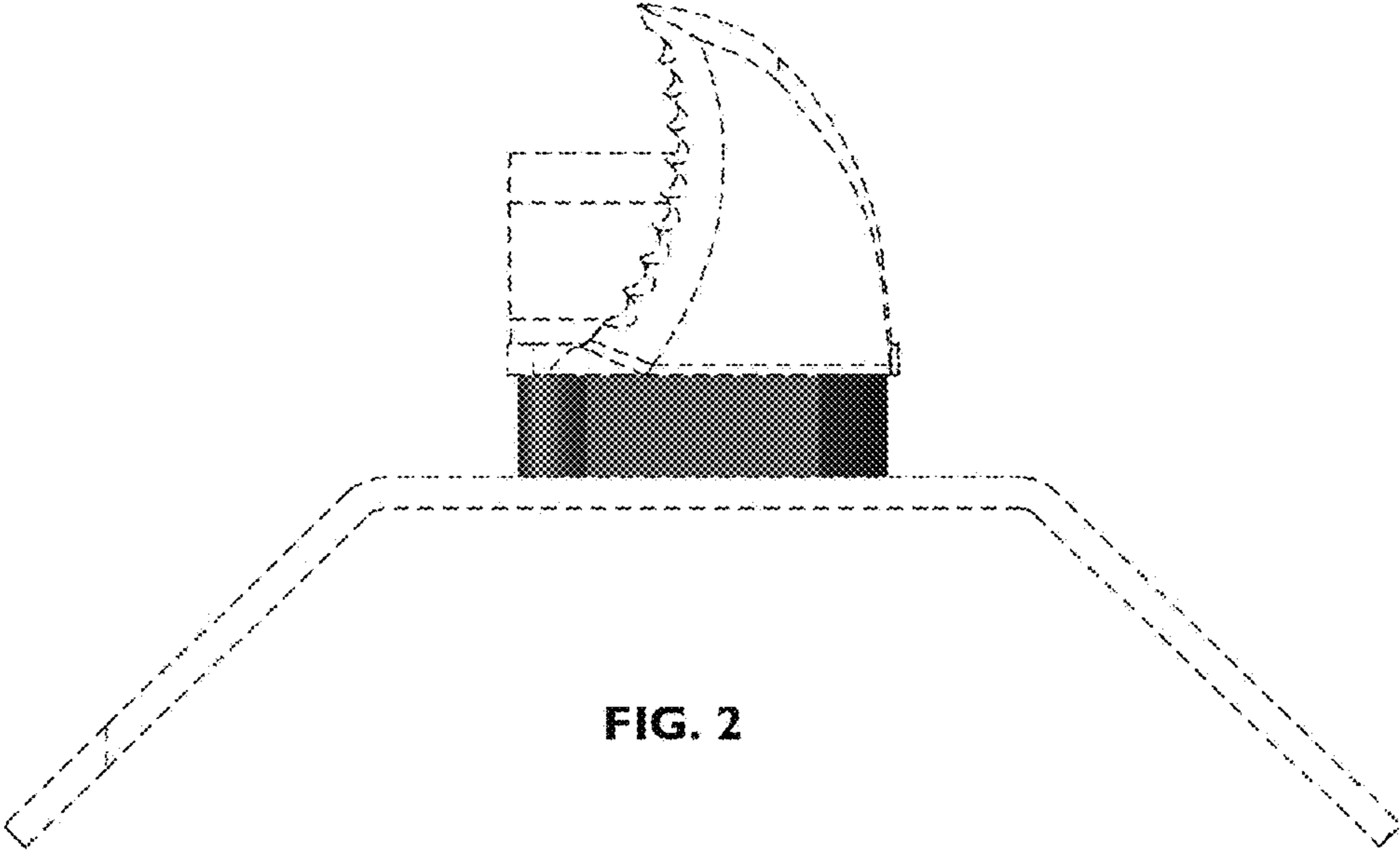

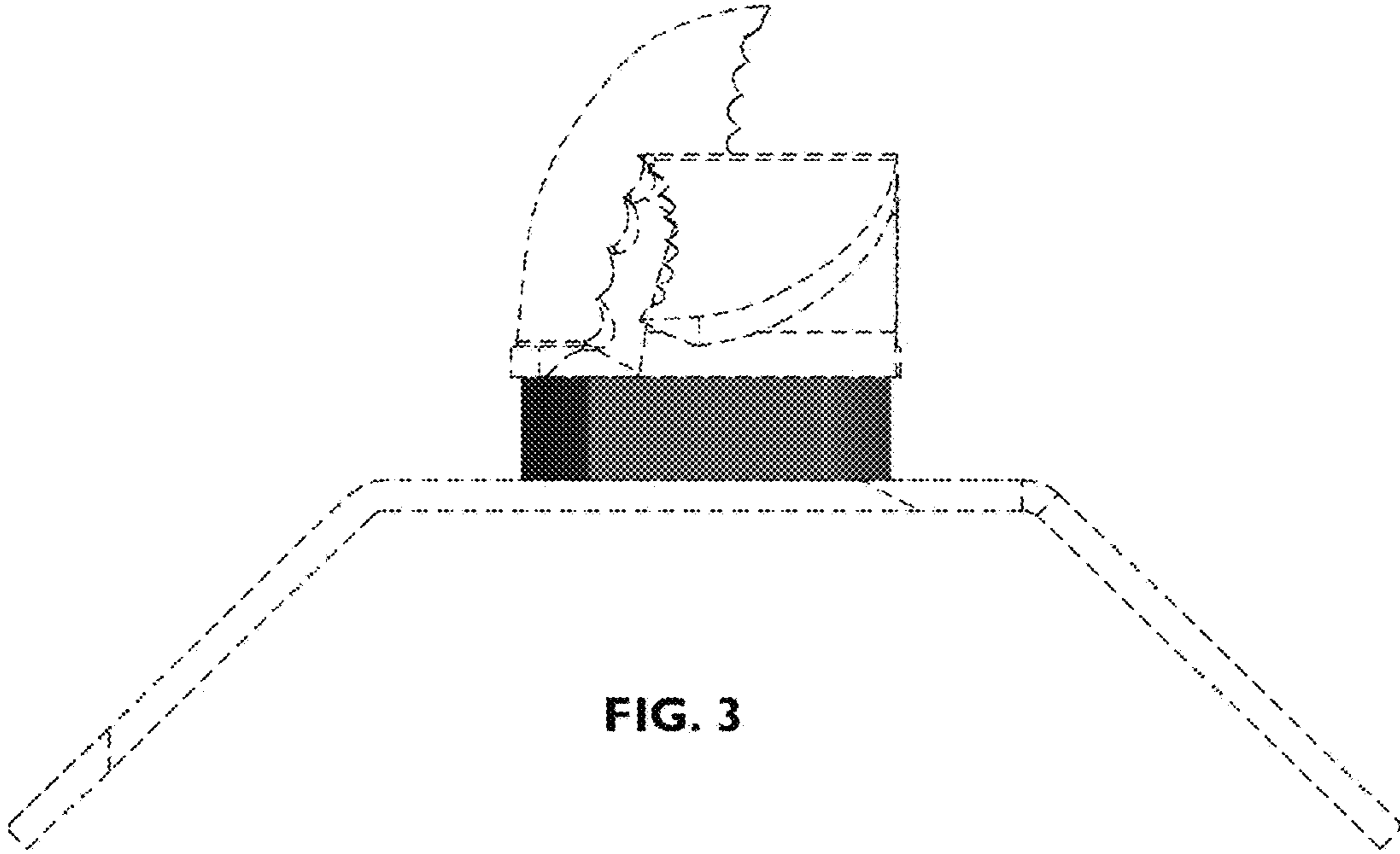

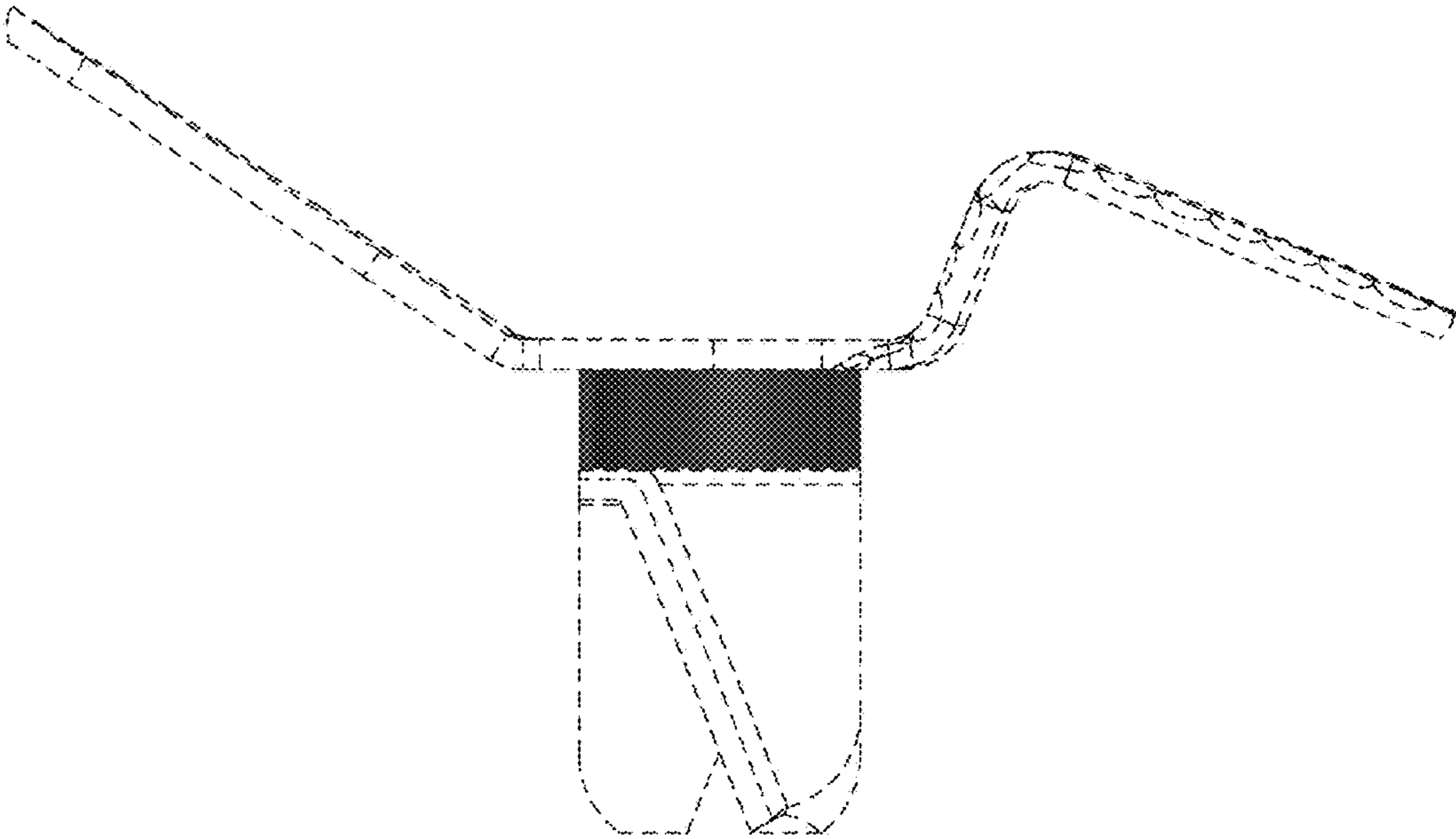

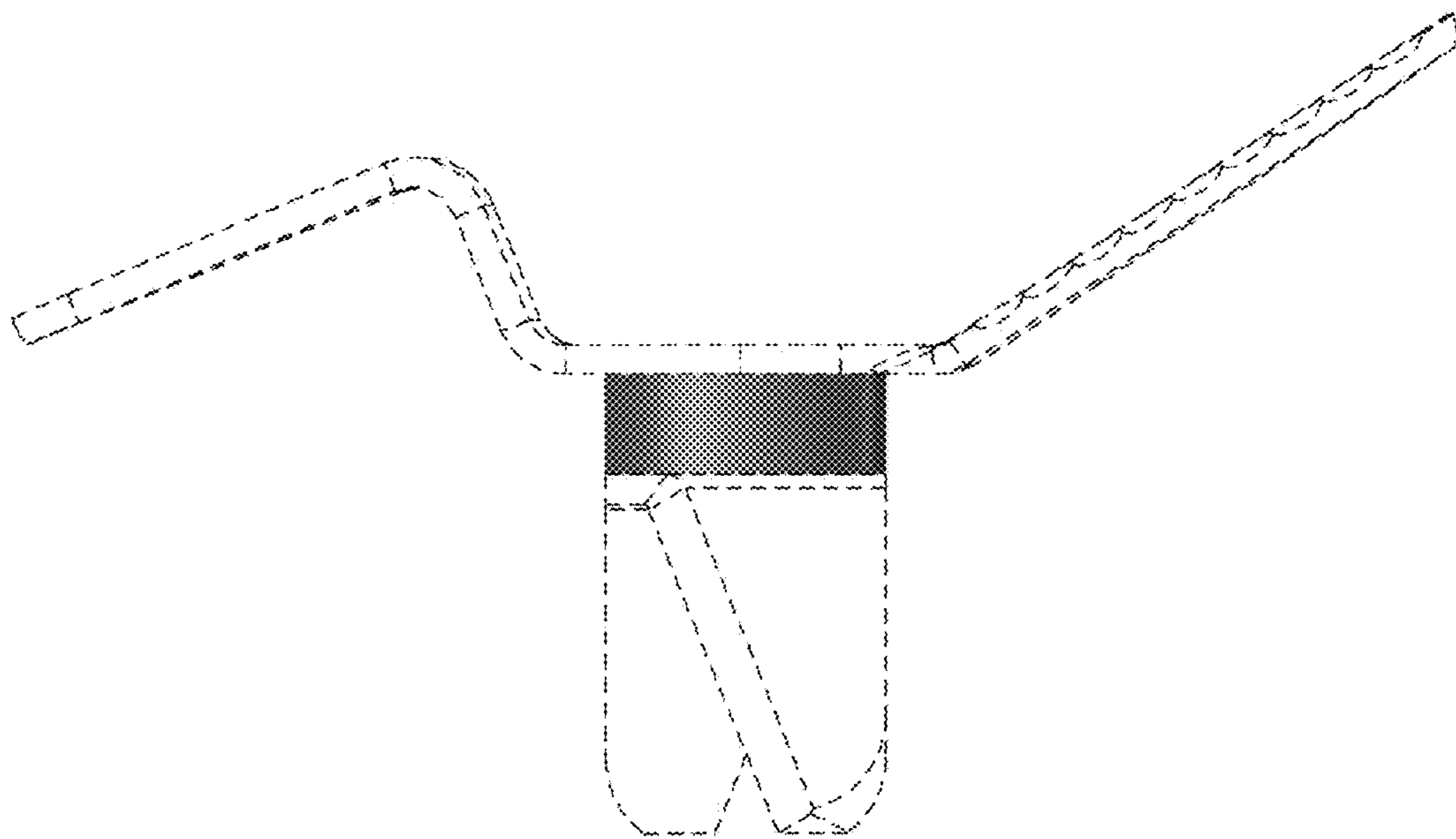

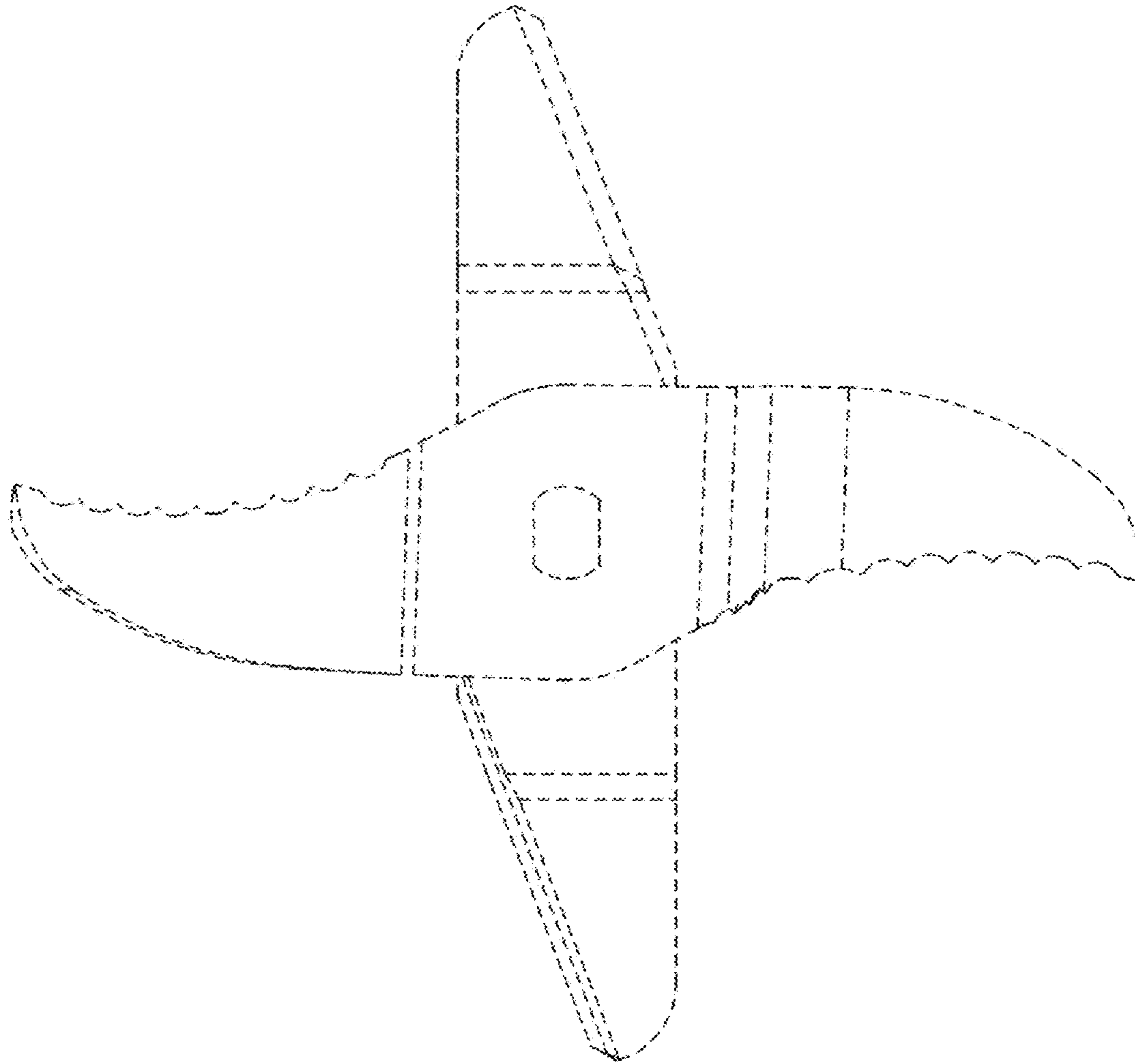

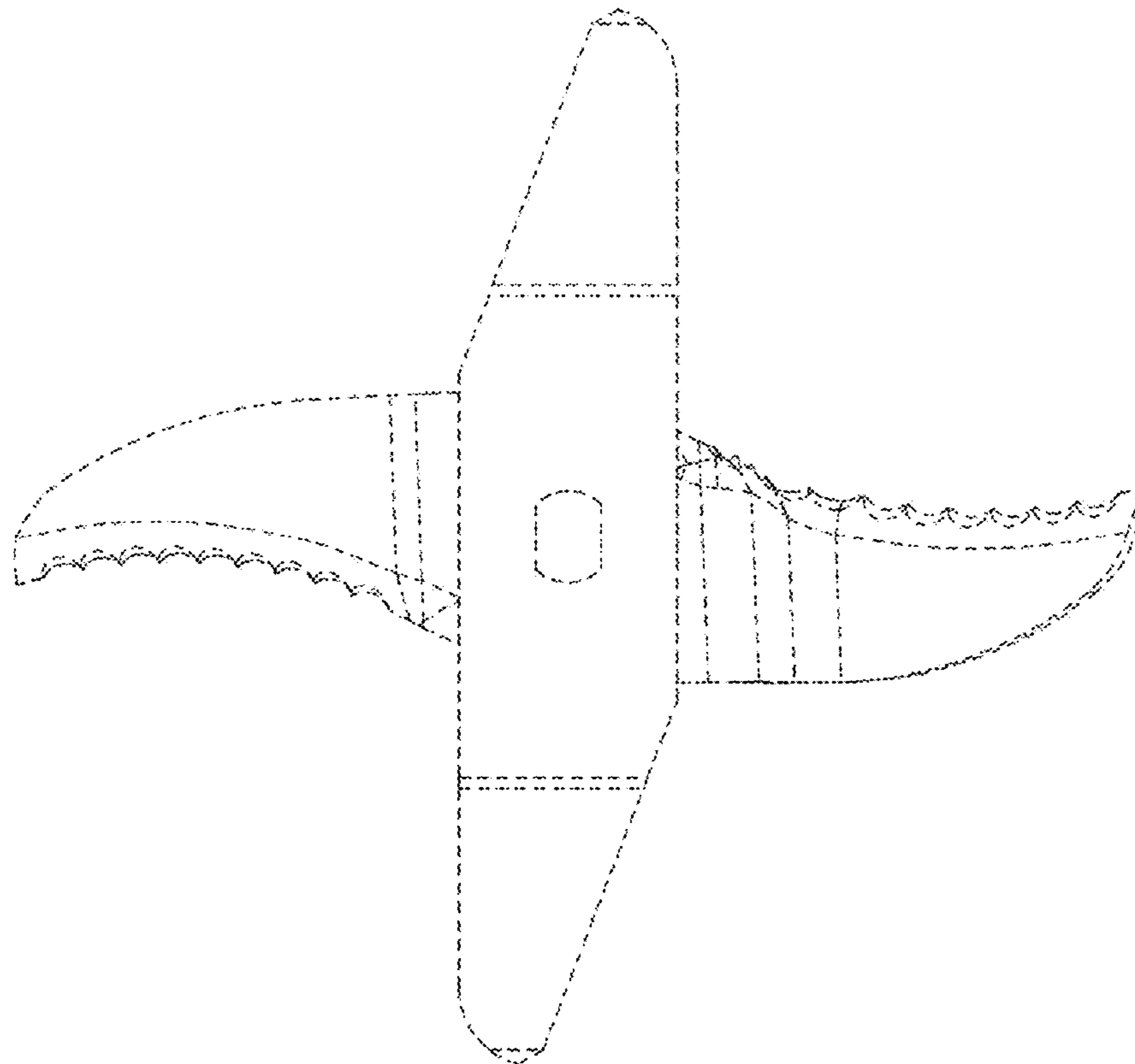
