(57) **CLAIM**

The ornamental design for the tube cutter or cutting nipper, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of tube cutter or cutting nipper showing our new design;
 FIG. 2 is a rear perspective view of the tube cutter or cutting nipper of FIG. 1;
 FIG. 3 is a front view of the tube cutter or cutting nipper of FIG. 1;
 FIG. 4 a back view of the tube cutter or cutting nipper of FIG. 1;
 FIG. 5 is an elevational end view of the tube cutter or cutting nipper taken from the right-hand side of FIG. 3;
 FIG. 6 is an elevational end view of the tube cutter or cutting nipper taken from the left-hand side of FIG. 3;
 FIG. 7 is a top view of the tube cutter or cutting nipper of FIG. 3; and,
 FIG. 8 is a bottom view of the tube cutter or cutting nipper of FIG. 3.

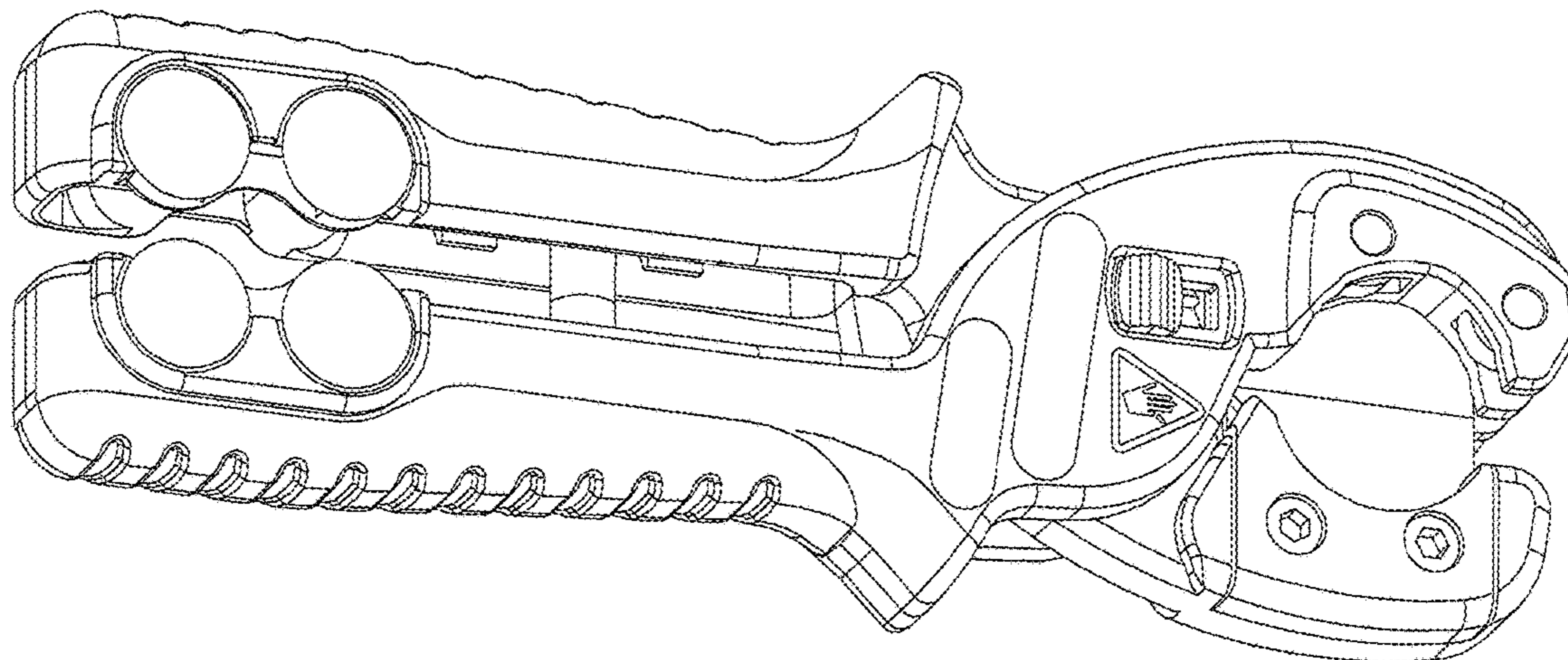

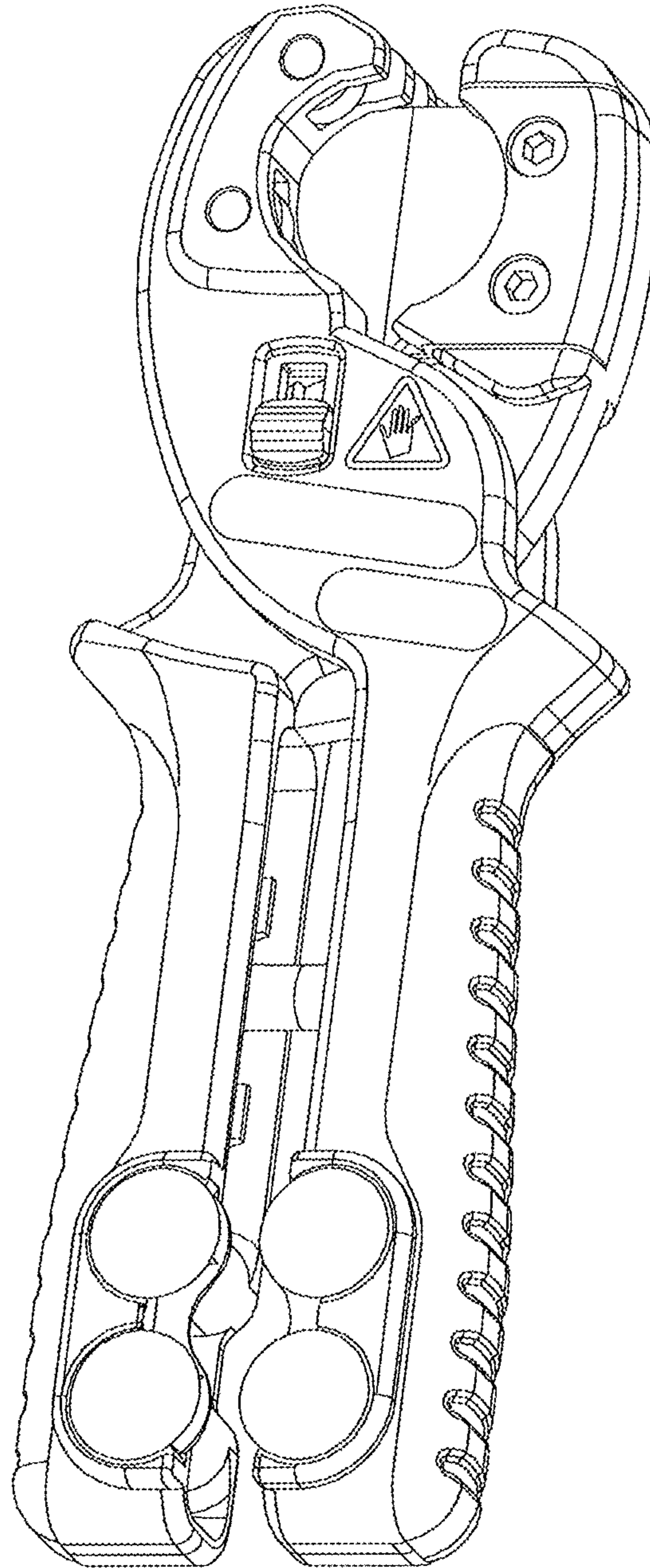

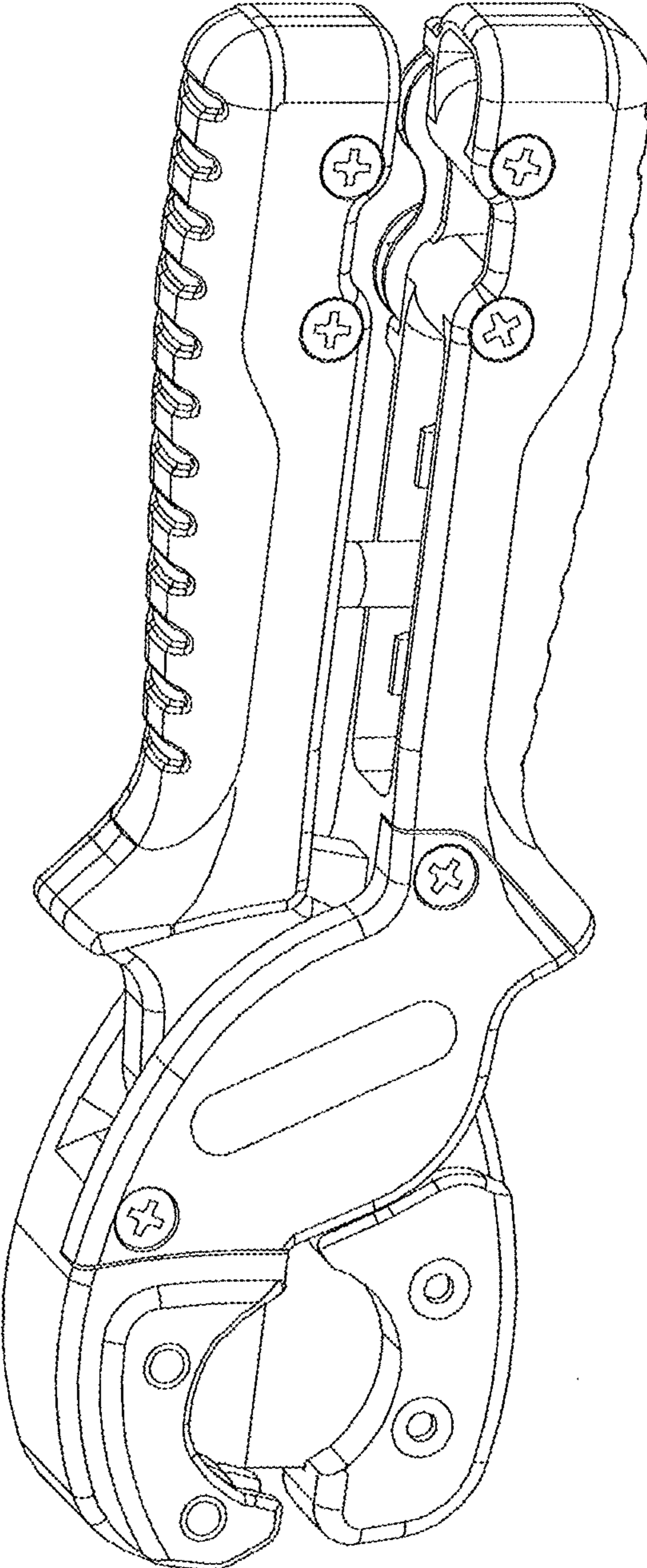

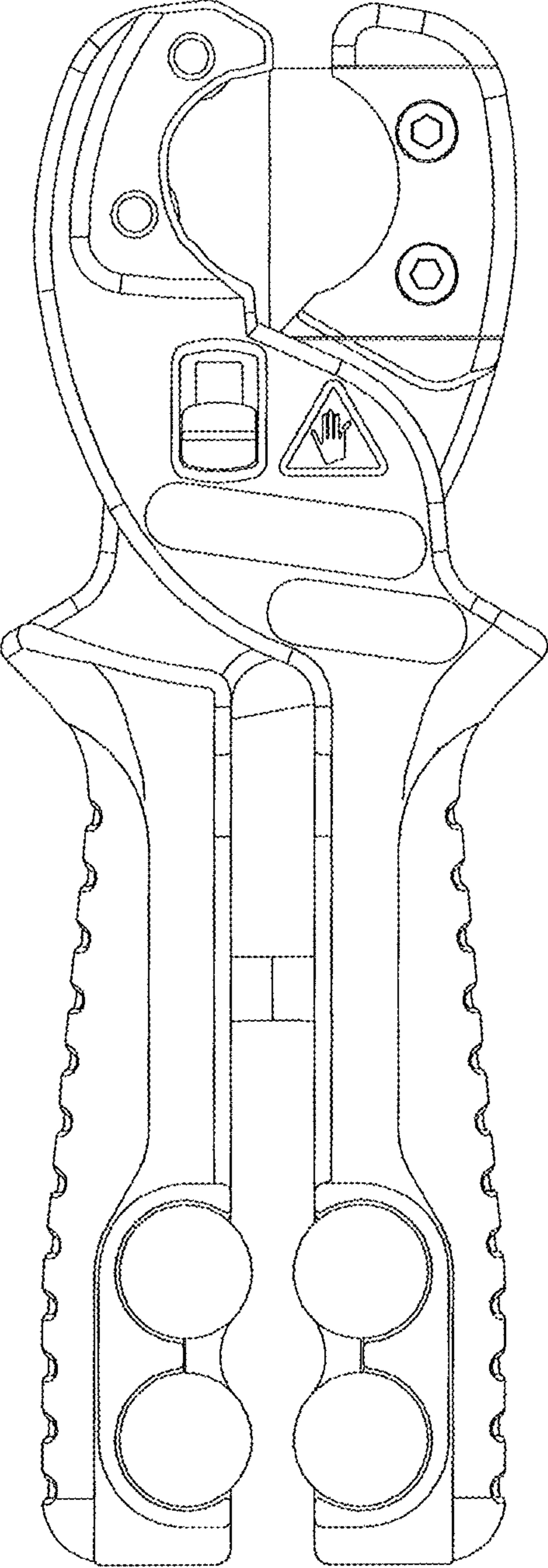
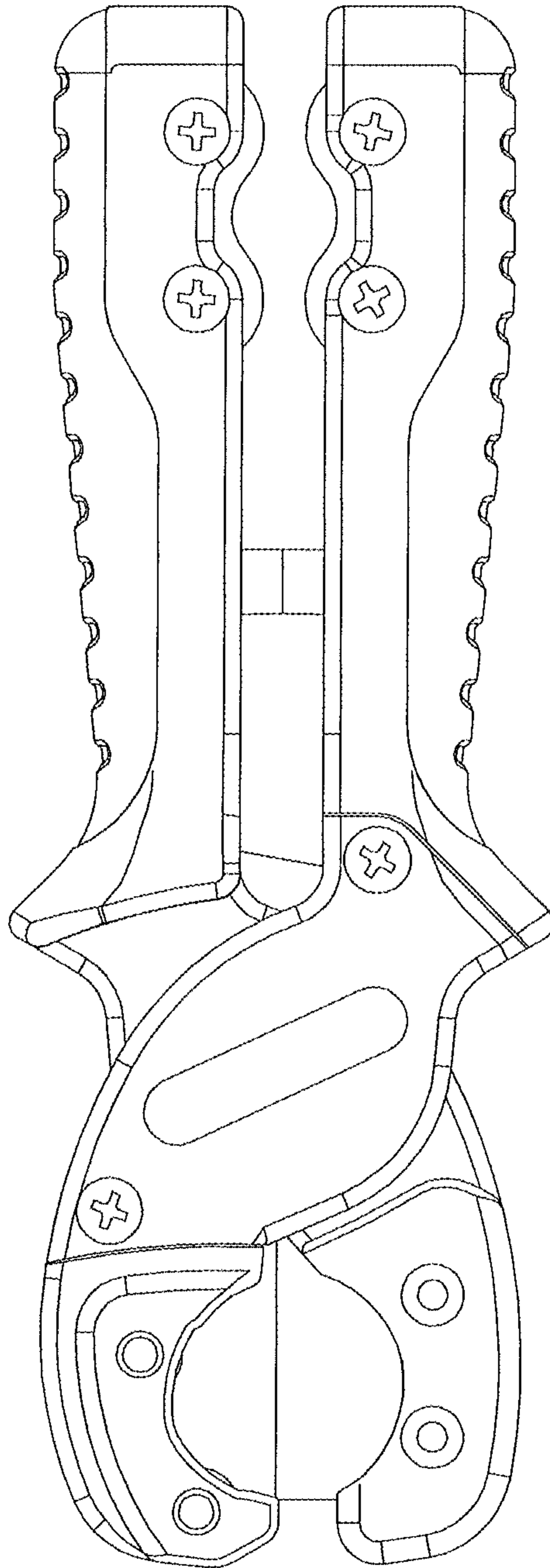

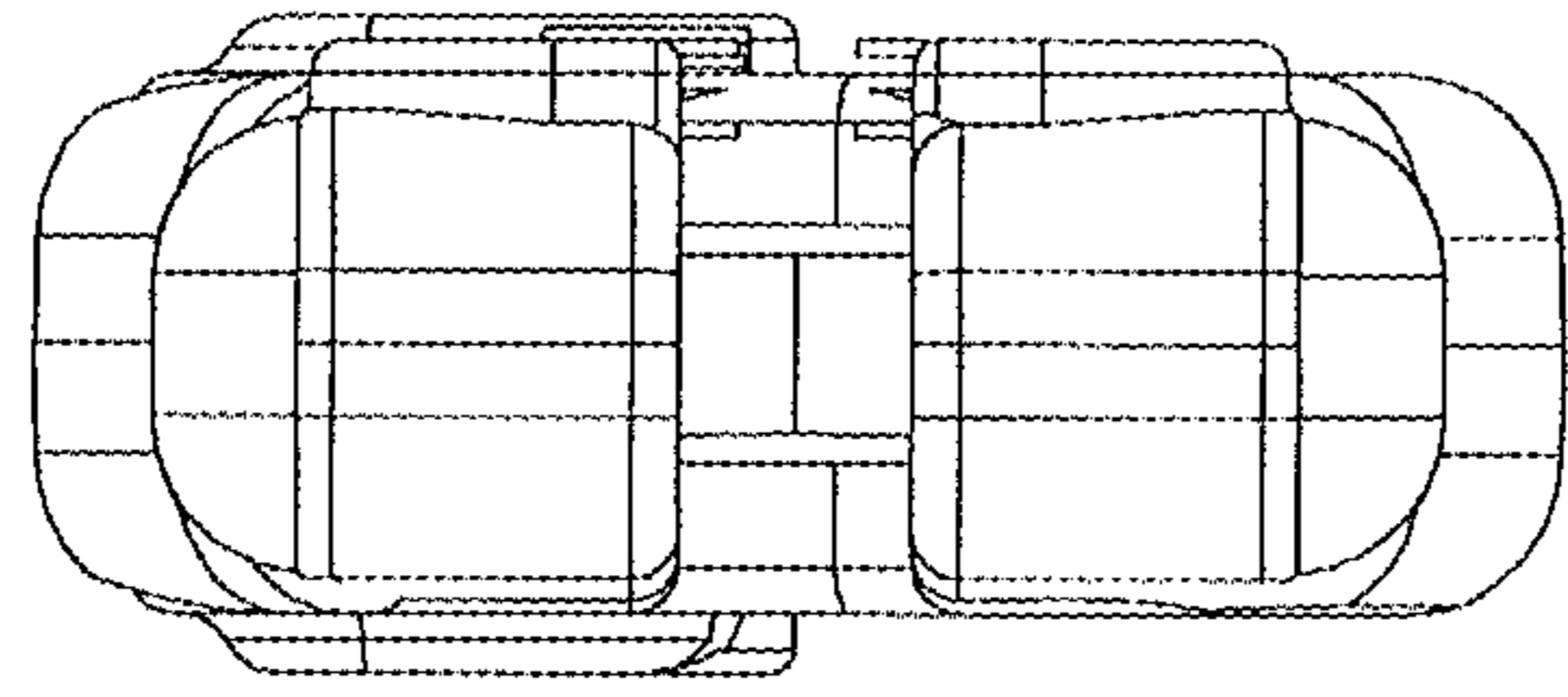

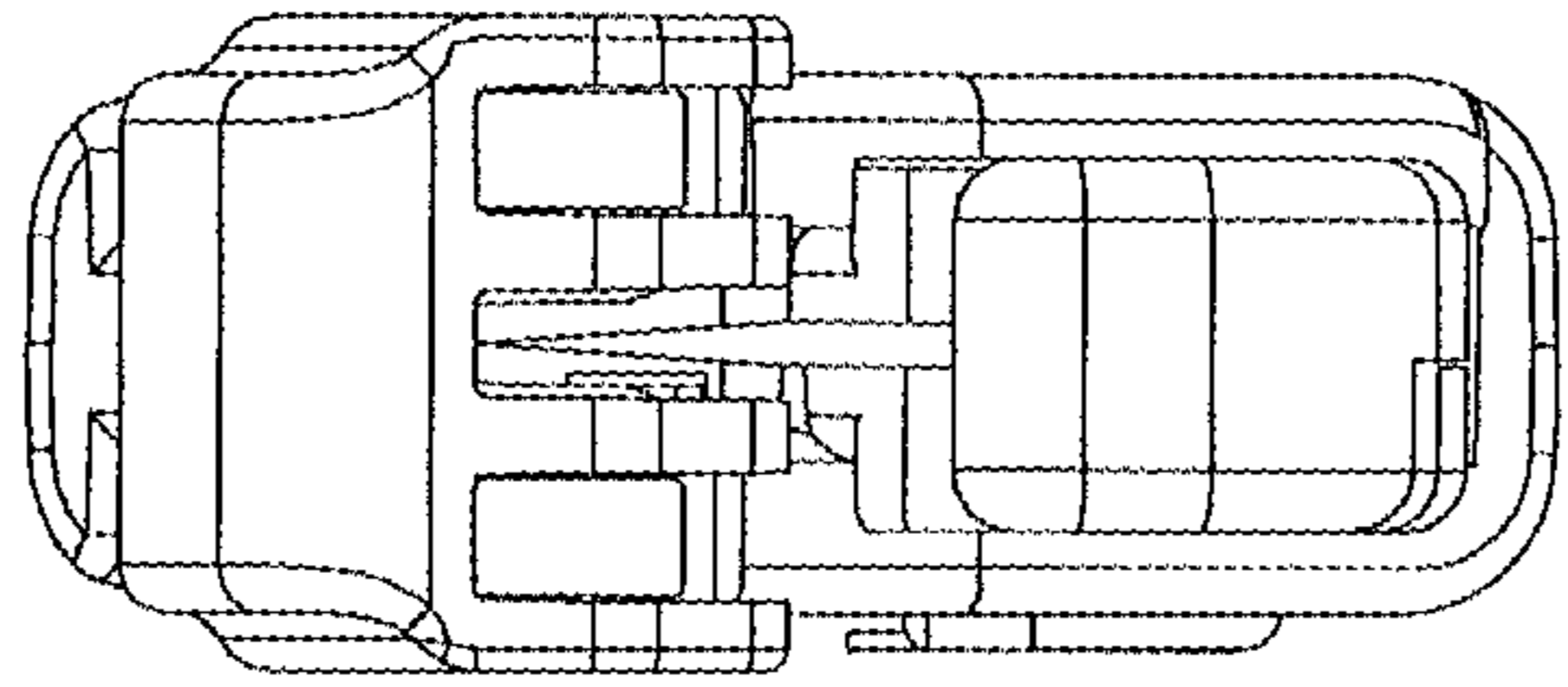

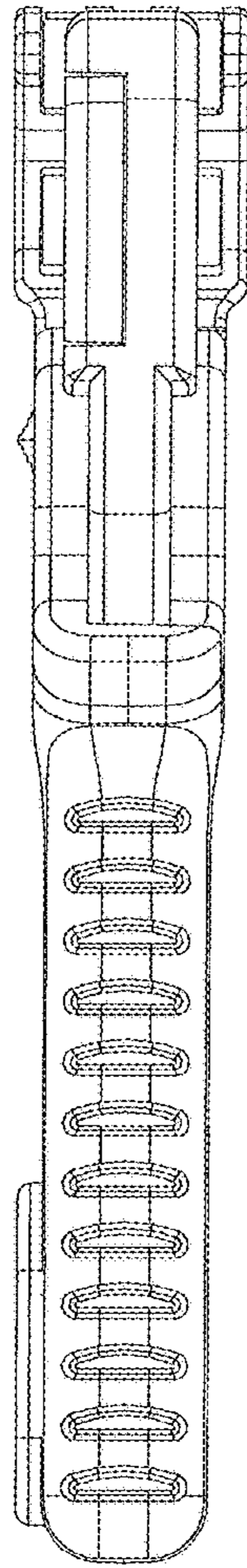
