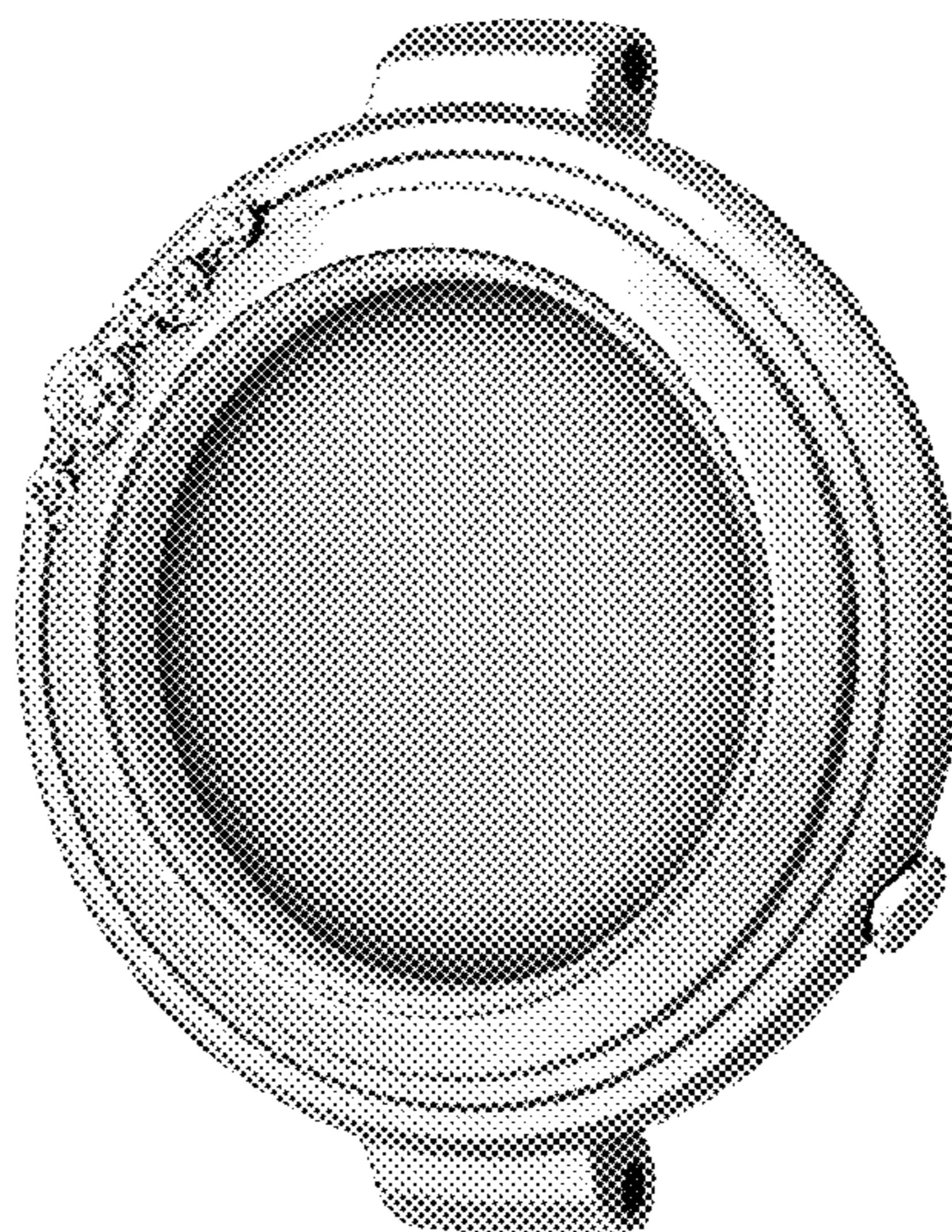
The ornamental design for a wrist watch case, as shown and described.

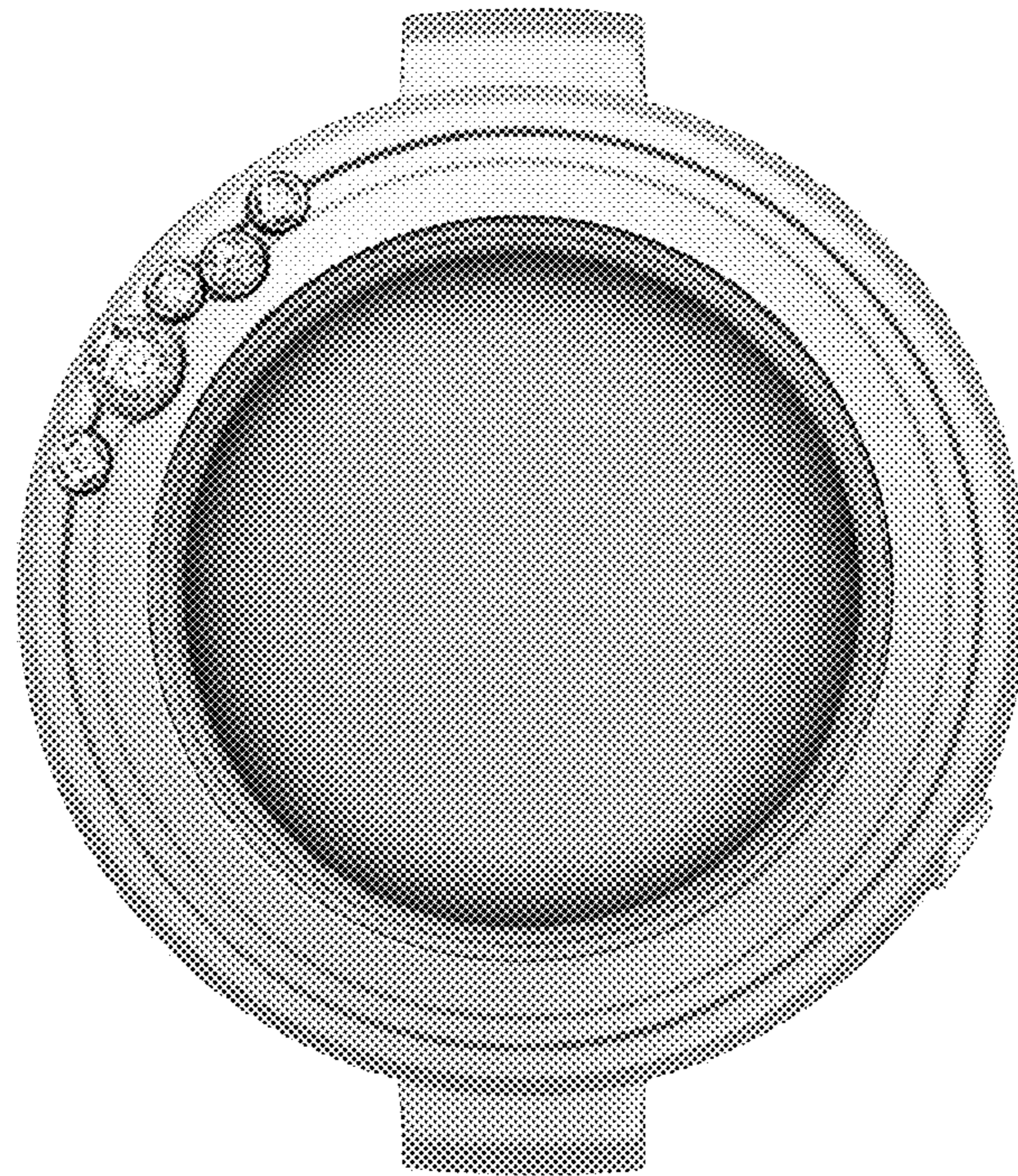

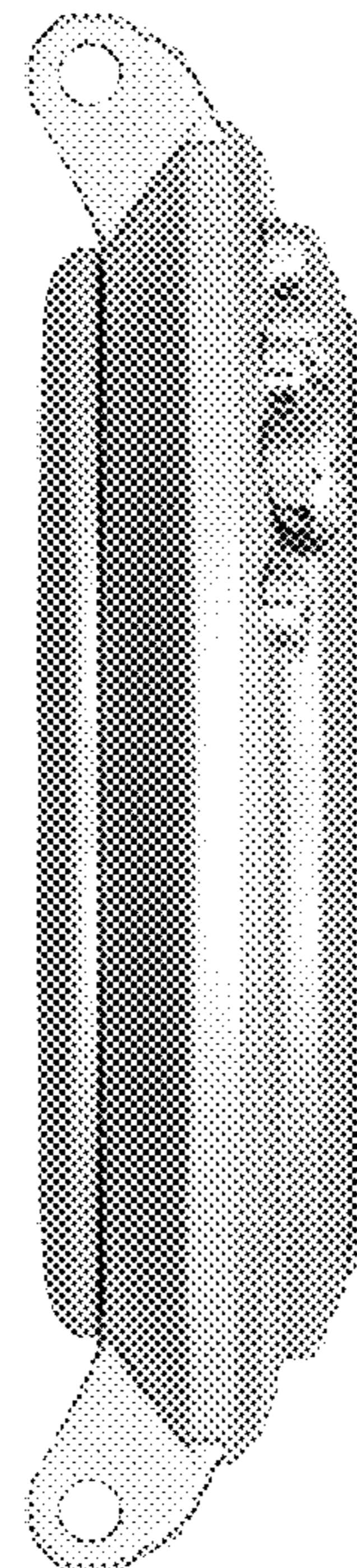

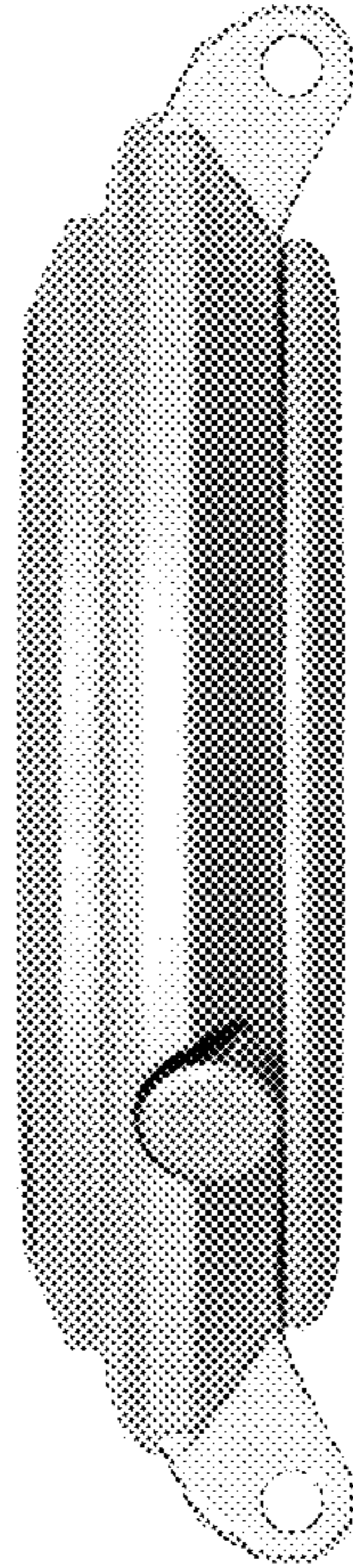

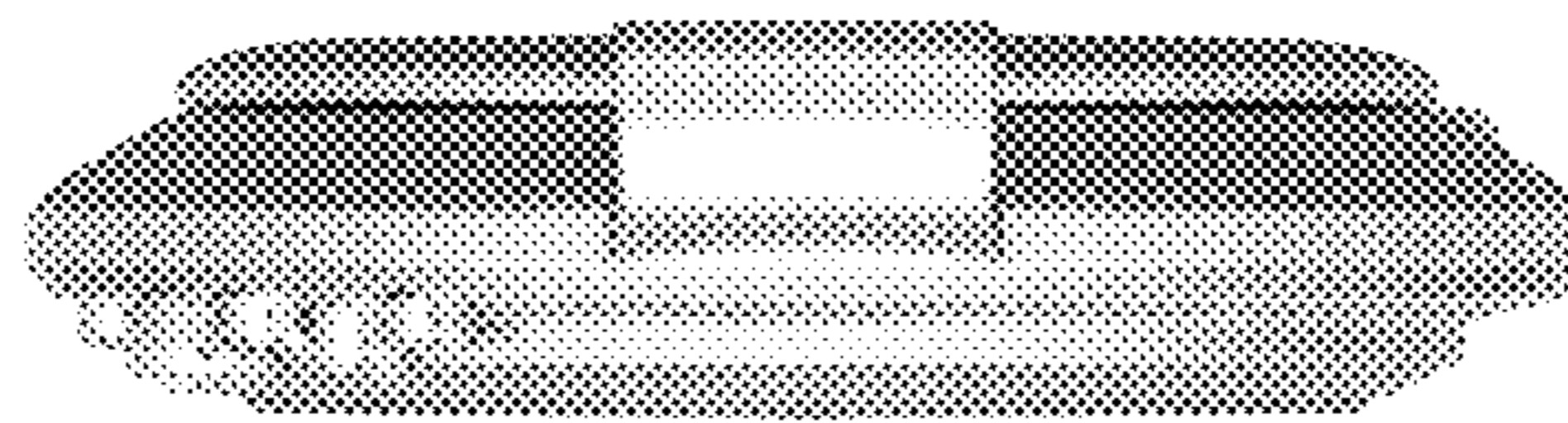
