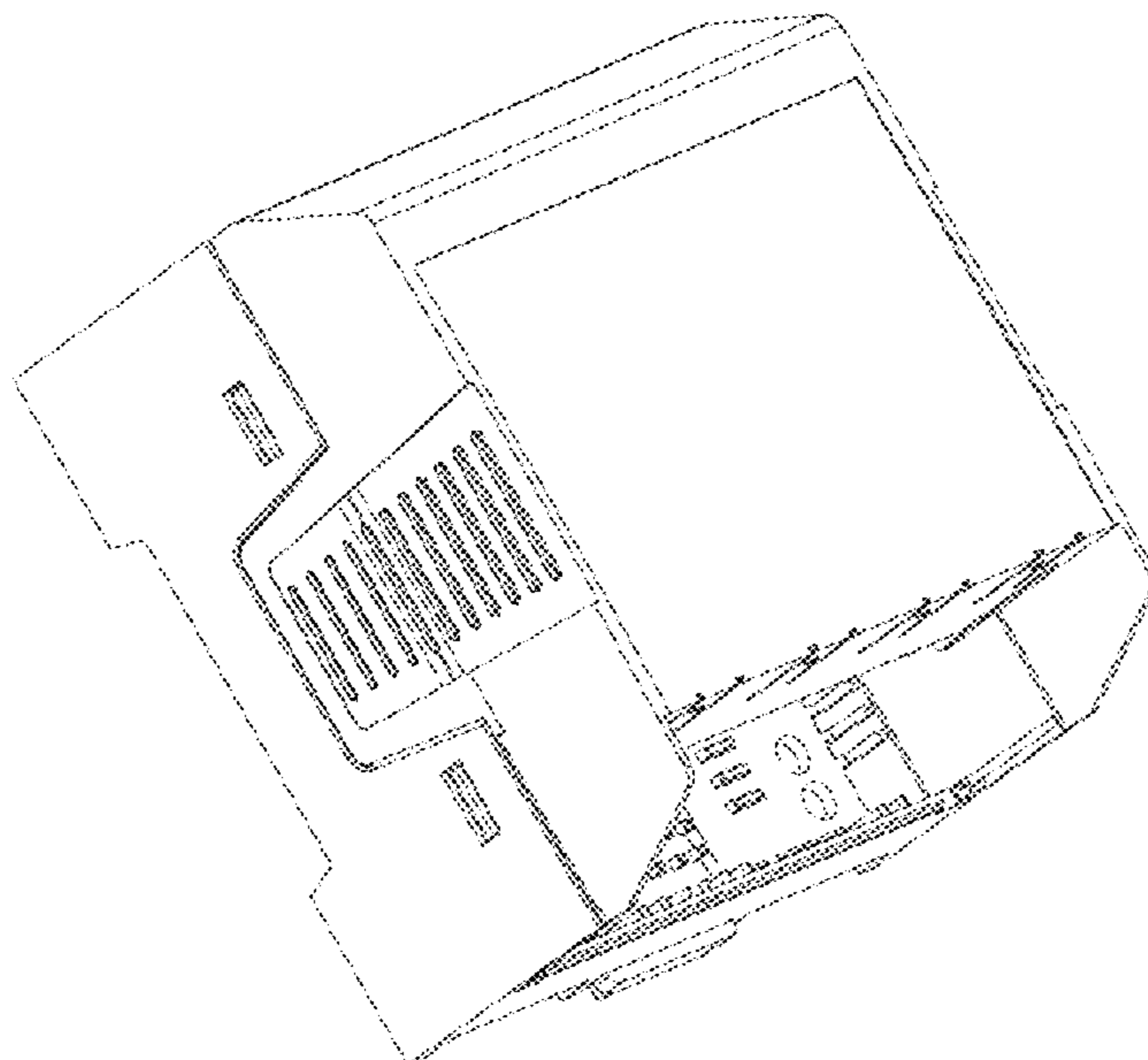
(57) **CLAIM**

The ornamental design for a housing for electrical or electronic component, as shown and described.

DESCRIPTION

FIG. 1 is a top left front perspective view of the housing for electrical or electronic component showing our new design; FIG. 2 is a left side elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a bottom plan view thereof; FIG. 5 is a front elevational view thereof; FIG. 6 is a right side elevational view thereof; and, FIG. 7 is a top plan view thereof. Any broken lines in the drawings indicate portions which form no part of the claimed design.

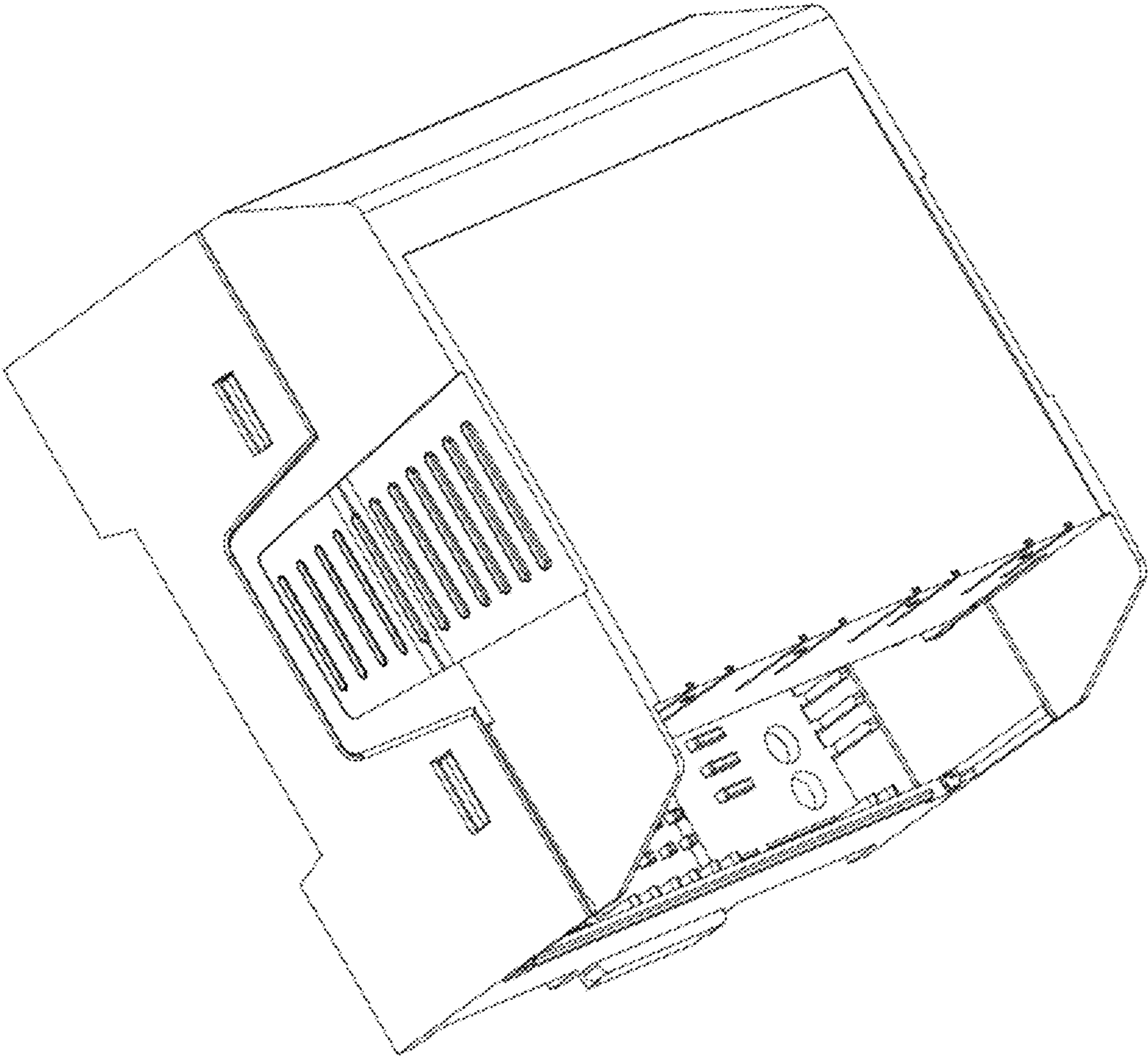

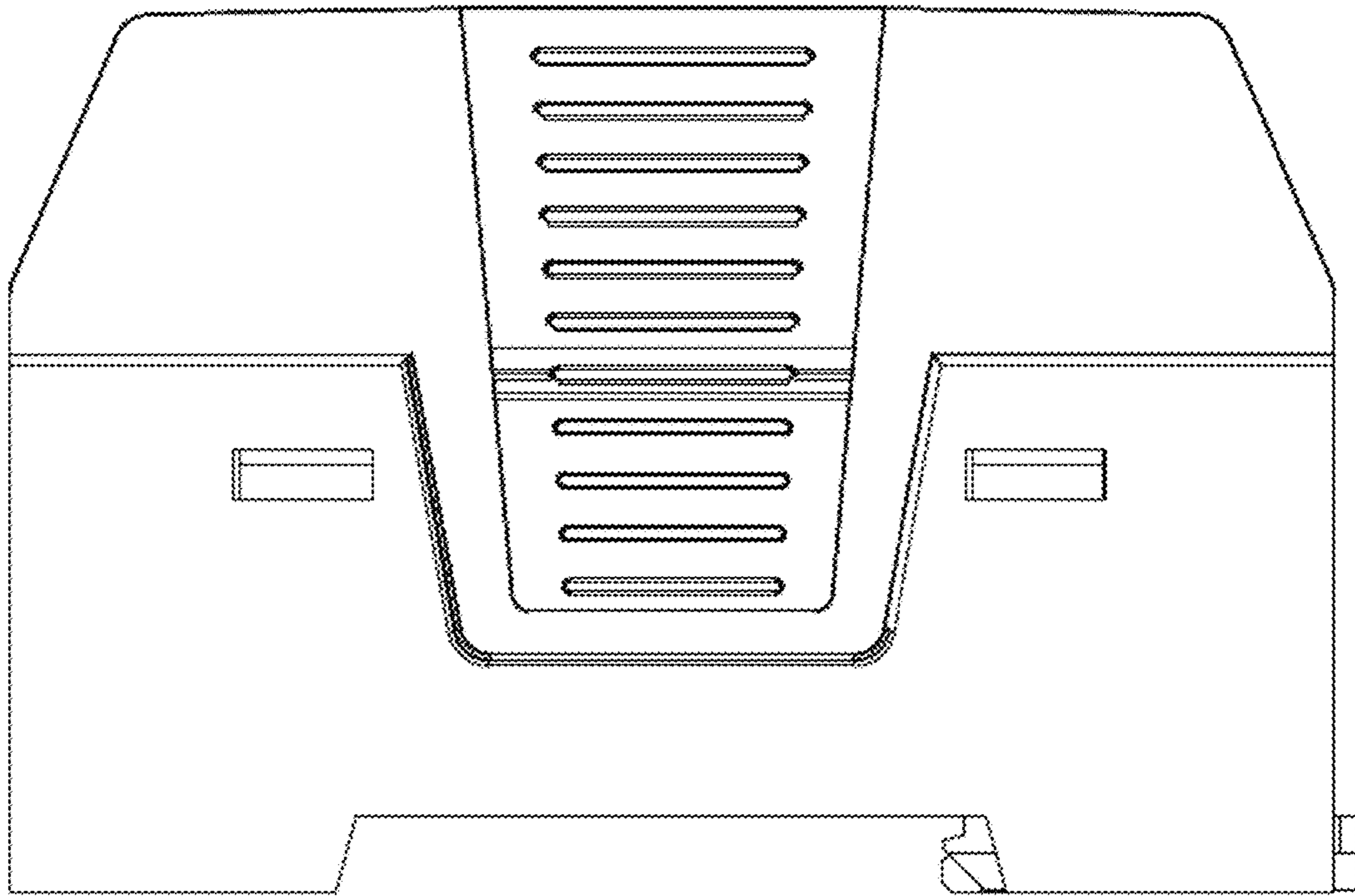

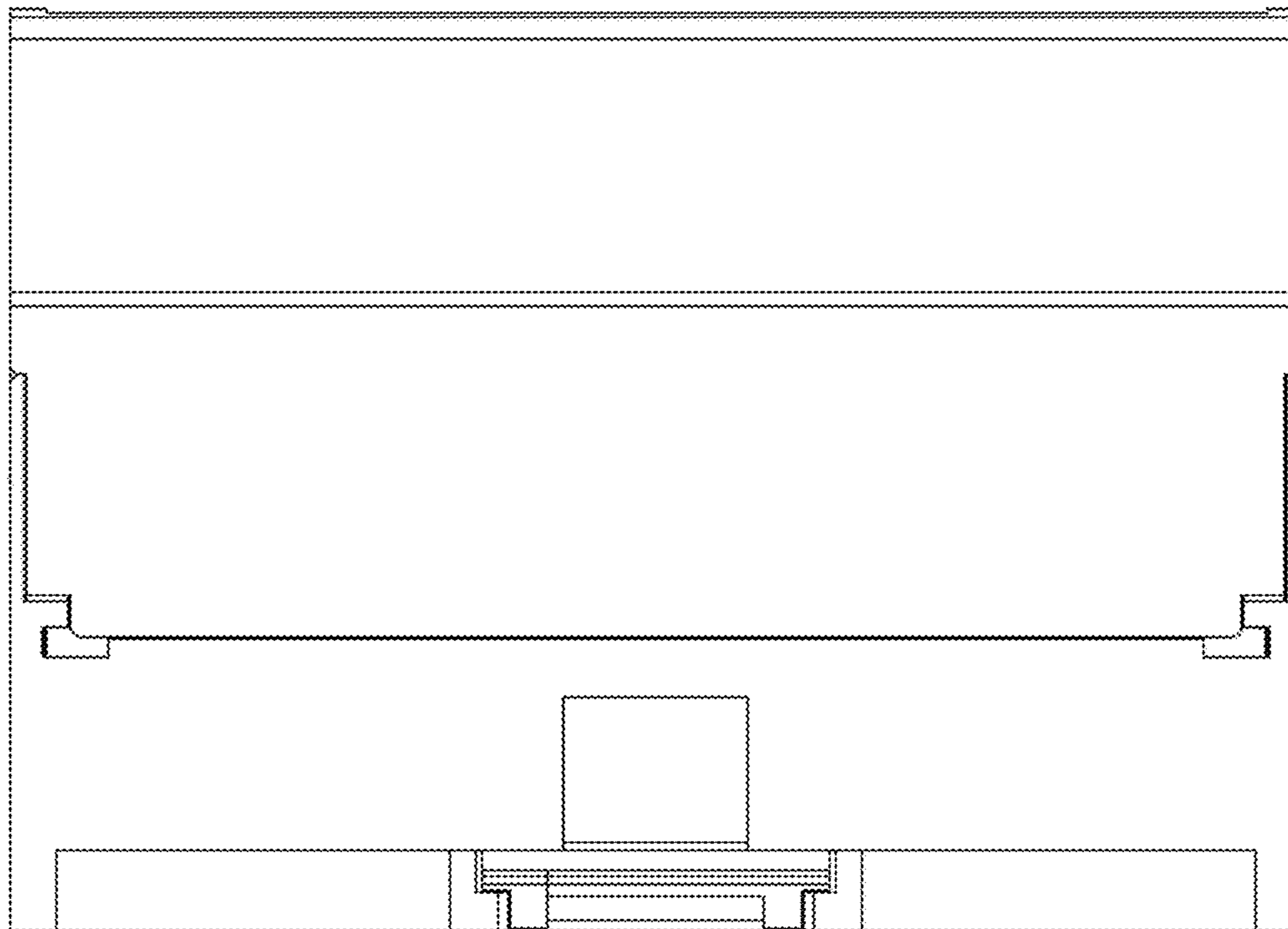

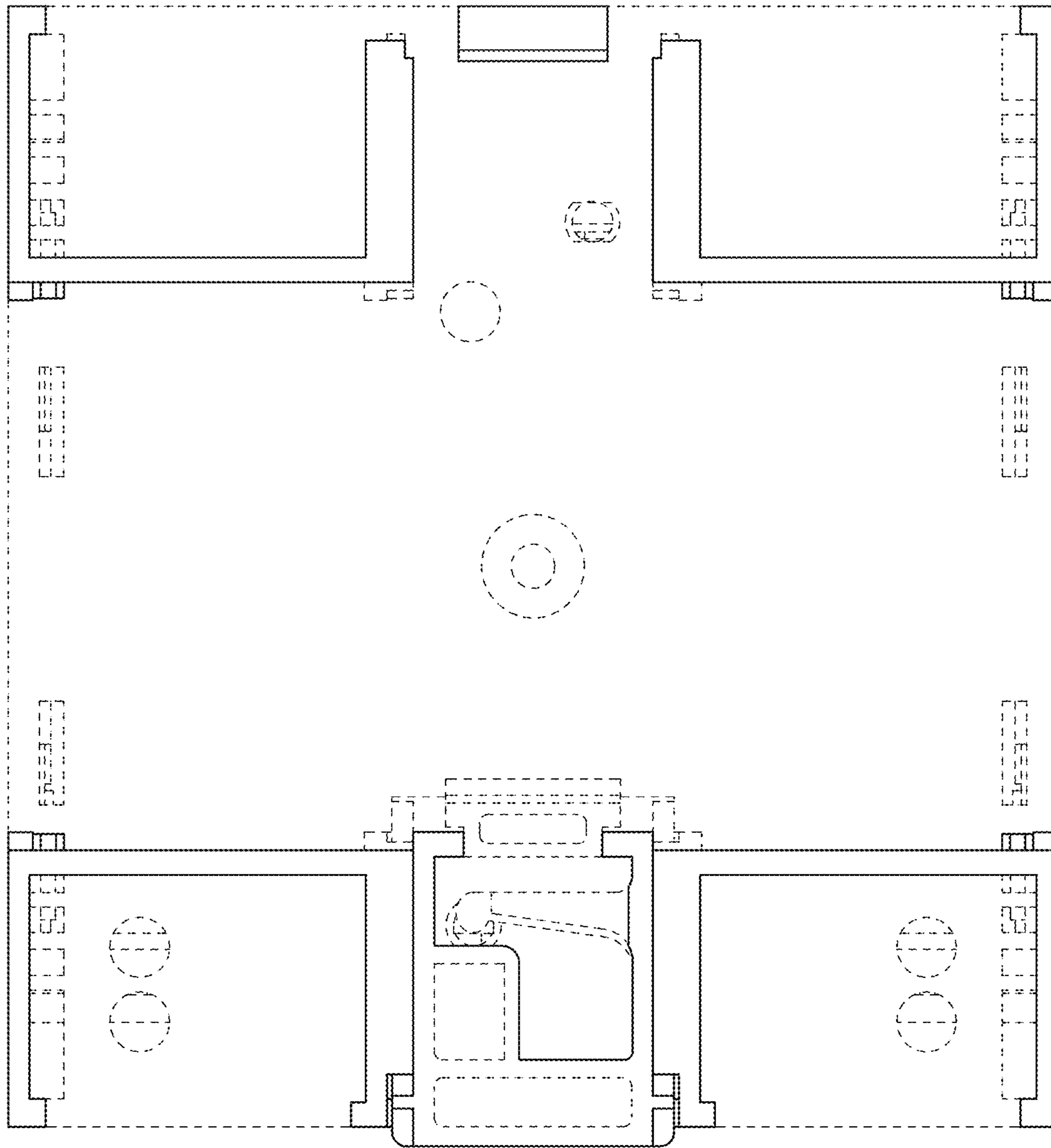

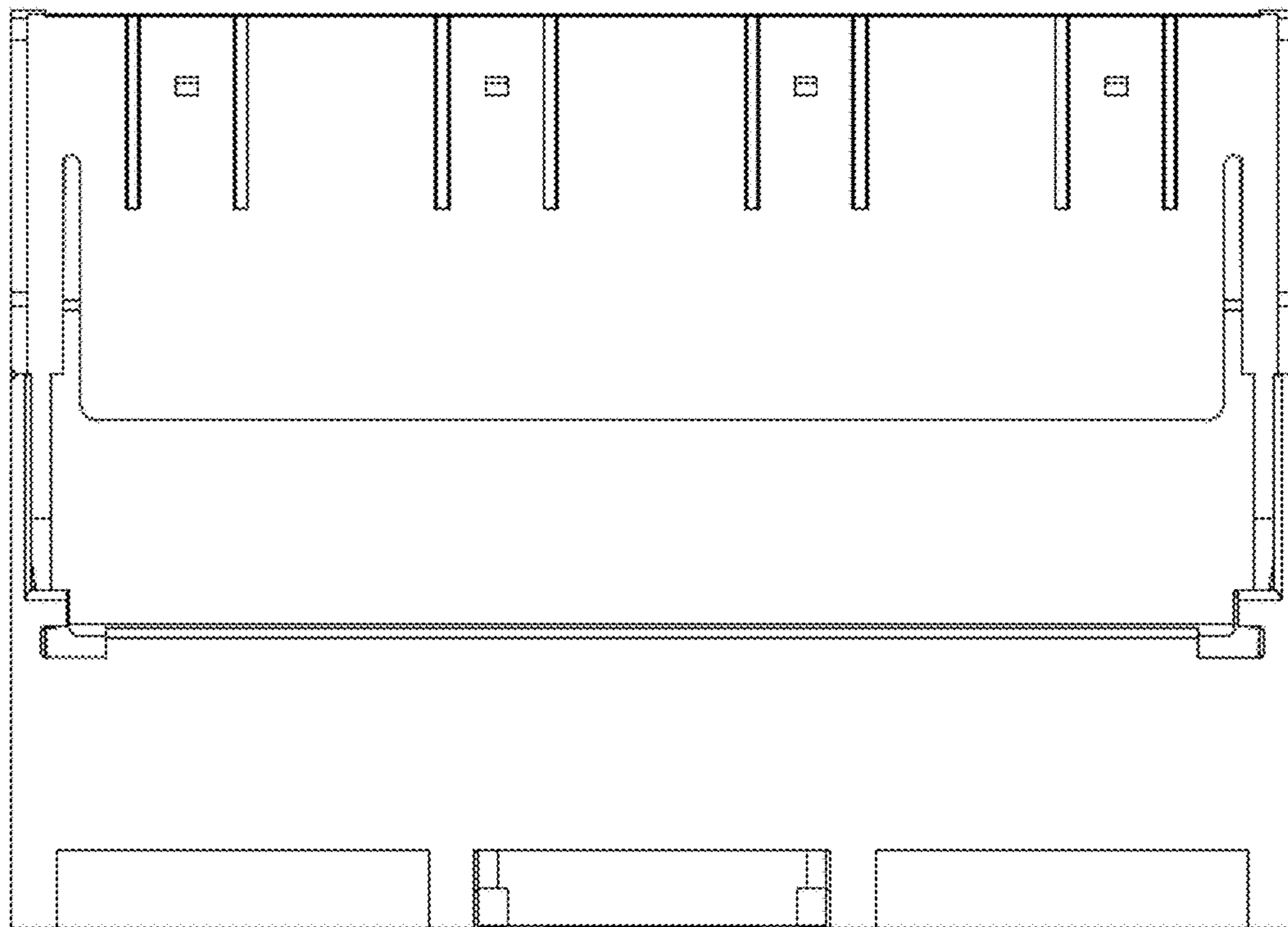

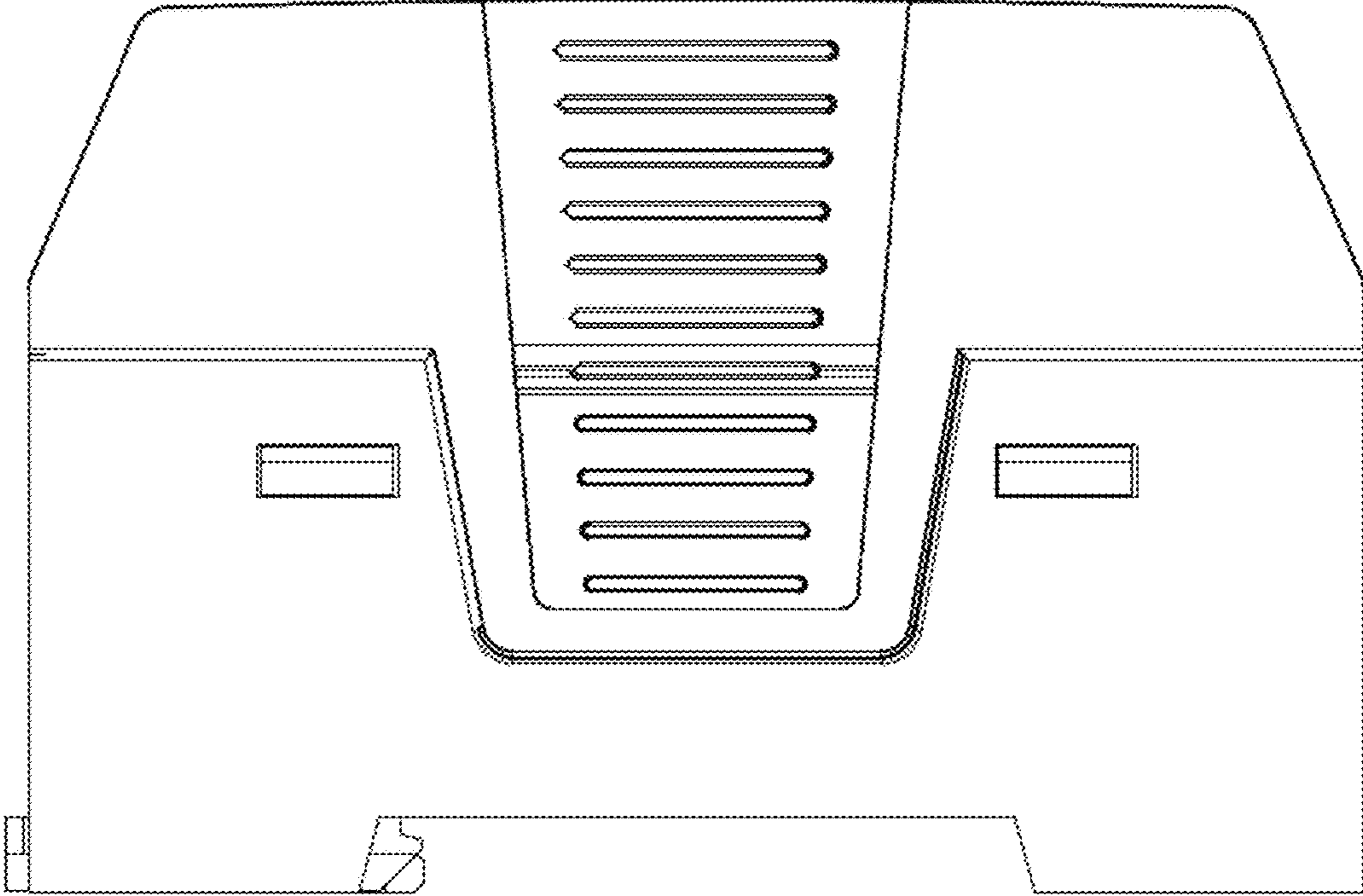

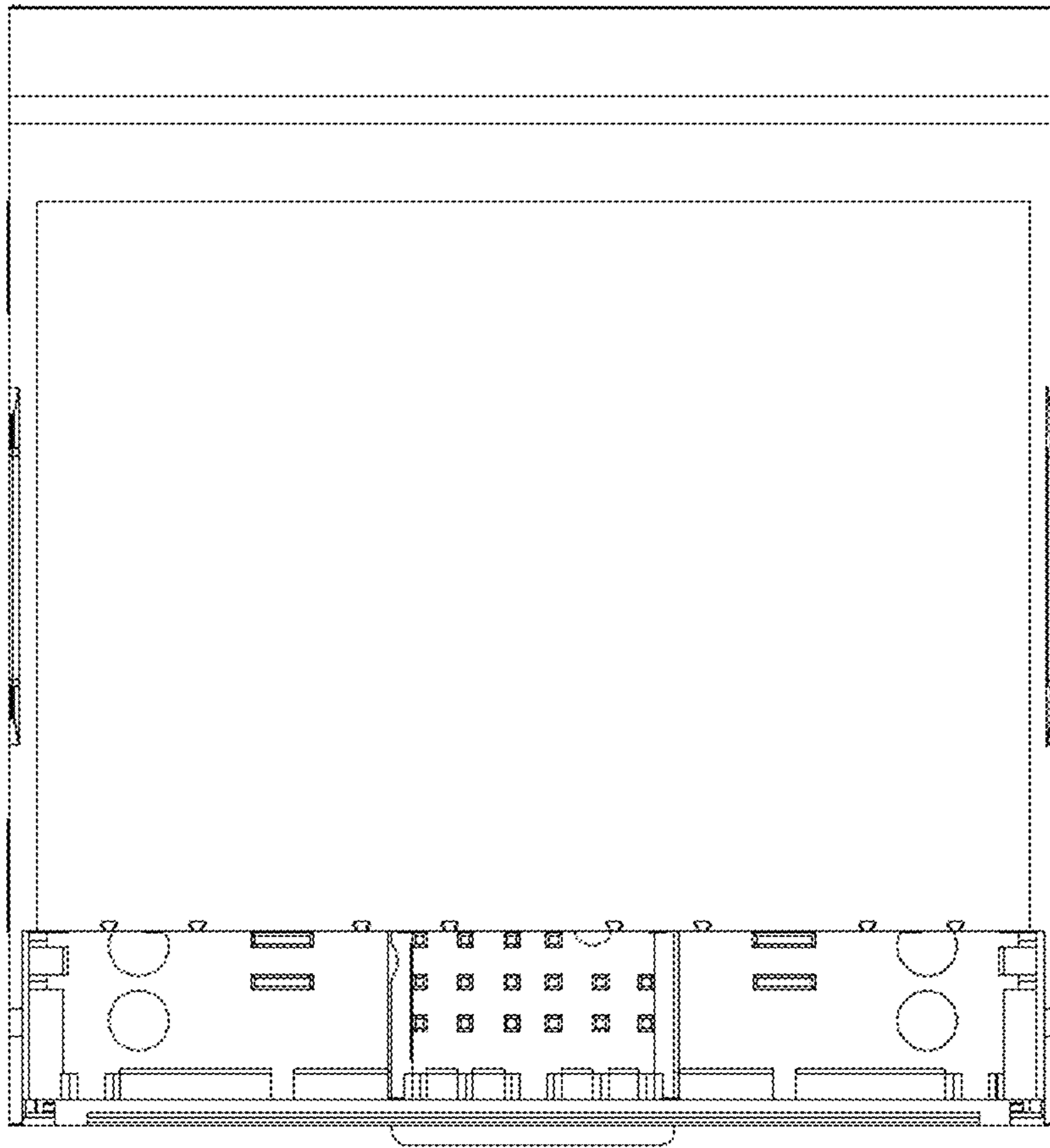
