The ornamental design for a smart phone, as shown and described.

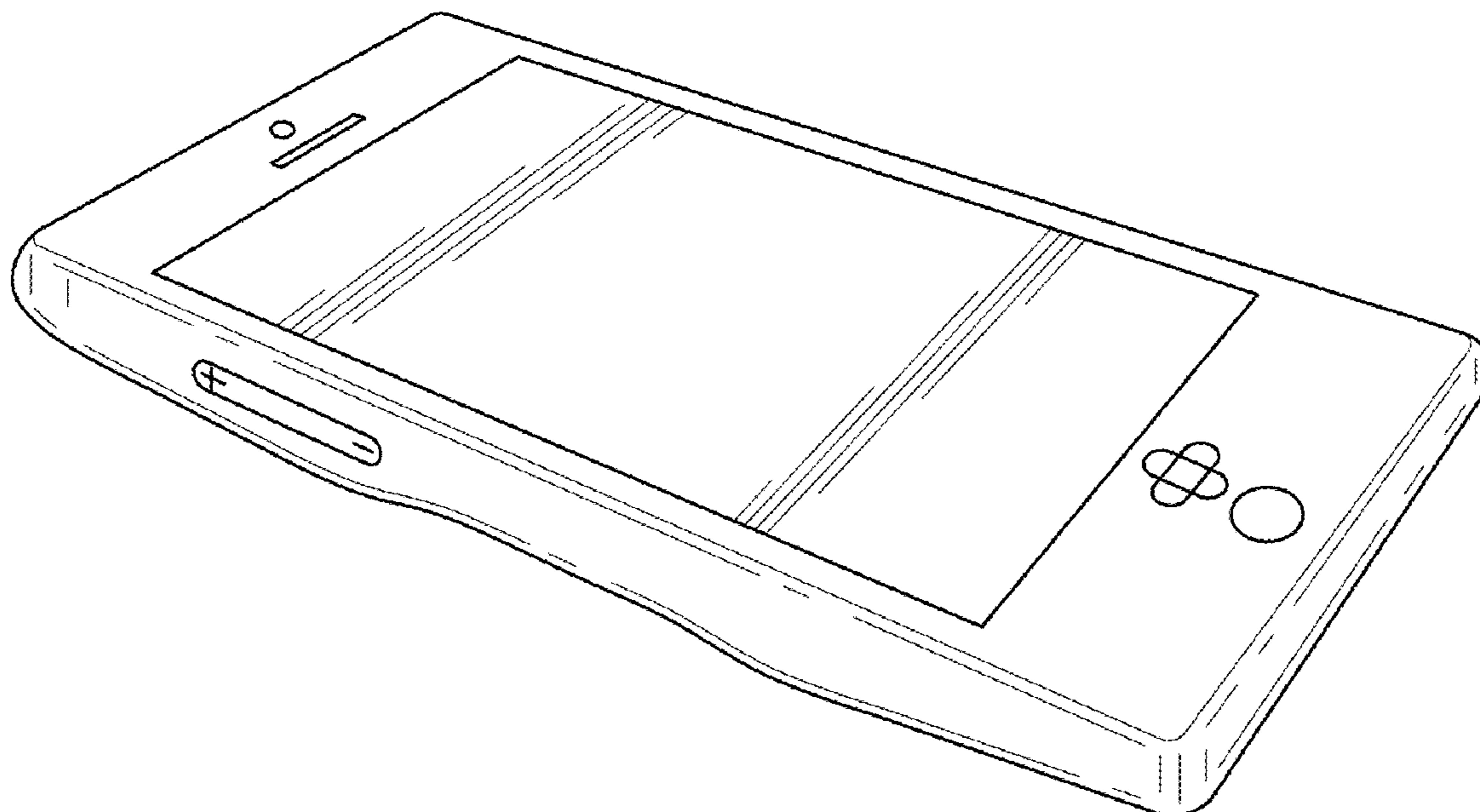
DESCRIPTION

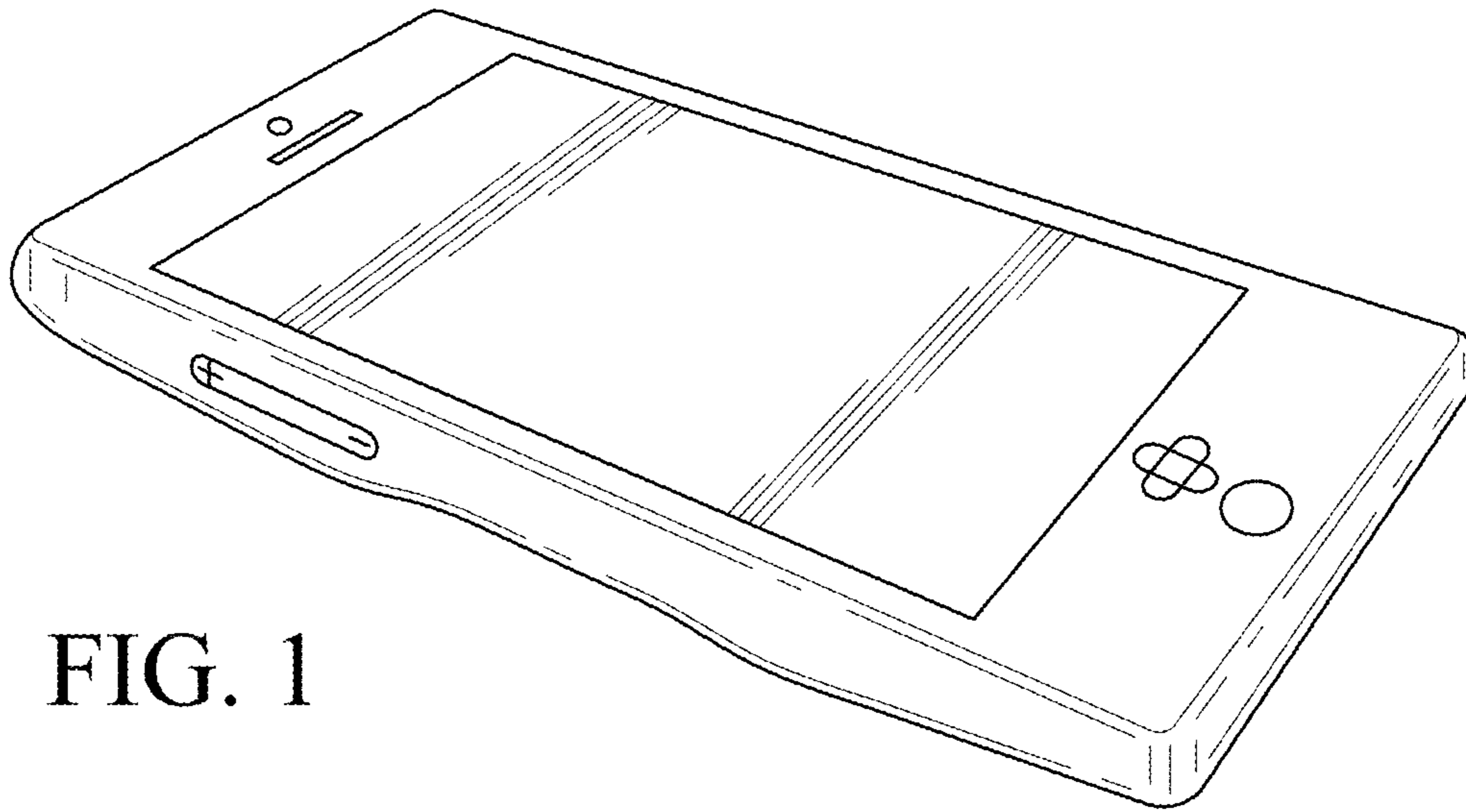

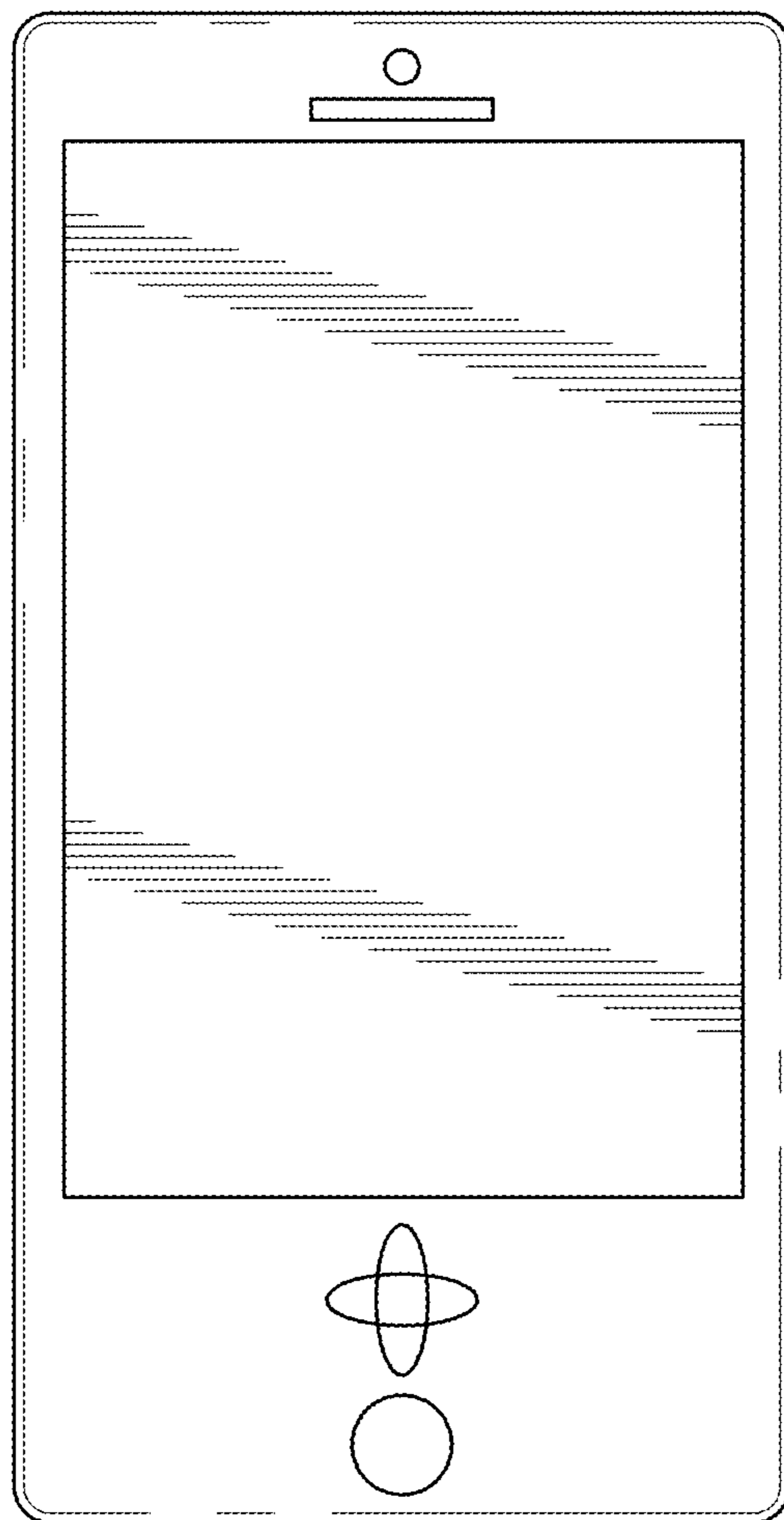

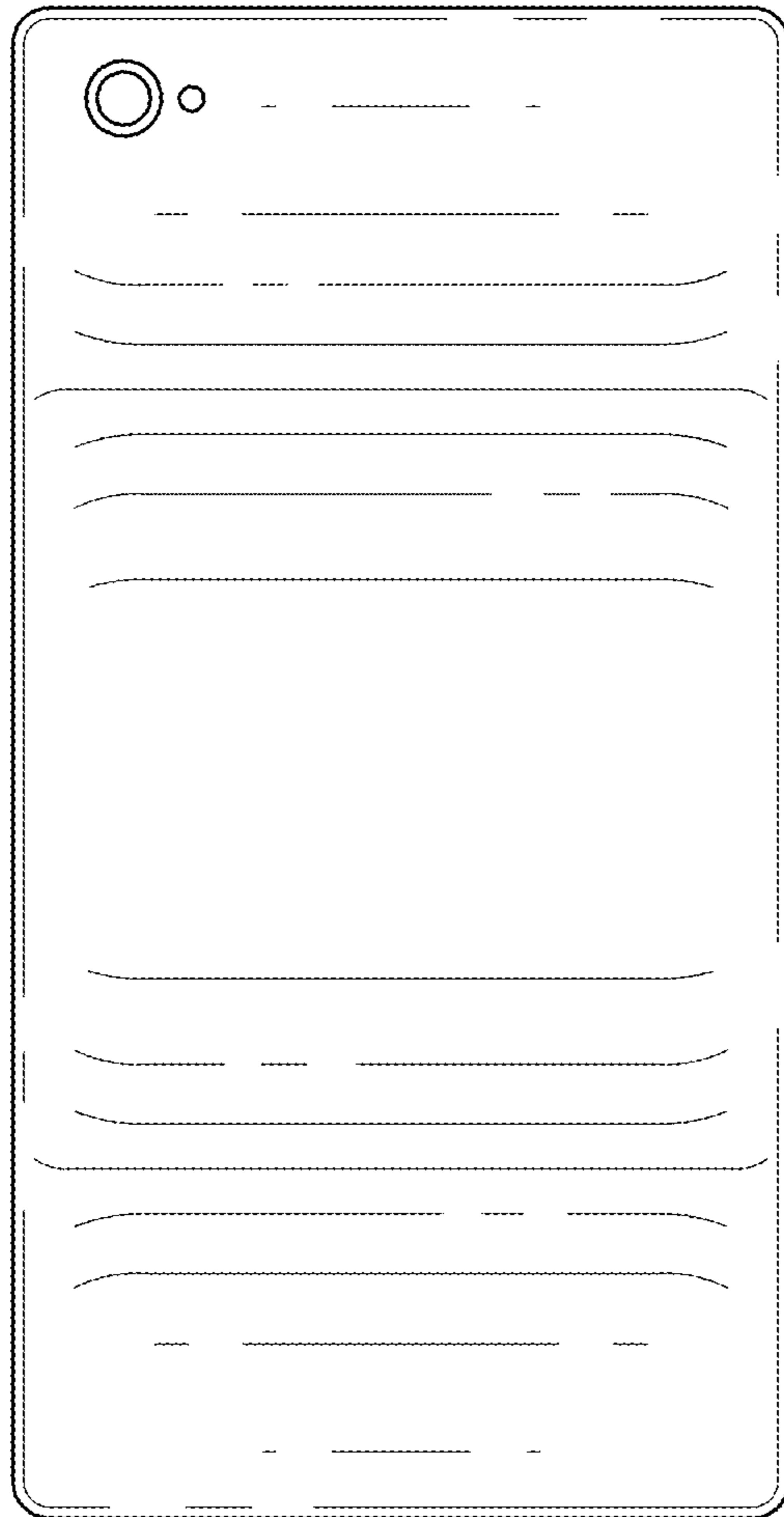

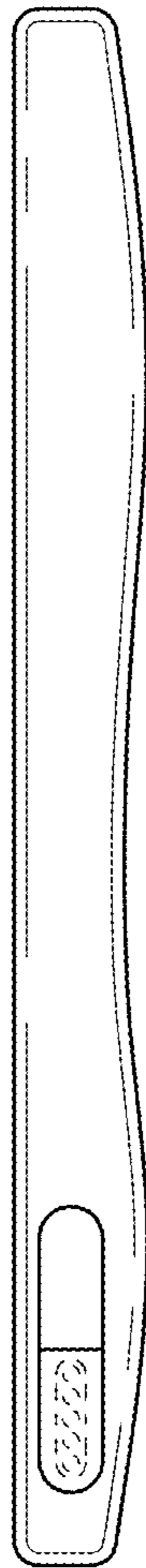

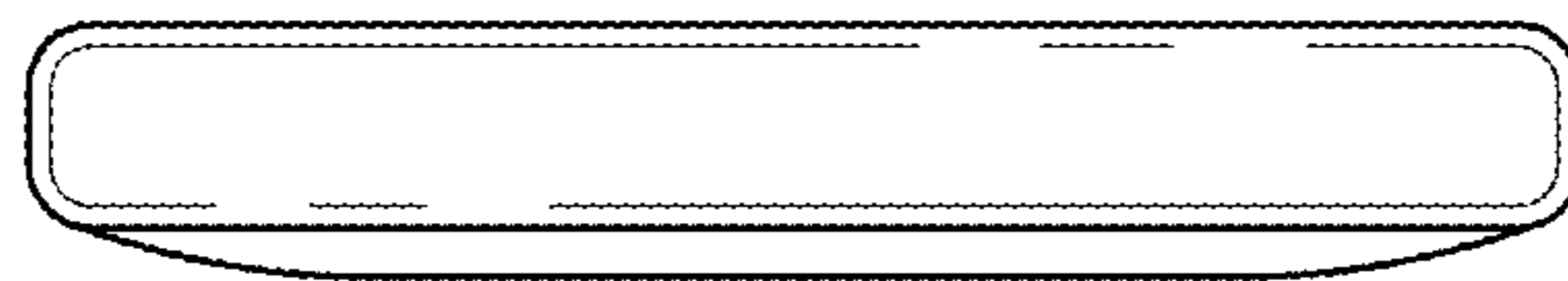
