The ornamental design for a loudspeaker, as shown and described.

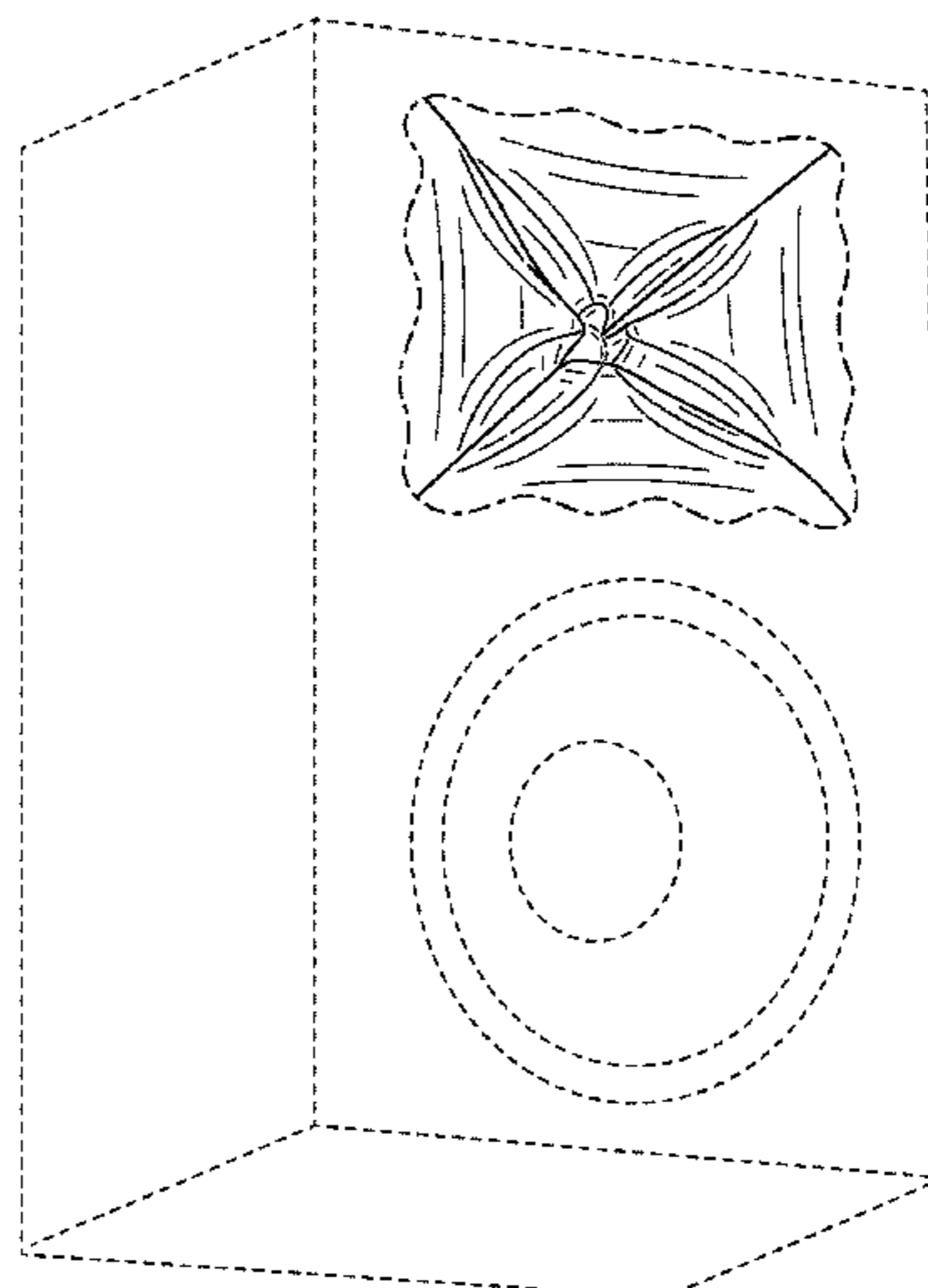
DESCRIPTION

FIG. 1 is a first perspective view of a loudspeaker, showing my new design;
 FIG. 2 is a second perspective view thereof, shown without the rest of the loudspeaker, for ease of illustration;
 FIG. 3 is an elevational view thereof, shown without the rest of the loudspeaker, for ease of illustration;
 FIG. 4 is a third perspective view thereof, shown without the rest of the loudspeaker, for ease of illustration;
 FIG. 5 is a cross-section thereof, taken in the direction of line 5-5 of FIG. 3; and,
 FIG. 6 is a cross-section thereof, taken in the direction of line 6-6 of FIG. 3.
 The broken line showings of the center circles and the remainder of the loudspeaker form no part of the claimed design.
 The dot-dash broken lines define the bounds of the claimed design and form no part thereof.

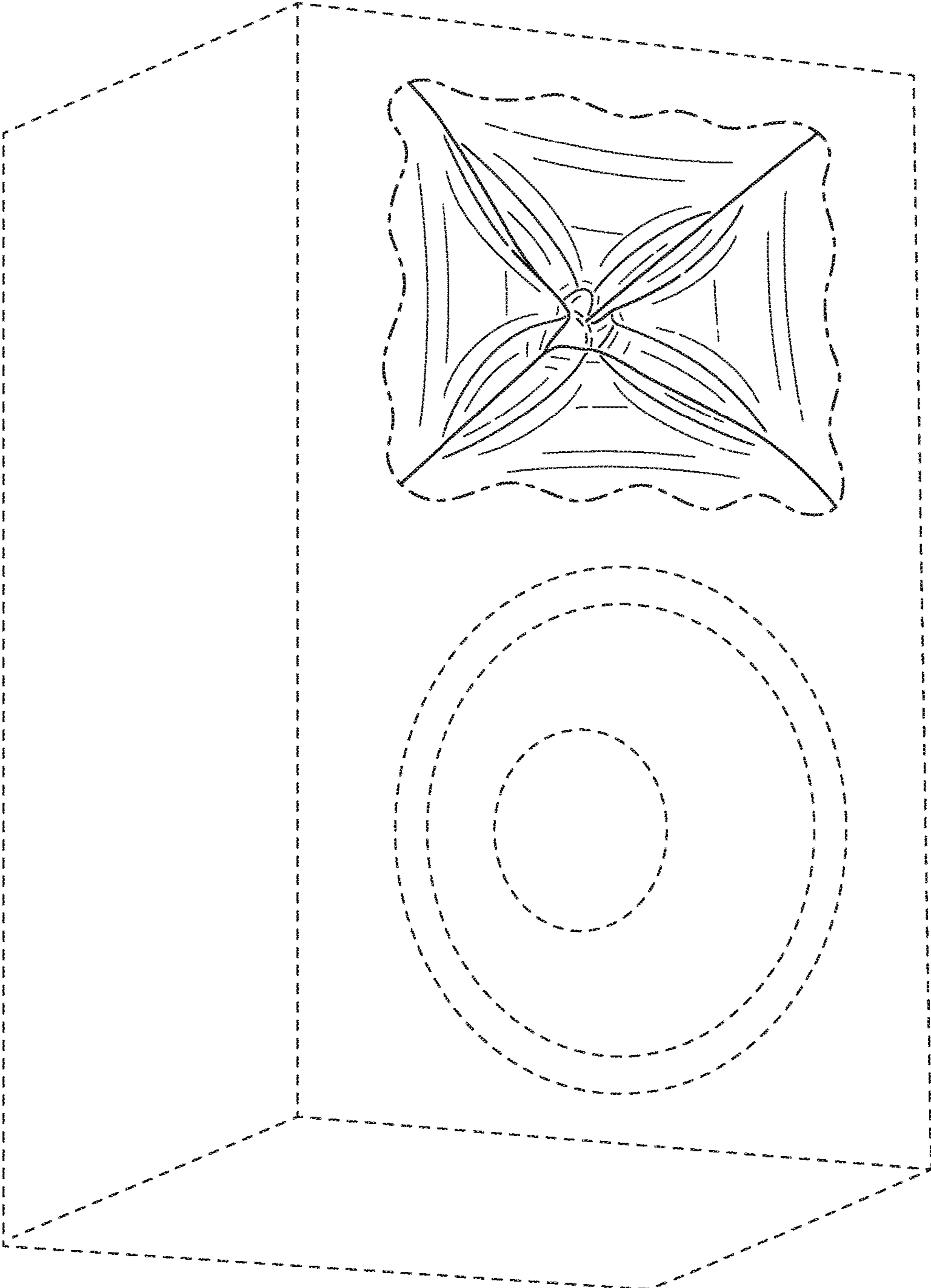

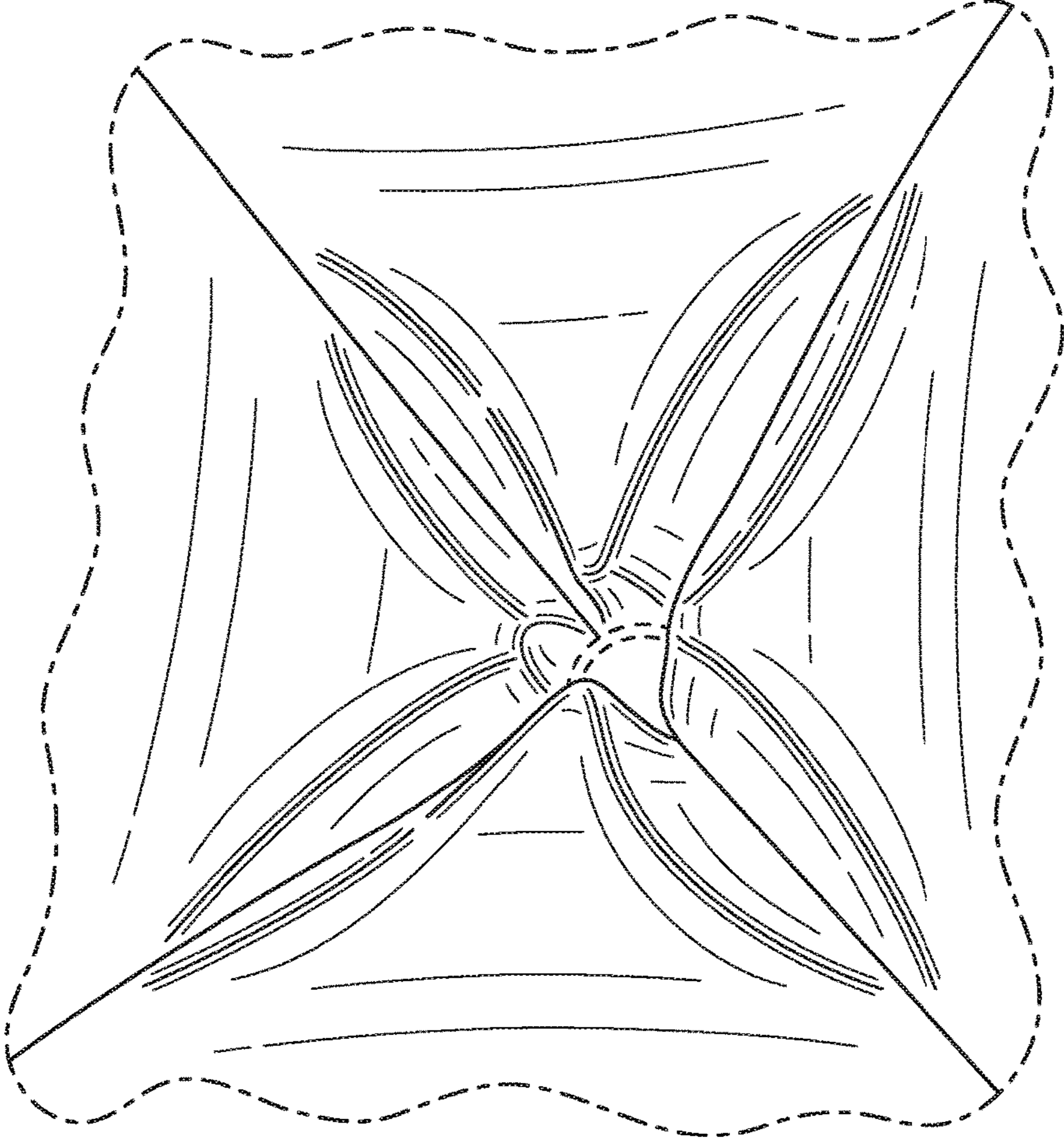

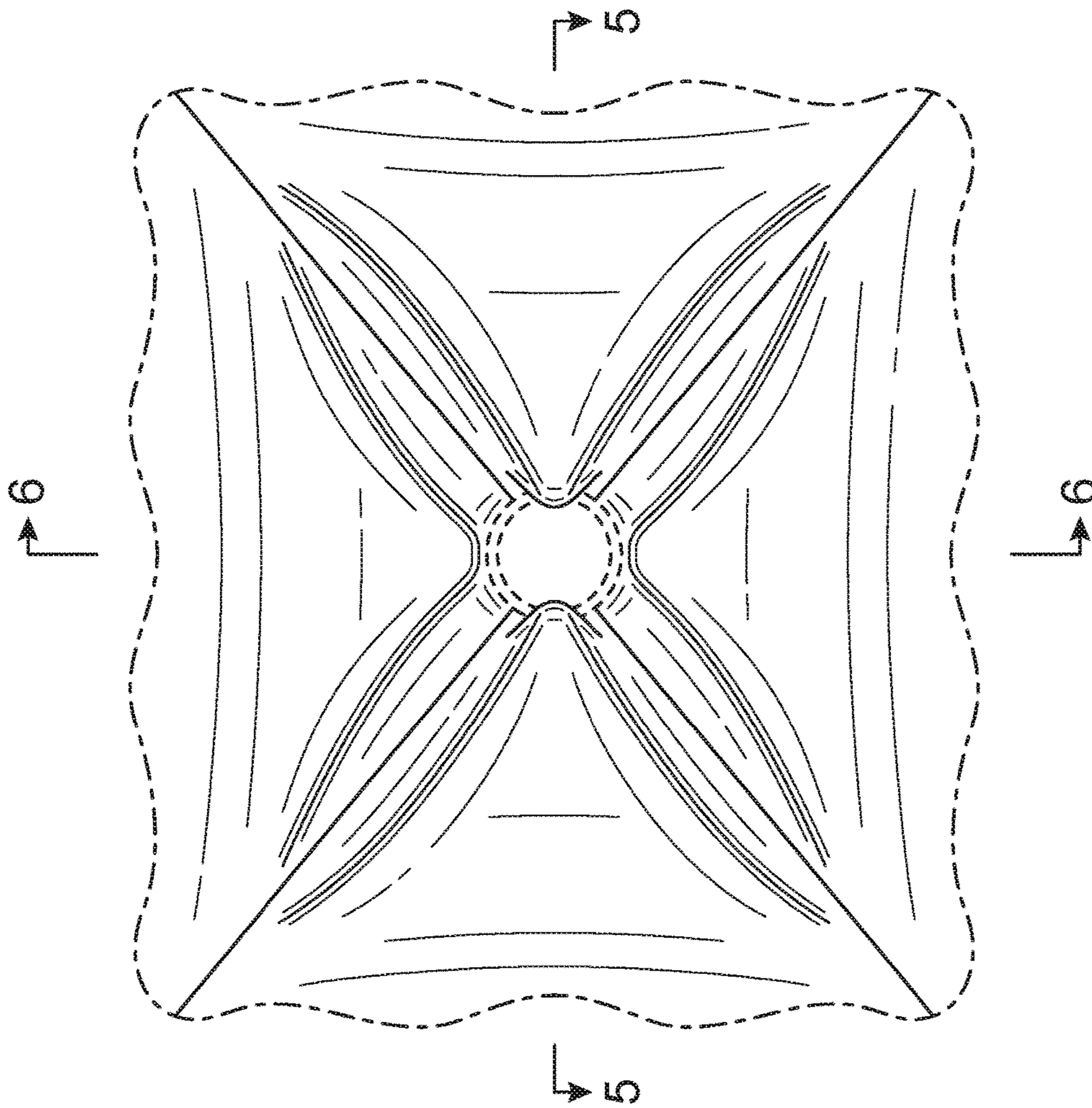

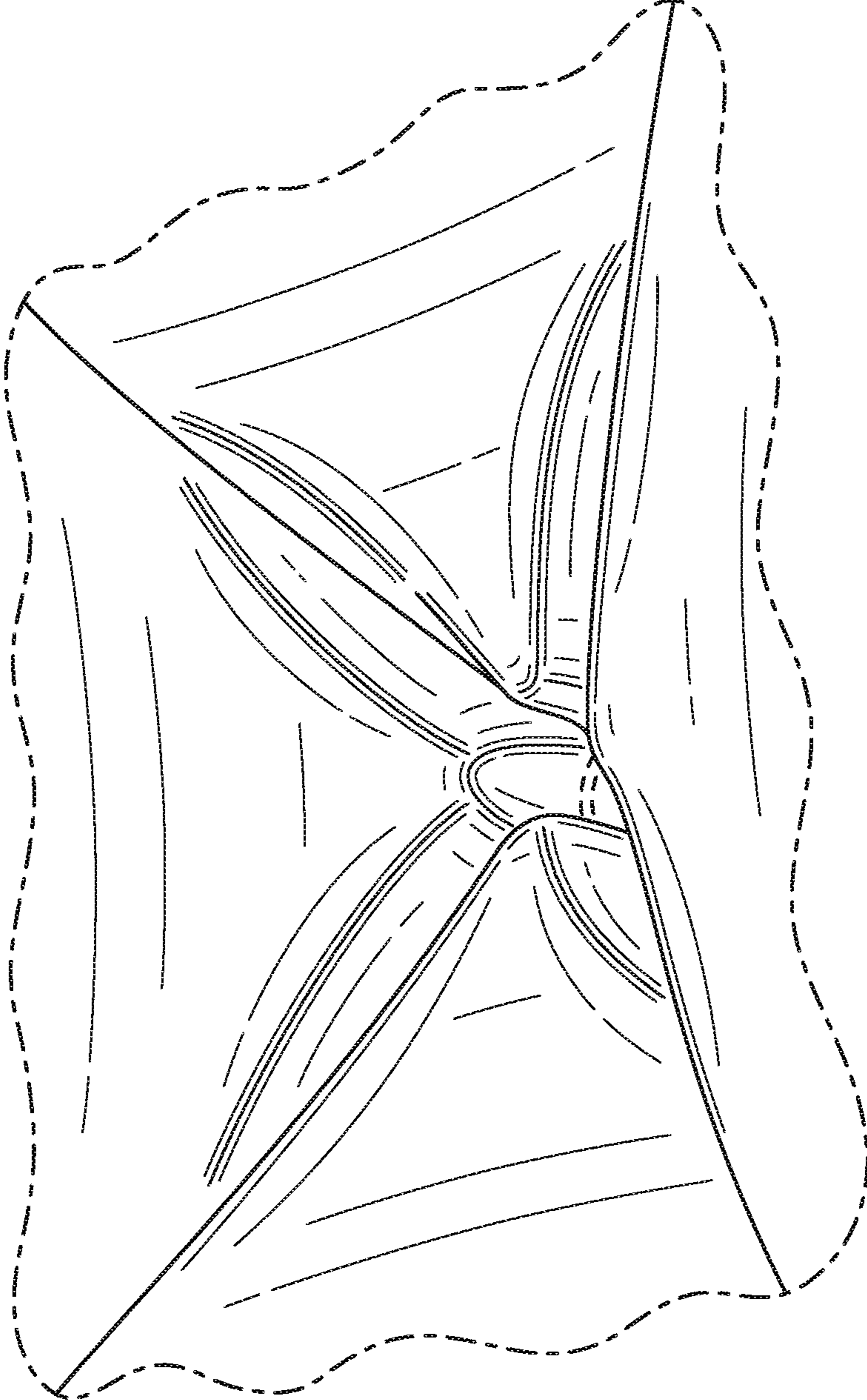

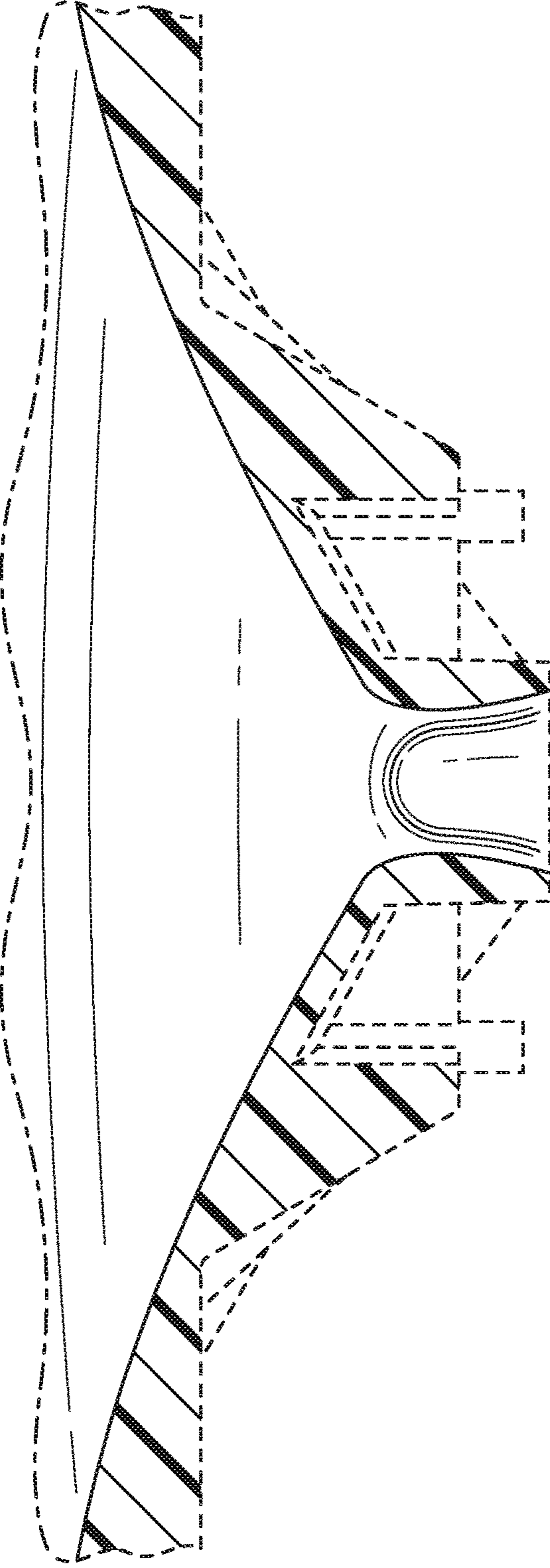

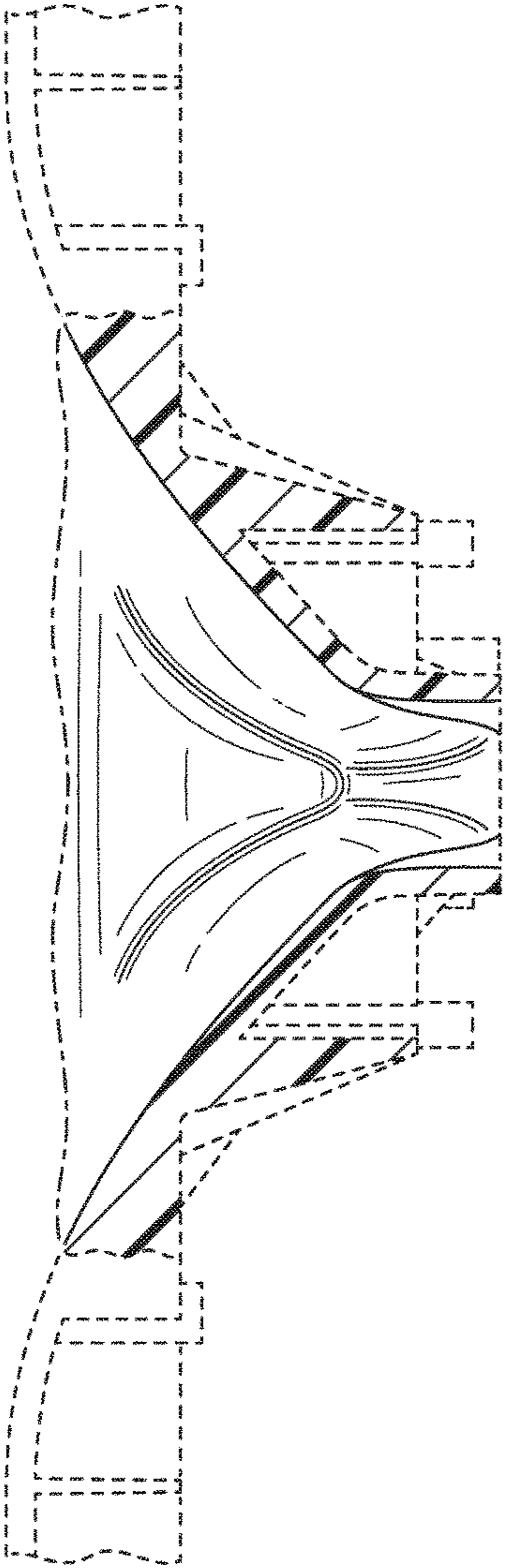
