(57) **CLAIM**
The ornamental design for a poker chip, as shown and described.

DESCRIPTION
FIG. 1 is a front perspective view of the poker chip according to the invention, showing the front side of the chip. FIG. 2 is a front plan view of the poker chip, the rear view being a mirror image thereof. FIG. 3 is a right side plan view of the poker chip, the left side view being a mirror image thereof; and, FIG. 4 is a top plan view of the poker chip, the bottom view being a mirror image thereof.

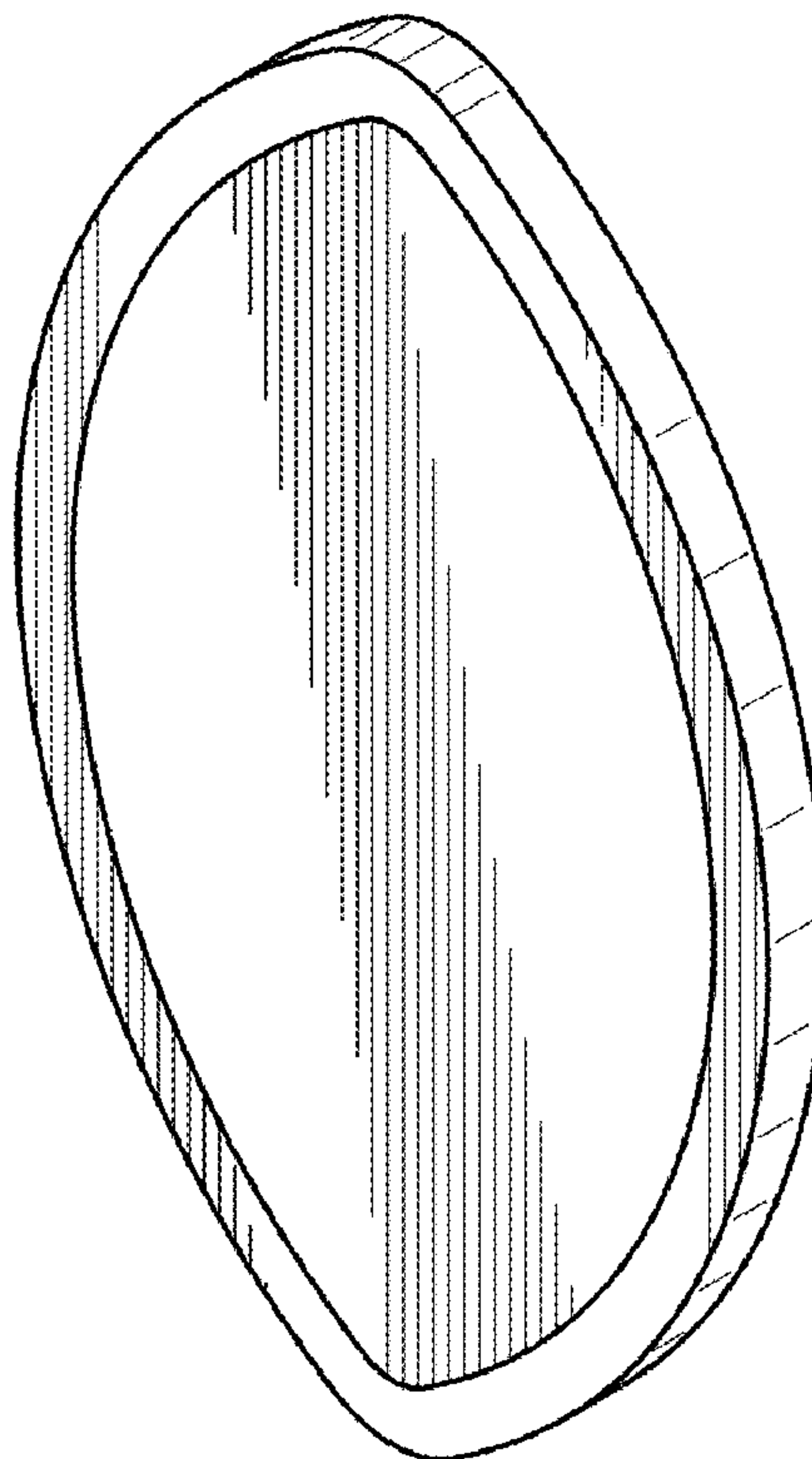

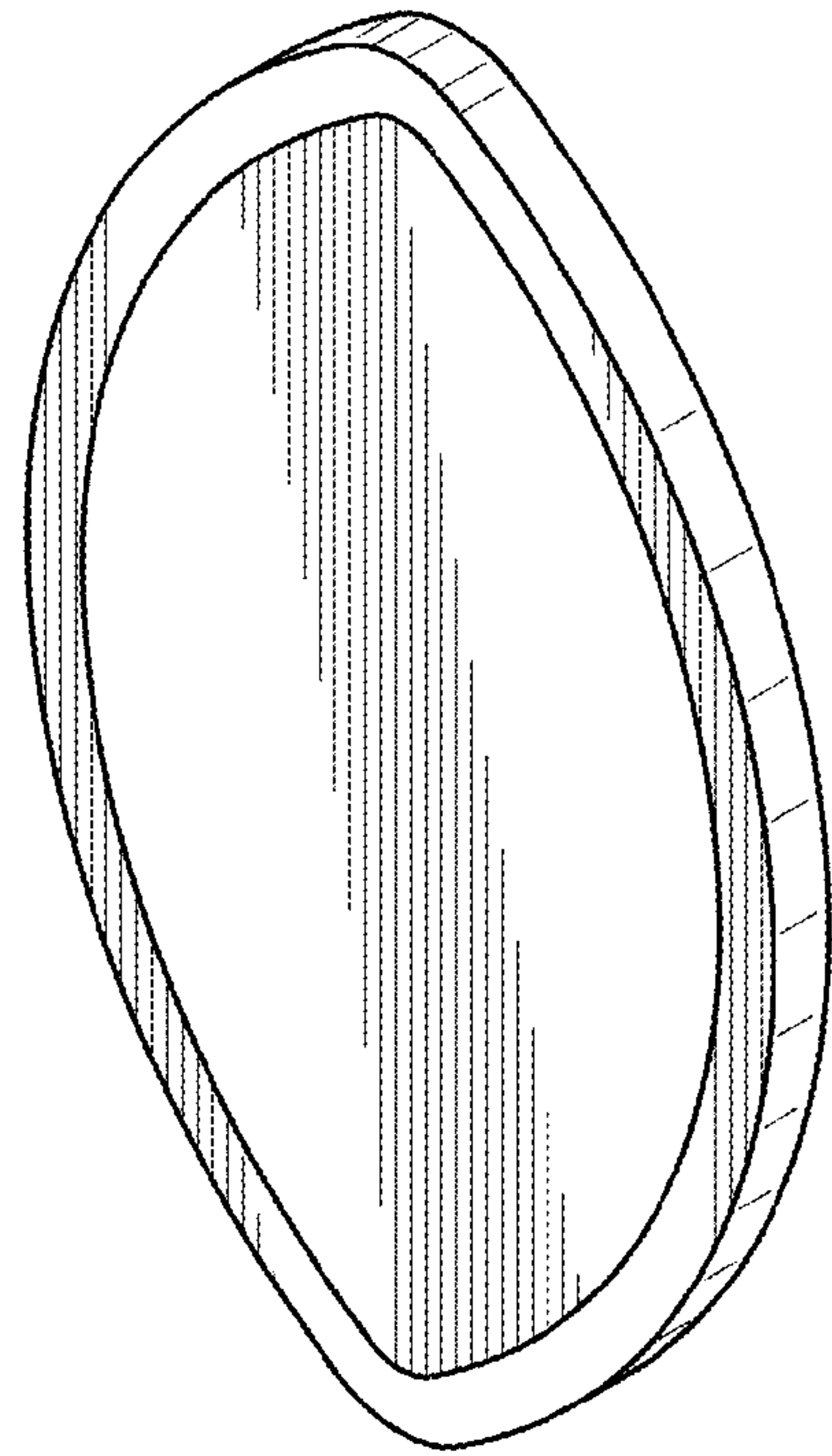

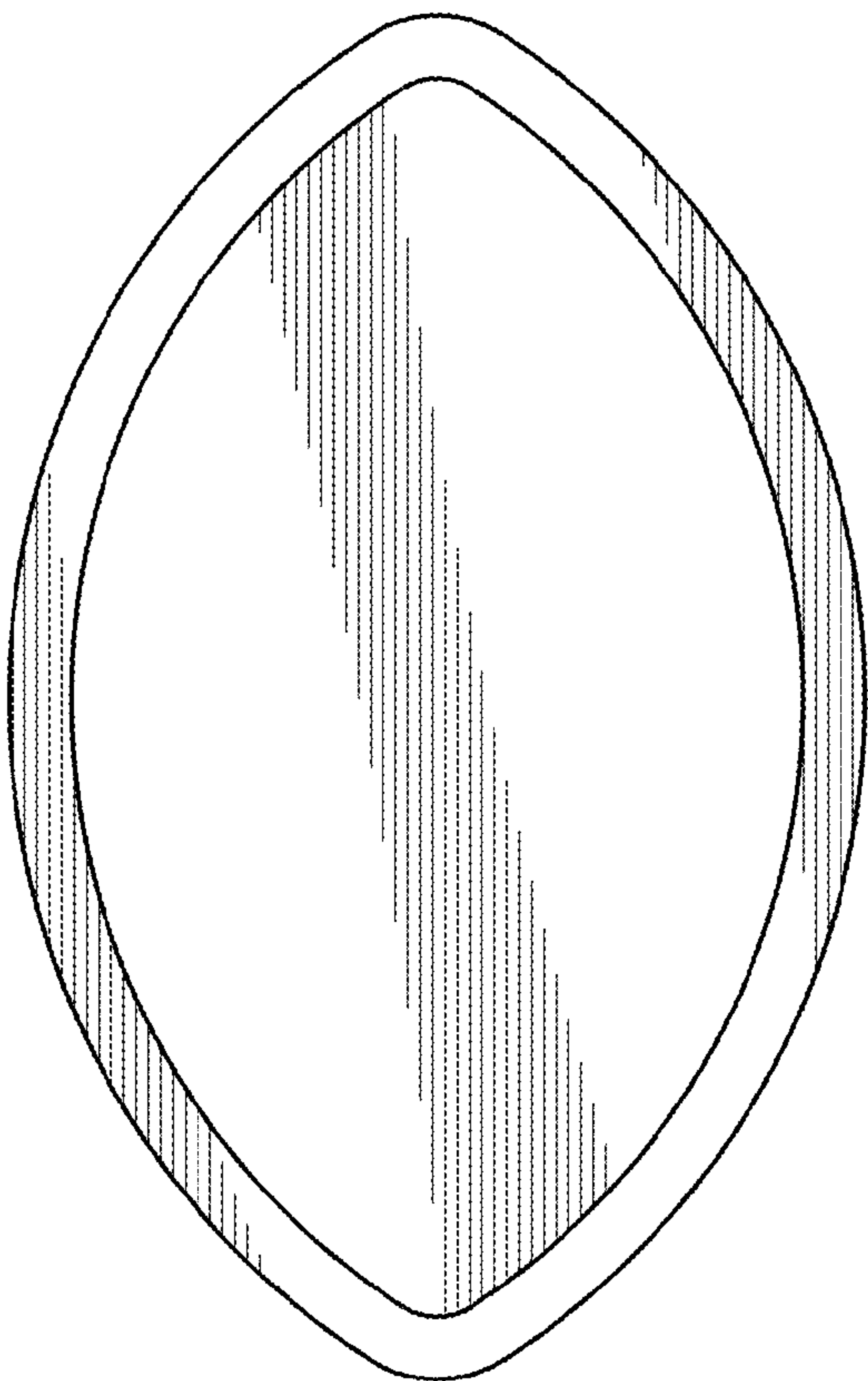
